**DESCRIPTION**

showing my new design;

in FIG. 1;

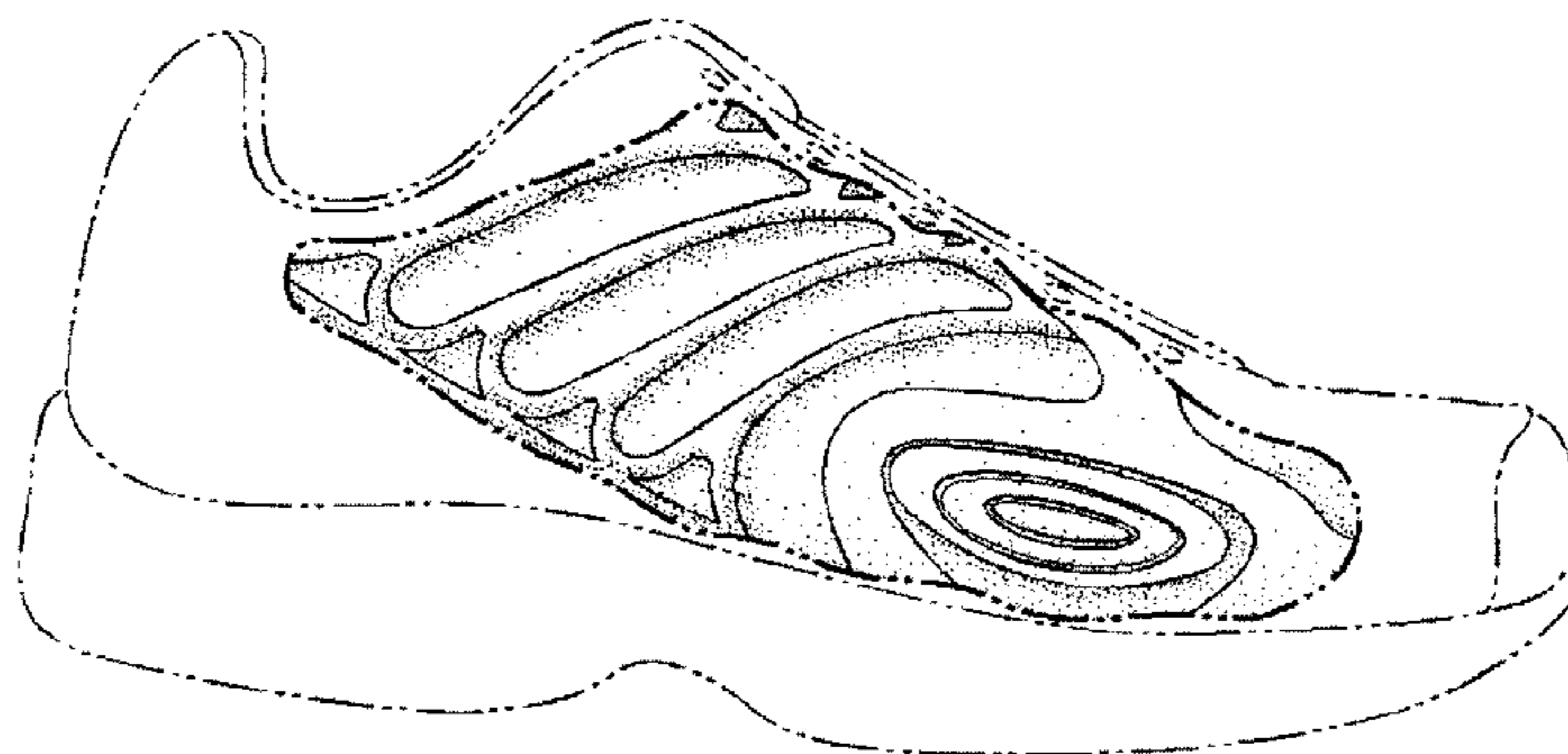
FIG. 3 is a front view of the portion of a shoe upper shown

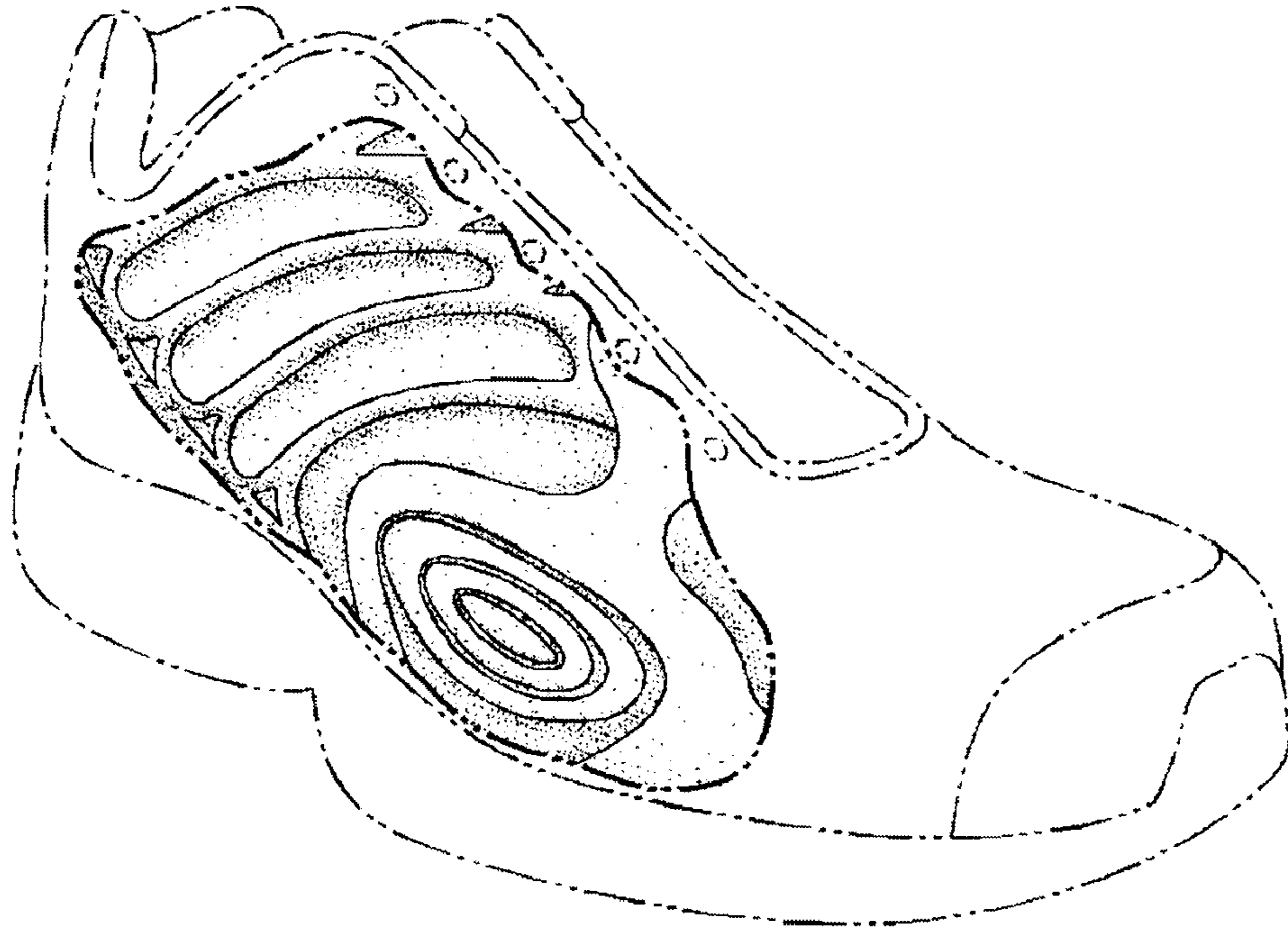

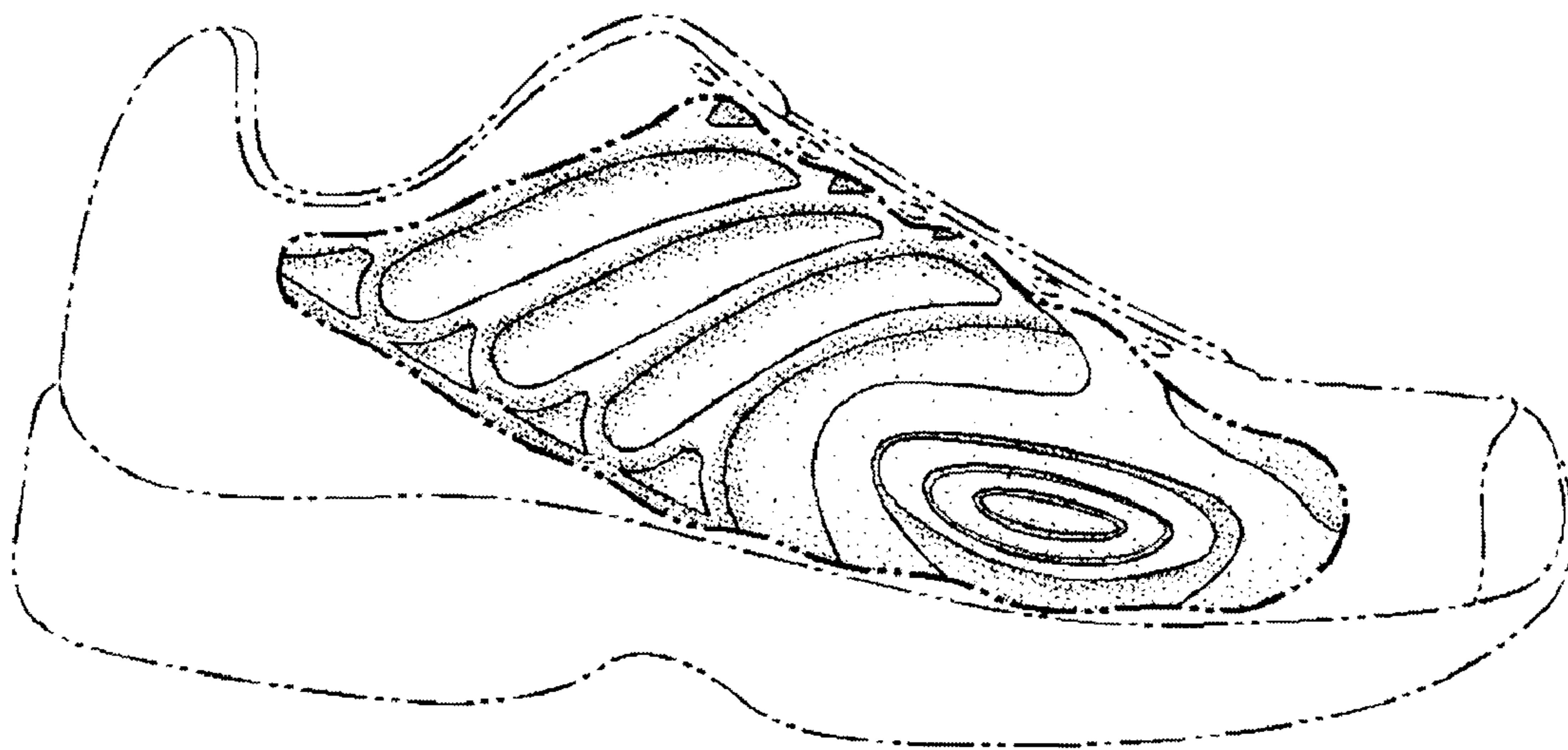

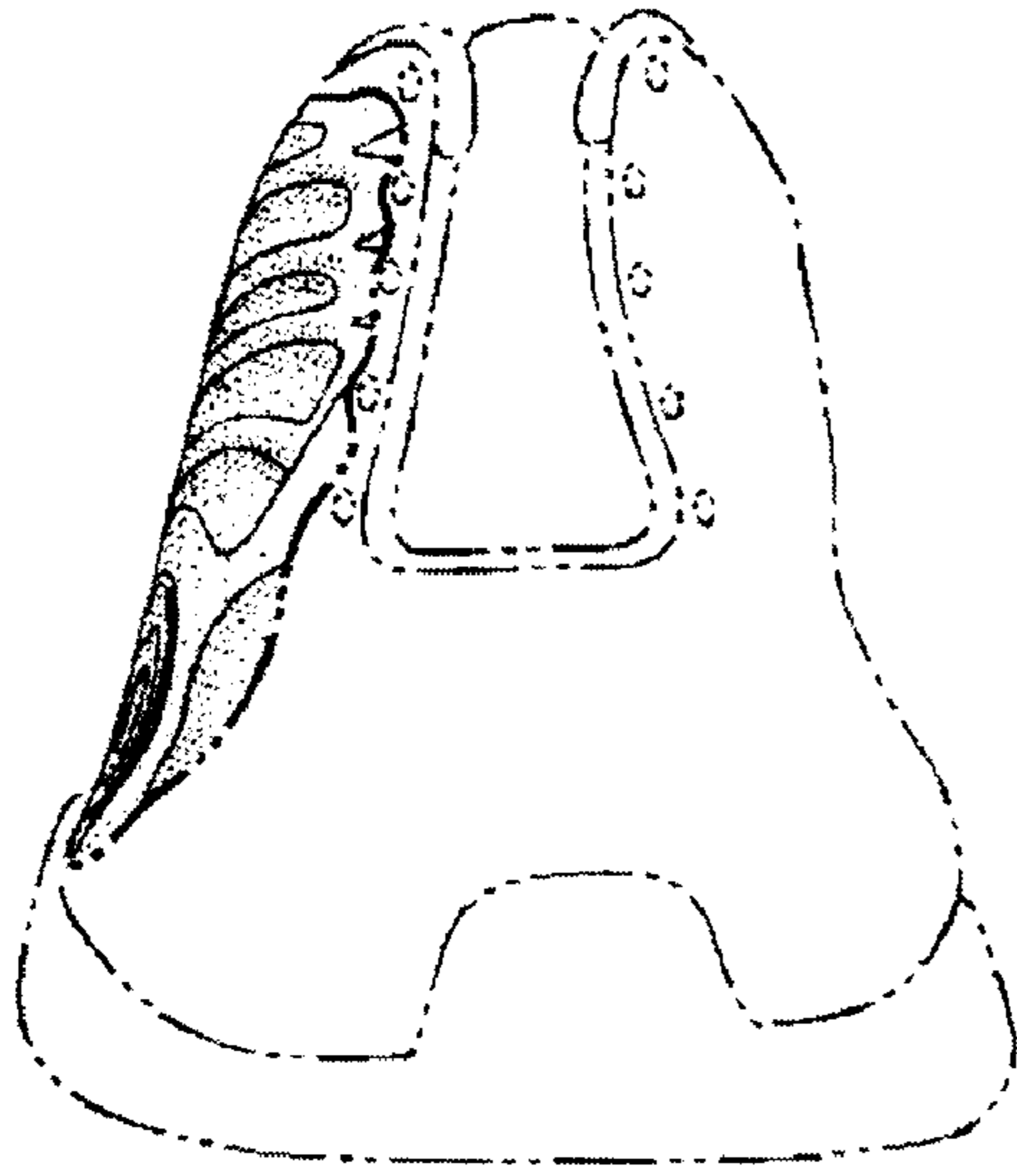

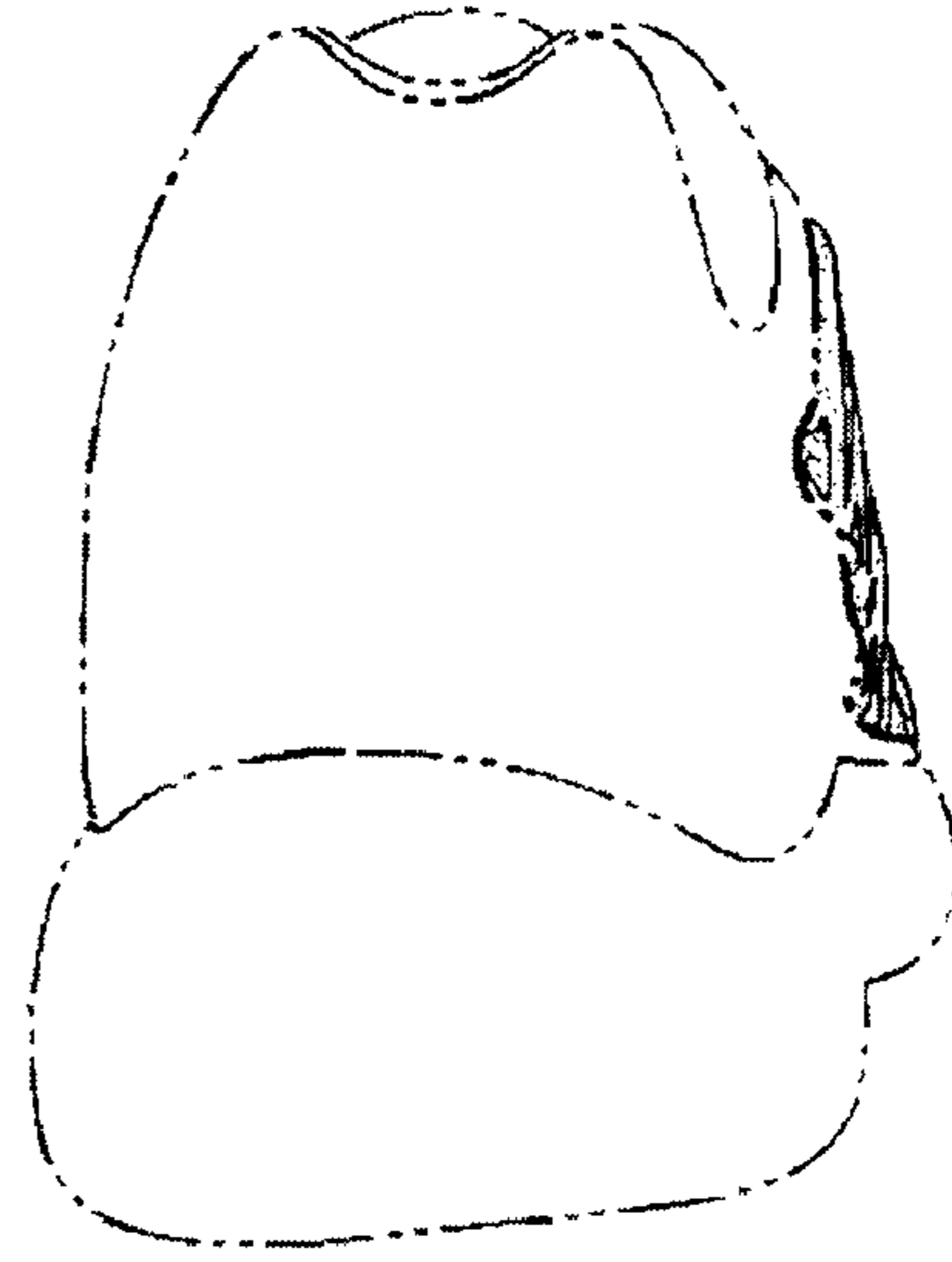

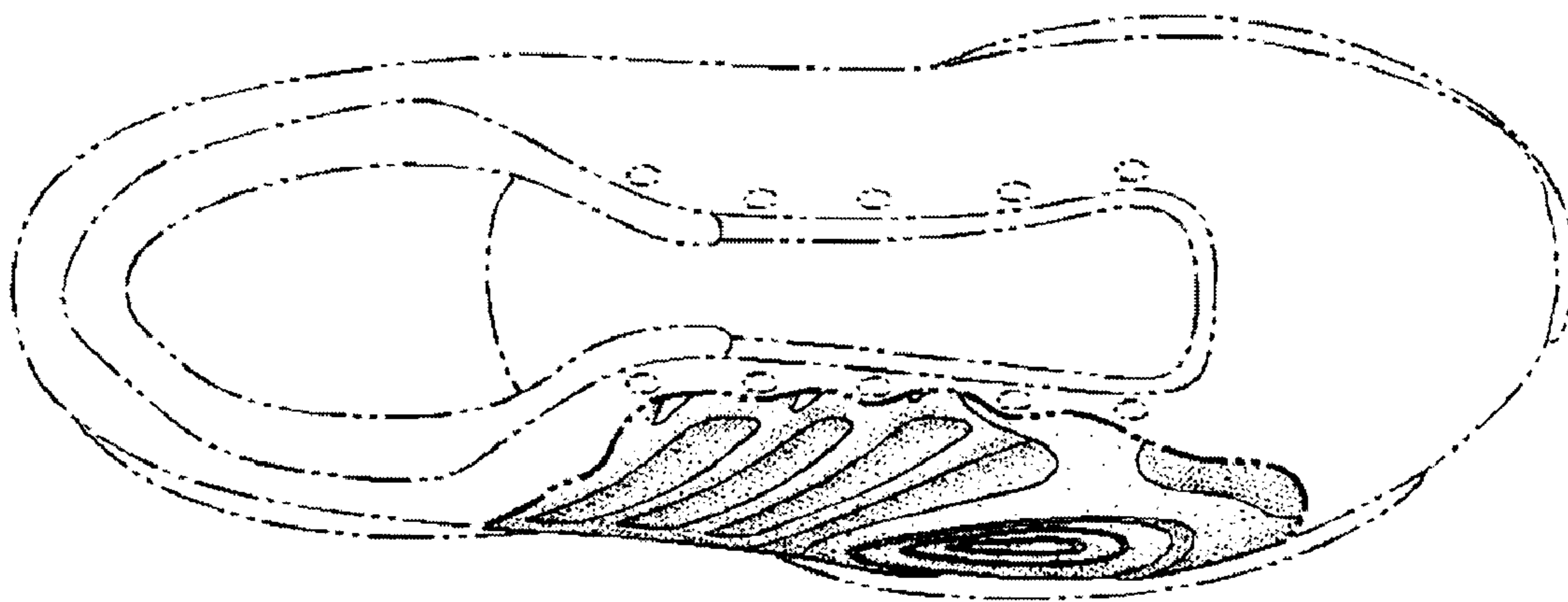
