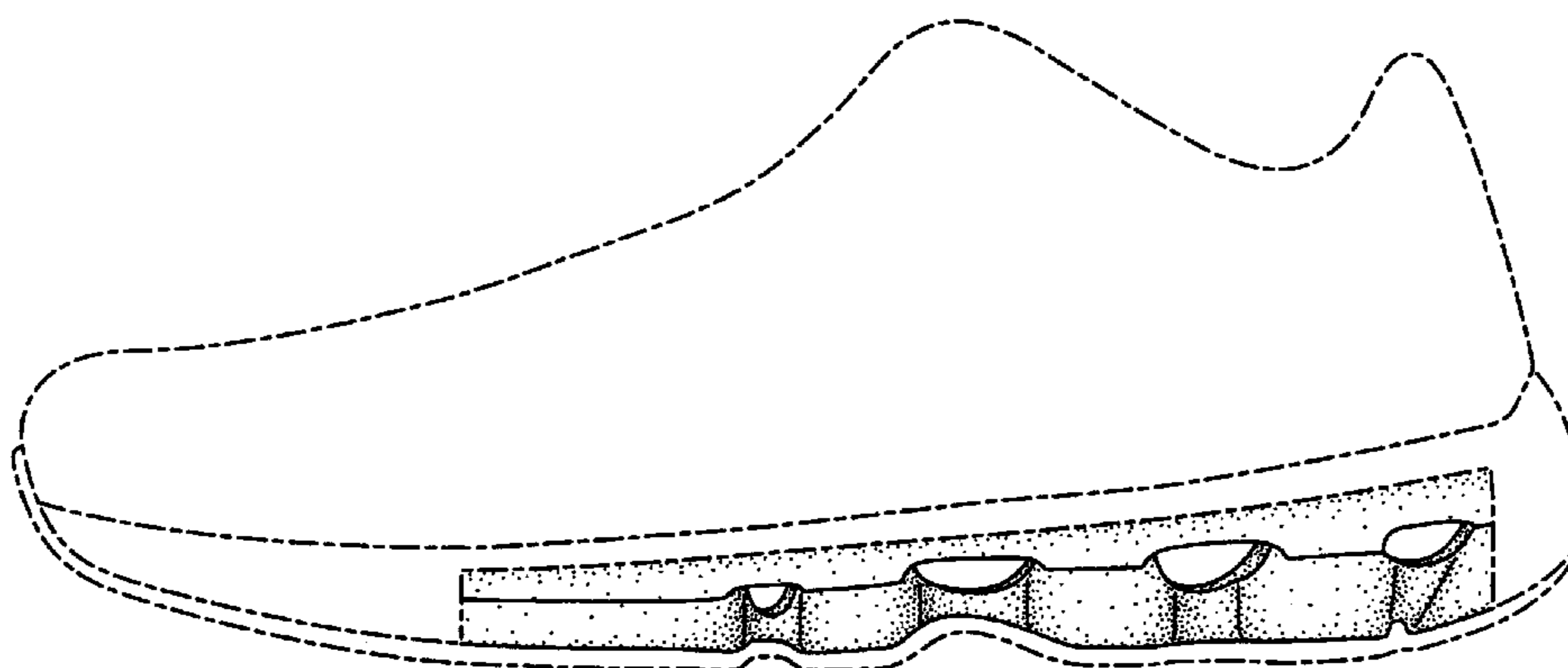
(57) **CLAIM**

The ornamental design for a portion of a shoe midsole, as
shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portion of a shoe
midsole showing my new design;
FIG. 2 is a rear perspective view thereof; and,
FIG. 3 is a view of one side thereof thereof.
The uneven broken line showing the upper and the remain-
der of the shoe sole is for illustrative purposes only and
forms no part of the claimed design. The uneven broken line
immediately adjacent to the shaded area represents a portion
of an unclaimed boundary of the design.

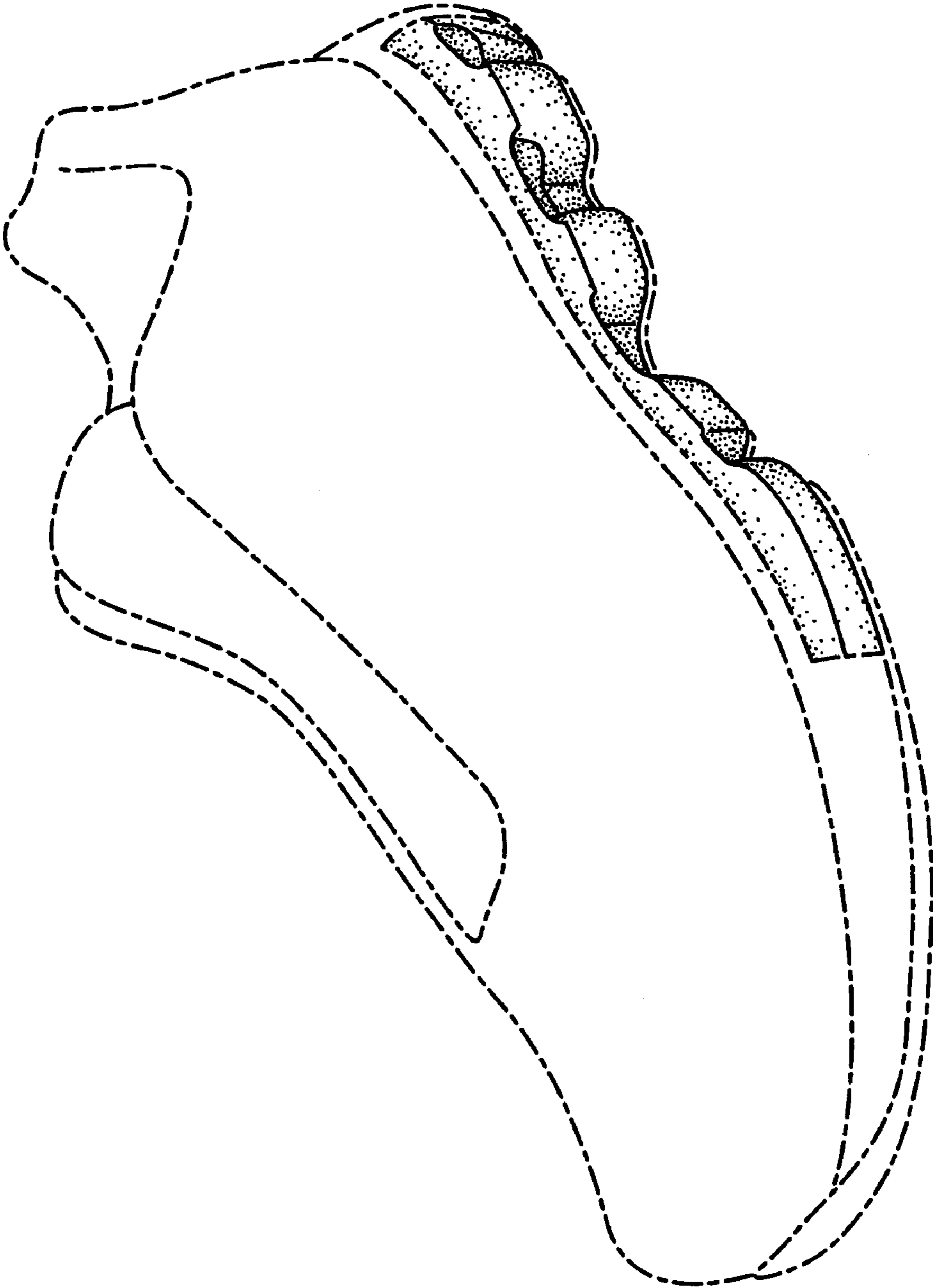

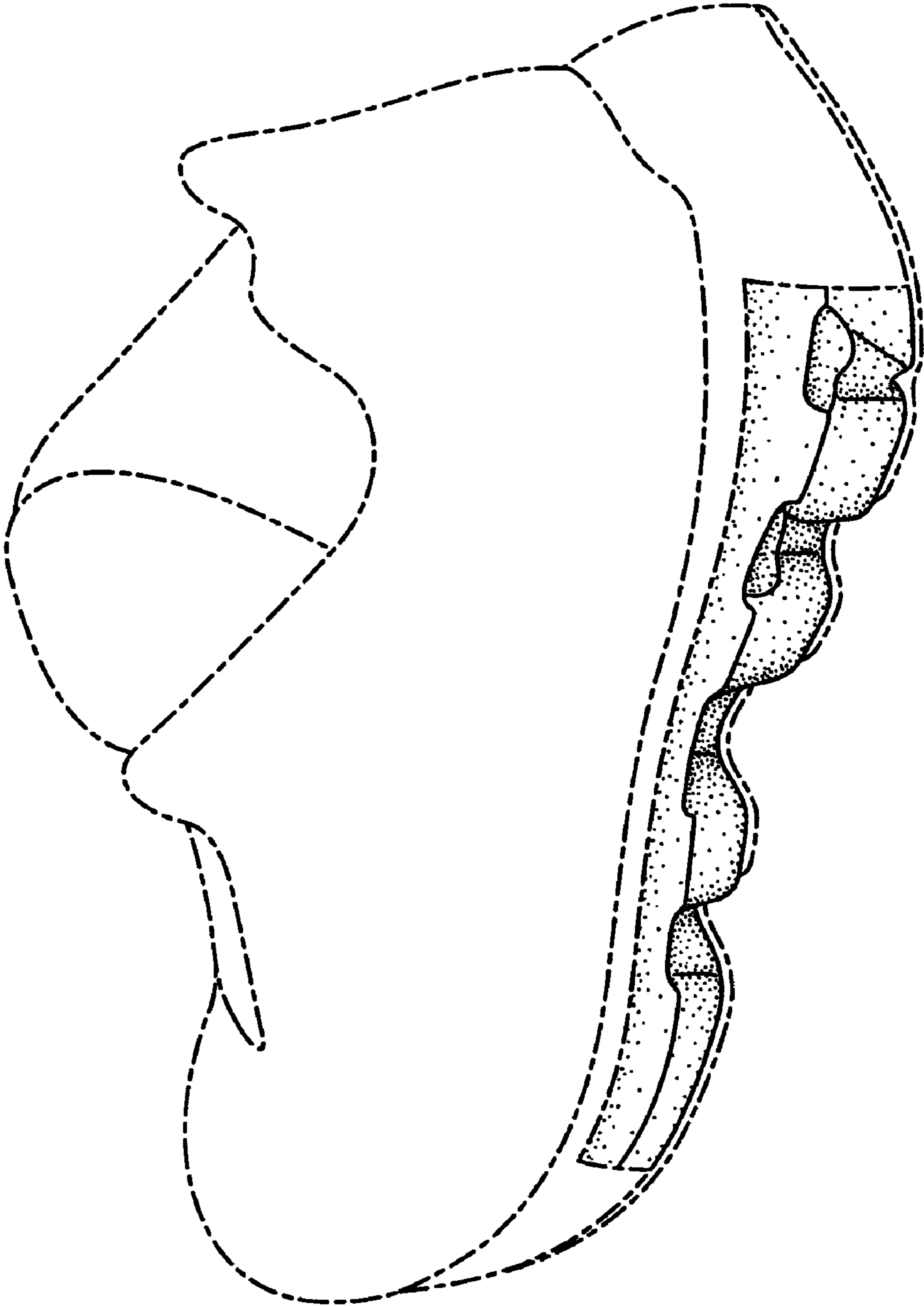

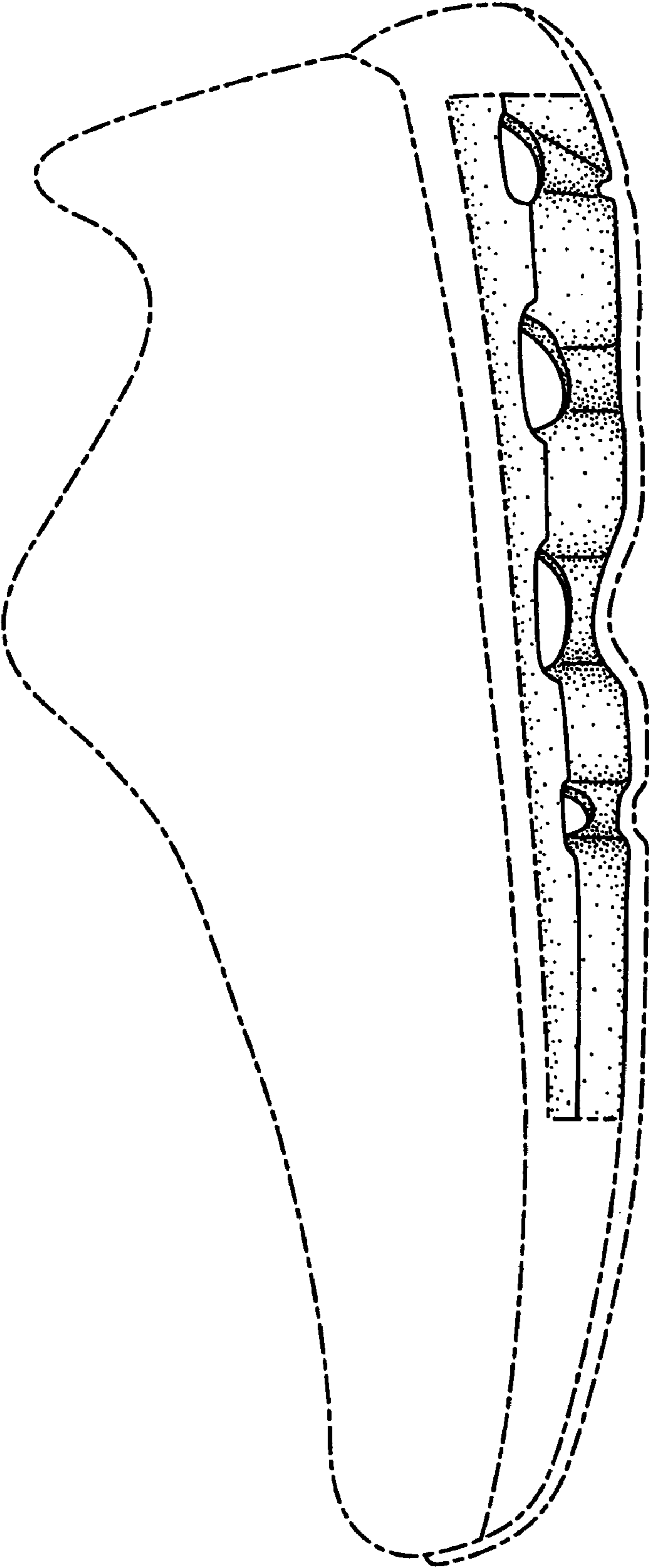
