(57) **CLAIM**

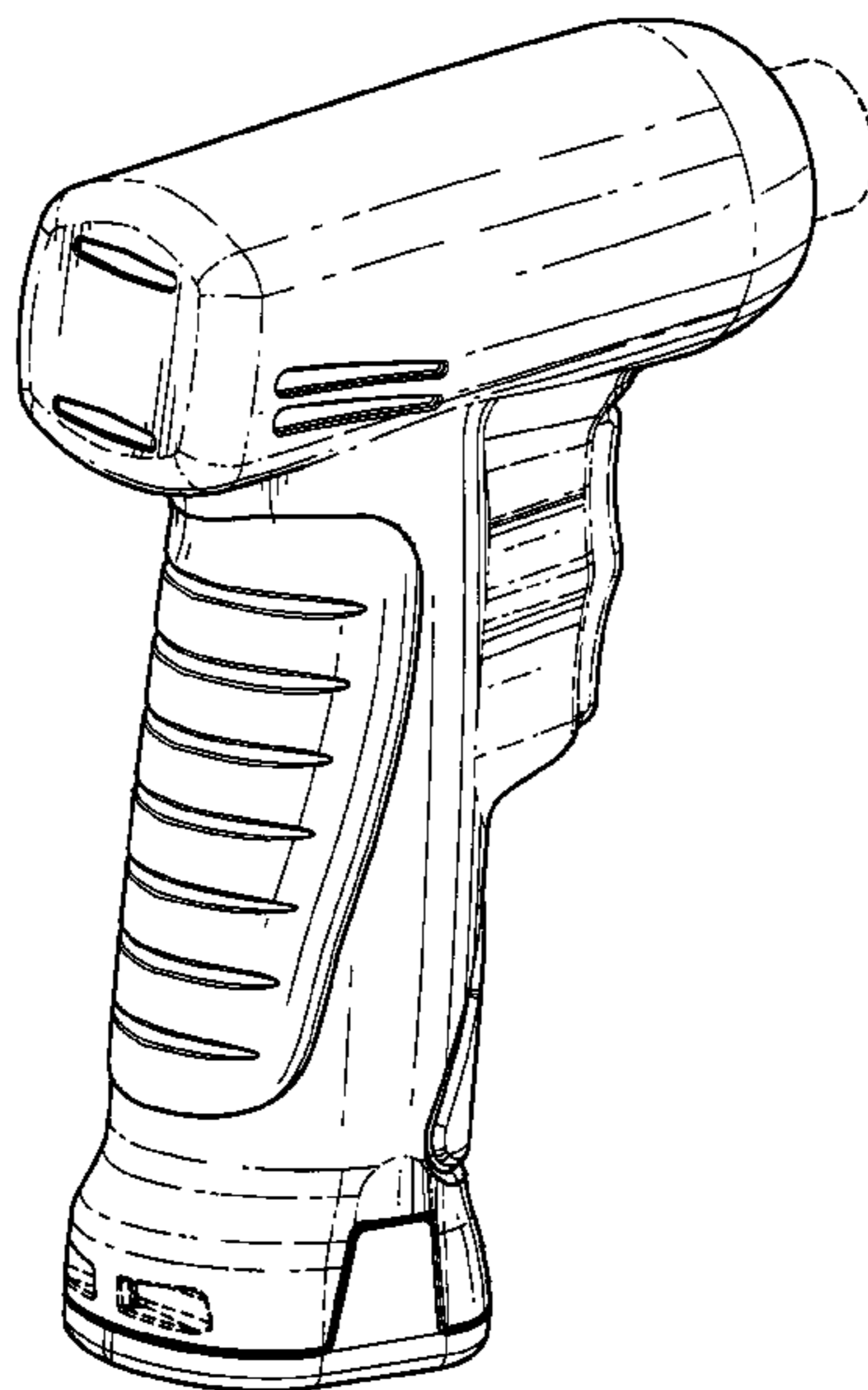
The ornamental design for a cordless power tool, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the cordless power tool; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof, the right side view is not shown as it is a mirror image of the left side view; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines are shown in the views for illustrative purposes only and form no part of the claimed design.

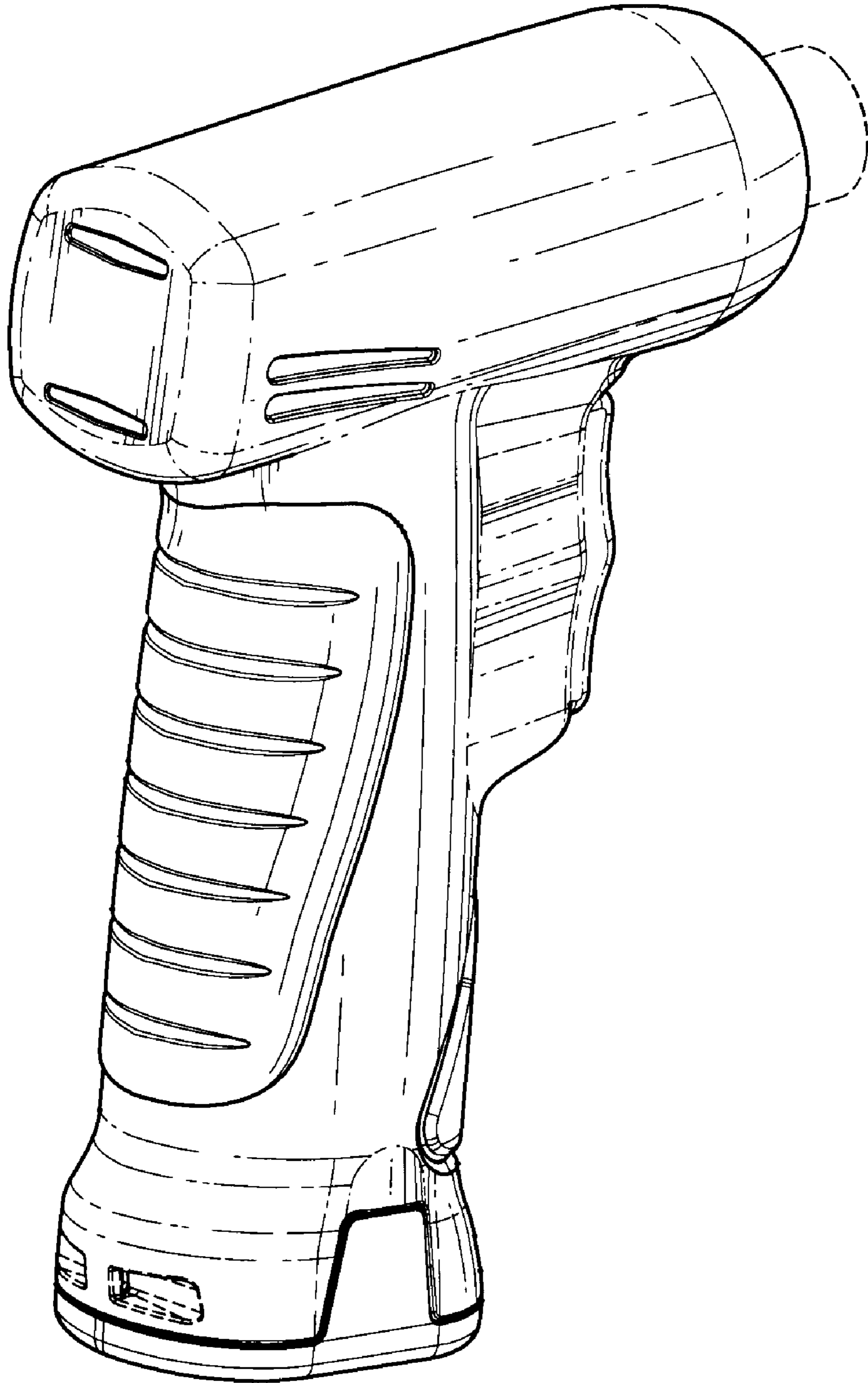

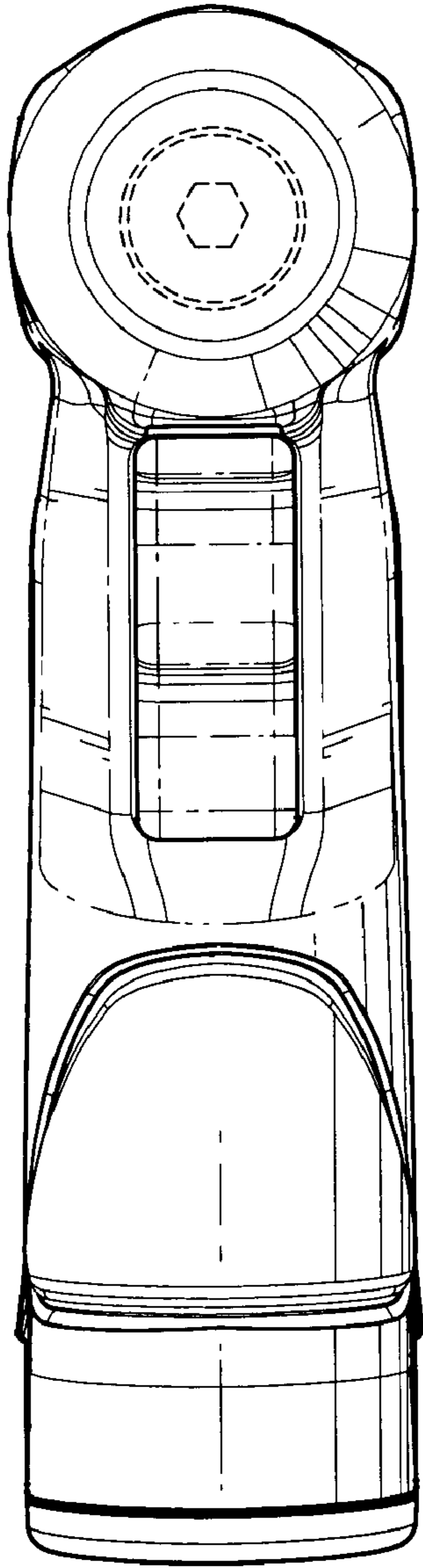

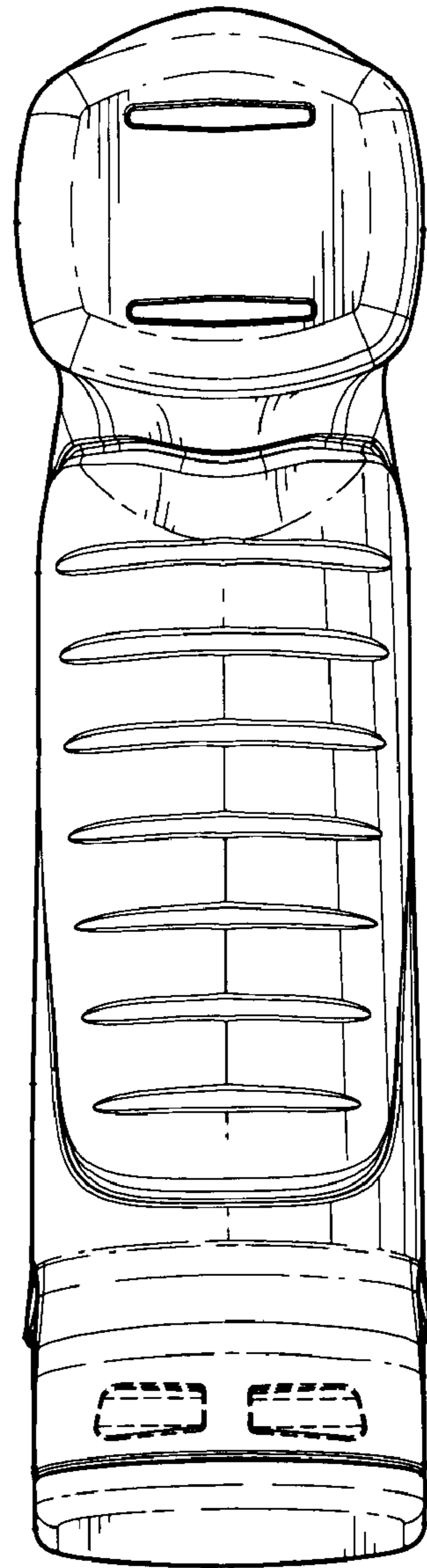

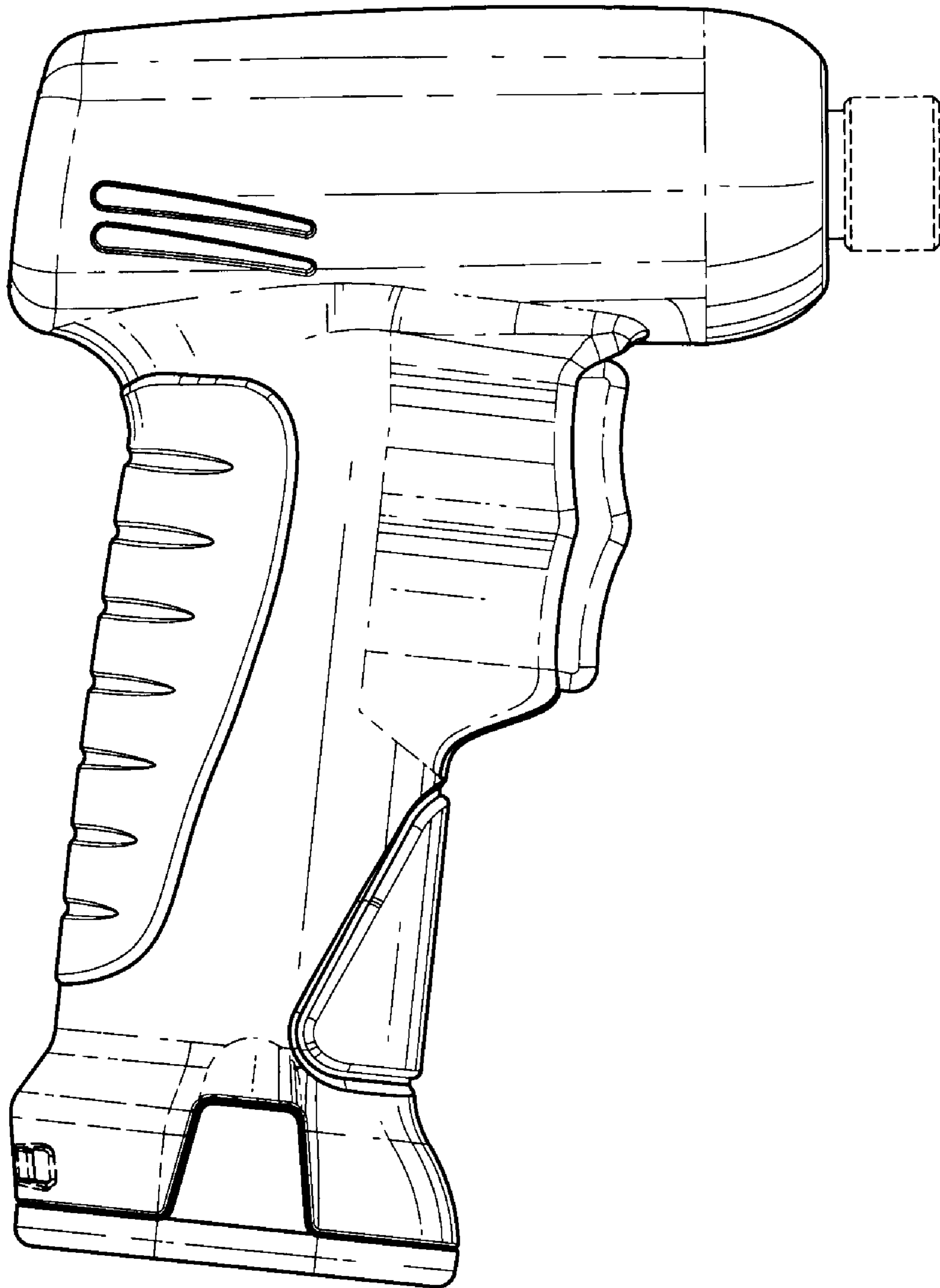

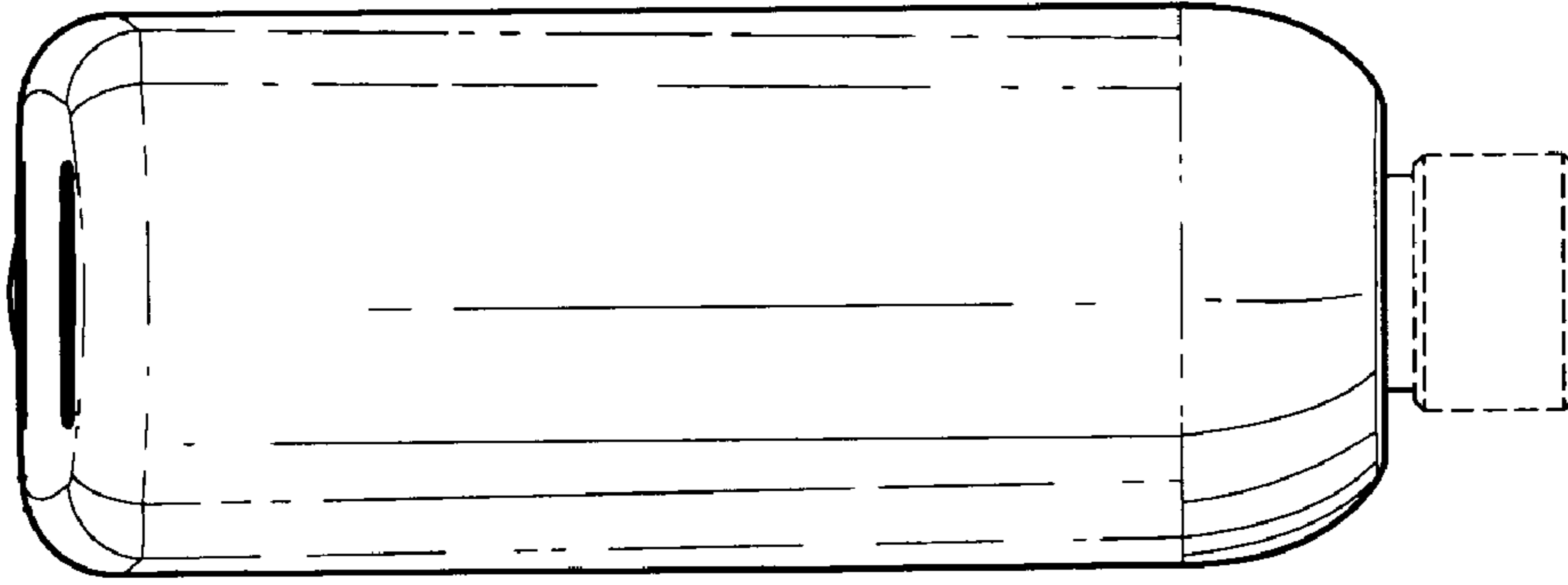

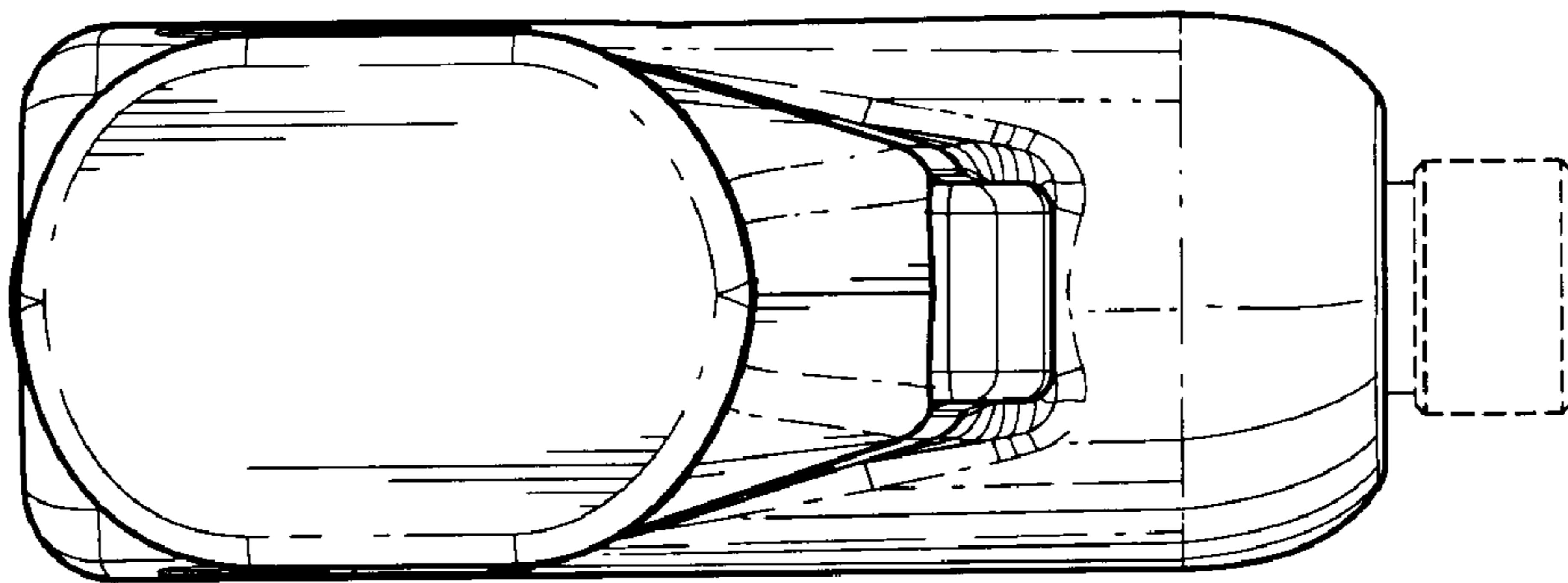
