We claim the ornamental design for a package, as shown and described.

FIG. 3 is a right side view thereof, wherein the left side view is a mirror image thereof;

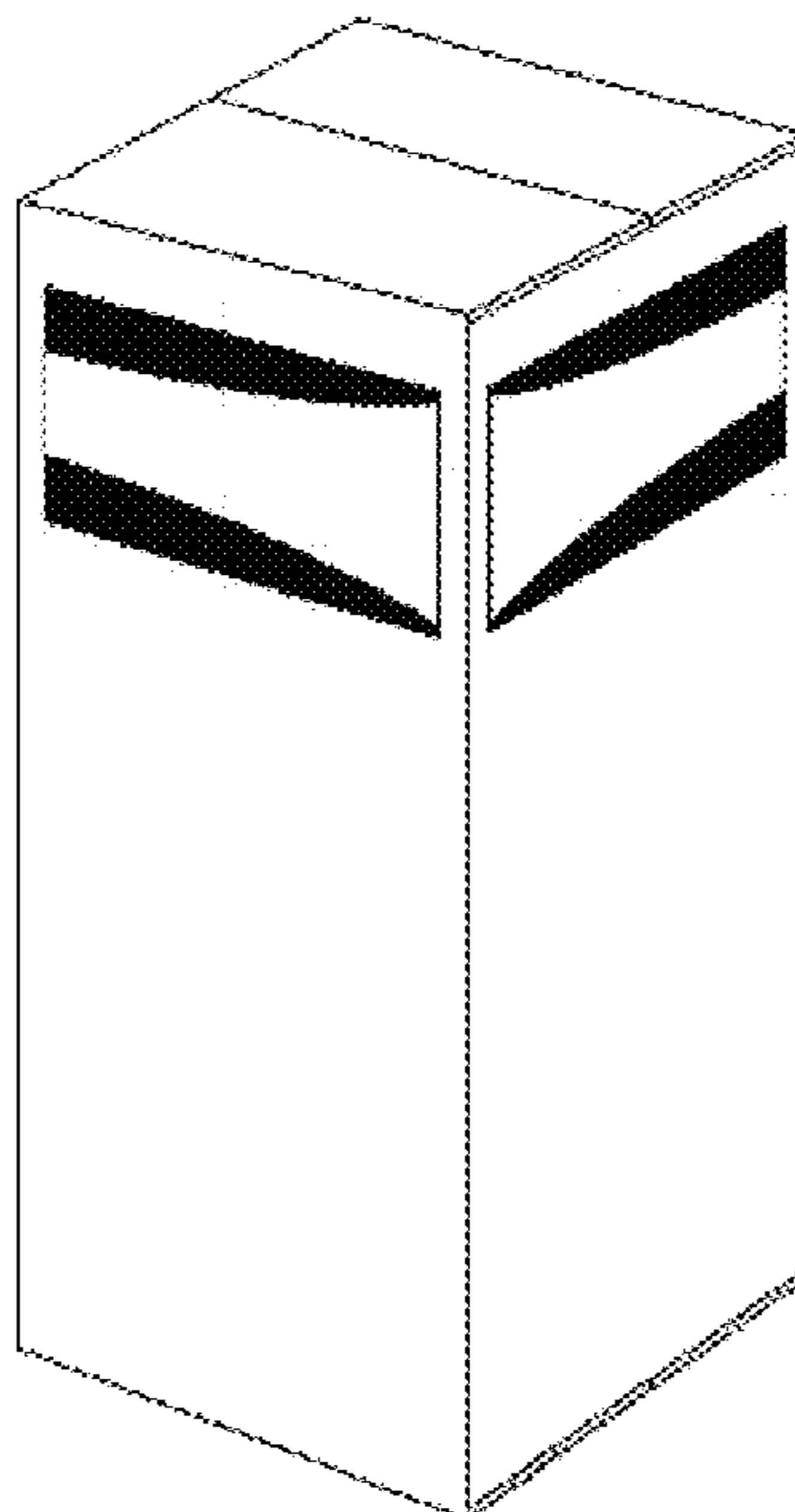
FIG. 4 is a top view thereof; and,

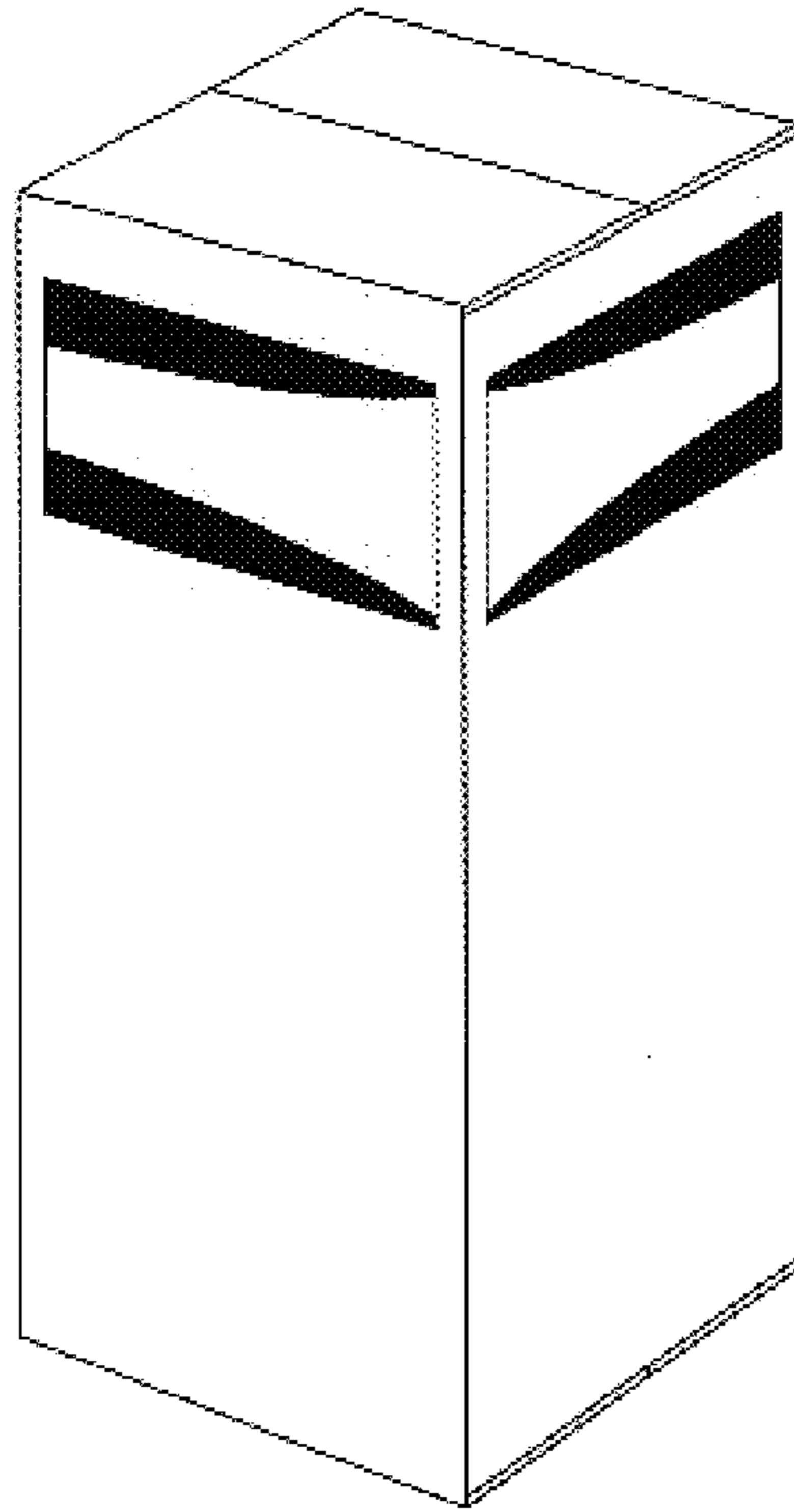

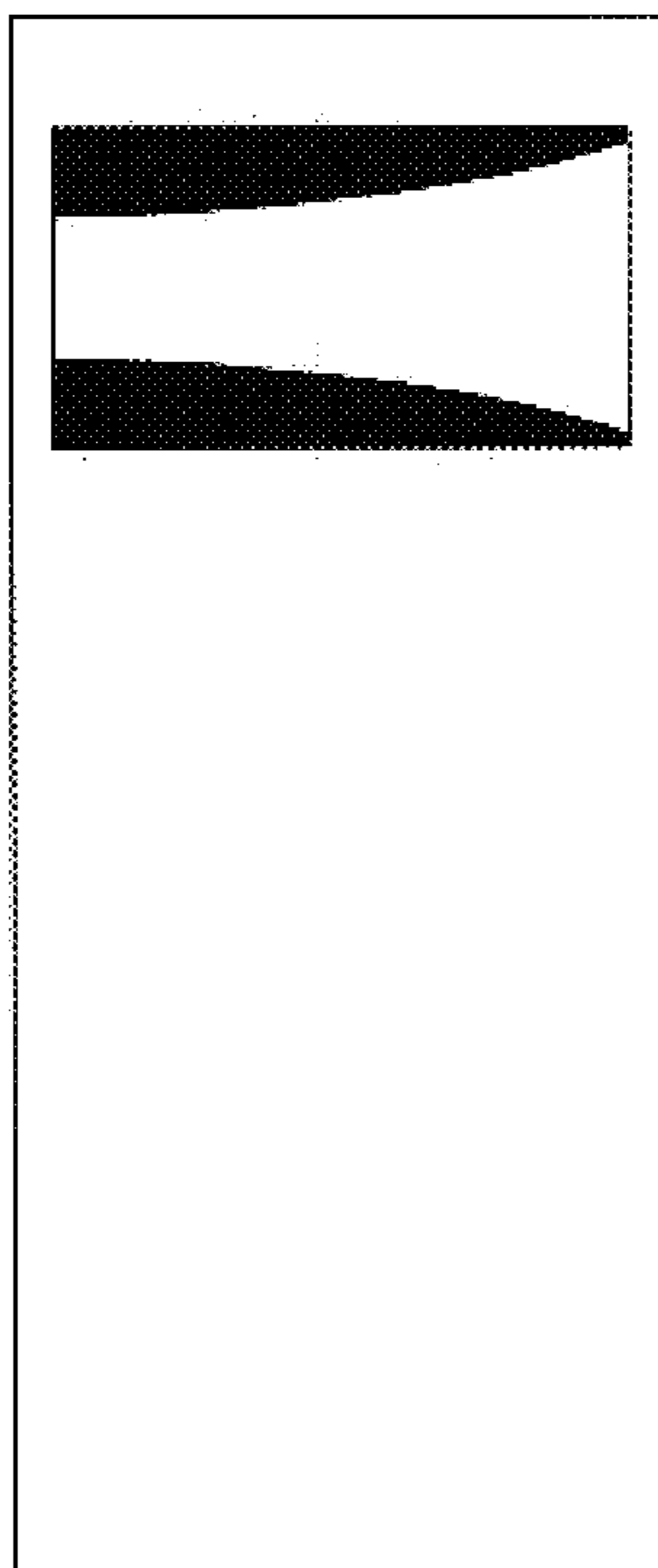

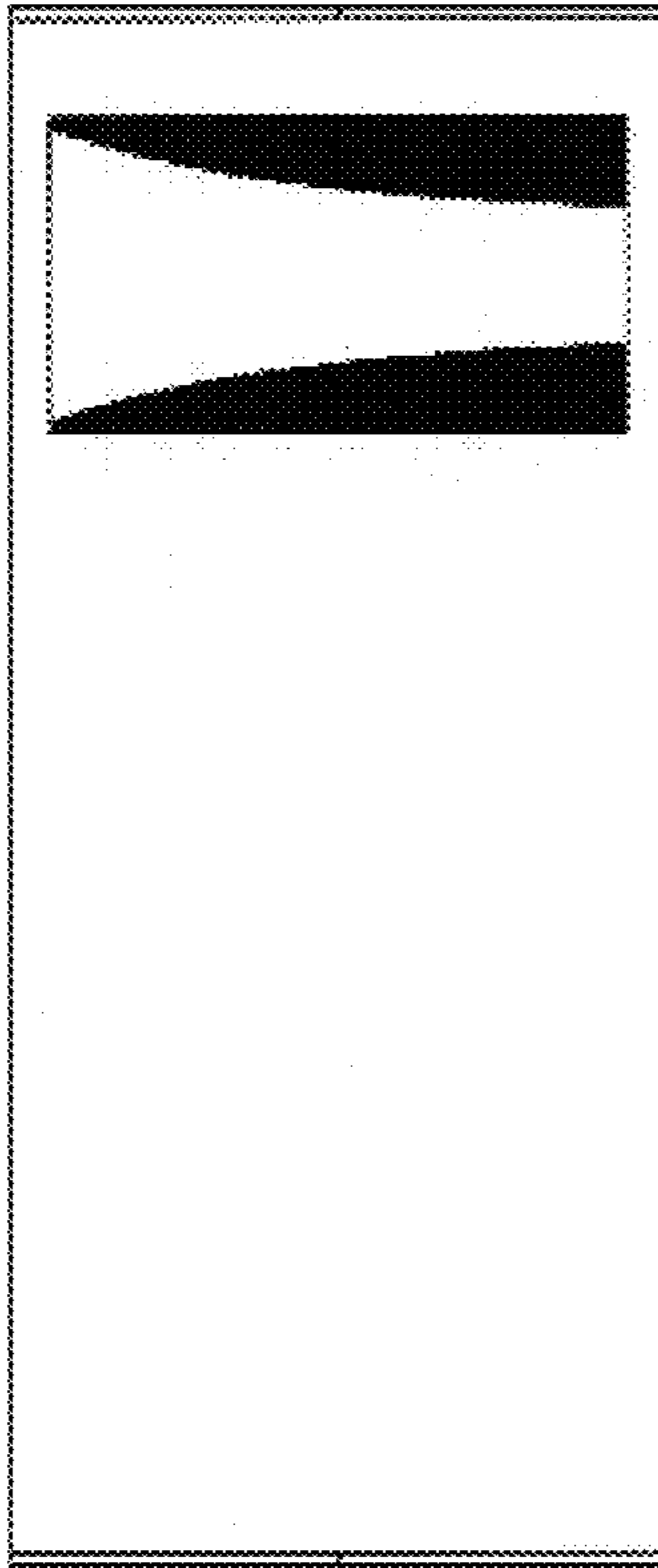

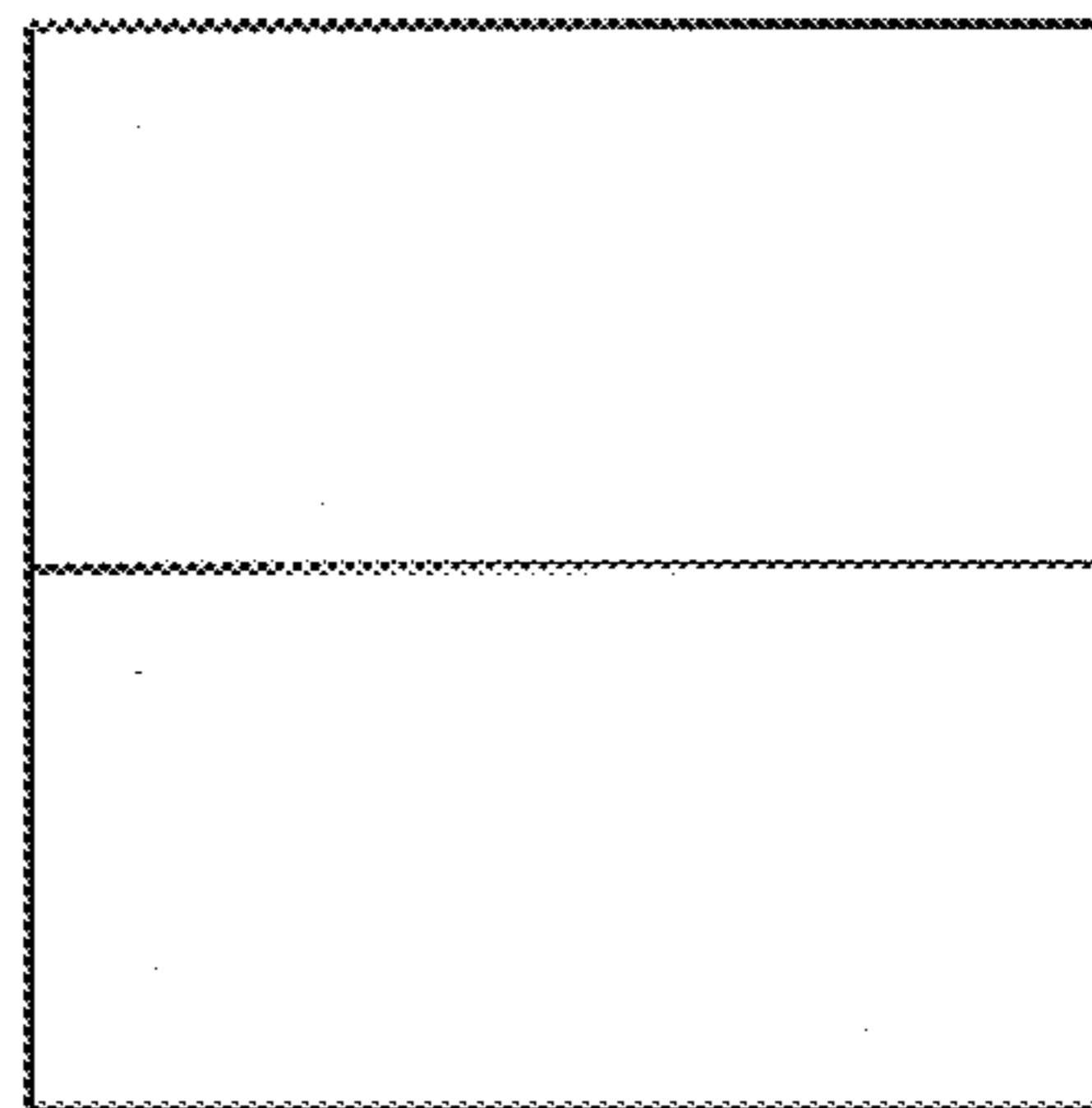

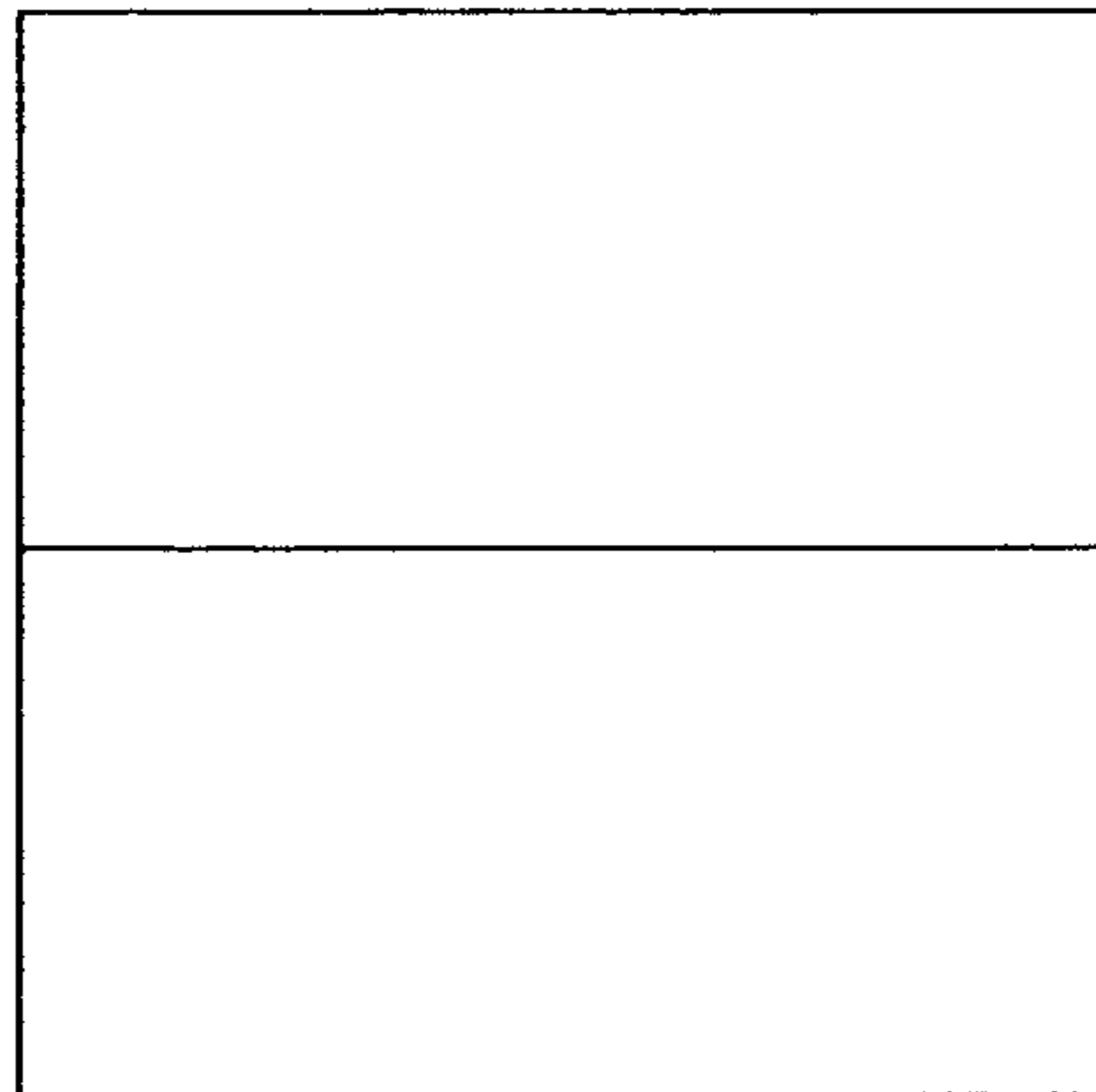
