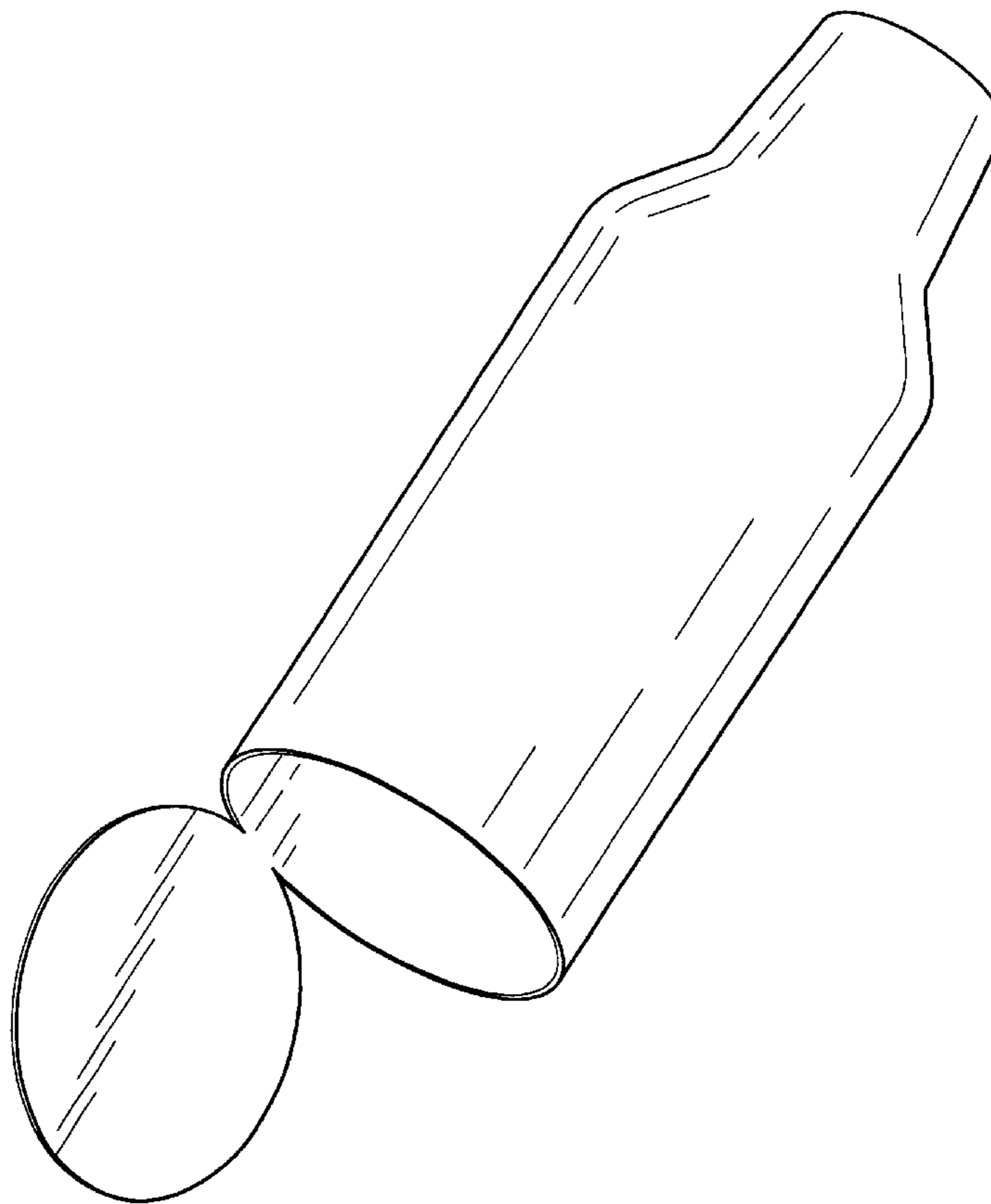
(57) **CLAIM**

The ornamental design for a disposable insulating beverage bottle jacket, as shown and described.

**DESCRIPTION**

FIG. 1 is a lower front perspective view of the bottle jacket. FIG. 2 is a front view of the bottle jacket. FIG. 3 is a rear view of the bottle jacket. FIG. 4 is a right side view of the bottle jacket. FIG. 5 is a left side view of the bottle jacket. FIG. 6 is a top view of the bottle jacket. FIG. 7 is a bottom view of the bottle jacket; and, FIG. 8 is a lower perspective view of the bottle jacket in an alternative position, with the phantom lines indicating the environment upon which the bottle jacket is used.

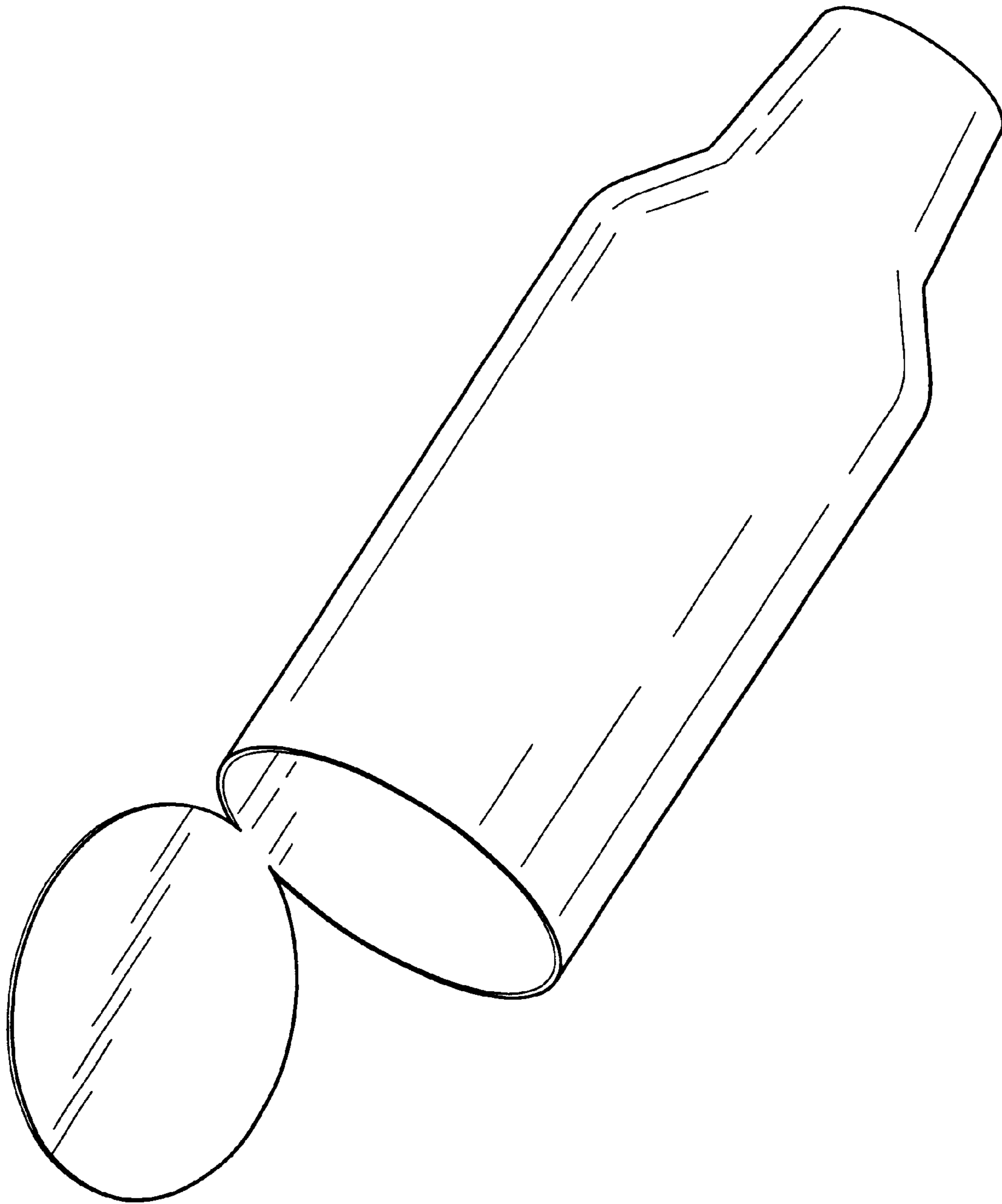
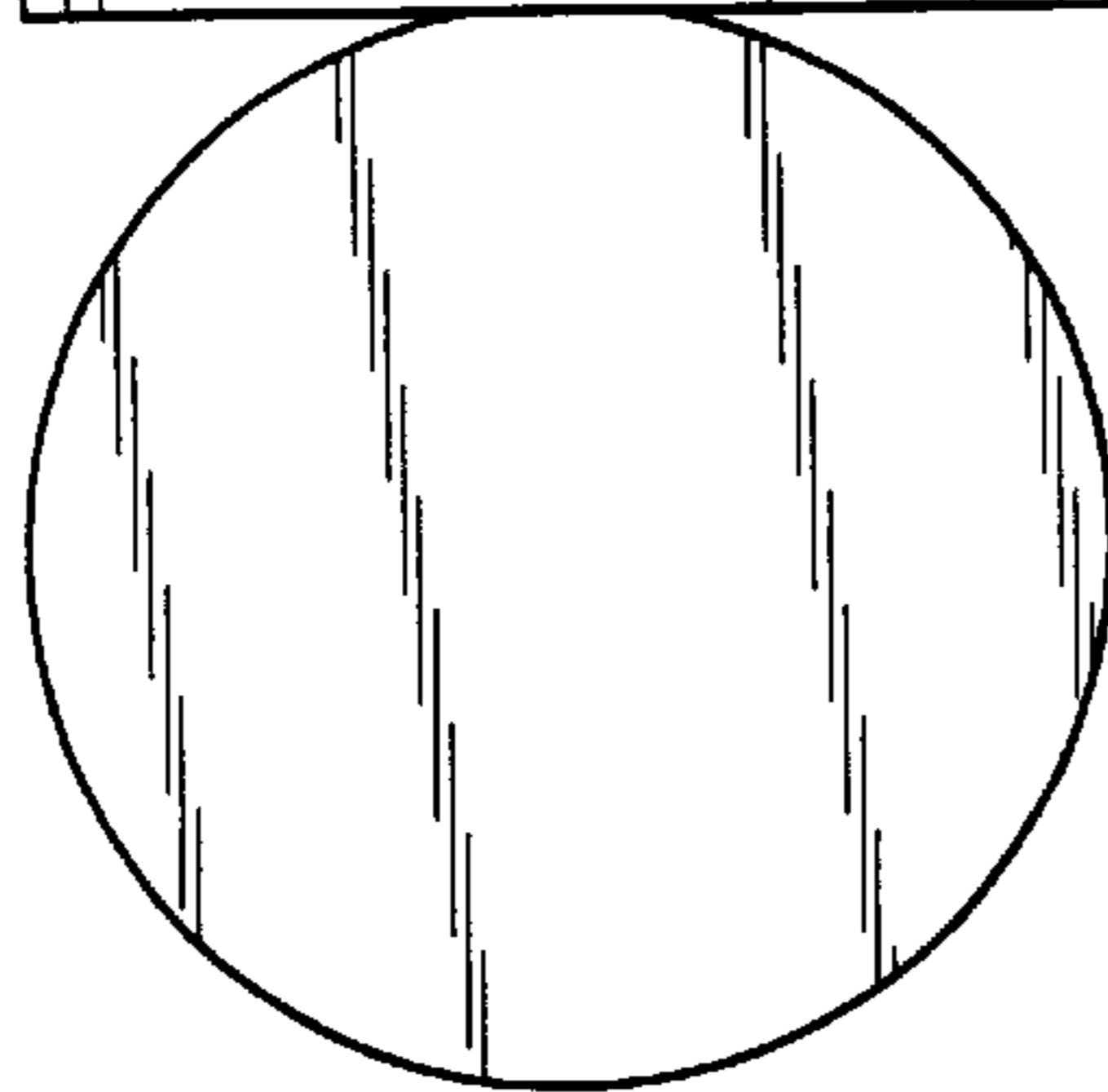
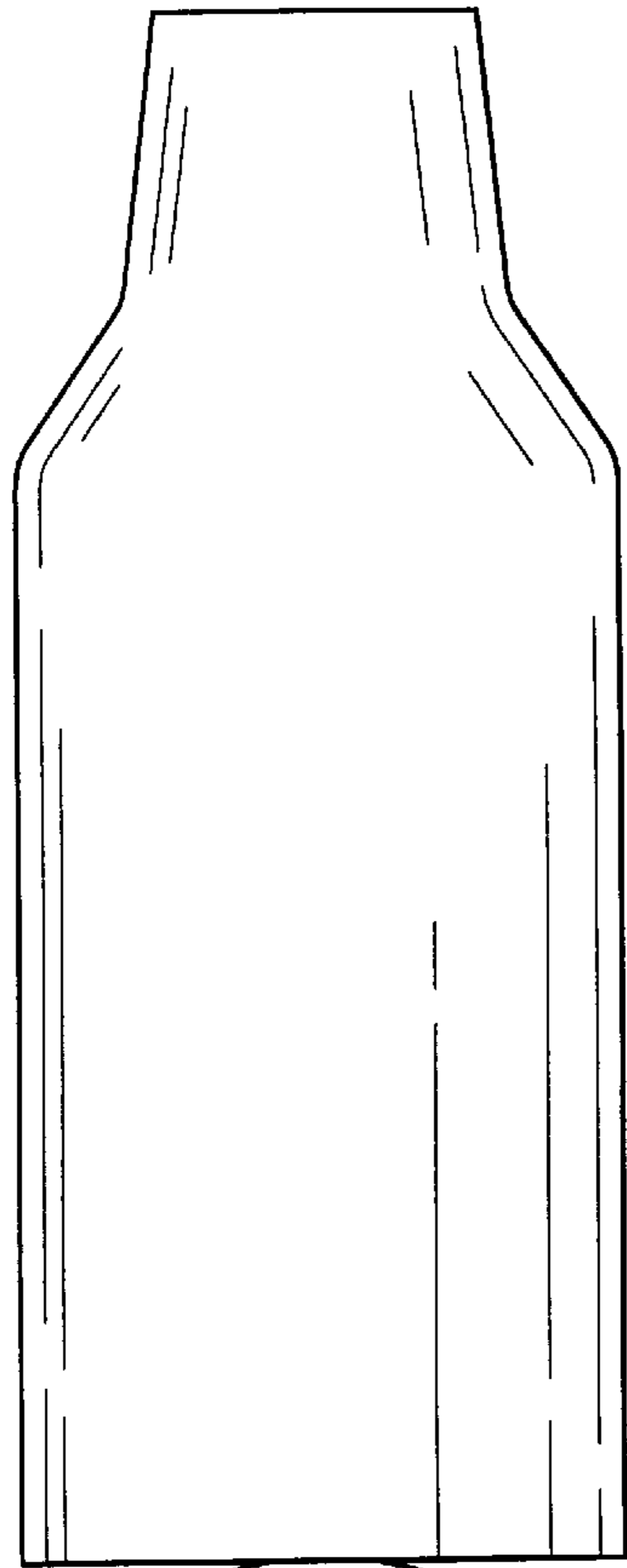
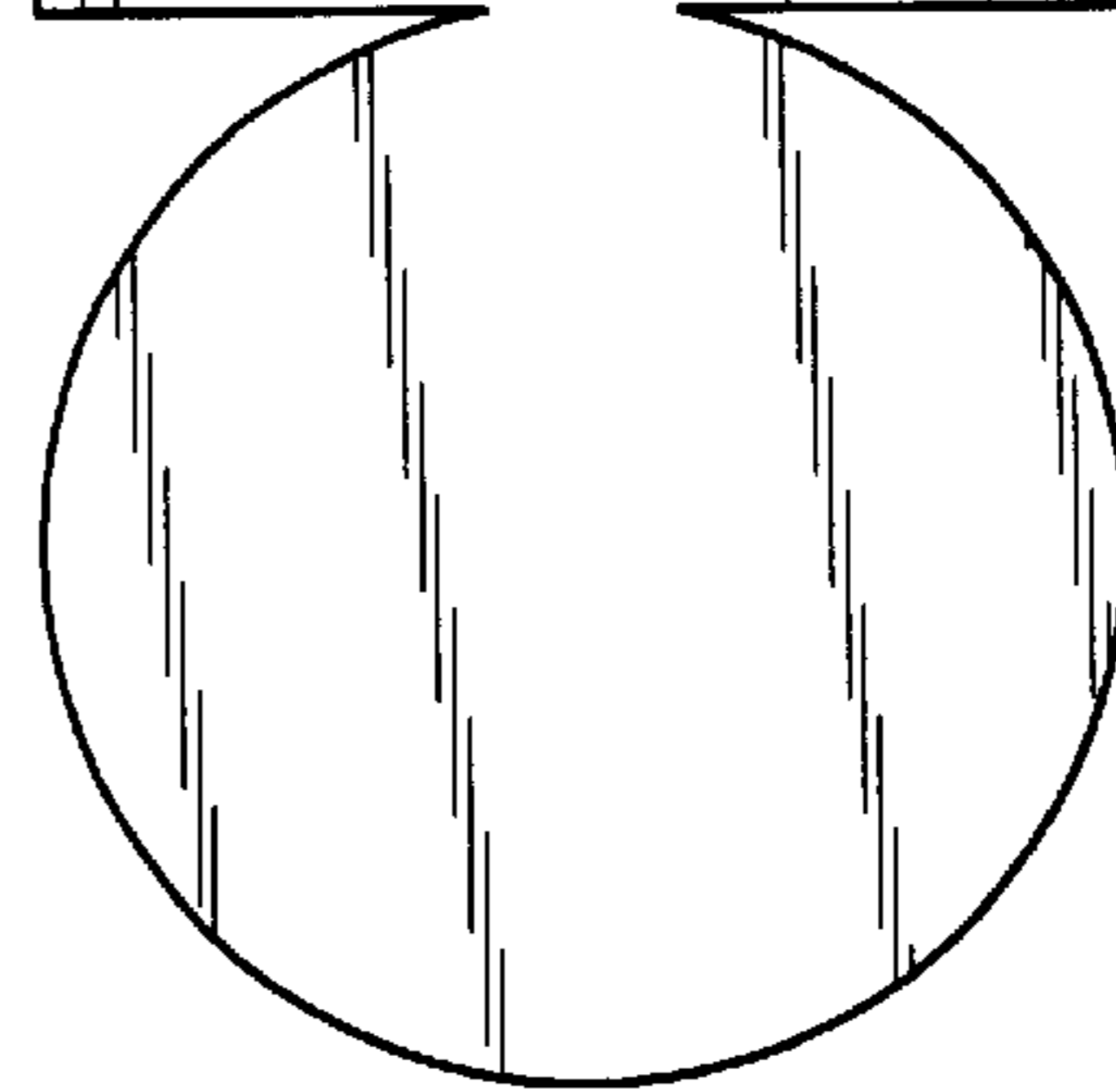
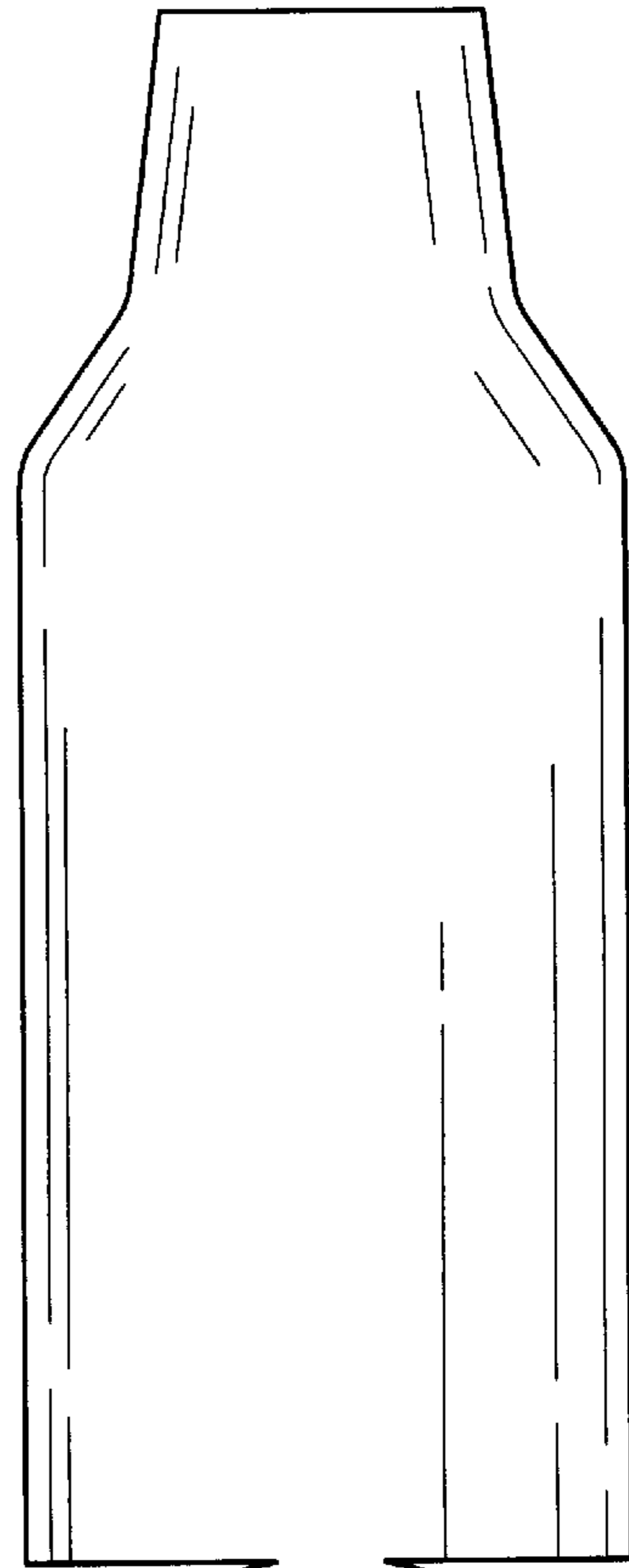
