FIG. 2 is a front view thereof;

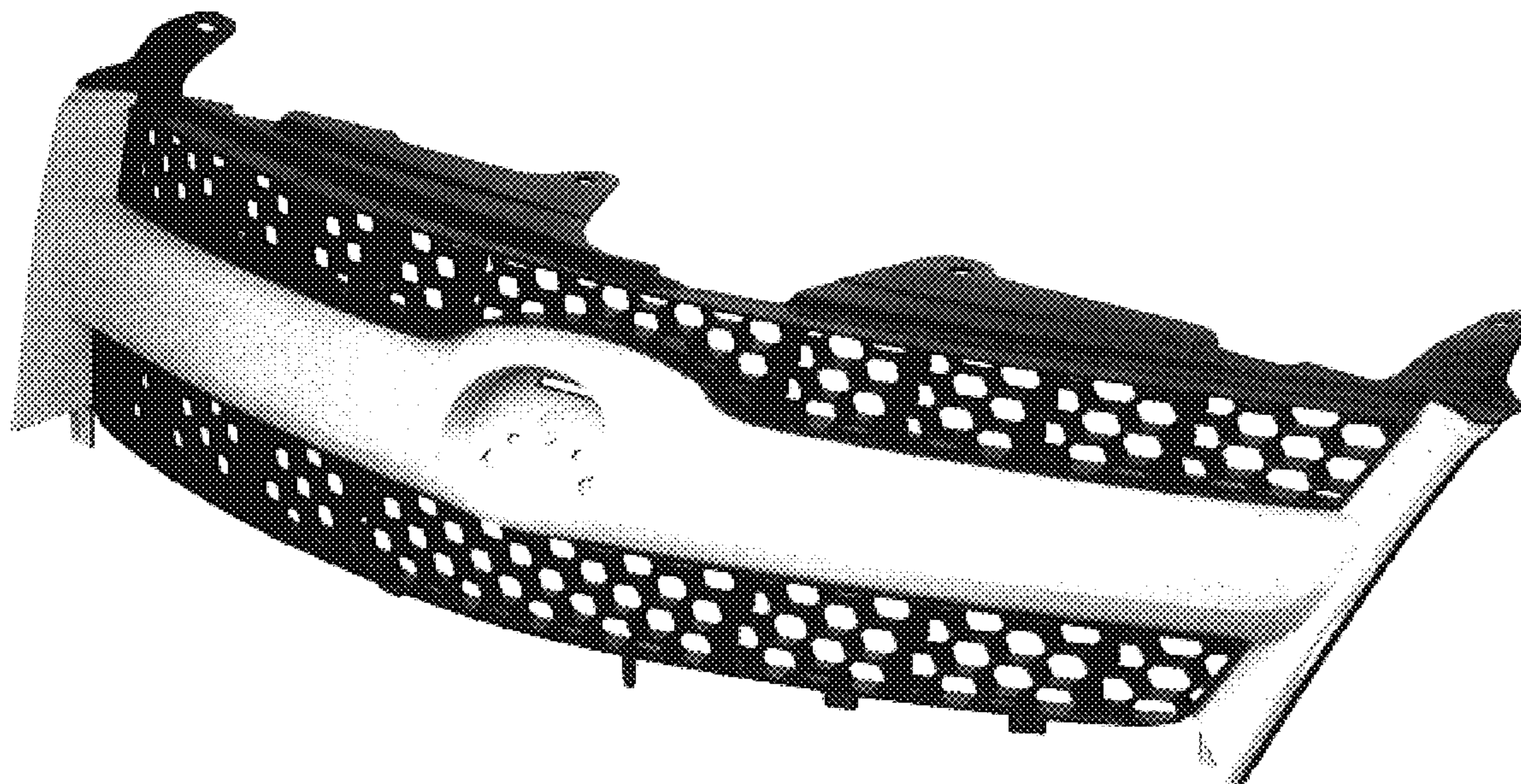
FIG. 3 is a rear view thereof;

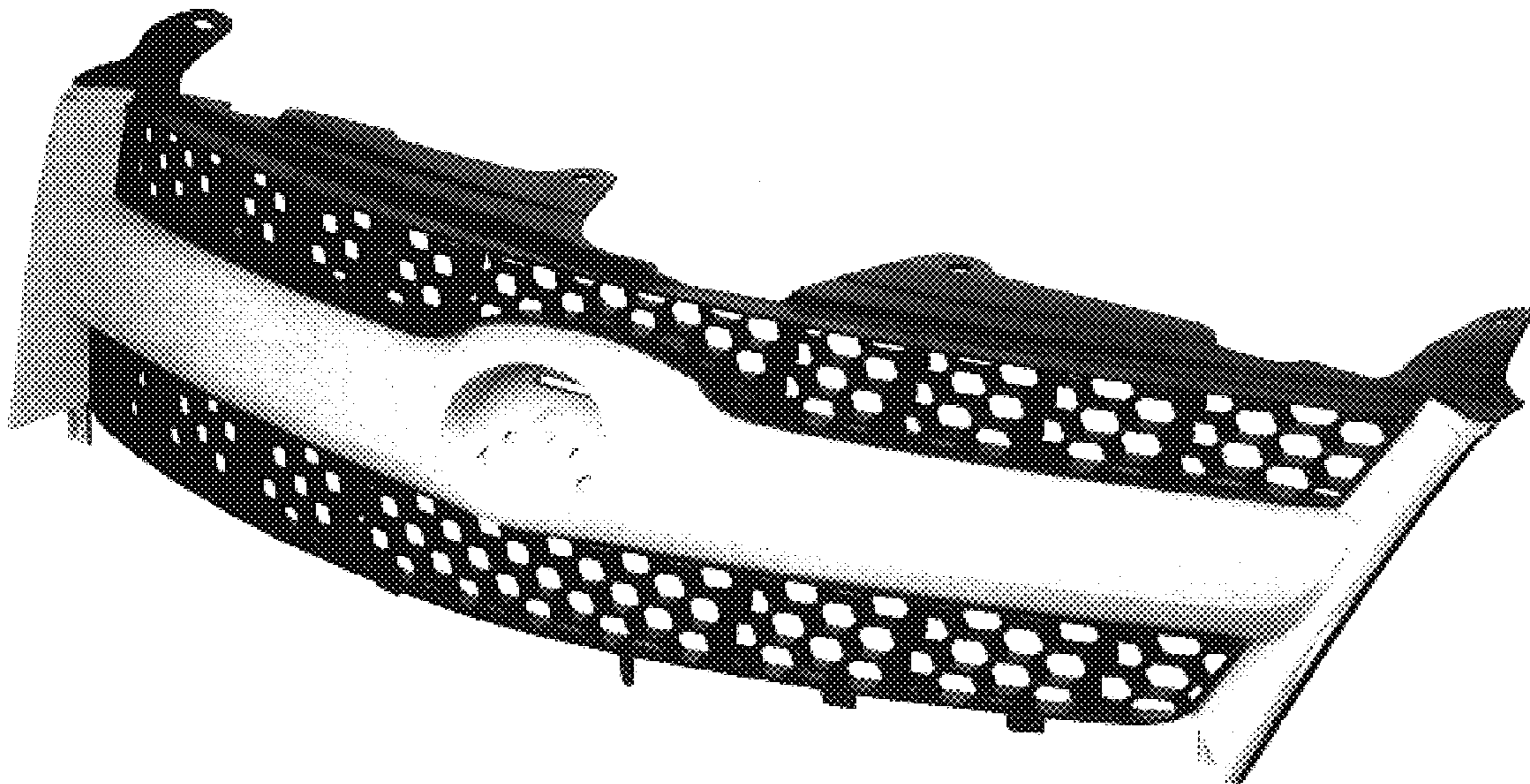
FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof; and,

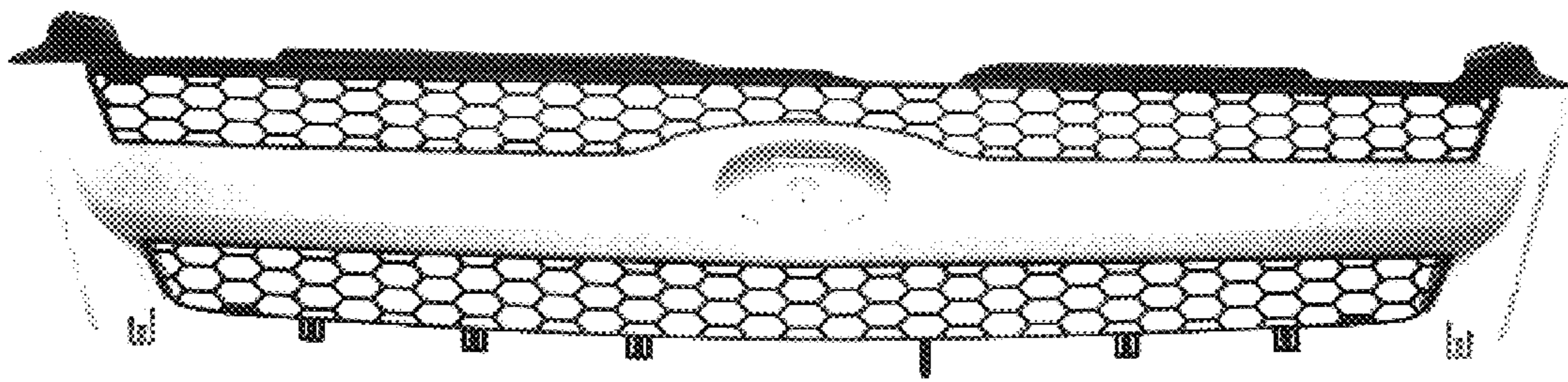
FIG. 6 is a right-side view of our new design, the left-side view being a mirror image thereof.

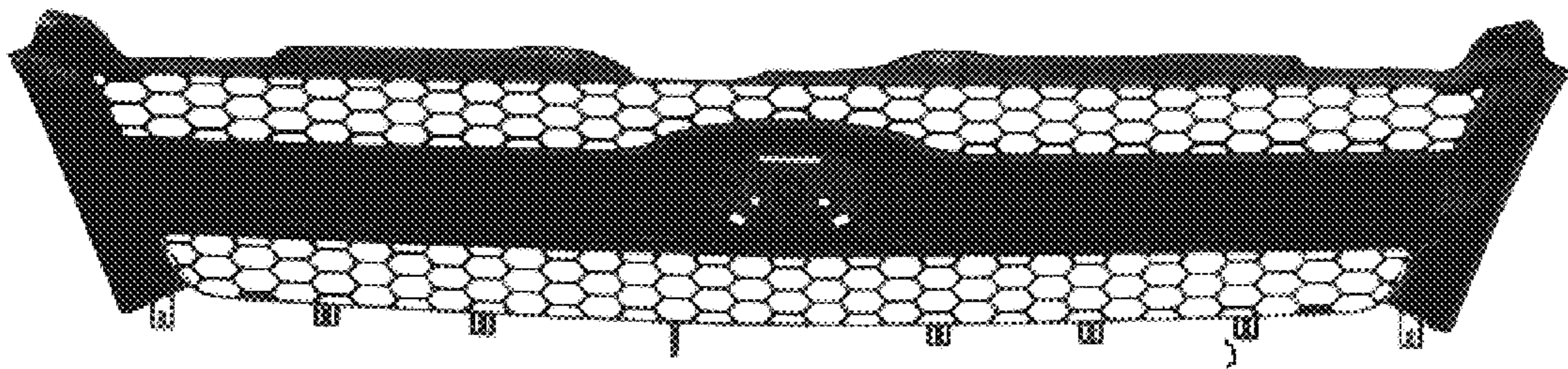




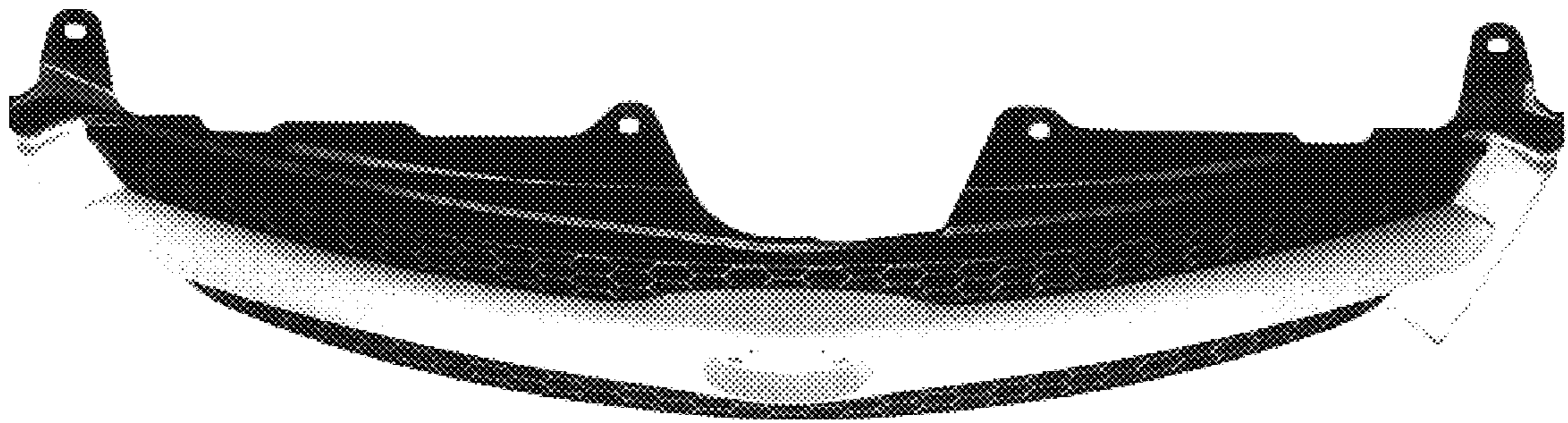

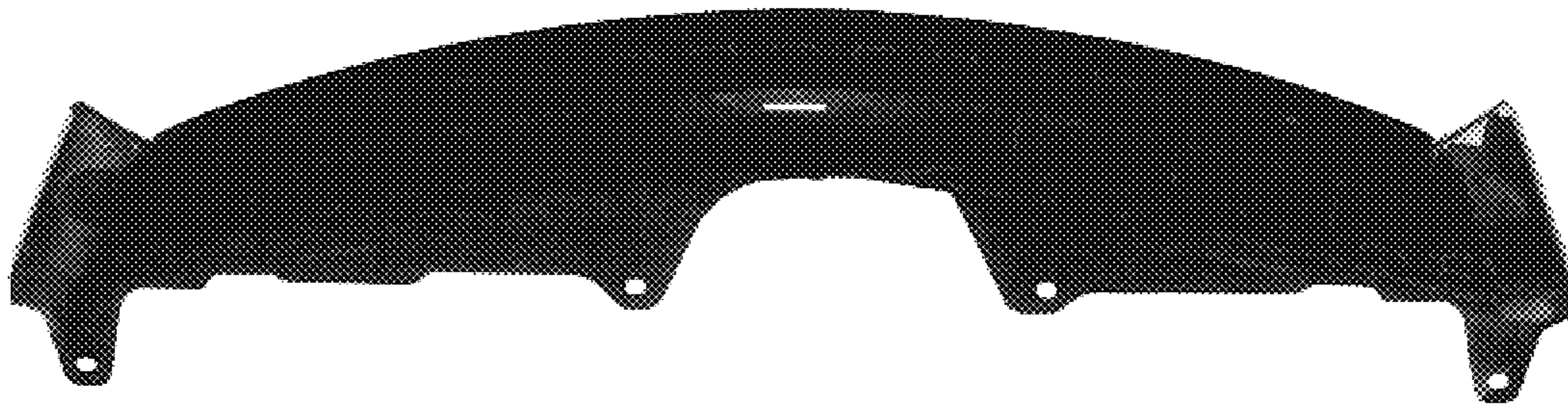

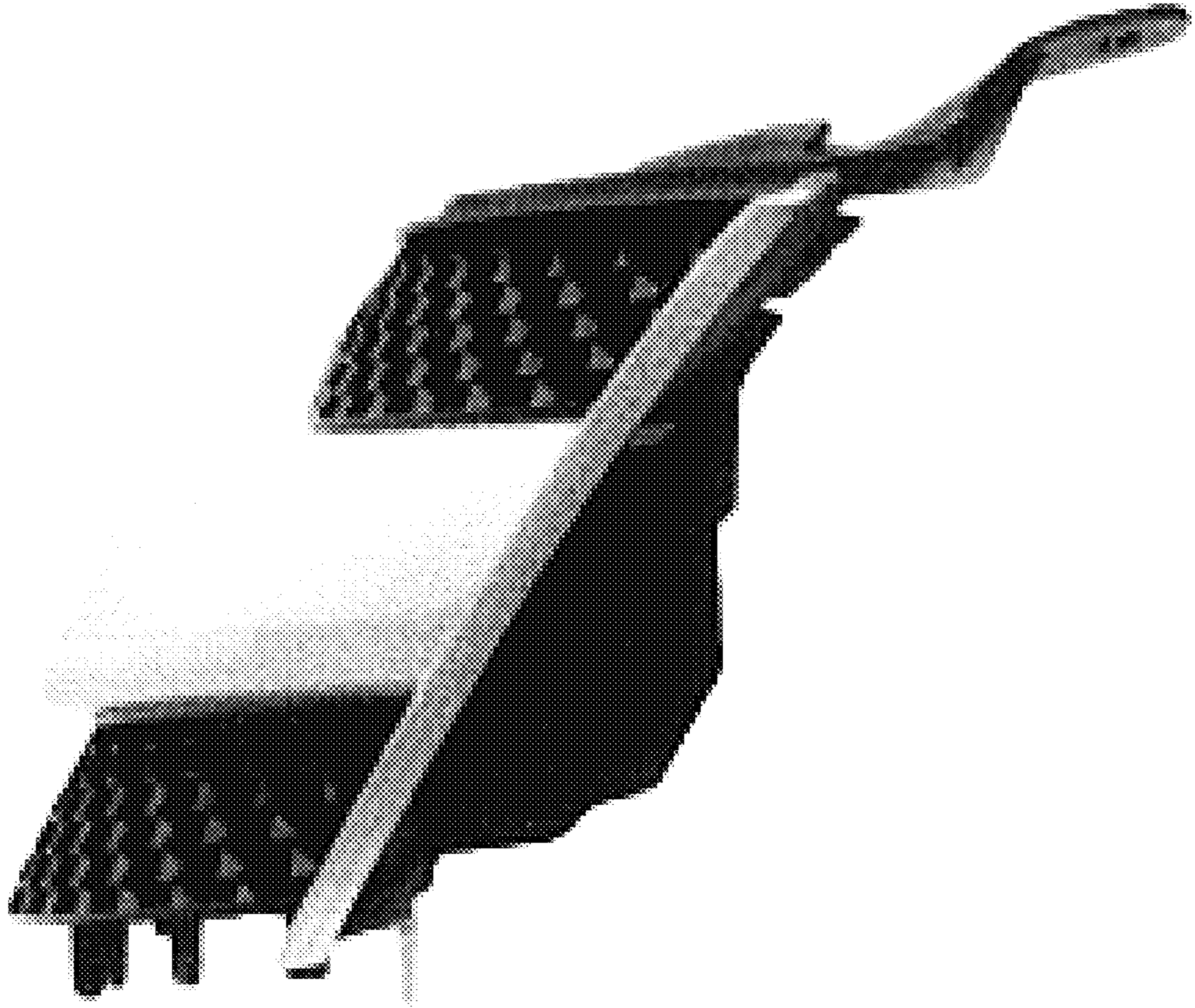

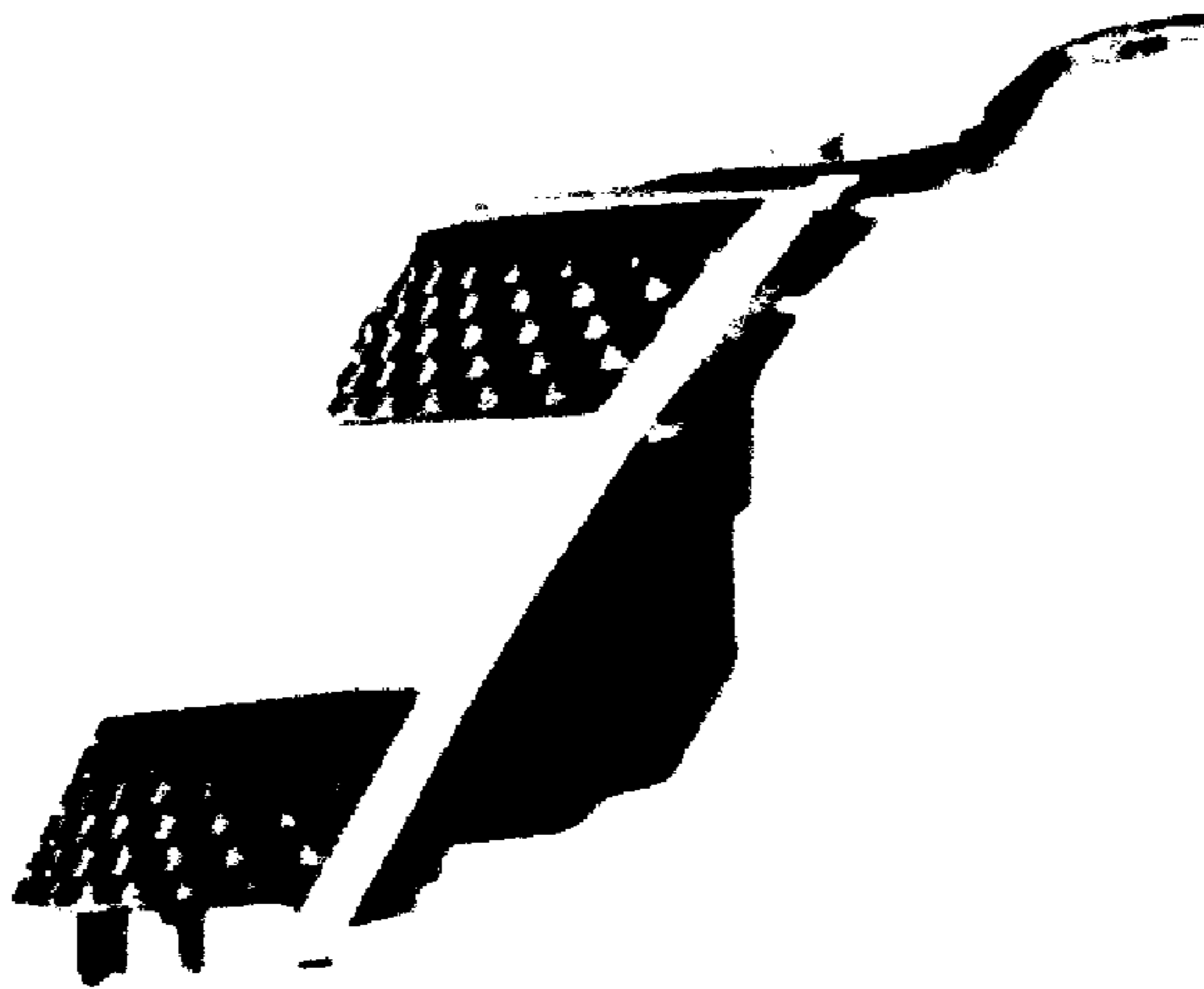
