DESCRIPTION

FIG. 4 is a front orthographic view thereof.

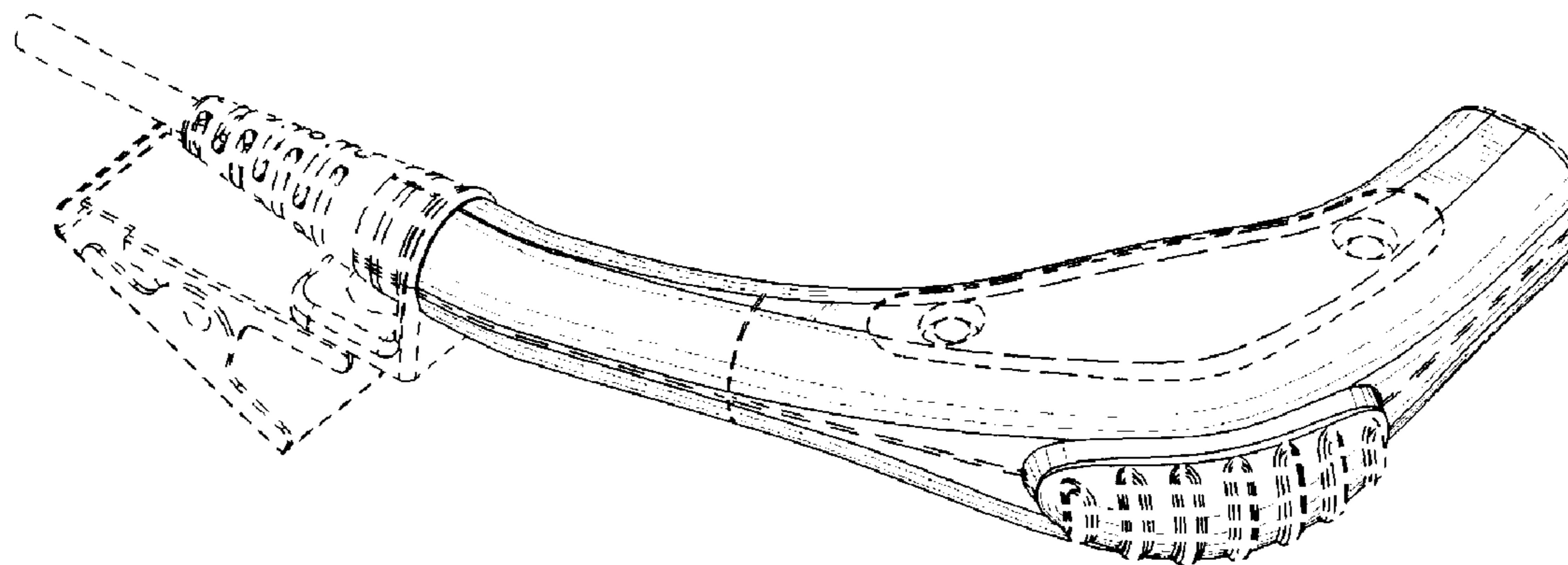
FIG. 5 is a rear orthographic view thereof.

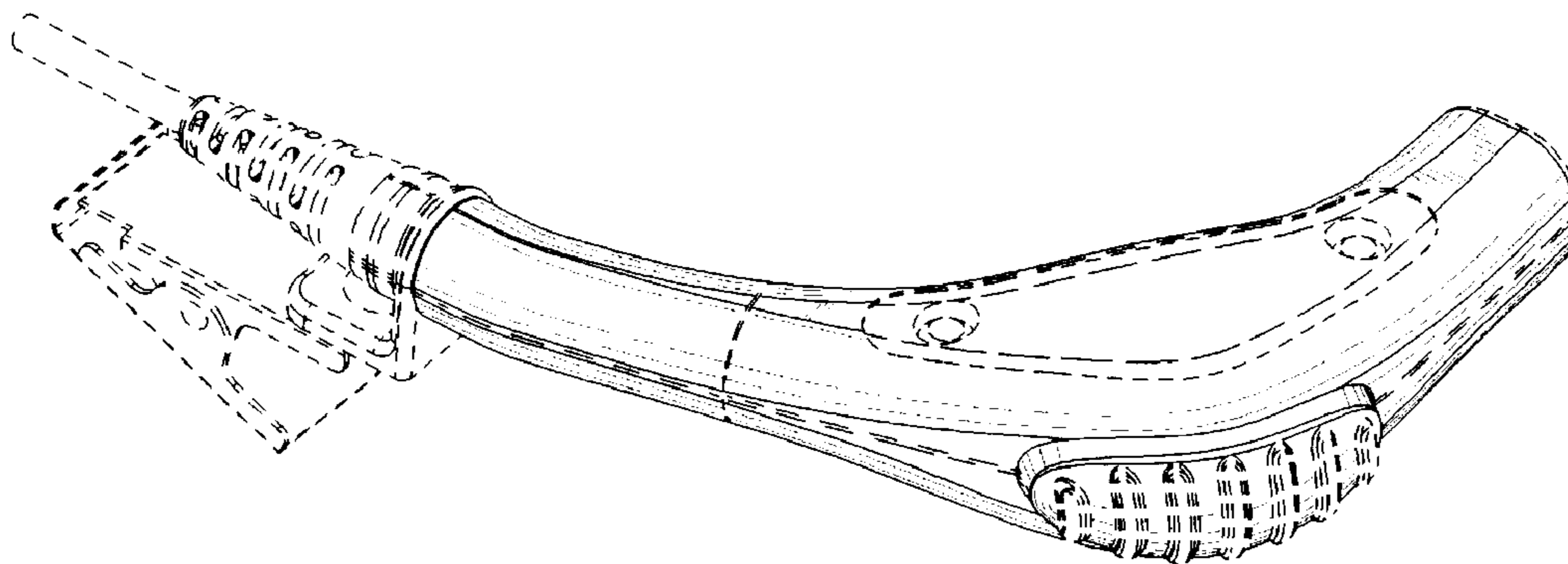

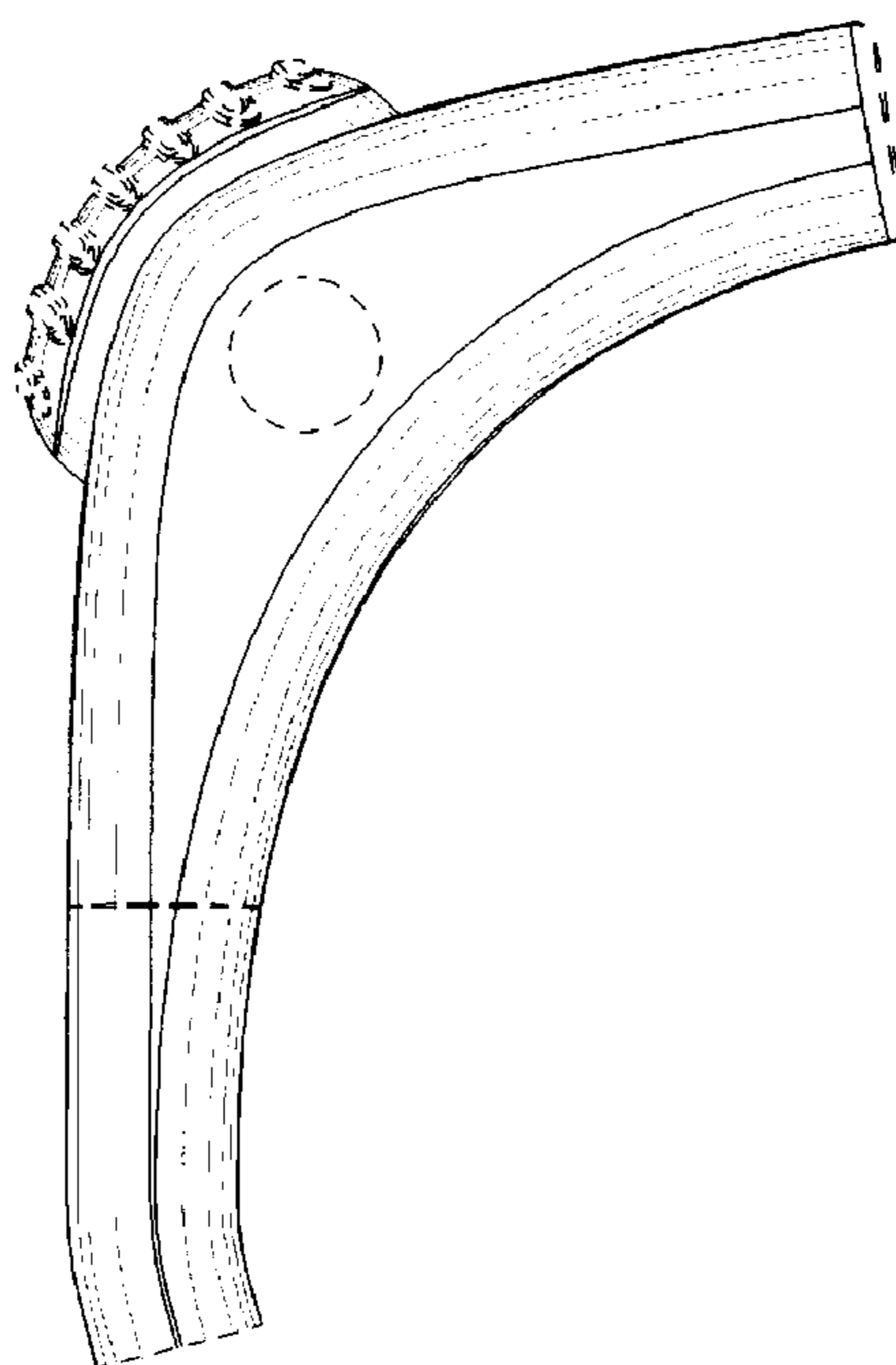

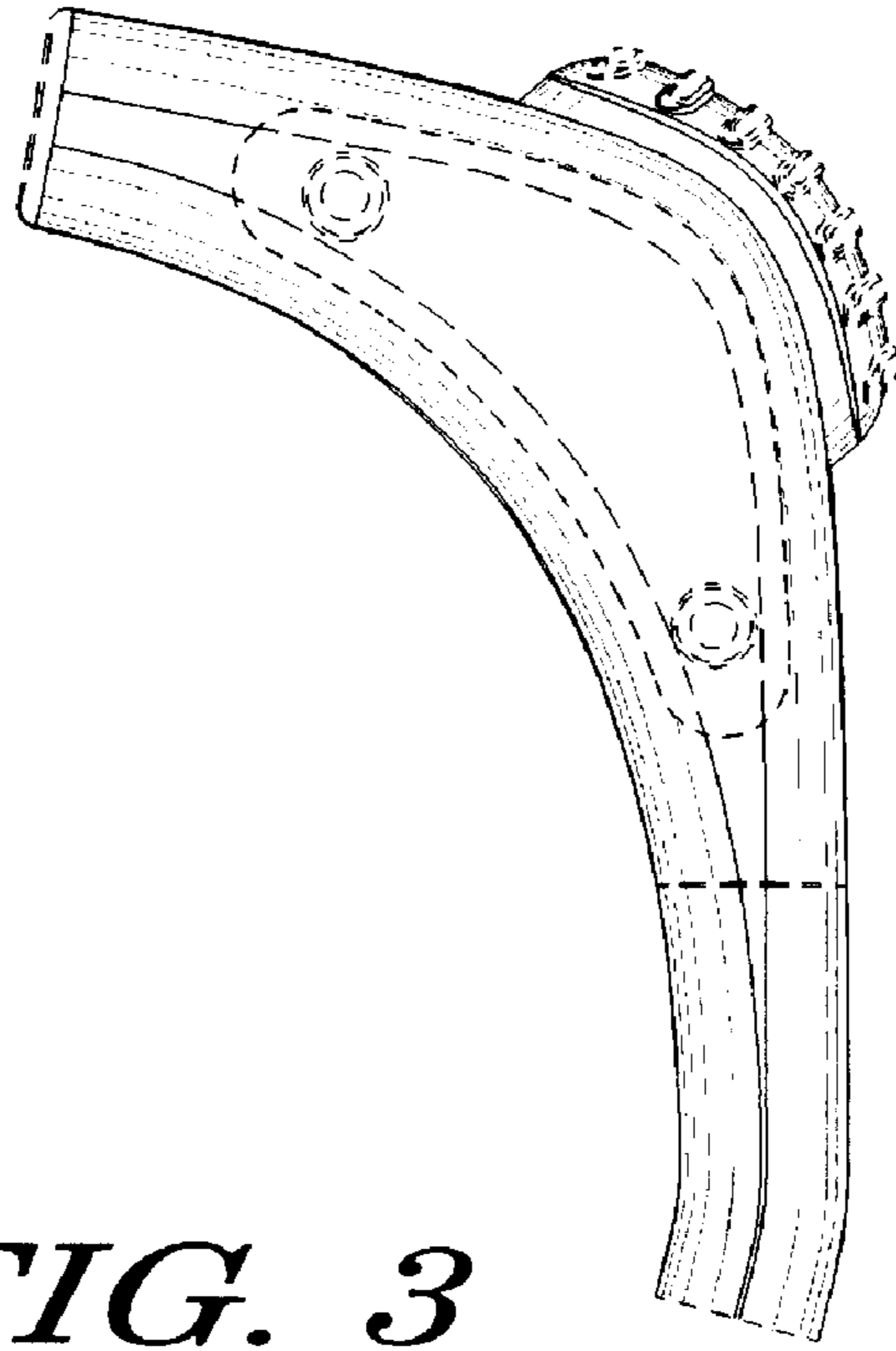

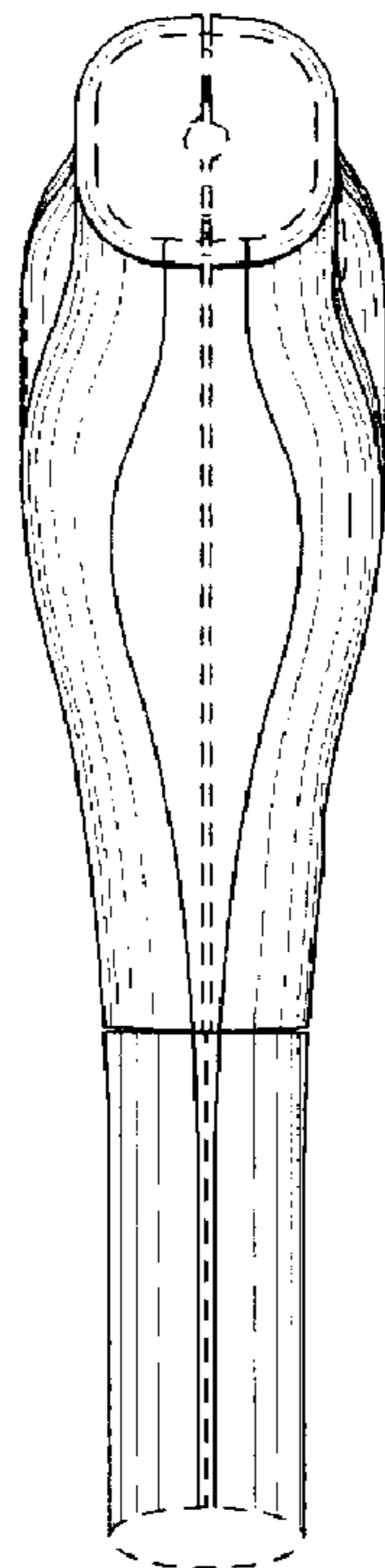

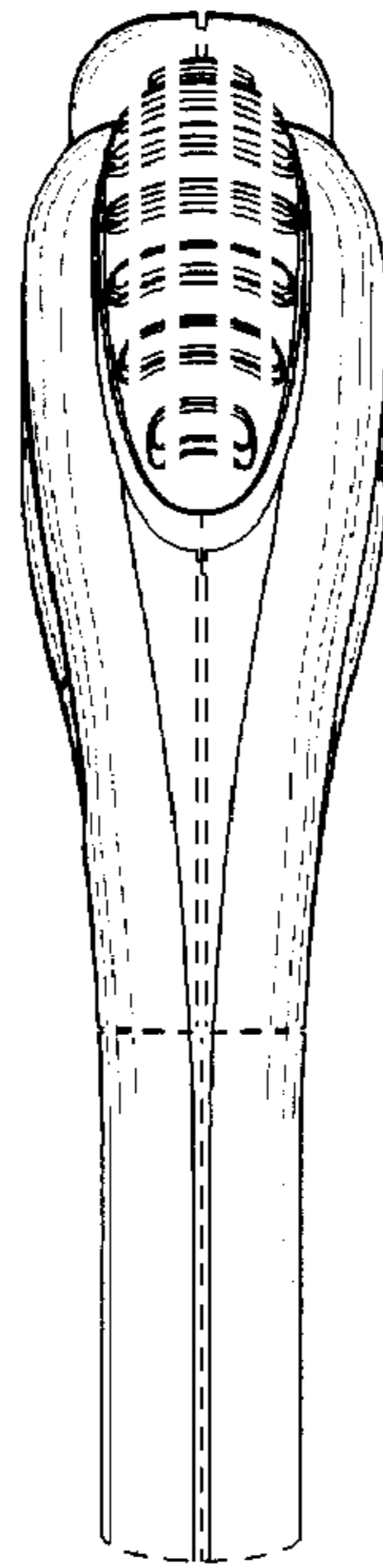

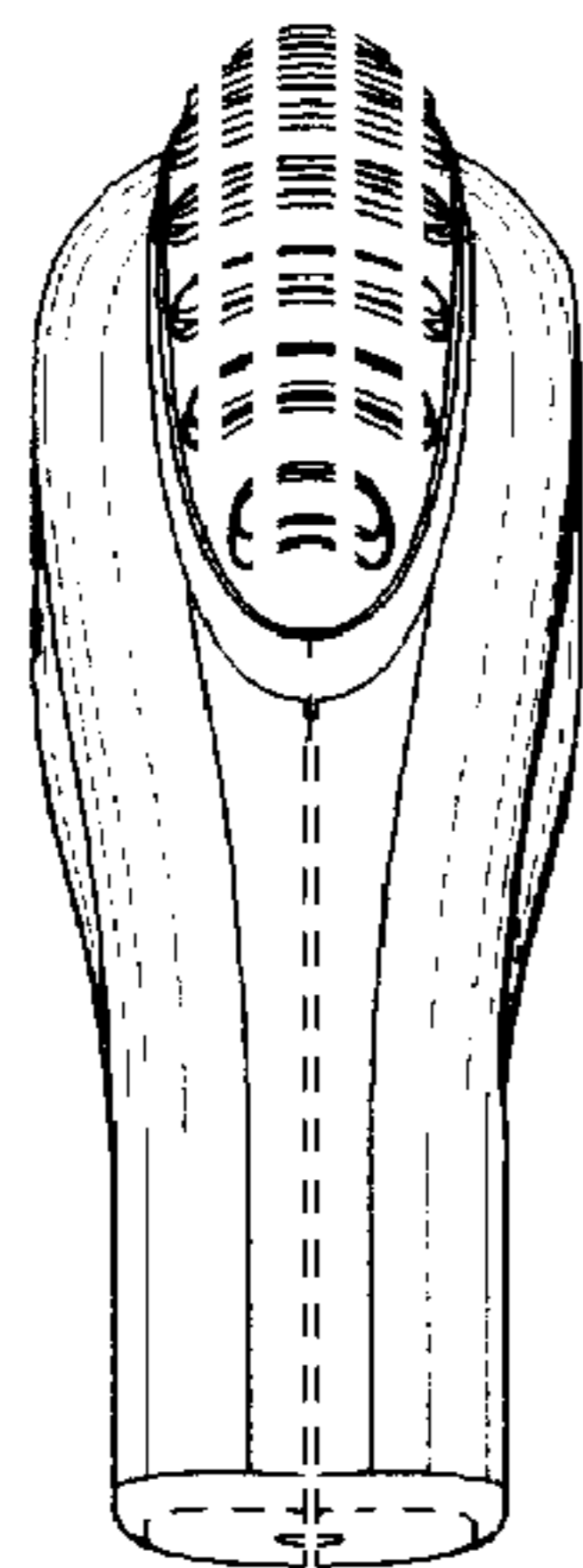

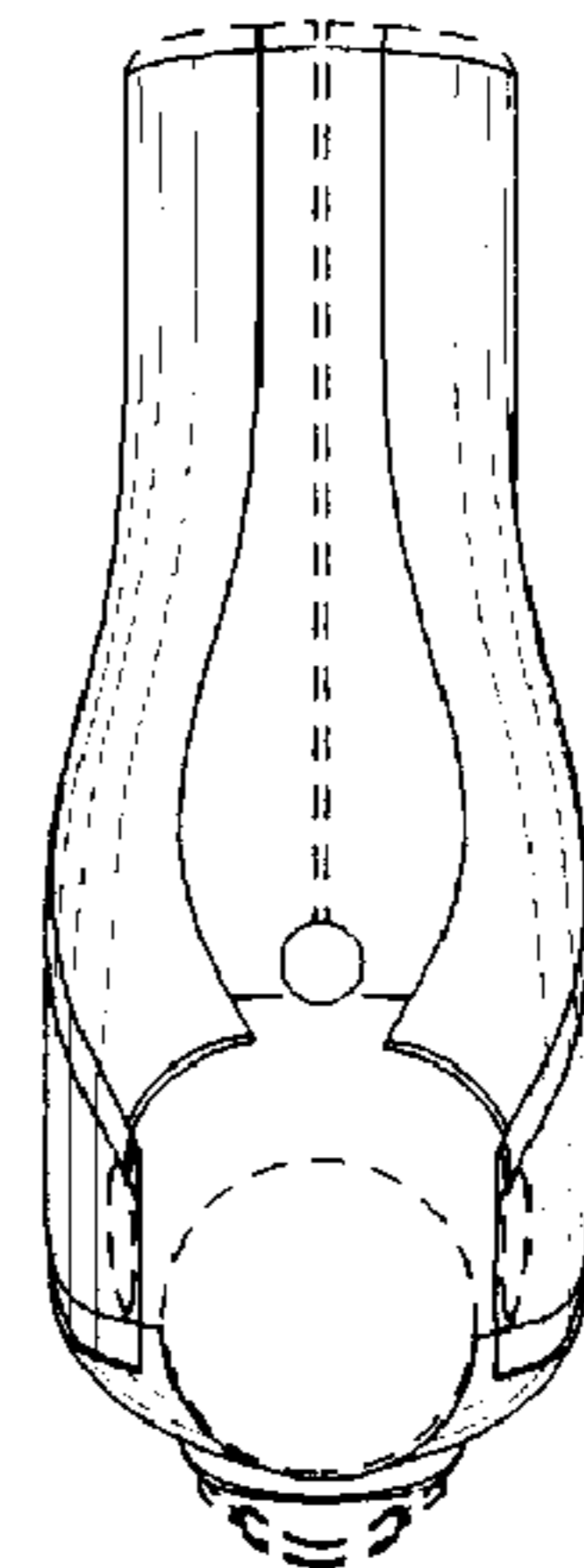
