The ornamental design for an animated image for a portion of a display screen, as shown and described.

**DESCRIPTION**

FIG. 23 is a front view of the eighth image thereof, on an enlarged scale, the image is shown separately for clarity of illustration;

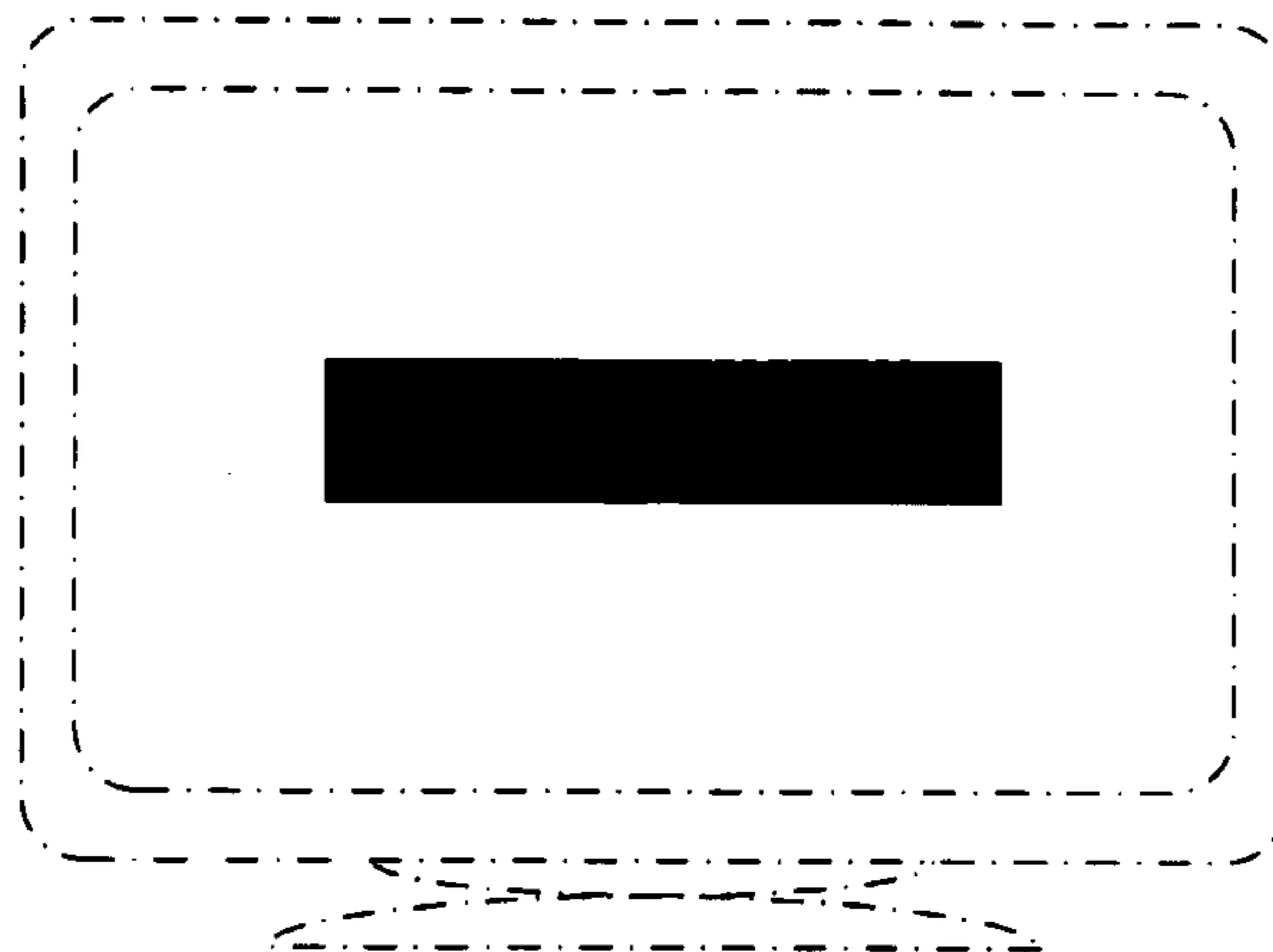


FIG. **24** is a front view of the ninth image thereof, on an enlarged scale, the image is shown separately for clarity of illustration;

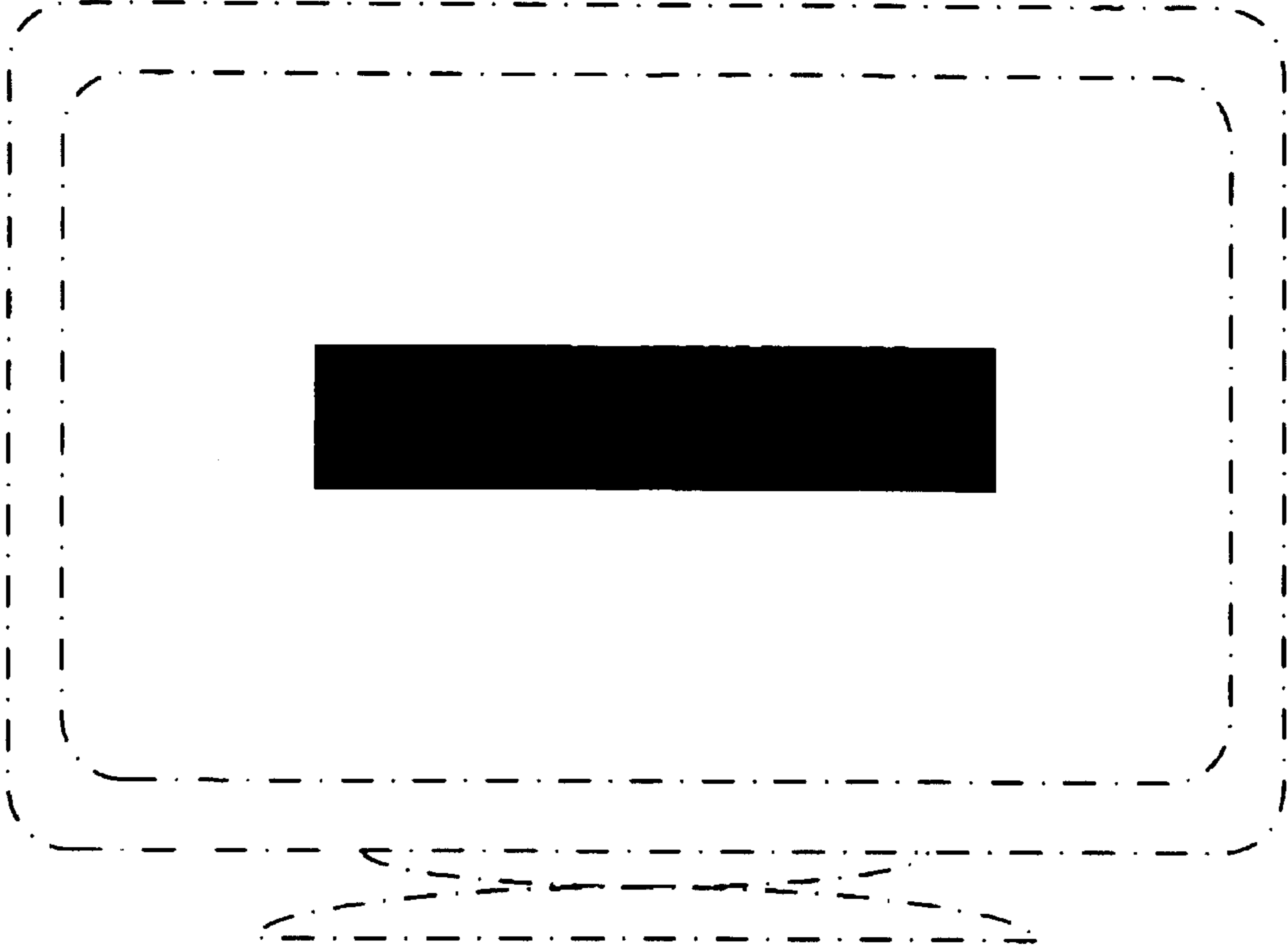

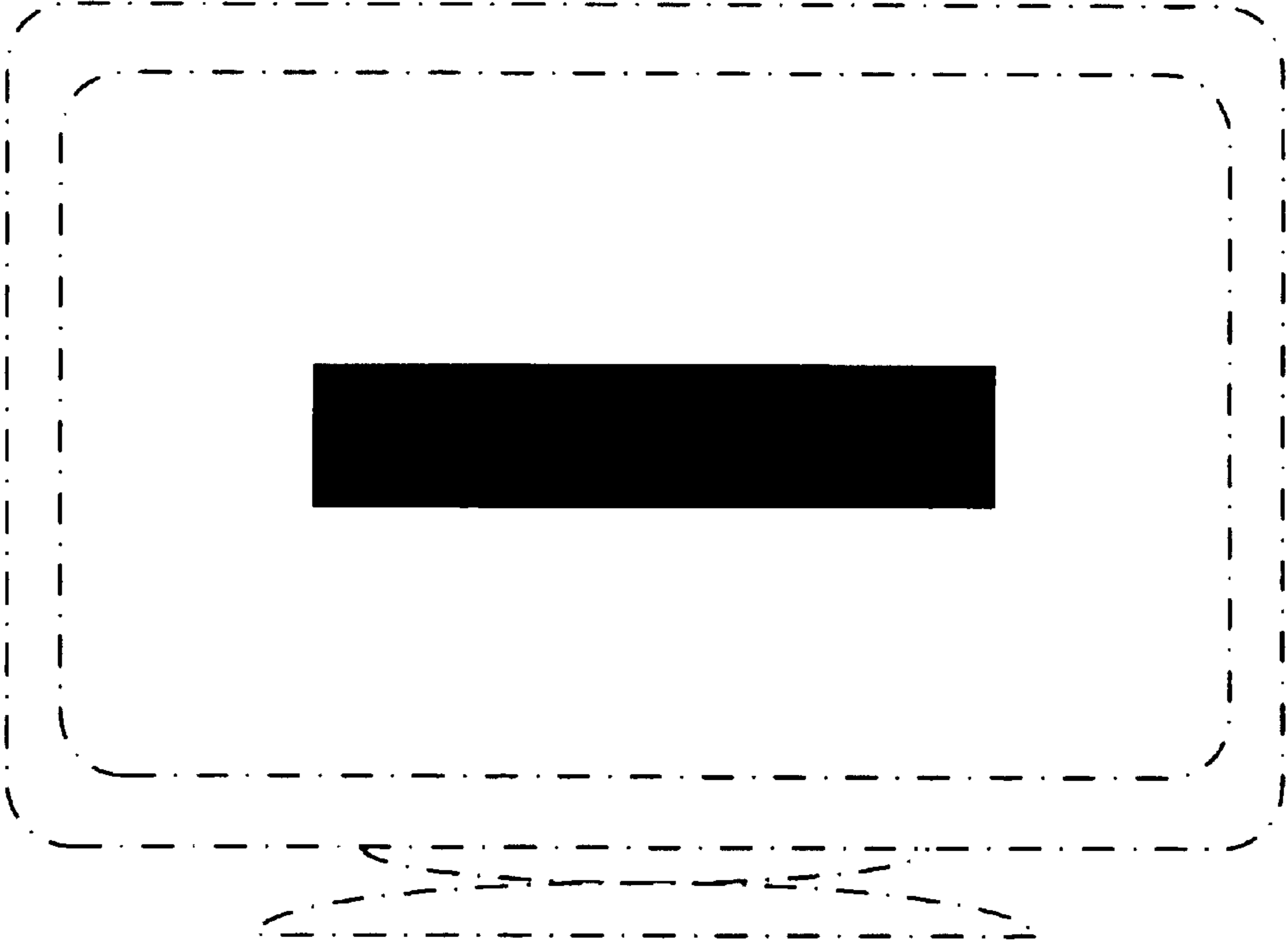

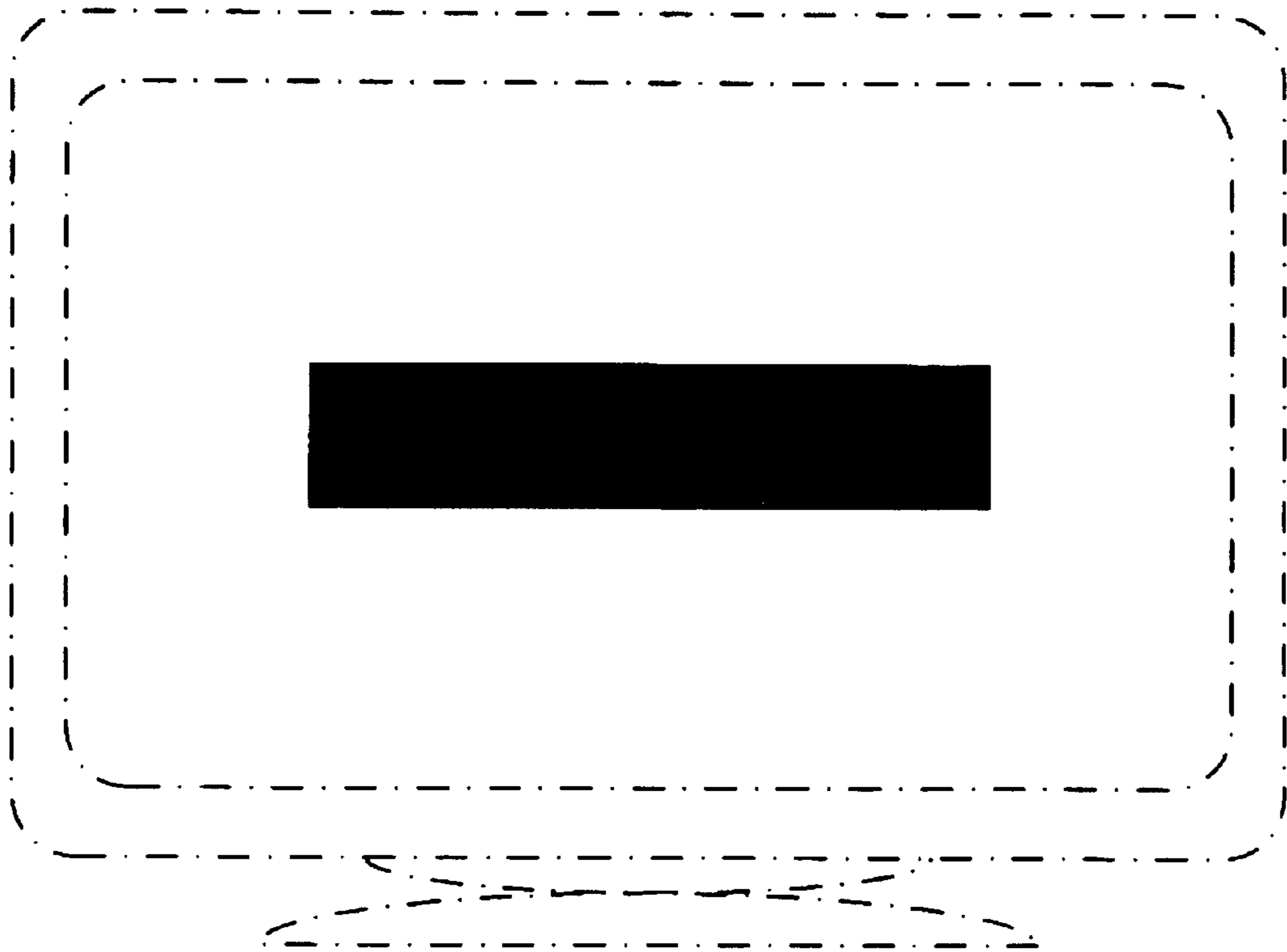

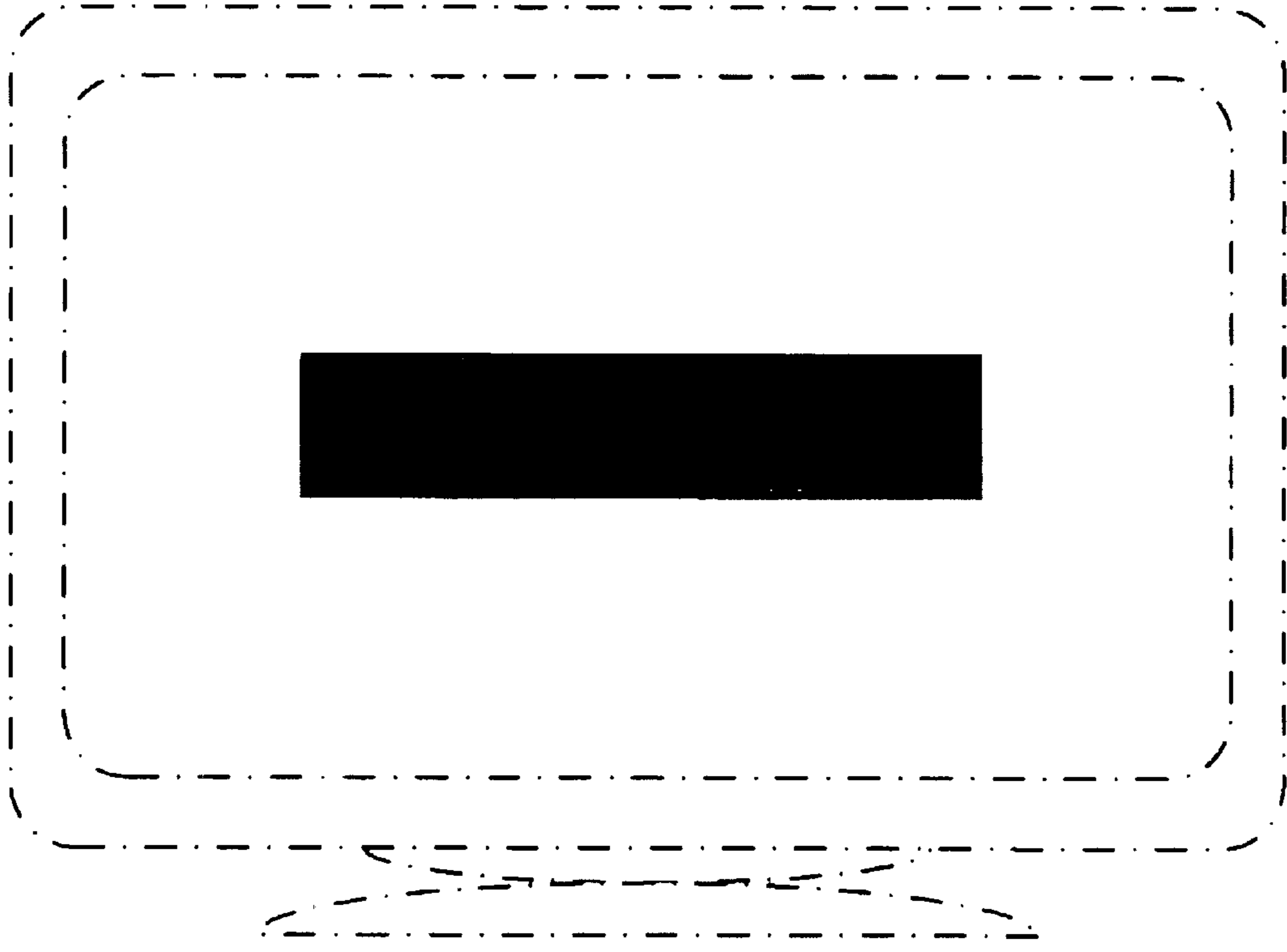

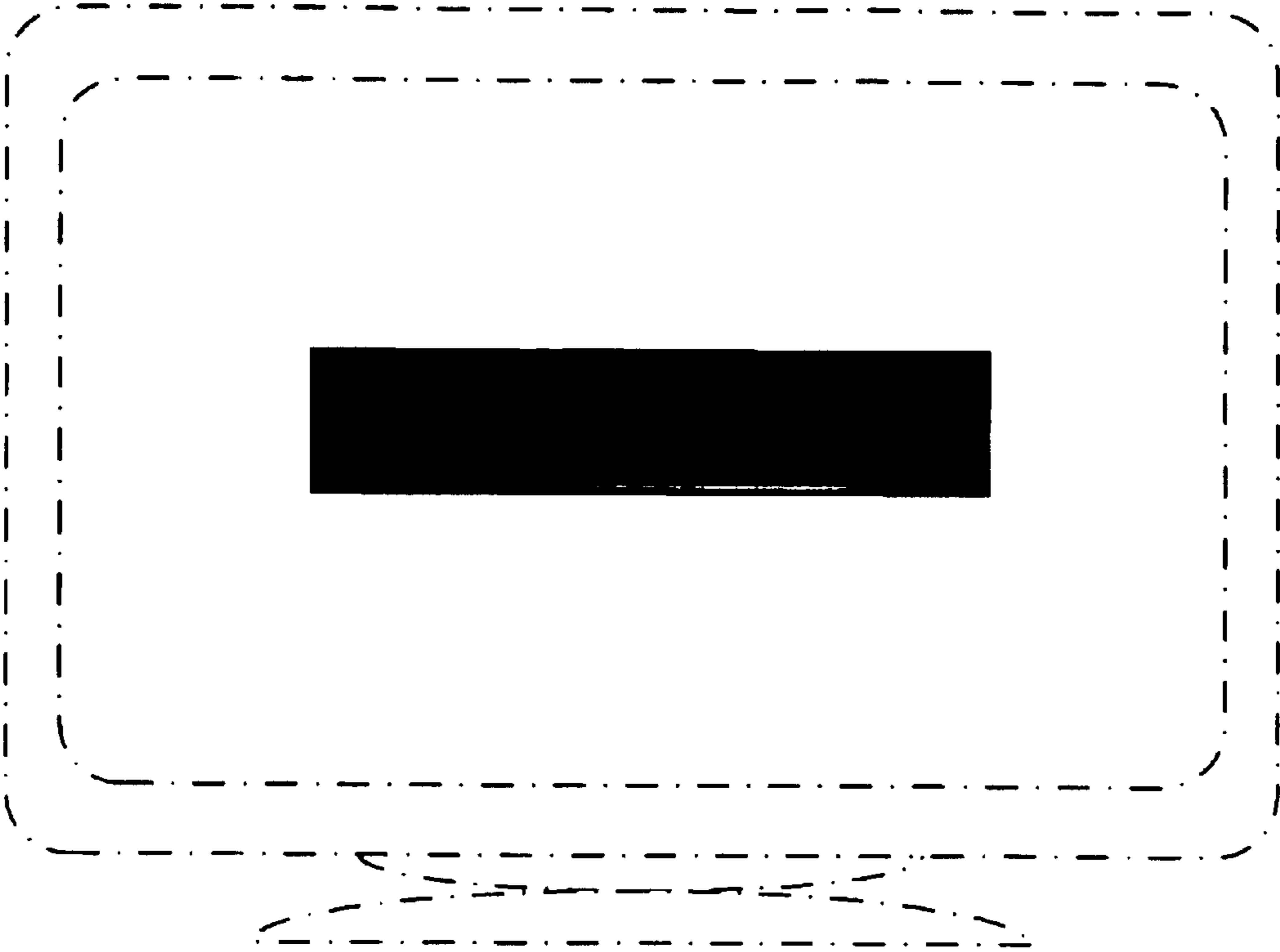

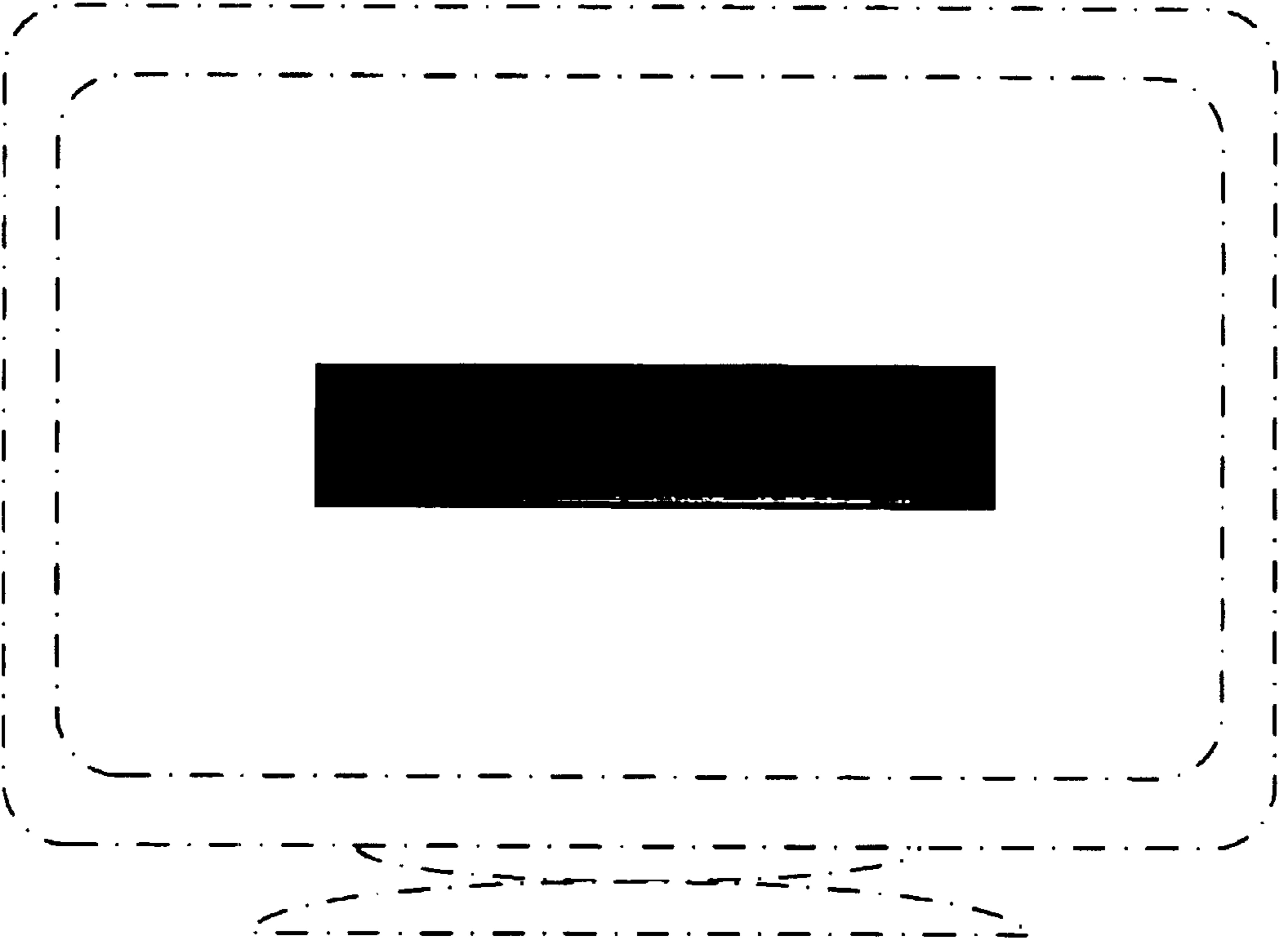

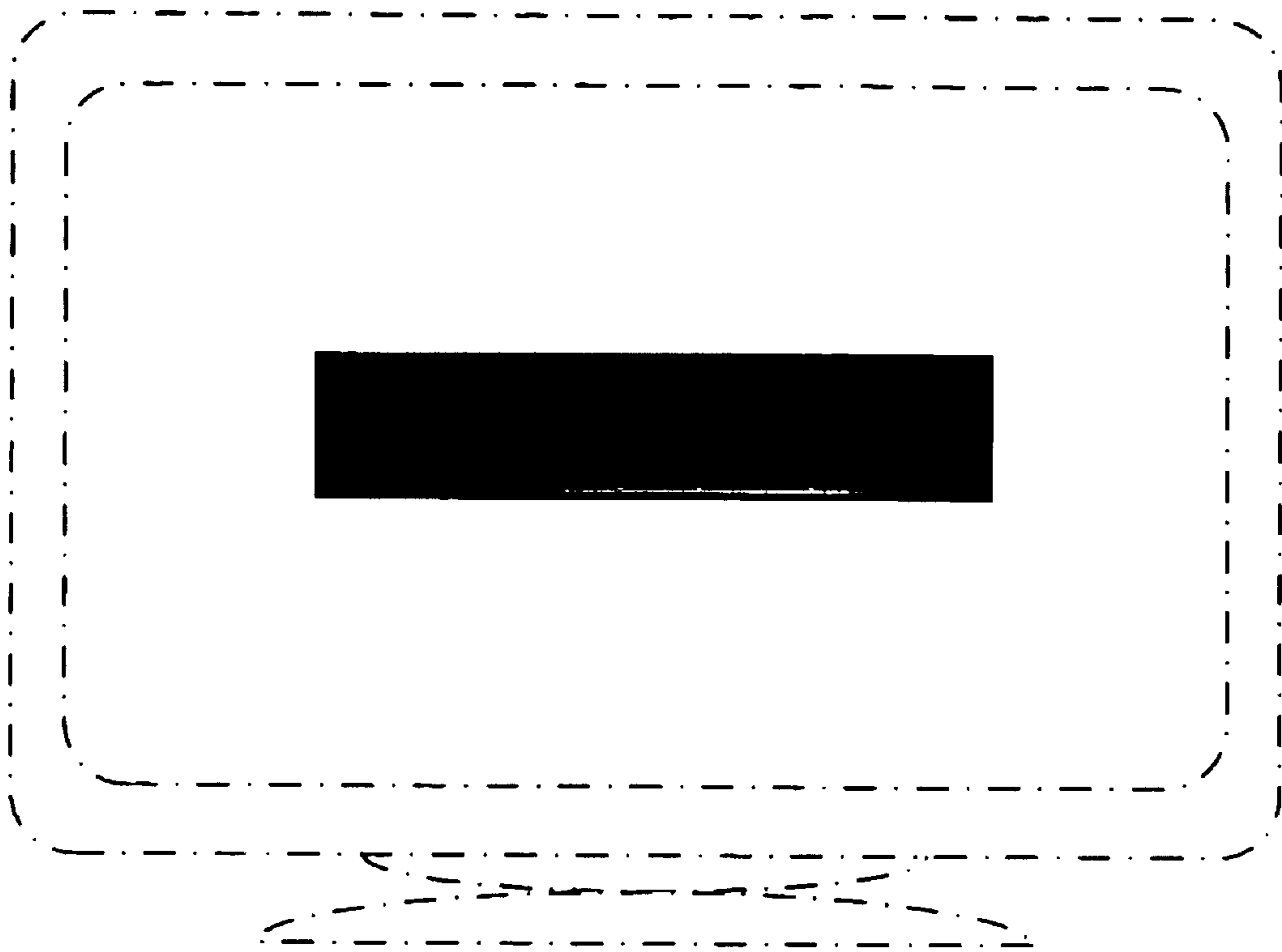

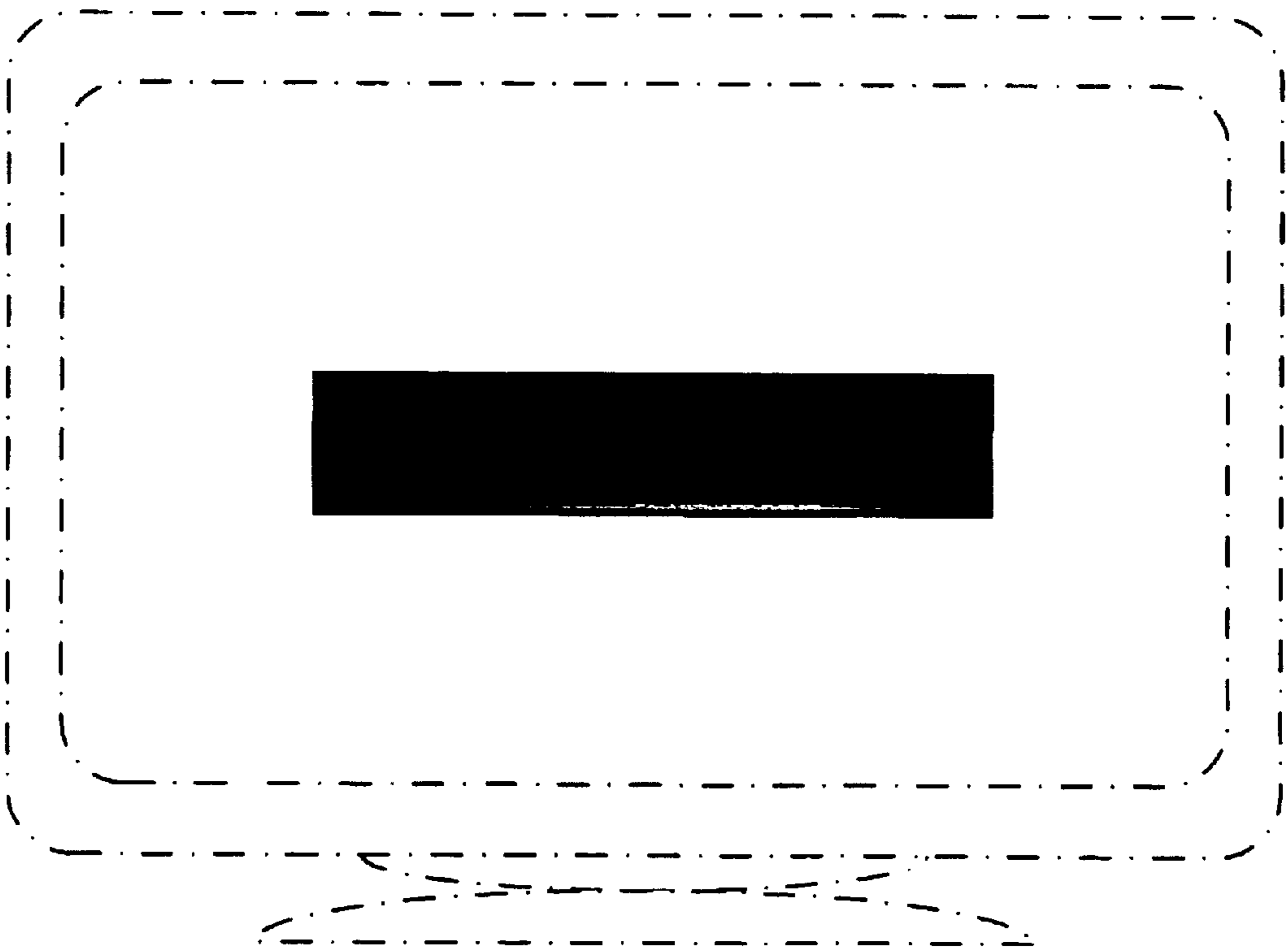

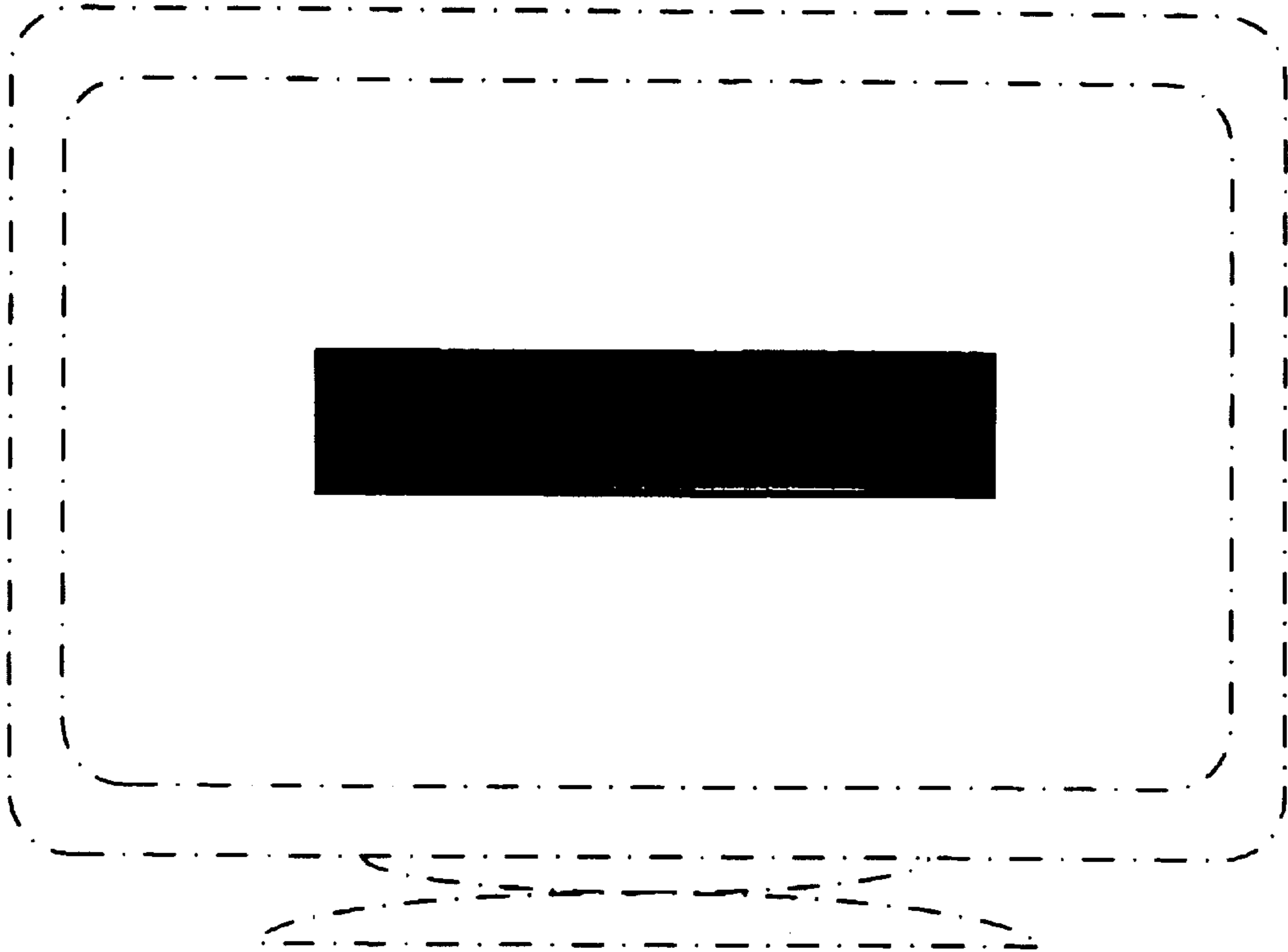

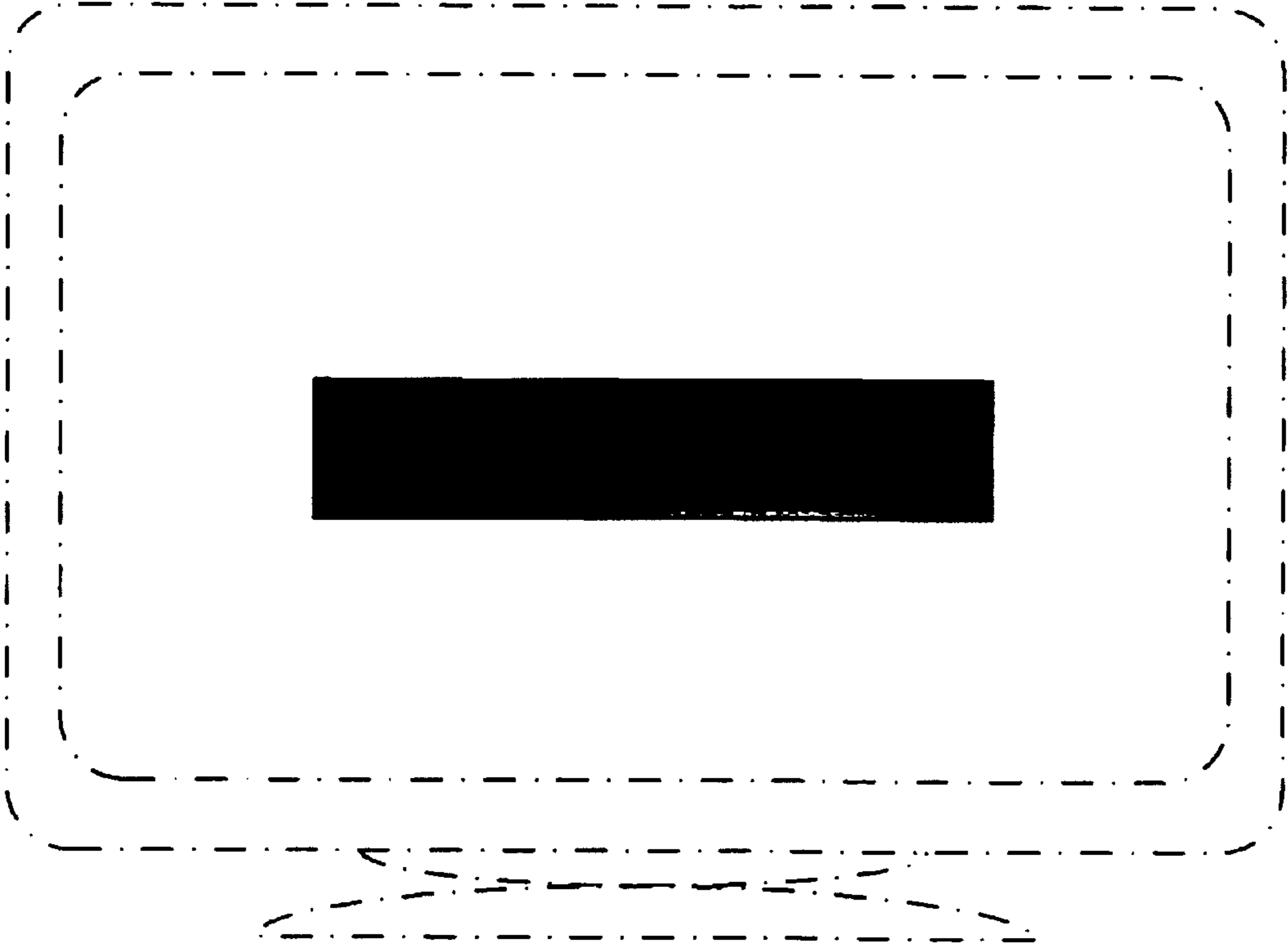

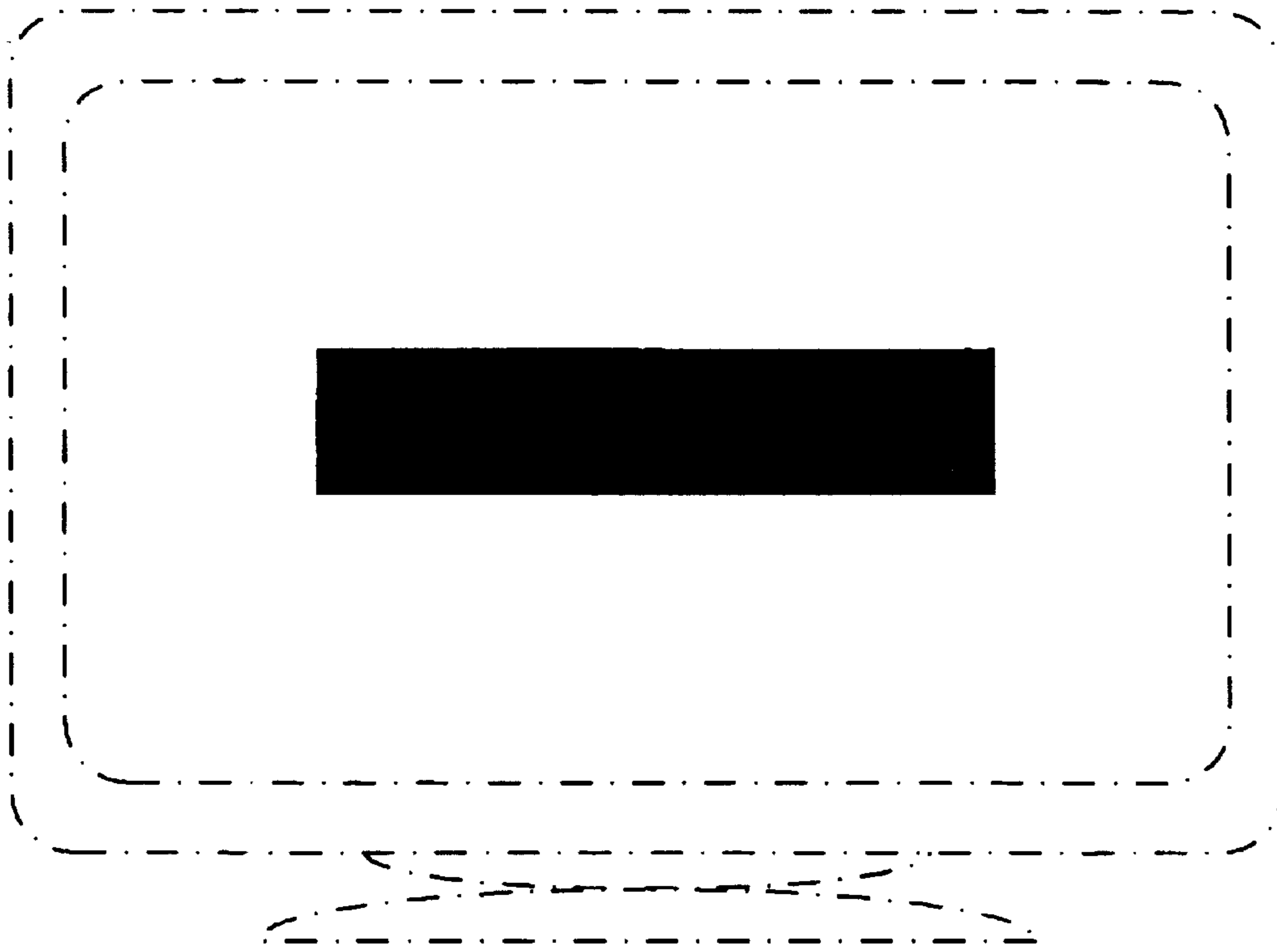

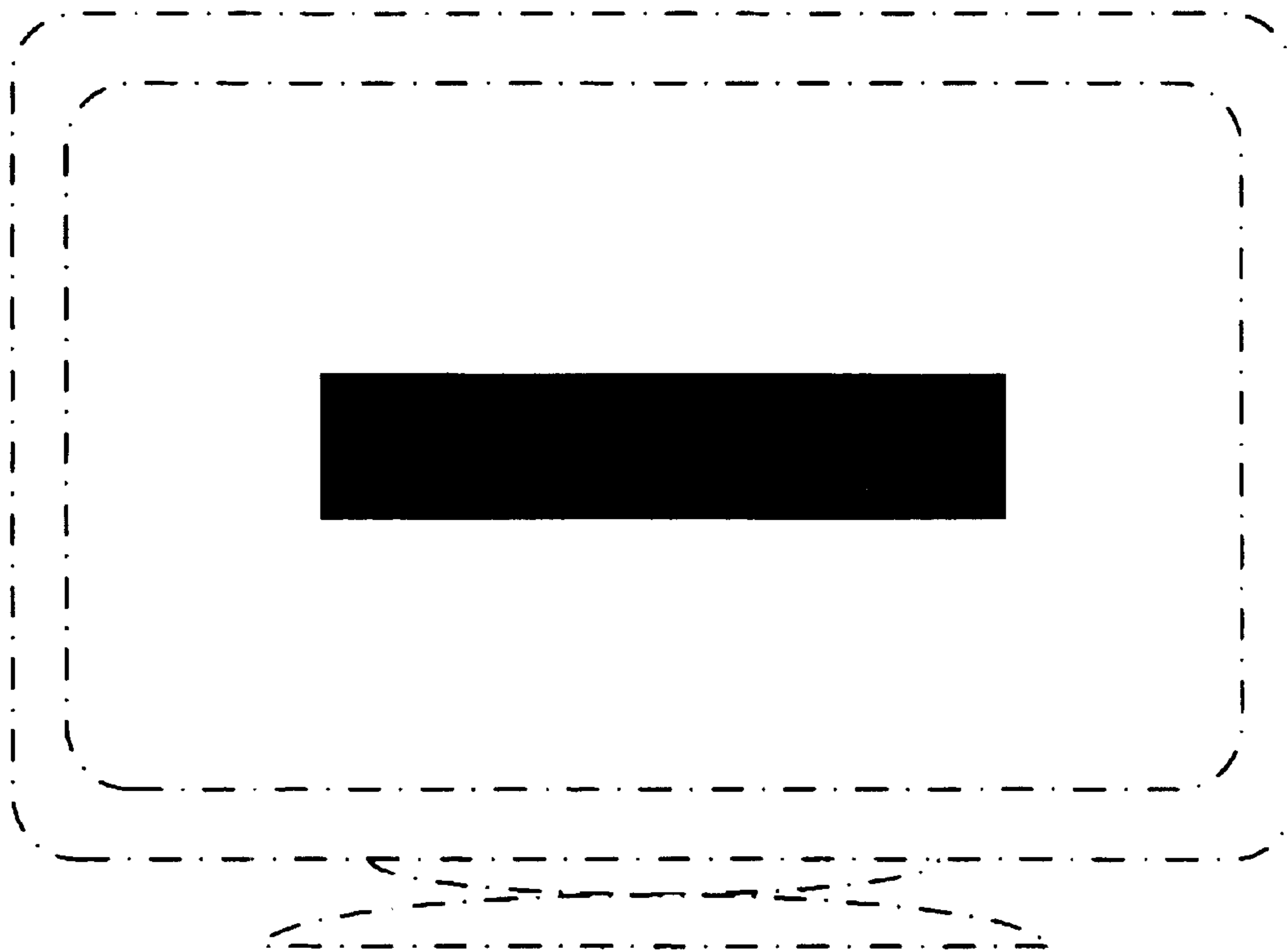

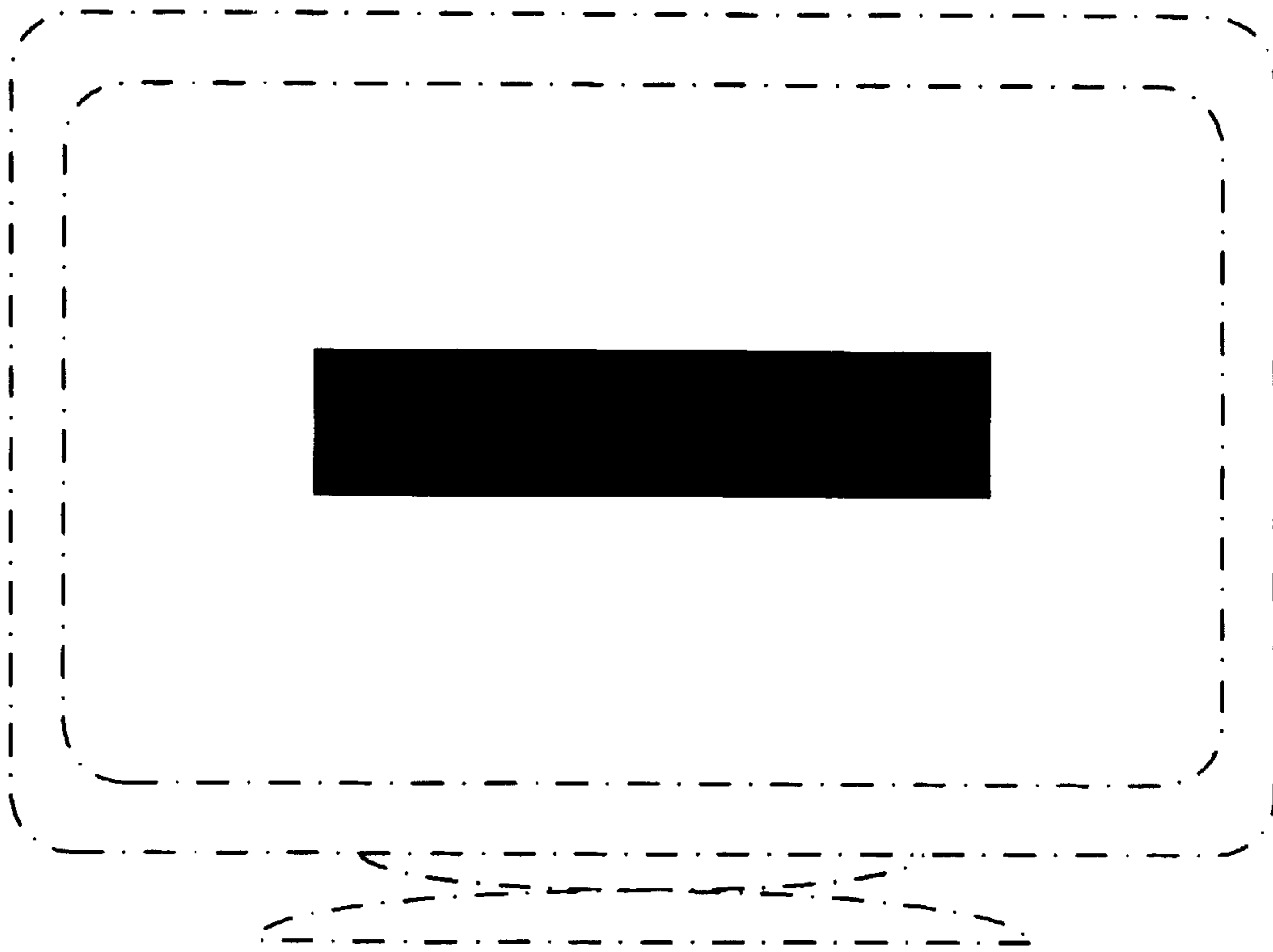

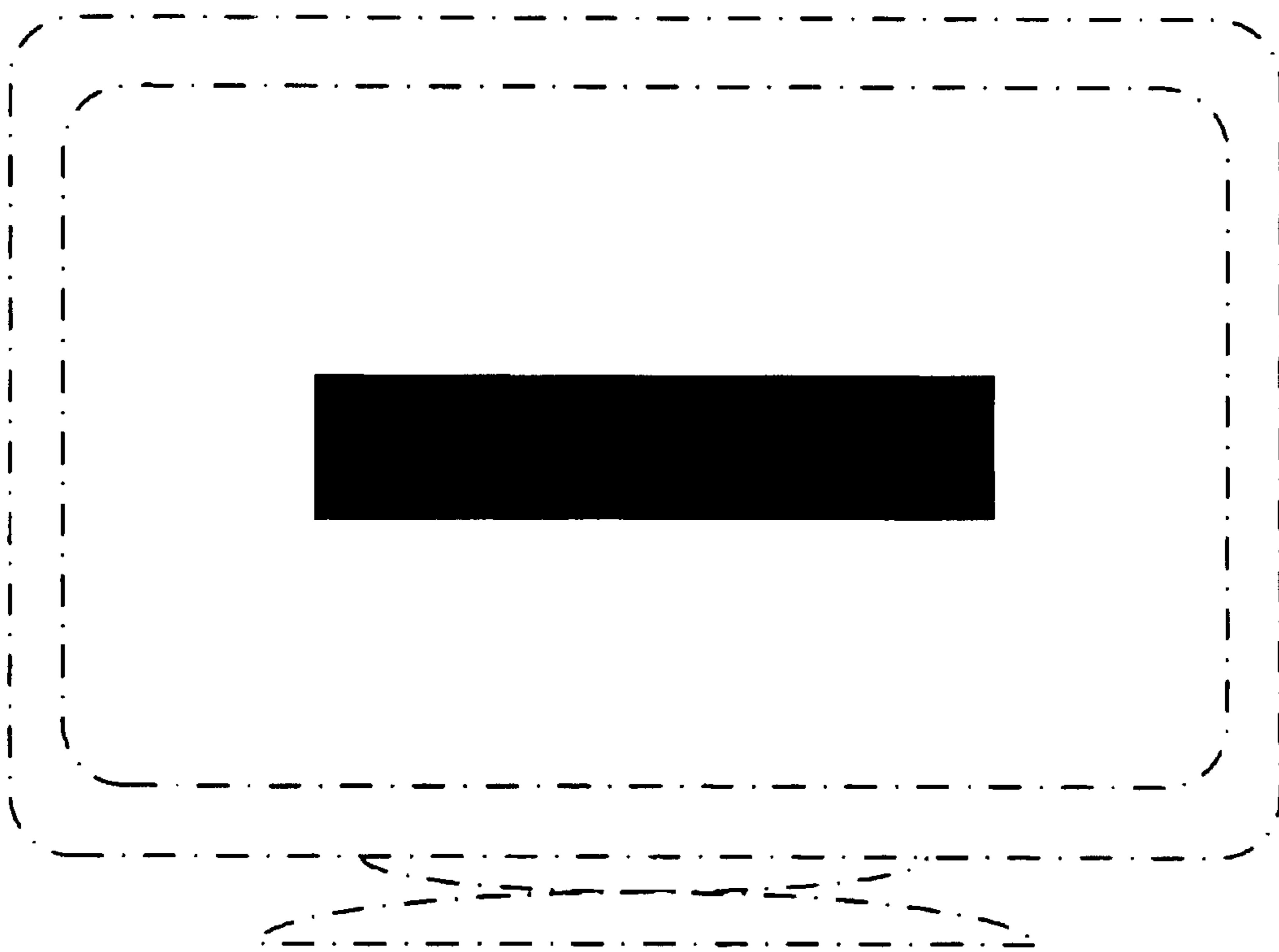

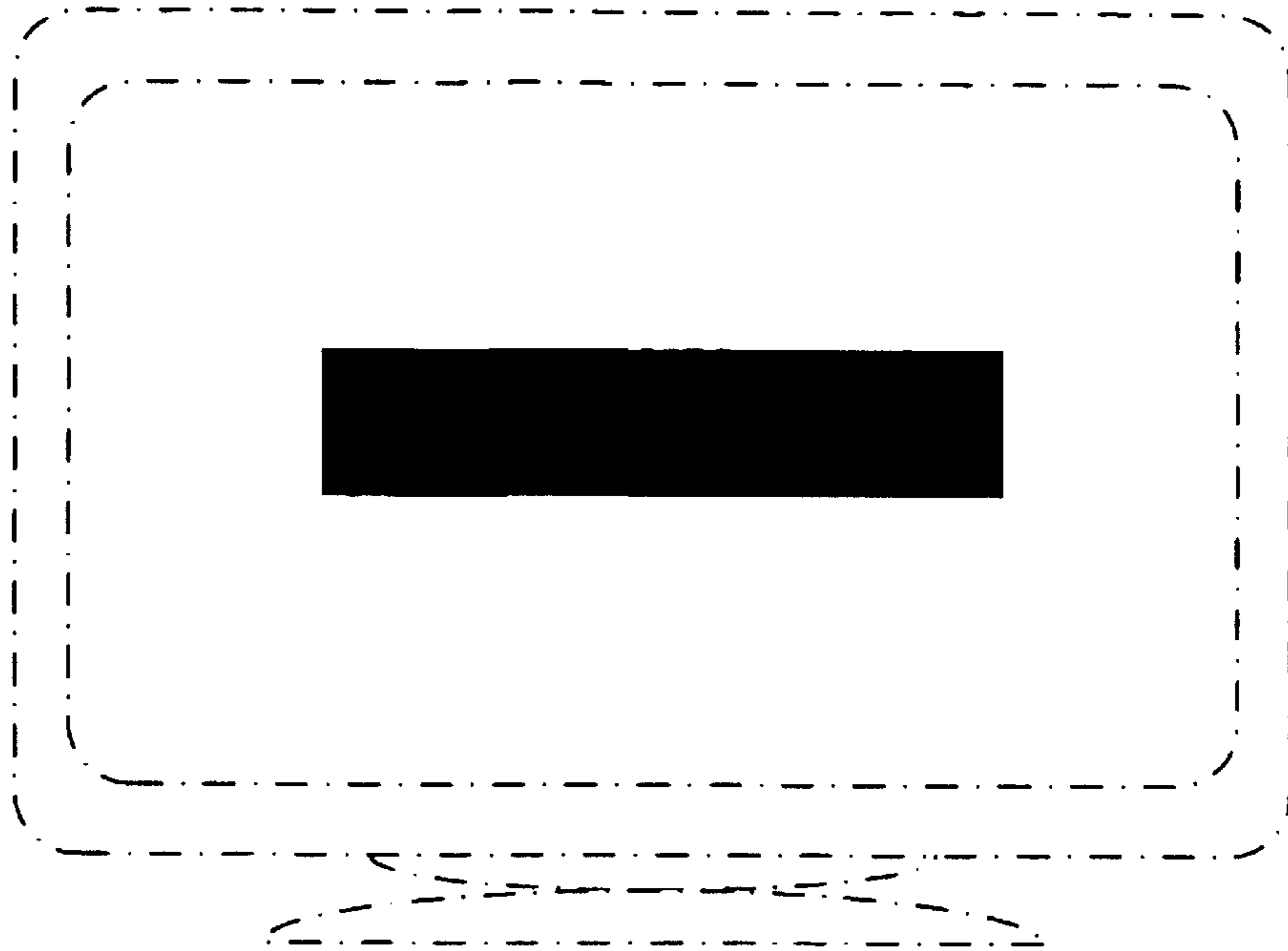

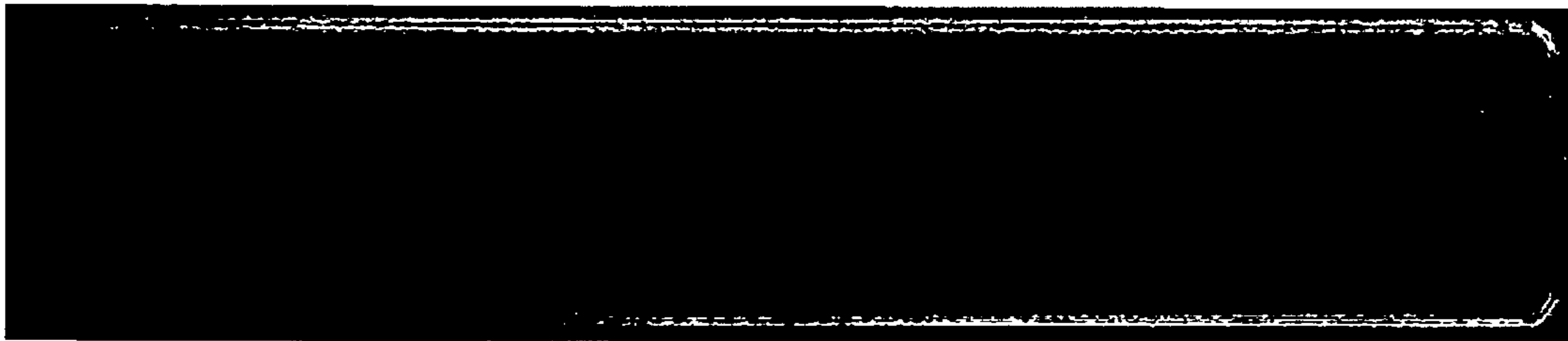

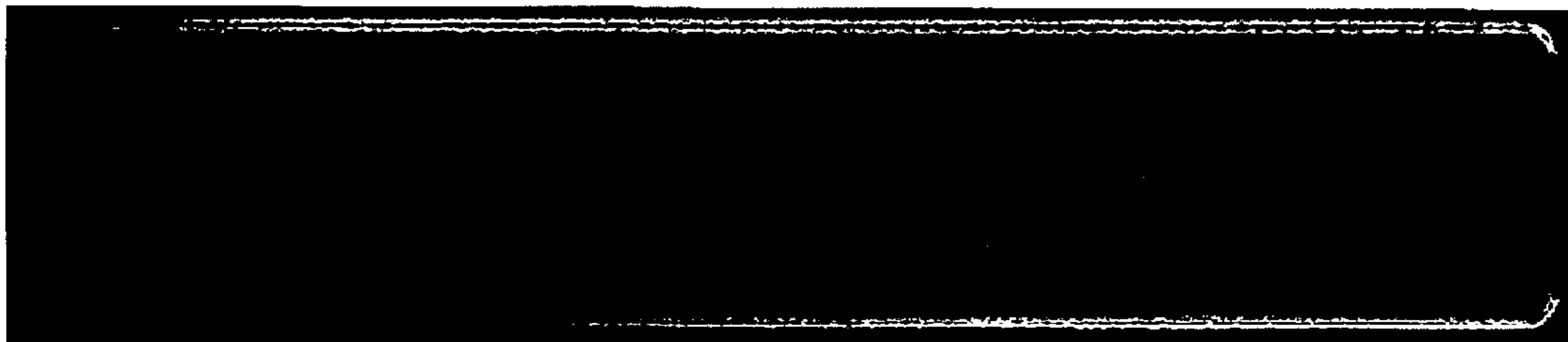

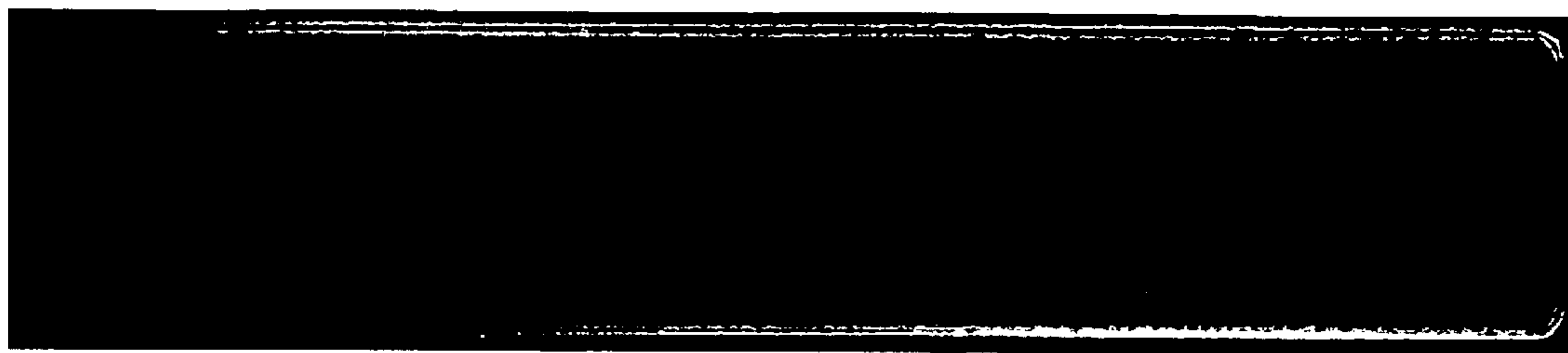

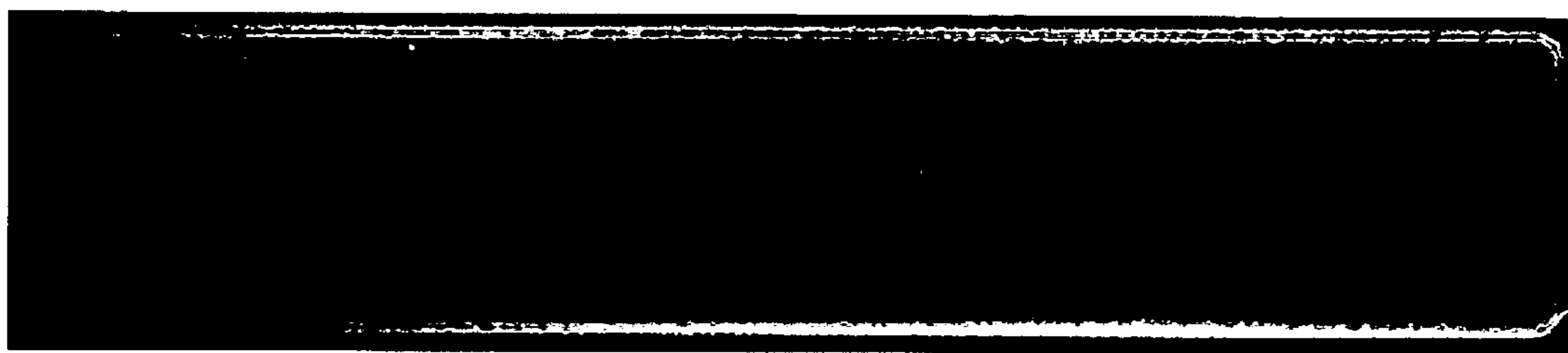

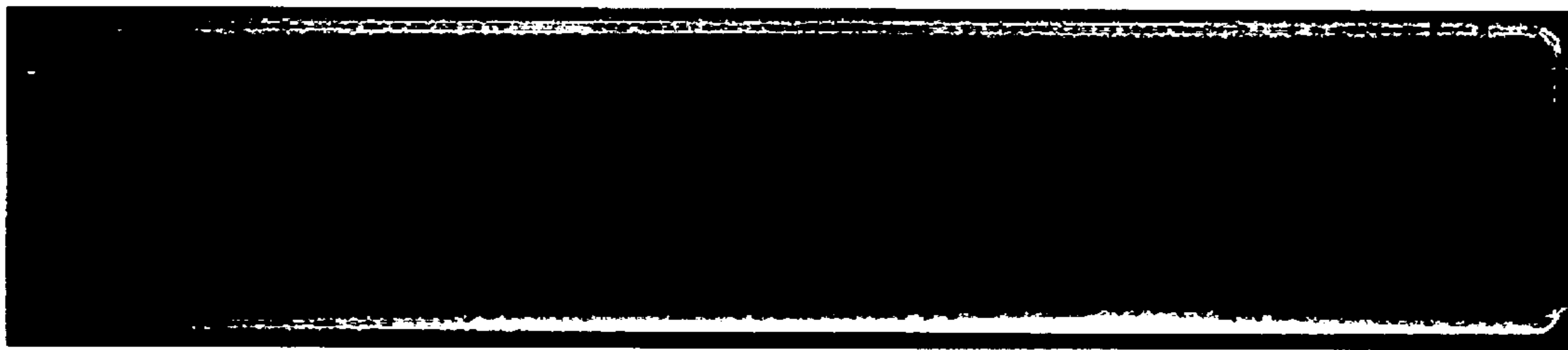

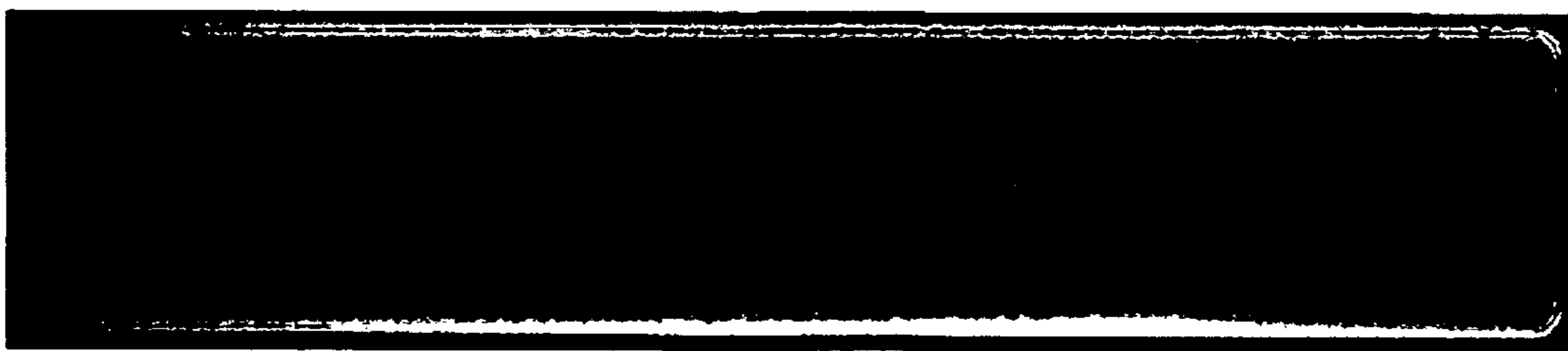

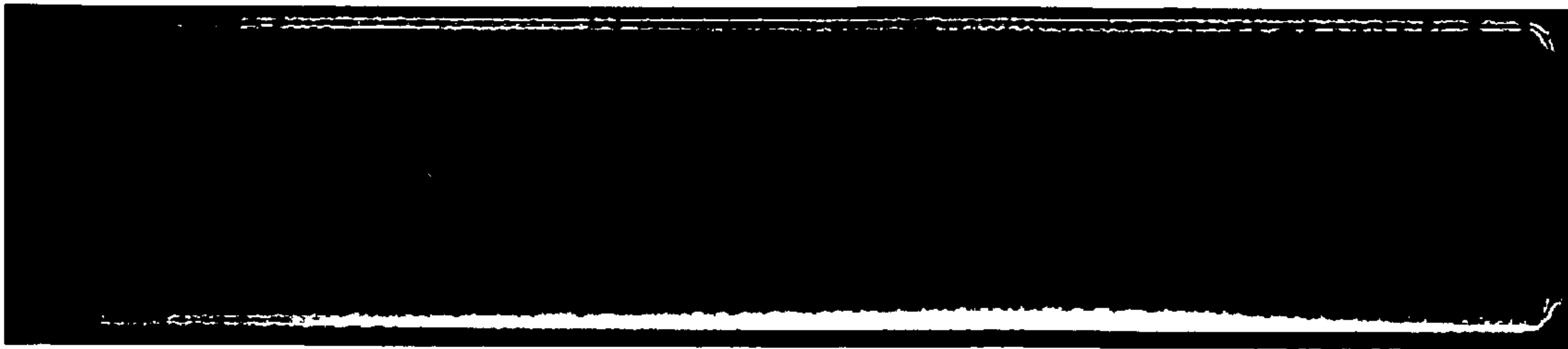

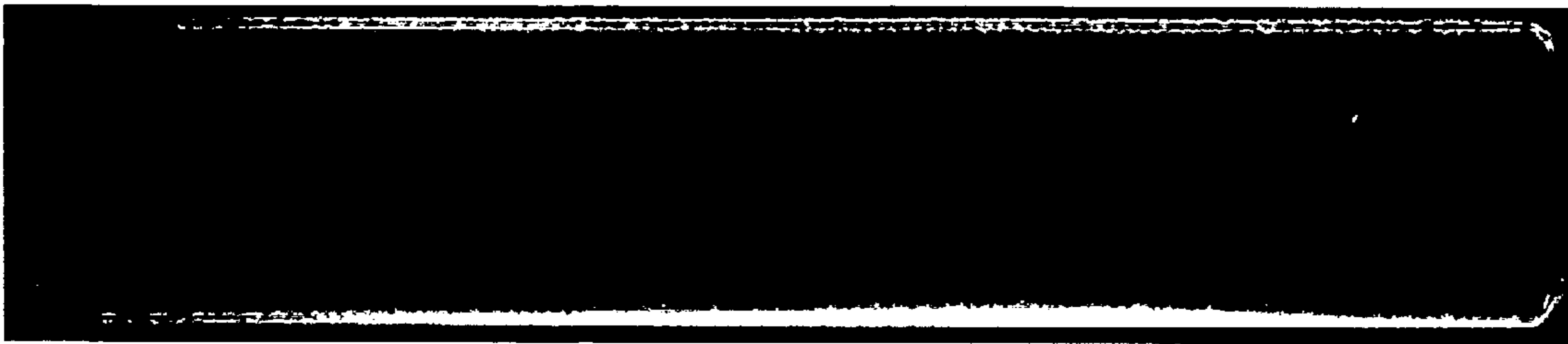

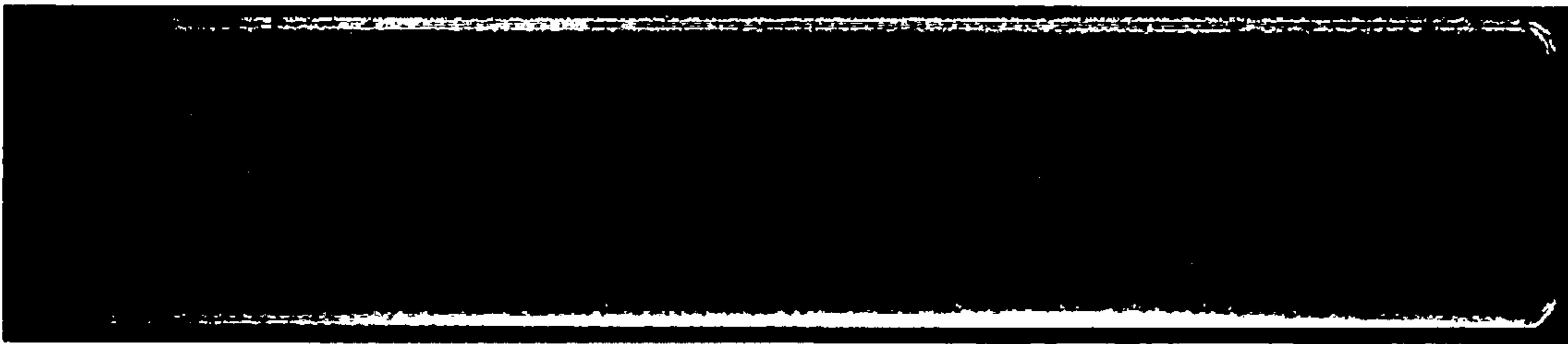

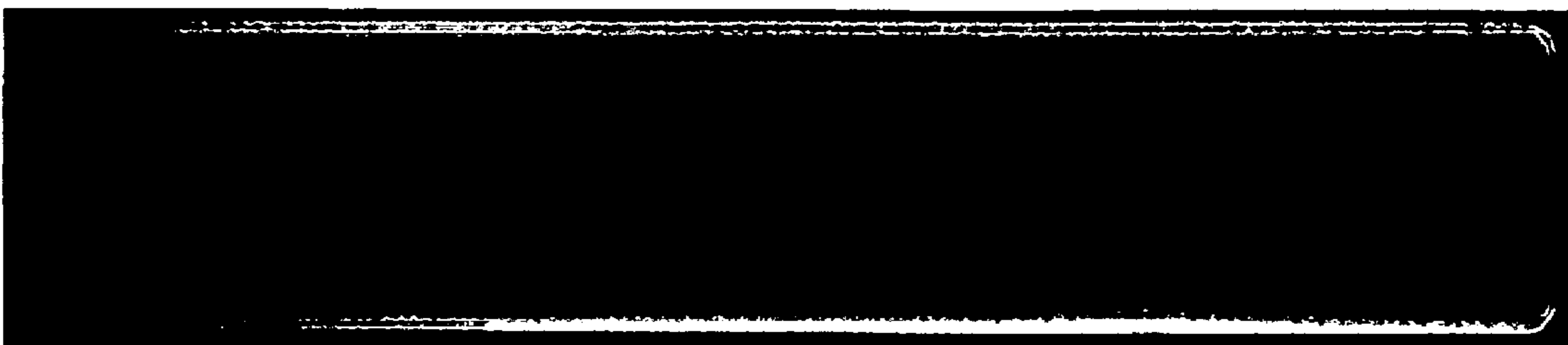

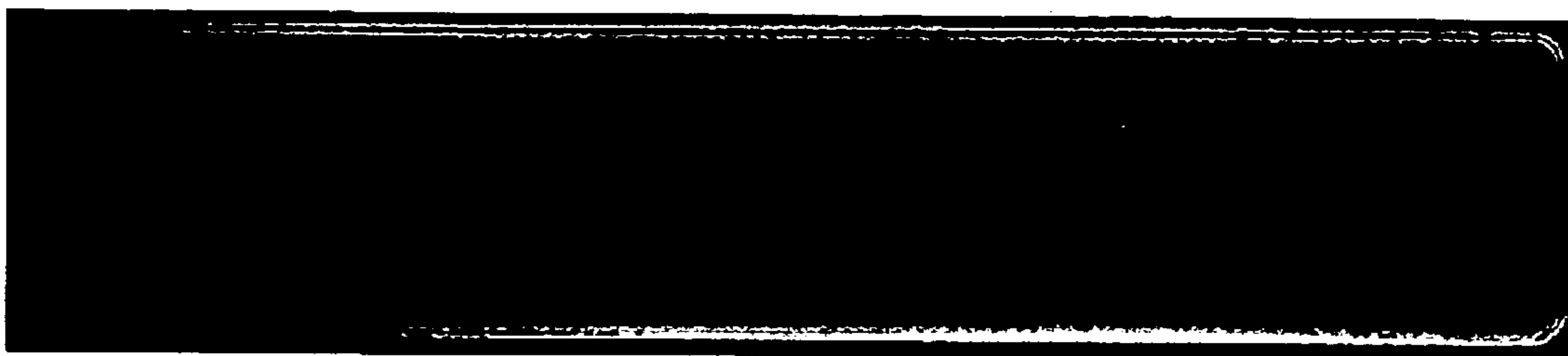

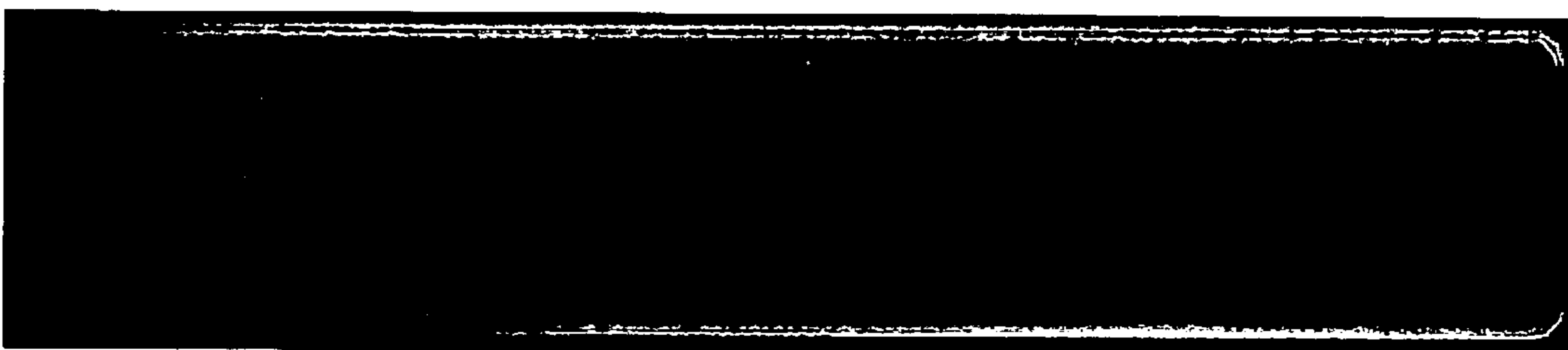

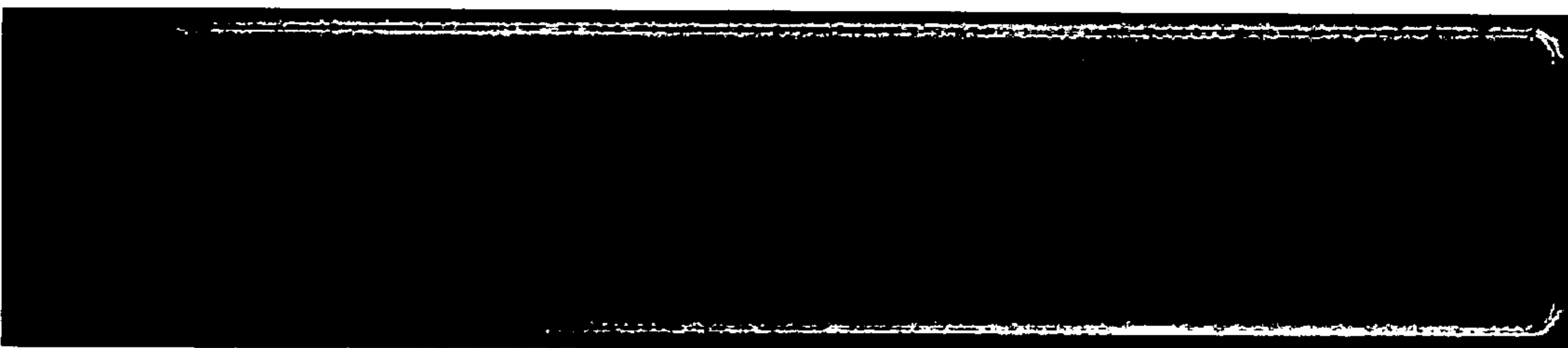

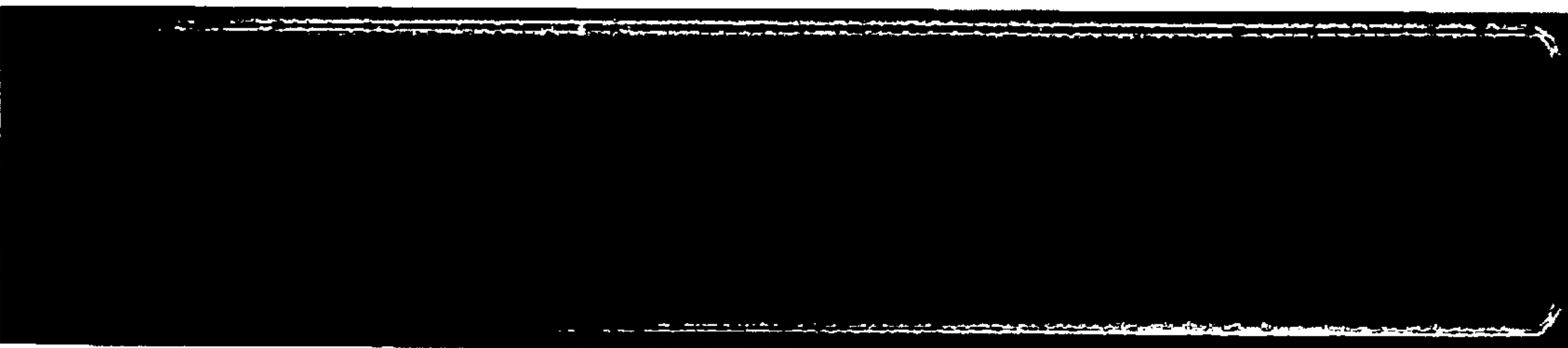

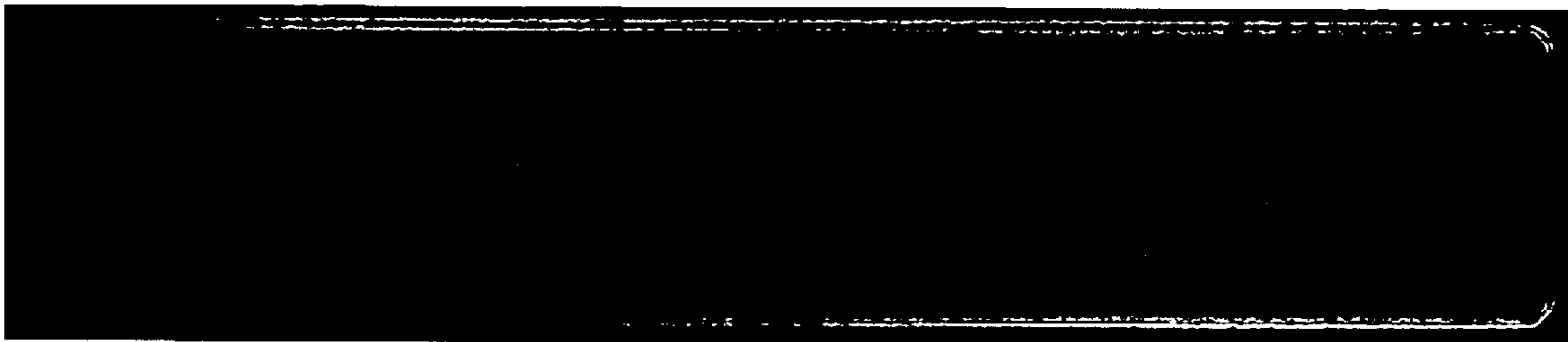

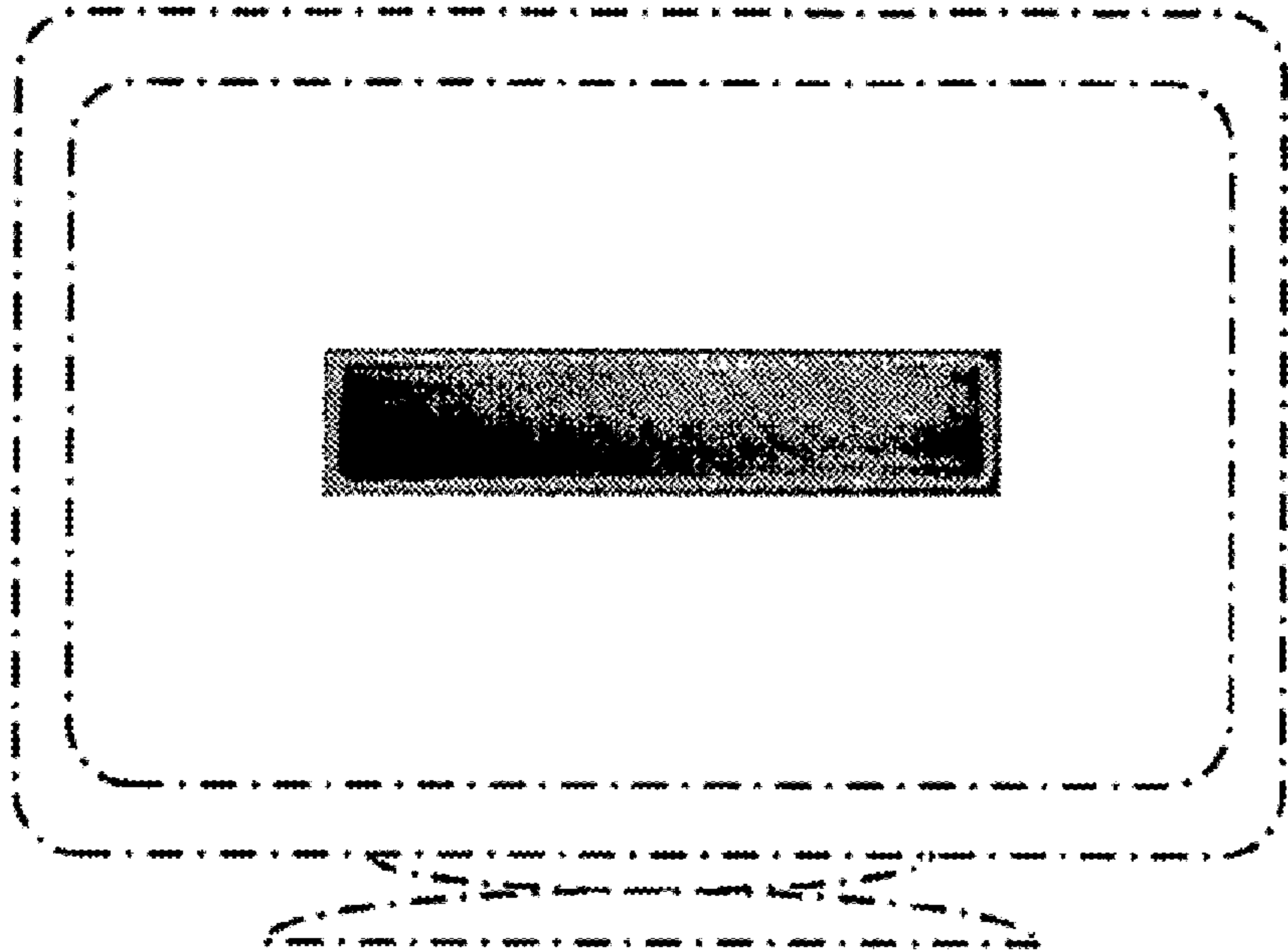

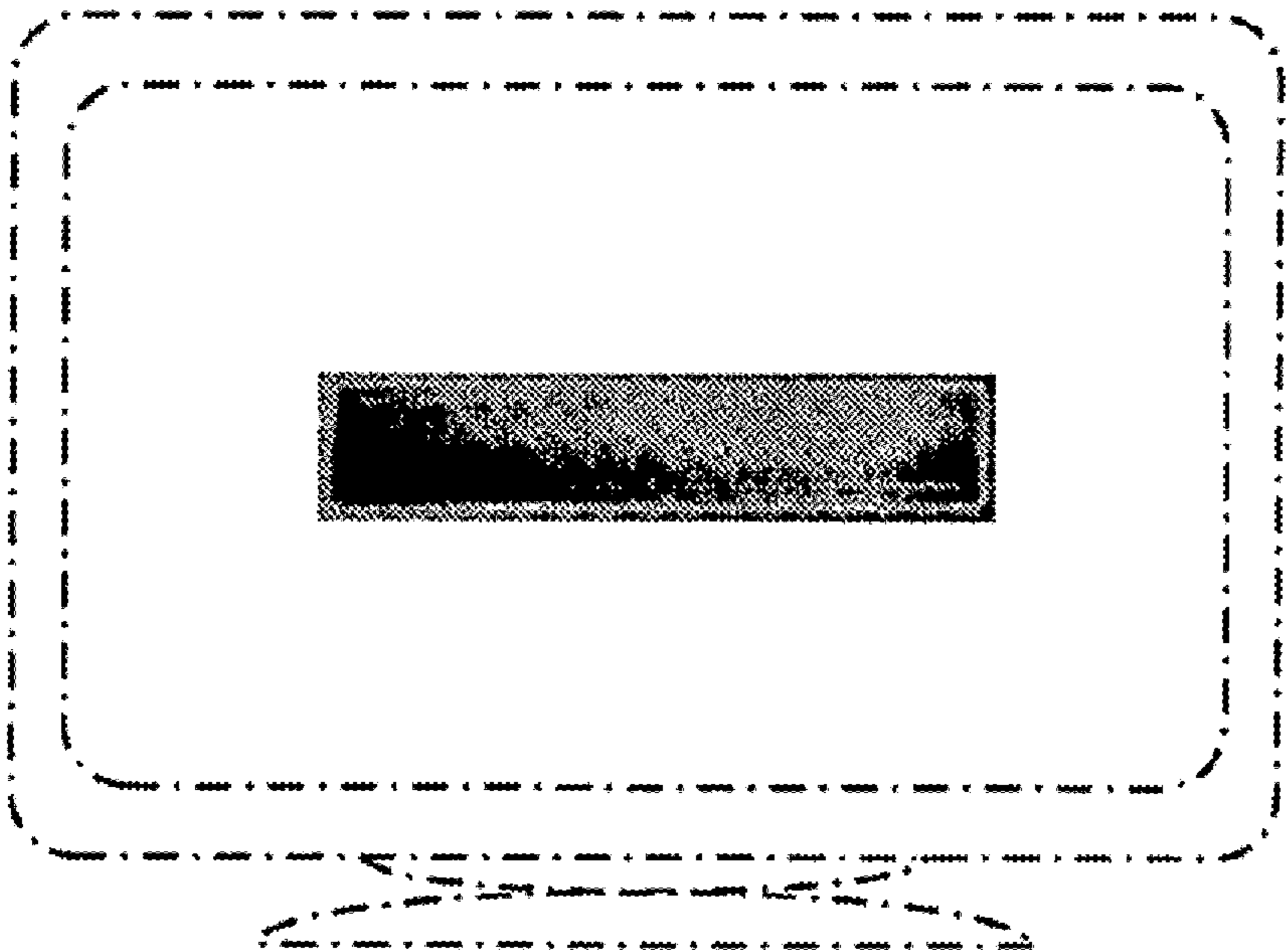

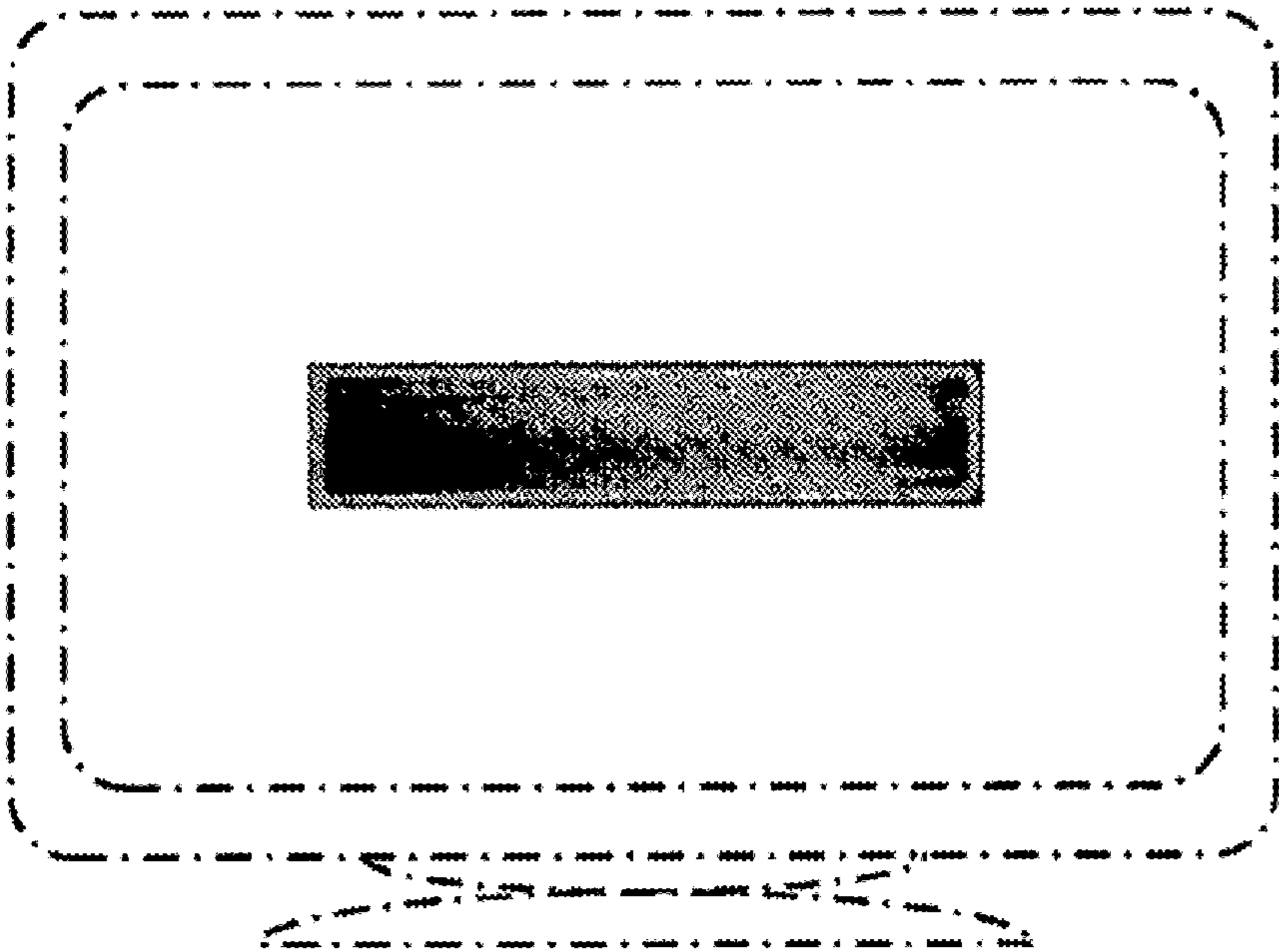

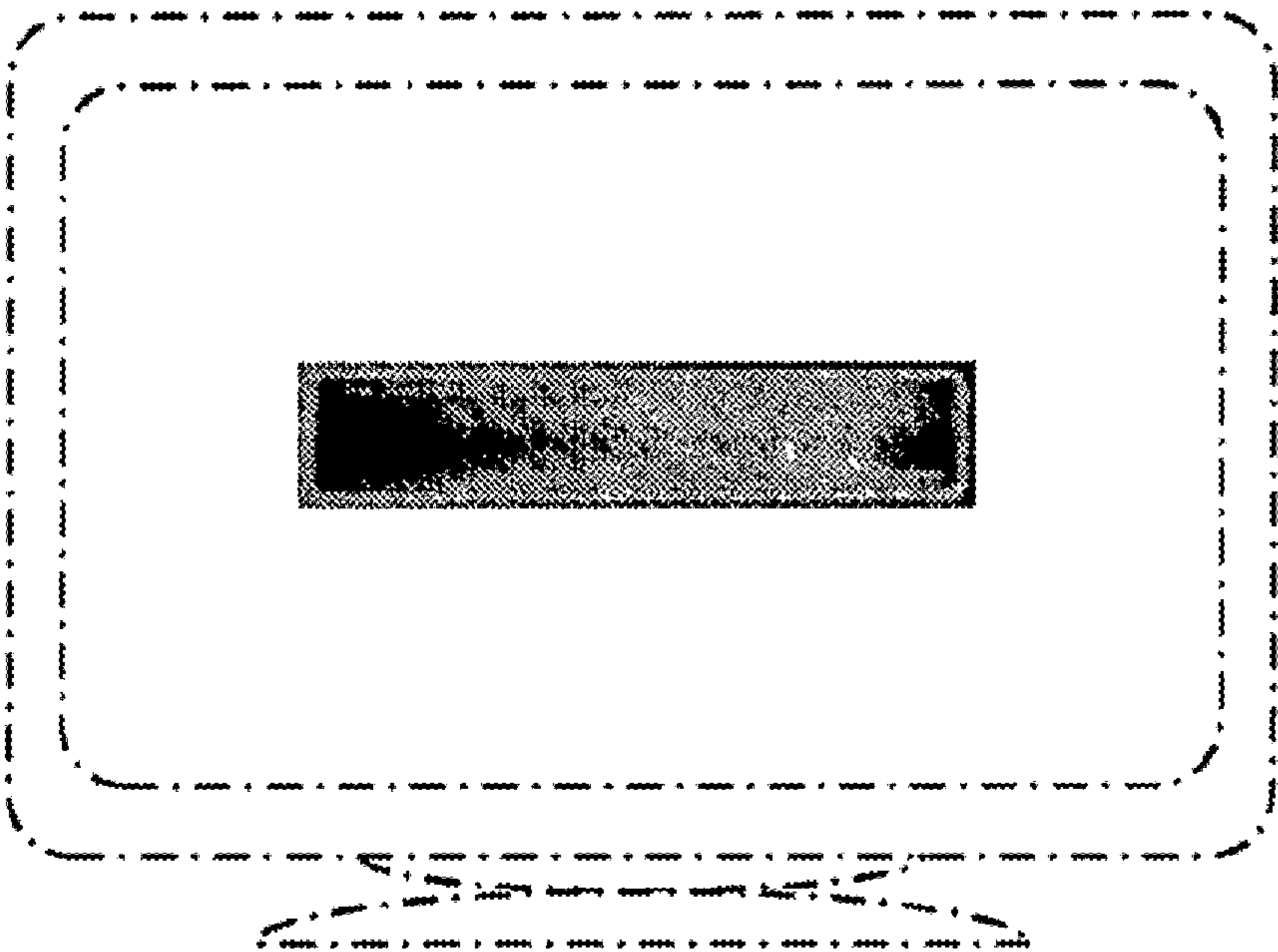

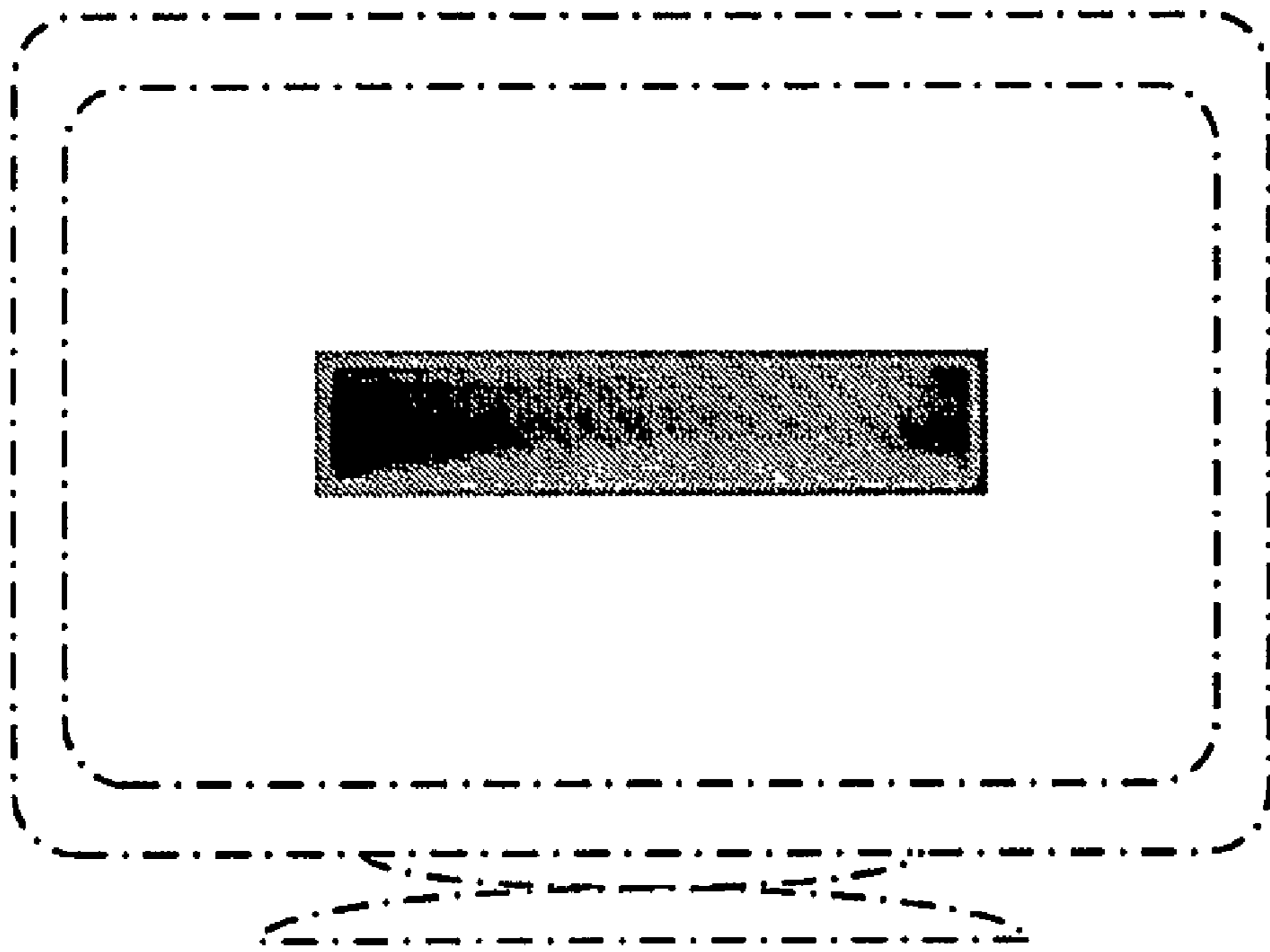

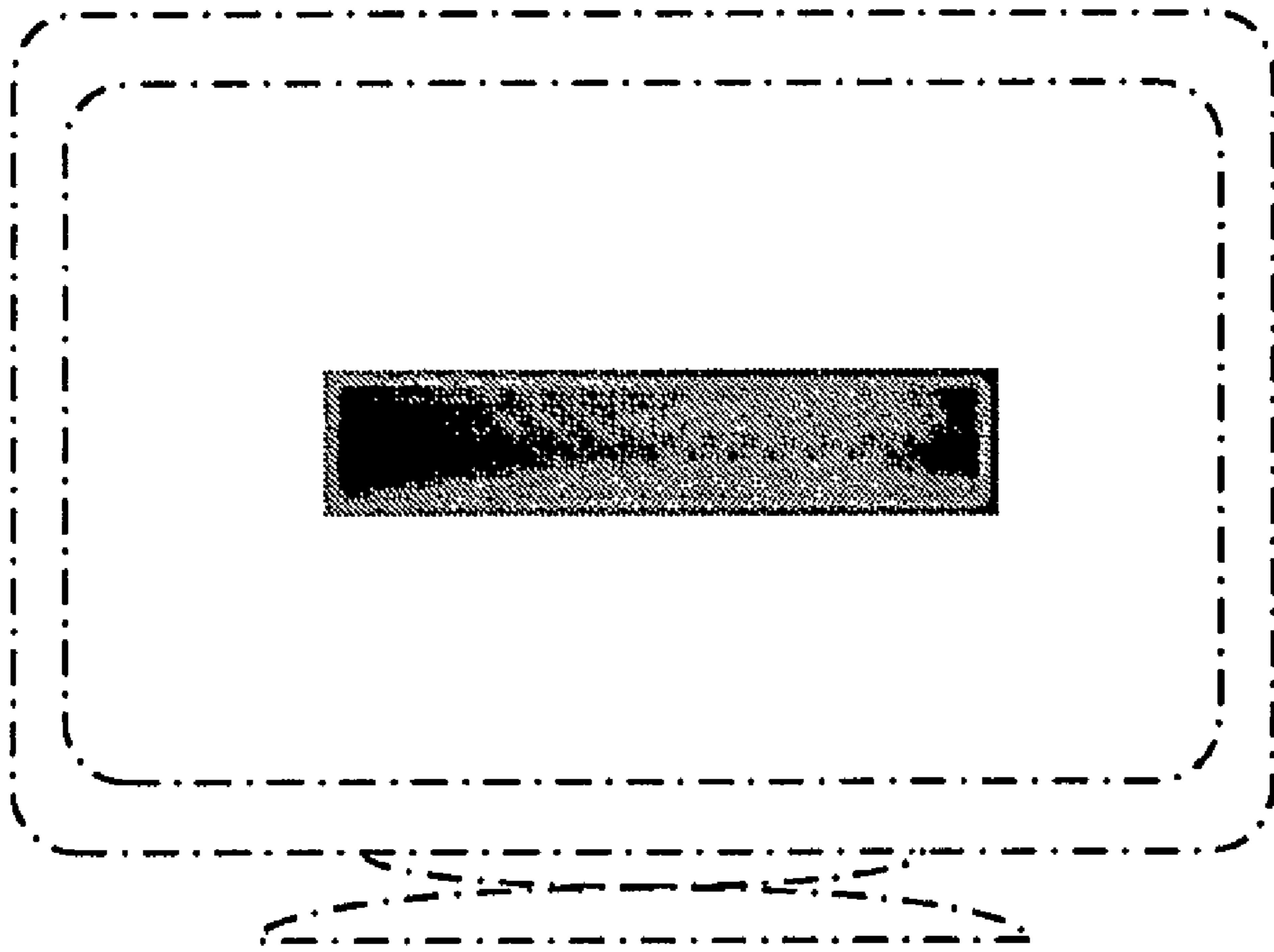

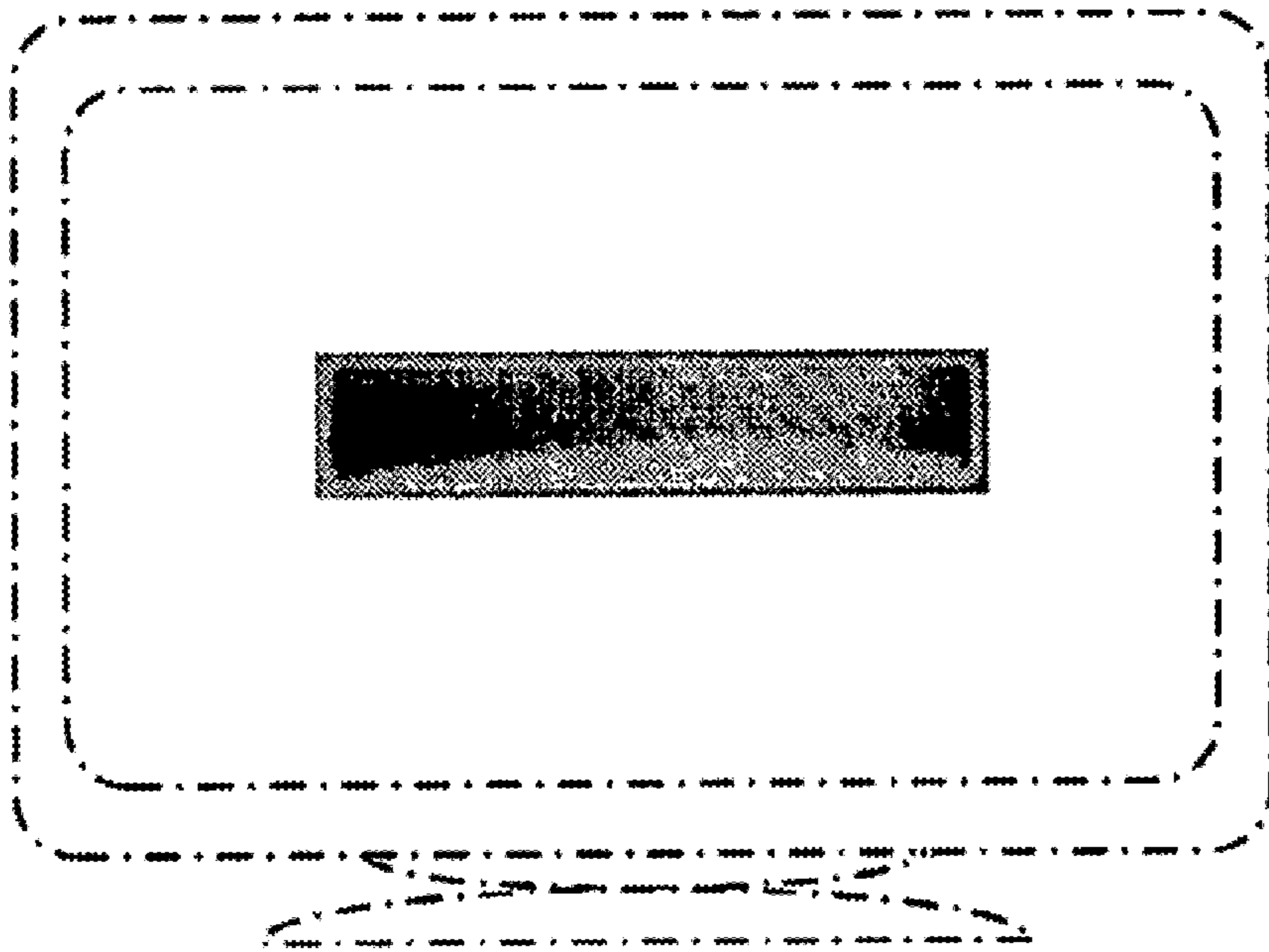

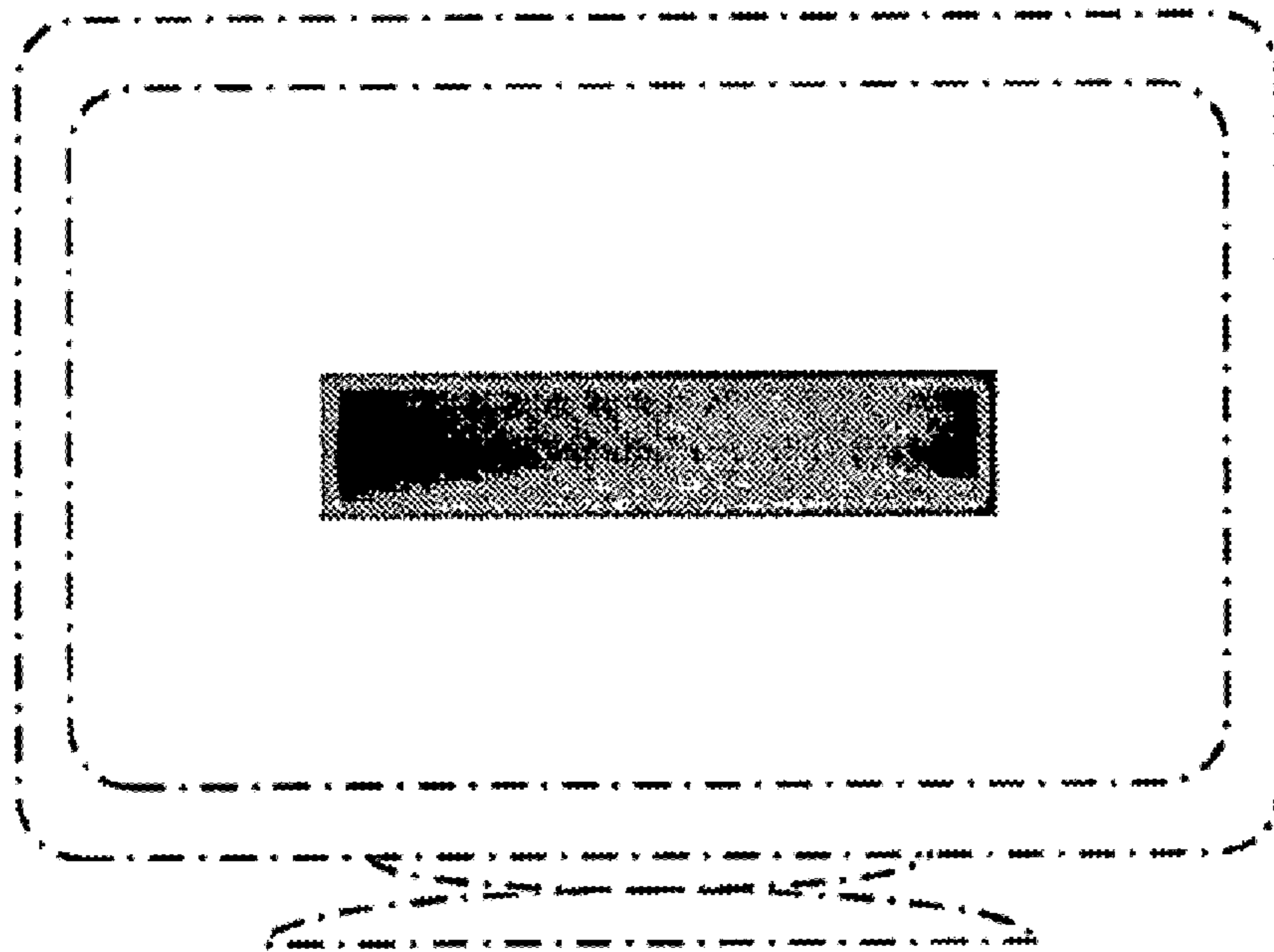

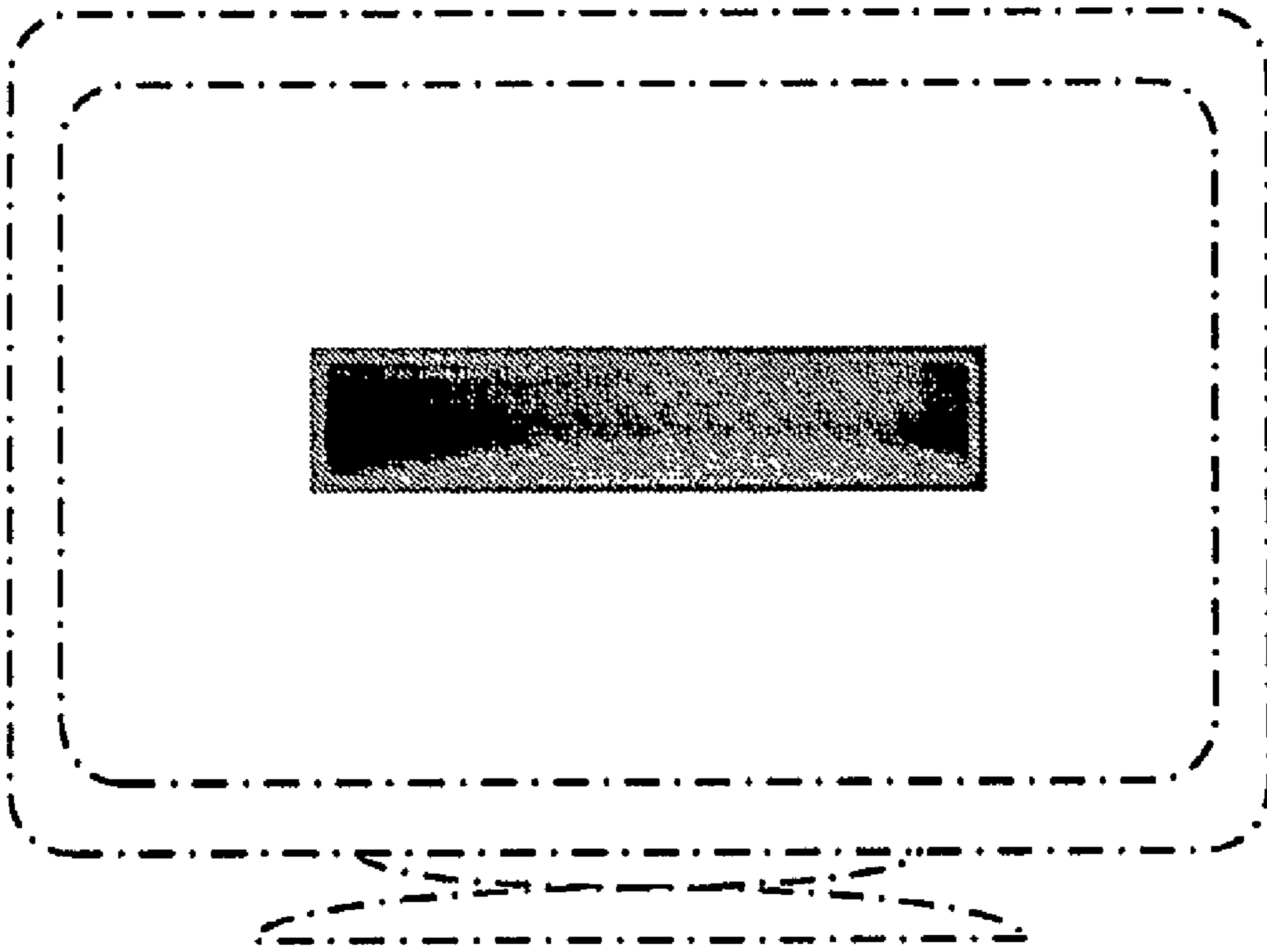

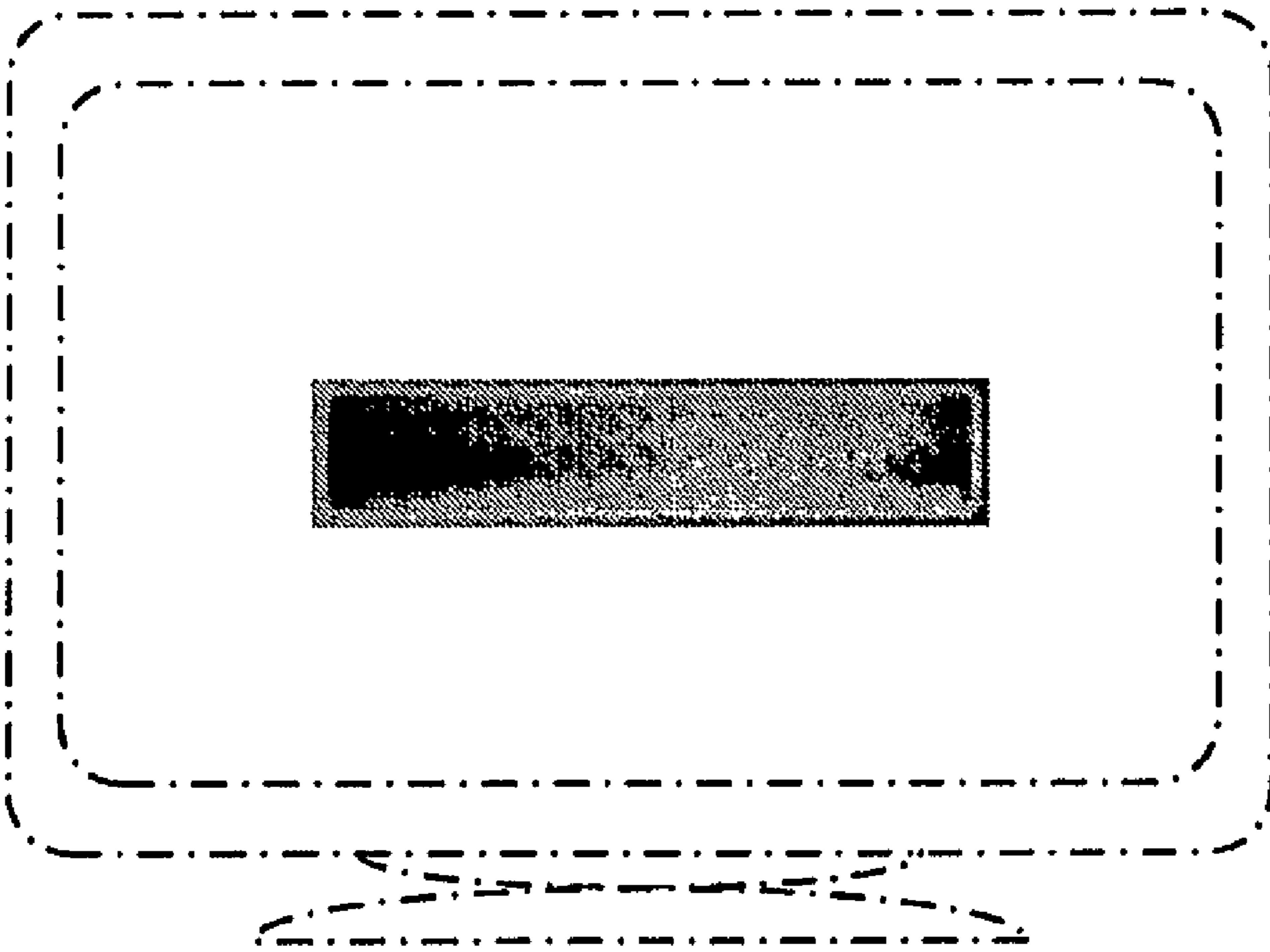

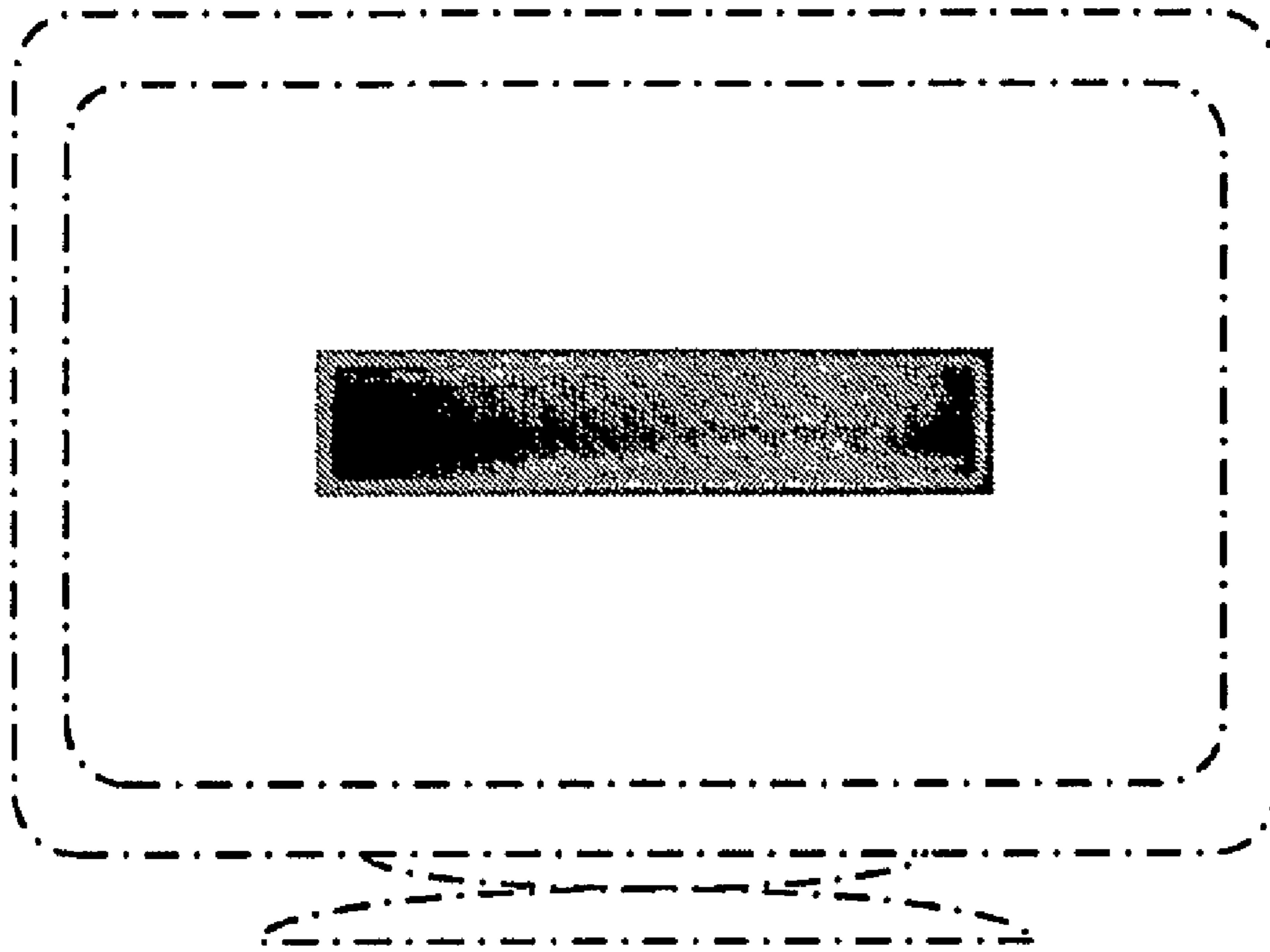

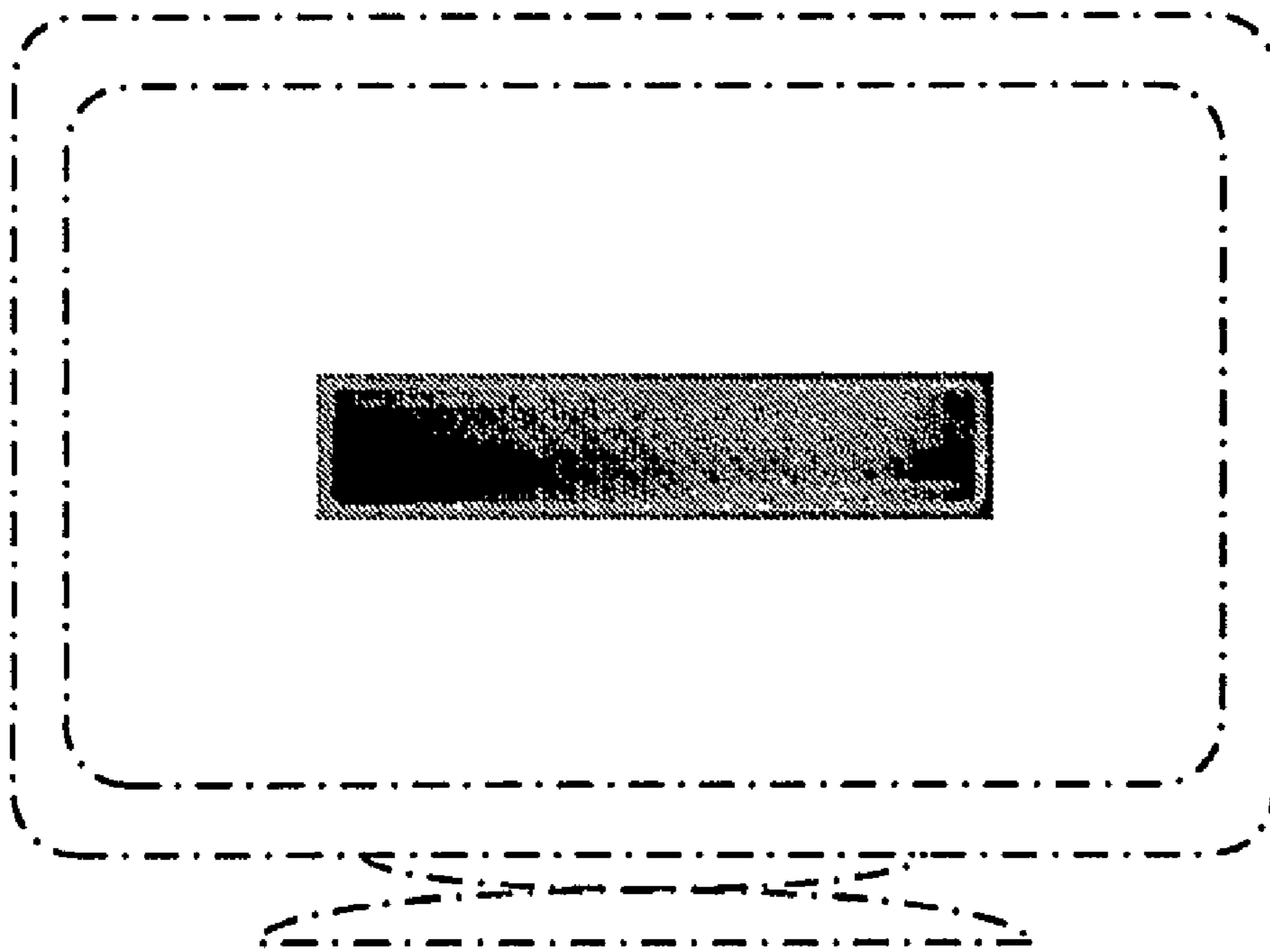

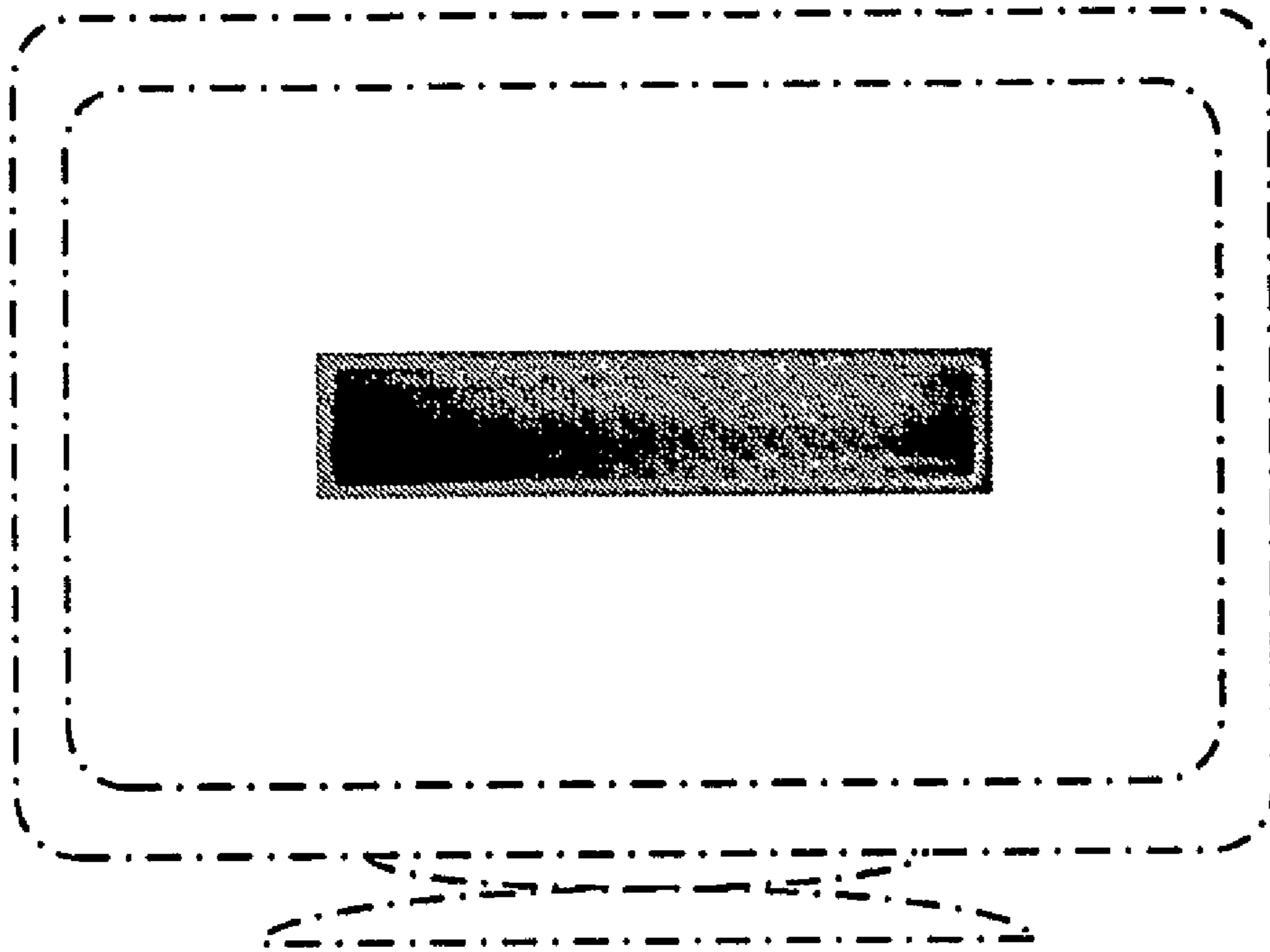

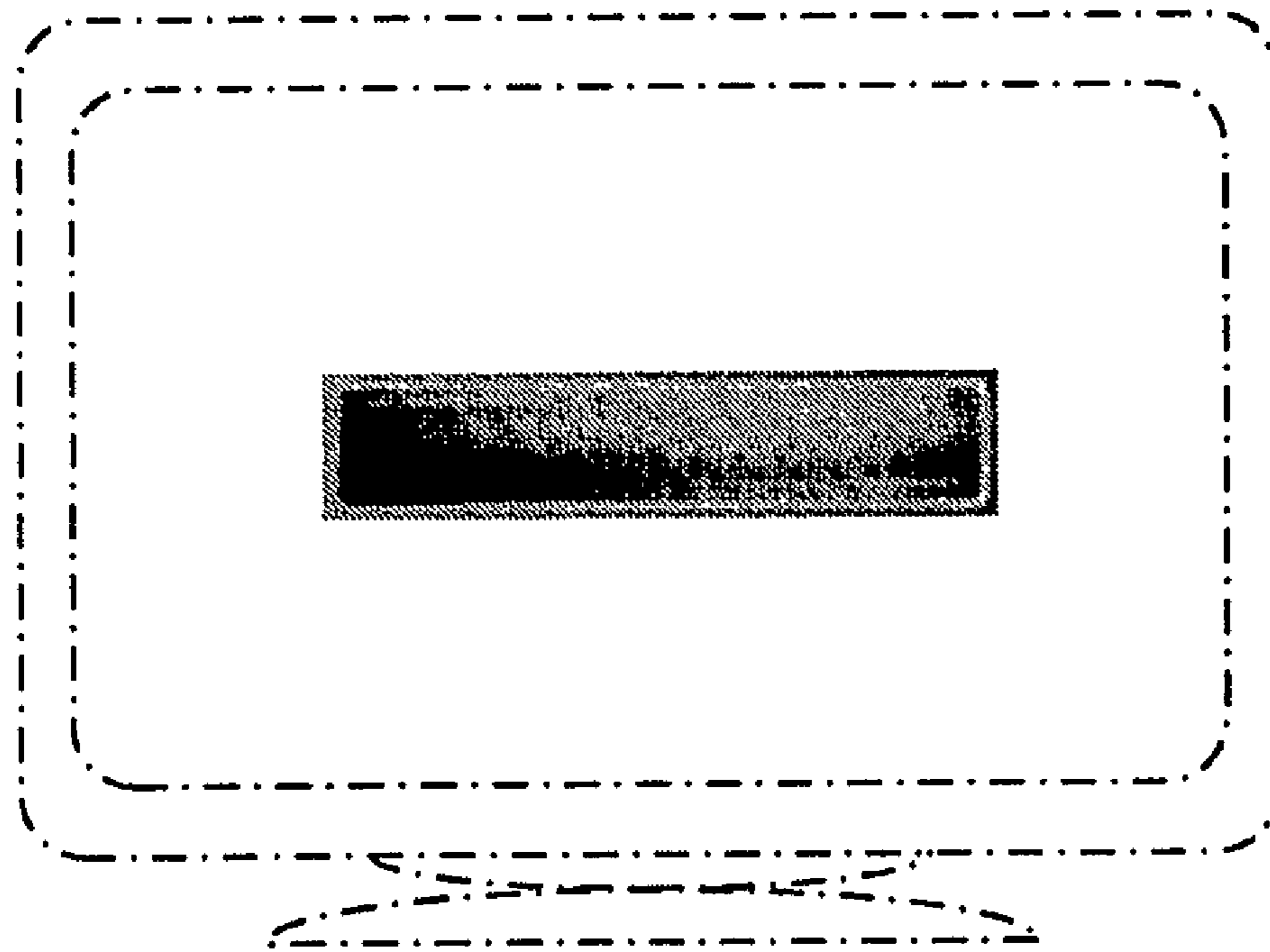

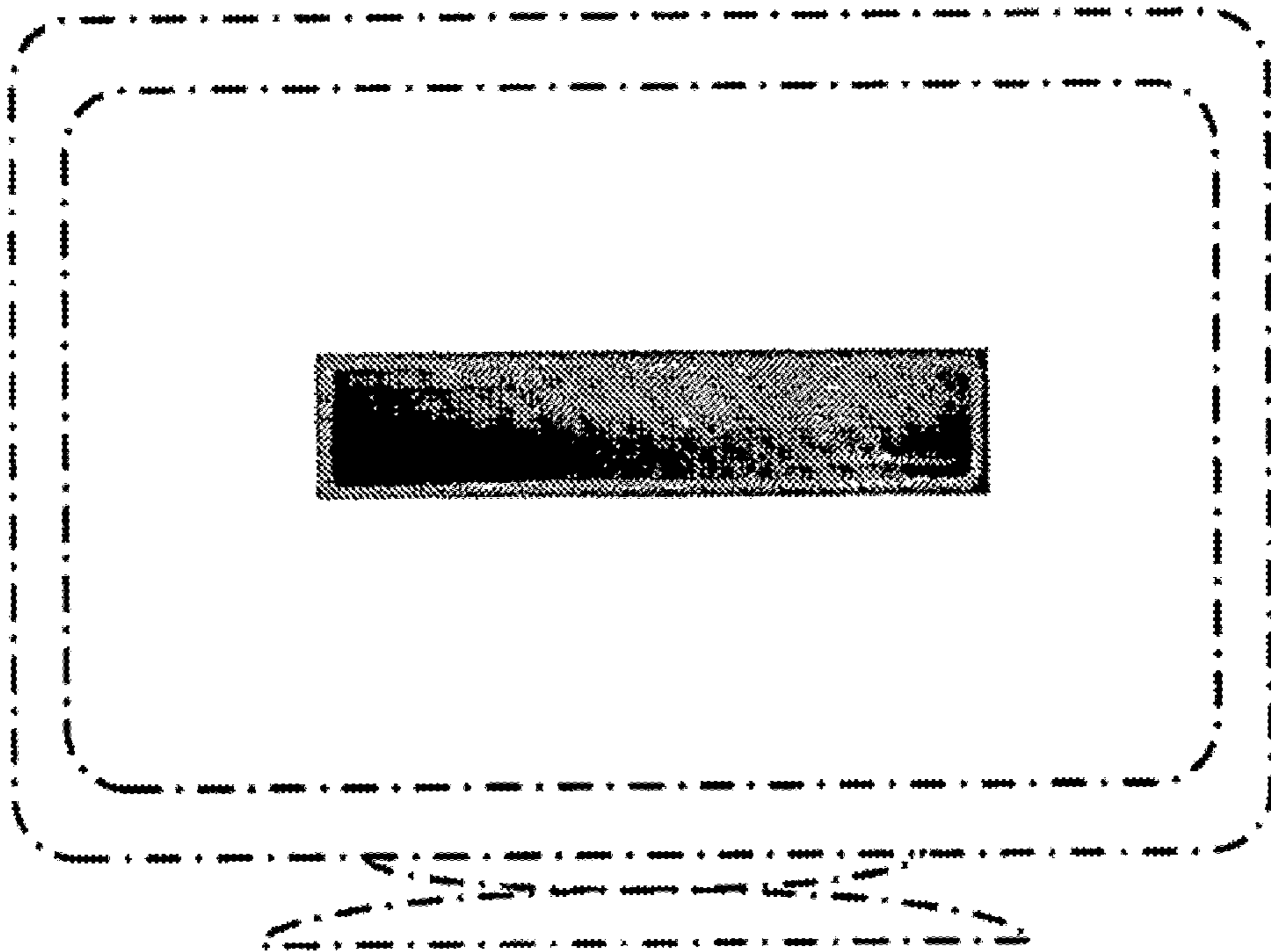

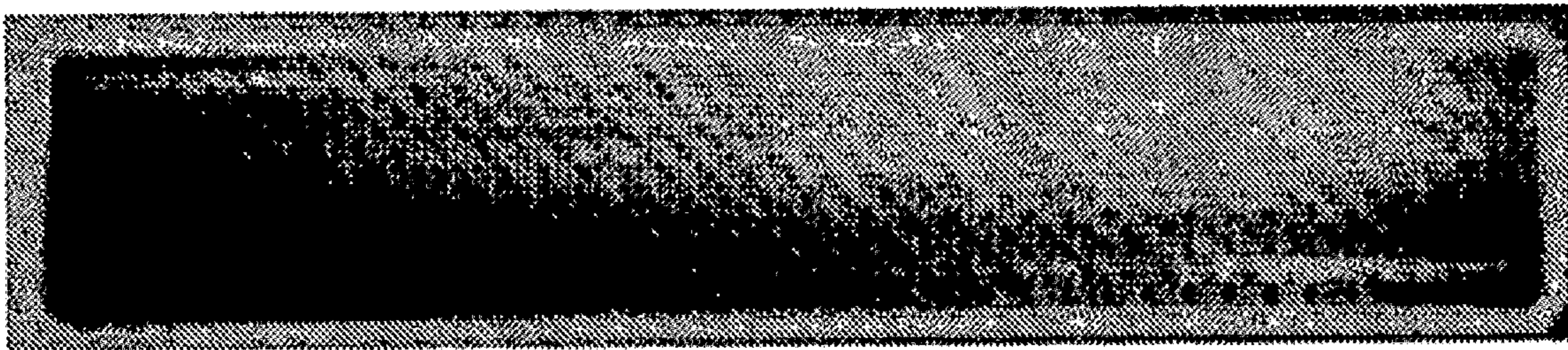

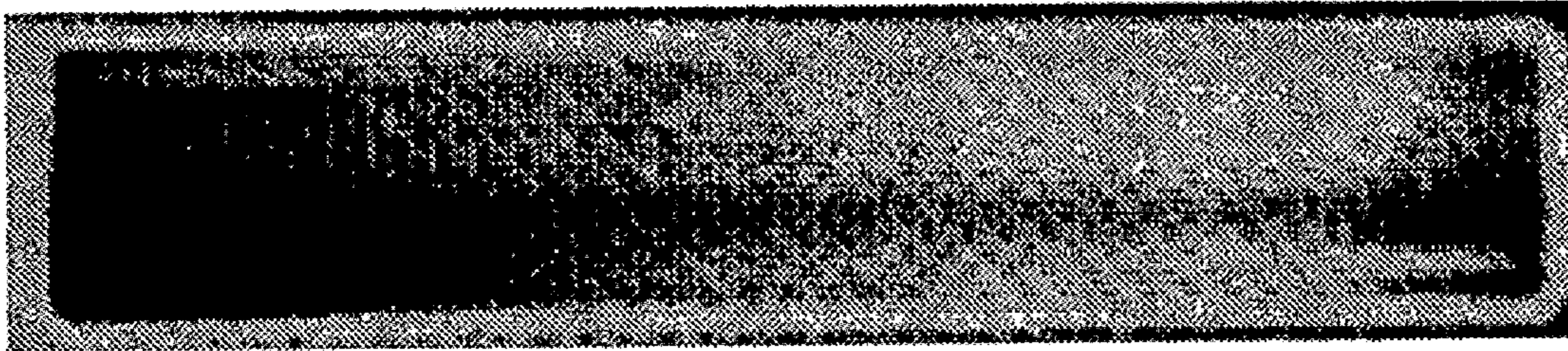

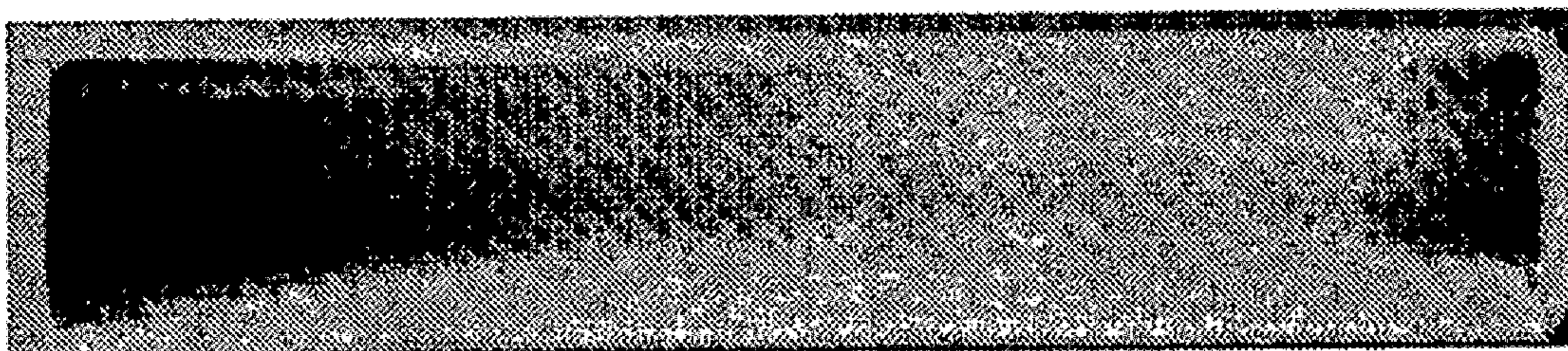

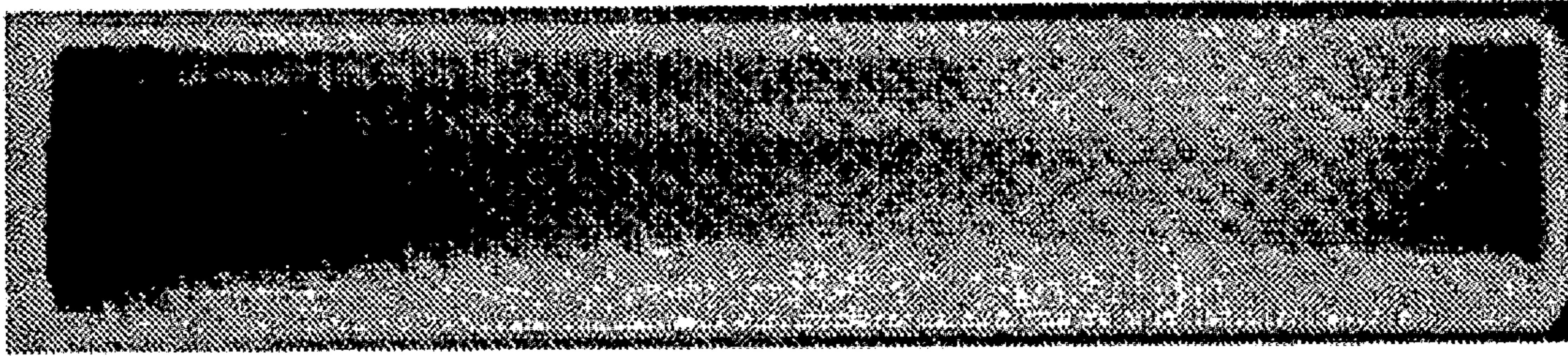

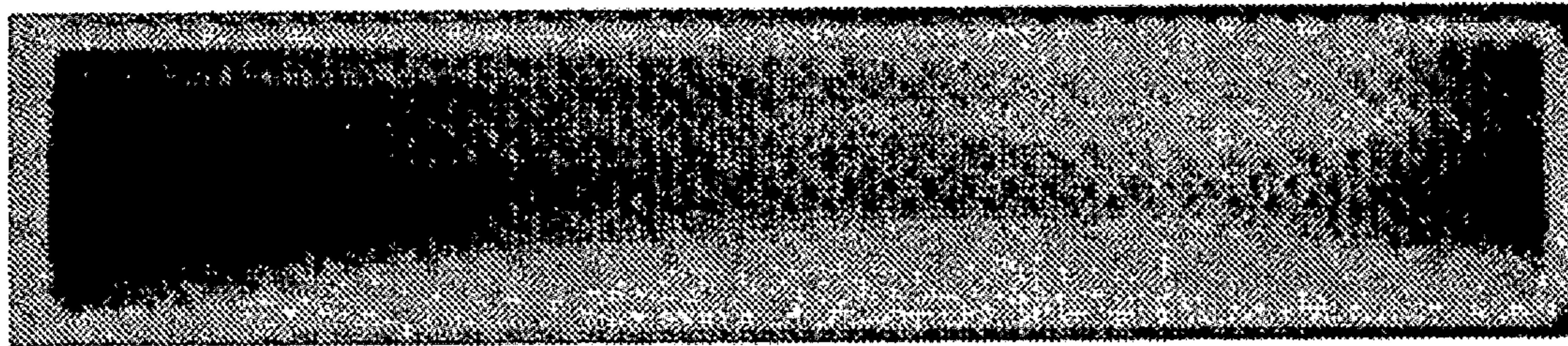

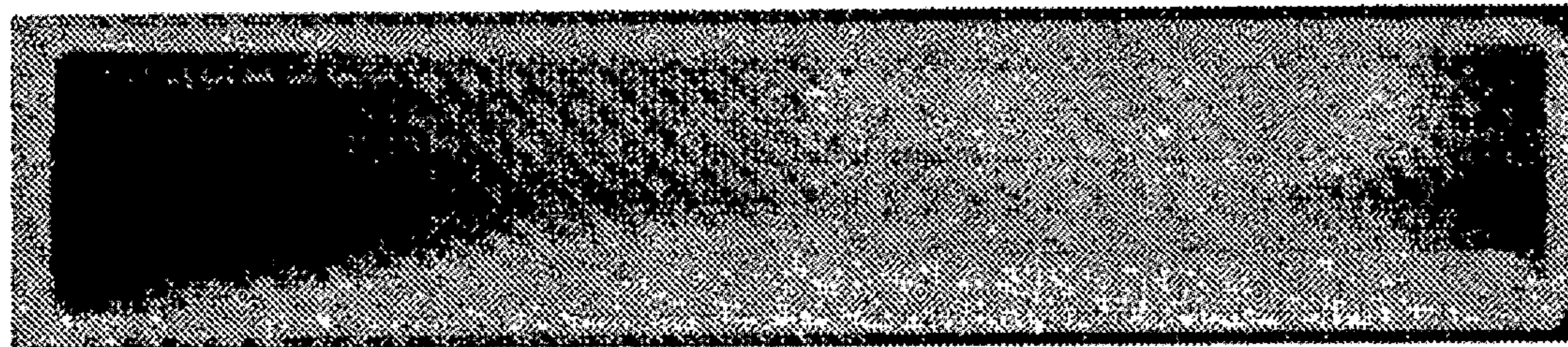

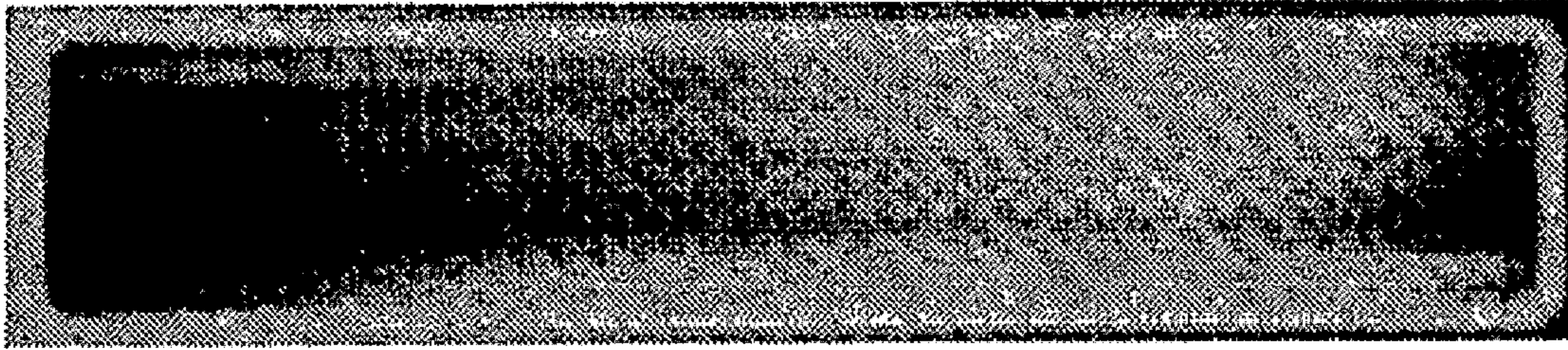

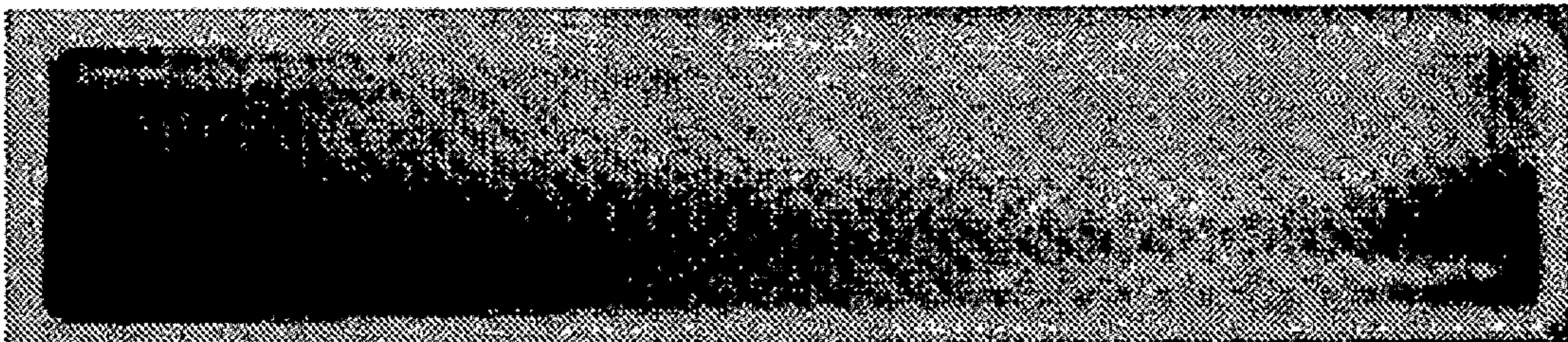
