FIG. 5 is a rear view of the invention of FIG. 1.

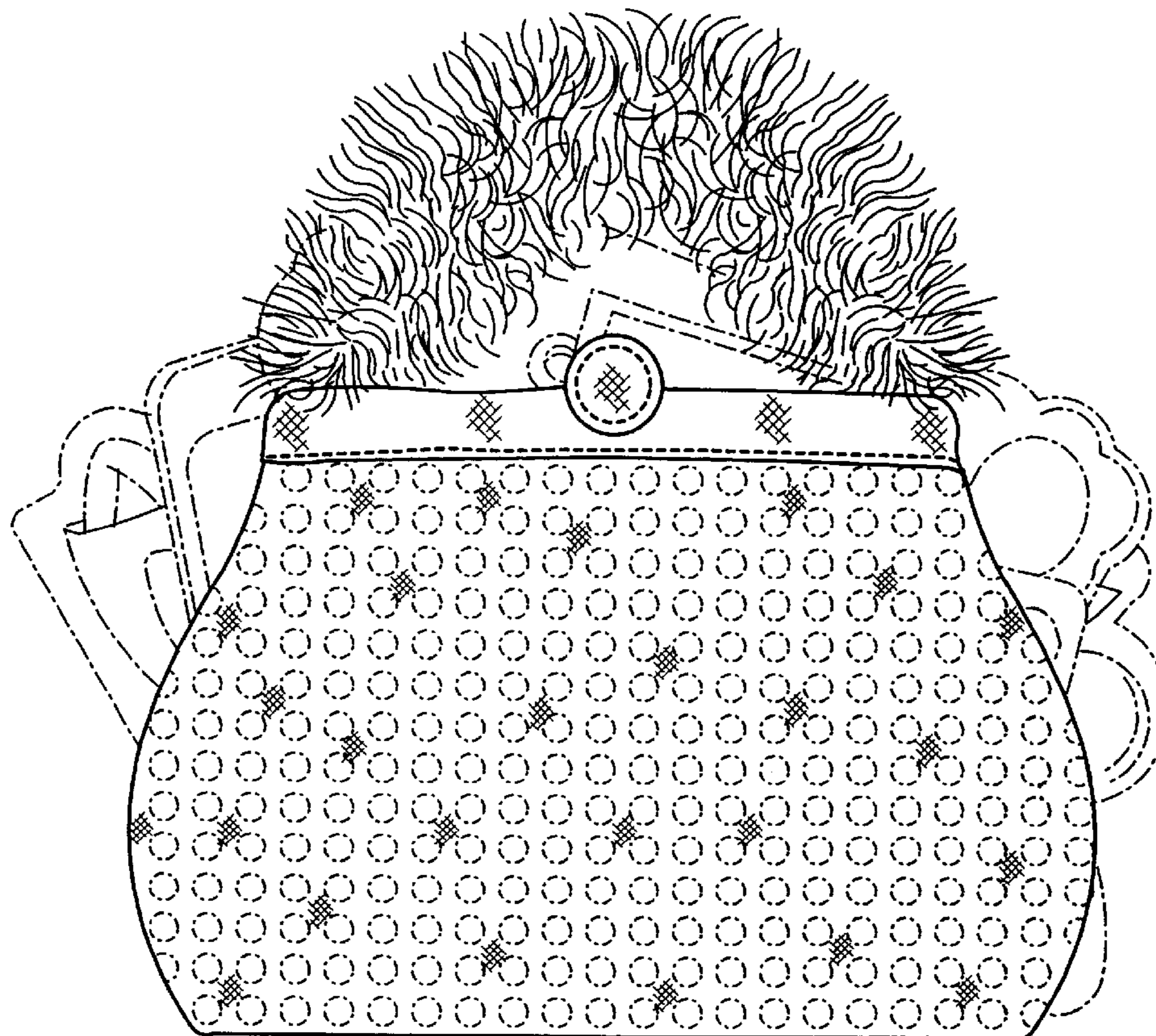

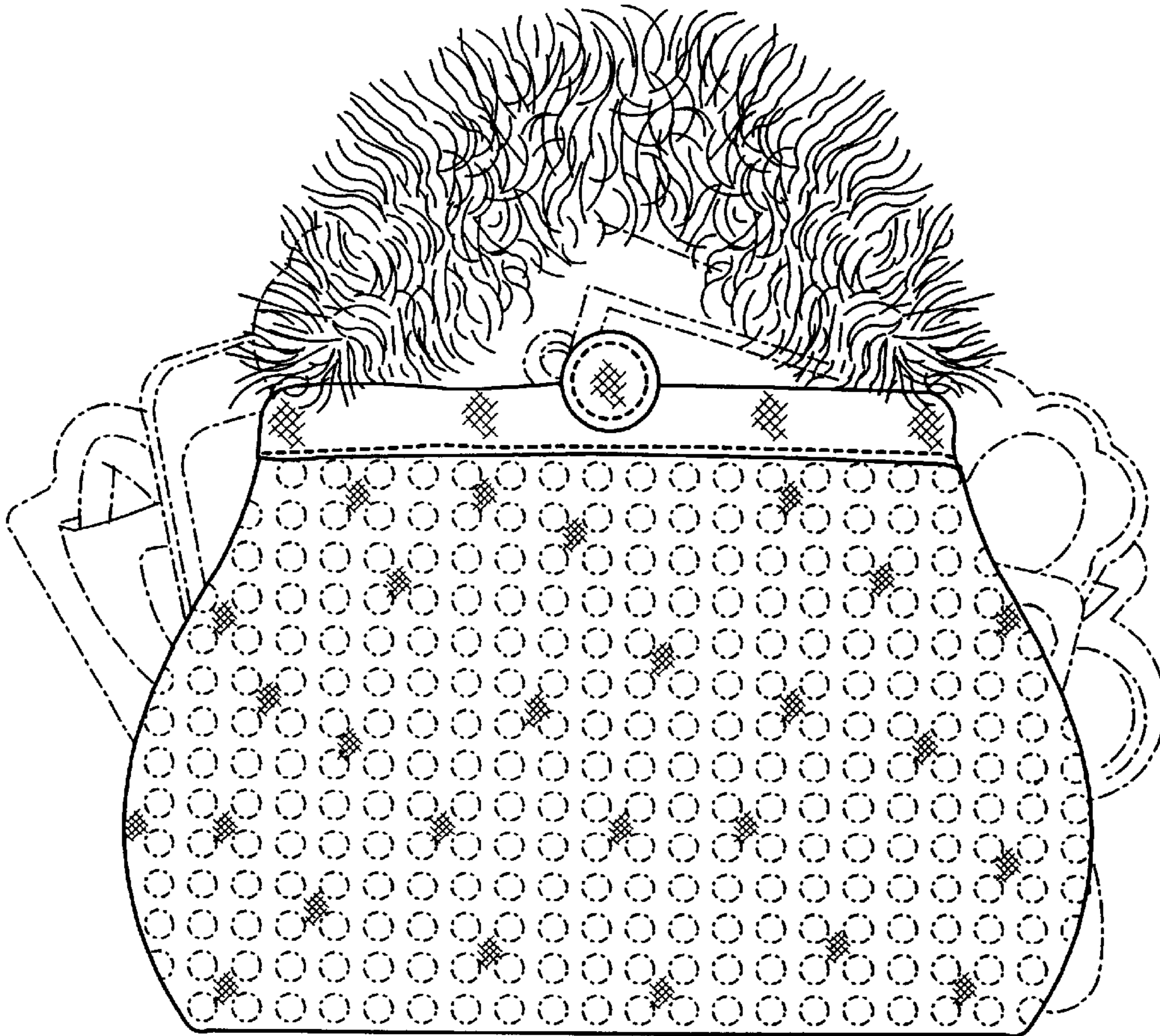

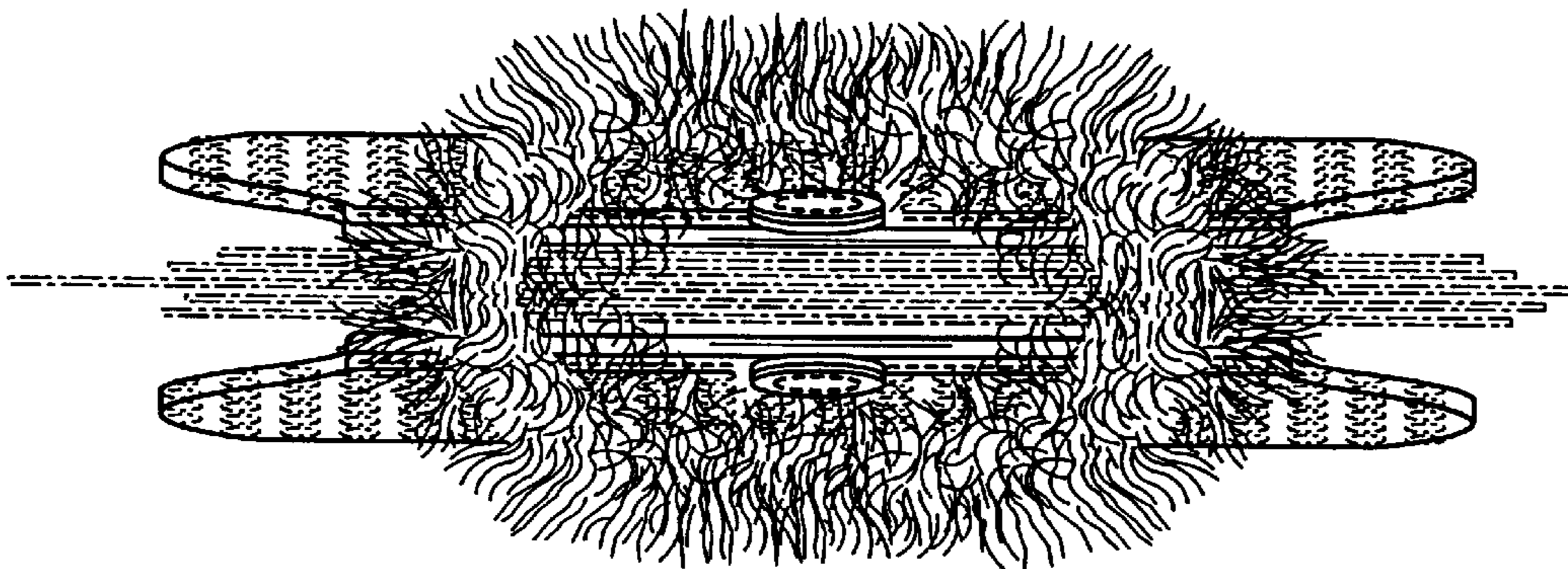

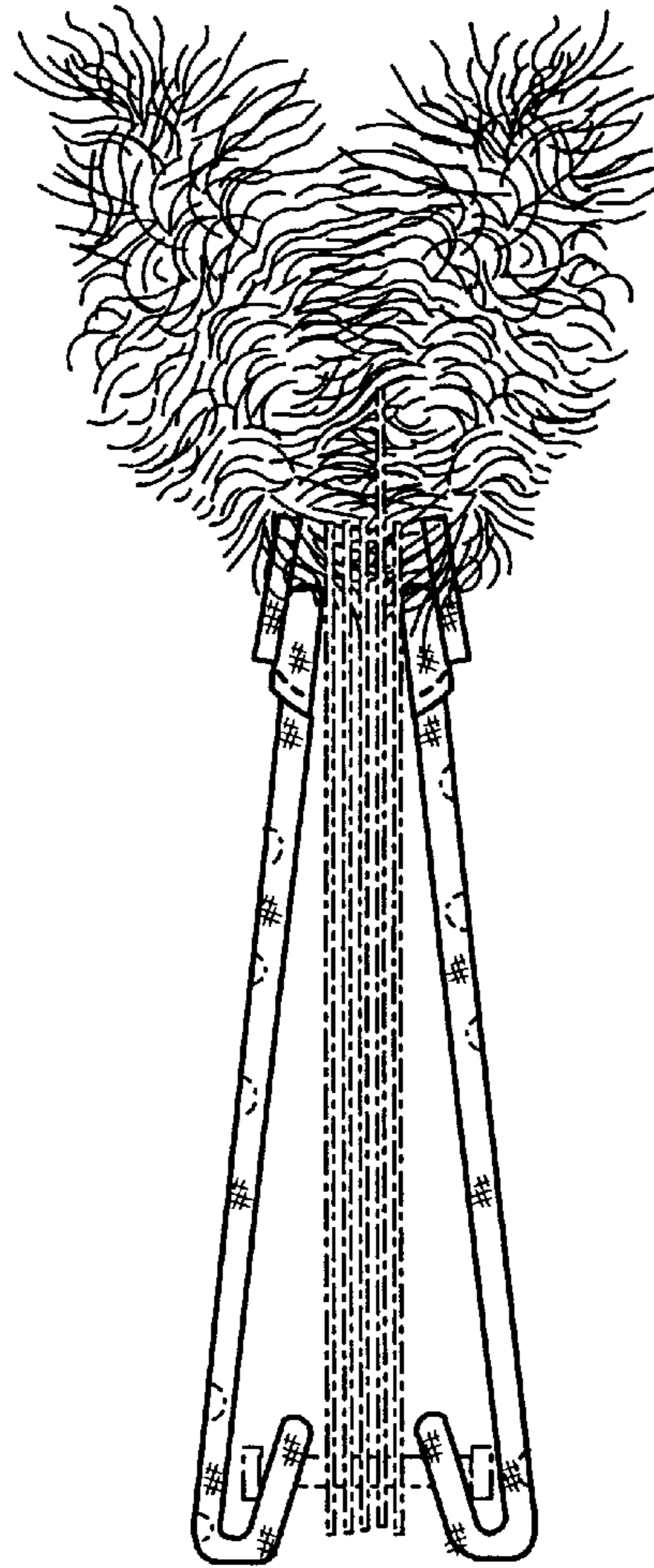

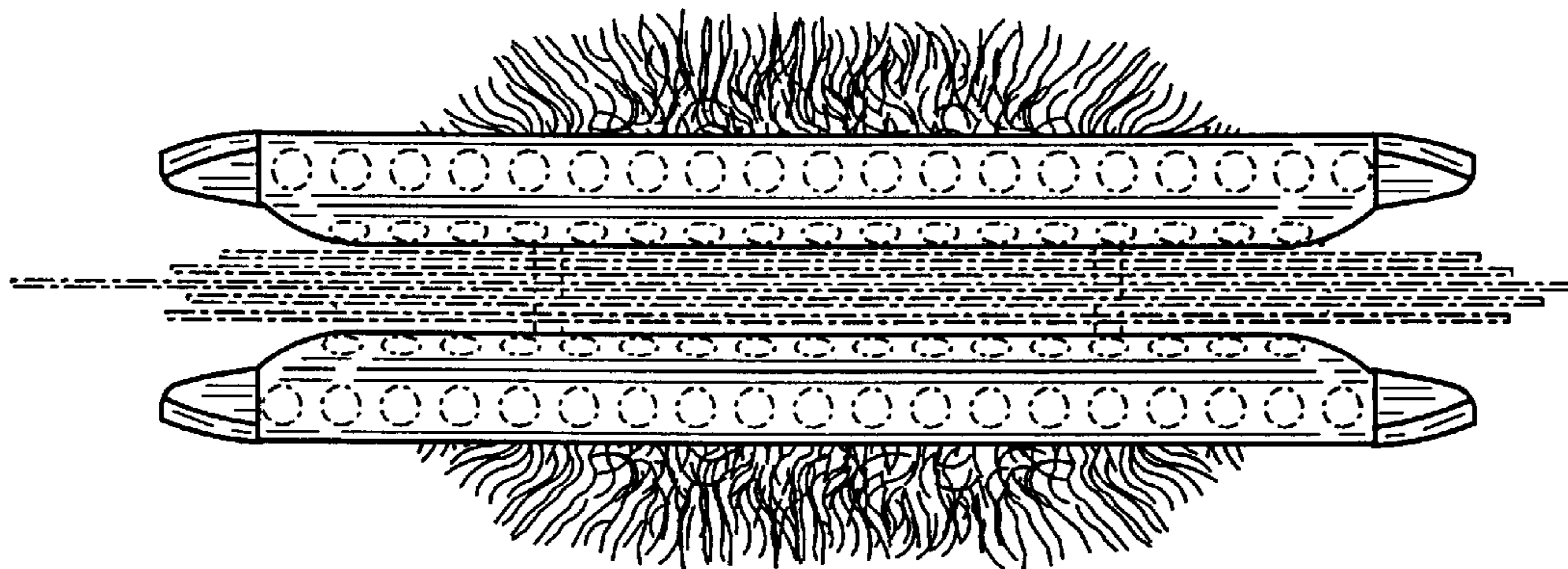

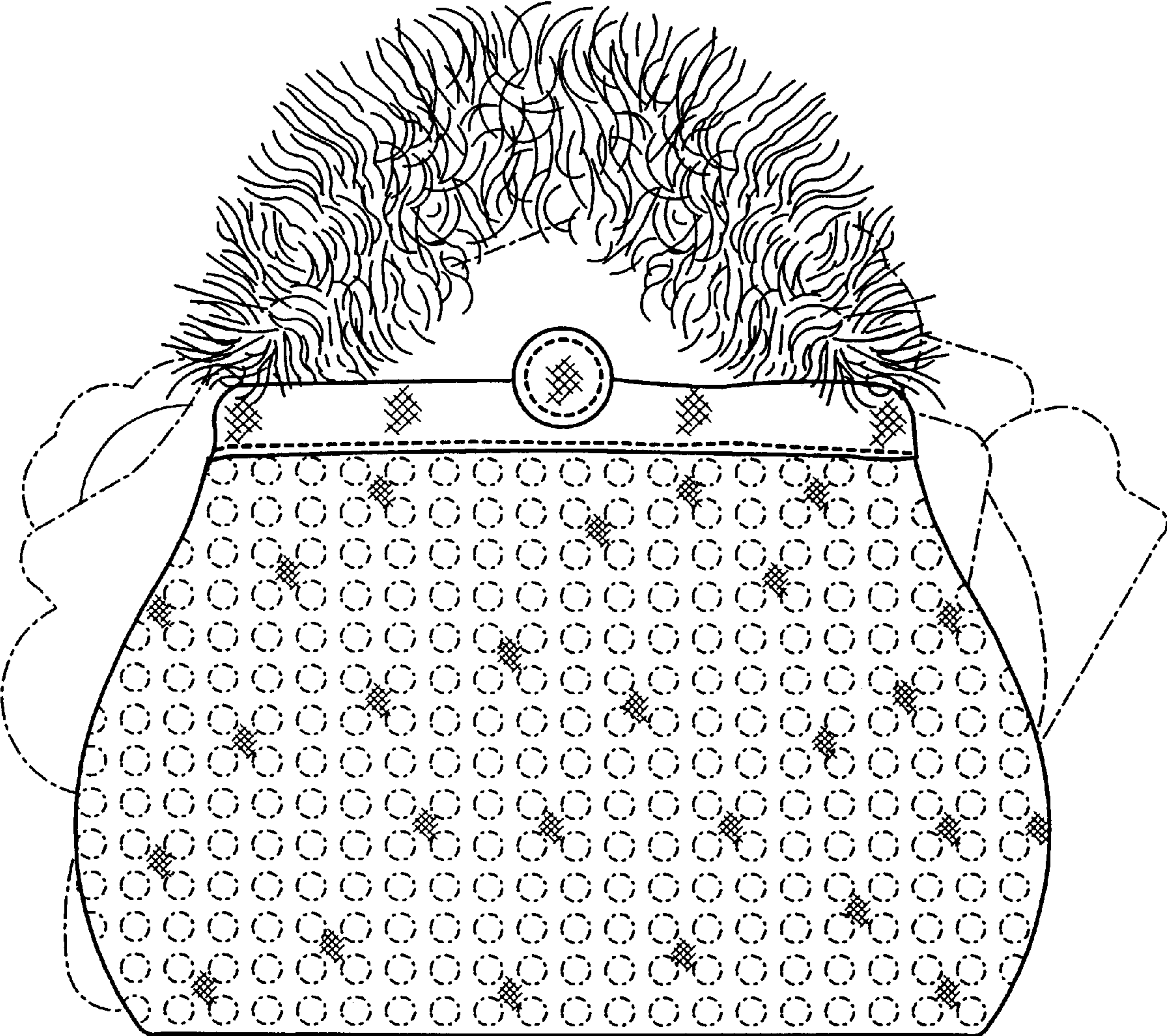
