(57) **CLAIM**

The ornamental design for a tape dispenser, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a tape dispenser showing our
new design;

FIG. 2 is a left side view of the tape dispenser illustrated in
FIG. 1, the right side view being the mirror image thereof;
FIG. 3 is a top view of the tape dispenser illustrated in FIG.
1;

FIG. 4 is a bottom view of the tape dispenser illustrated in
FIG. 1;

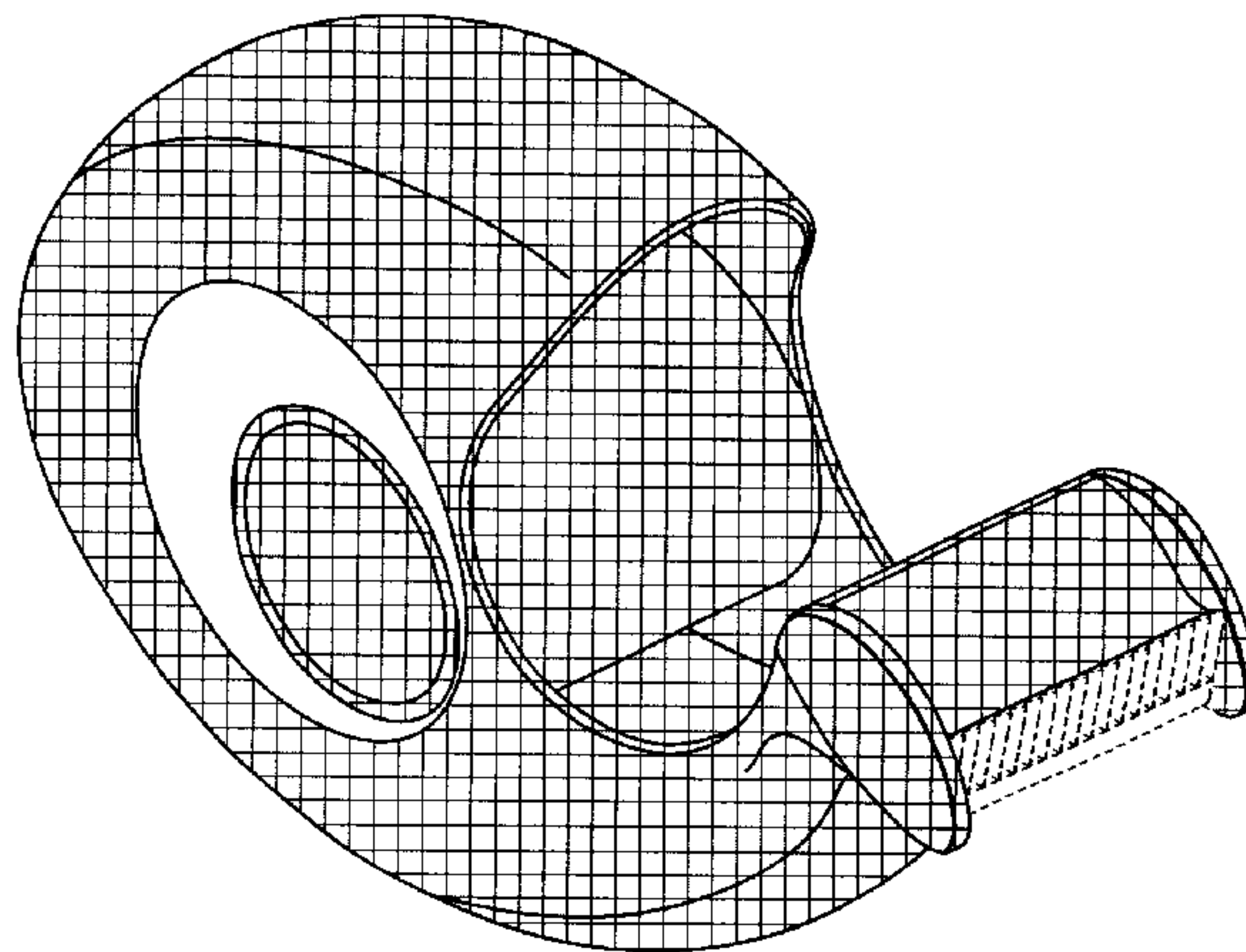
FIG. 5 is a front view of the tape dispenser illustrated in FIG.
1; and,

FIG. 6 is a rear view of the tape dispenser illustrated in FIG.
1.

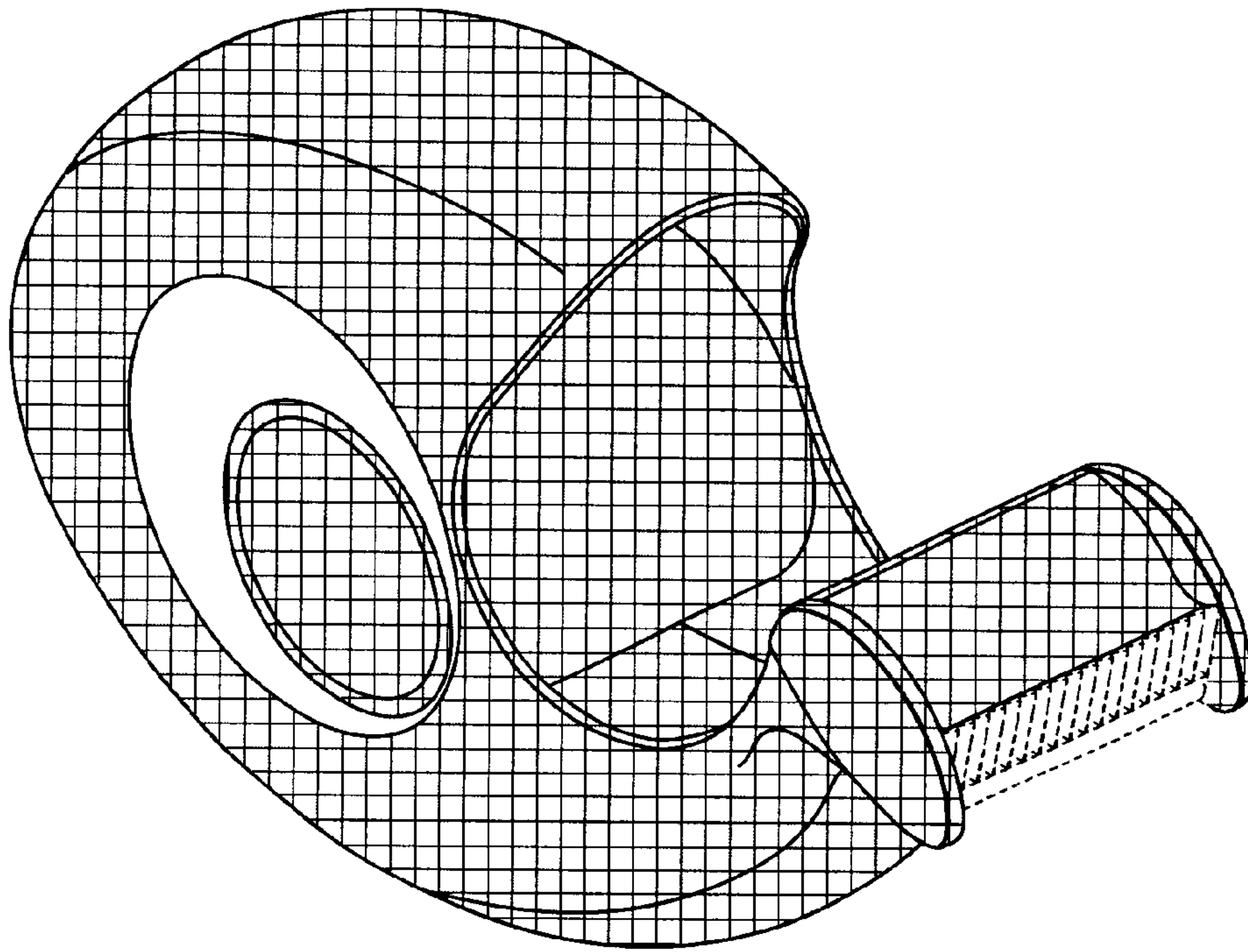

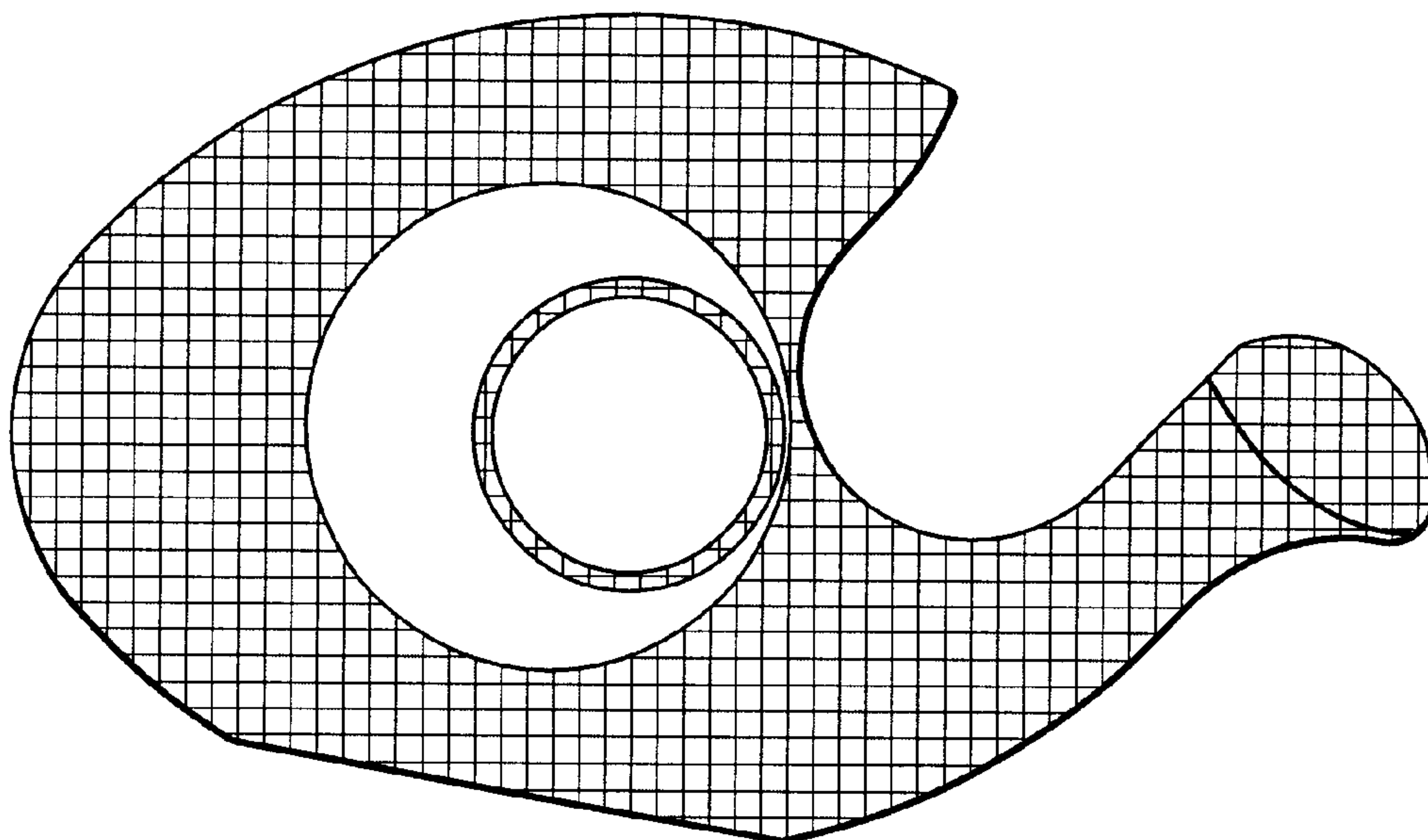

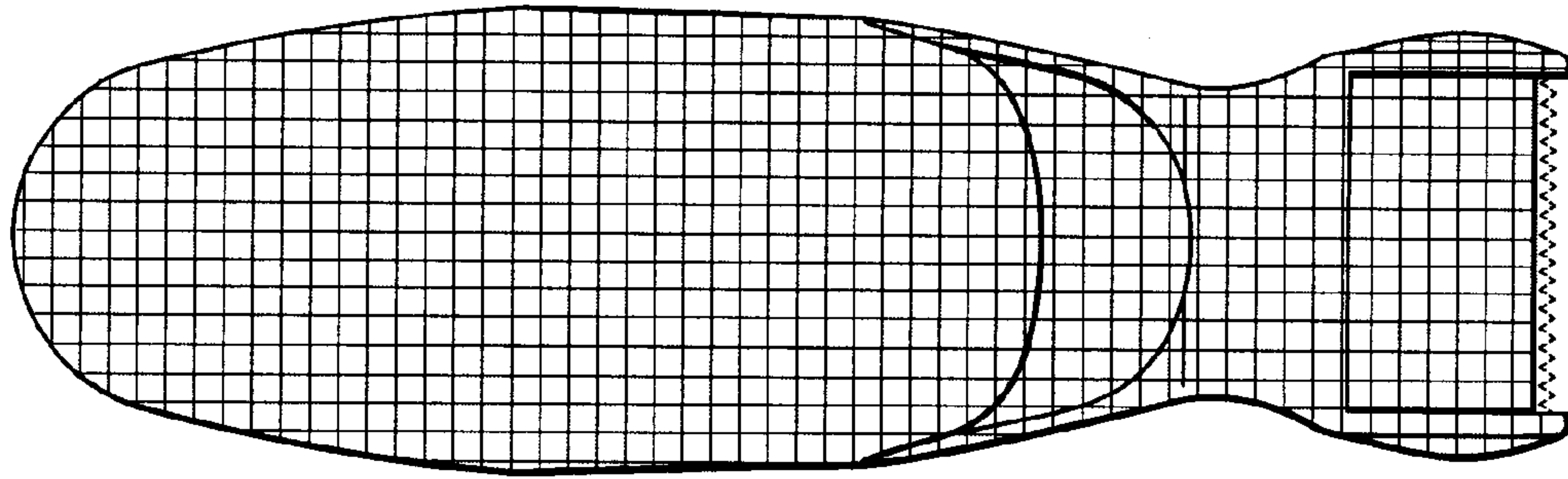

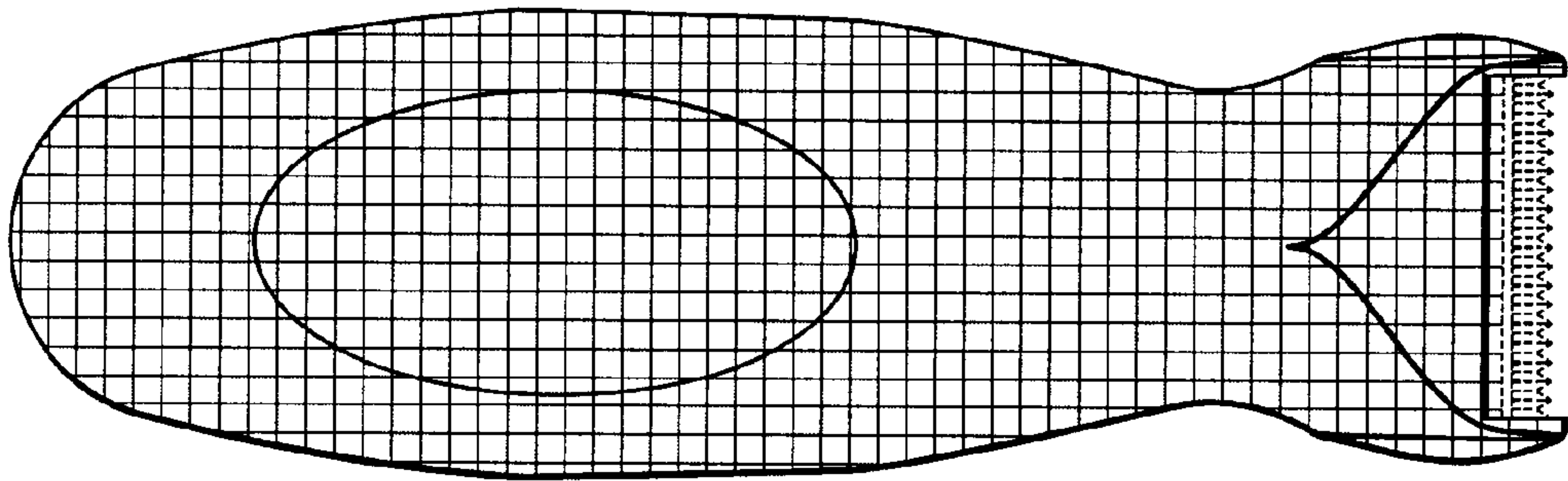

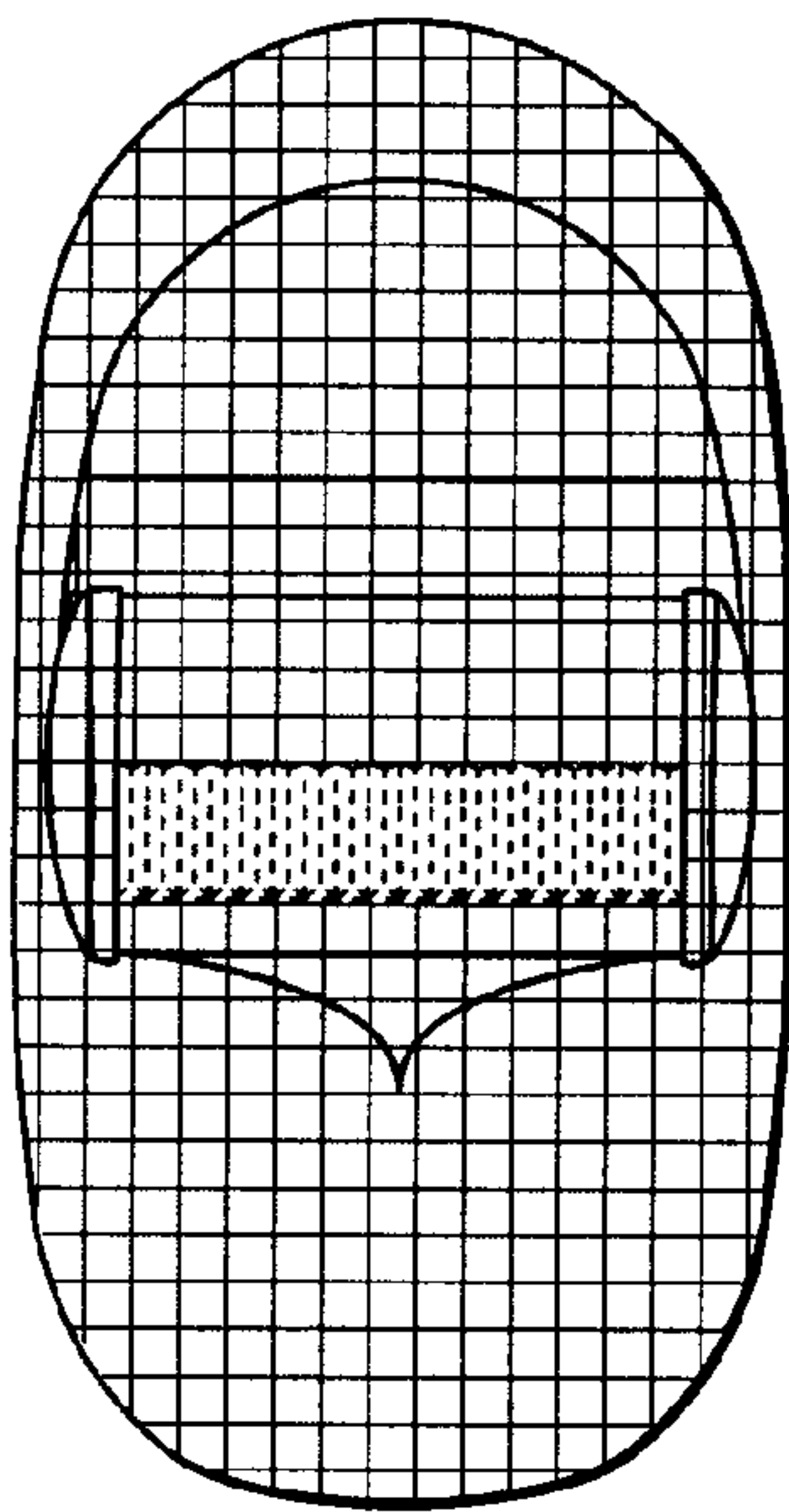

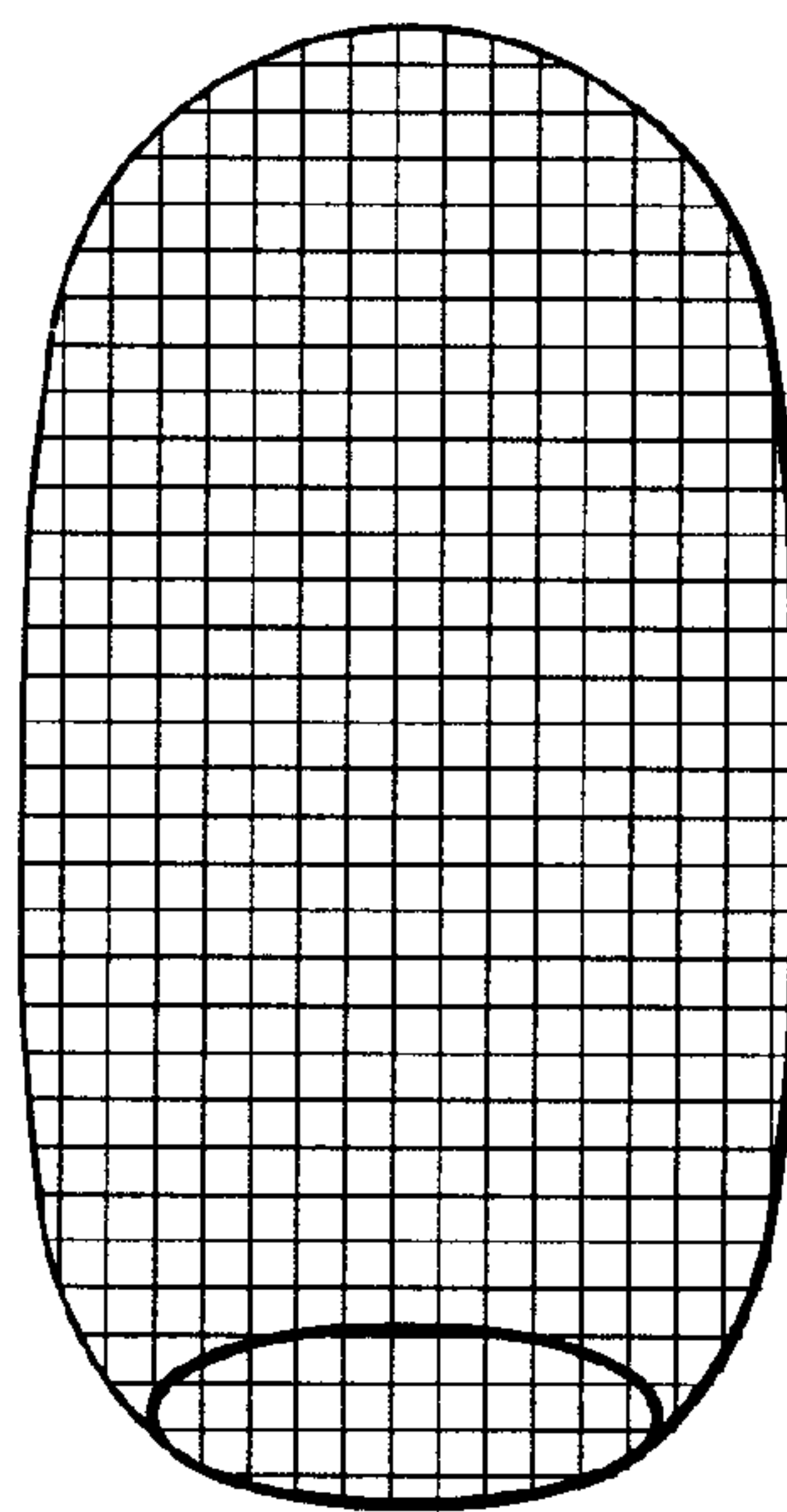
