FIG. 4 is a top plan view thereof;

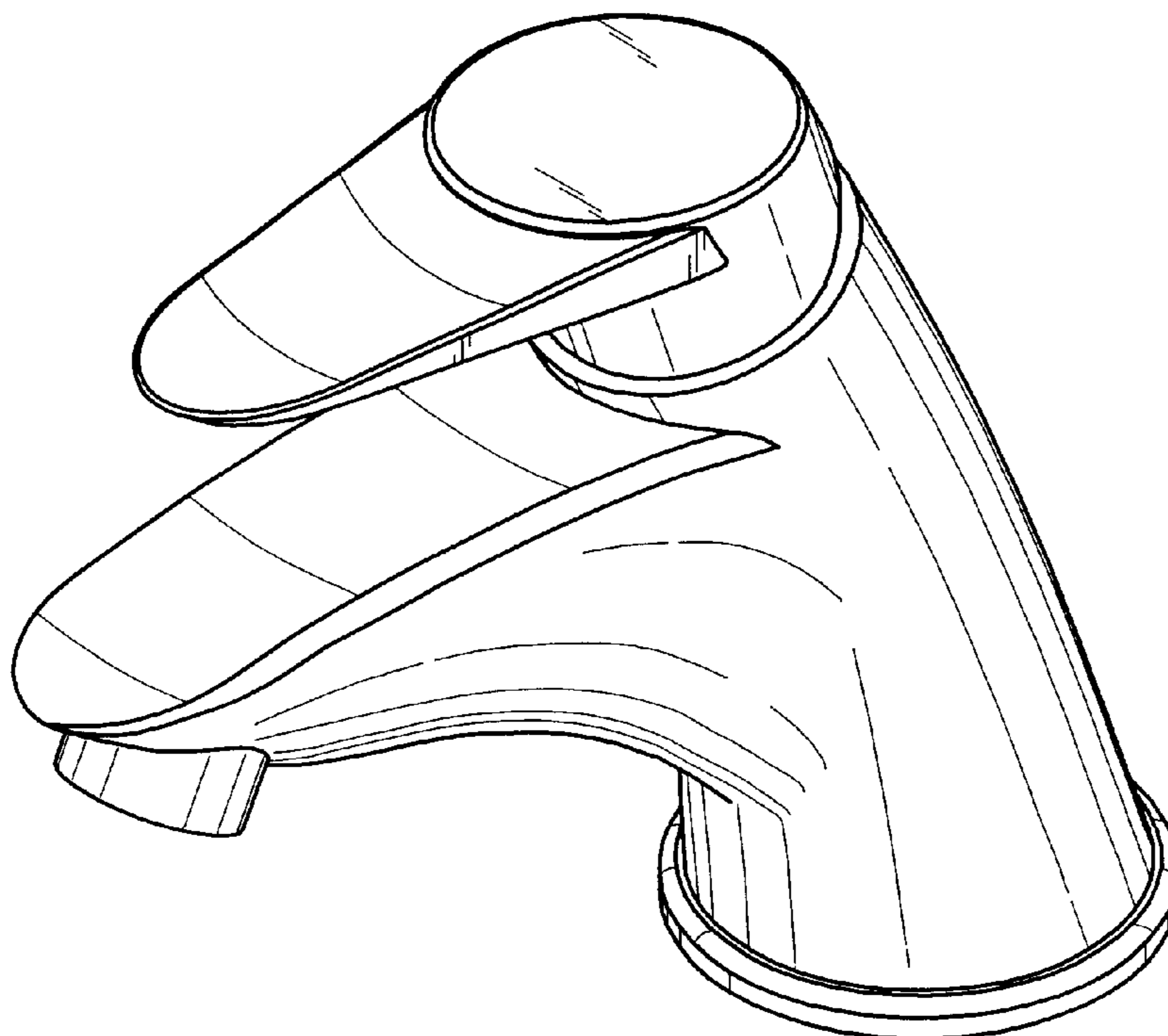
FIG. 5 is a bottom plan view thereof;

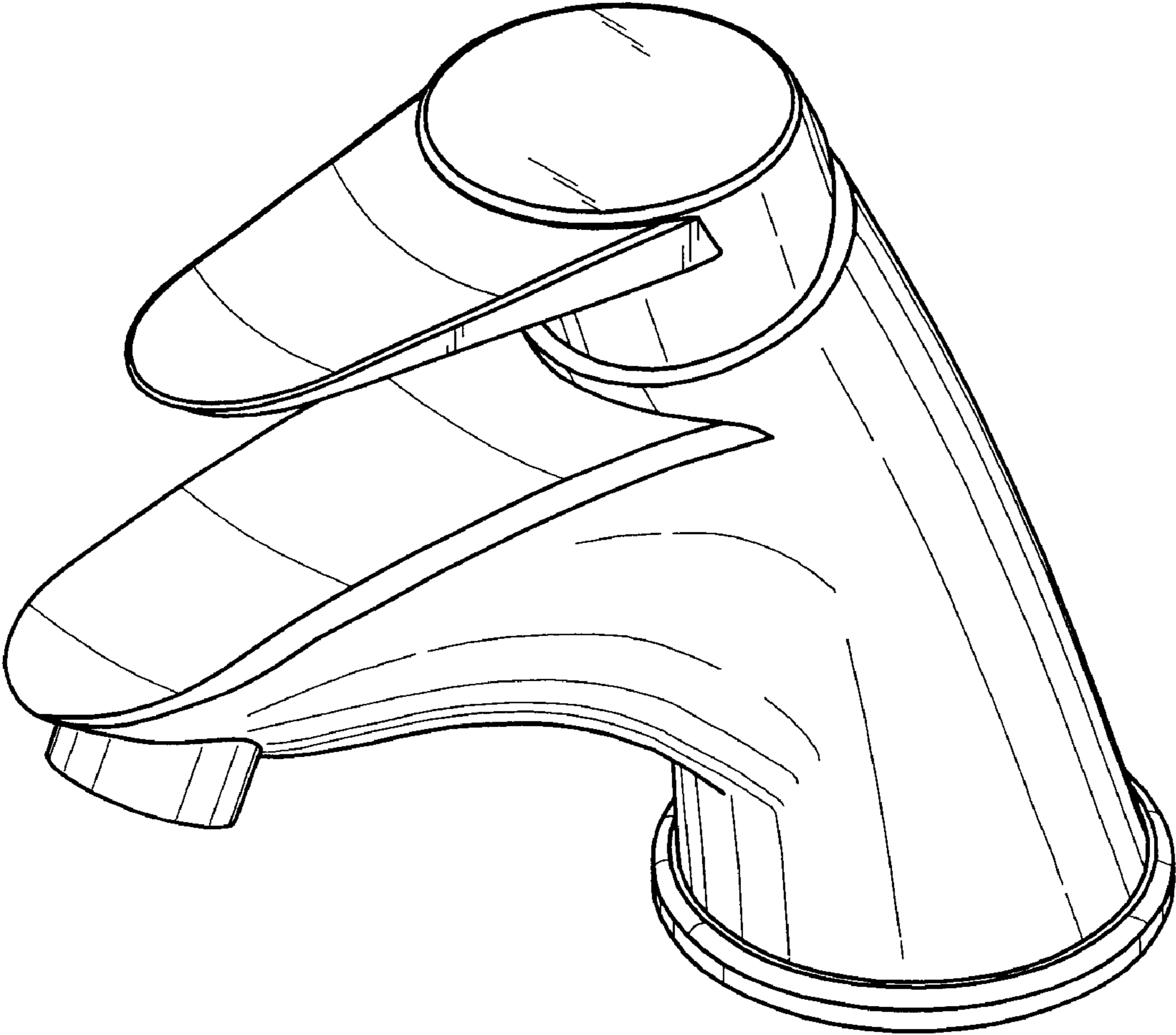
FIG. 6 is a left-side elevation view thereof; and,

FIG. 7 is a right-side elevation view thereof.

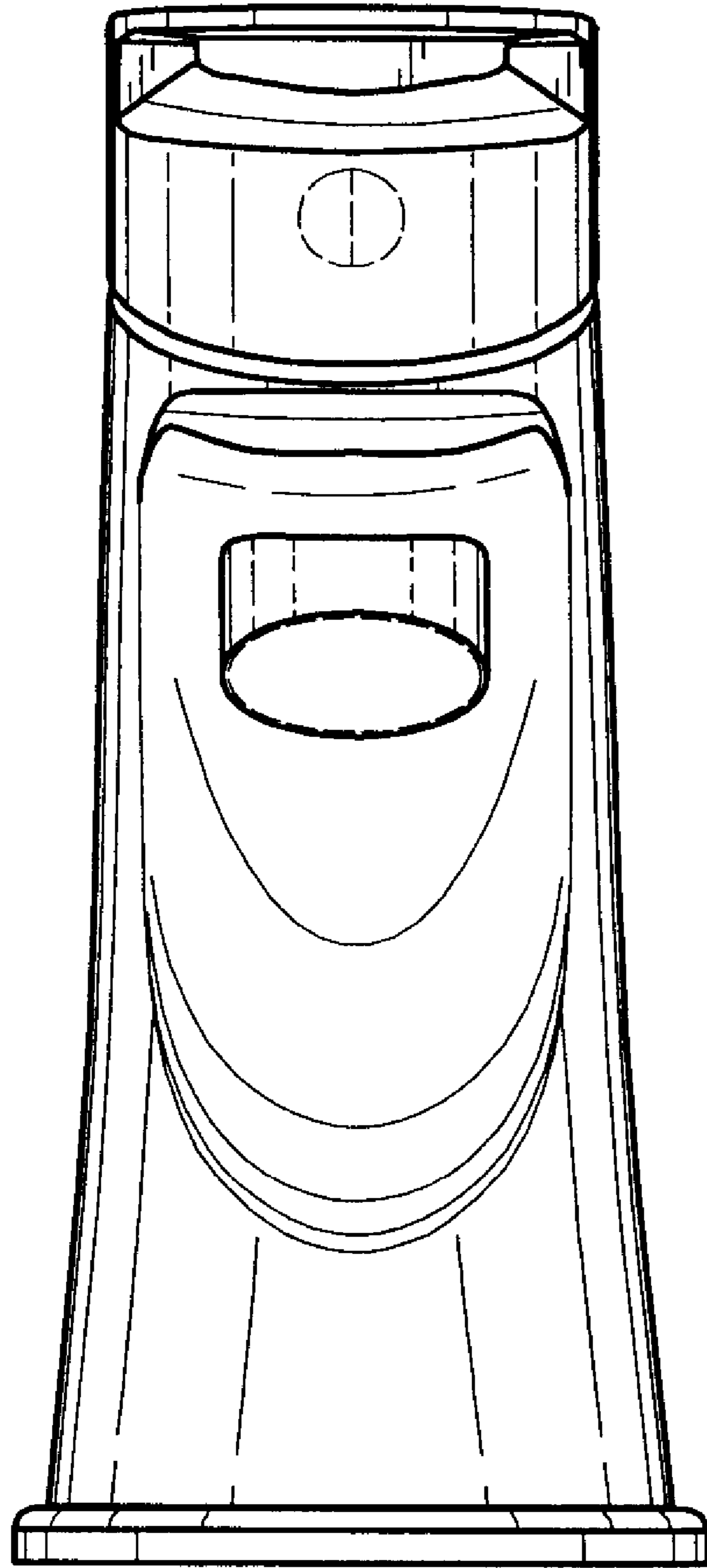
The broken lines in FIGS. 2-7 are for illustrative purposes only and form no part of the claimed design.

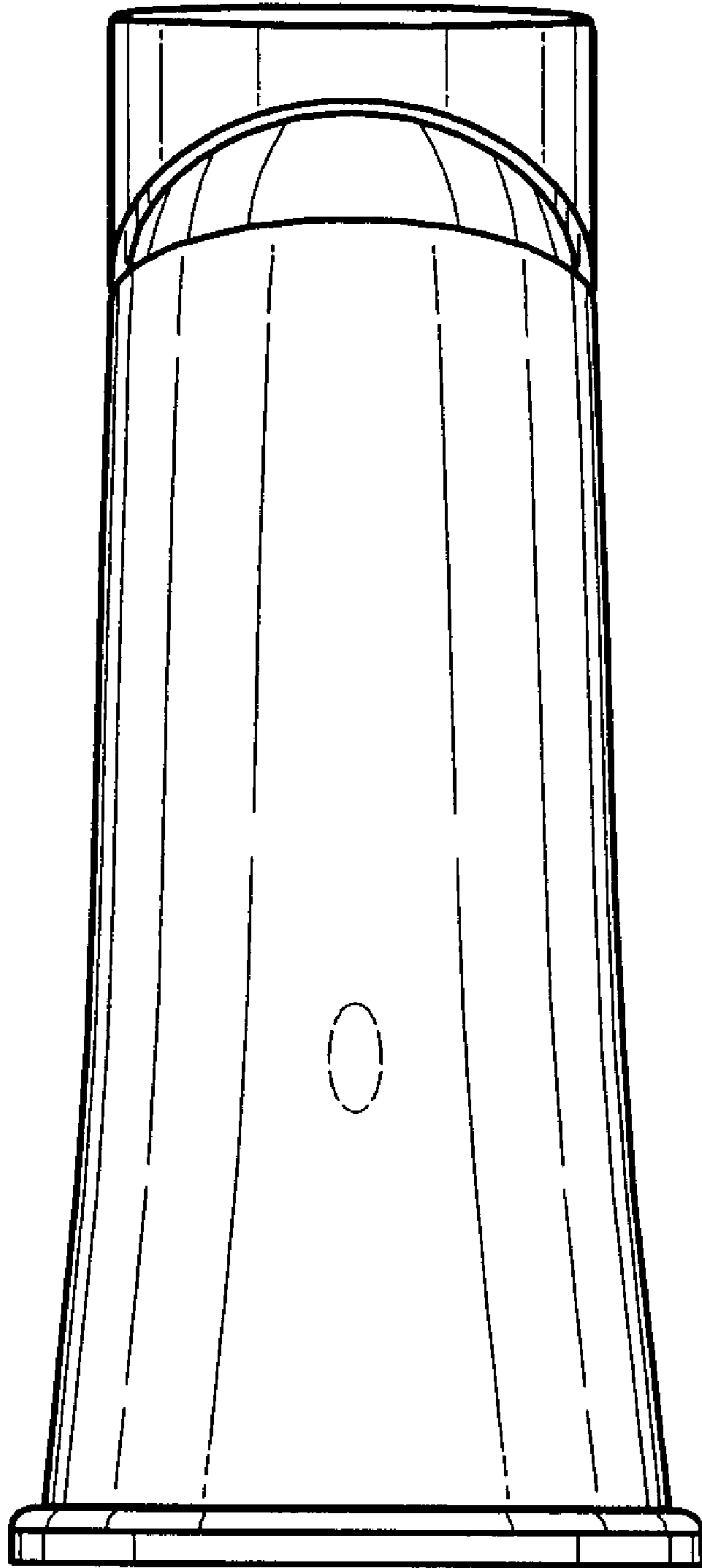




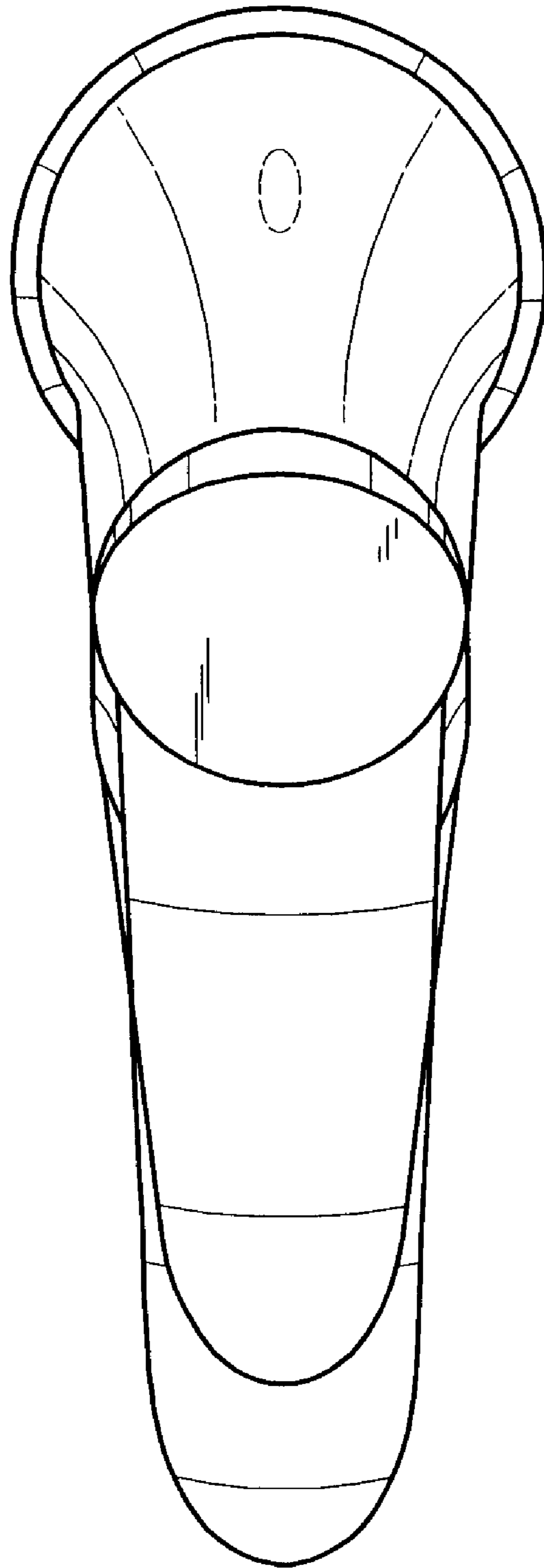

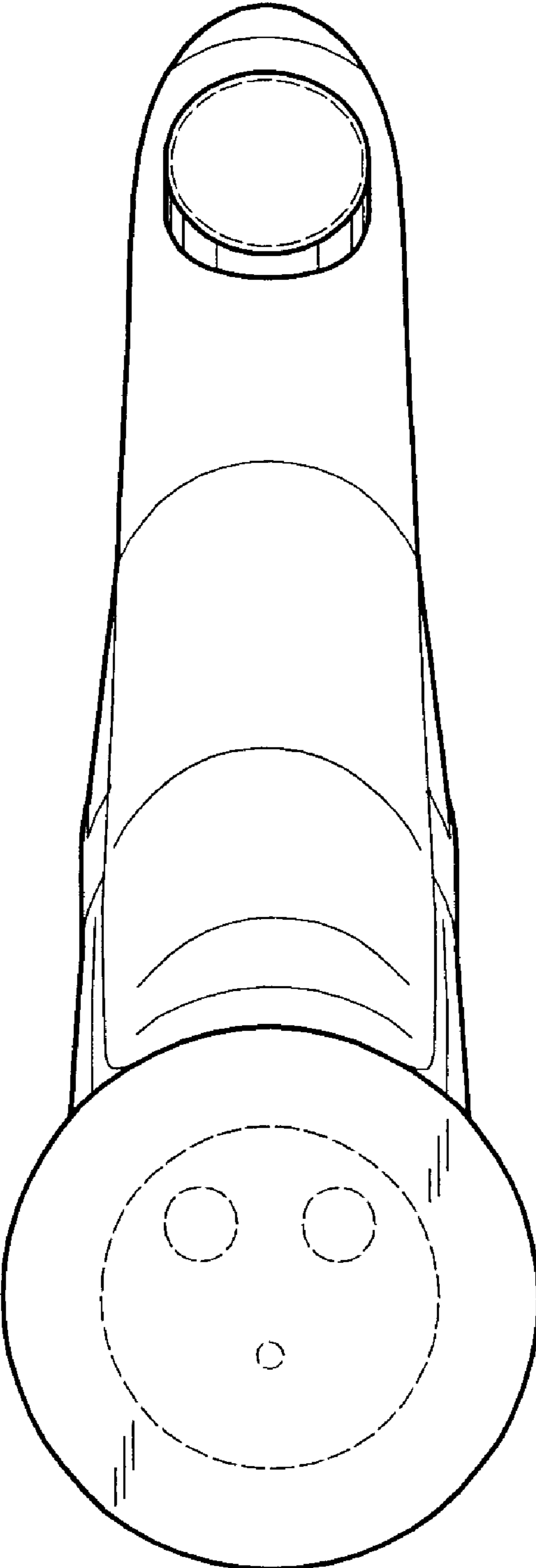

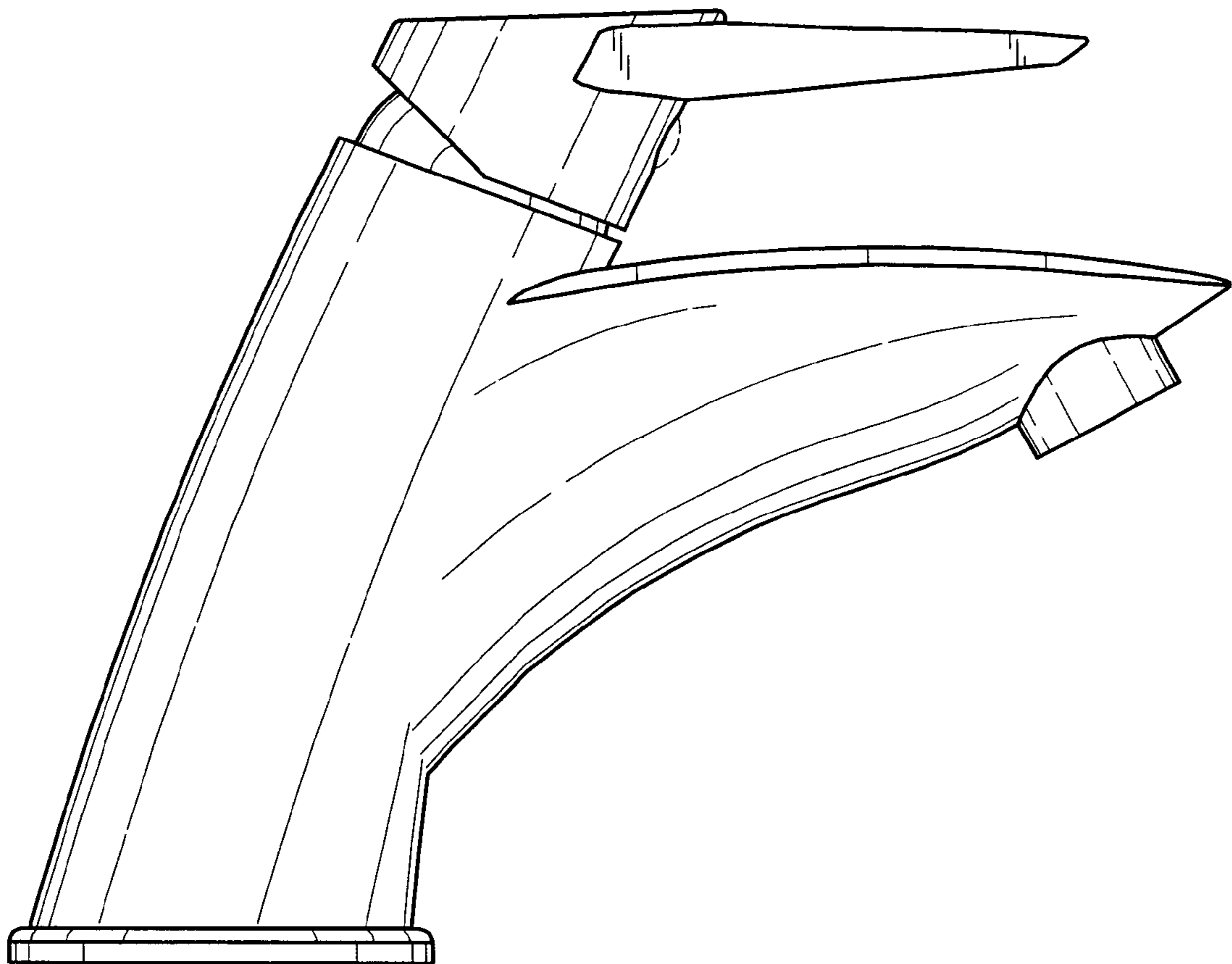

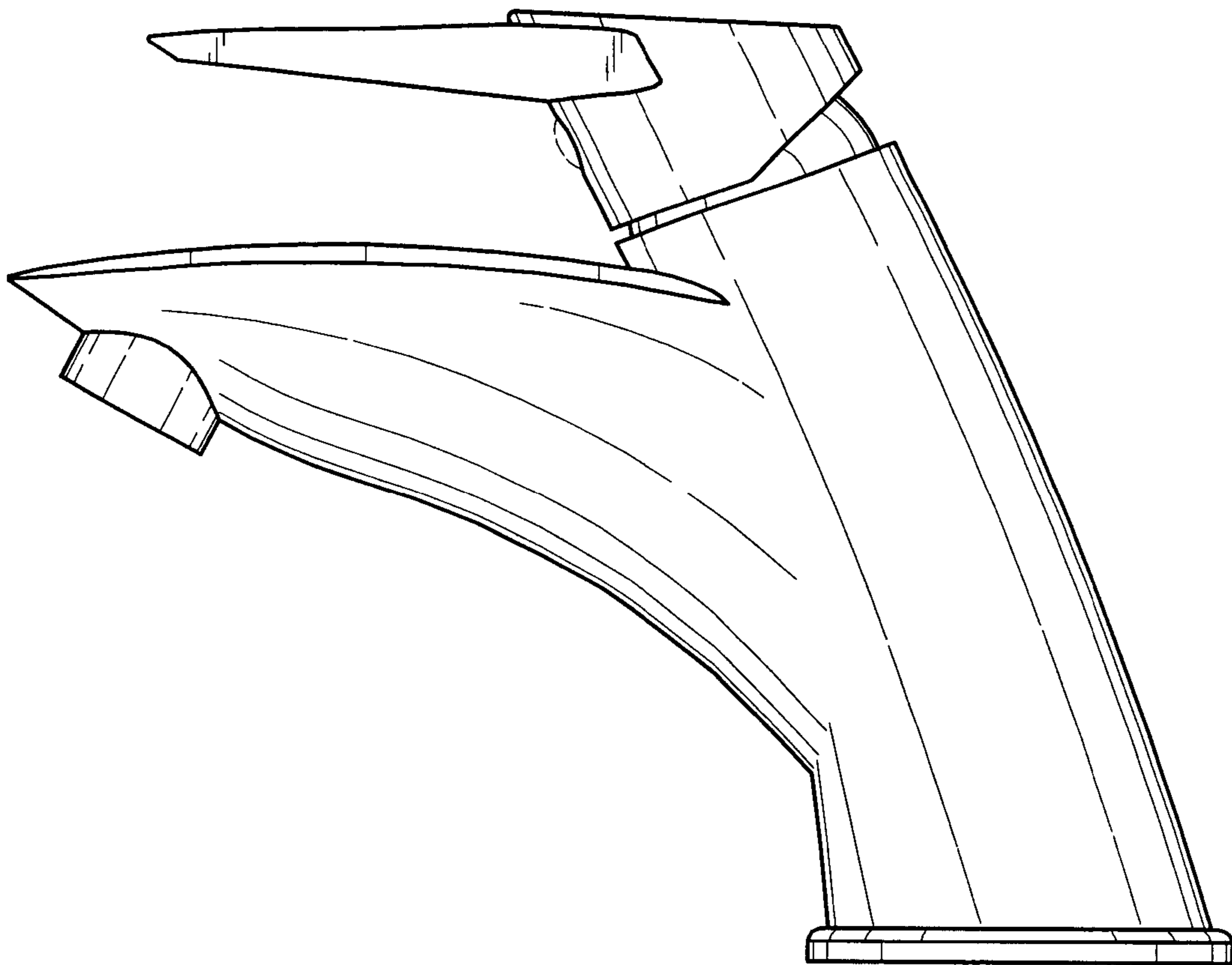
