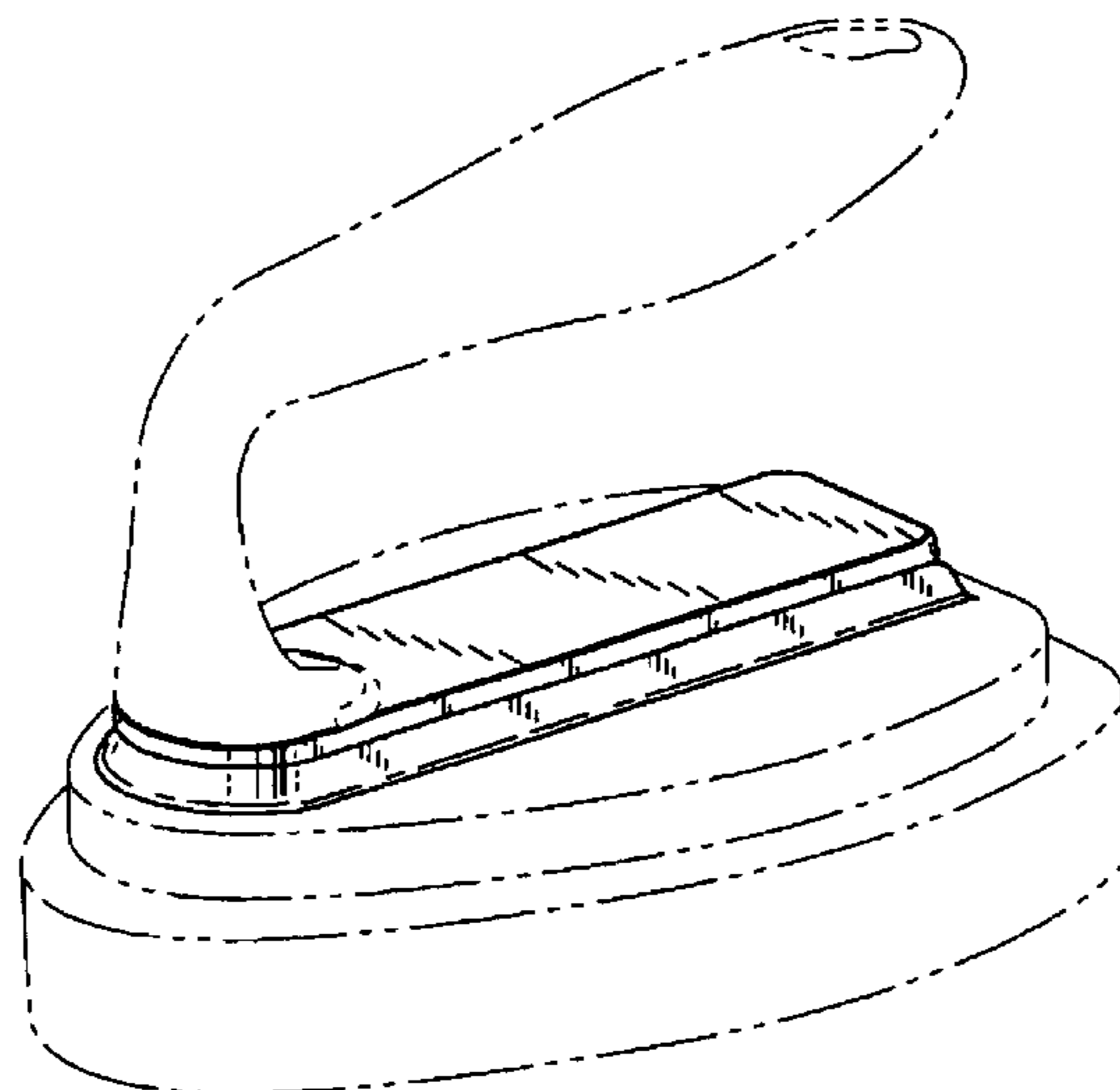
(57) **CLAIM**

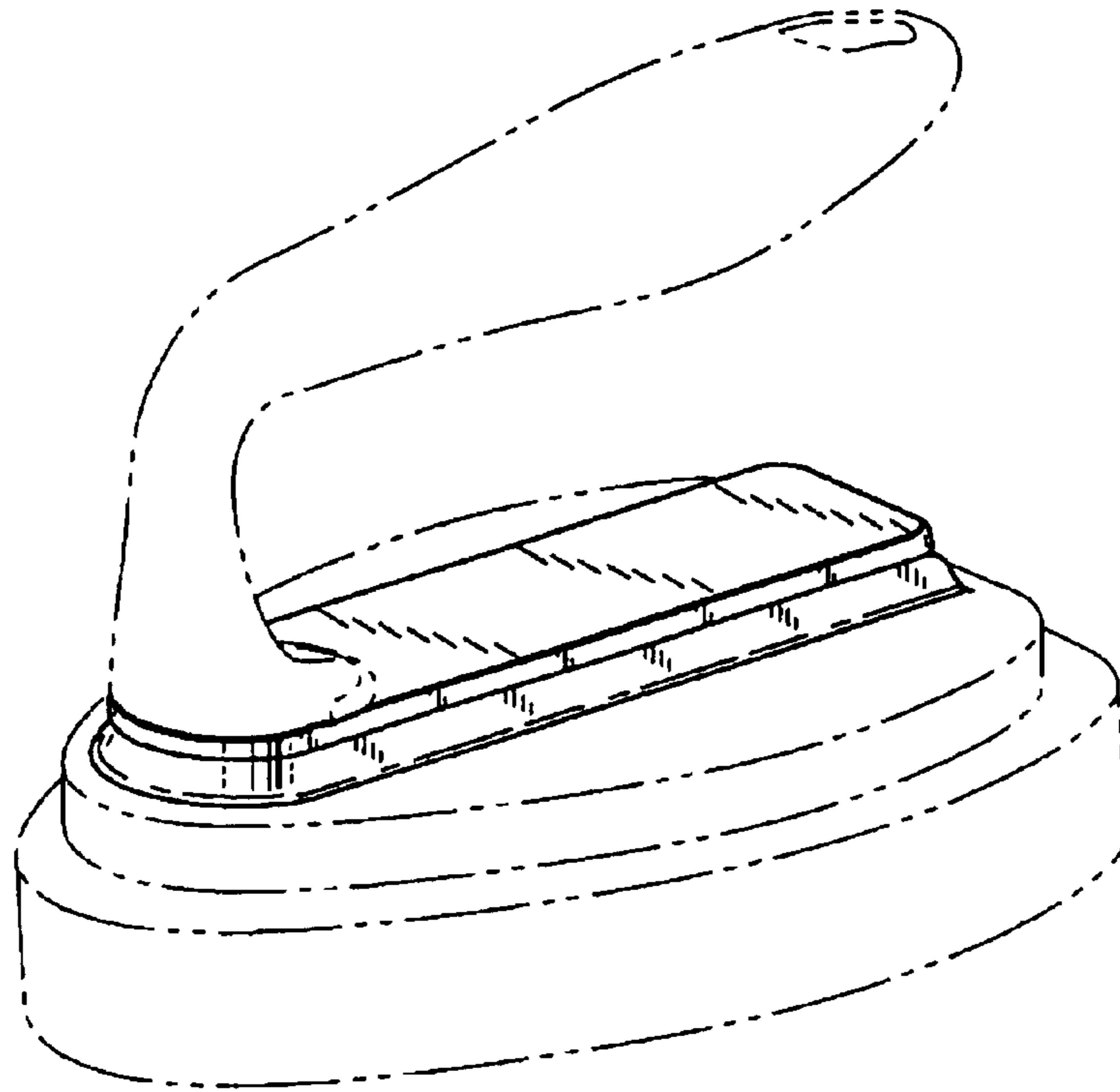
The ornamental design for a household tool with detachable head, substantially as shown and described.

**DESCRIPTION**

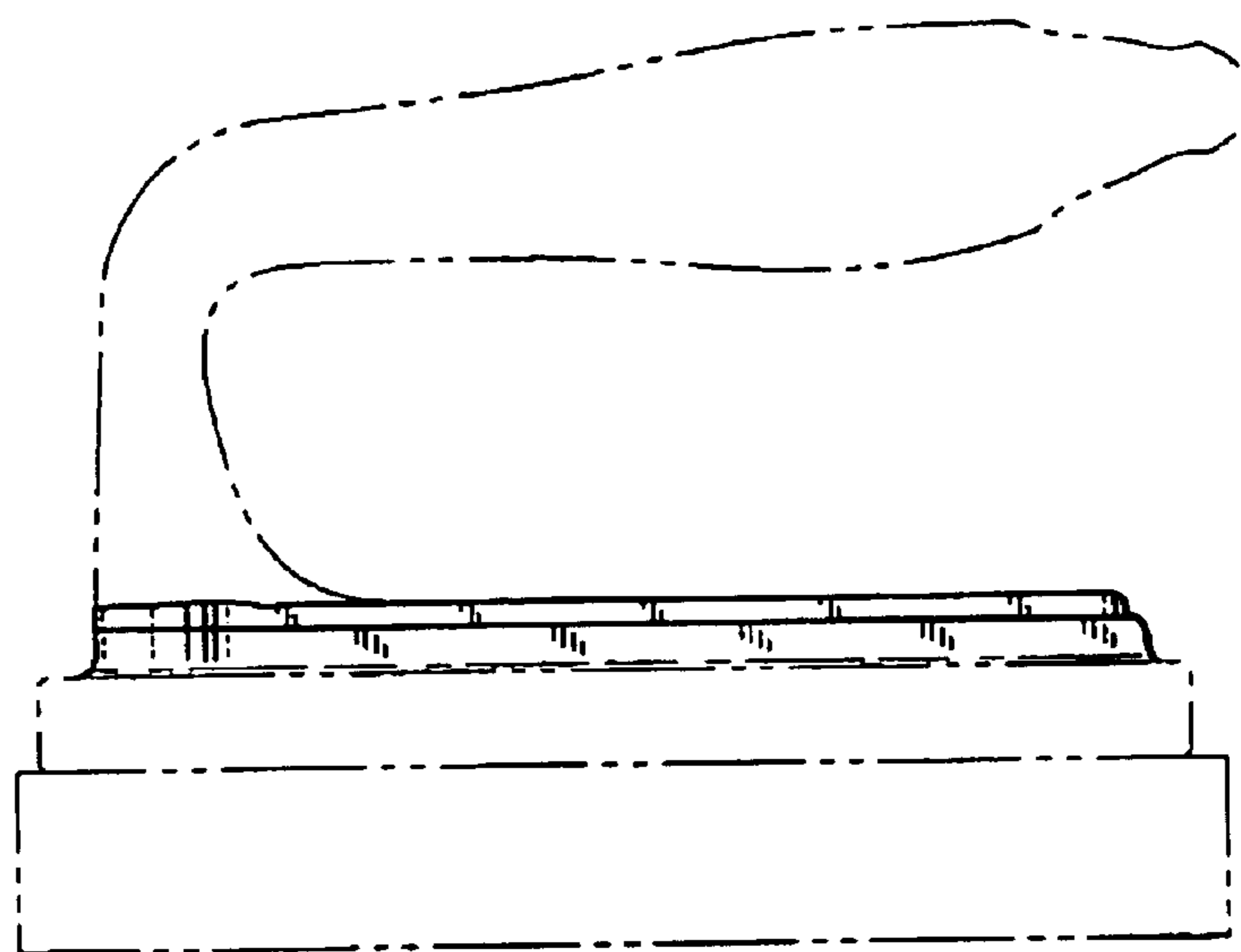
FIG. 1 is a perspective view of a household tool with detachable head showing our new design;  
 FIG. 2 is a side elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom elevational view thereof;  
 FIG. 5 is a rear elevational view thereof; and,  
 FIG. 6 is a front elevational view thereof.  
 The broken line drawing in all figure views is for illustrative purposes only, and forms no part of the claimed design.  
 The forward portion of the unclaimed handle is partially shown in FIG. 3 to illustrate the peripheral edges of the claimed design.

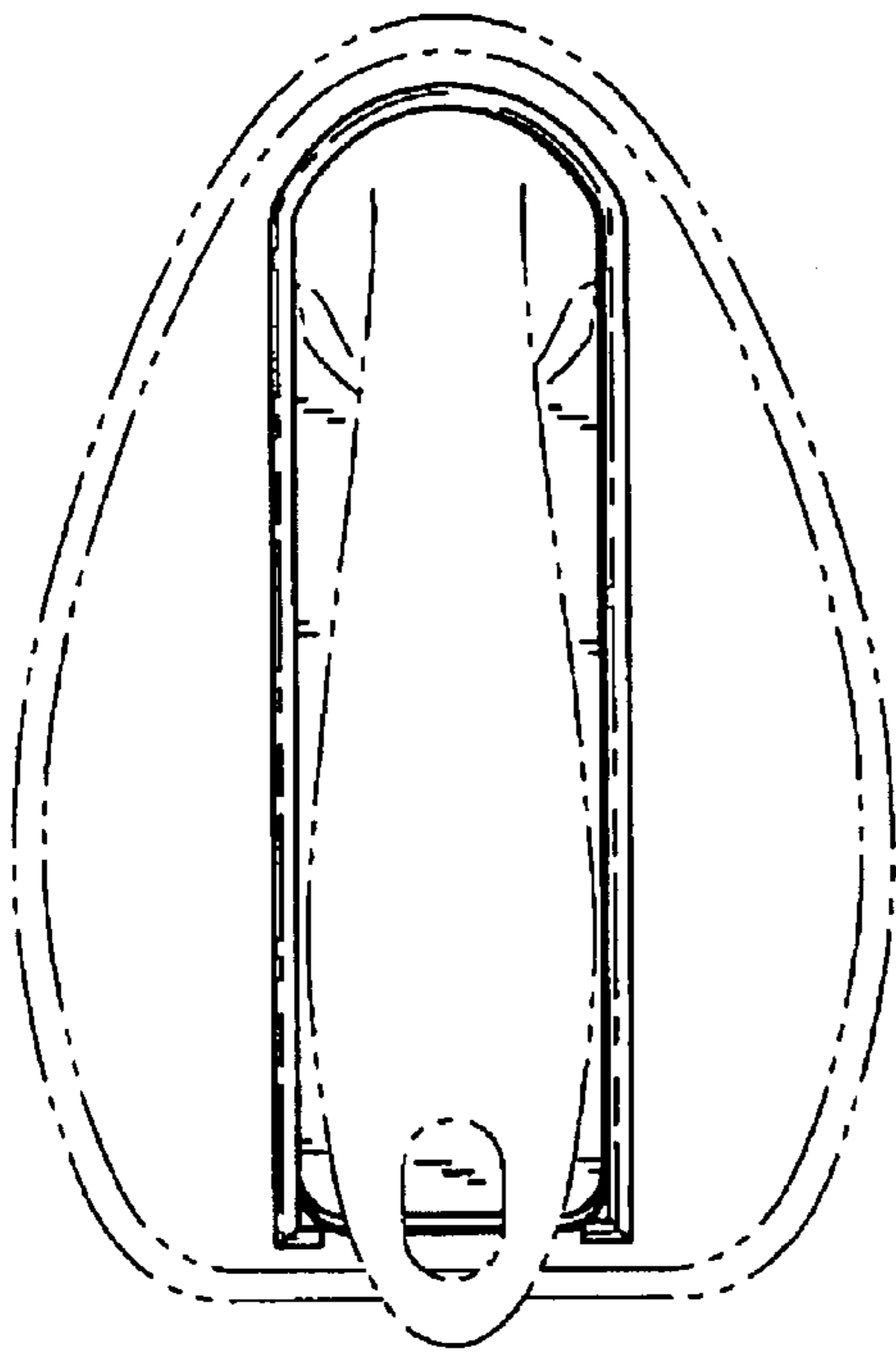




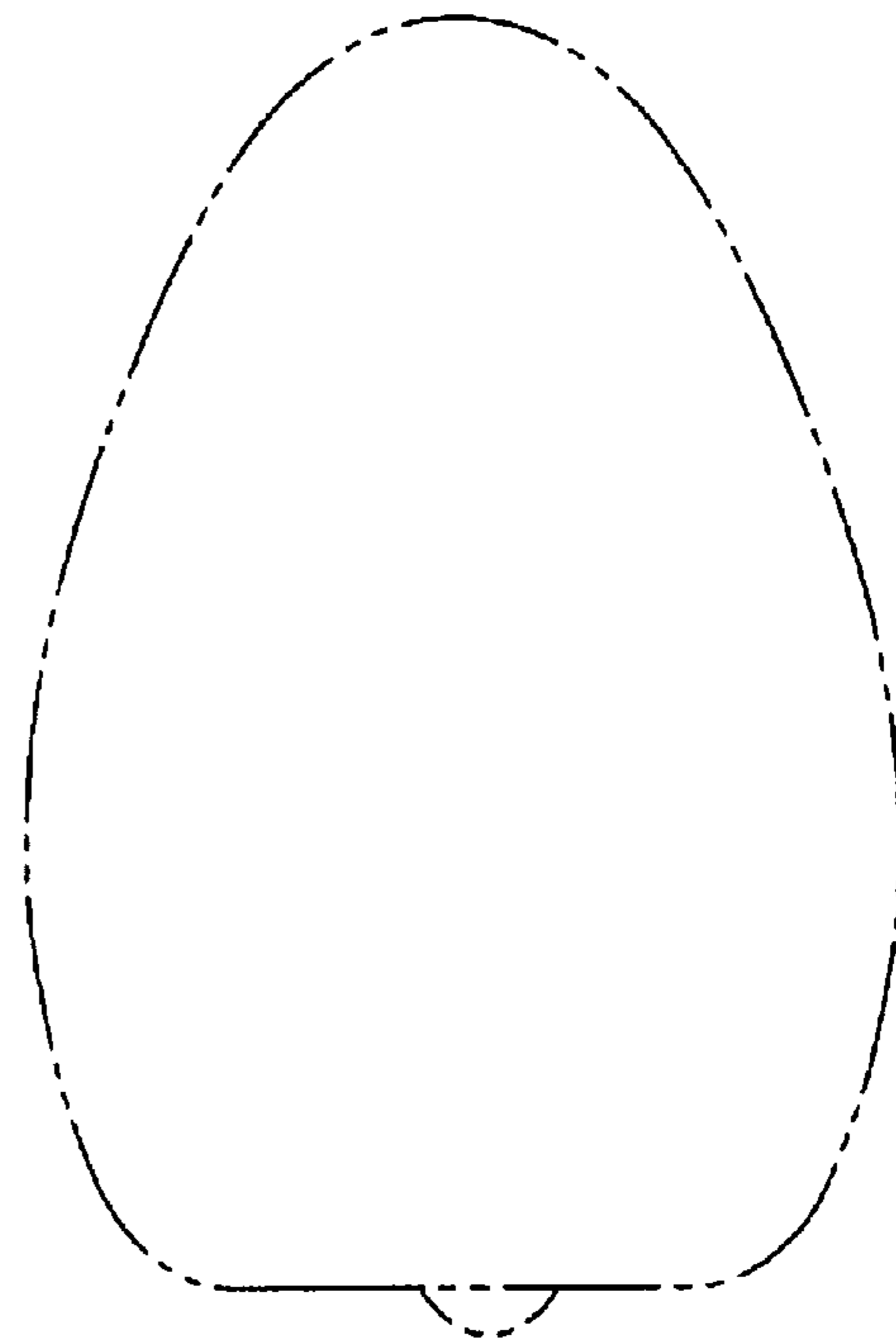

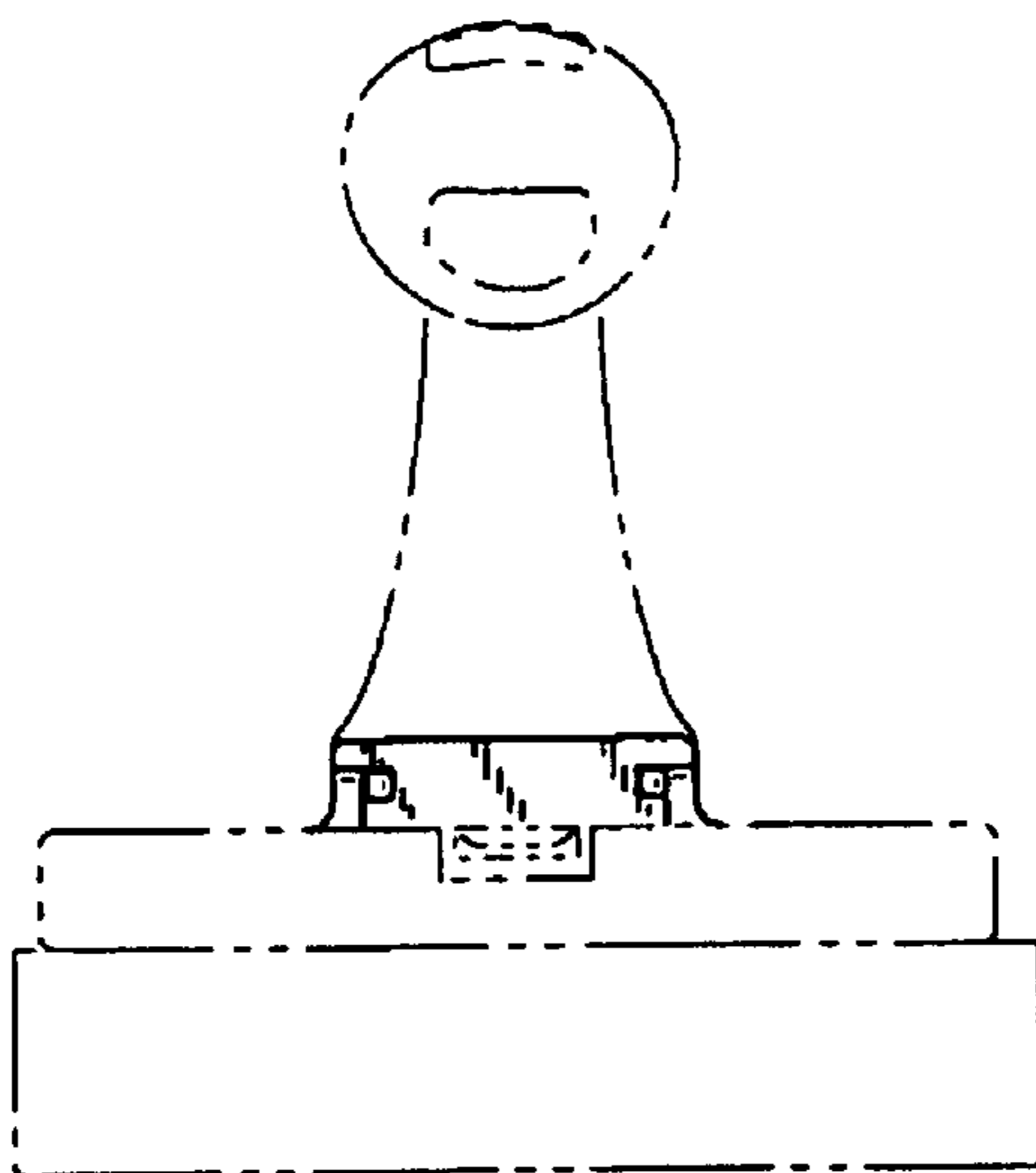

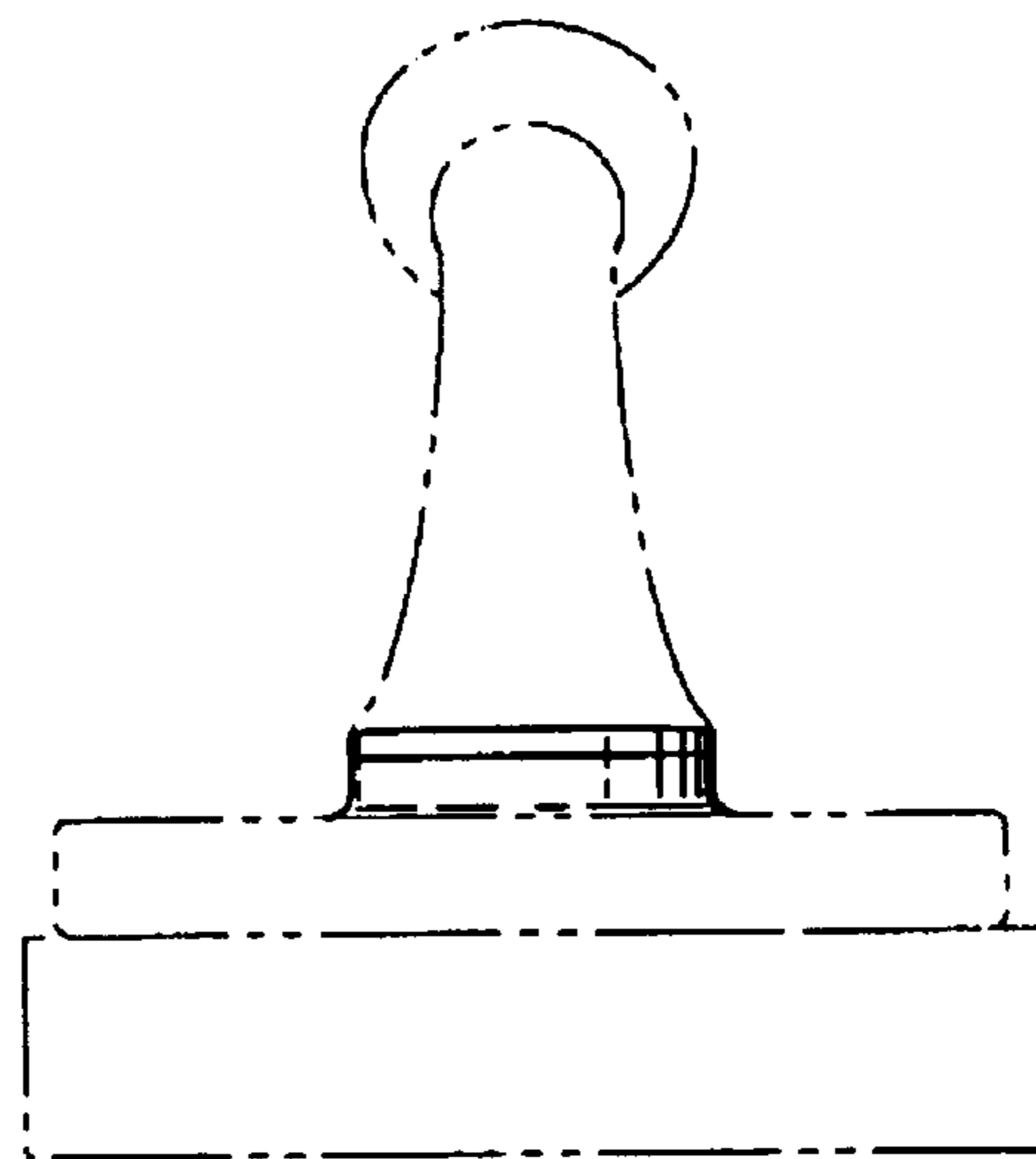
