(57) **CLAIM**

The ornamental design for a candy or confection having bunny caricature, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a design for a candy or confection having the surface ornamentation of a bunny caricature.

FIG. 2 is a right side view of the design of FIG. 1.

FIG. 3 is a left side view of the design of FIG. 1.

FIG. 4 is a top view of the design of FIG. 1; and,

FIG. 5 is a bottom view of the design of FIG. 1.

The dotted lines illustrate the environment for the design for a candy or confection, and are not part of the design.

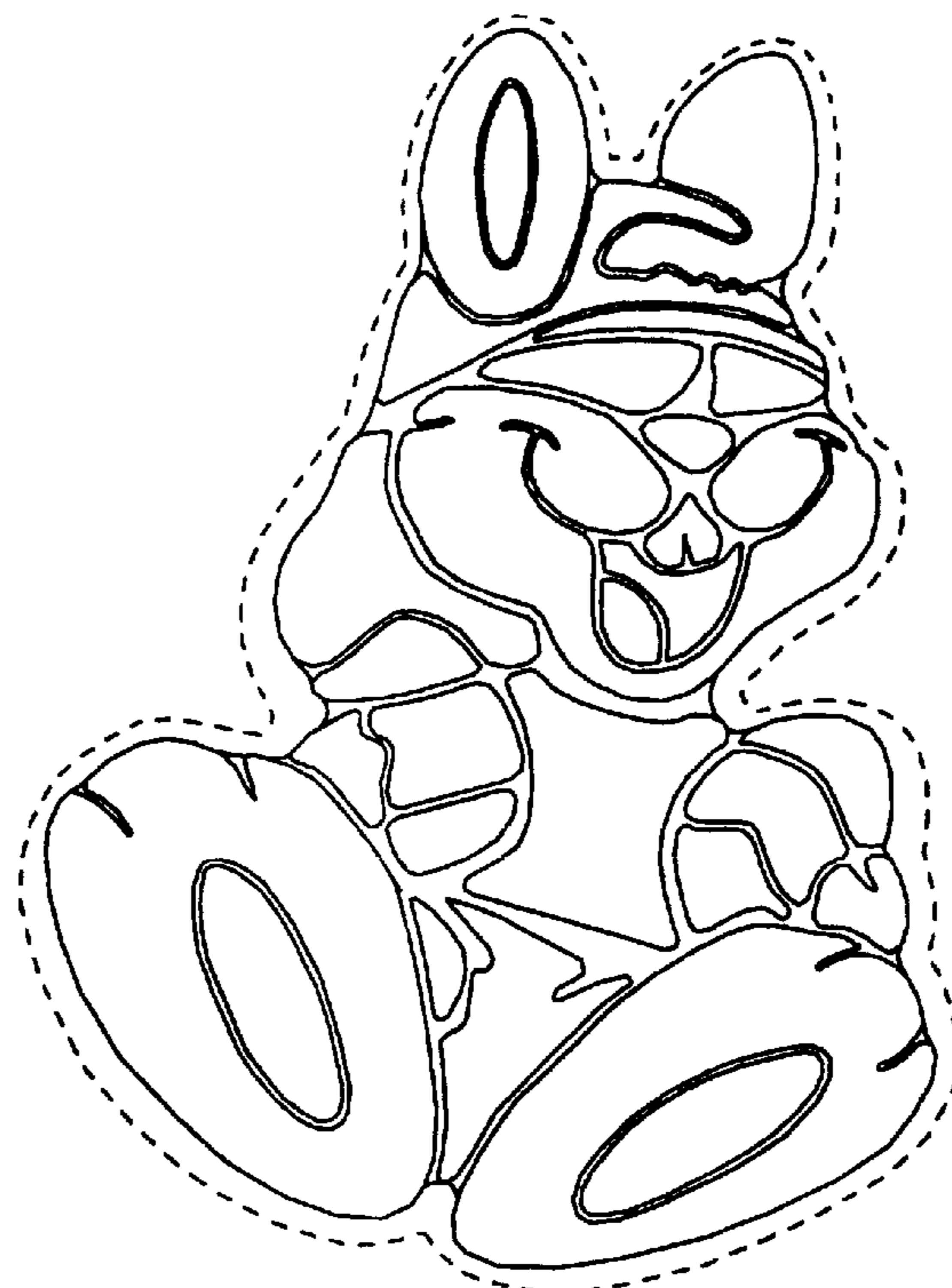

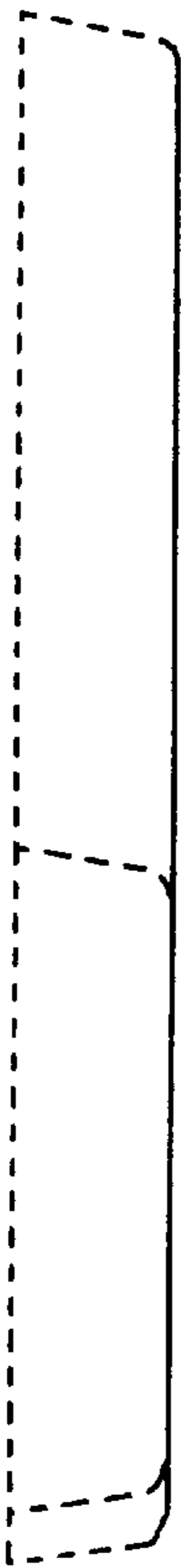

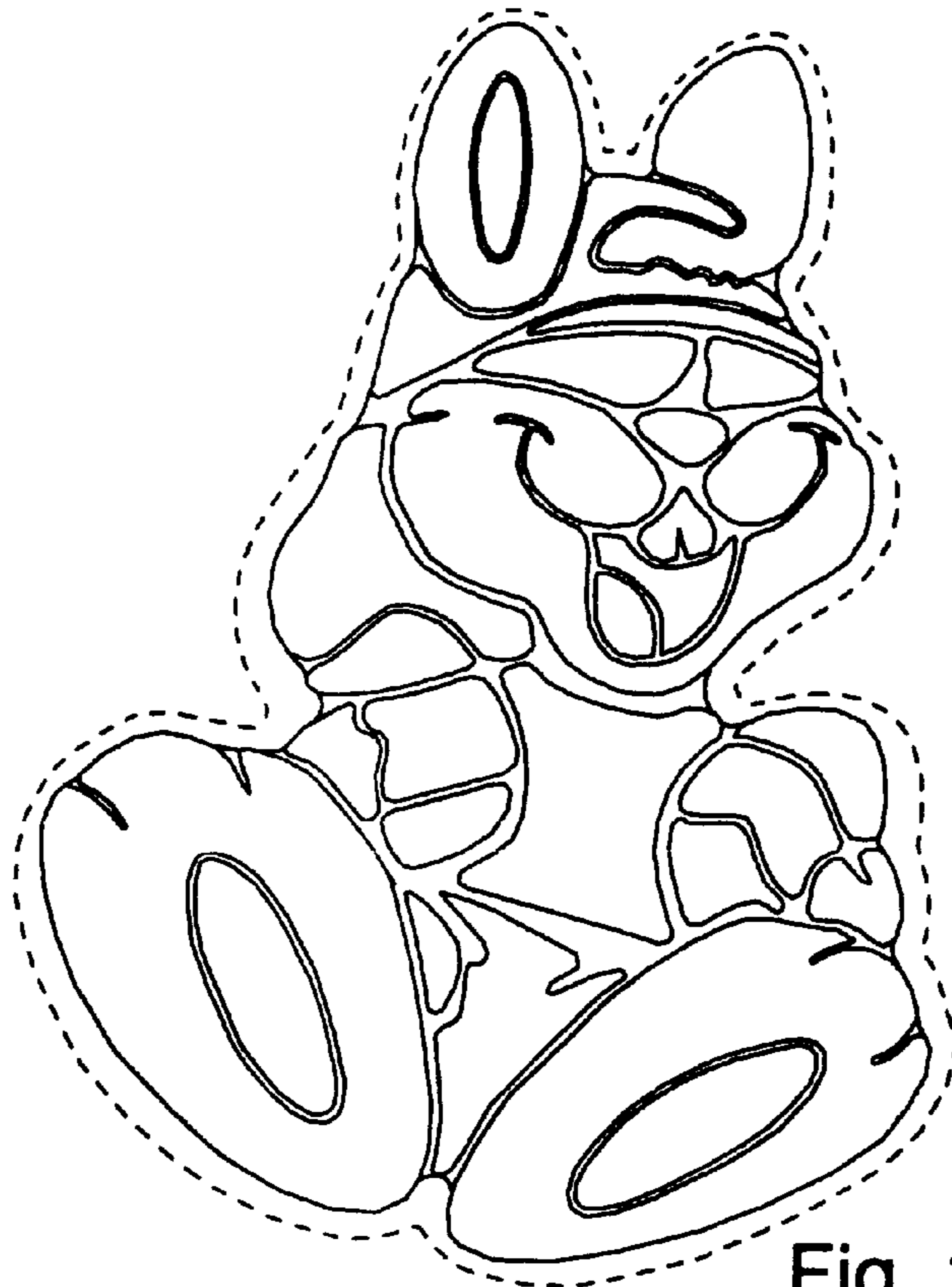

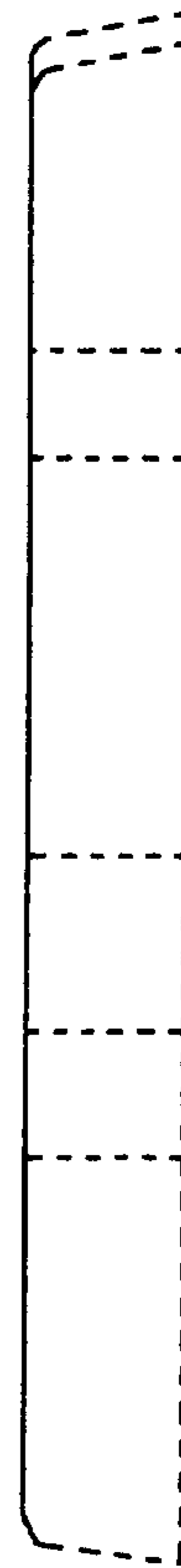

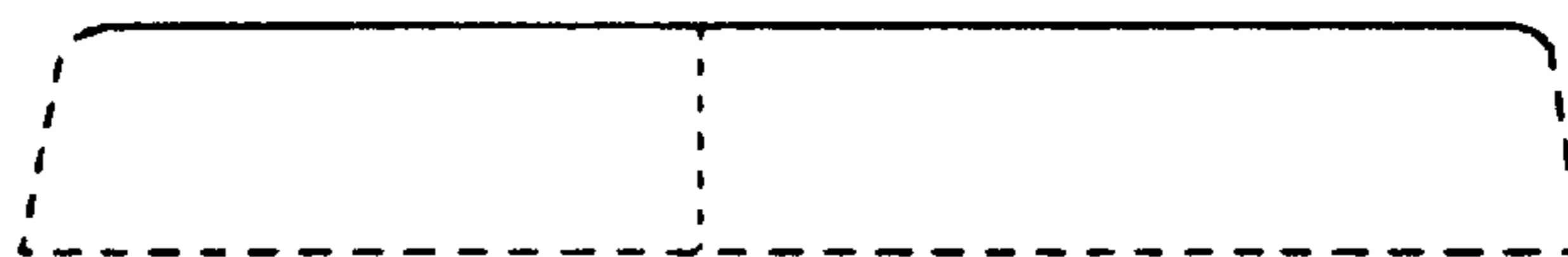
