(57) **CLAIM**

The ornamental design for a T-shirt, as shown and described.

DESCRIPTION

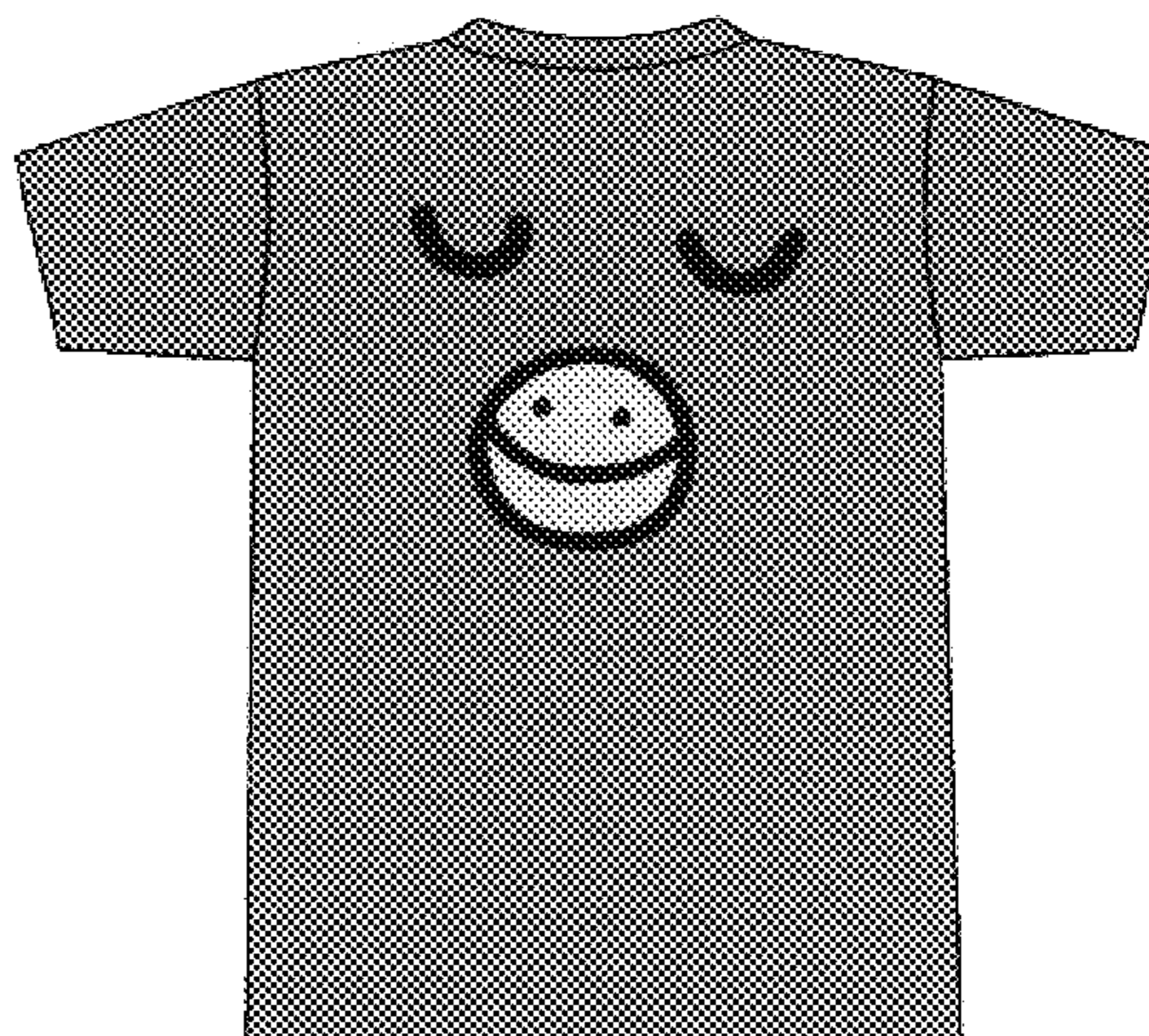

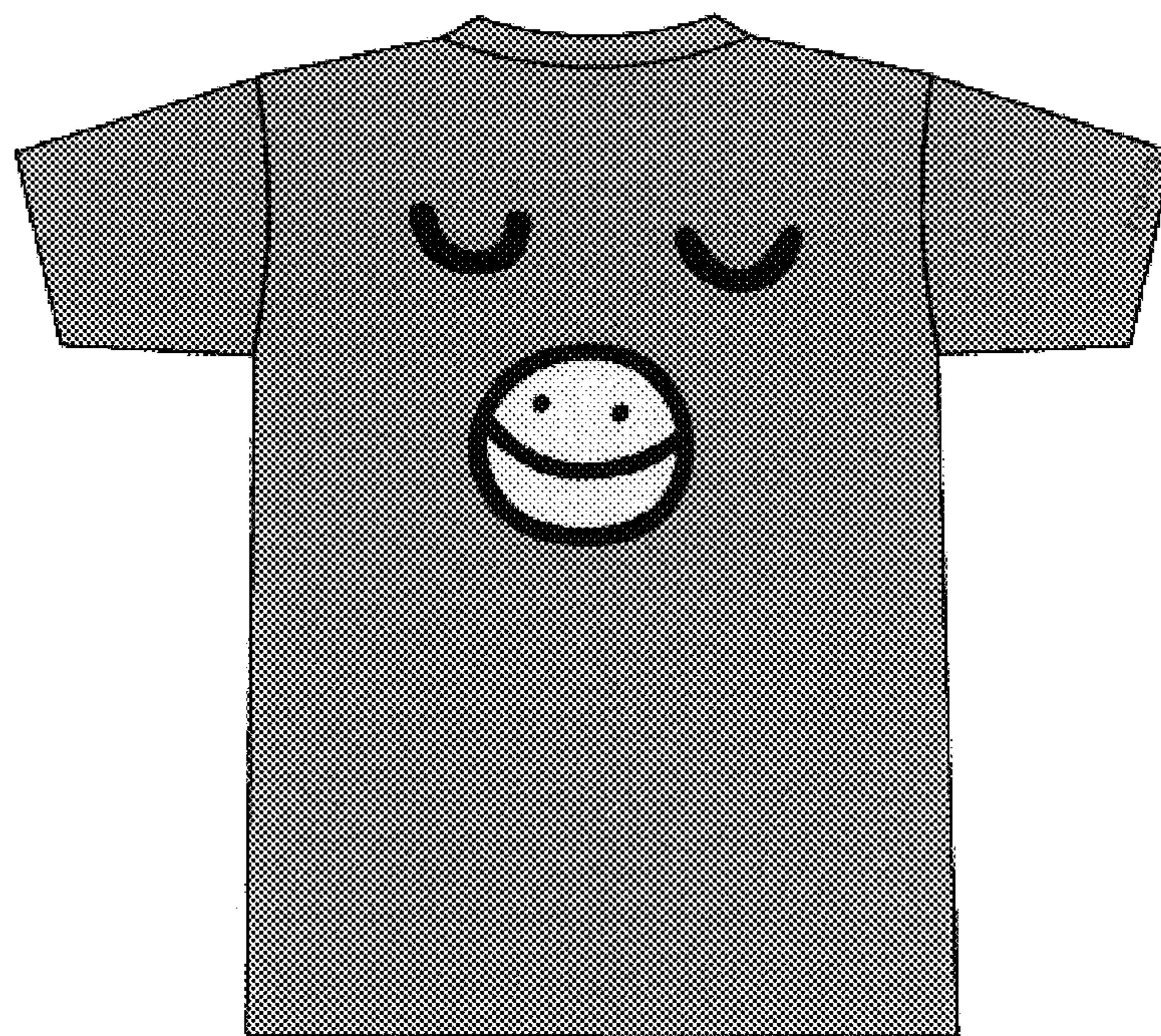

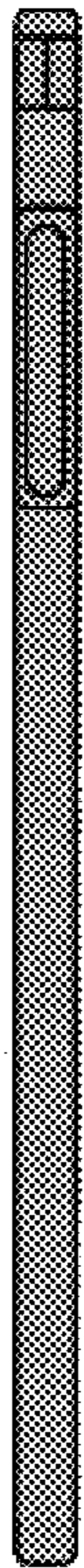

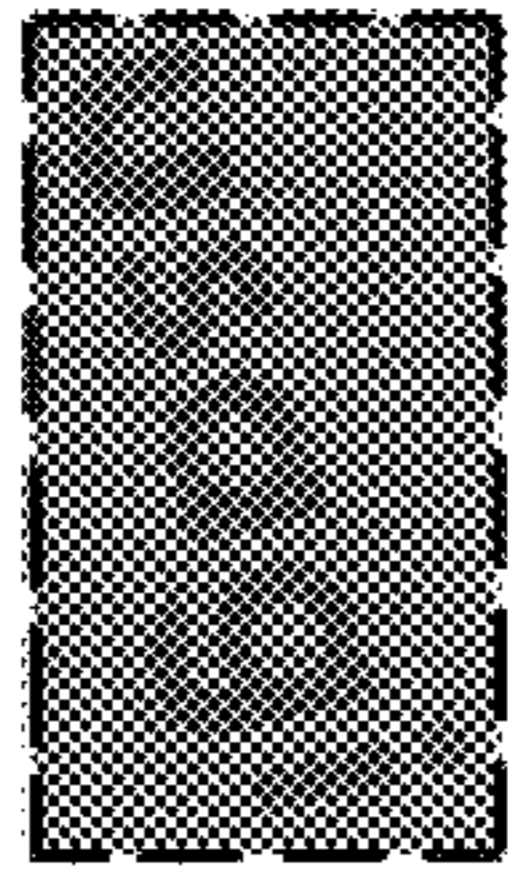

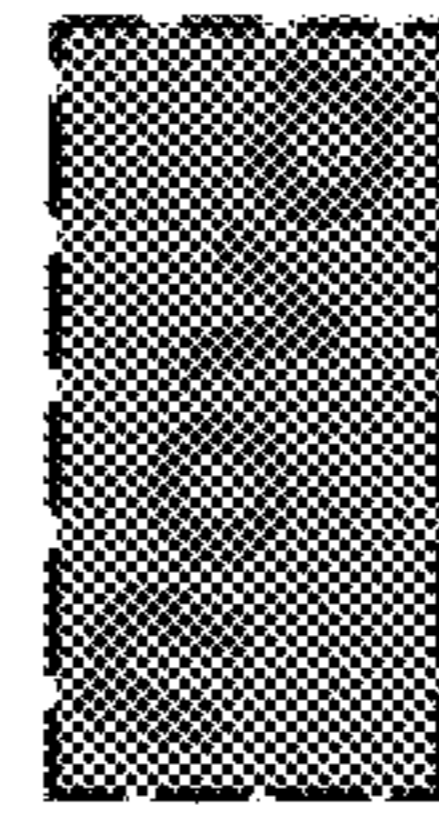
