(57) **CLAIM**

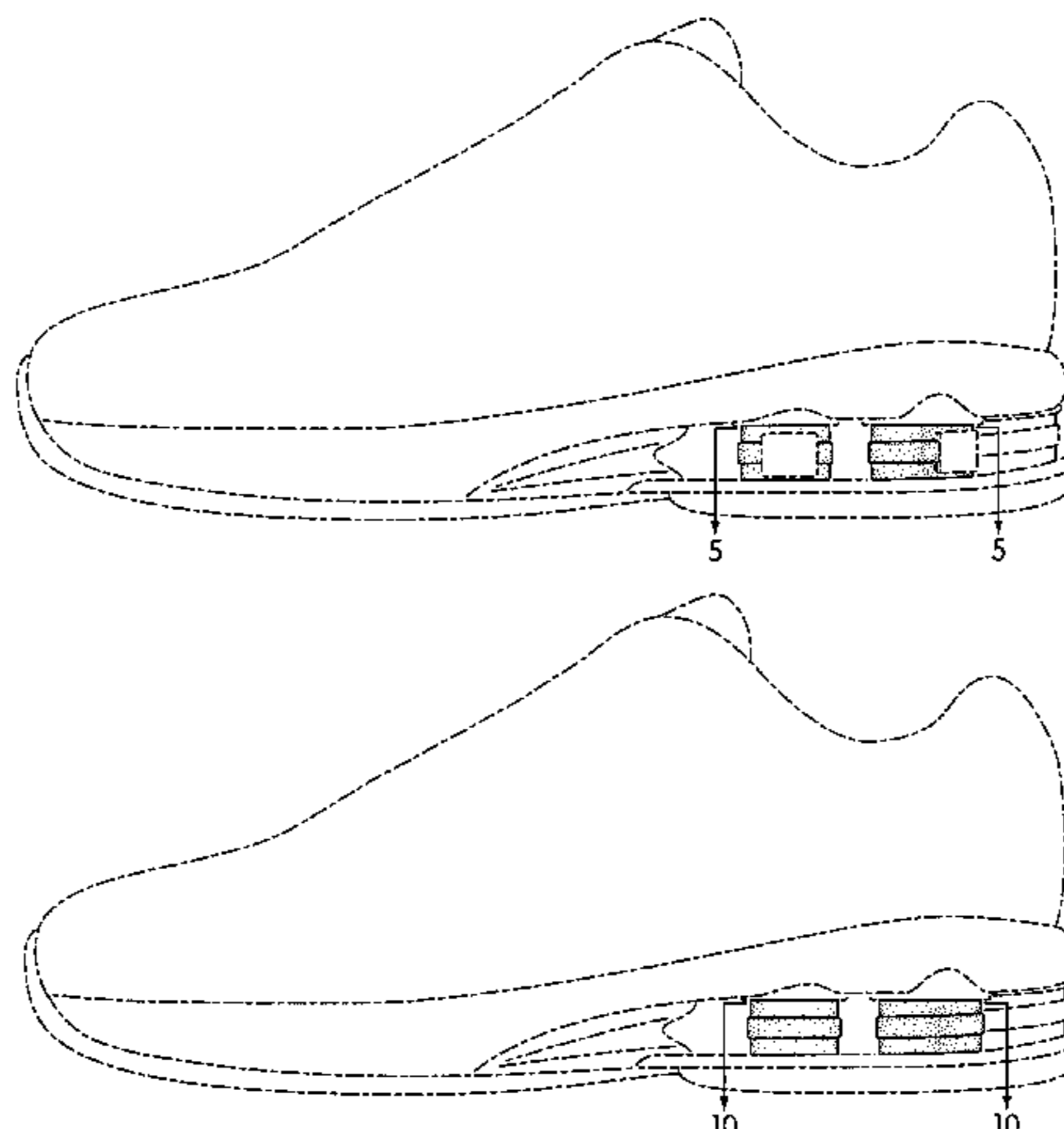
The ornamental design for a portion of a shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a portion of a shoe midsole showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a side elevational view of one side thereof; FIG. 4 is a side elevational view of the other side thereof; FIG. 5 is an enlarged cross sectional view taken along the line 5—5 of FIG. 3; FIG. 6 is a front perspective view of a second embodiment of a portion of a shoe midsole showing my new design; FIG. 7 is a rear perspective view thereof; FIG. 8 is a side elevational view of one side thereof; FIG. 9 is side elevational view of the other side thereof; and, FIG. 10 is an enlarged cross sectional view taken along the line 10—10 of FIG. 8.

The unshaded areas in the claimed regions shown FIGS. 1-3 and 5 are for illustrative purposes only and form no part of the claimed design. The broken line showing of the shoe upper and the remainder of the shoe sole is for illustrative purposes only and forms no part of the claimed design.

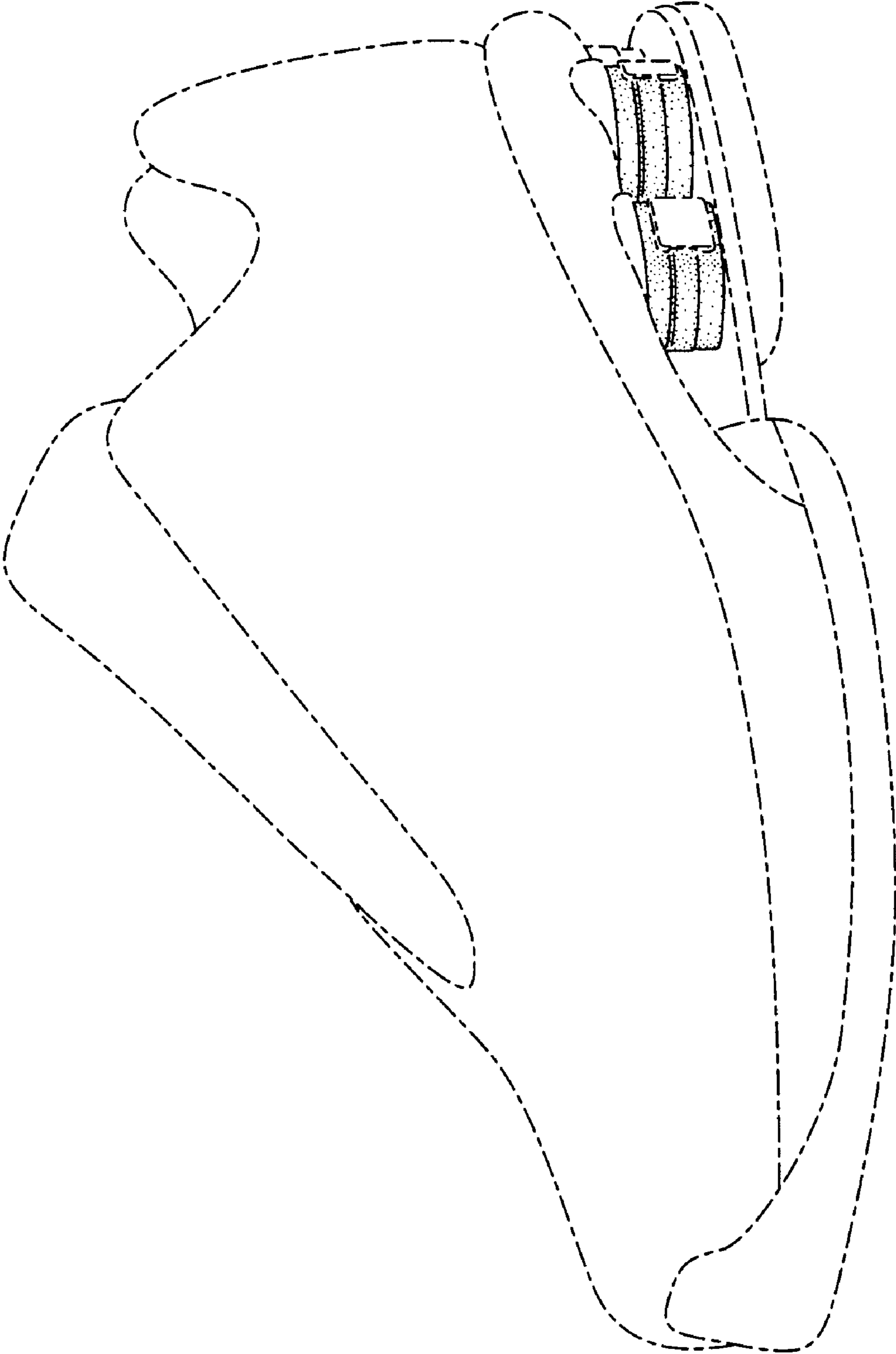

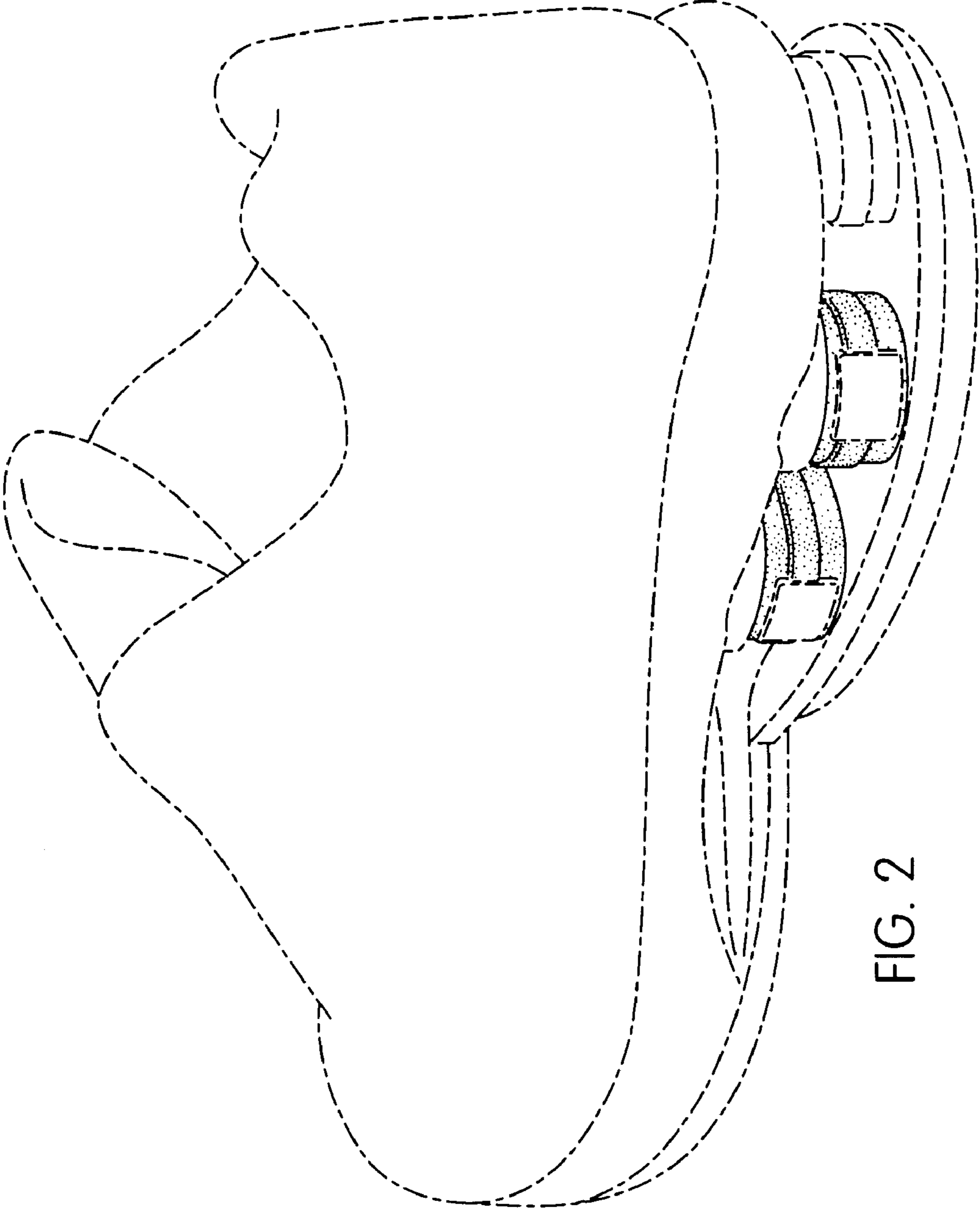

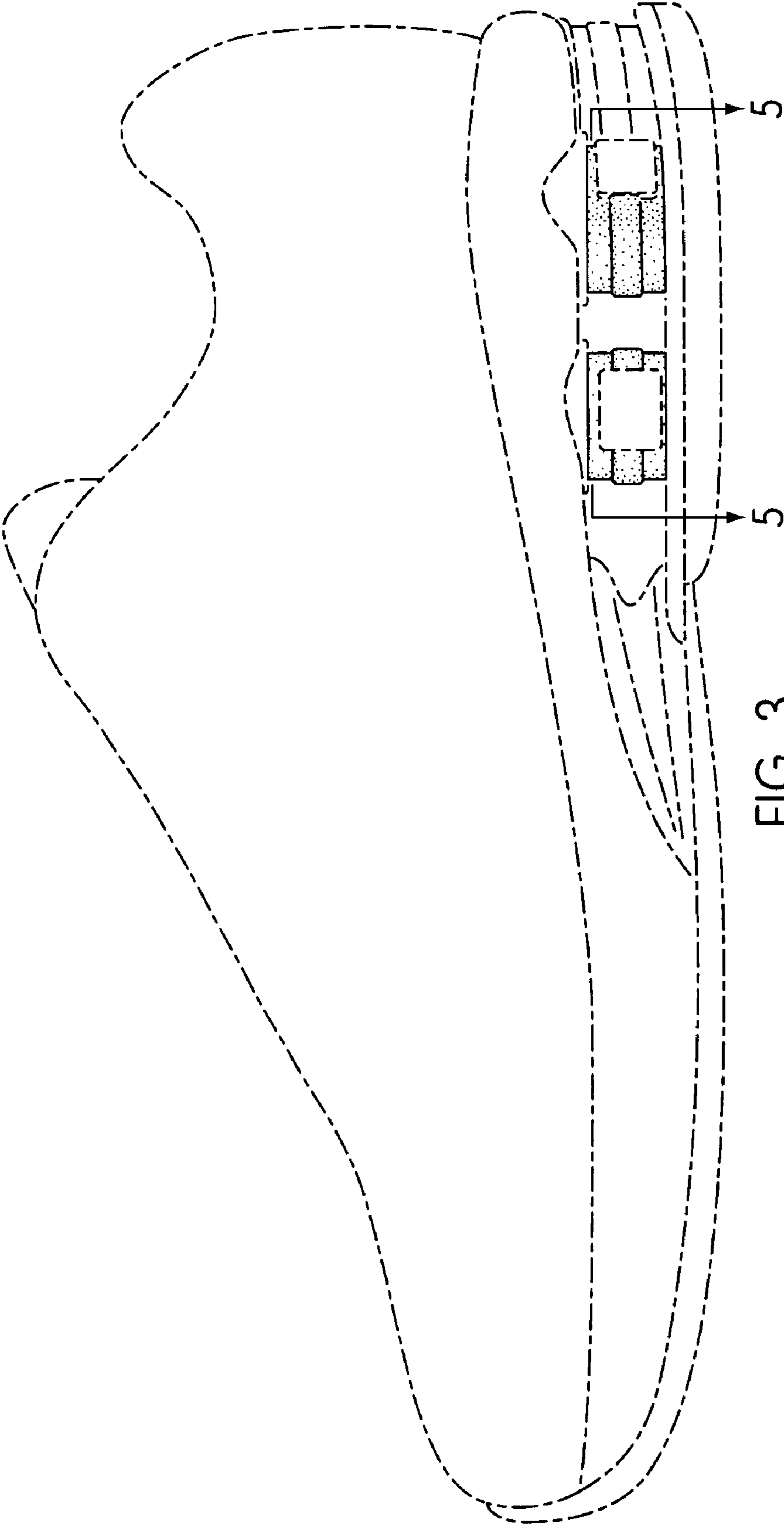

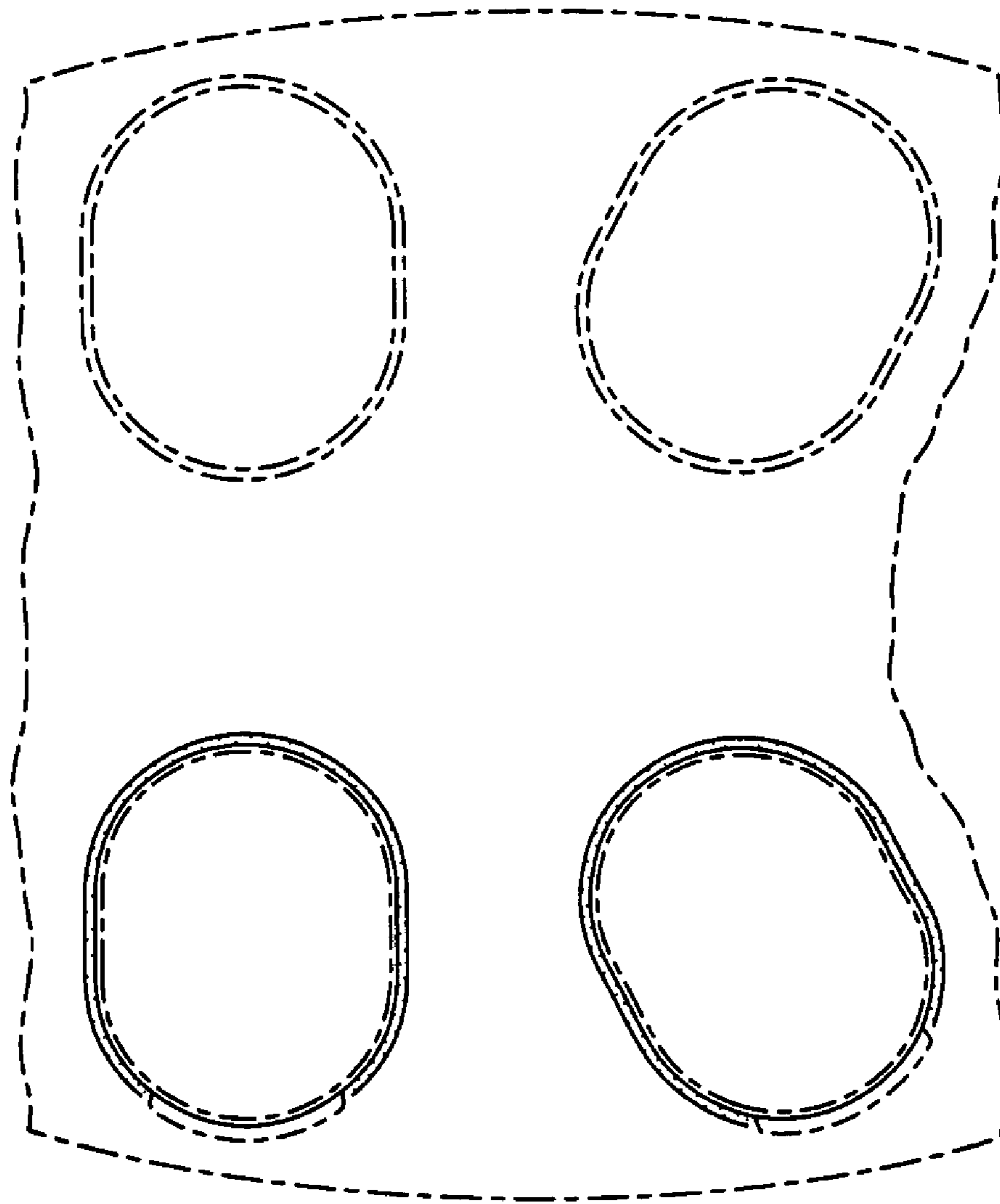

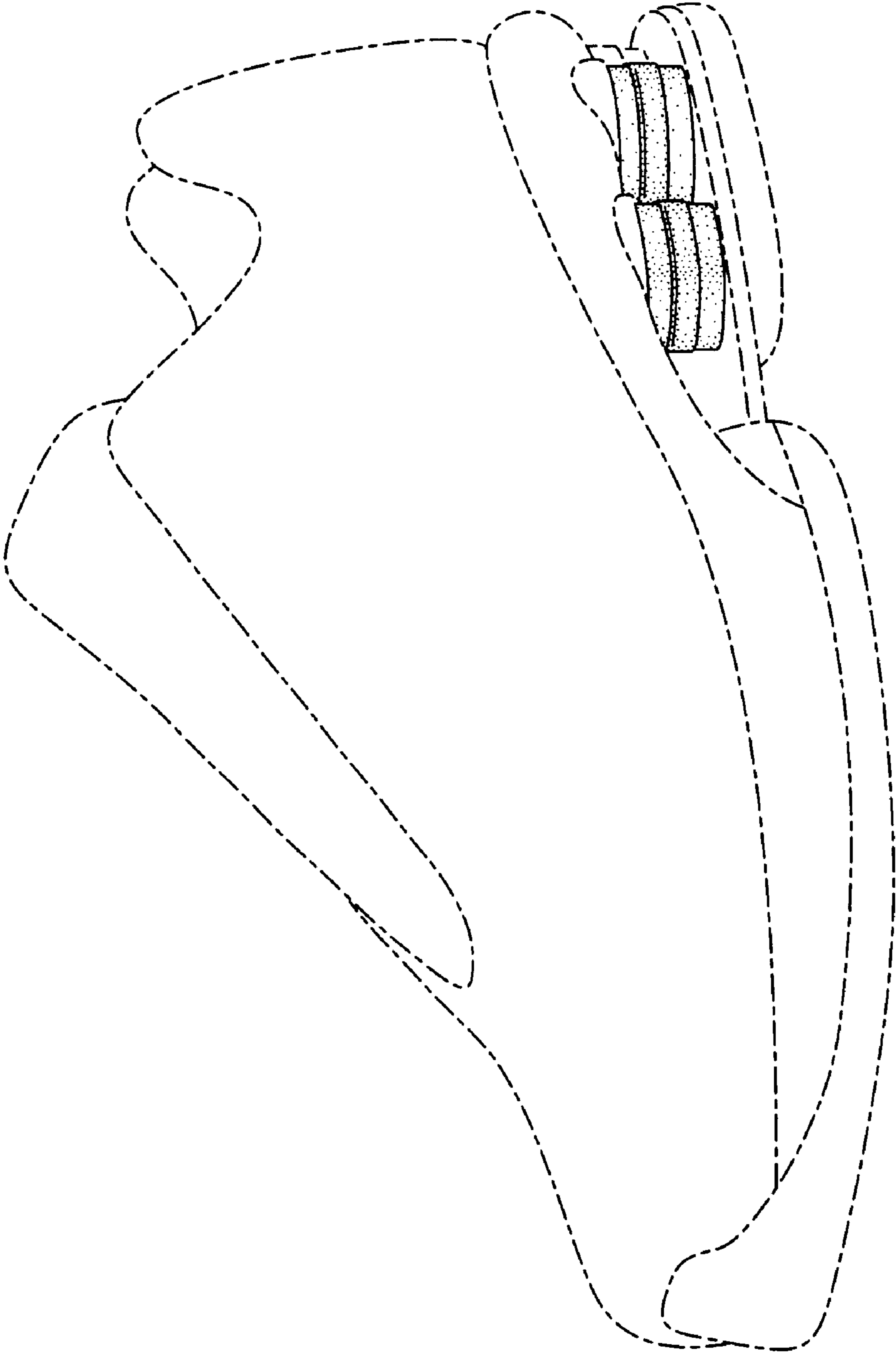

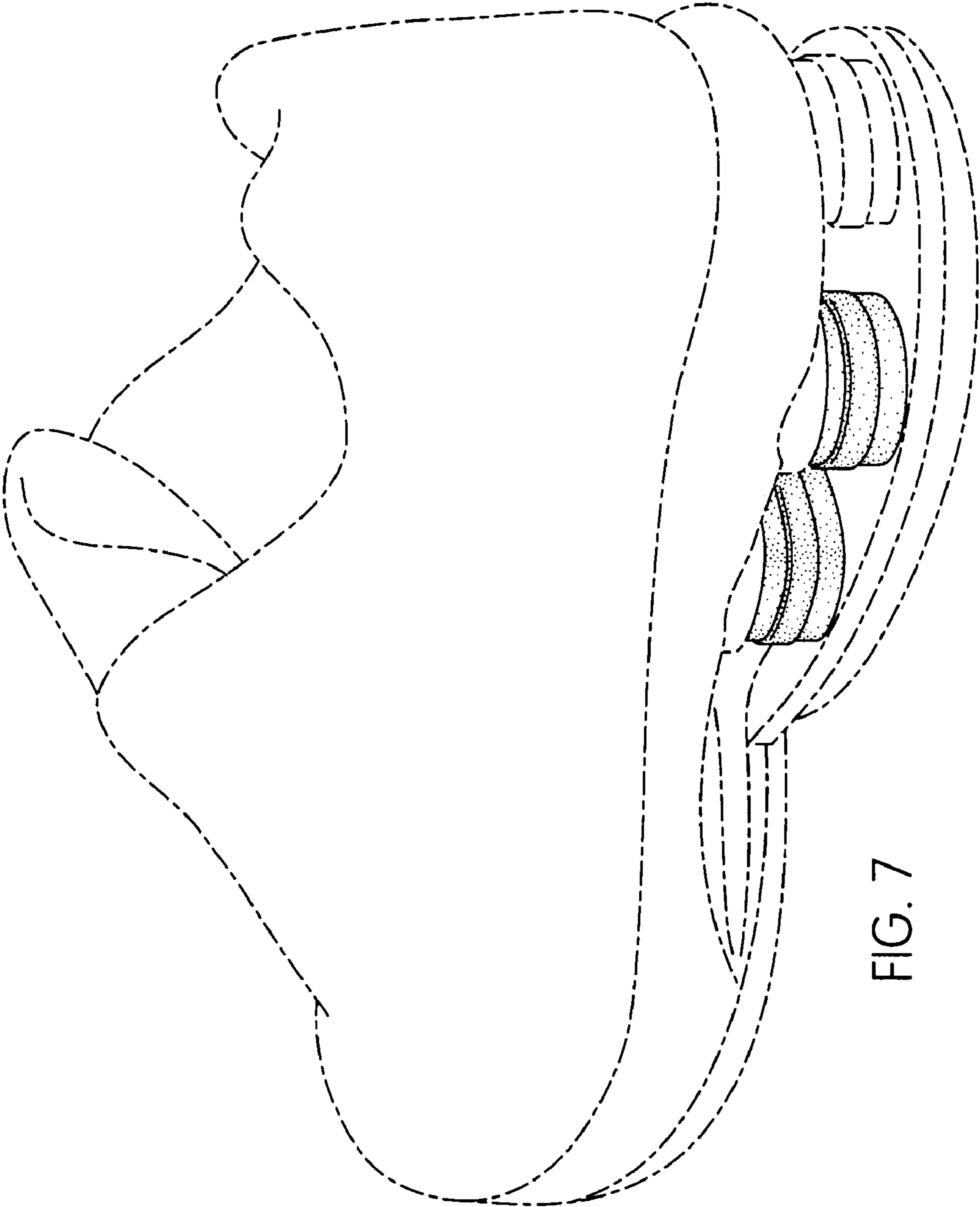

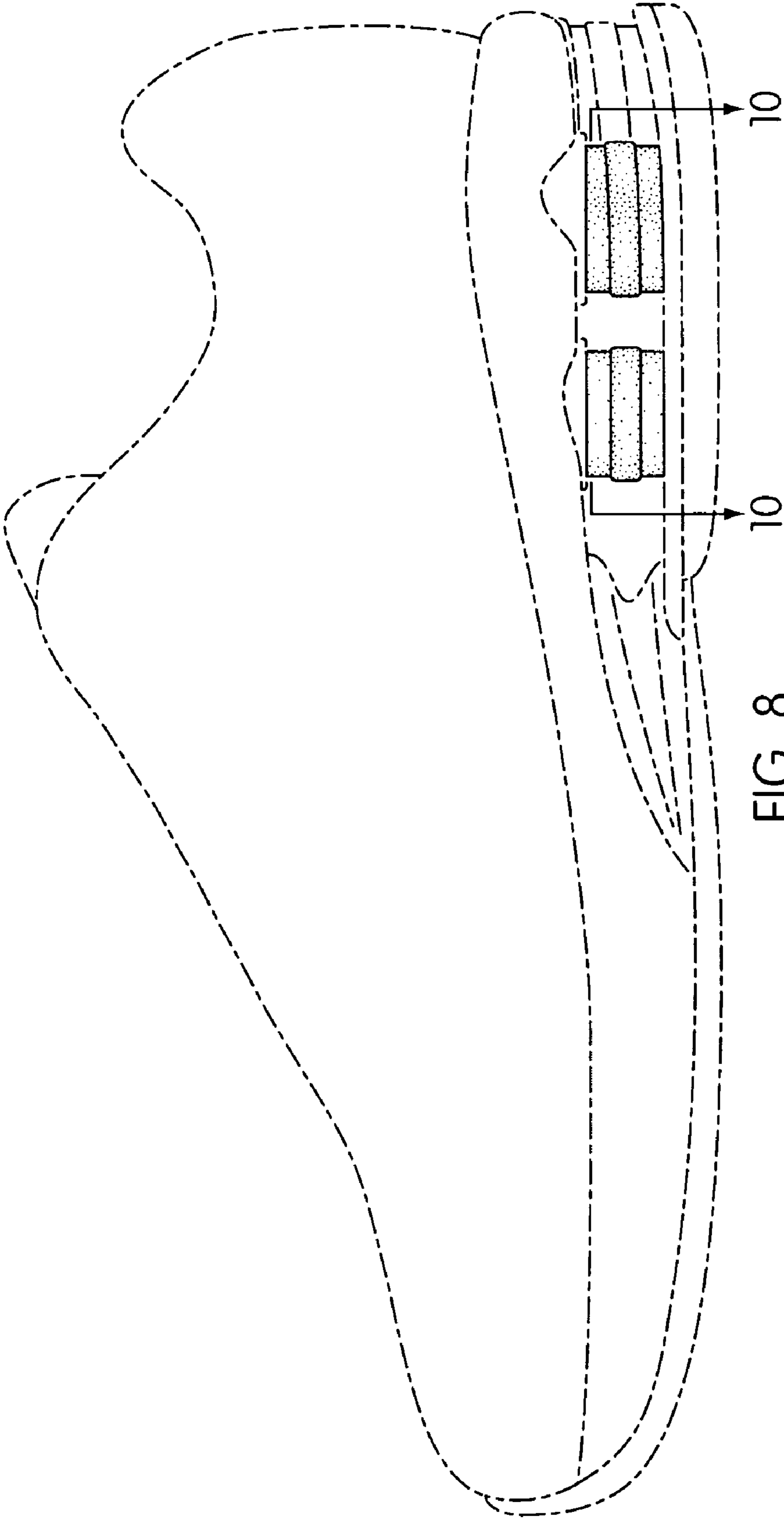

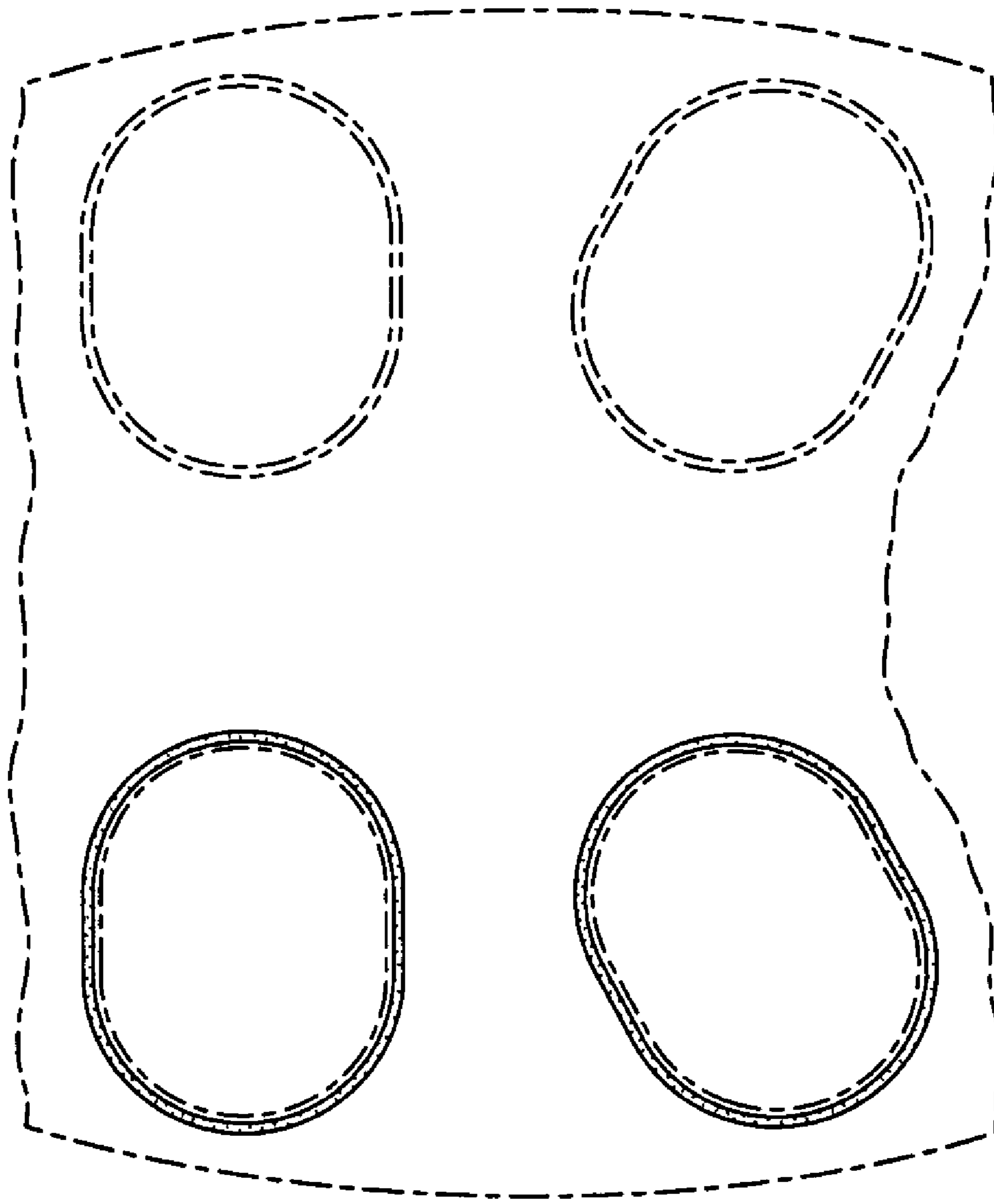
