**DESCRIPTION**

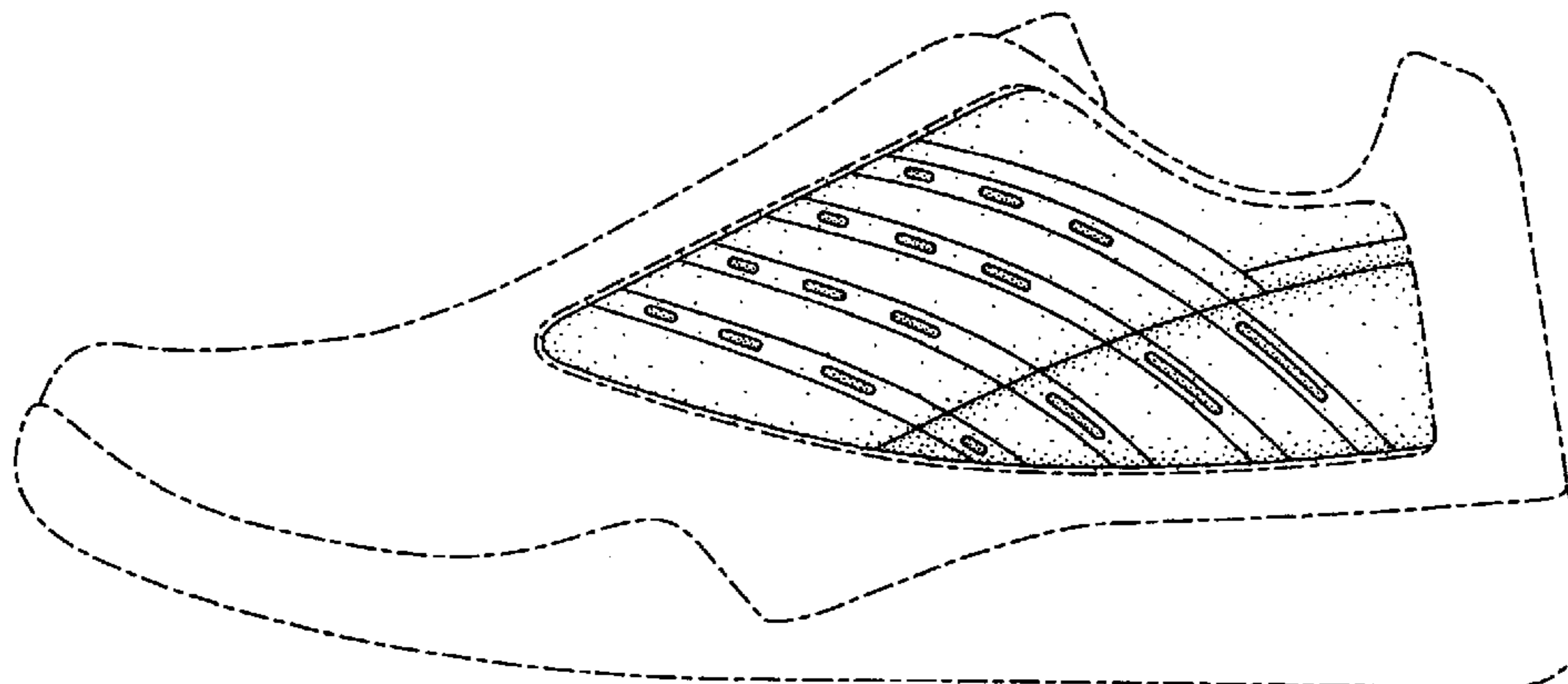
FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design.

FIG. 2 is a rear perspective view thereof; and,

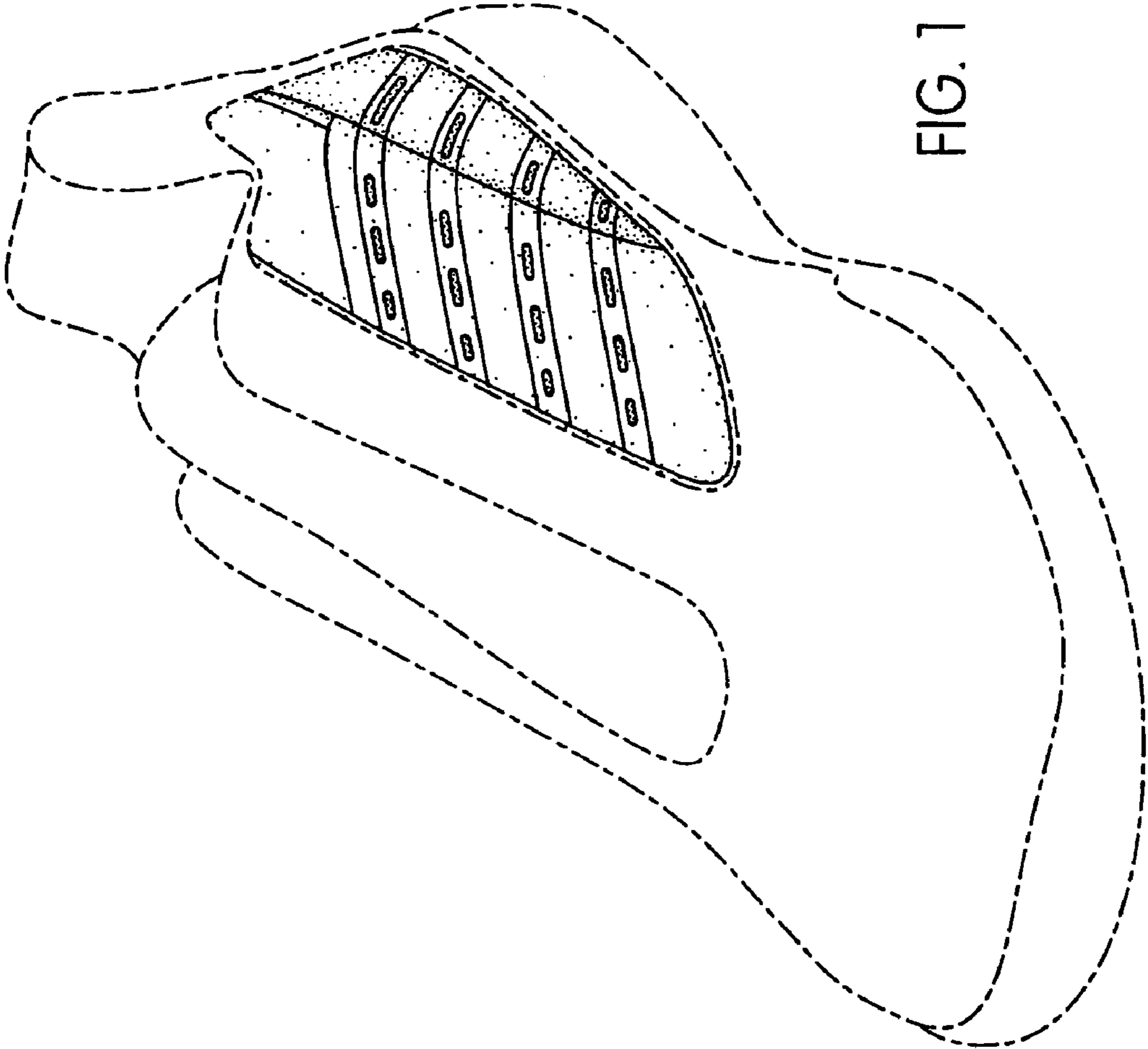

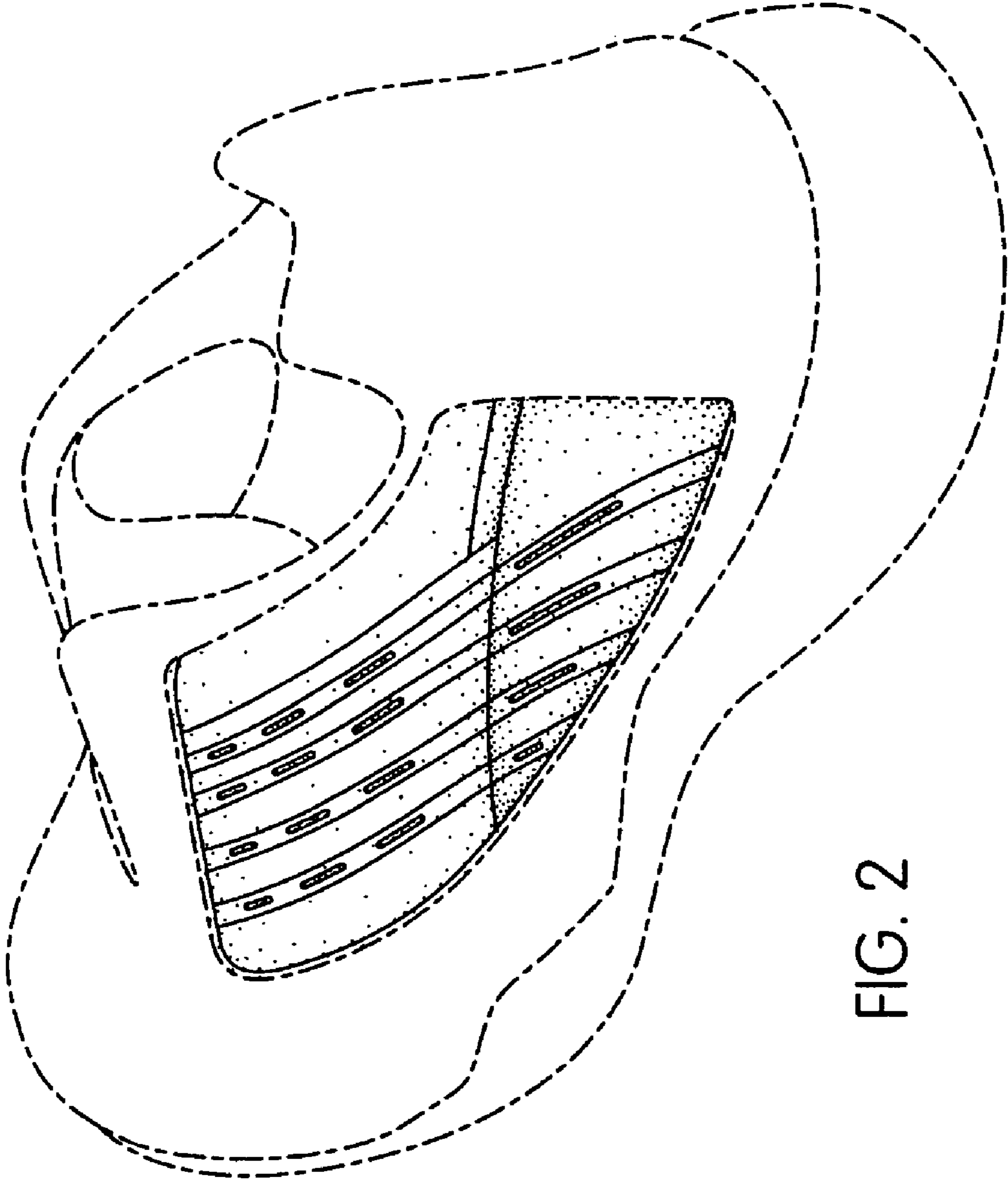

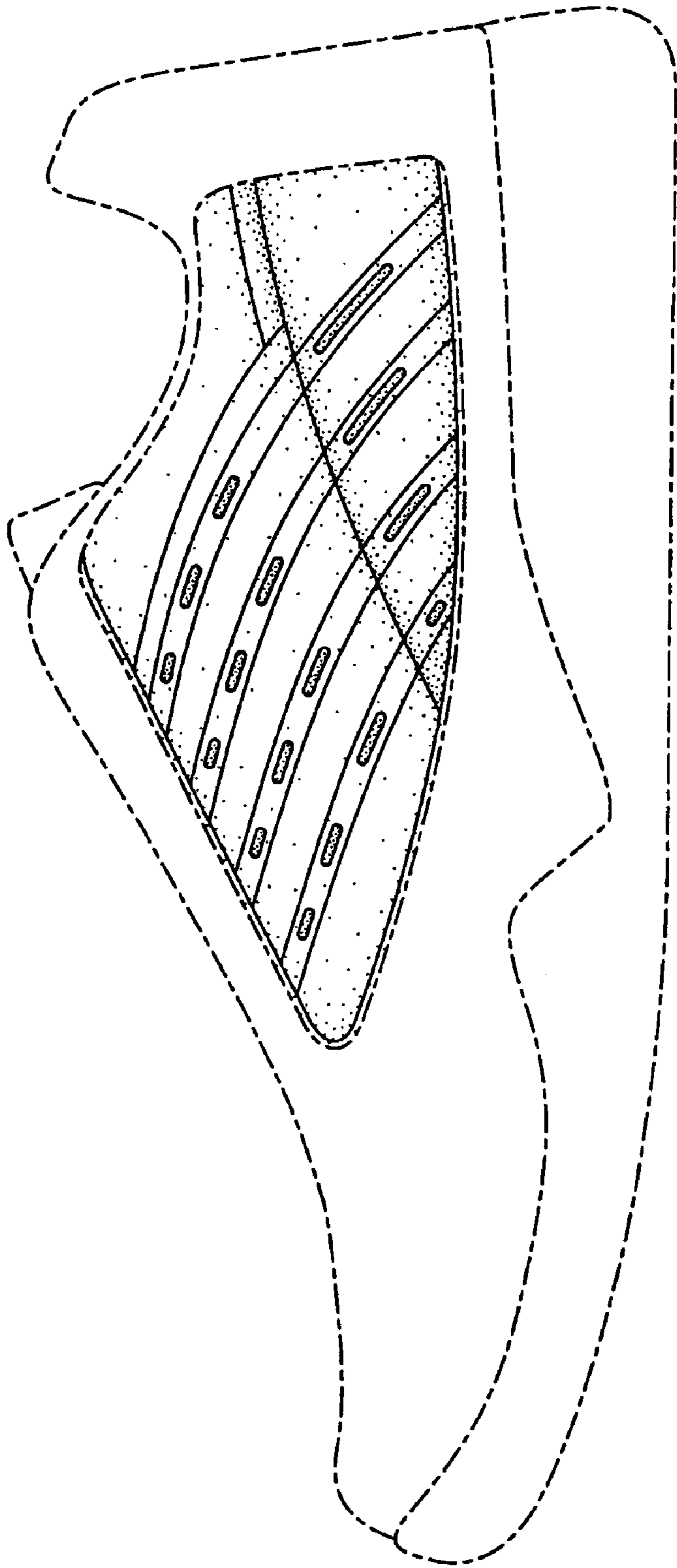
