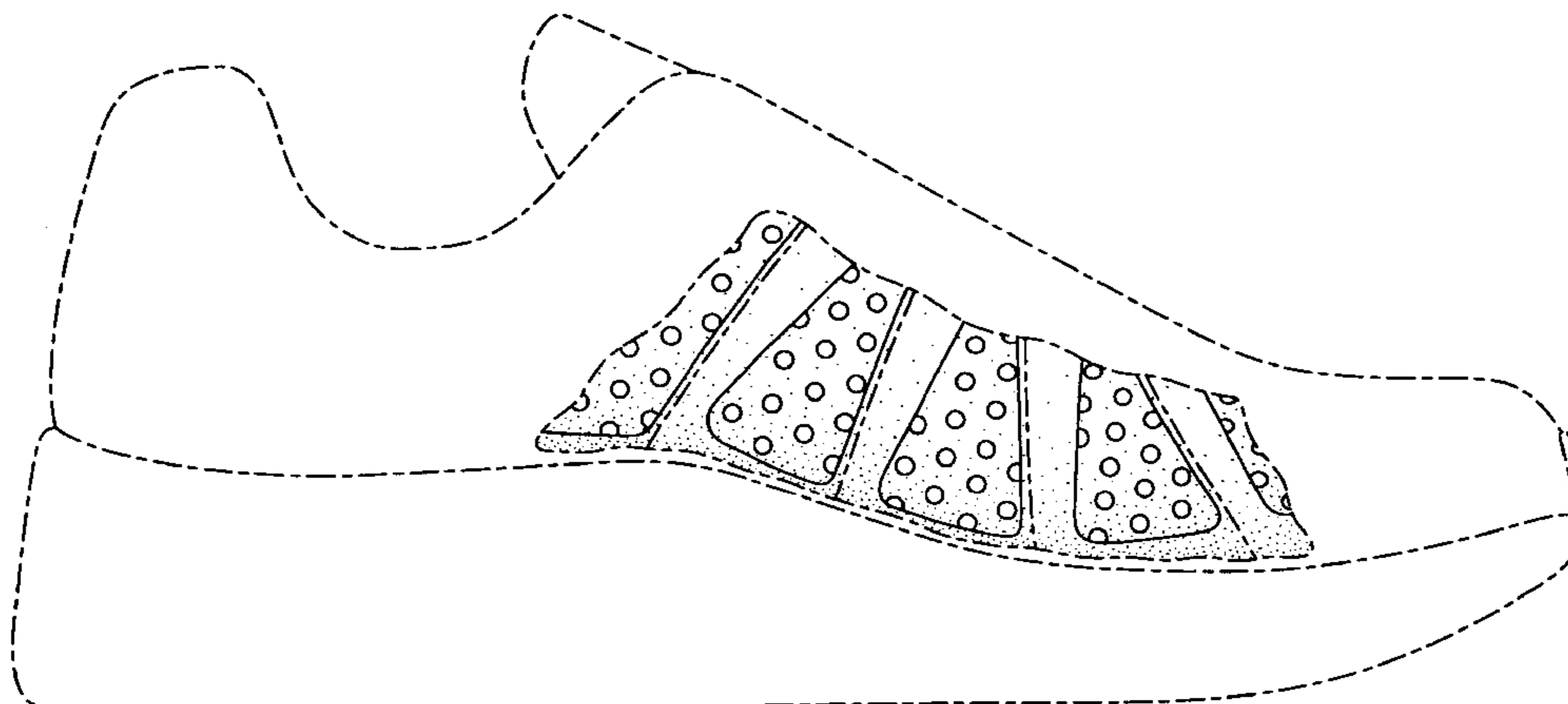
(57) **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portion of a shoe upper showing our new design.
 FIG. 2 is a rear perspective view thereof.
 FIG. 3 is a side elevational view thereof; and,
 FIG. 4 is a top view thereof.
 The broken lines immediately adjacent to the shaded areas represent an unclaimed boundary of the design. The broken lines transecting the shaded region represent unclaimed edges of overlay panels, and form no part of the claimed design. The broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

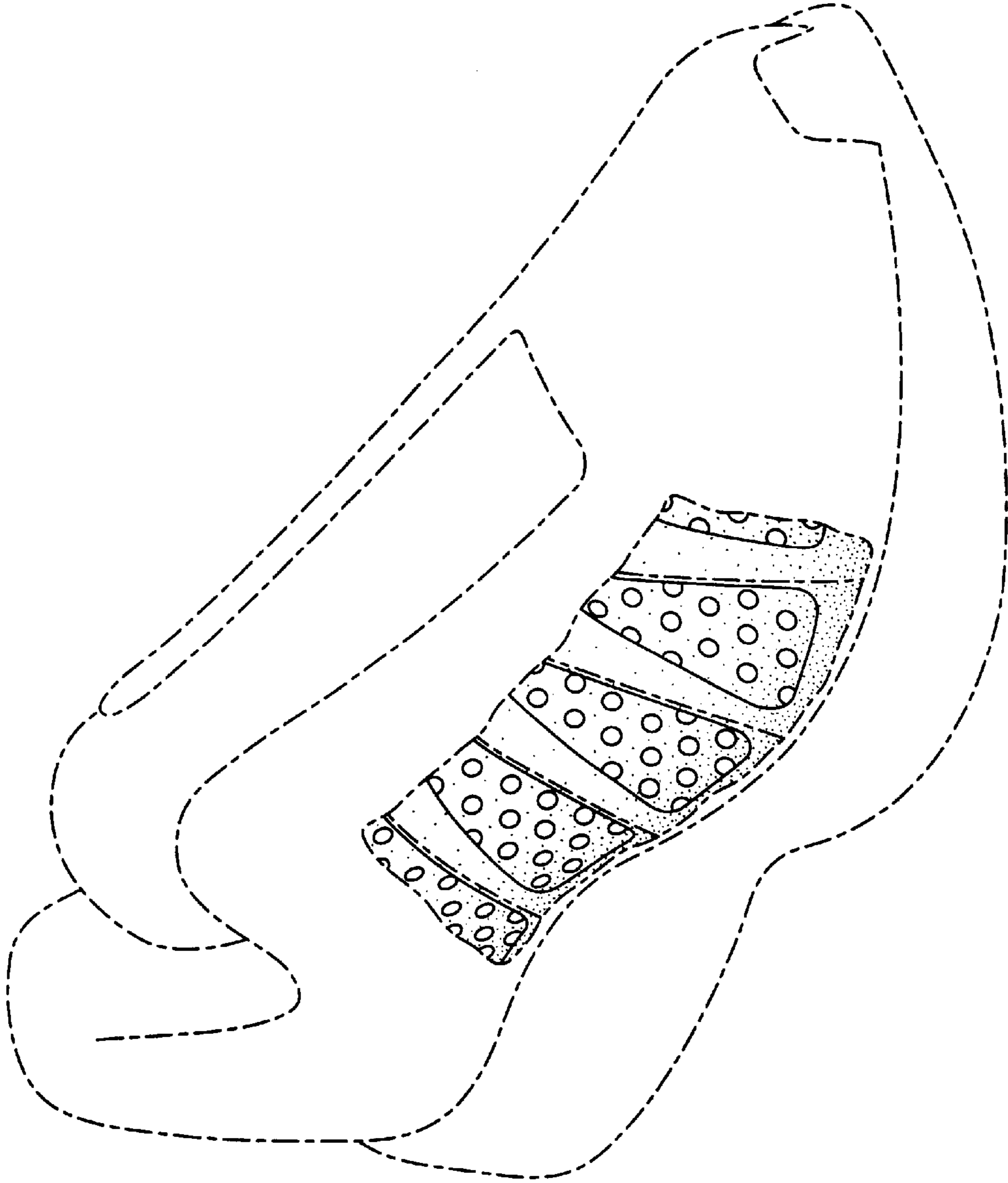

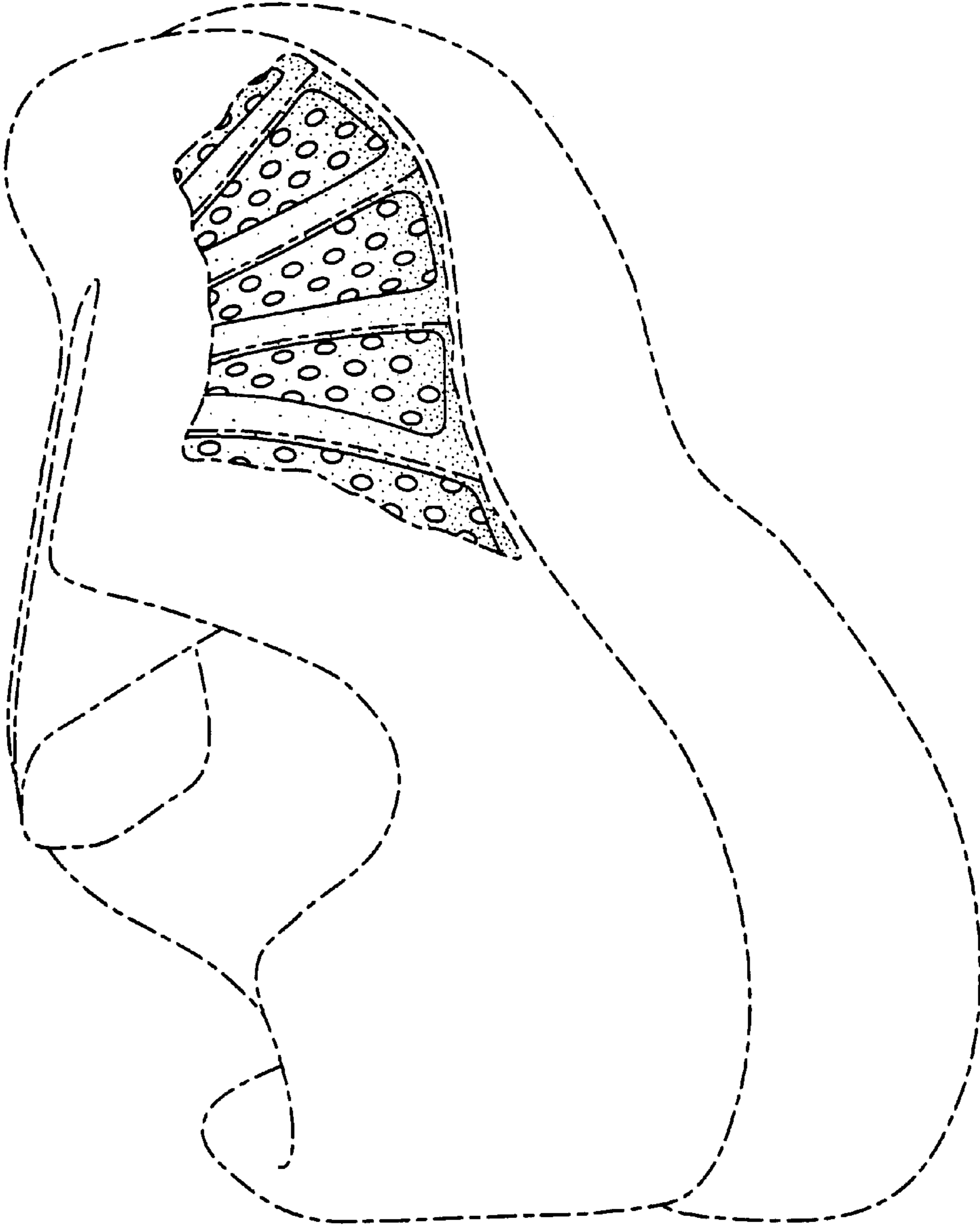

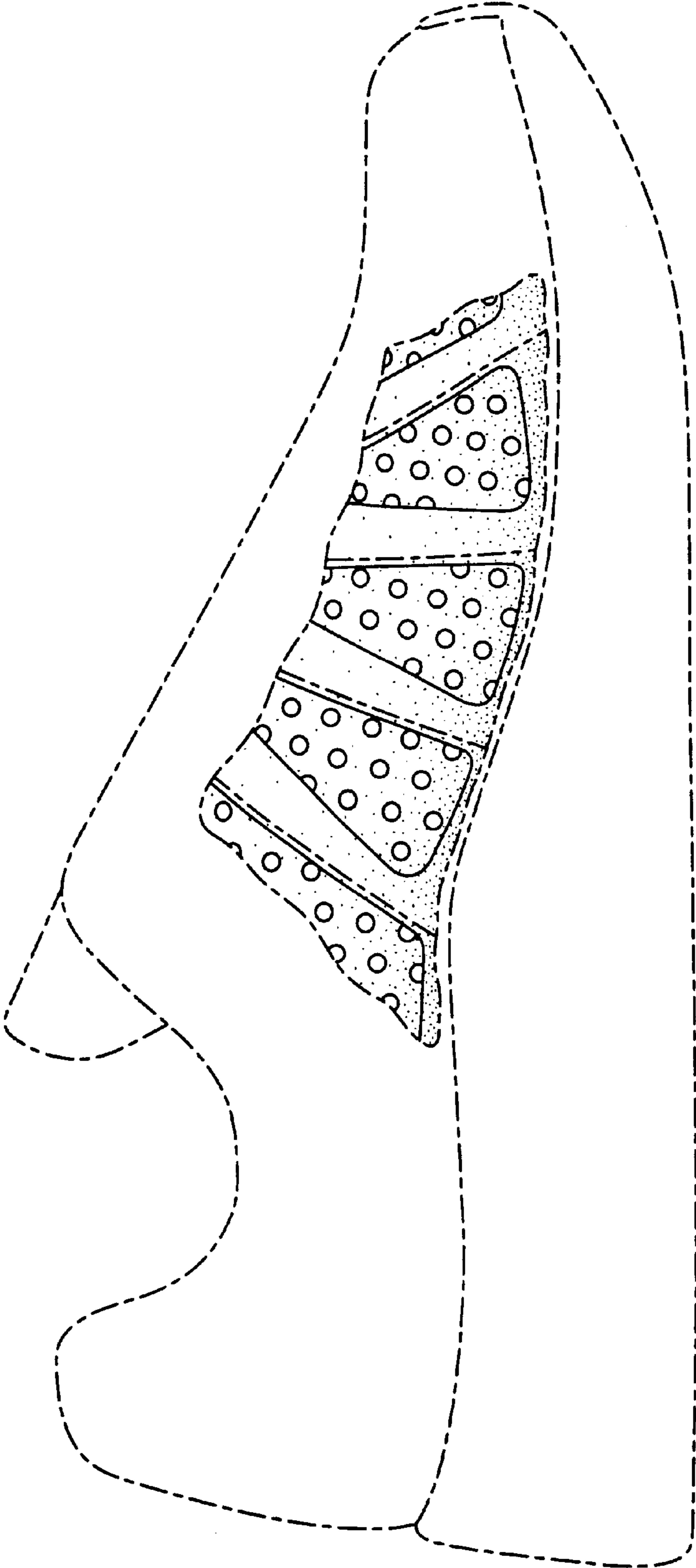

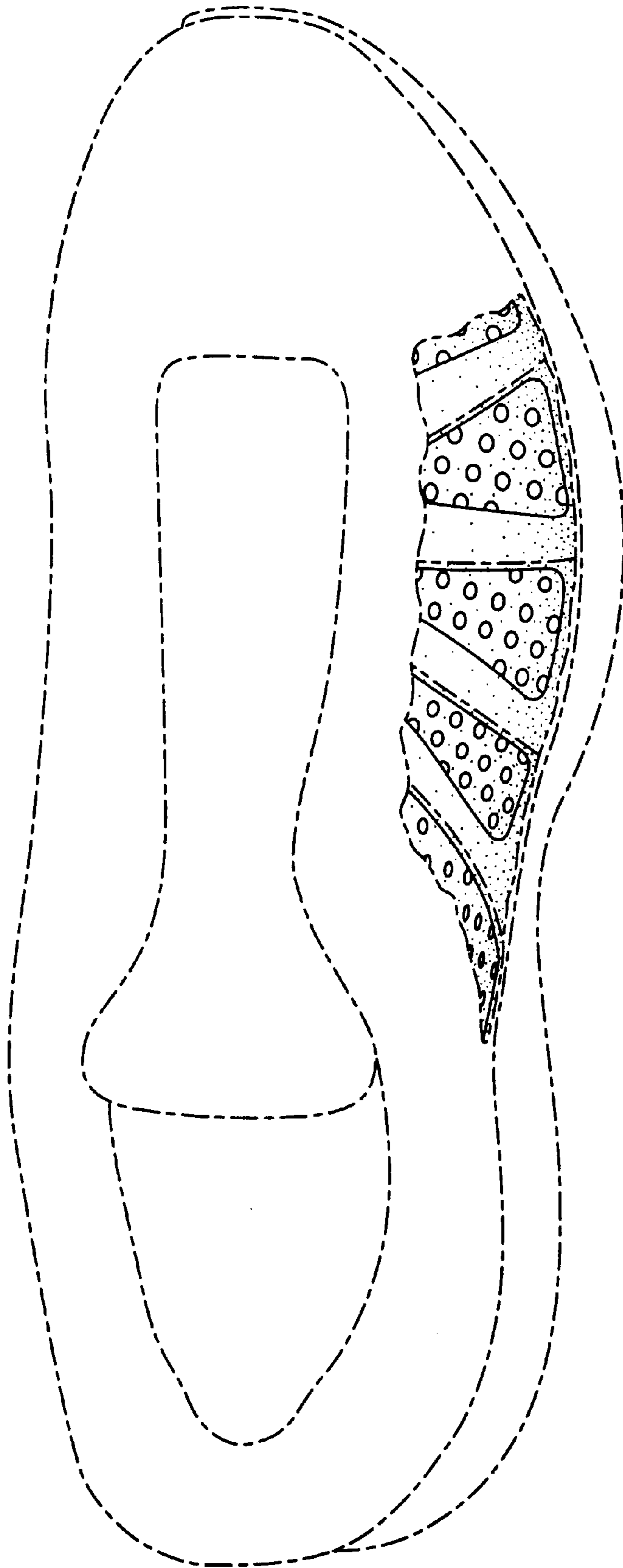
