(57) **CLAIM**

The ornamental design for a chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the chair in a first position, looking towards the front, bottom and right of the chair.

FIG. 2 is a front elevation view of the chair in the first position.

FIG. 3 is a rear elevation view of the chair in the first position.

FIG. 4 is a top plan view of the chair in the first position.

FIG. 5 is a bottom plan view of the chair in the first position.

FIG. 6 is a right side elevation view of the chair in the first position.

FIG. 7 is a left side elevation view of the chair in the first position.

FIG. 8 is a perspective view of a second embodiment of the chair in a second position, looking towards the rear, top and left of the chair.

FIG. 9 is a front elevation view of the chair in the second position.

FIG. 10 is a rear elevation view of the chair in the second position.

FIG. 11 is a top plan view of the chair in the second position.

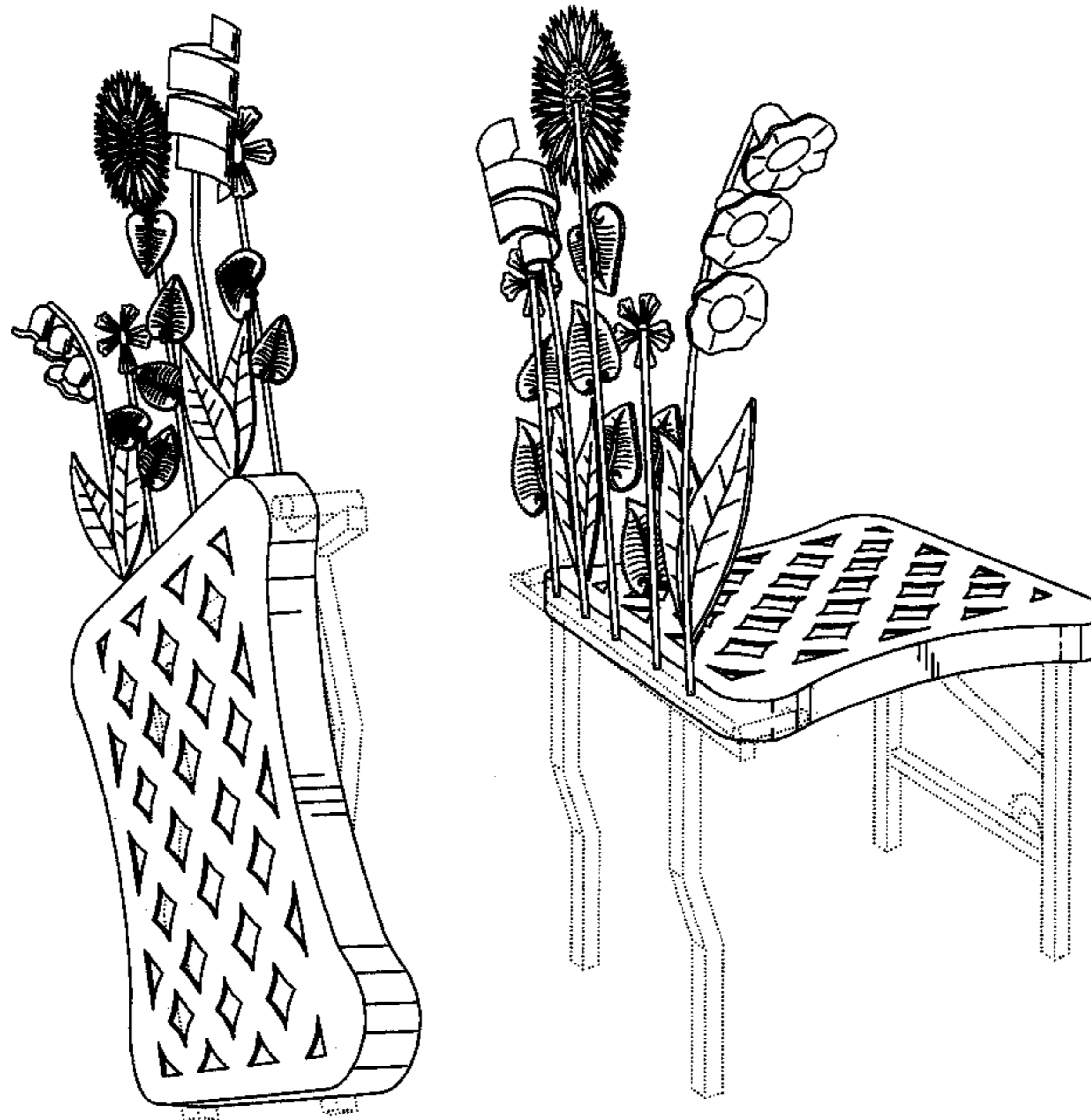
FIG. 12 is a bottom plan view of the chair in the second position.

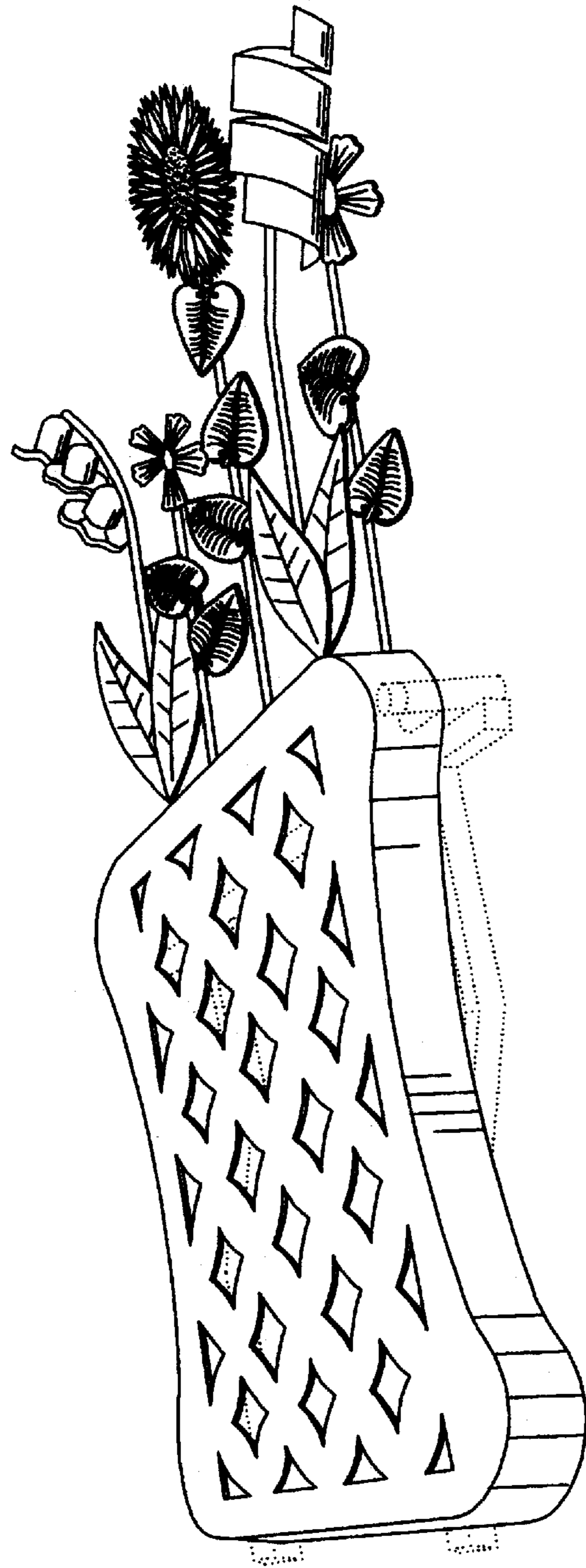
FIG. 13 is a right side elevation view of the chair in the second position; and,

FIG. 14 is a left side elevation view of the chair in the second position.

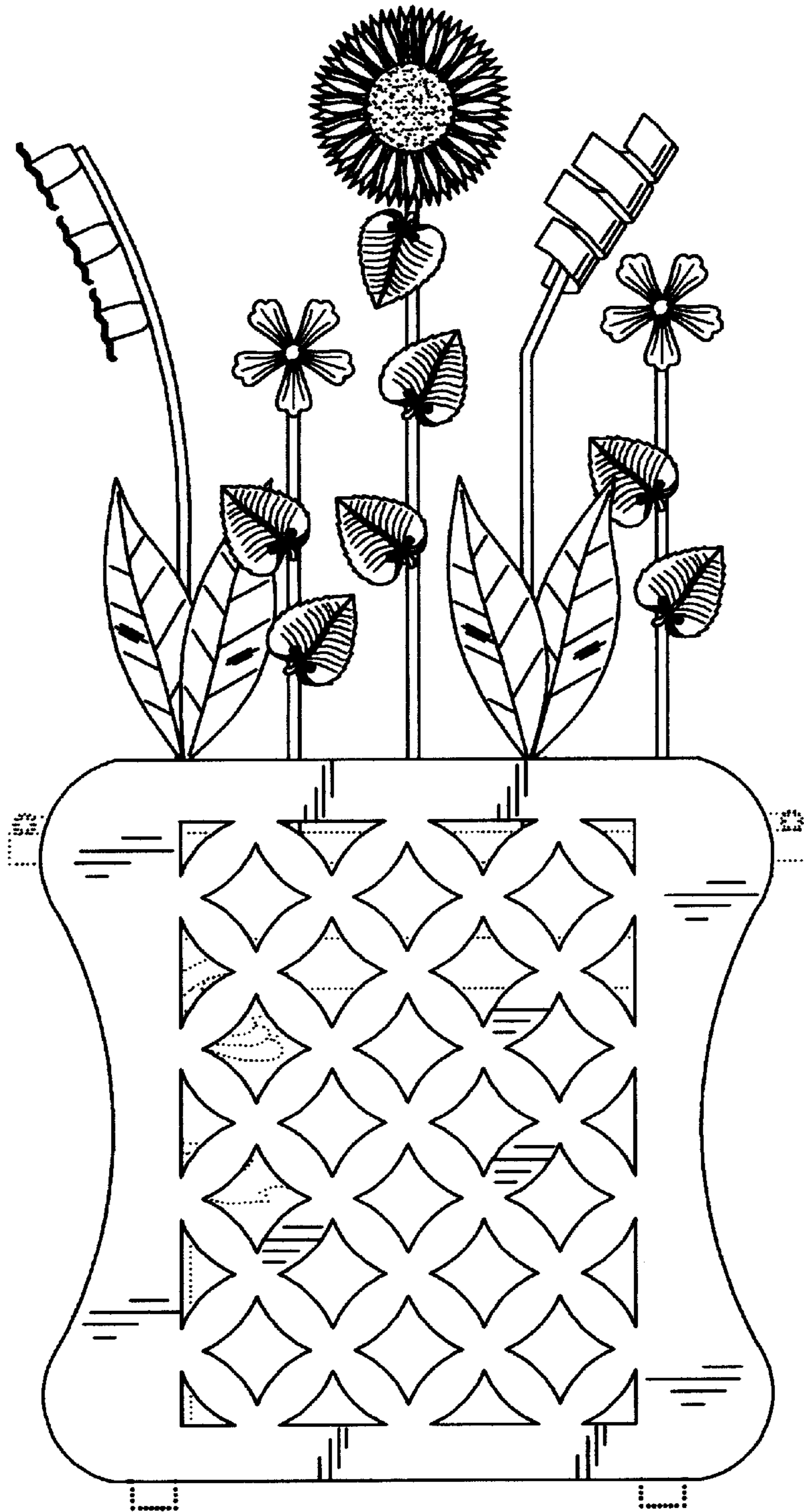

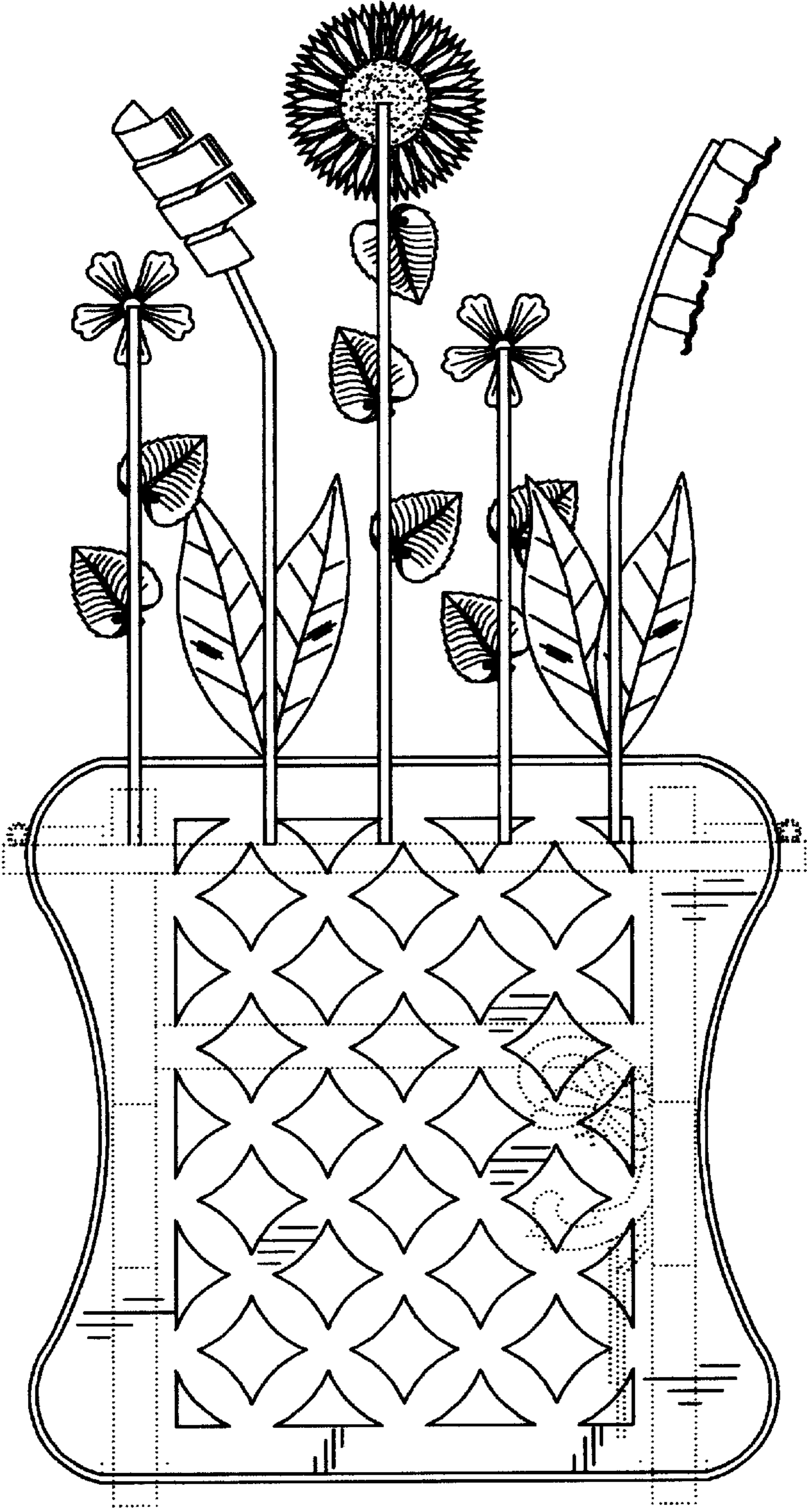




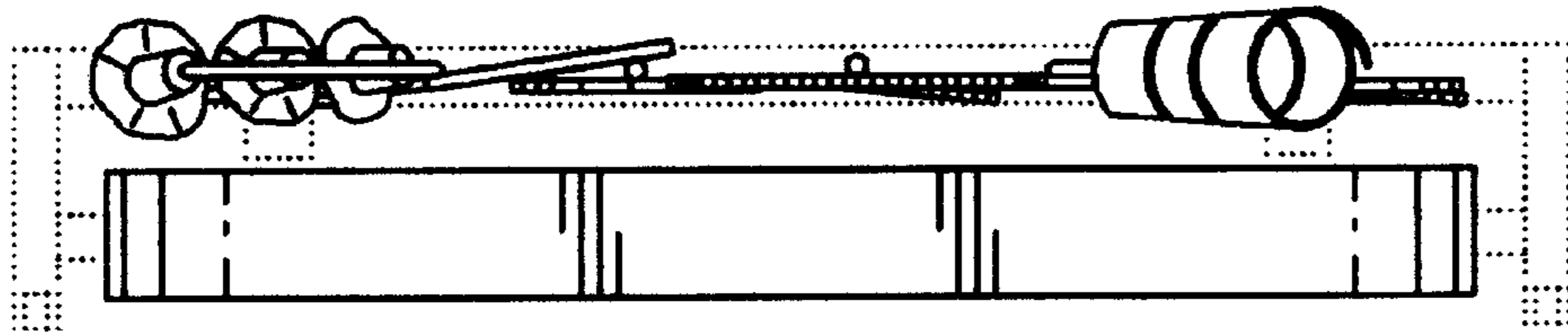

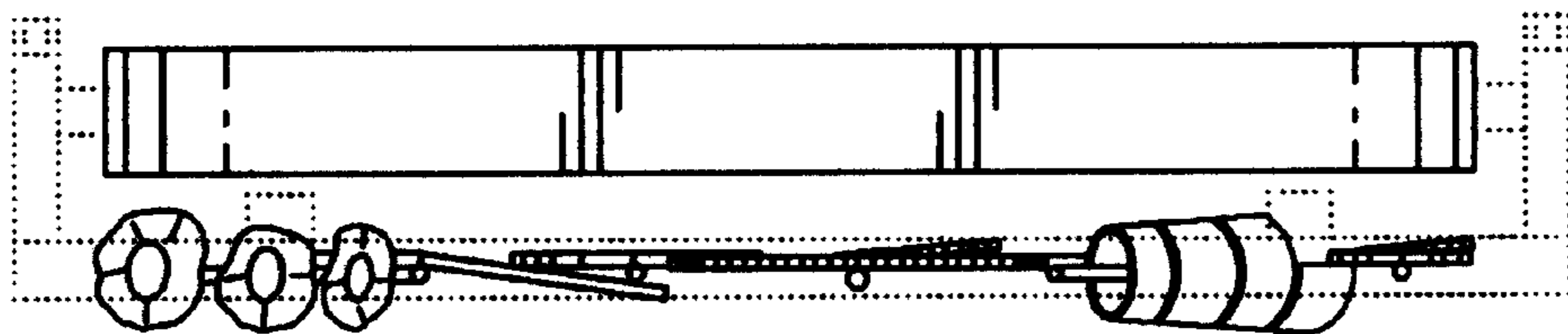

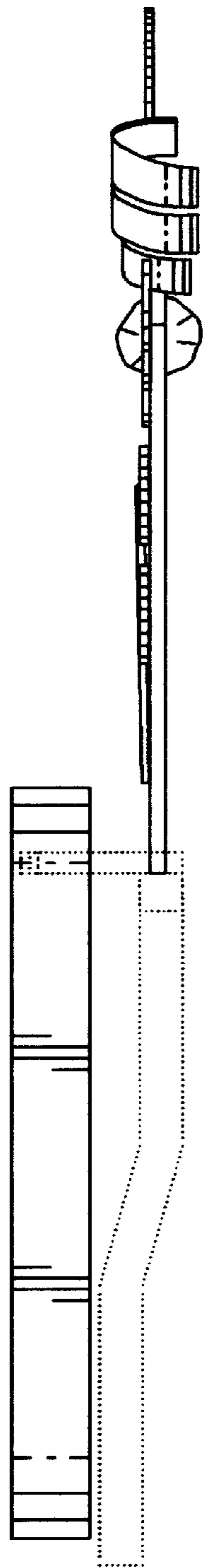

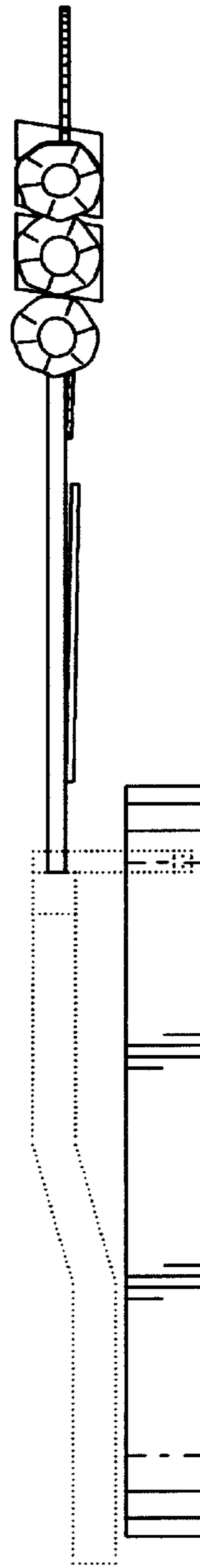

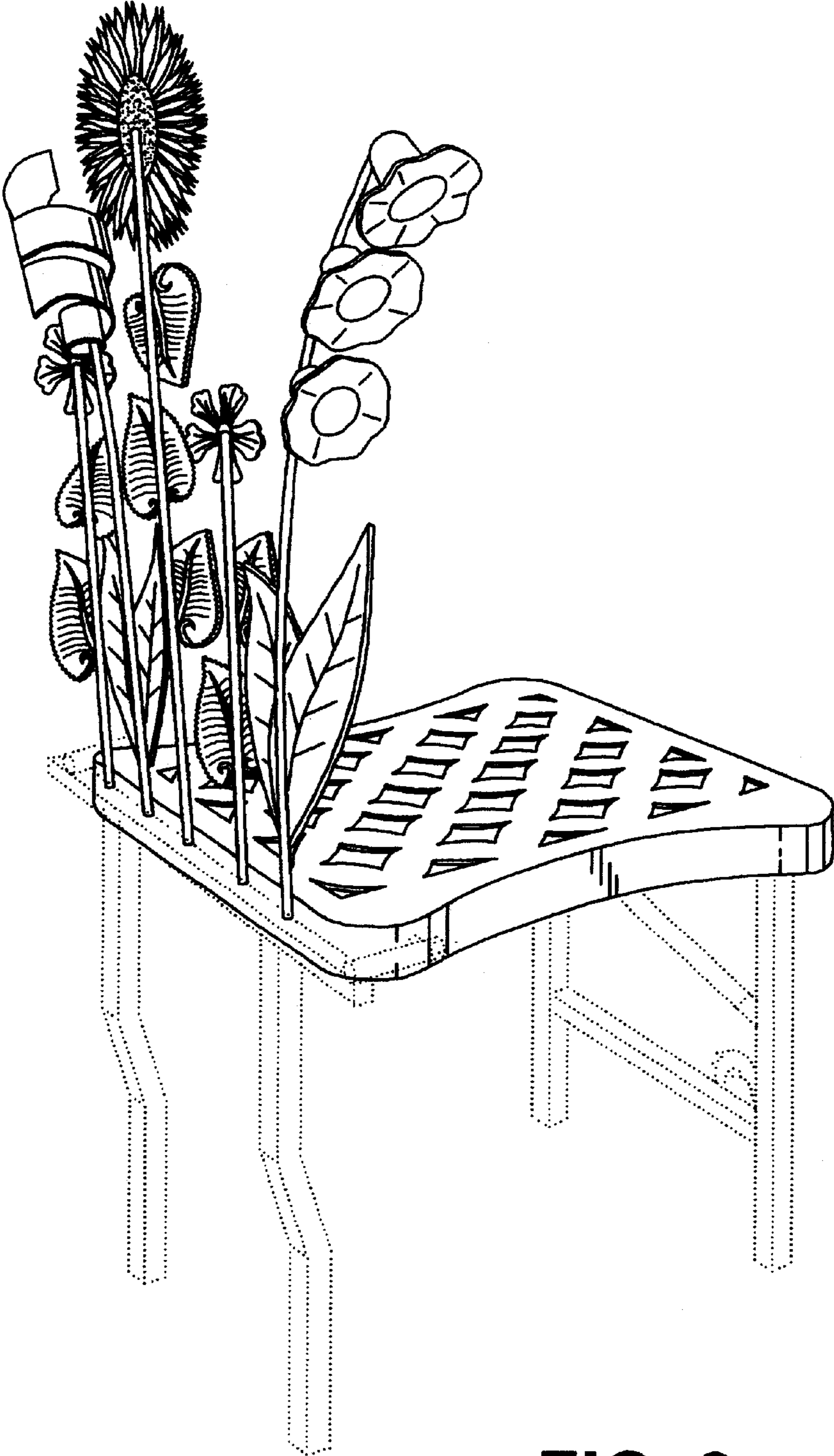

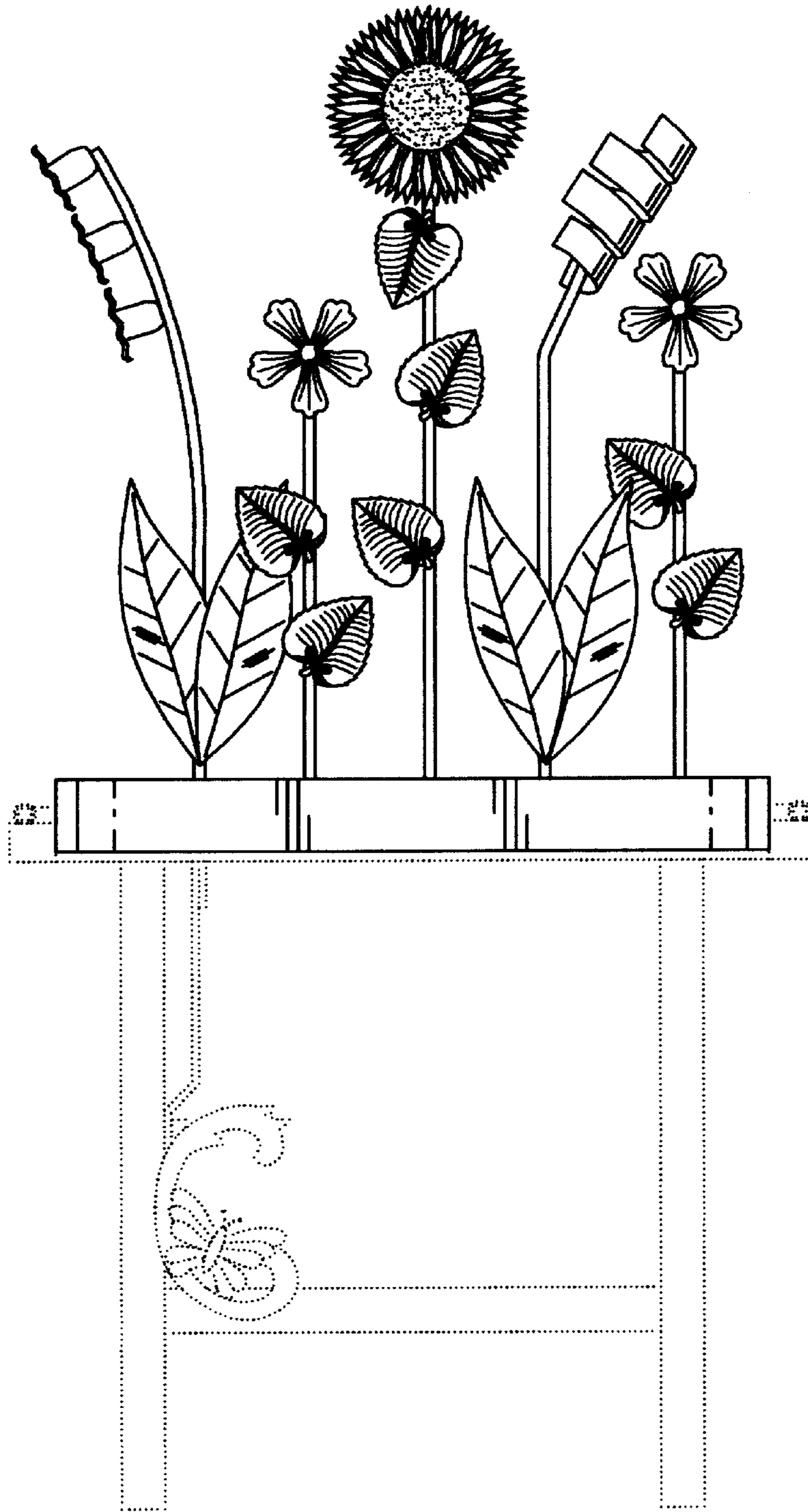

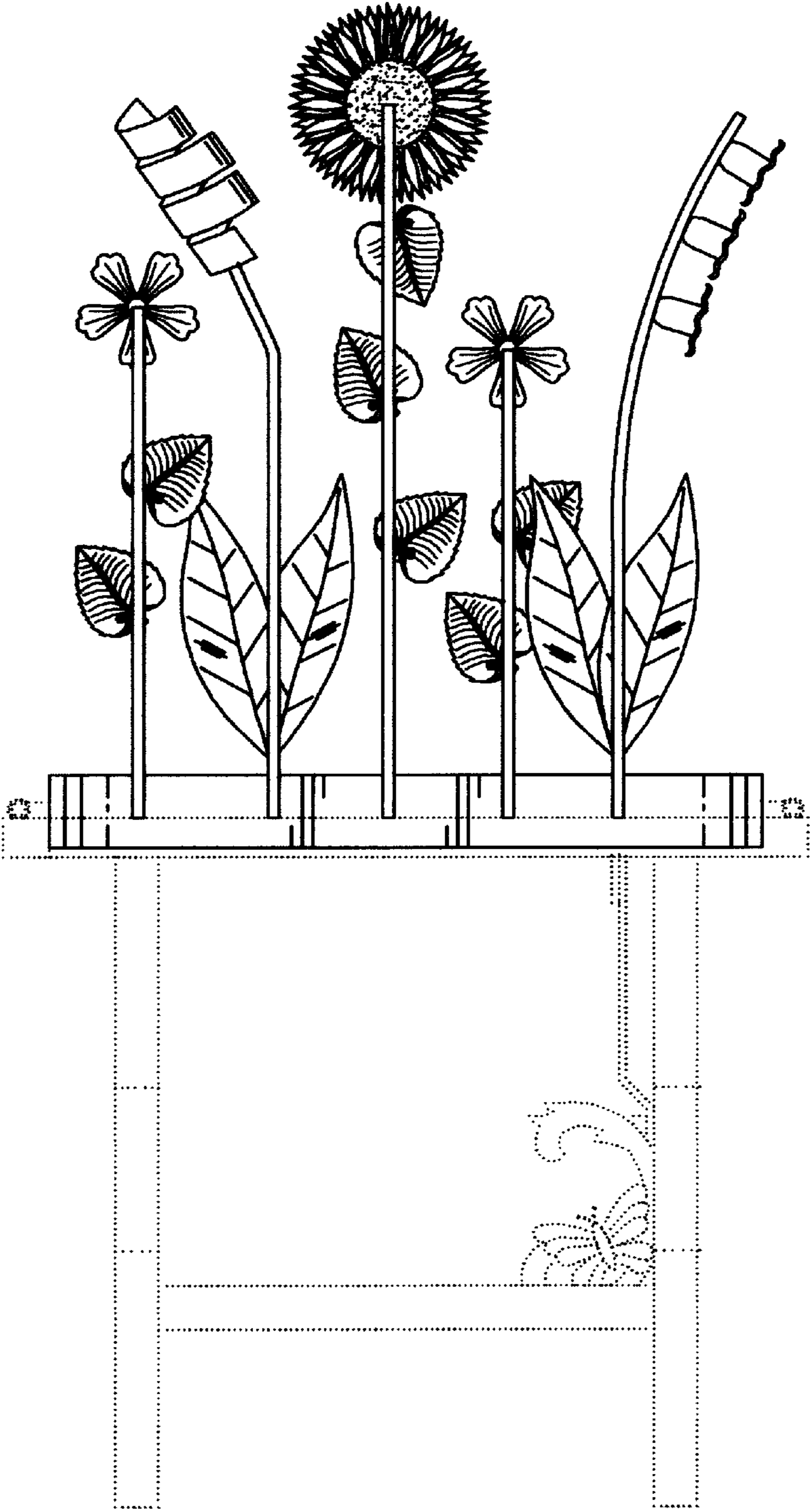
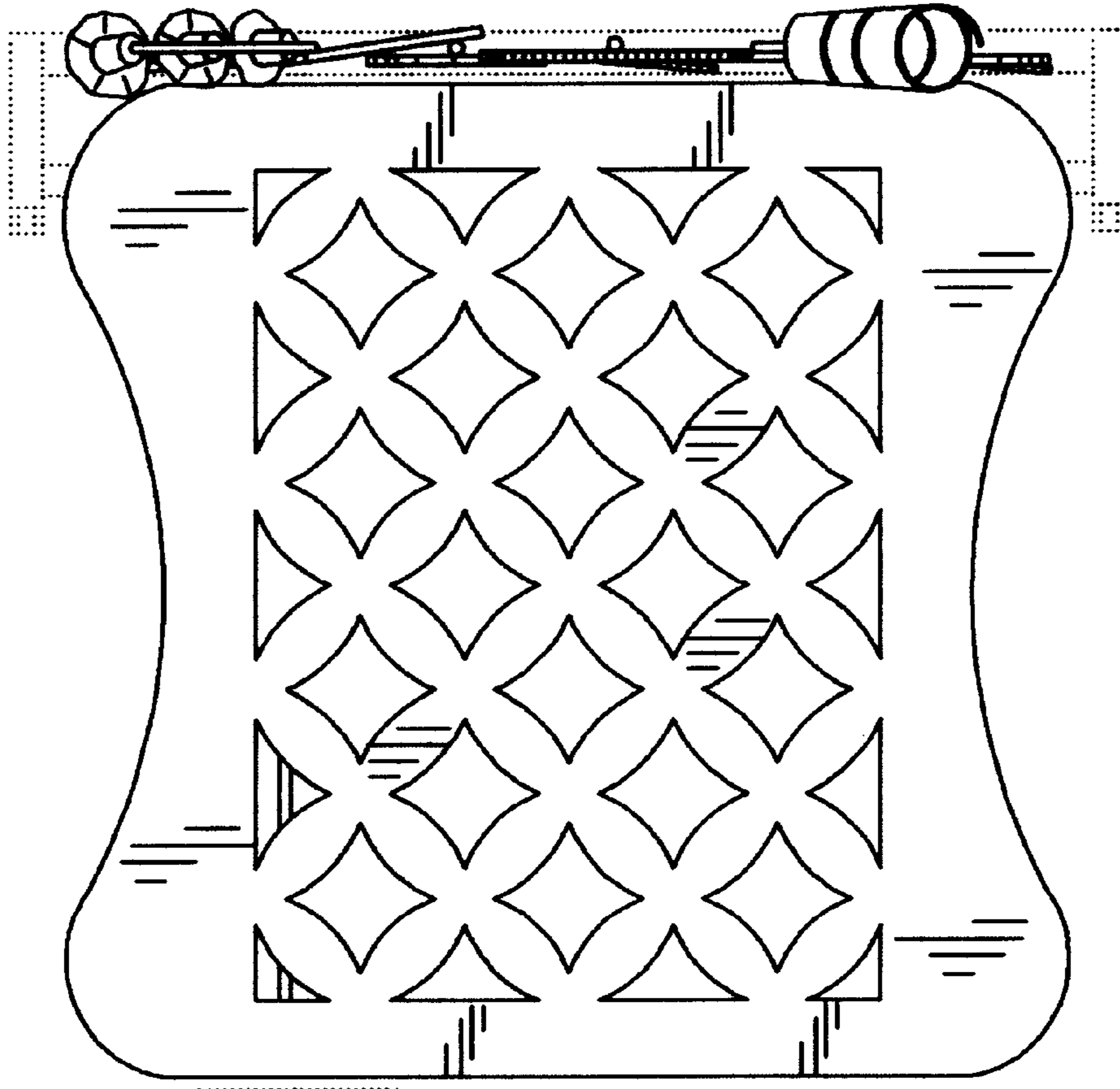
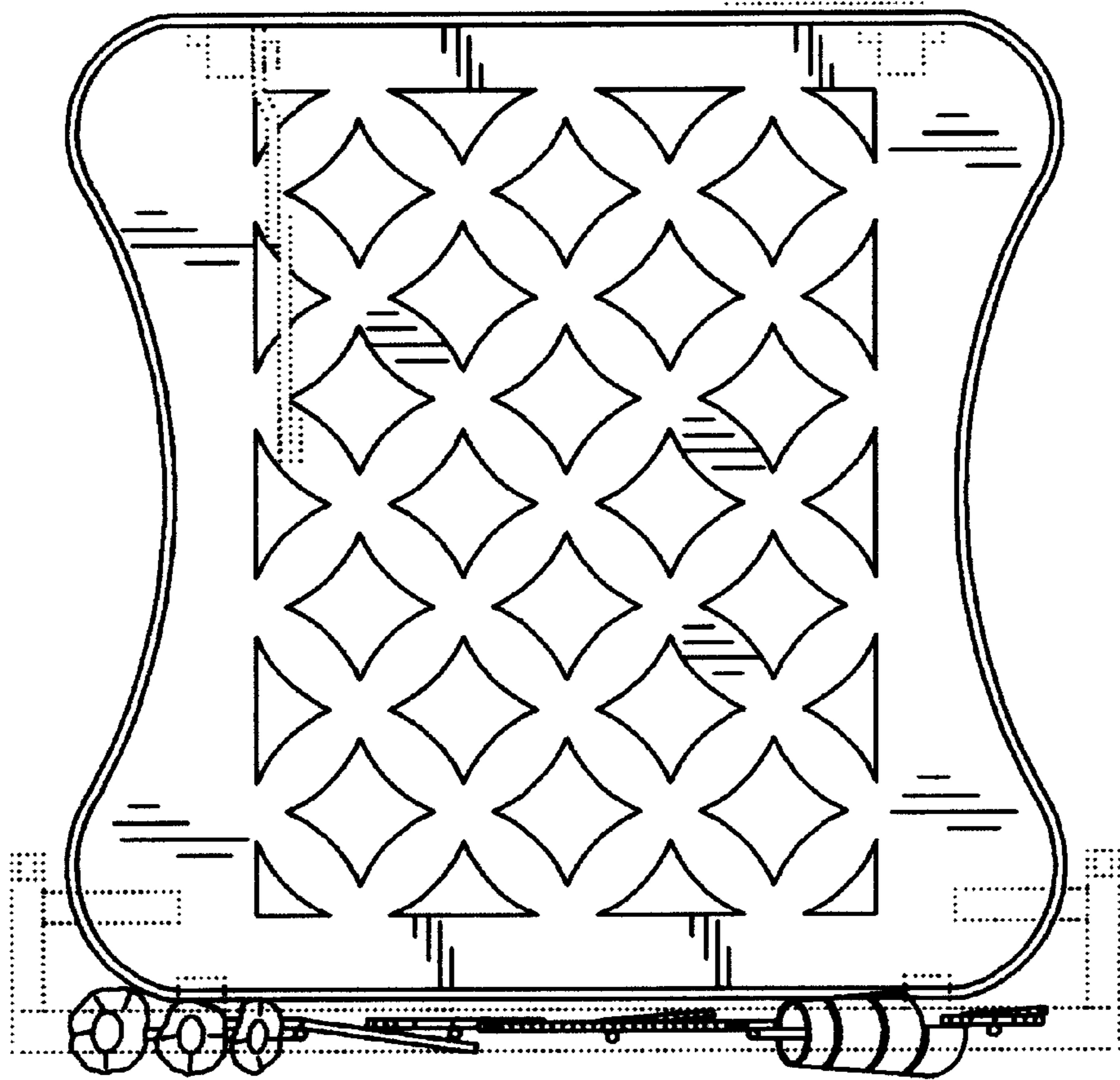


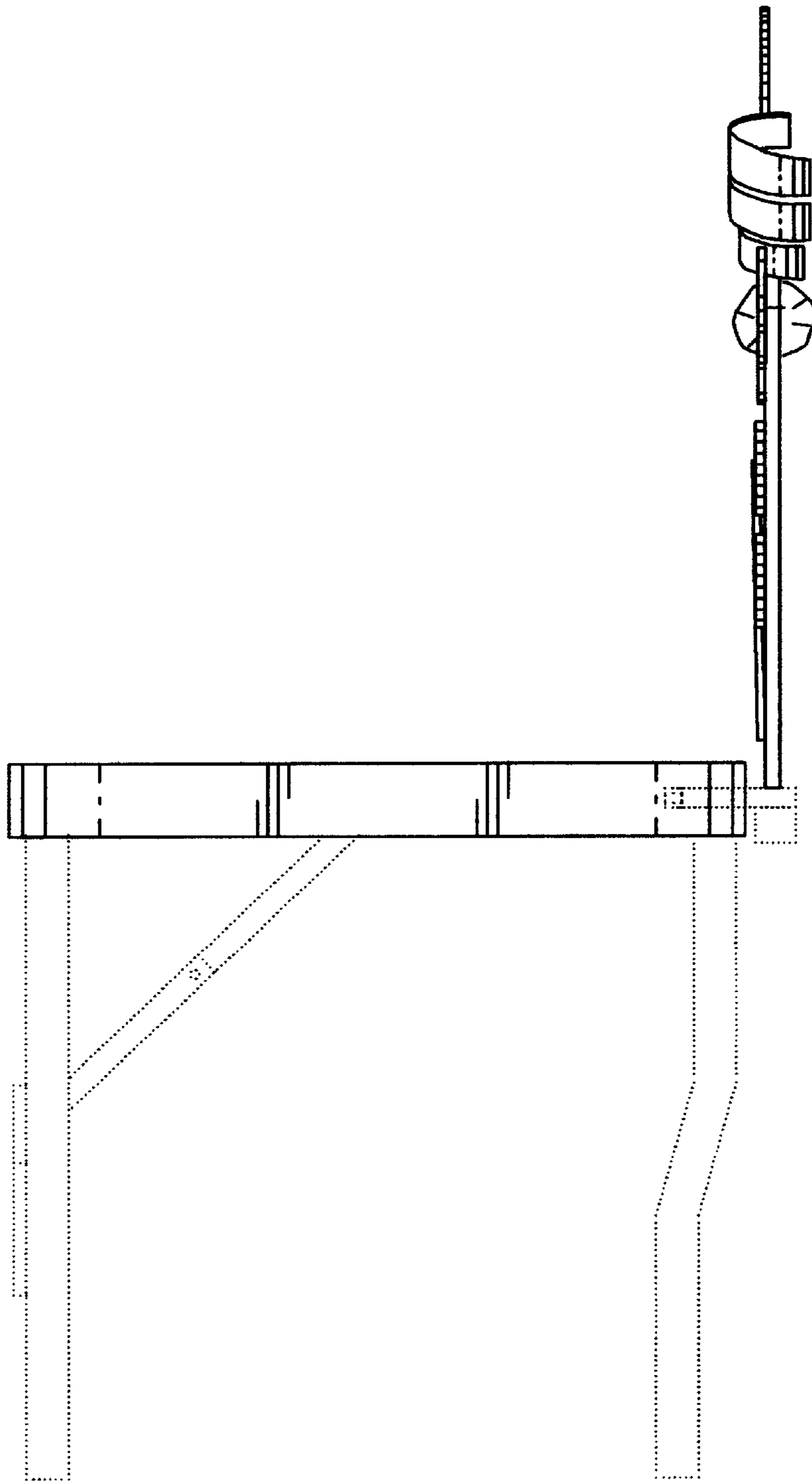

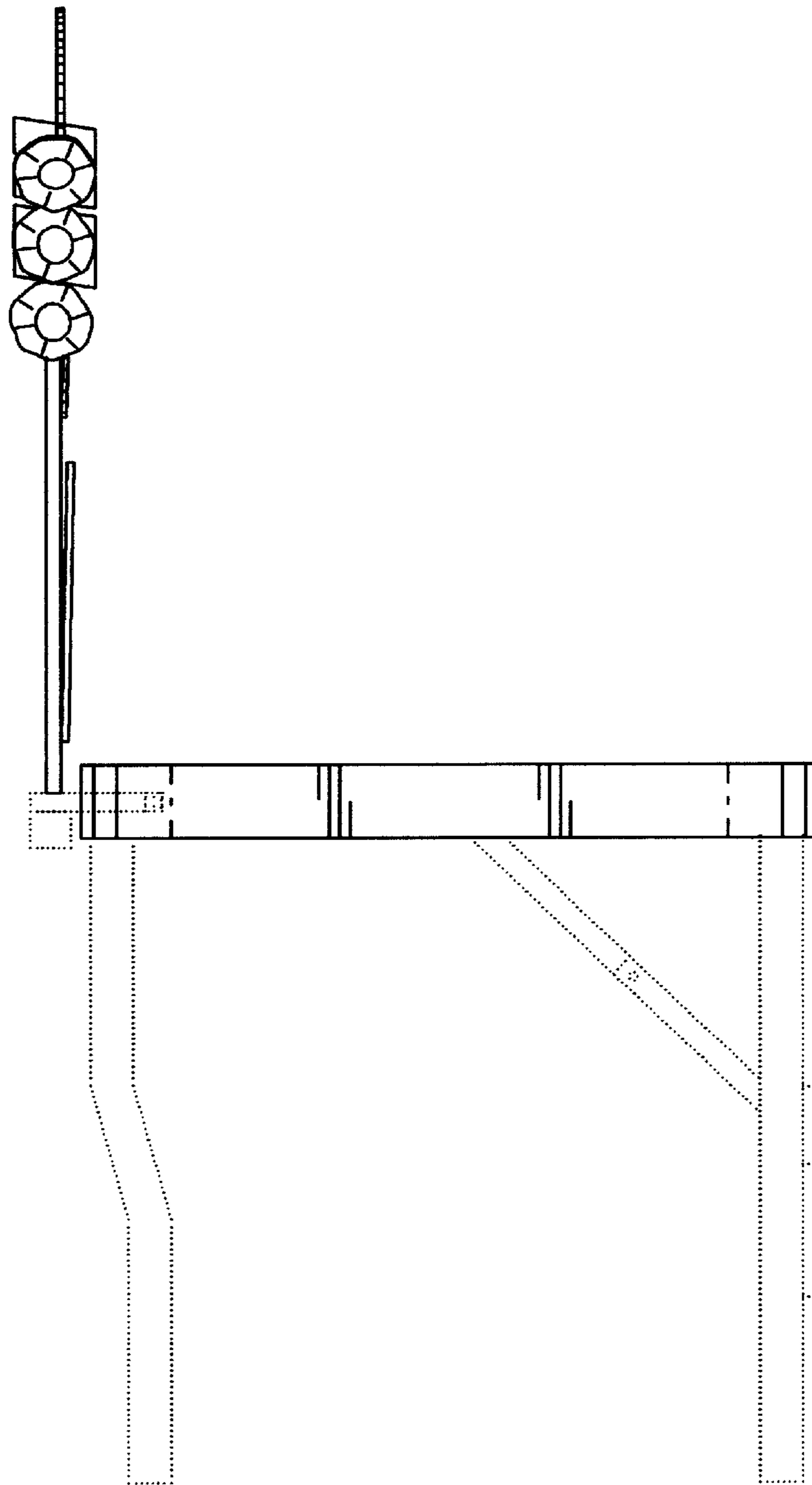
