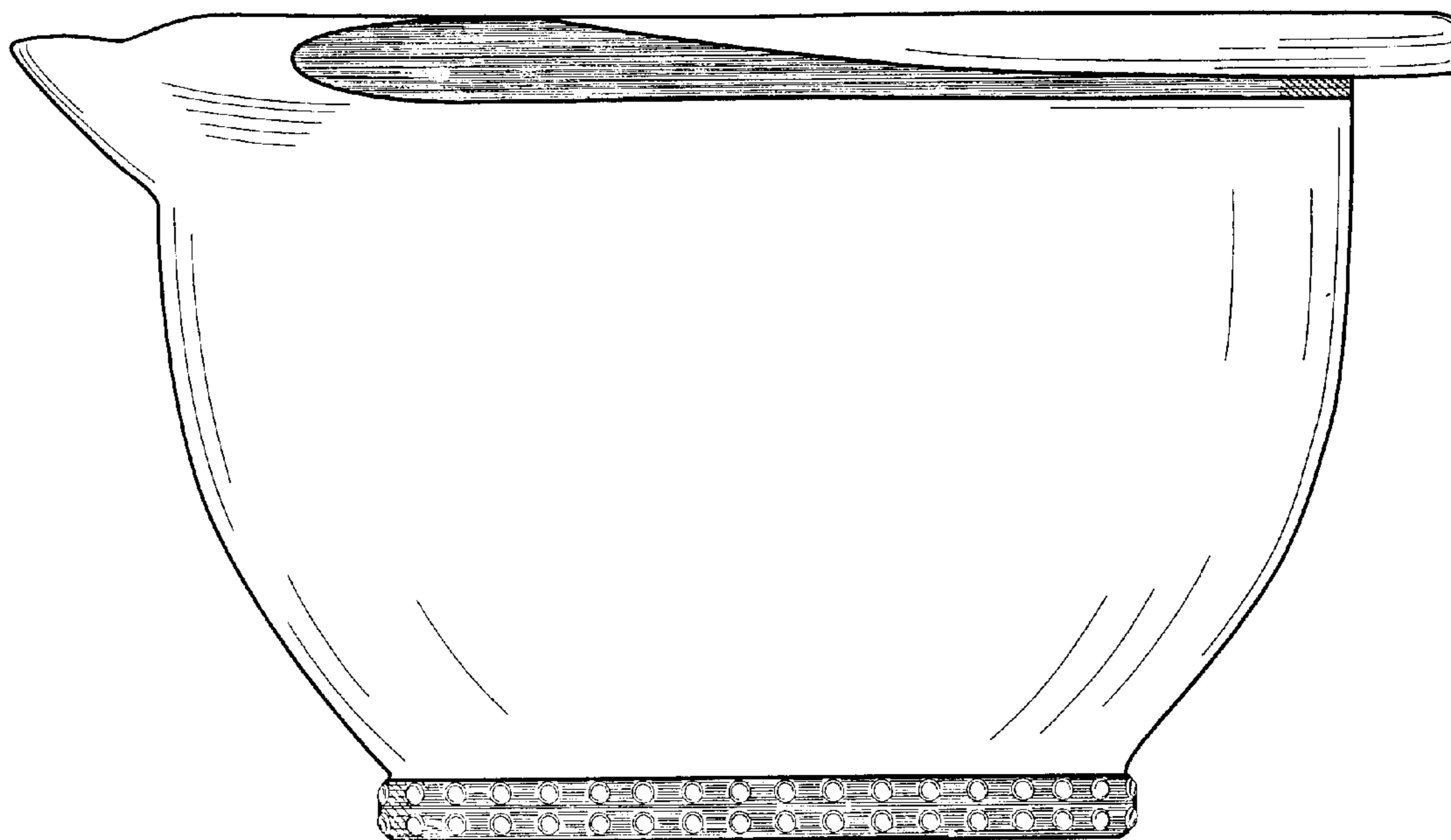
(57) **CLAIM**

The ornamental design for a bowl with friction material, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevational view of the bowl with the friction material, showing the new design; the right side elevation view is a mirror image thereof; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a perspective view thereof.

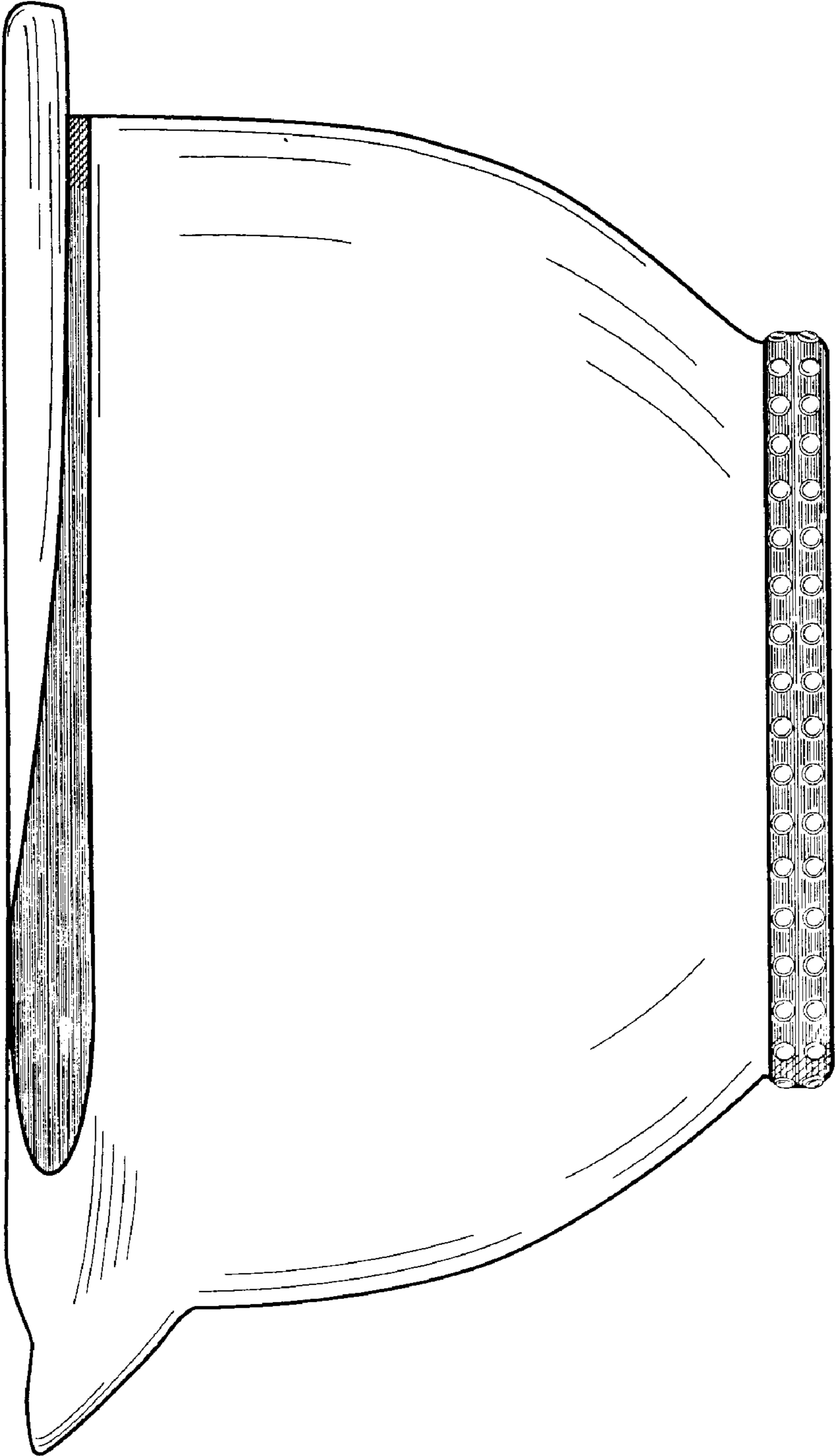

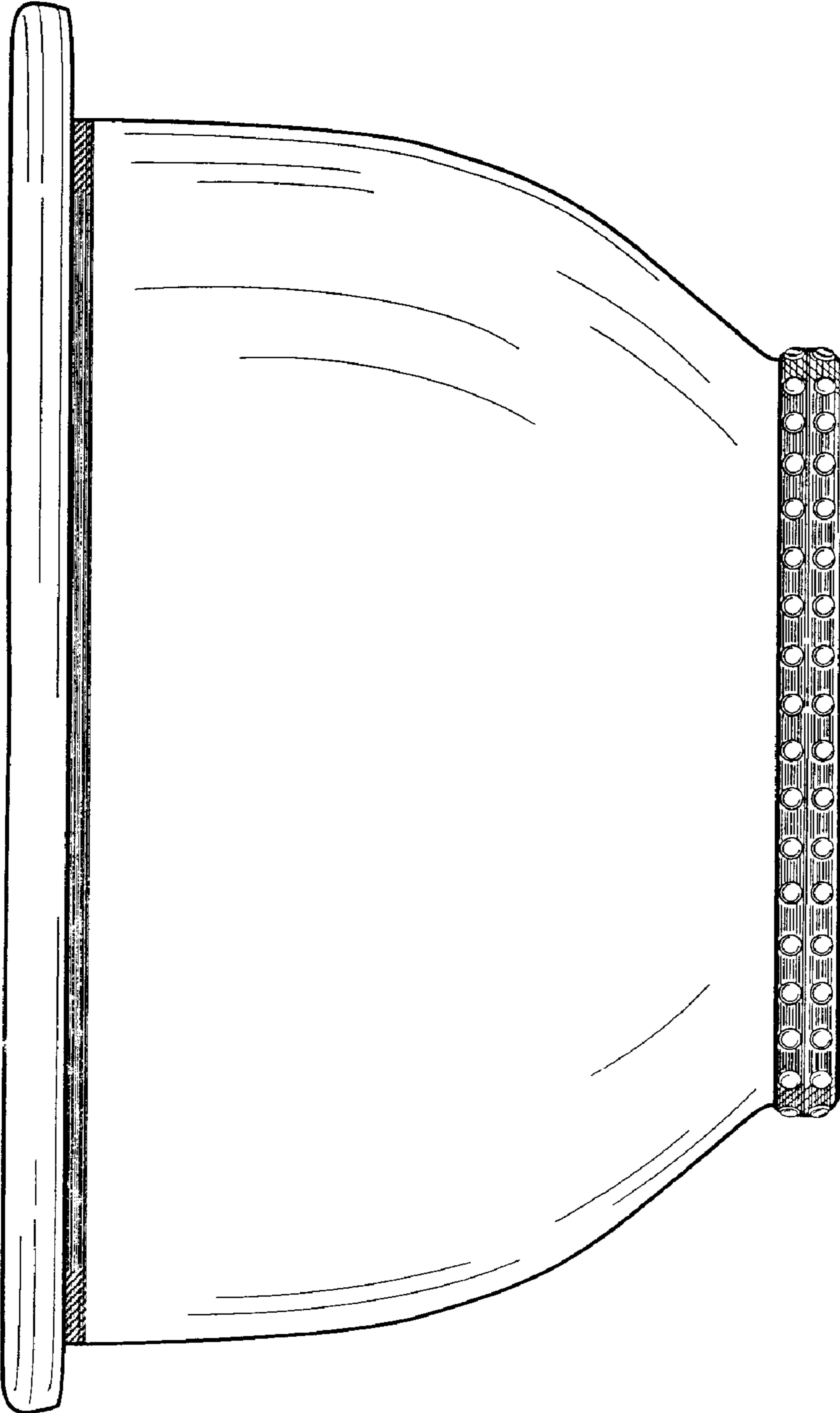

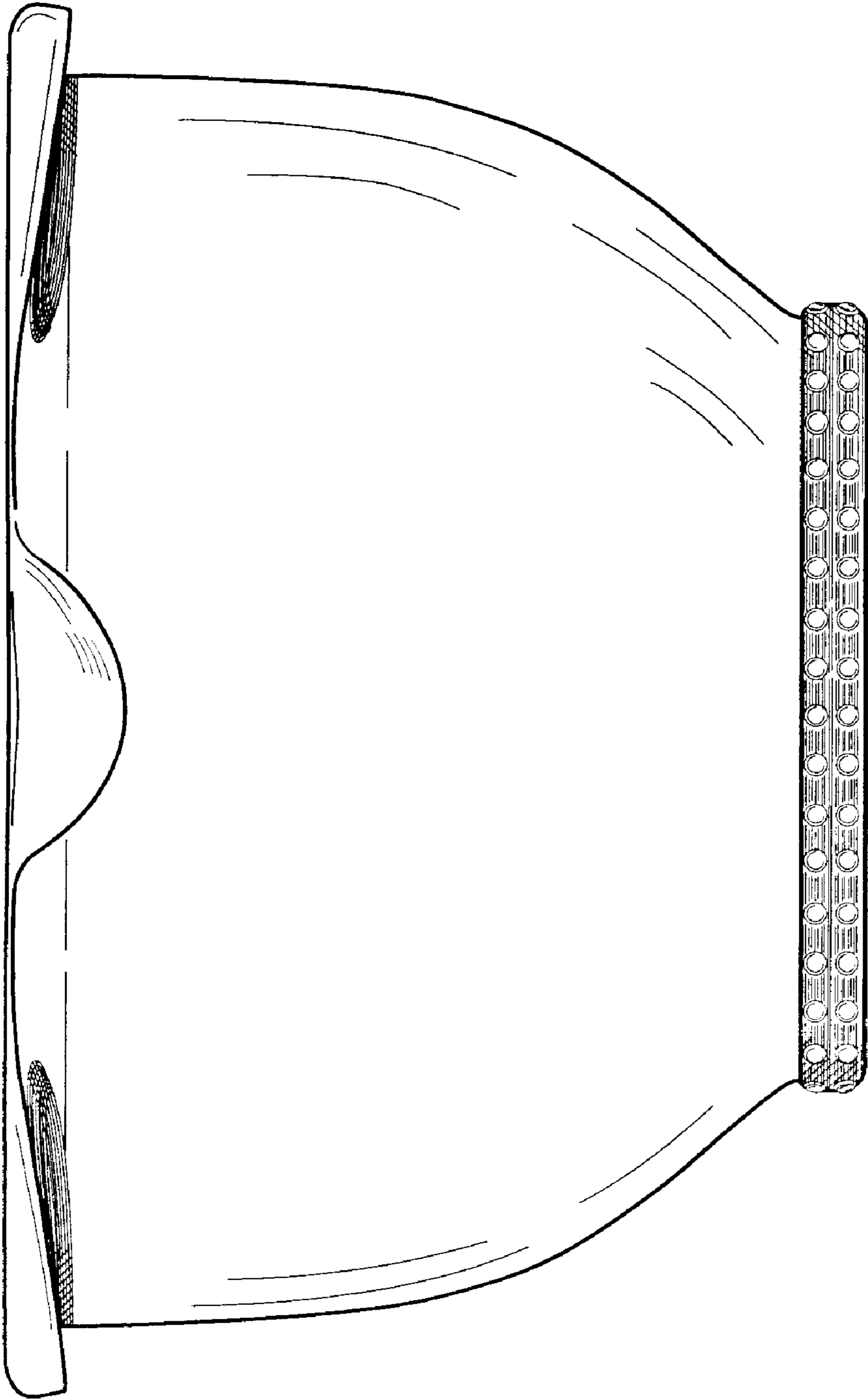

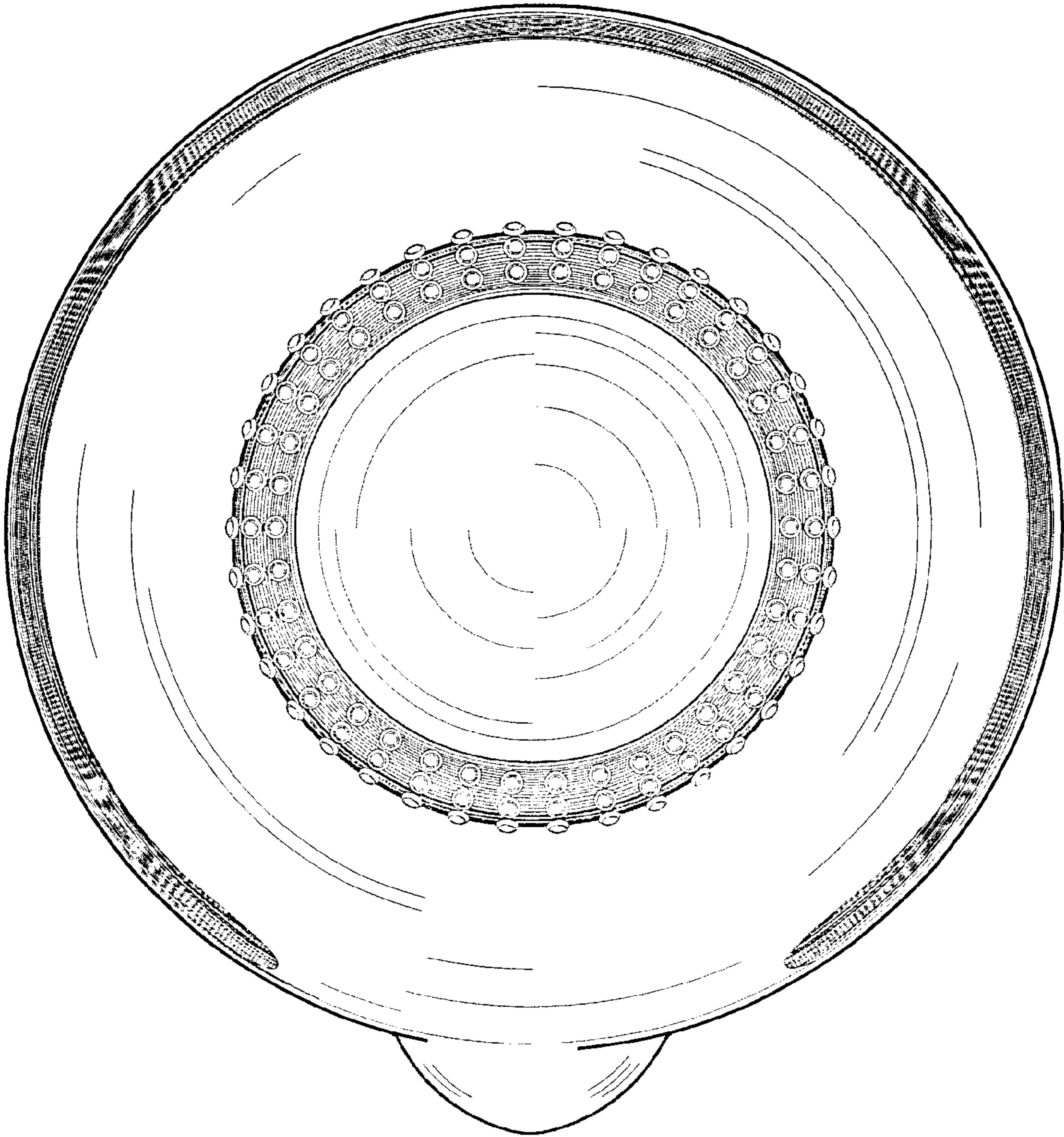

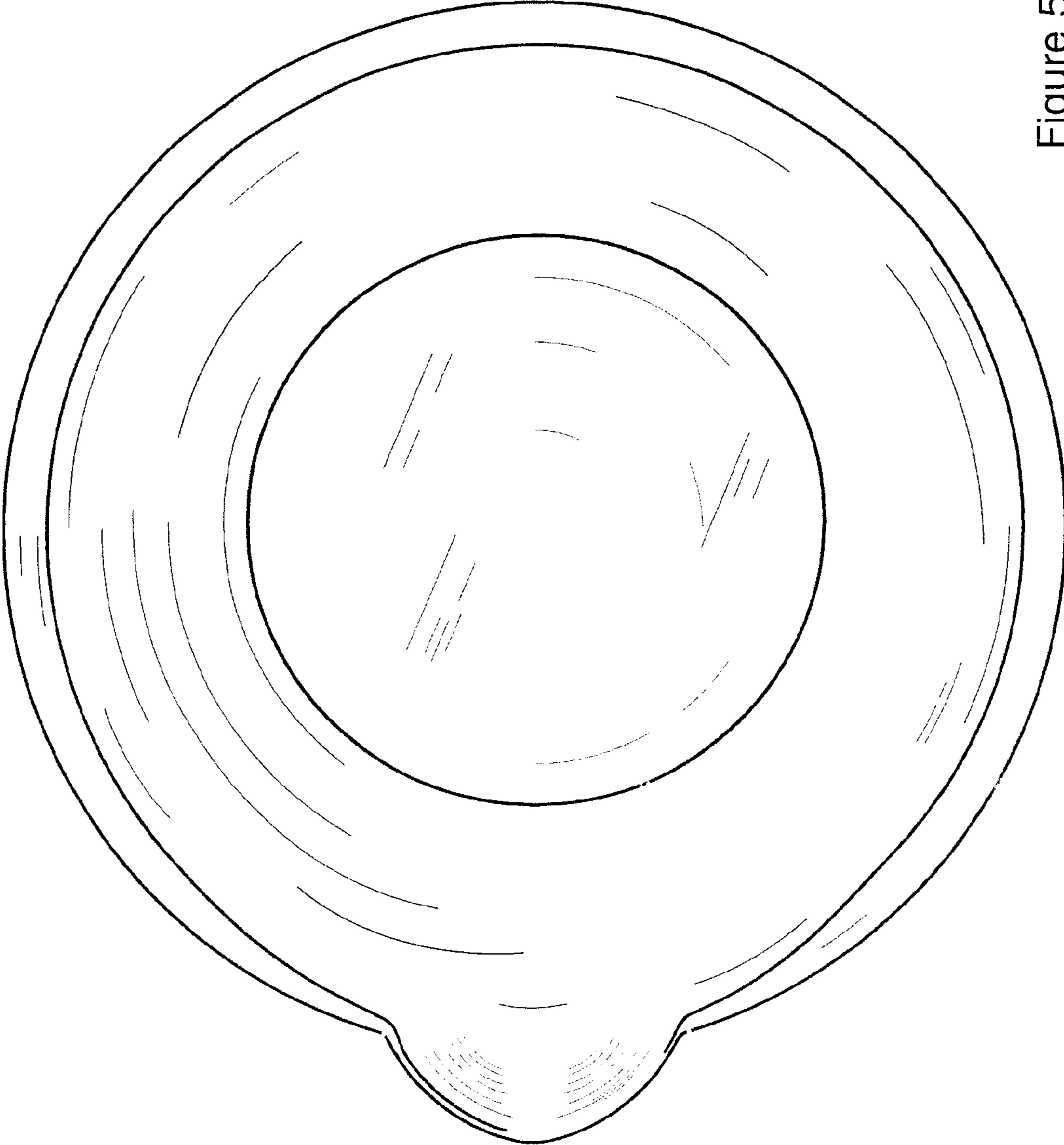

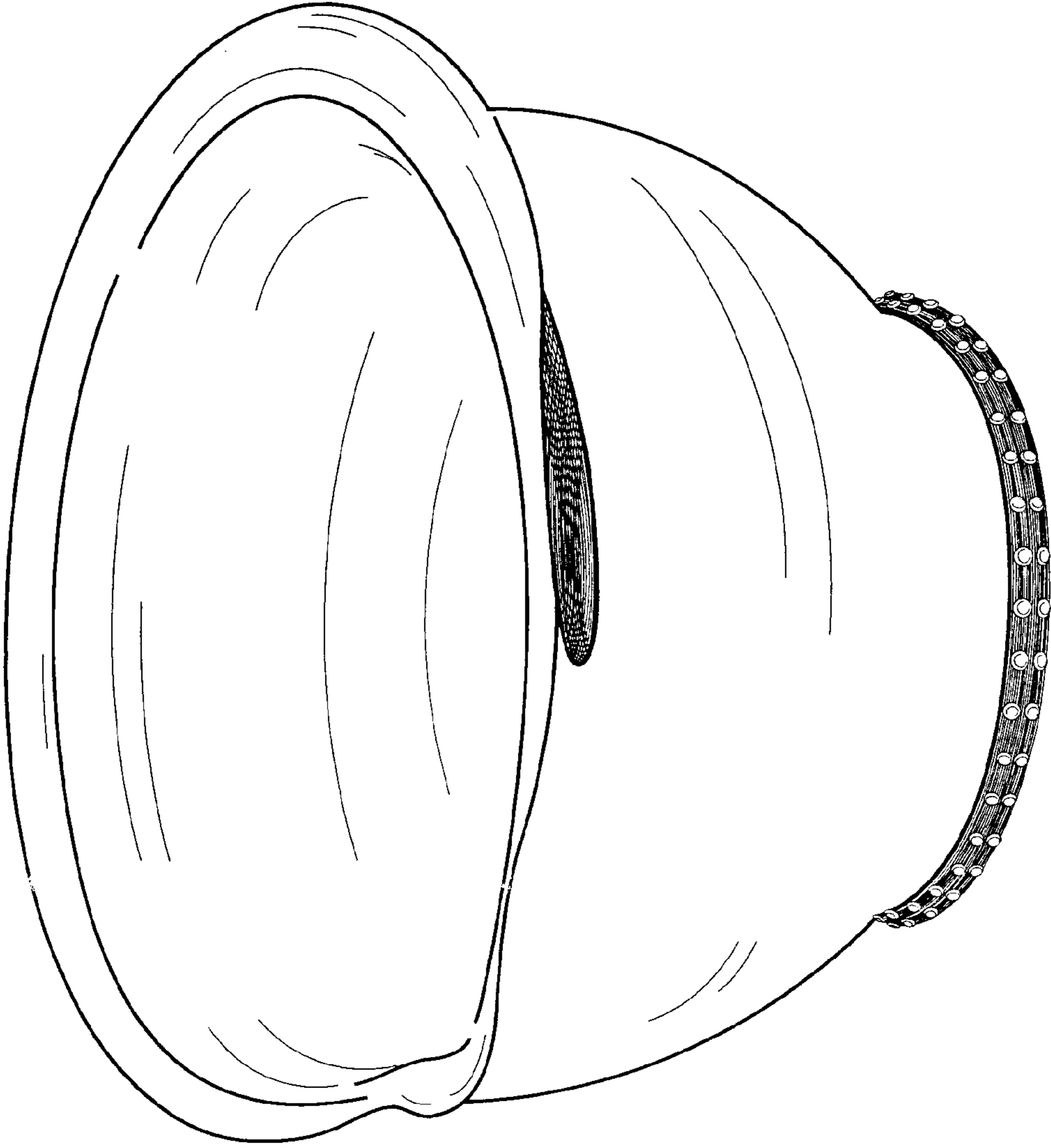
