FIG. 3 is a rear elevational view thereof;

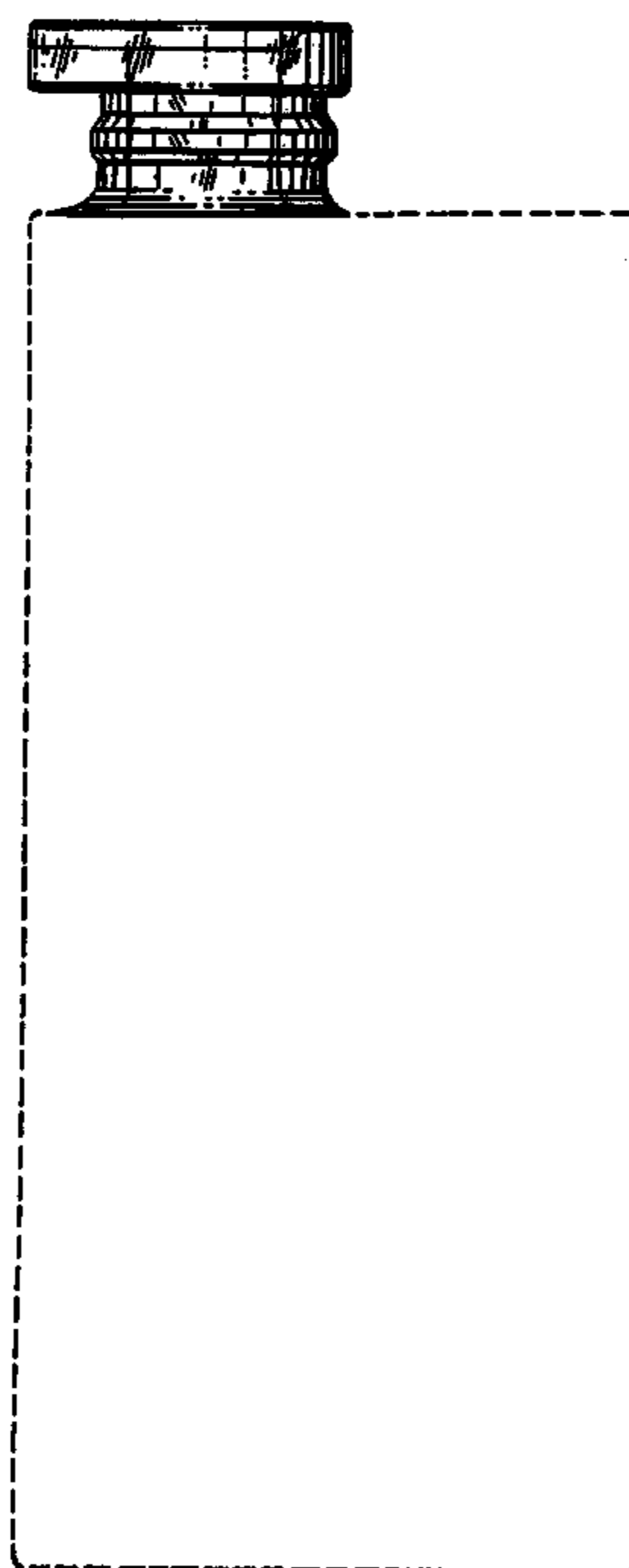
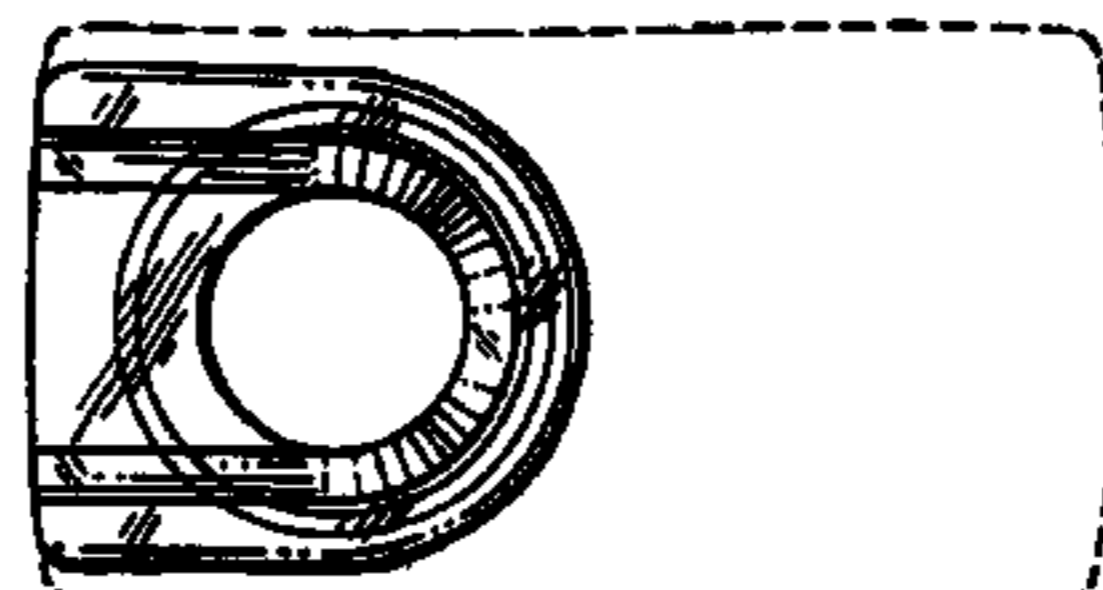
FIG. 4 is a front elevational view thereof;

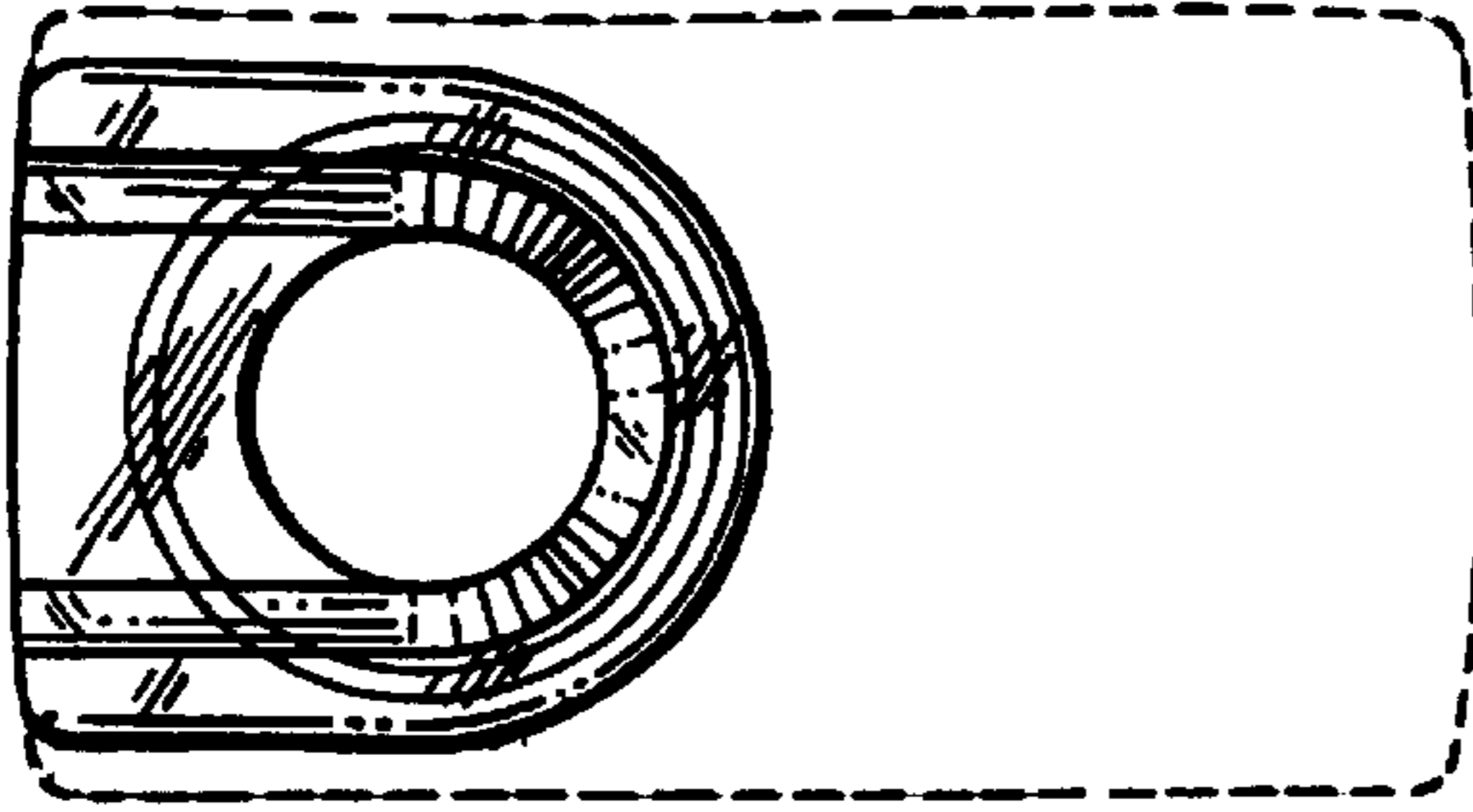
FIG. 5 is a left side view thereof; and,

FIG. 6 is a bottom view thereof.

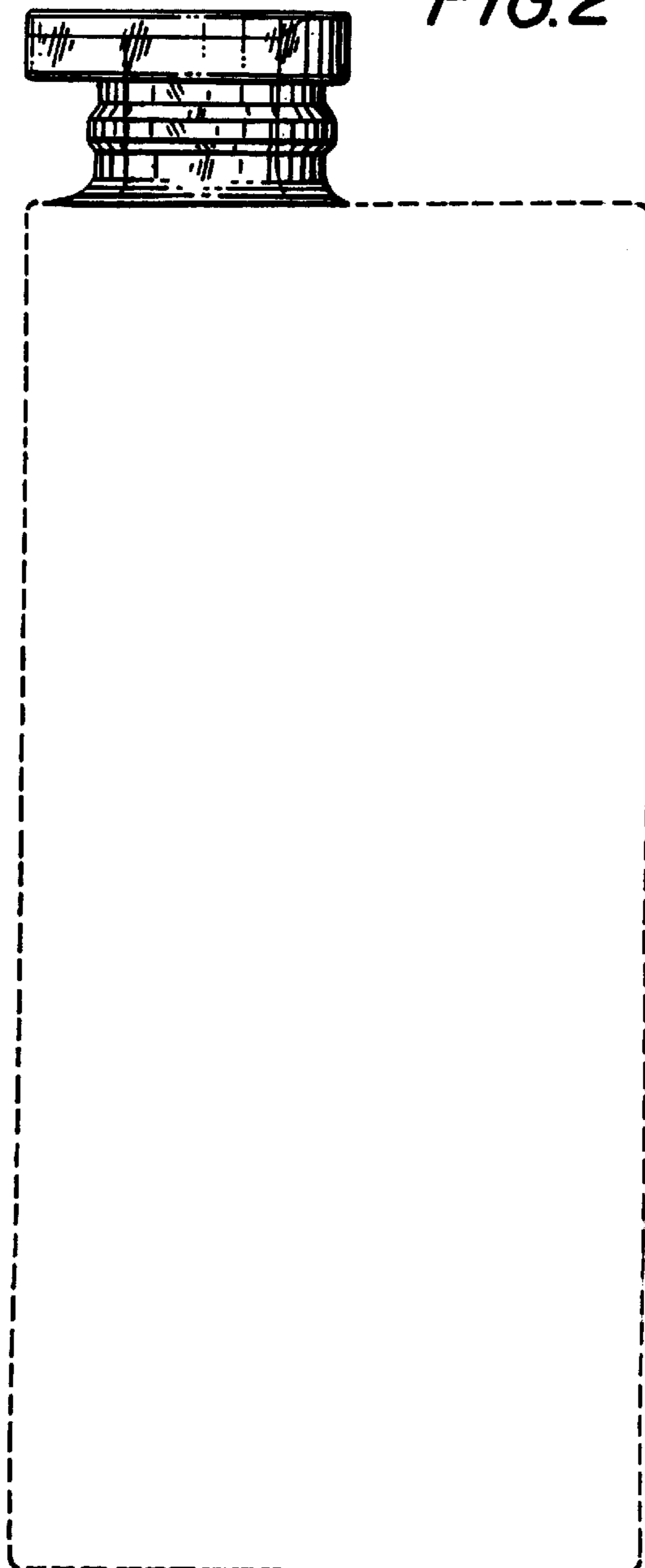

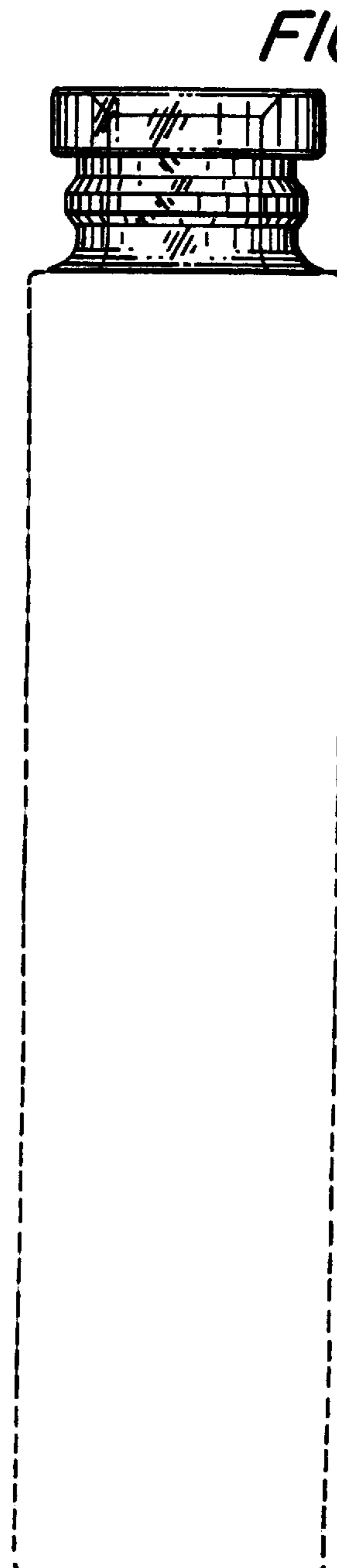

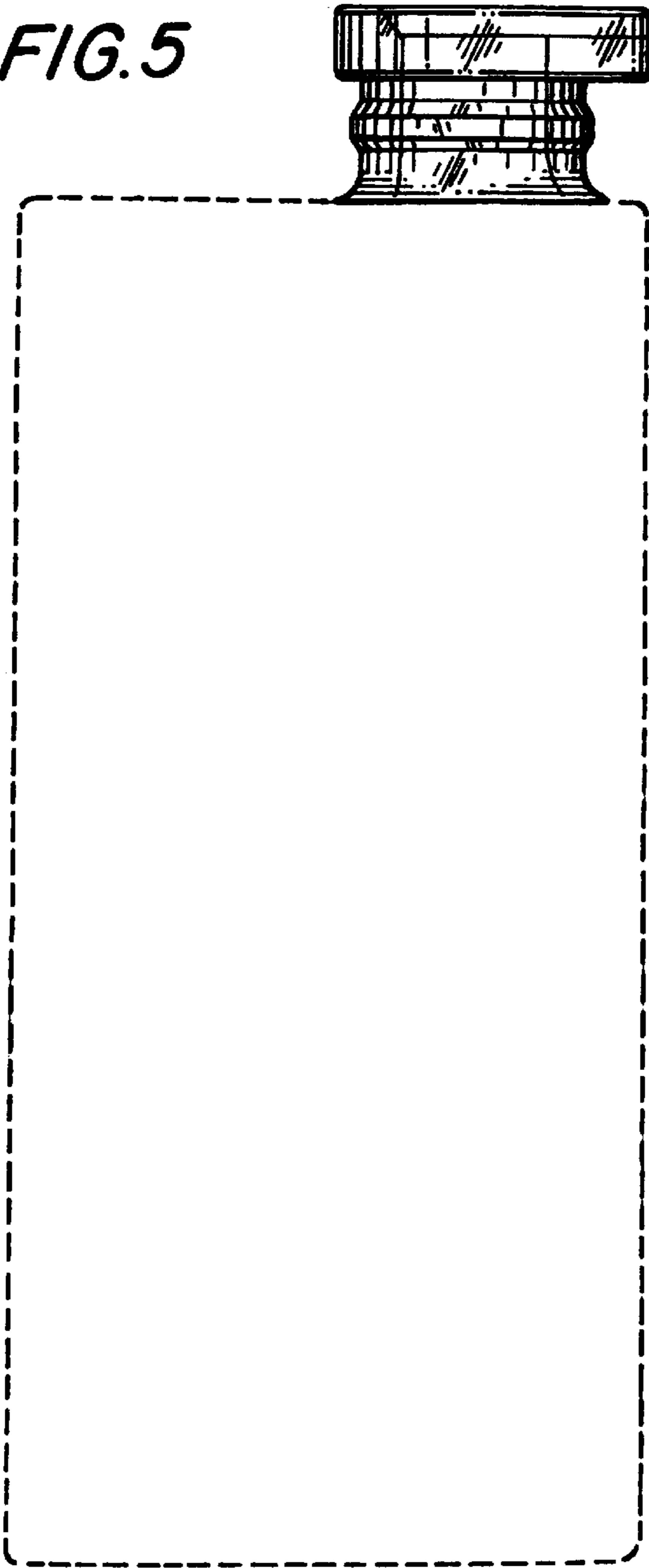

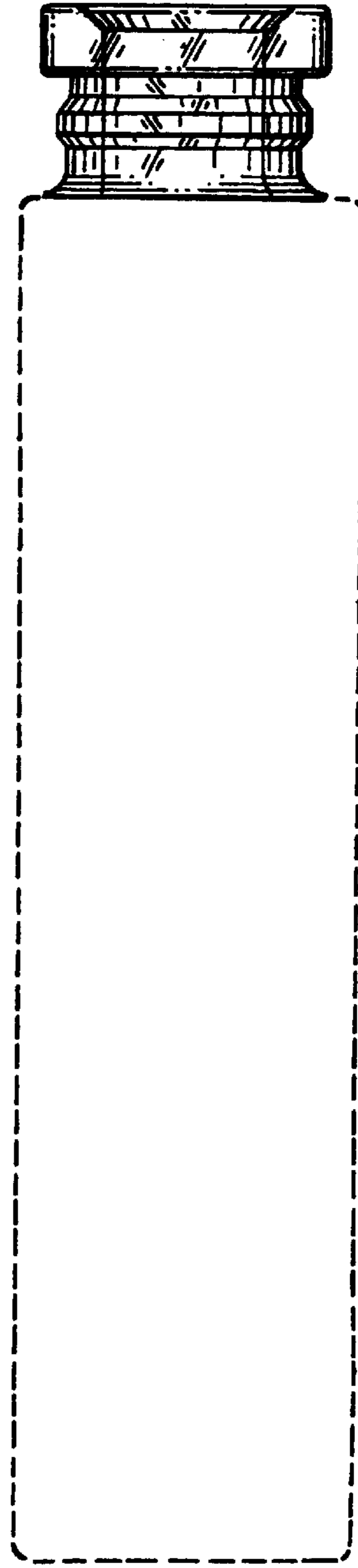

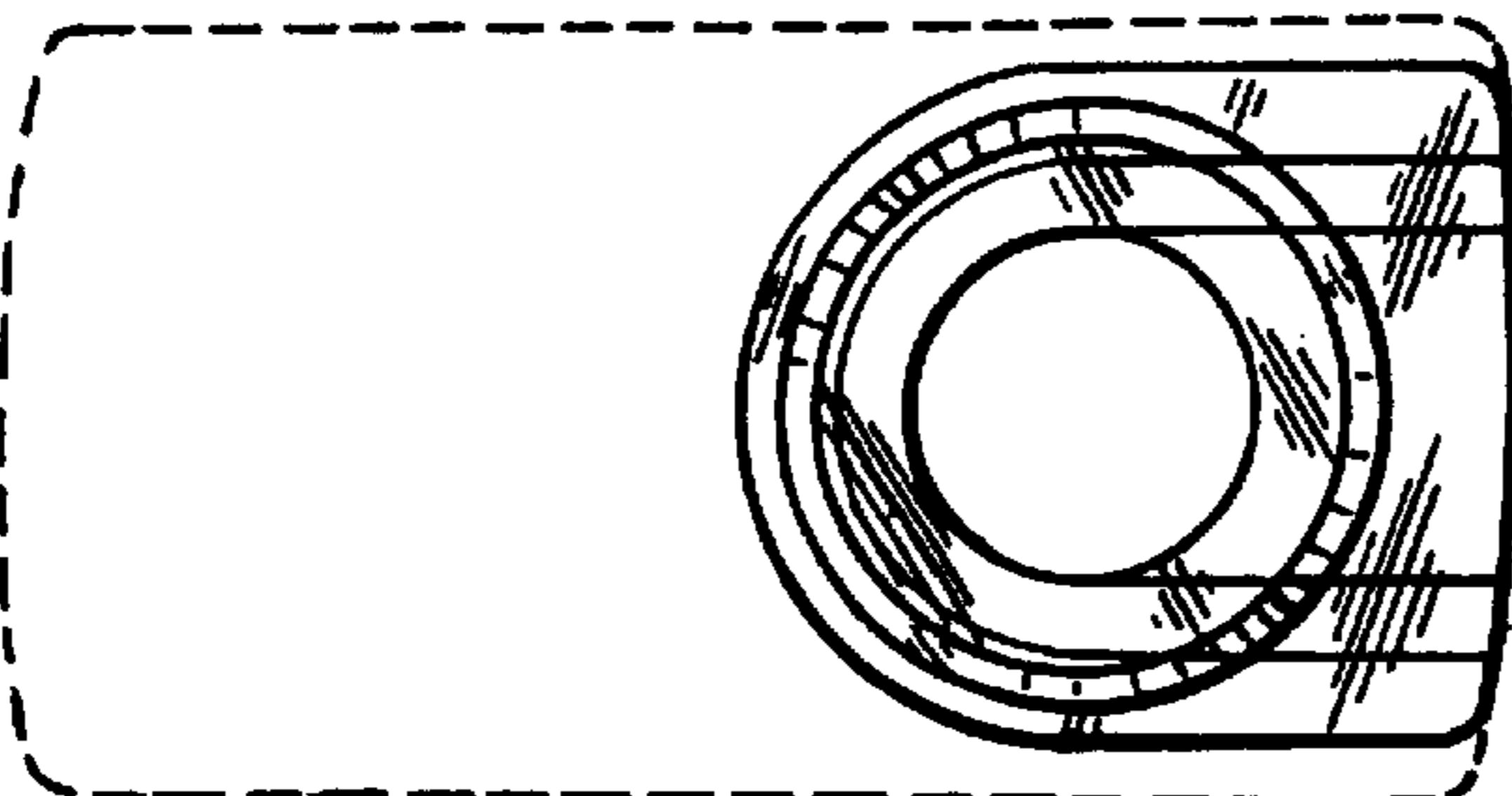
