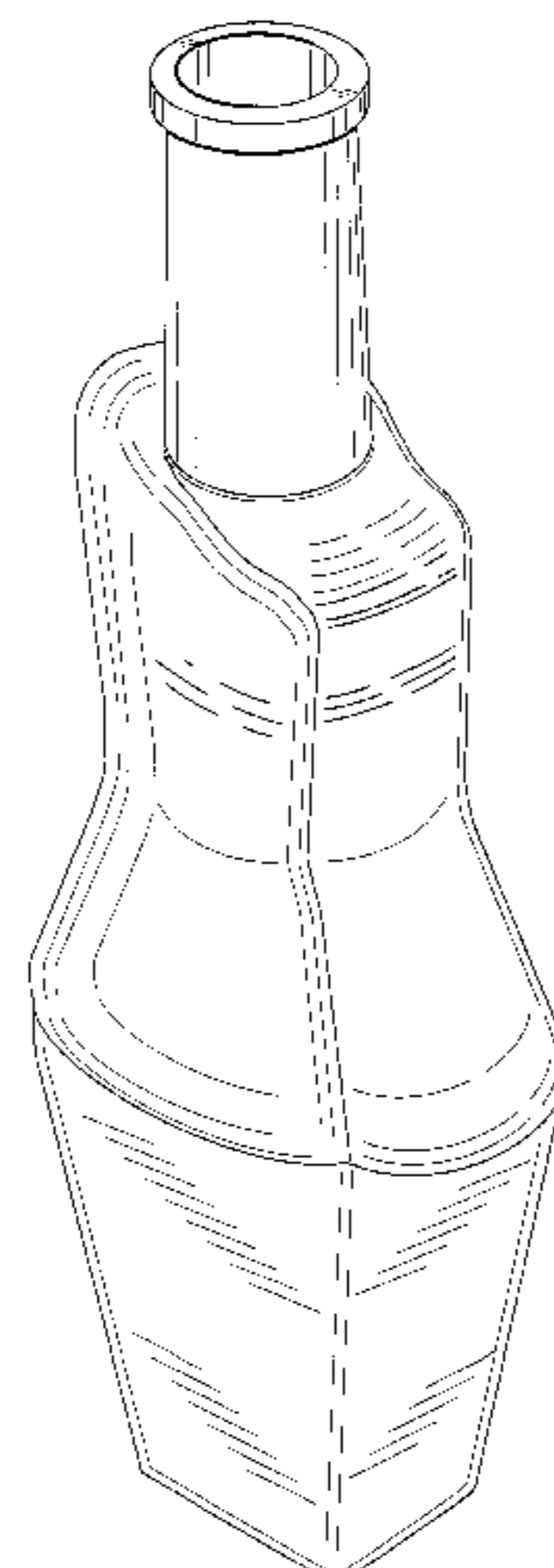
(57) **CLAIM**

The ornamental design for bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottle showing my new design;
FIG. 2 is front elevational view thereof, the rear elevational view being a mirror image;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

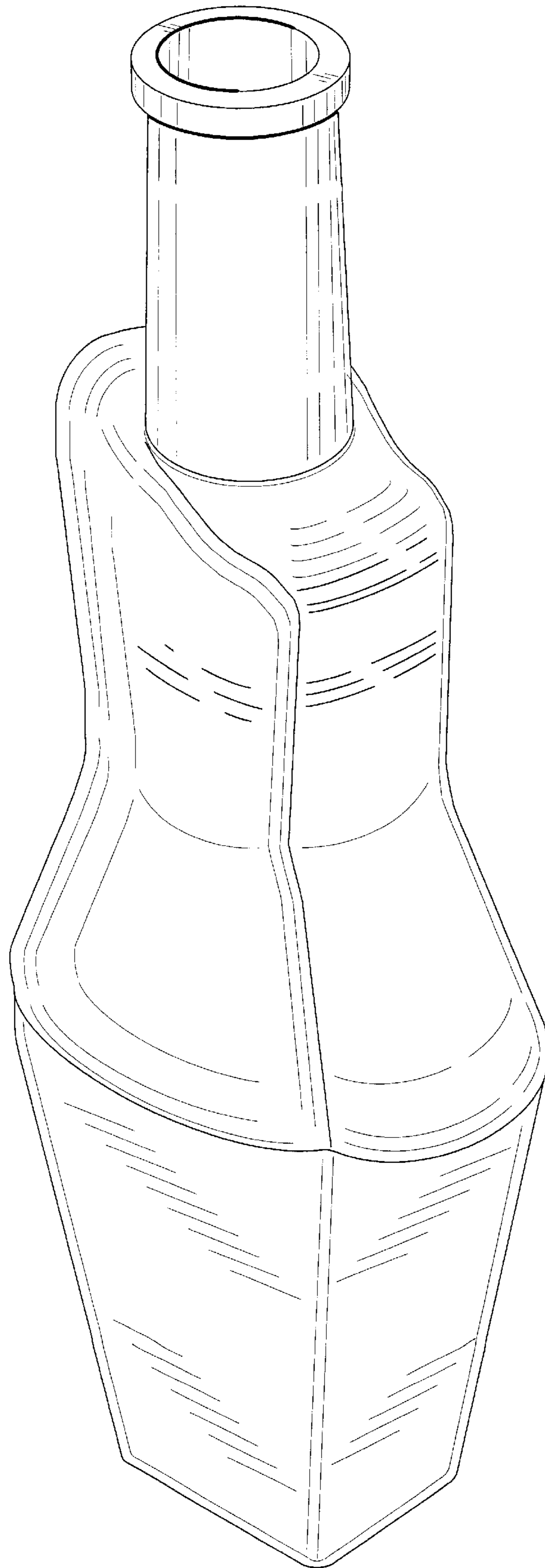

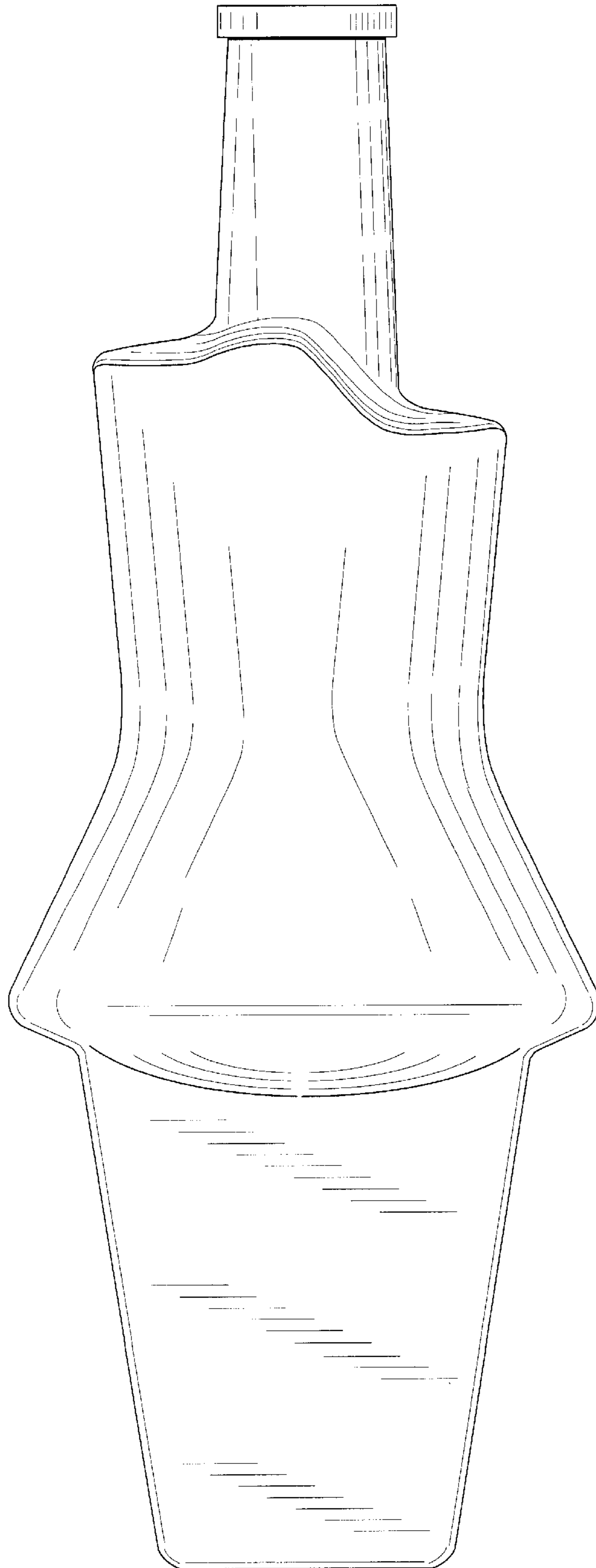

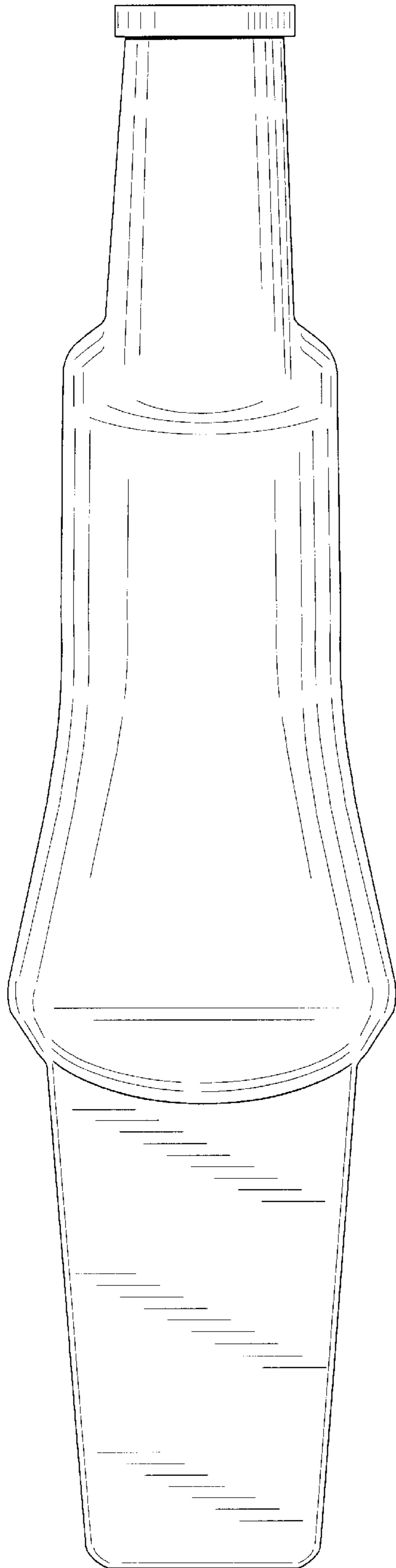

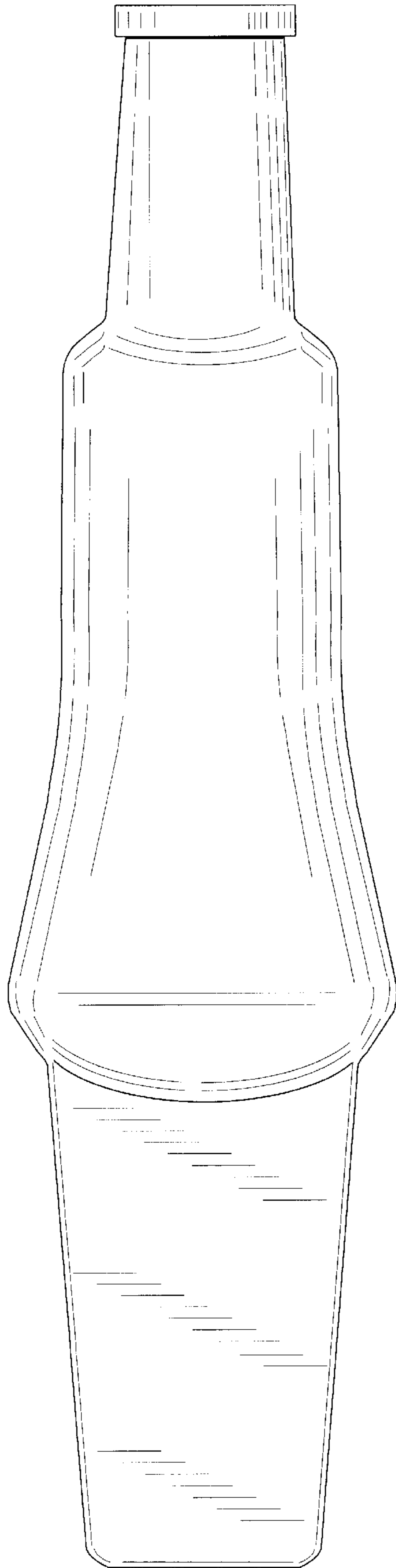

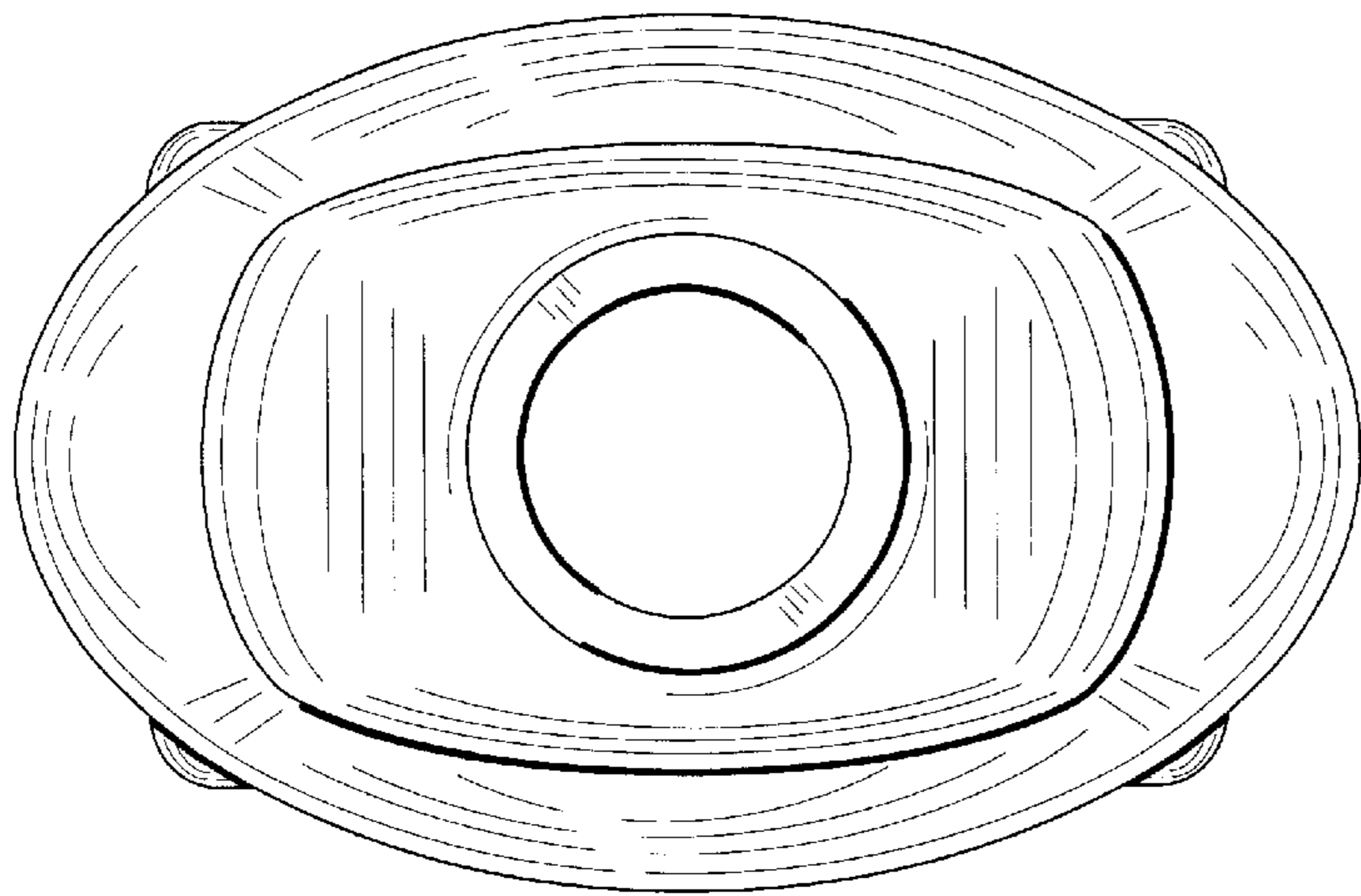

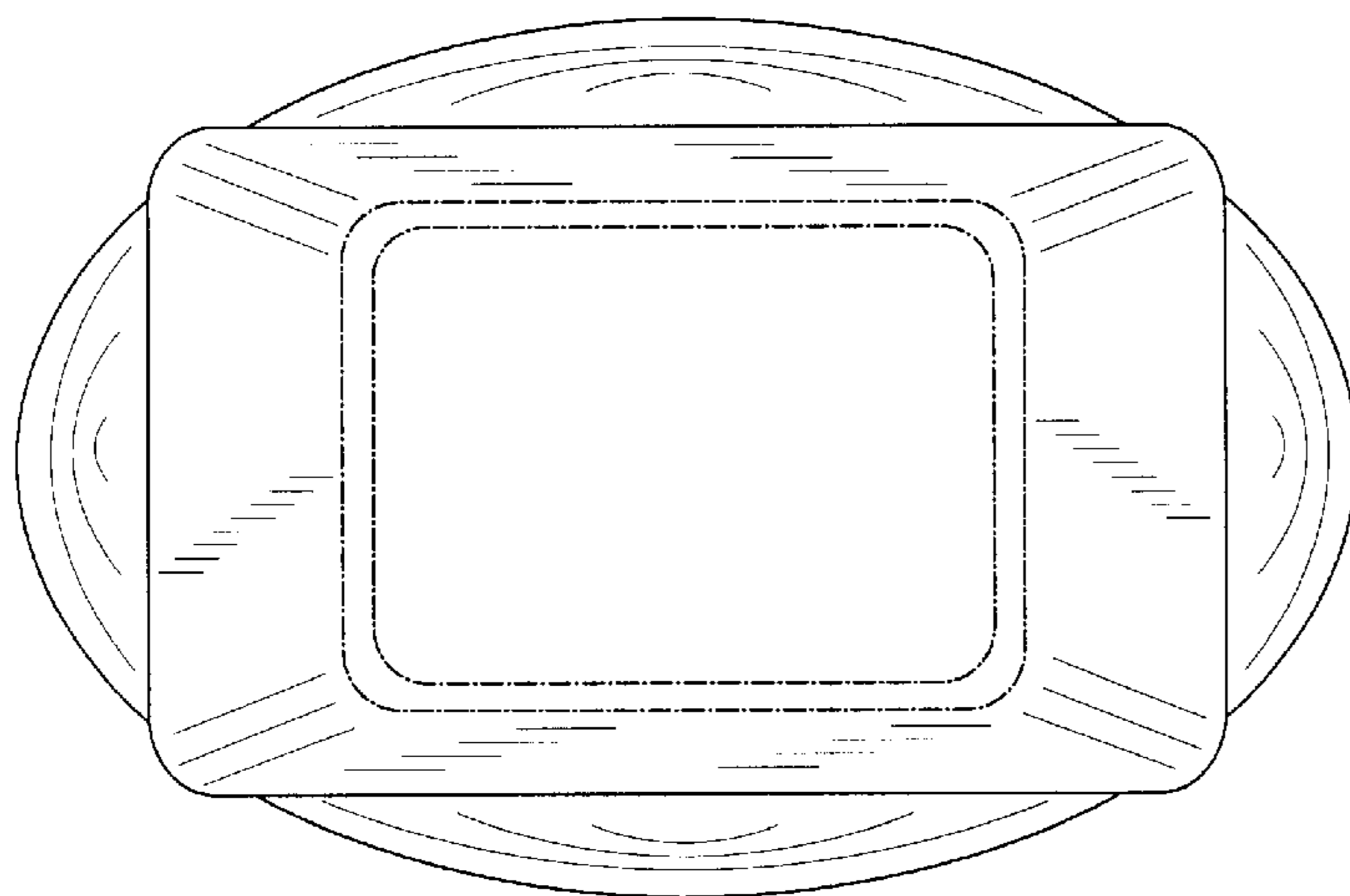
