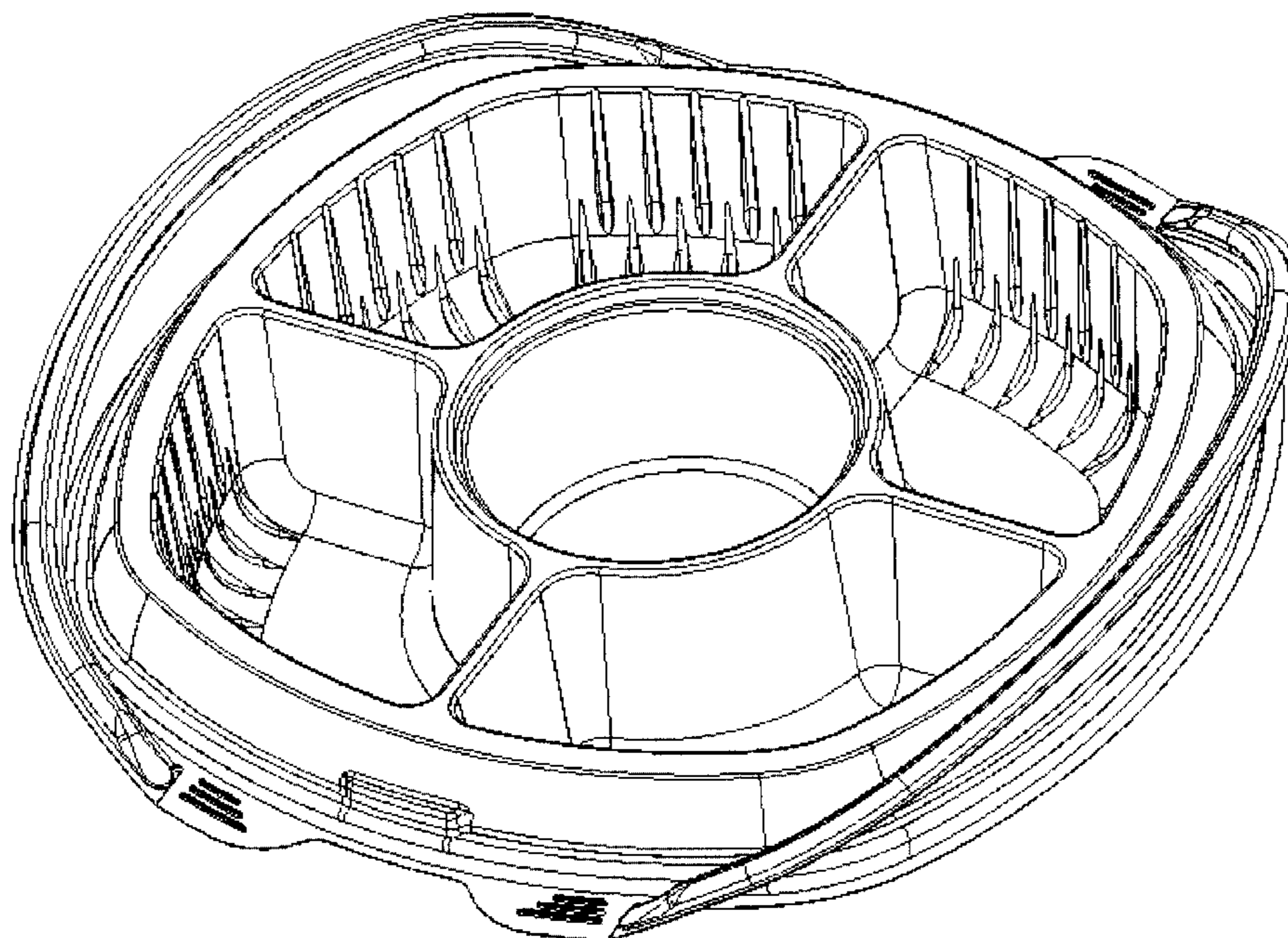
(57) **CLAIM**

We claim the ornamental design for a five compartment container base, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a five compartment container base showing my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a side elevation view of a first side thereof; and,
FIG. 6 is a side elevation view of a second side thereof.
The ornamental design which is claimed is shown in solid lines in the drawings.

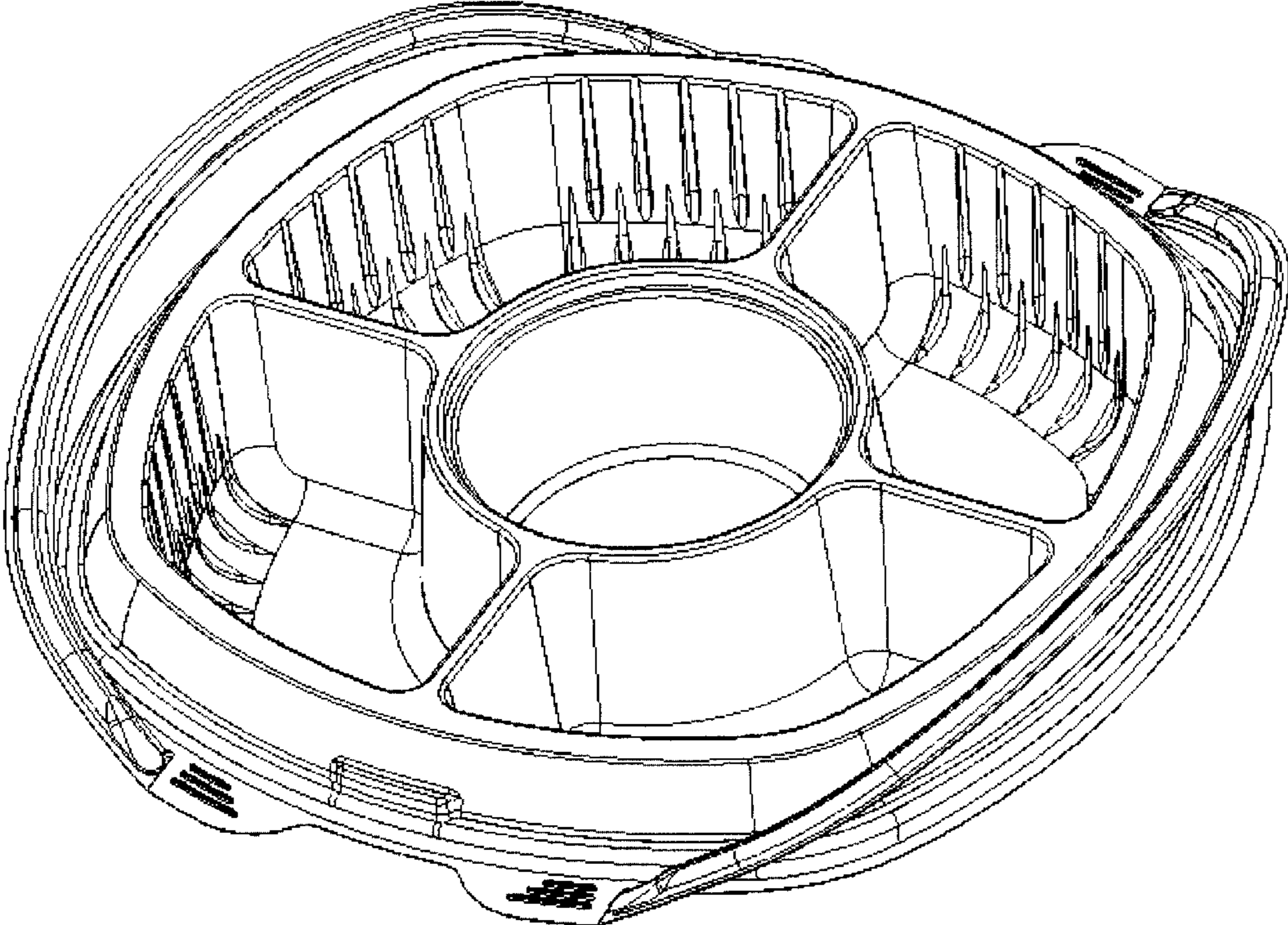

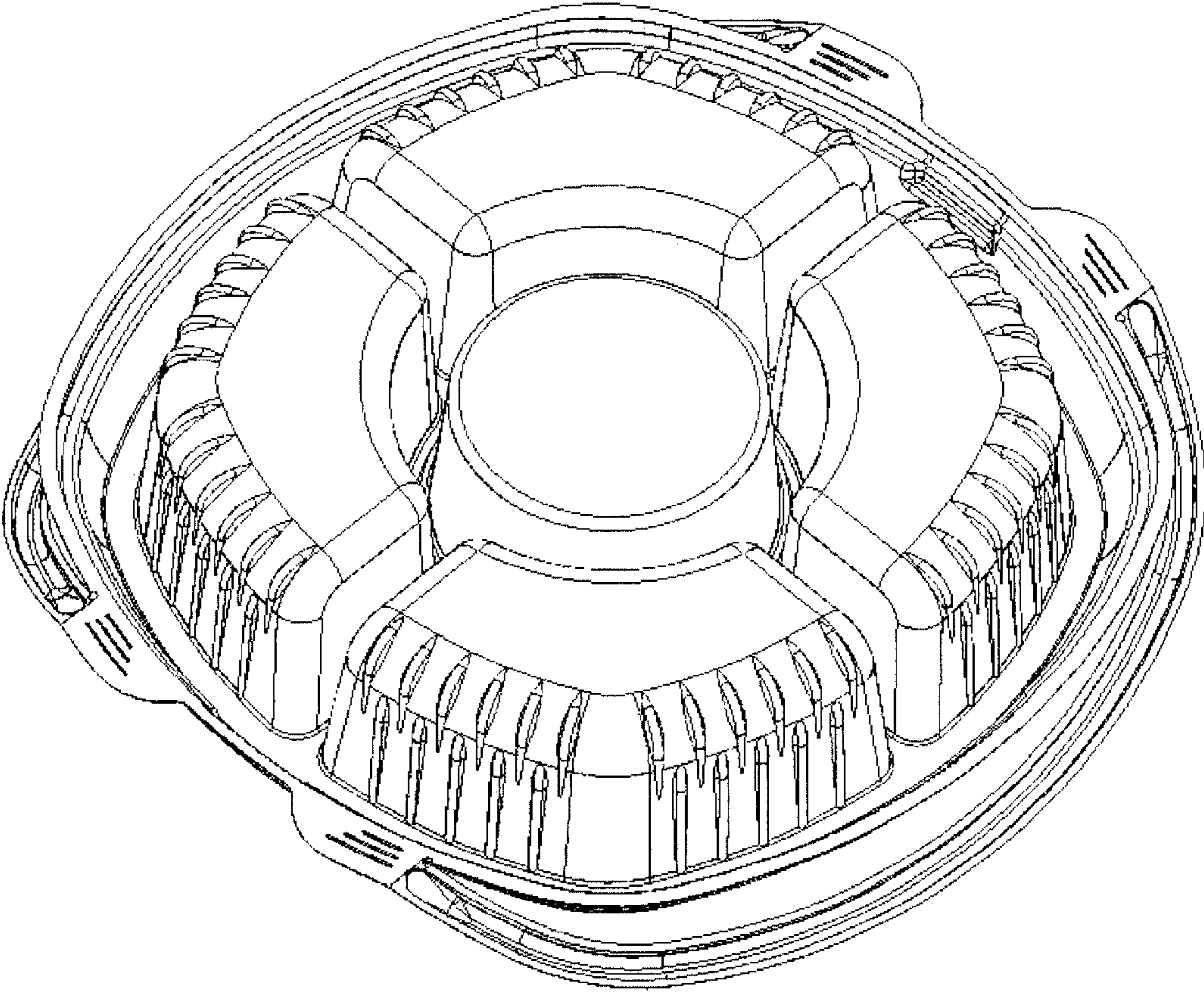

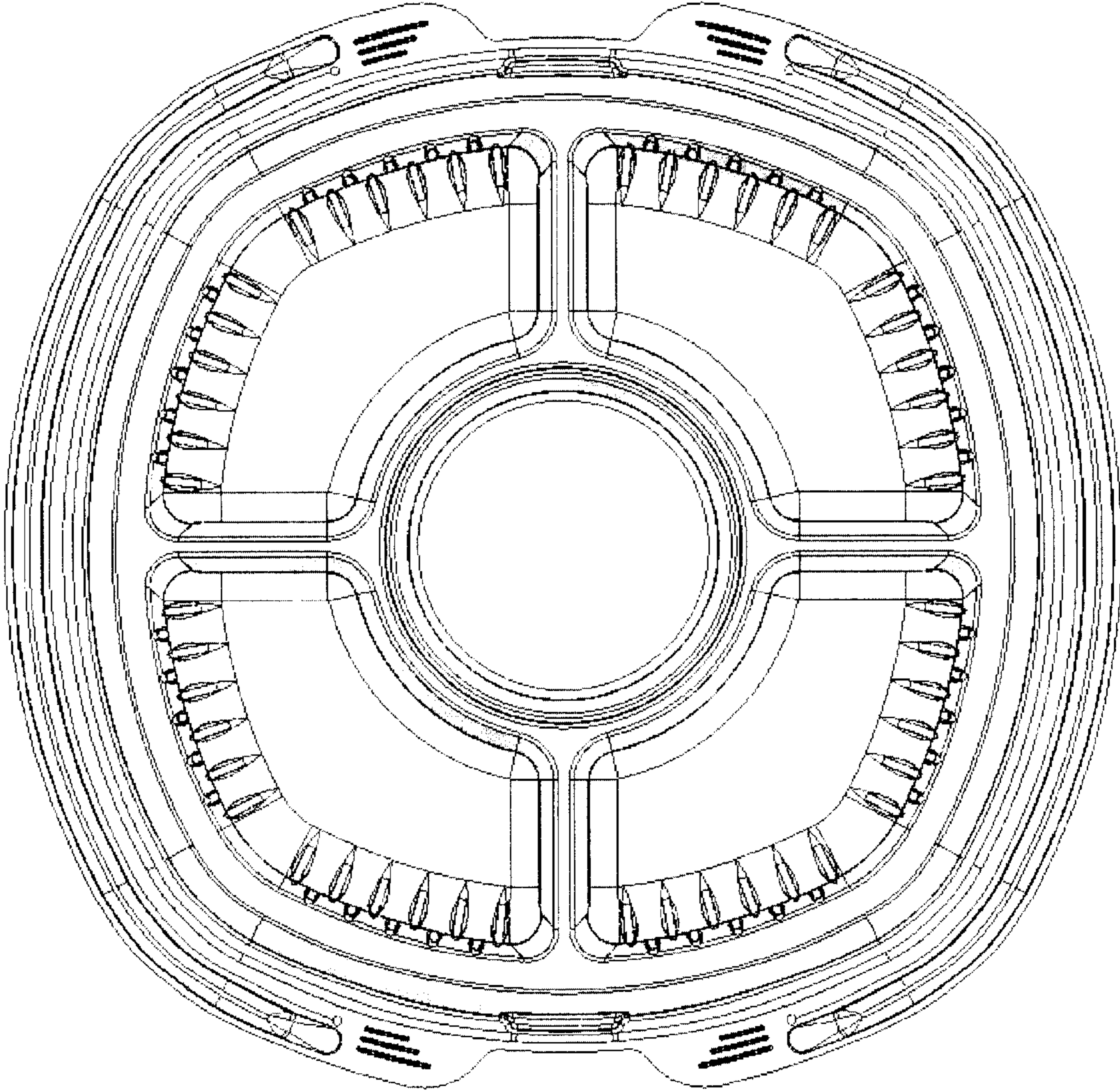

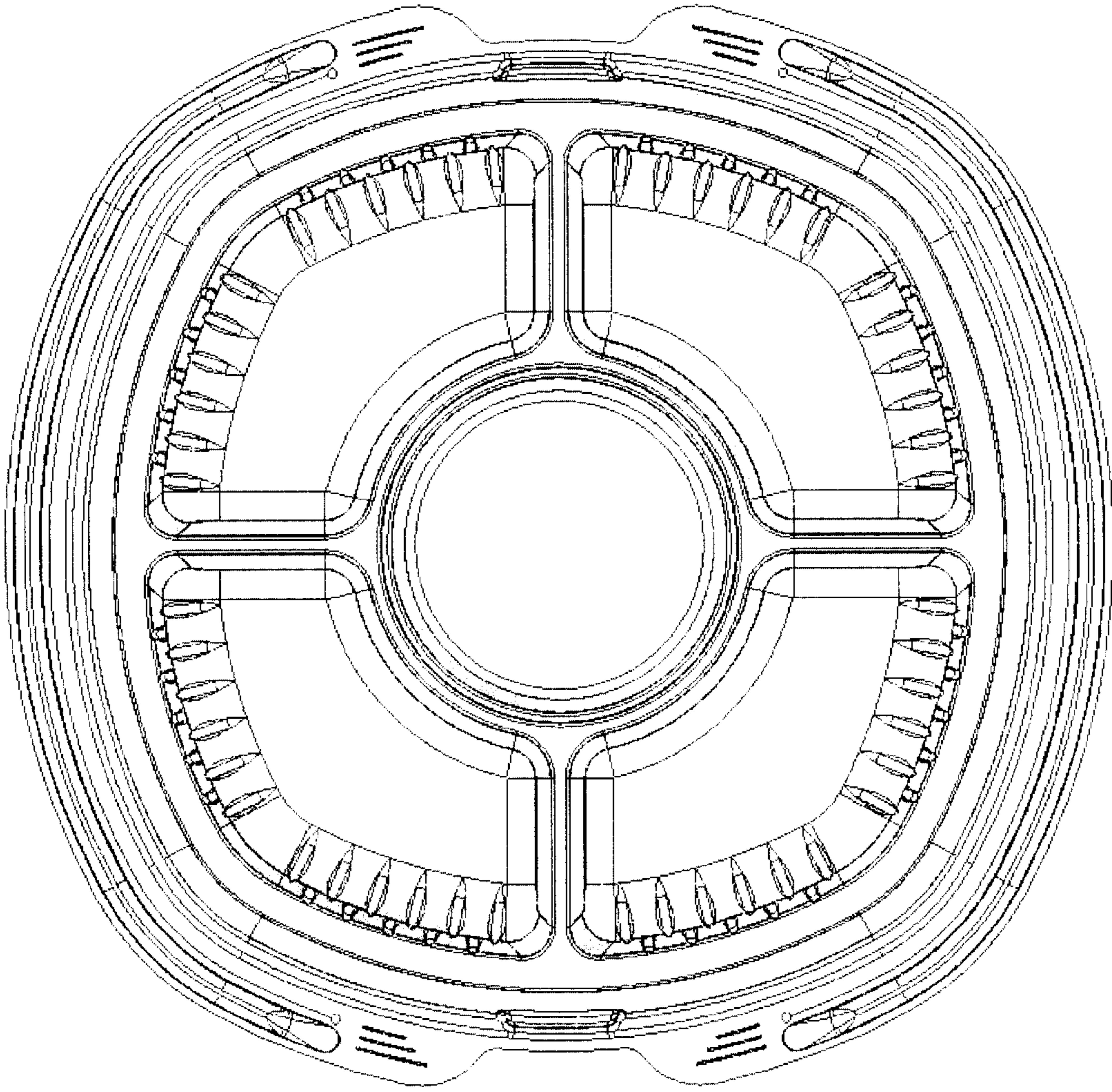

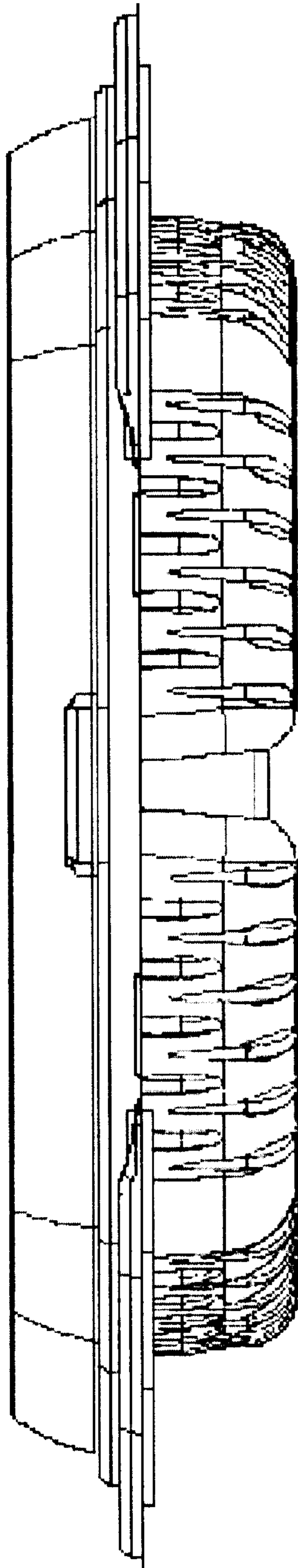

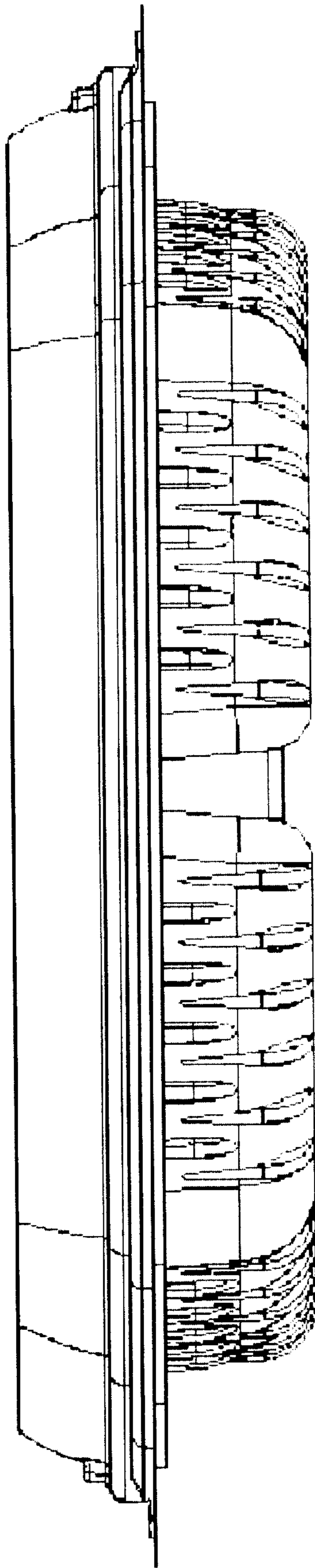
