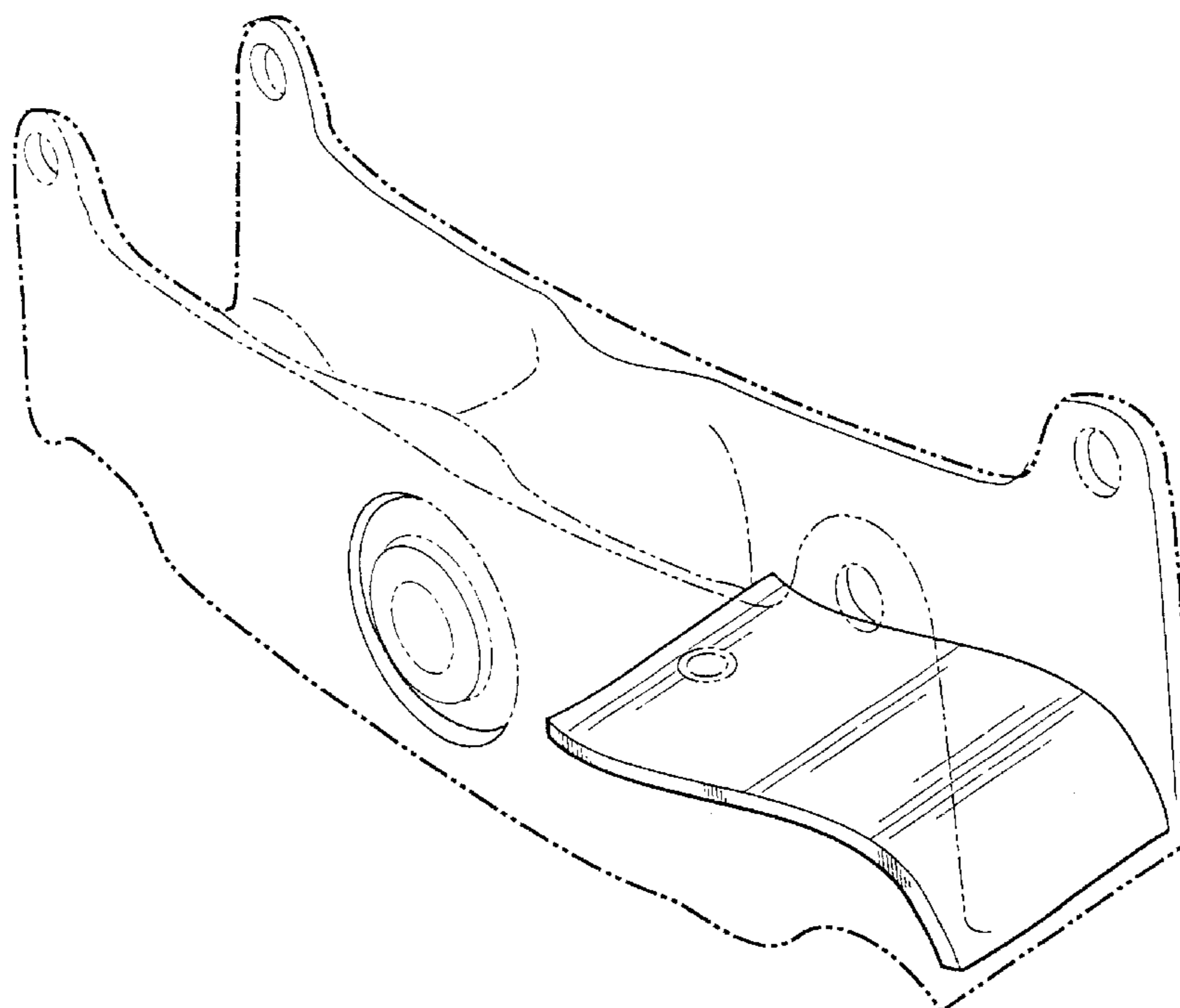
(57) **CLAIM**

The ornamental design for a padding for a trailer suspension equalizer, as shown and described.

FIG. 1 is a perspective view showing my new design for a padding for a trailer suspension equalizer;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof, the opposite side being a mirror image of FIG. 3;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a front elevational view of a second embodiment for the padding, the opposite side being a mirror image of FIG. 7;
 FIG. 8 is a left side elevational view of FIG. 7;
 FIG. 9 is a right side elevational view of FIG. 7;
 FIG. 10 is a top plan view of FIG. 7;
 FIG. 11 is a bottom plan view of FIG. 7;
 FIG. 12 is a front elevational view of a third embodiment for the padding, the opposite side being a mirror image of FIG. 12;
 FIG. 13 is a left side elevational view of a third embodiment for the padding, the opposite side being a mirror image of FIG. 13;
 FIG. 14 is a right side view of a third embodiment for the padding, the opposite side being a mirror image of FIG. 14;
 FIG. 15 is a top plan view of FIG. 12; and,
 FIG. 16 is a bottom plan view of FIG. 12 .

The broken lines showing the trailer suspension equalizer and connection thereto in FIGS. 1–16 are illustrative of environmental structure only and form no part of the claimed design.

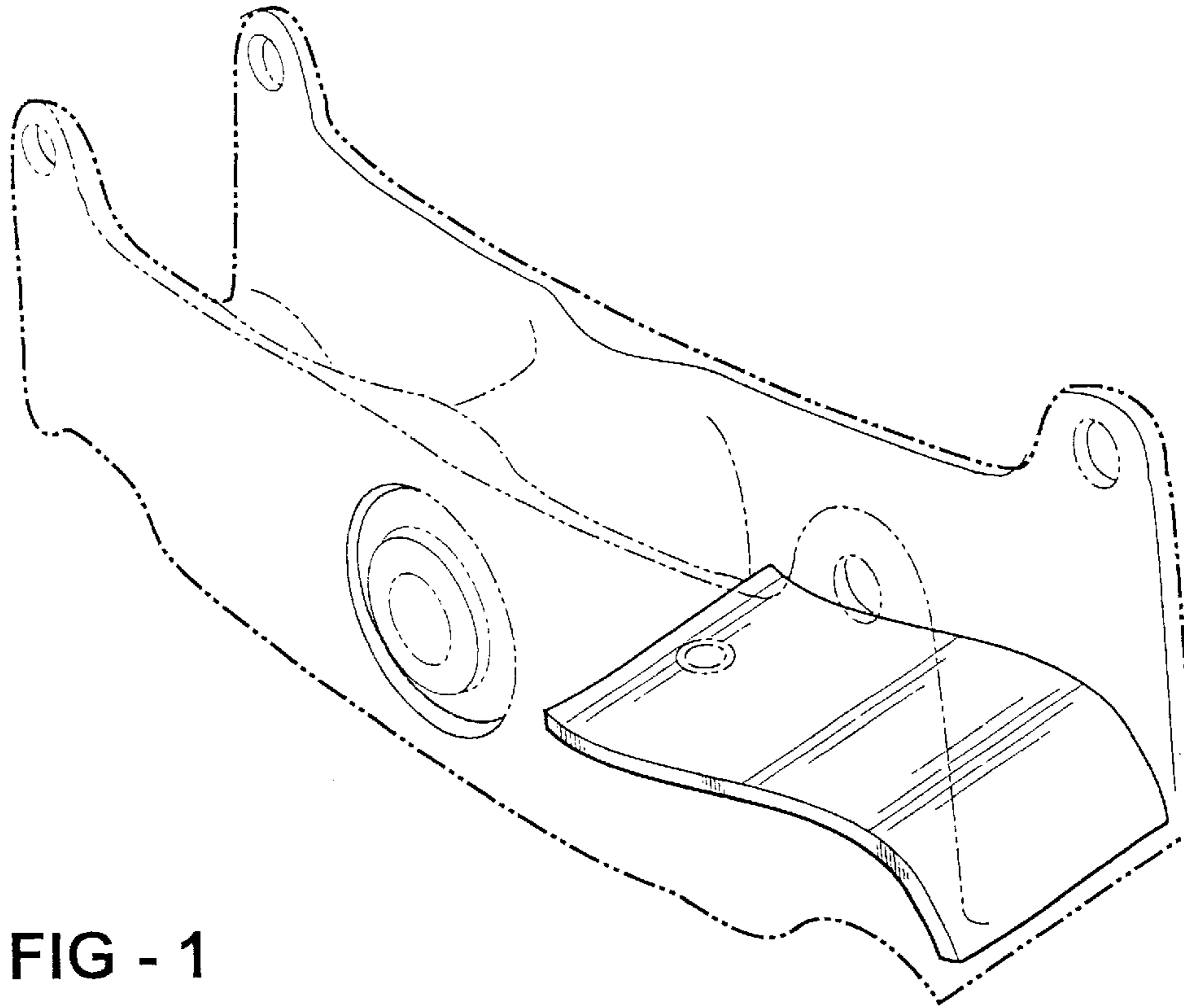

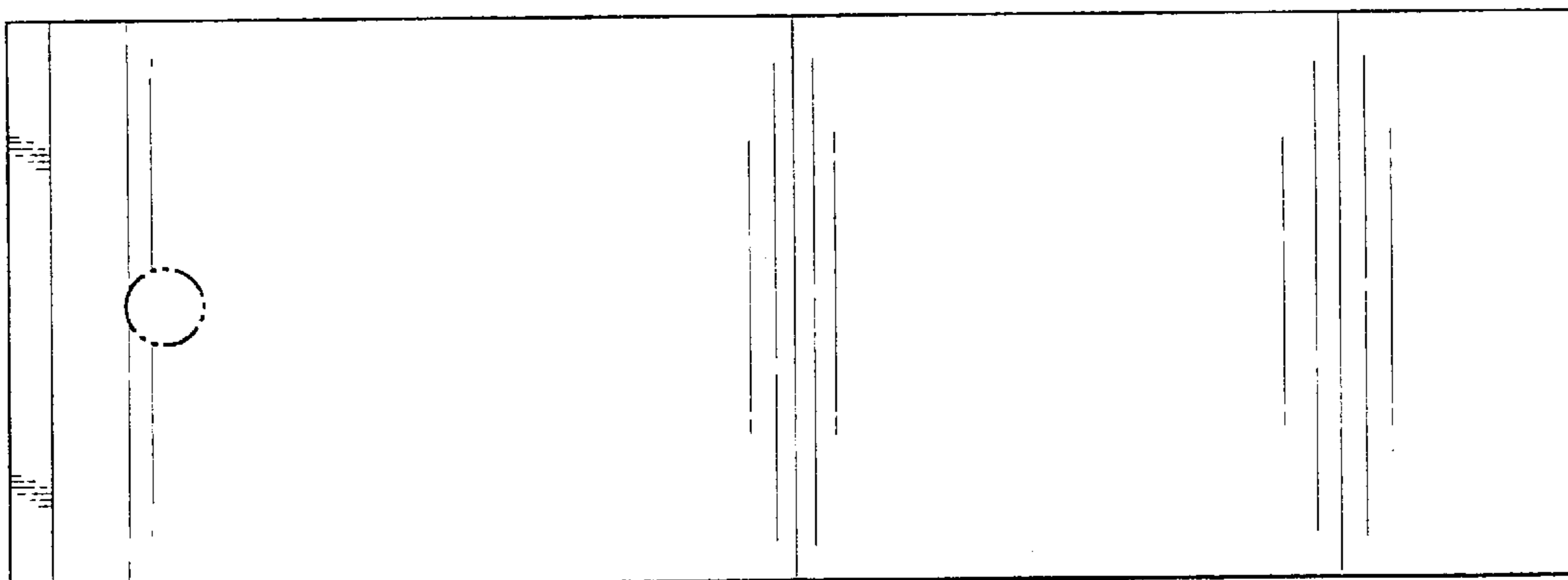

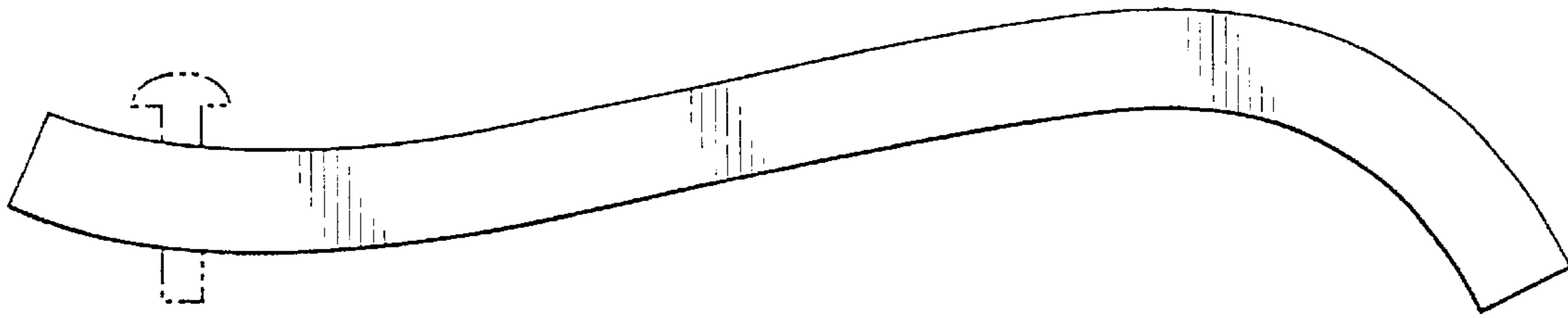

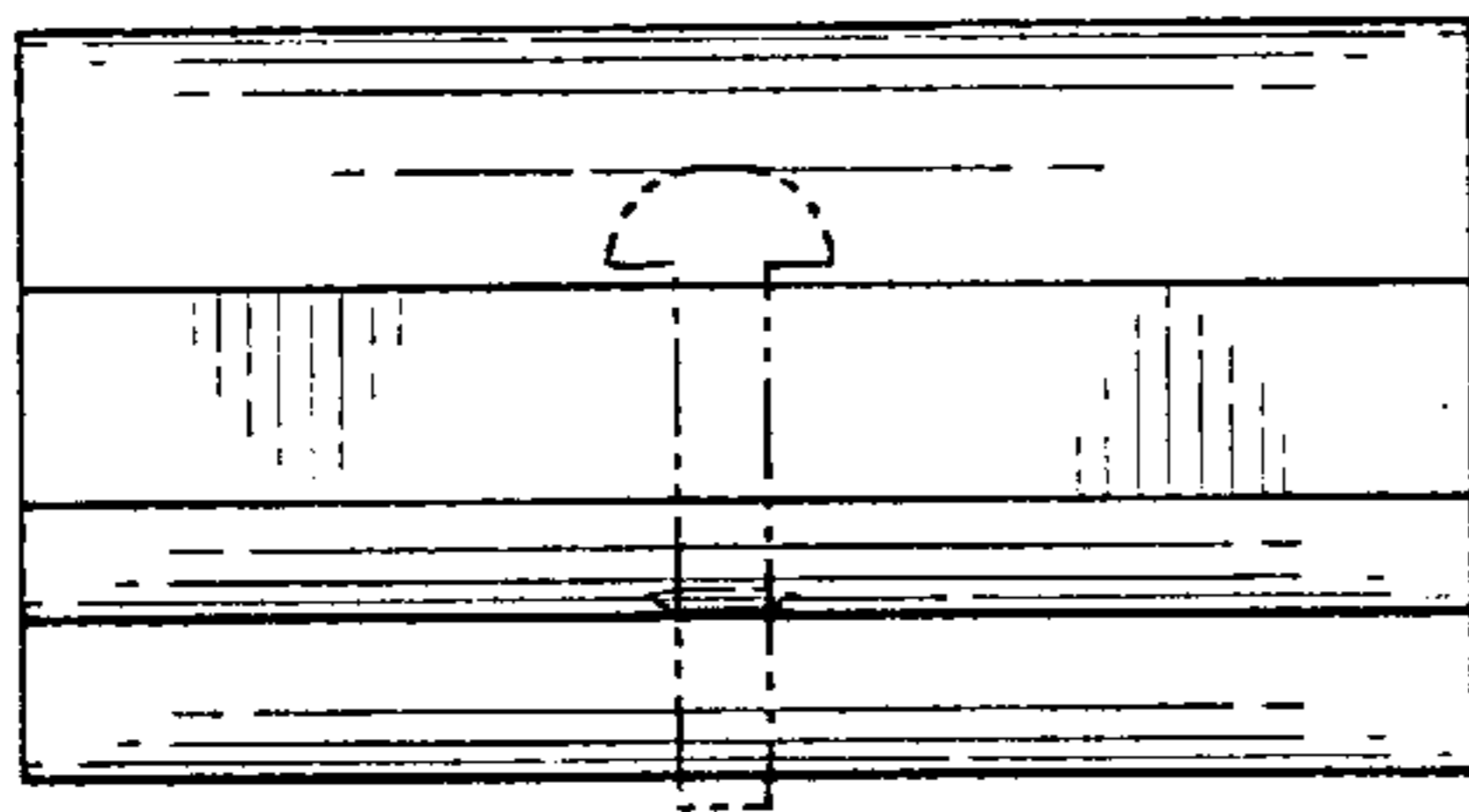

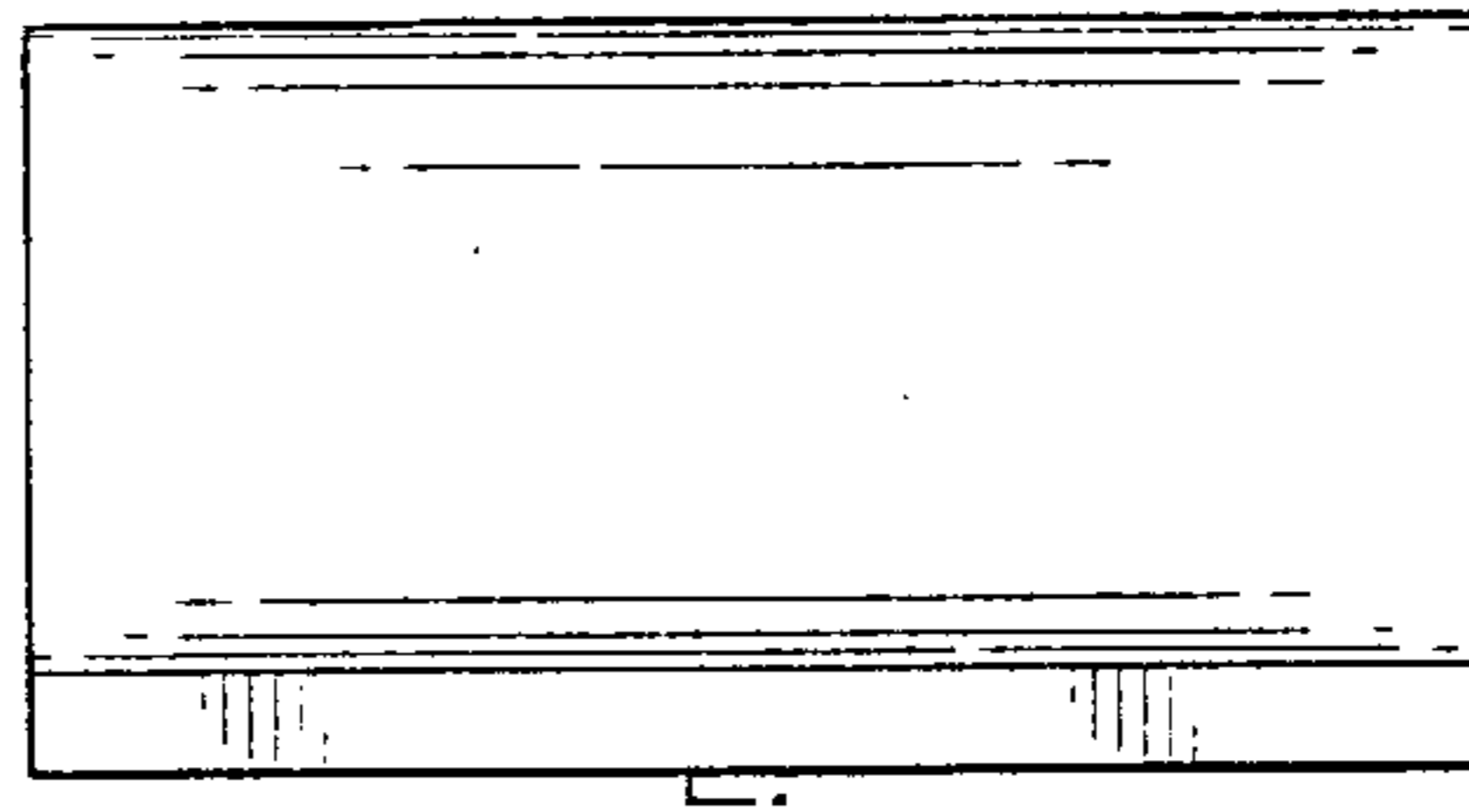

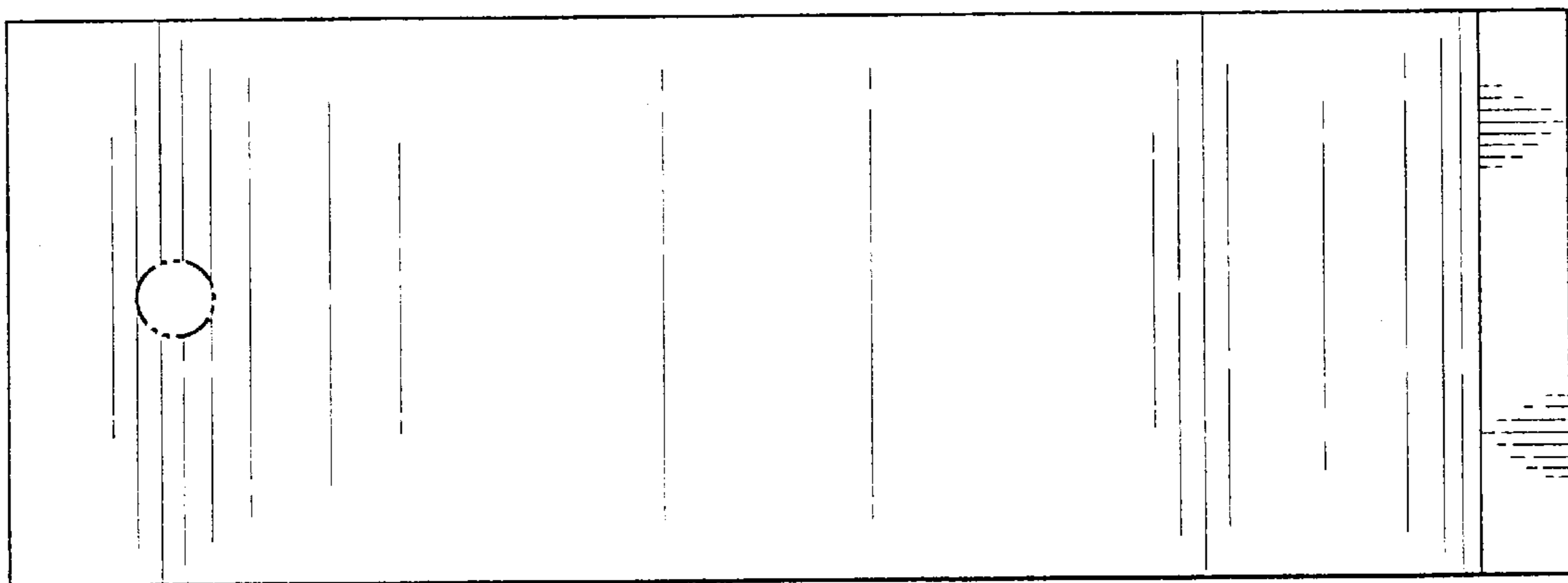

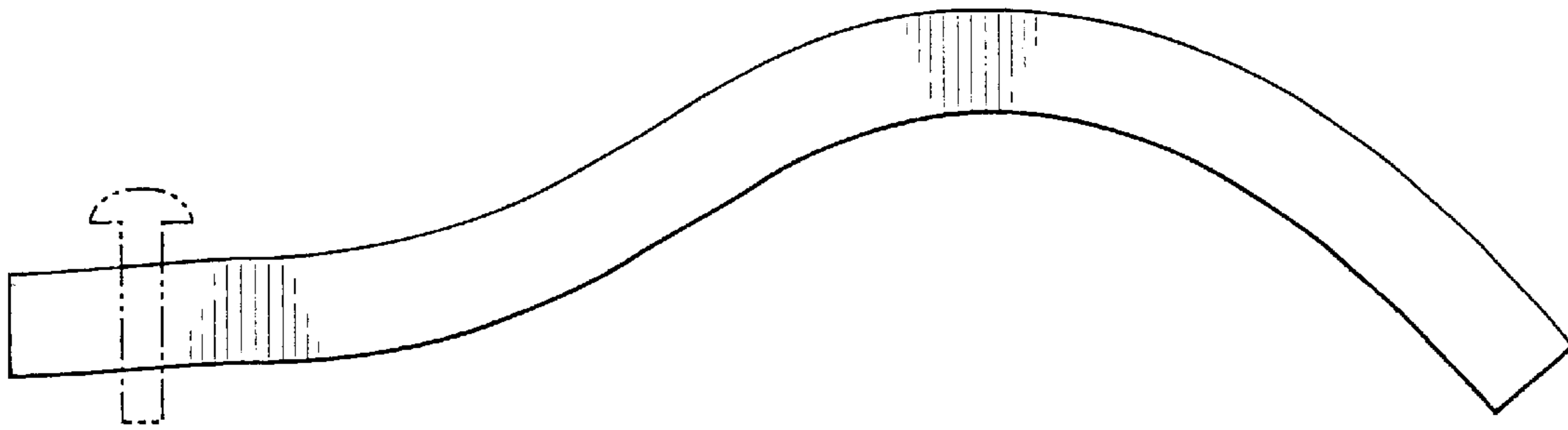

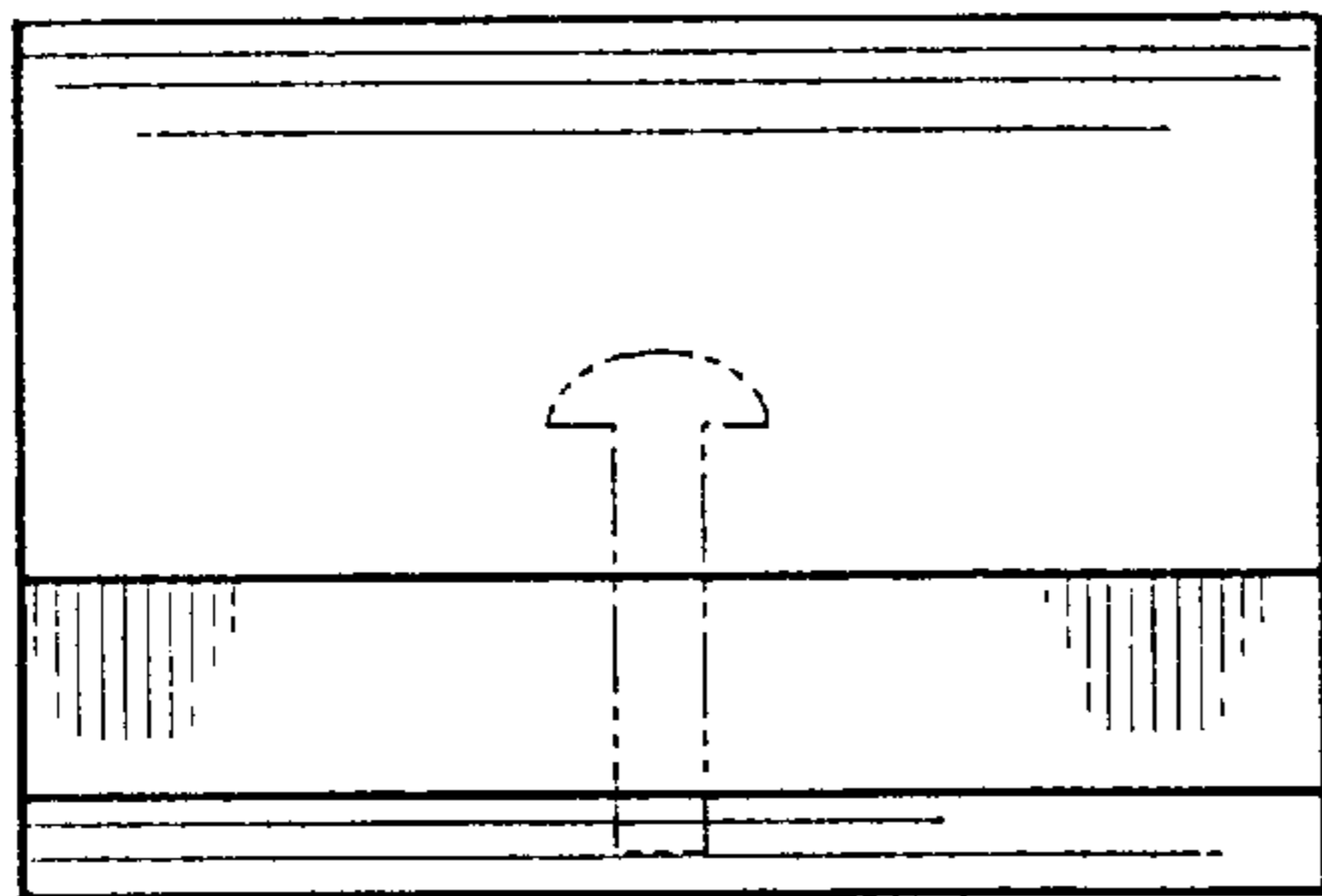

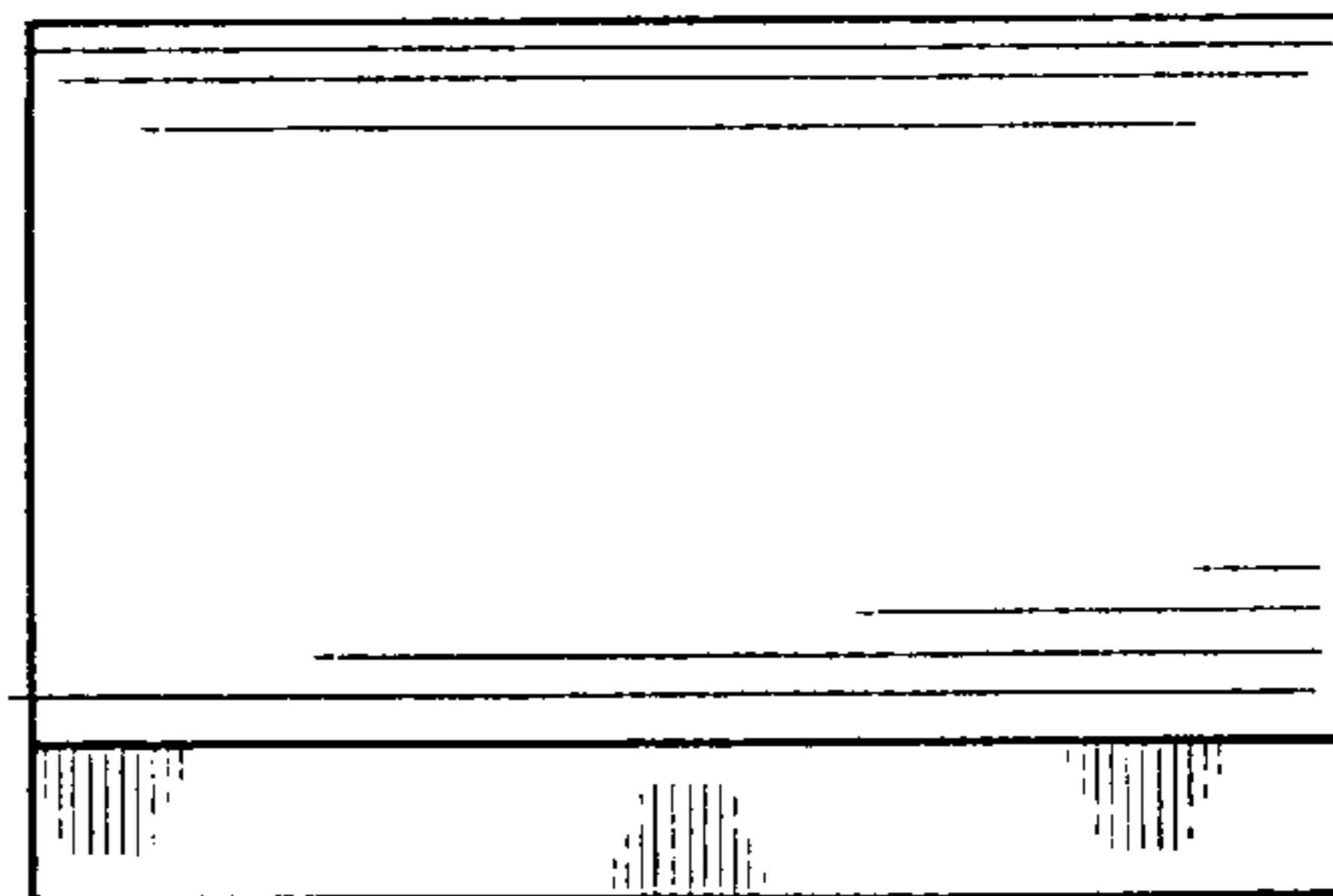

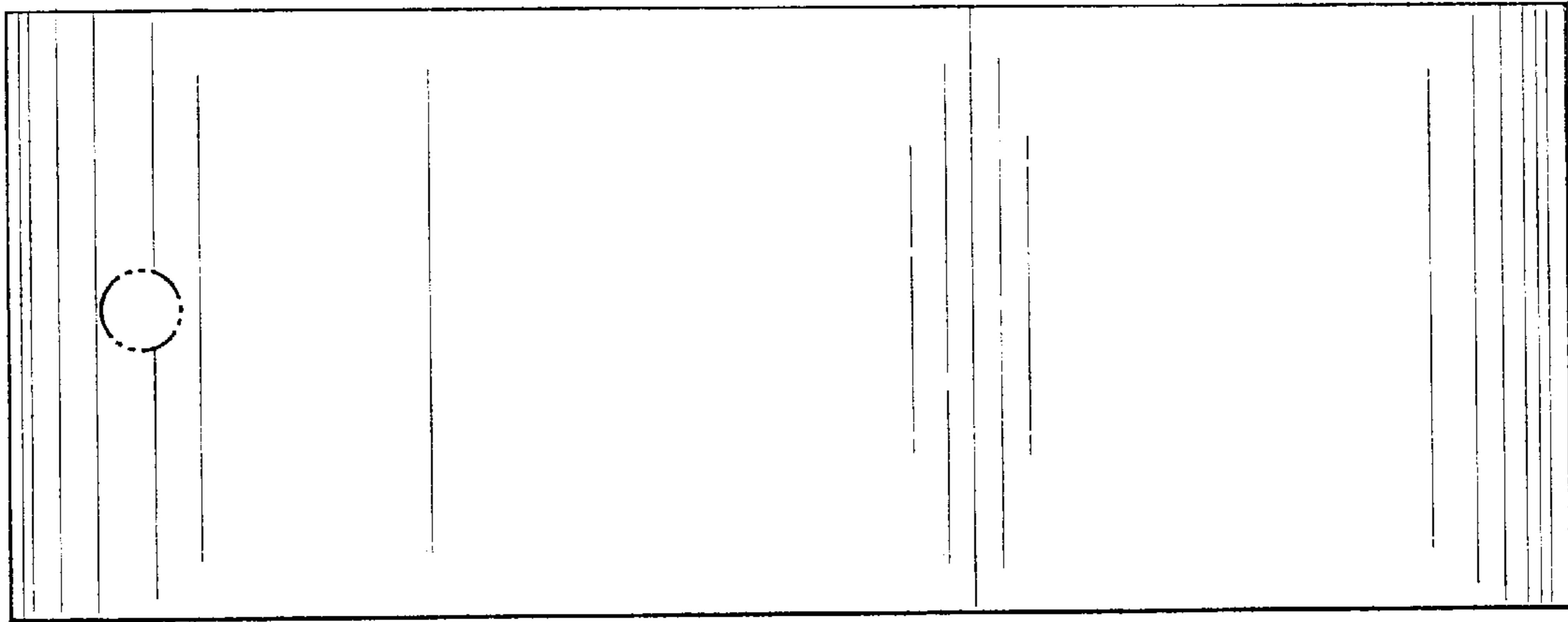

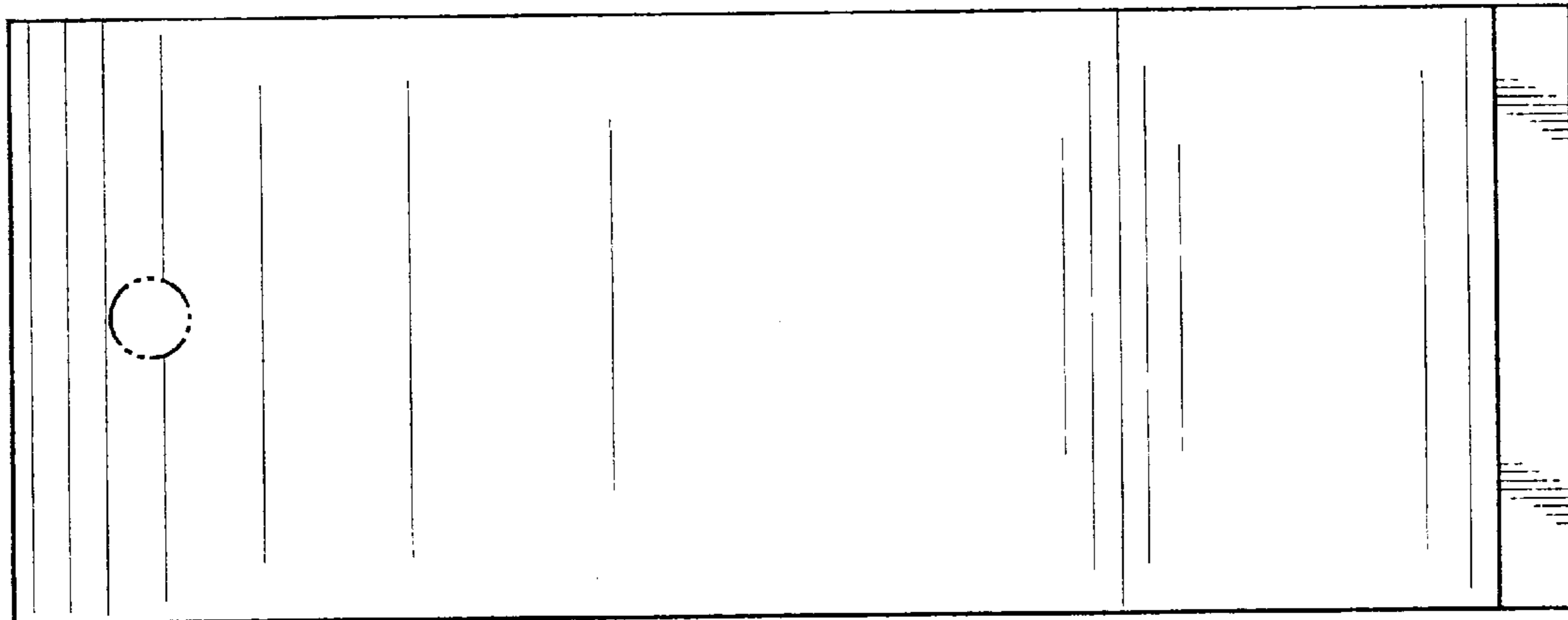

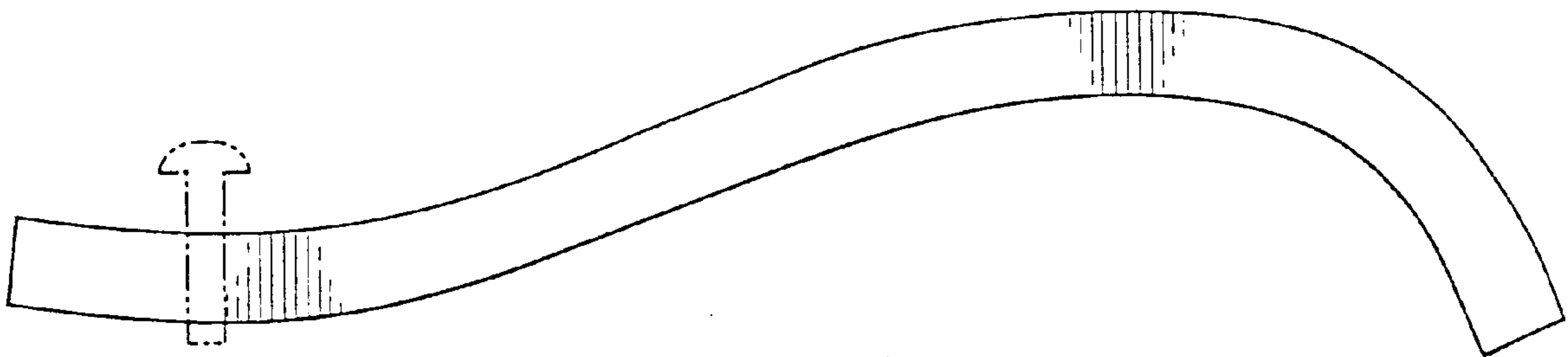

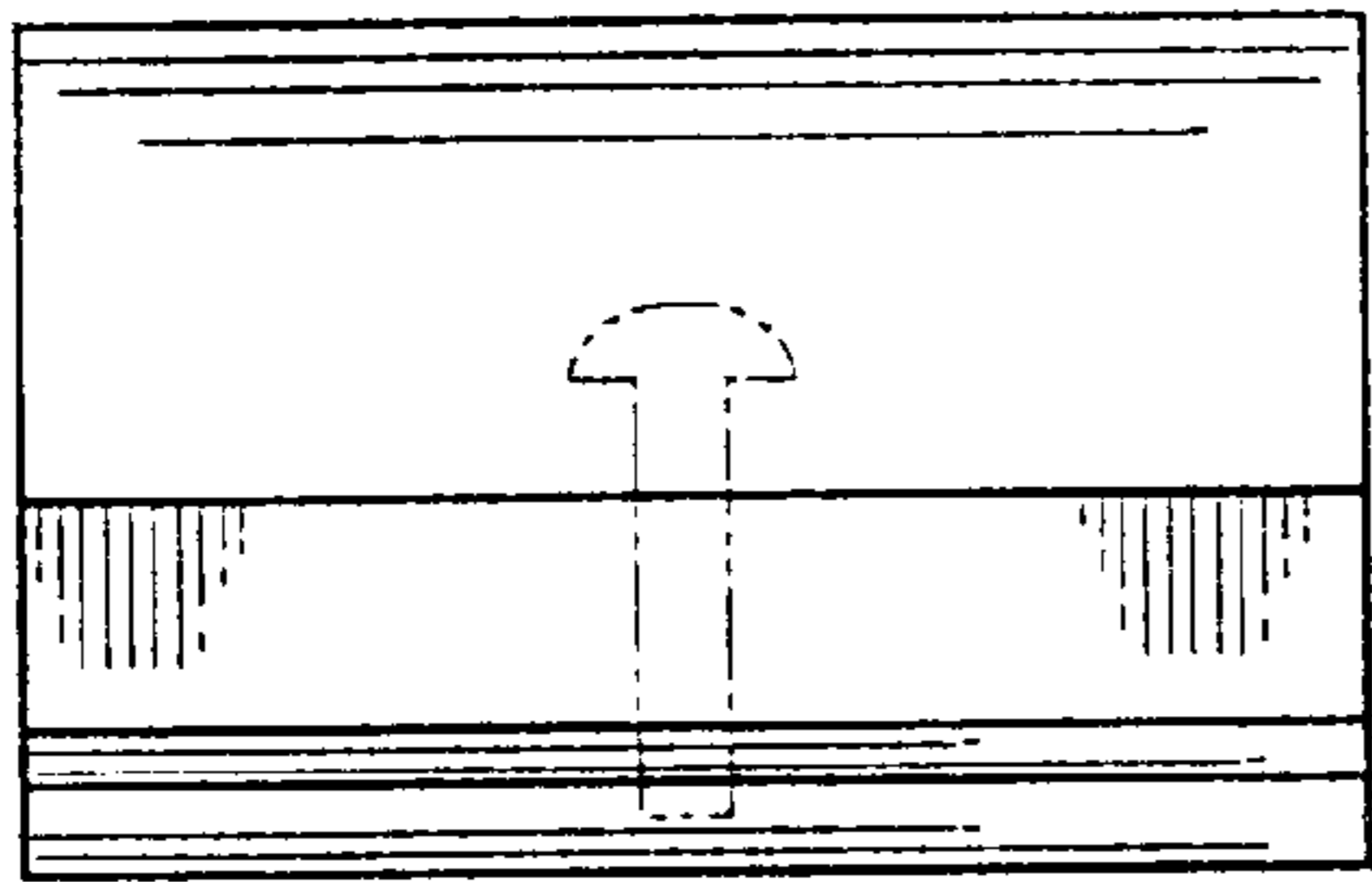

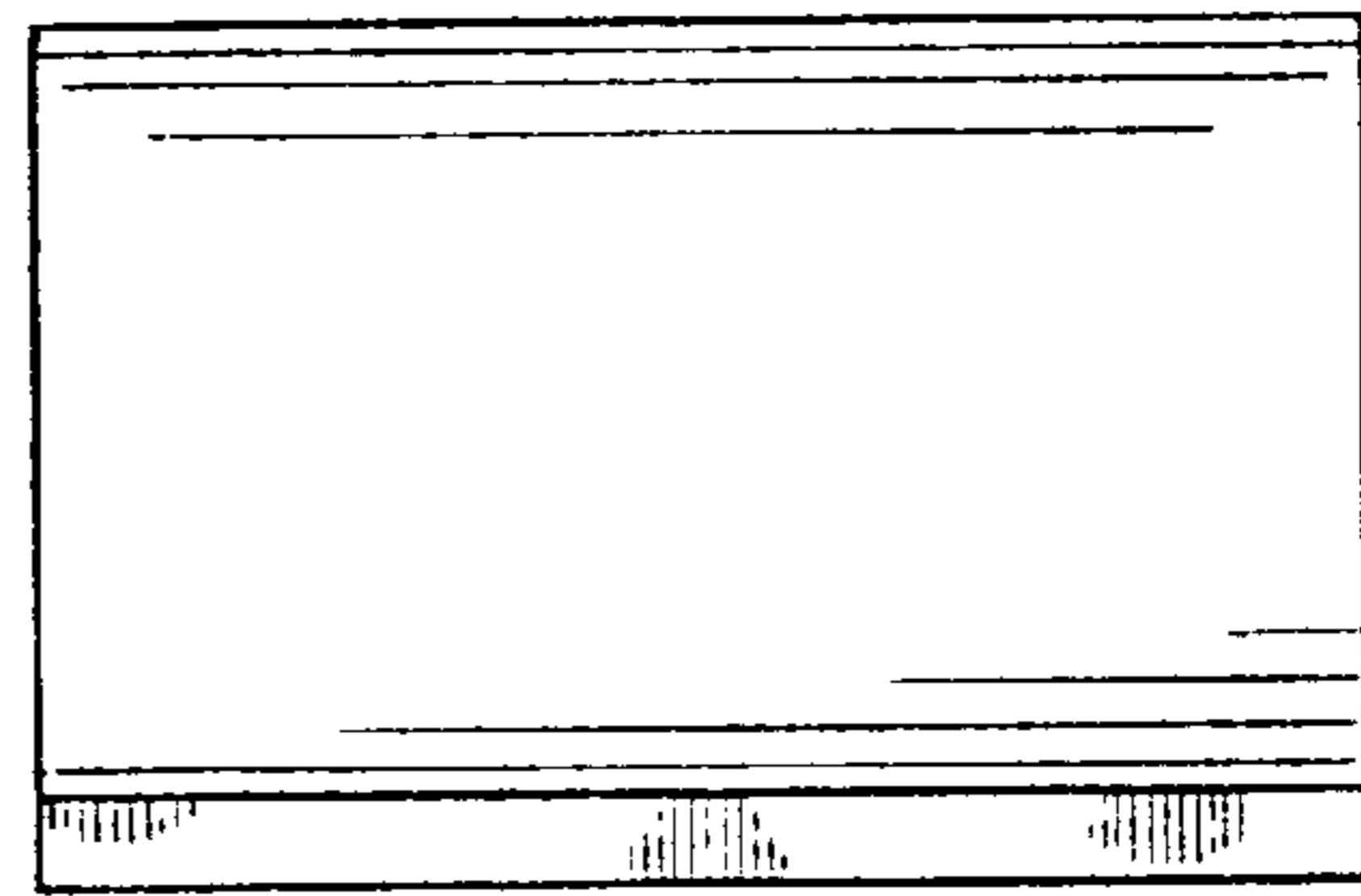

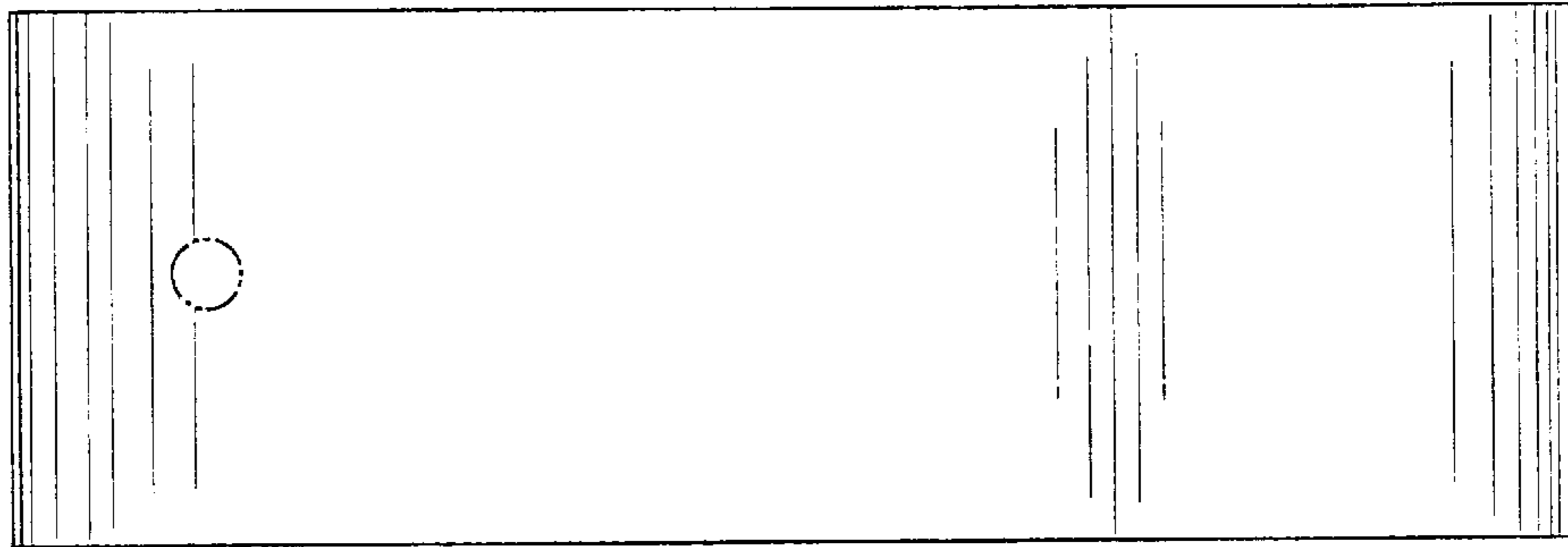
