FIG. 1 is a rear, right perspective view of my new design; FIG. 2 is a front view thereof;

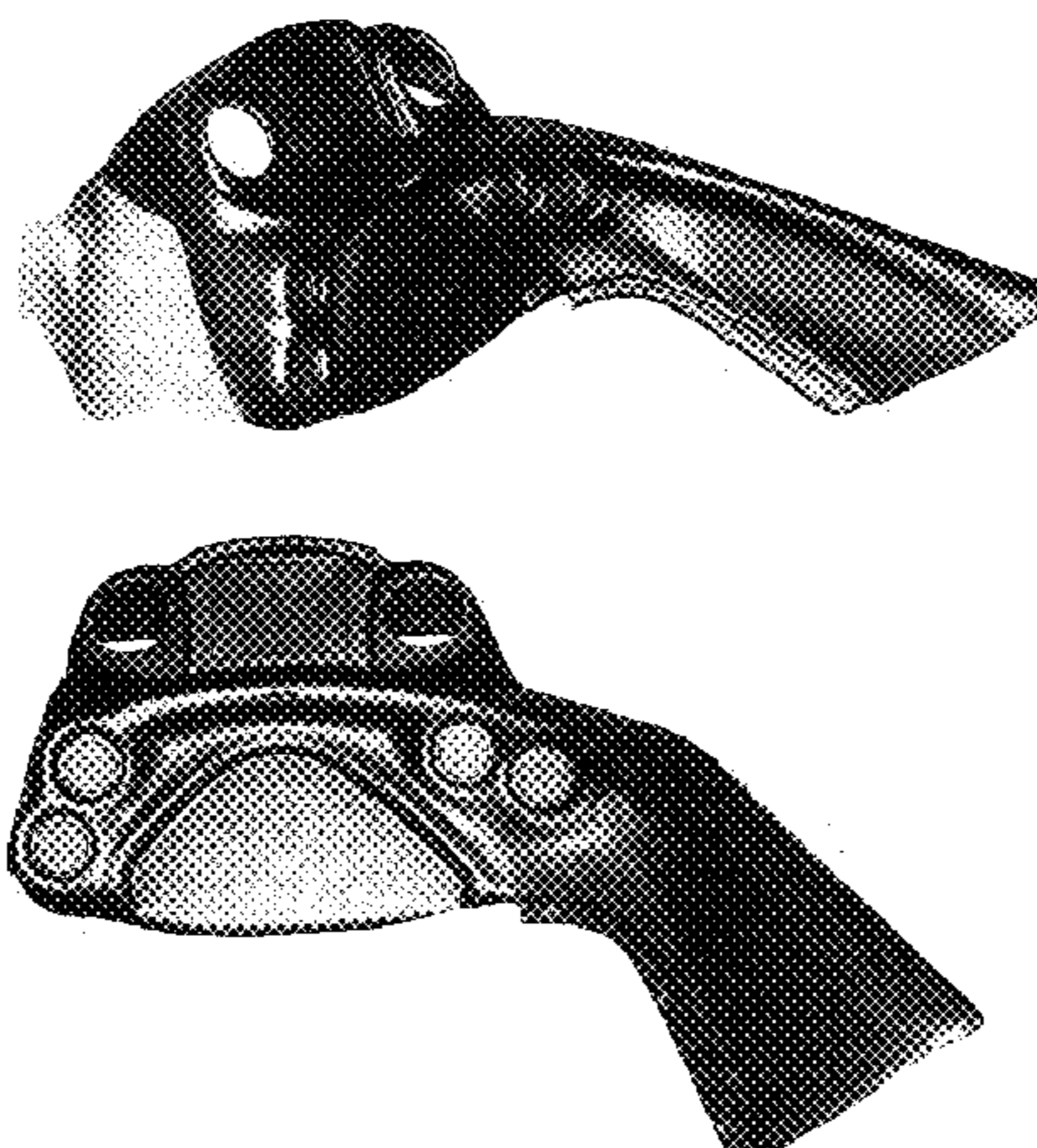
FIG. 3 is a rear view thereof;

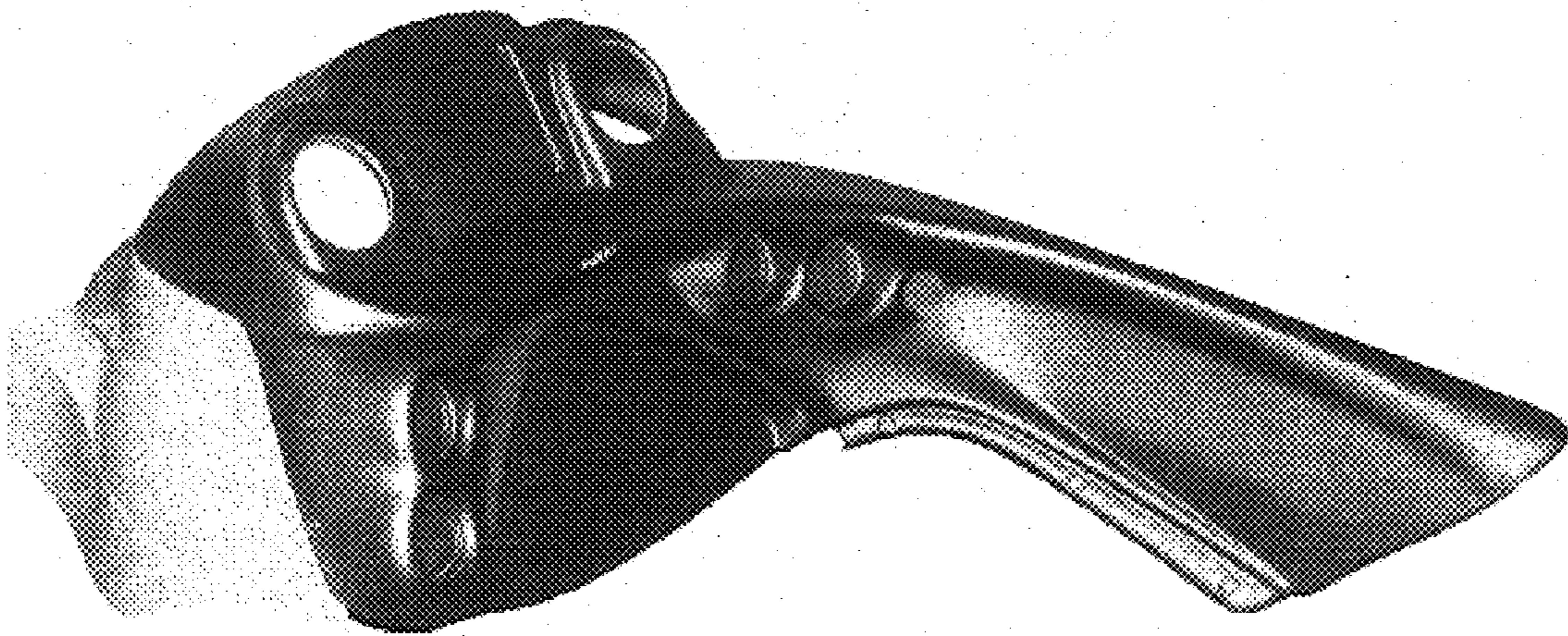

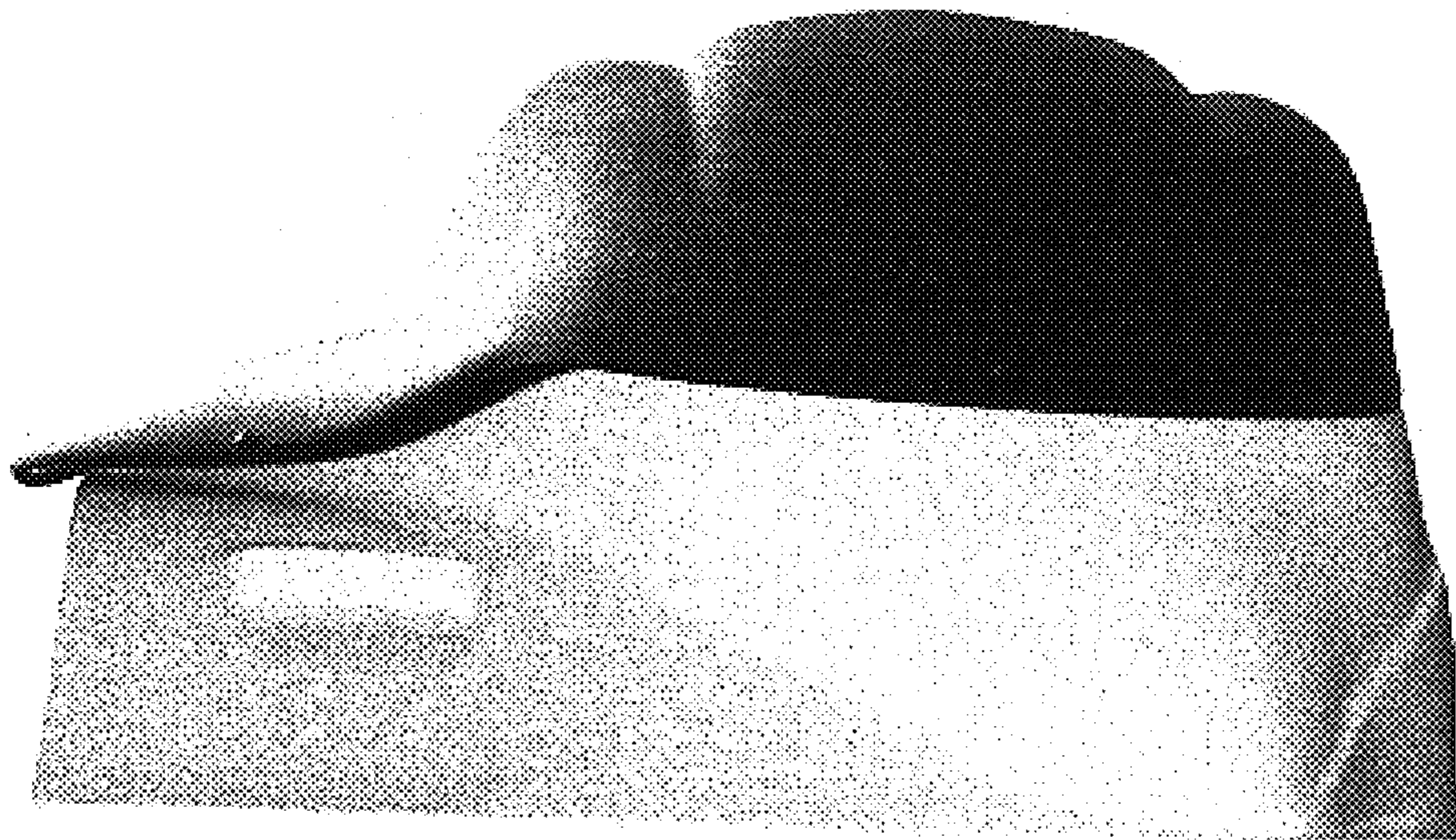

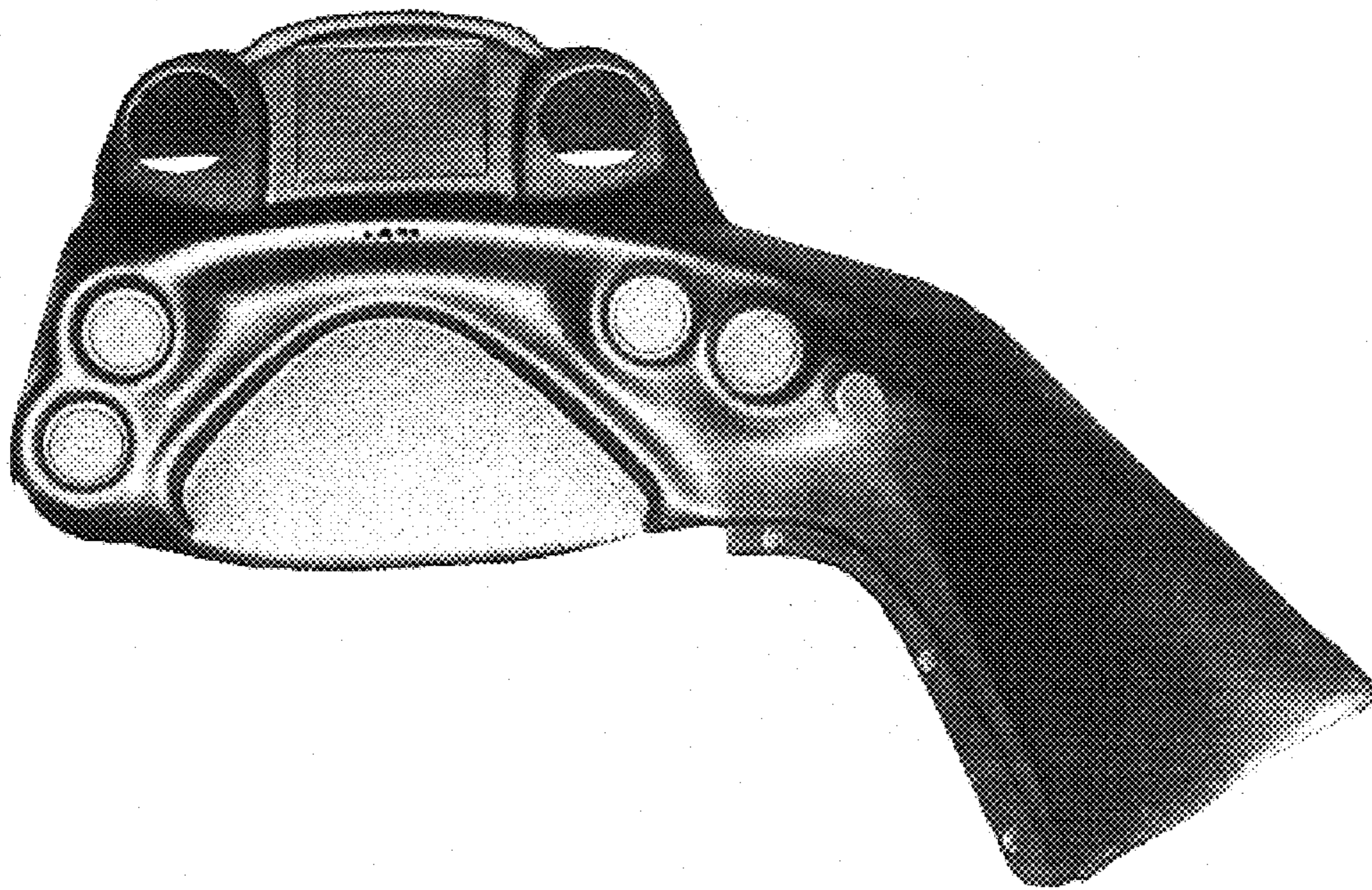

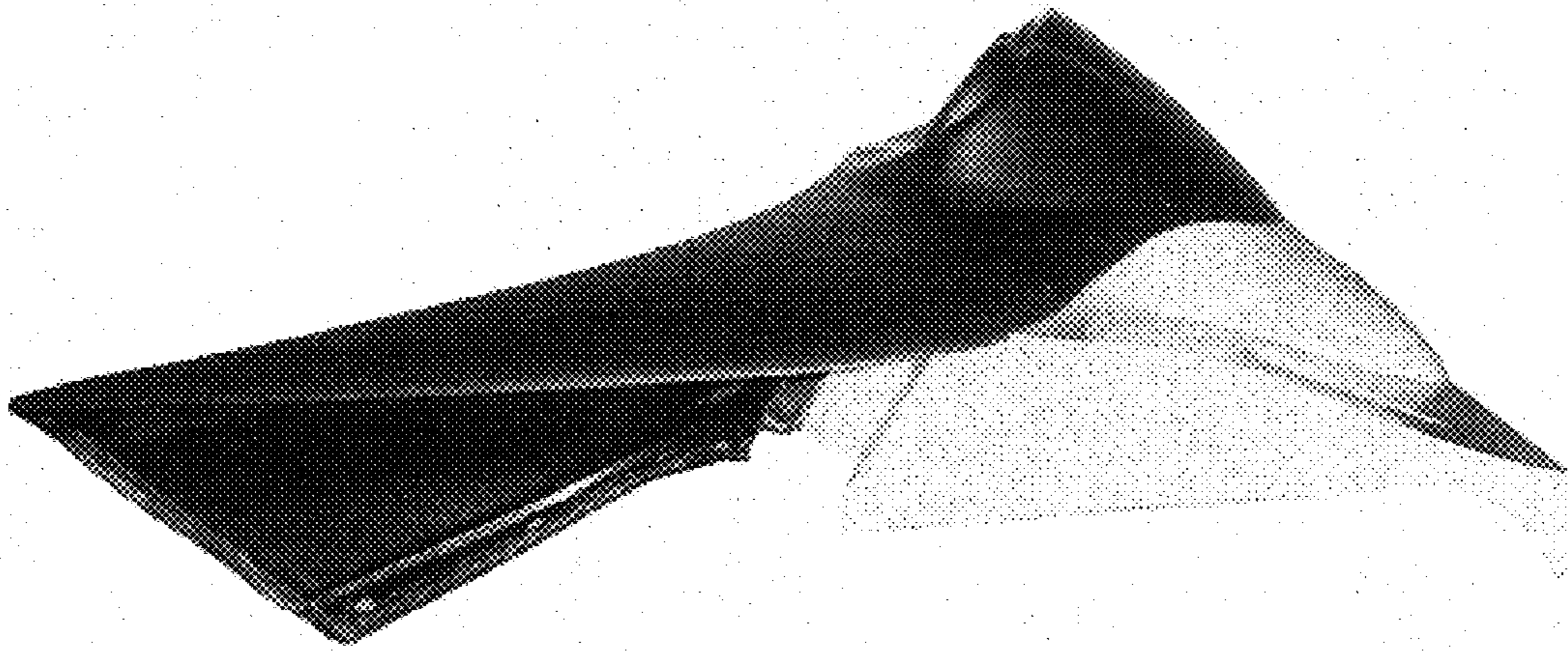

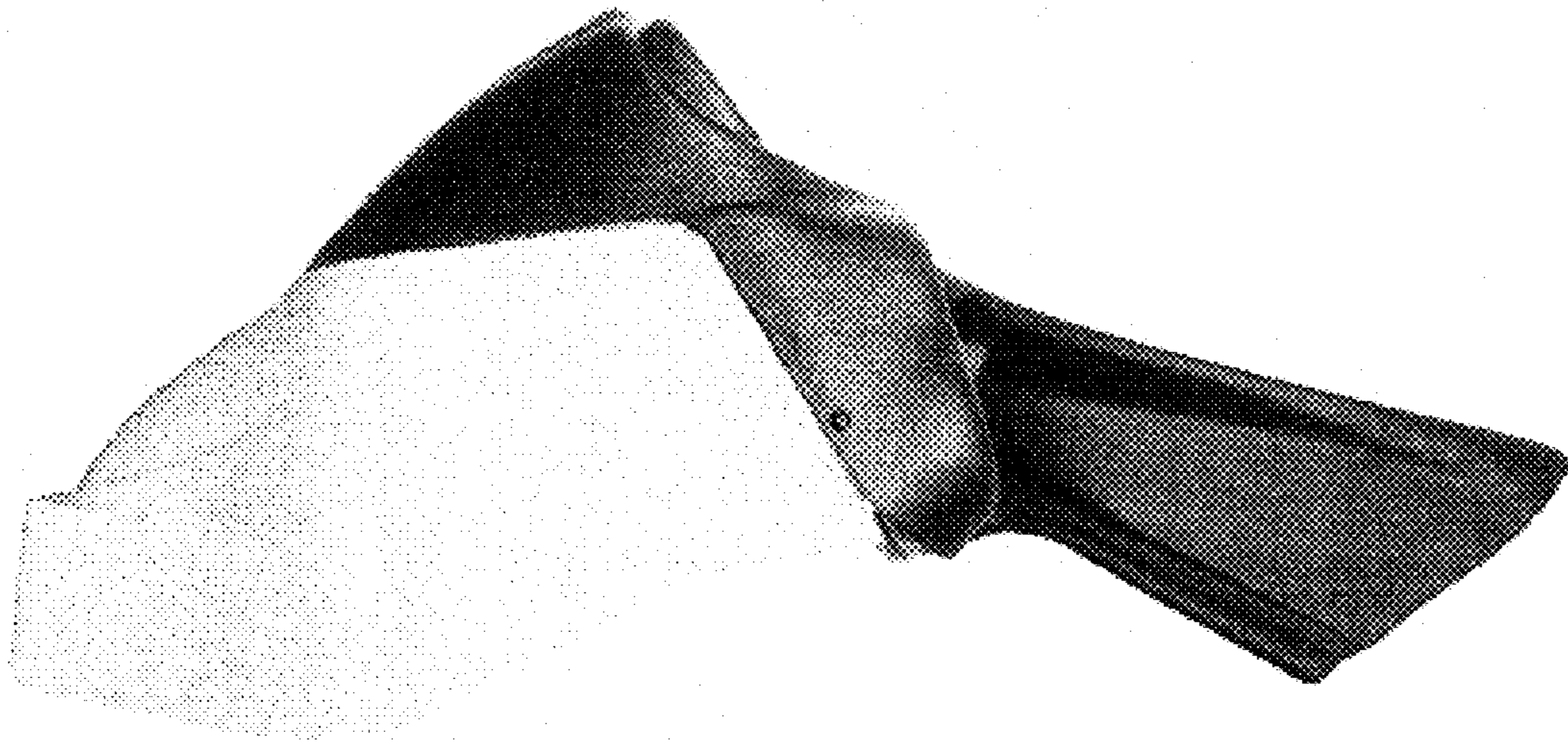
