(57) **CLAIM**

The ornamental design for a charger unit for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a charger unit for a toothbrush from above, showing my new design; FIG. 2 is a front view of the appliance thereof; FIG. 3 is a rear view of the appliance thereof; FIG. 4 is a top plan view of the appliance thereof; FIG. 5 is a side view of the appliance thereof; and, FIG. 6 is a bottom plan view of the appliance thereof. The broken line showing is for illustrative purposes only and forms no part of the claimed design.

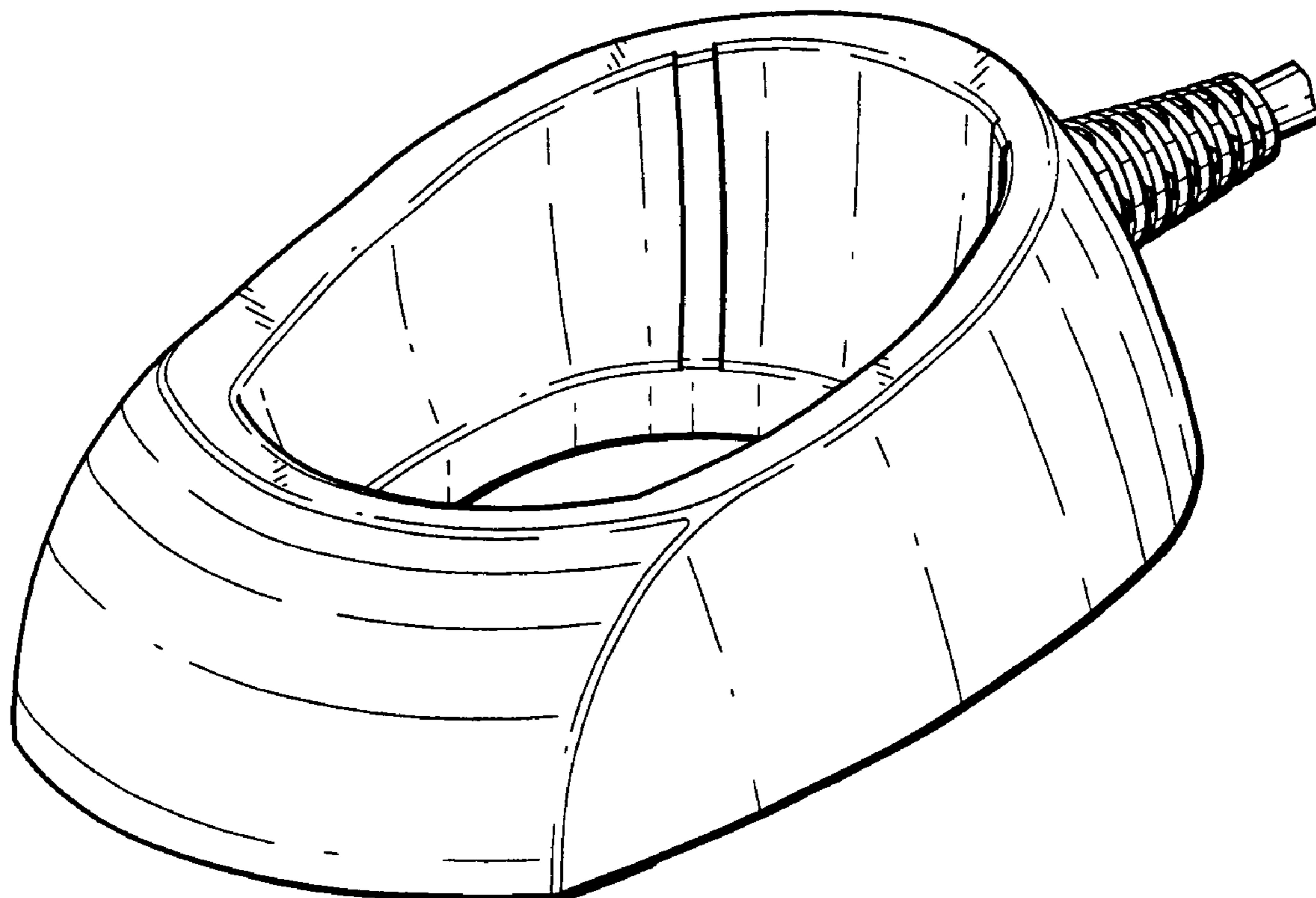

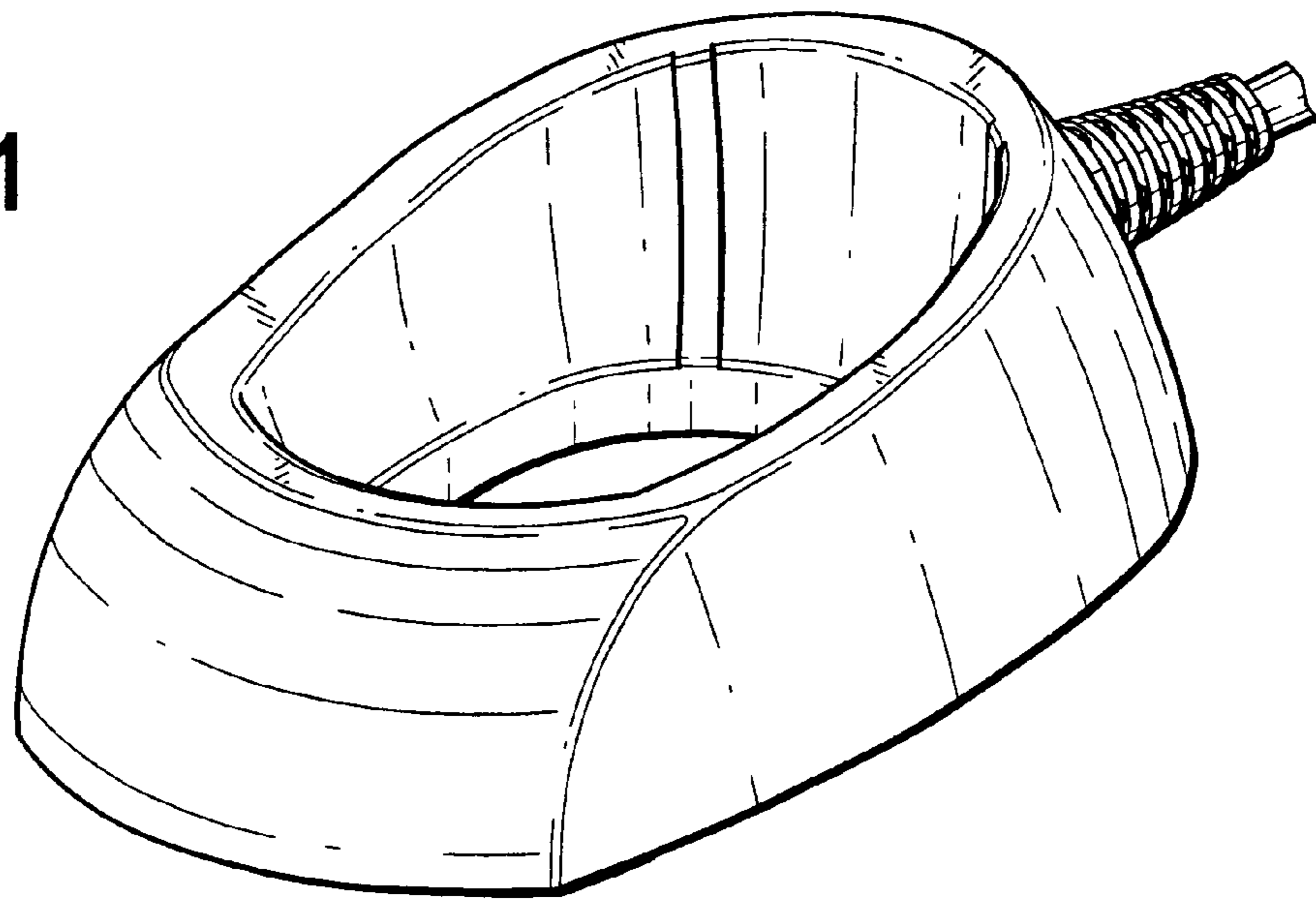

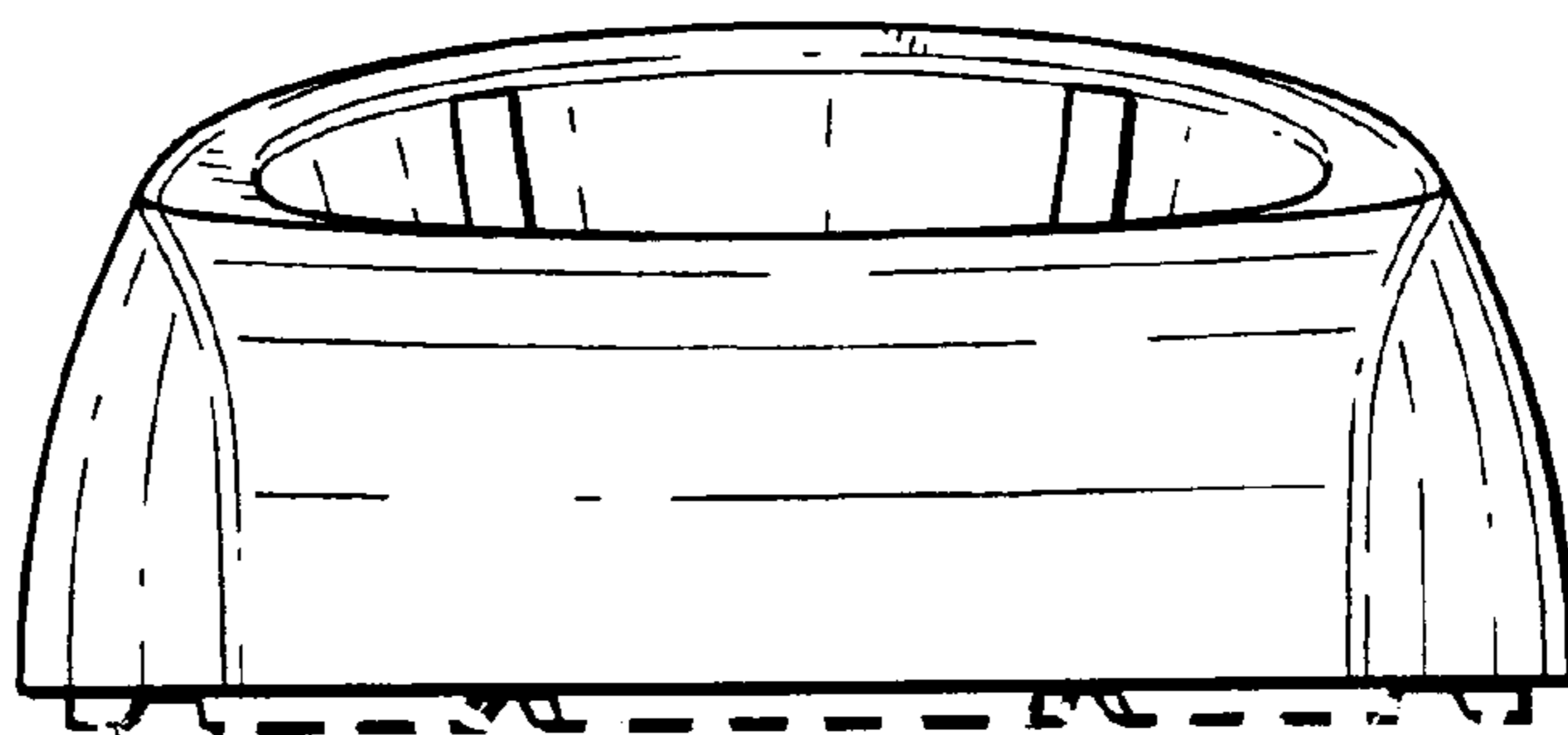

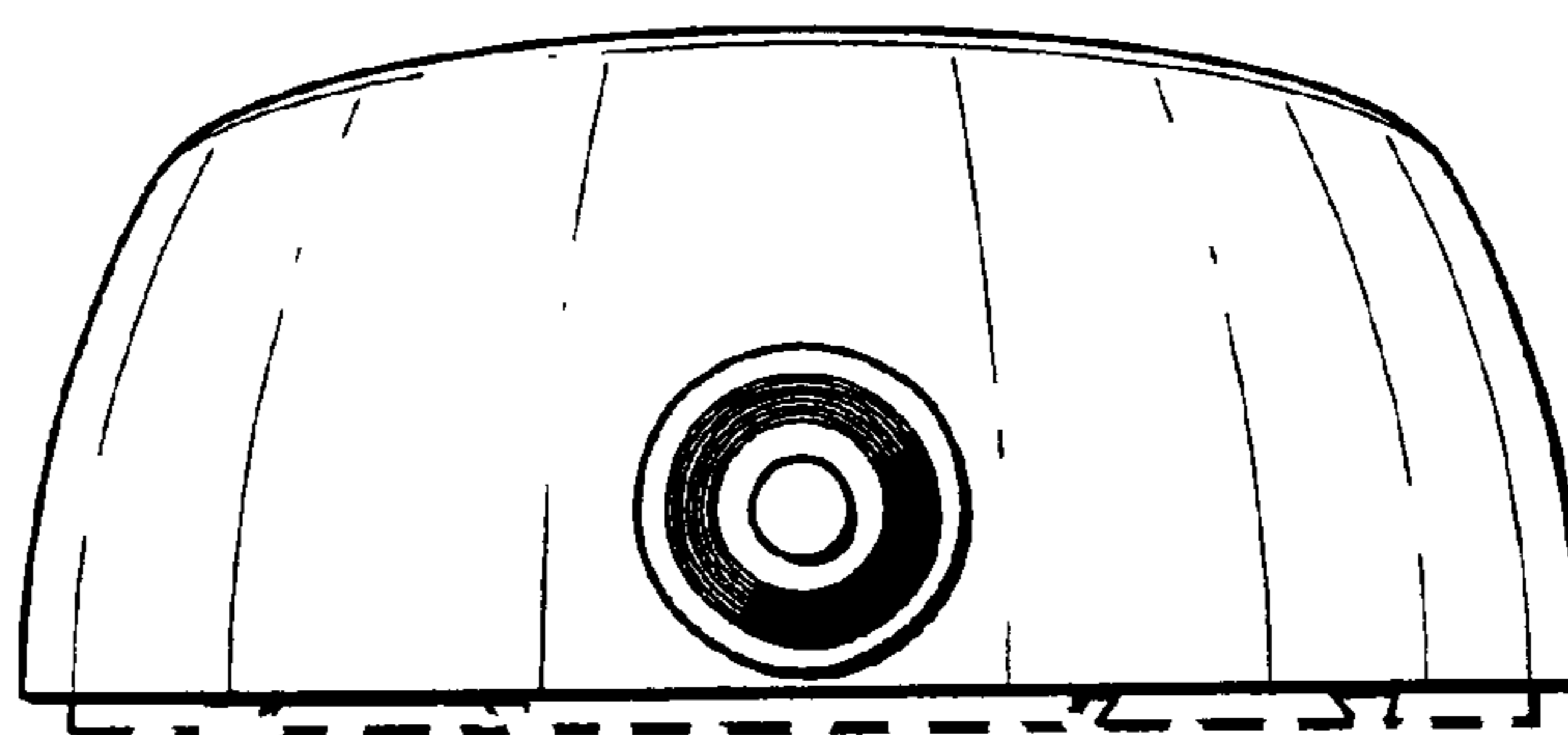

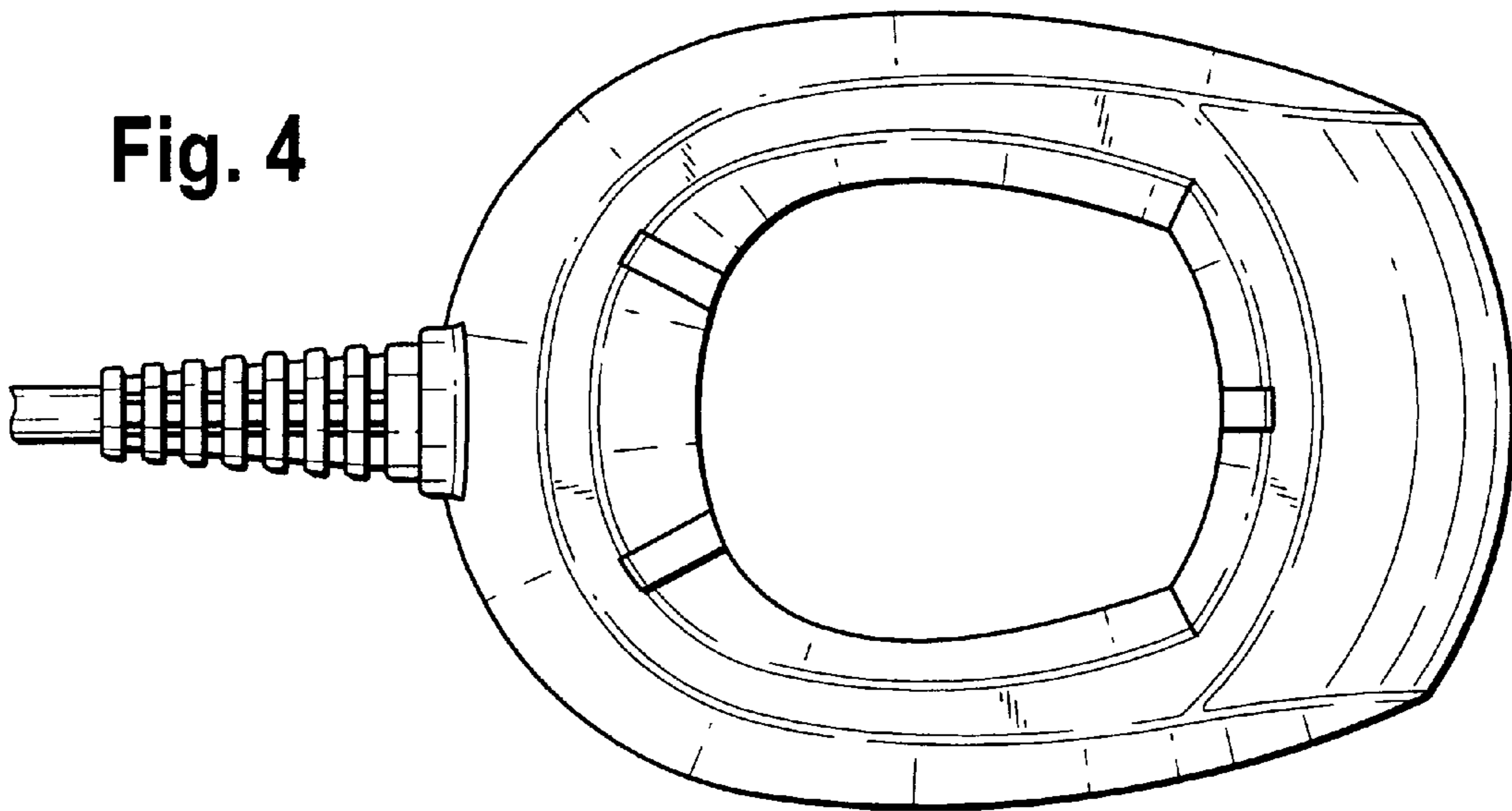

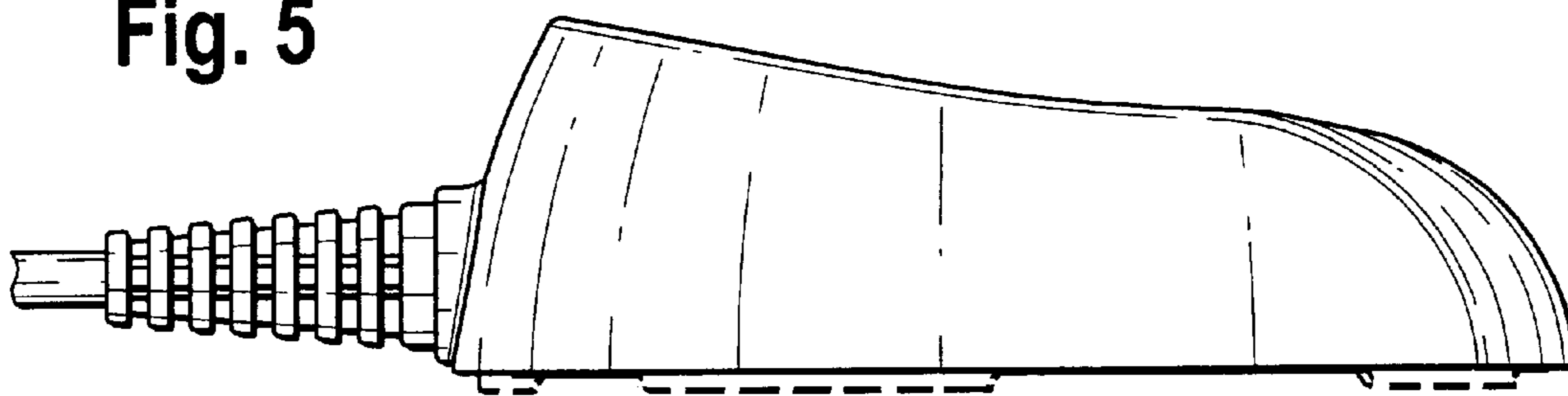
