(57) **CLAIM**

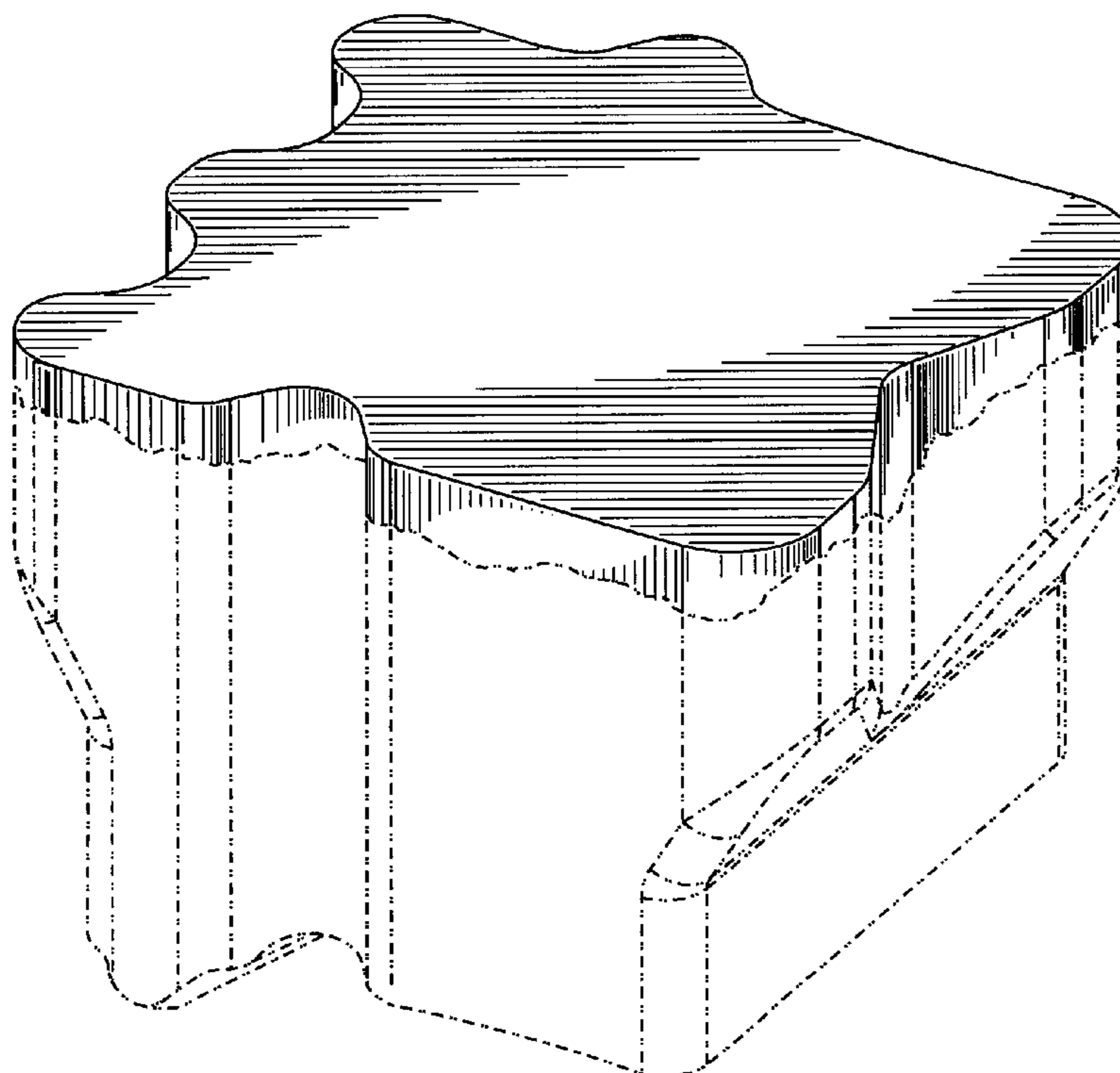
The ornamental design for an ink stick for phase change ink jet printer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an ink stick for phase change ink jet printer illustrating the new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

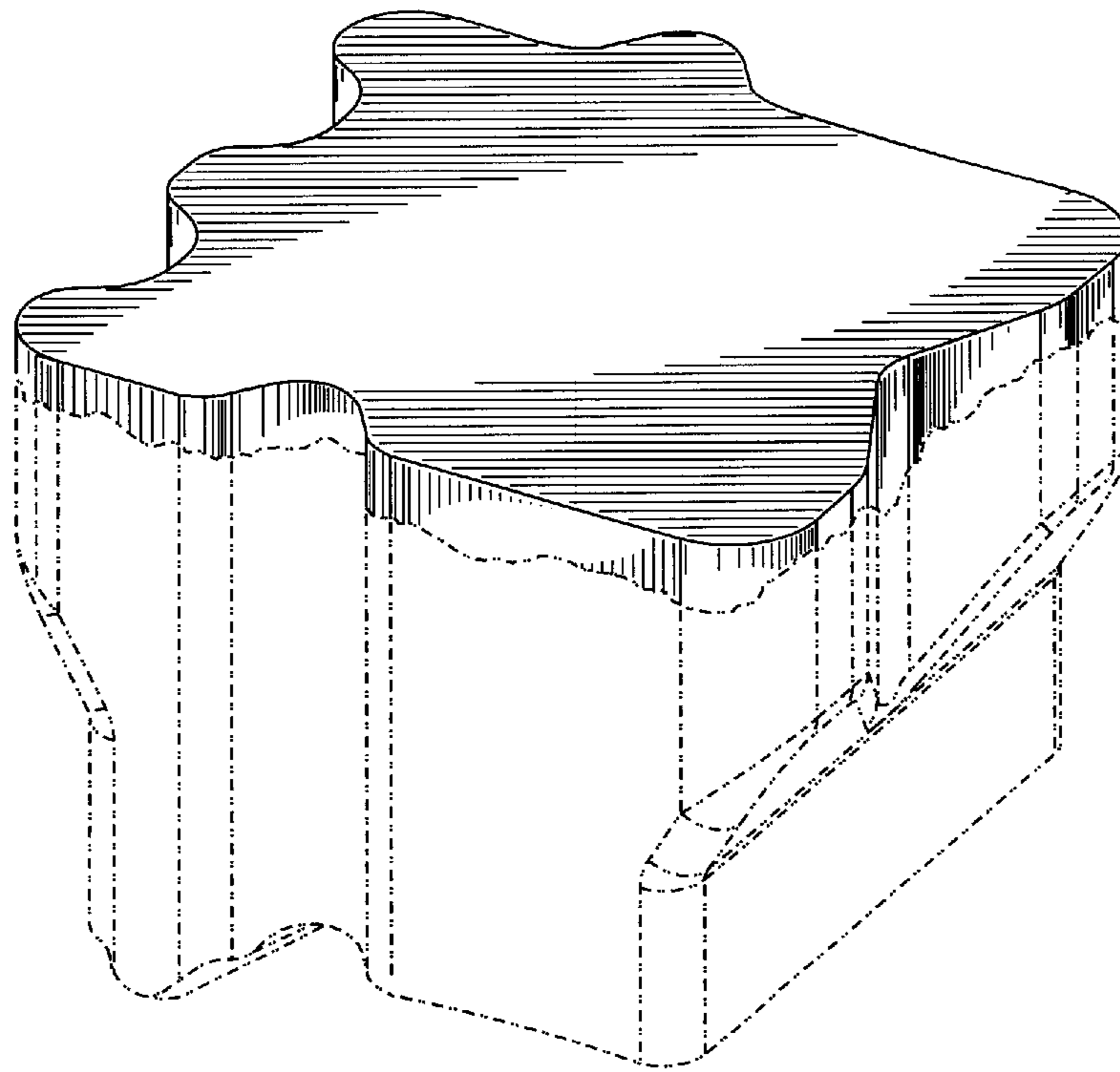

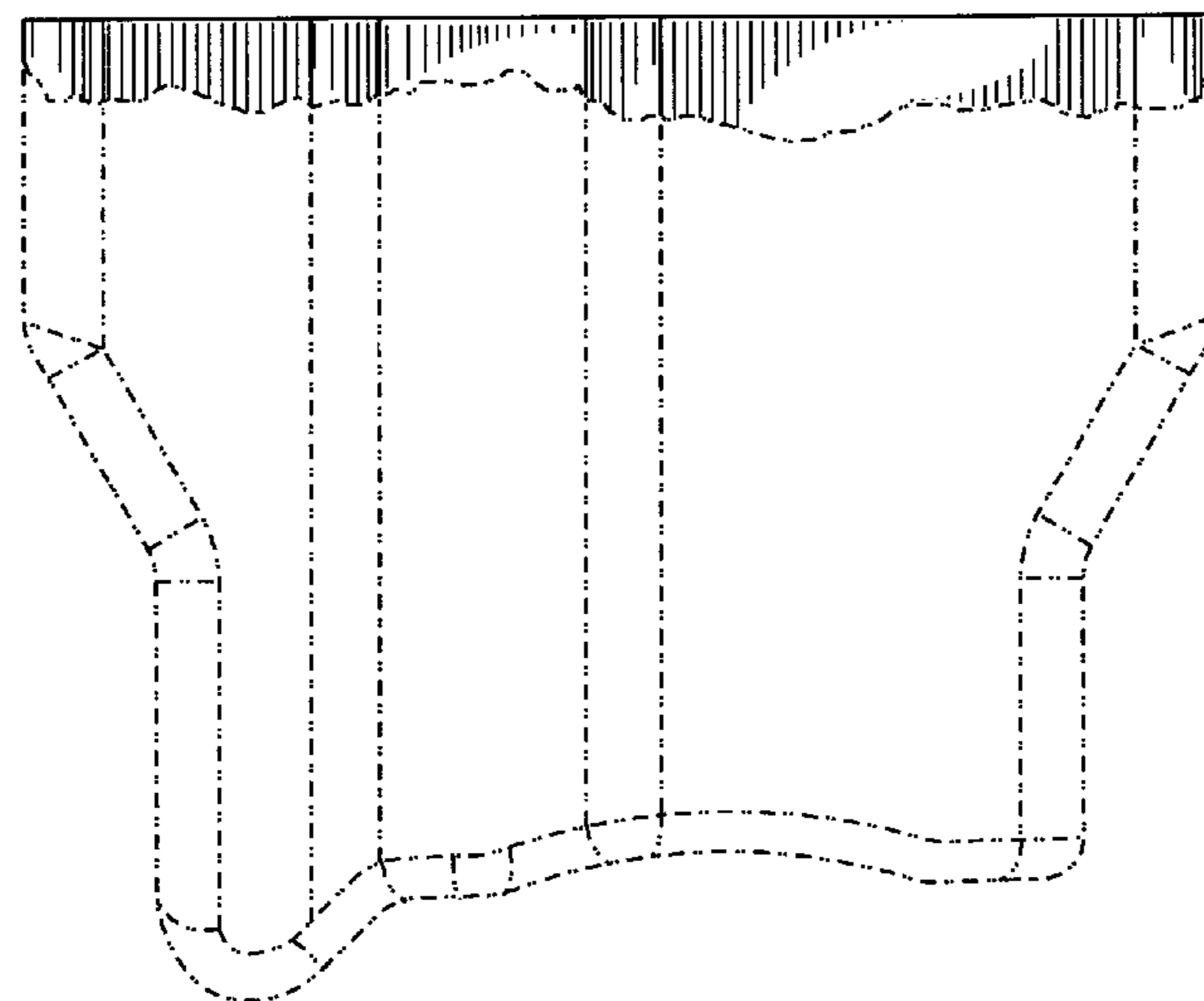

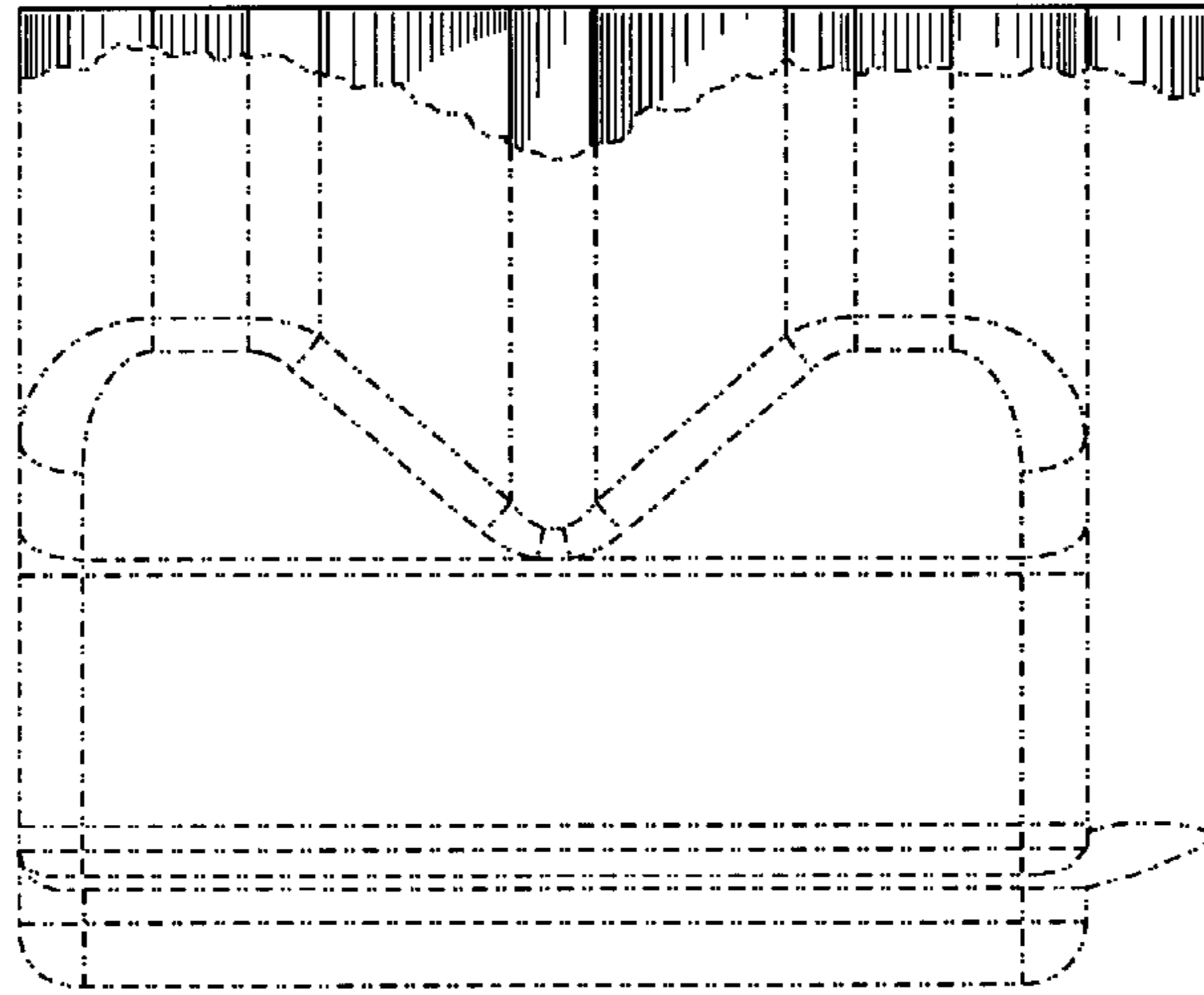

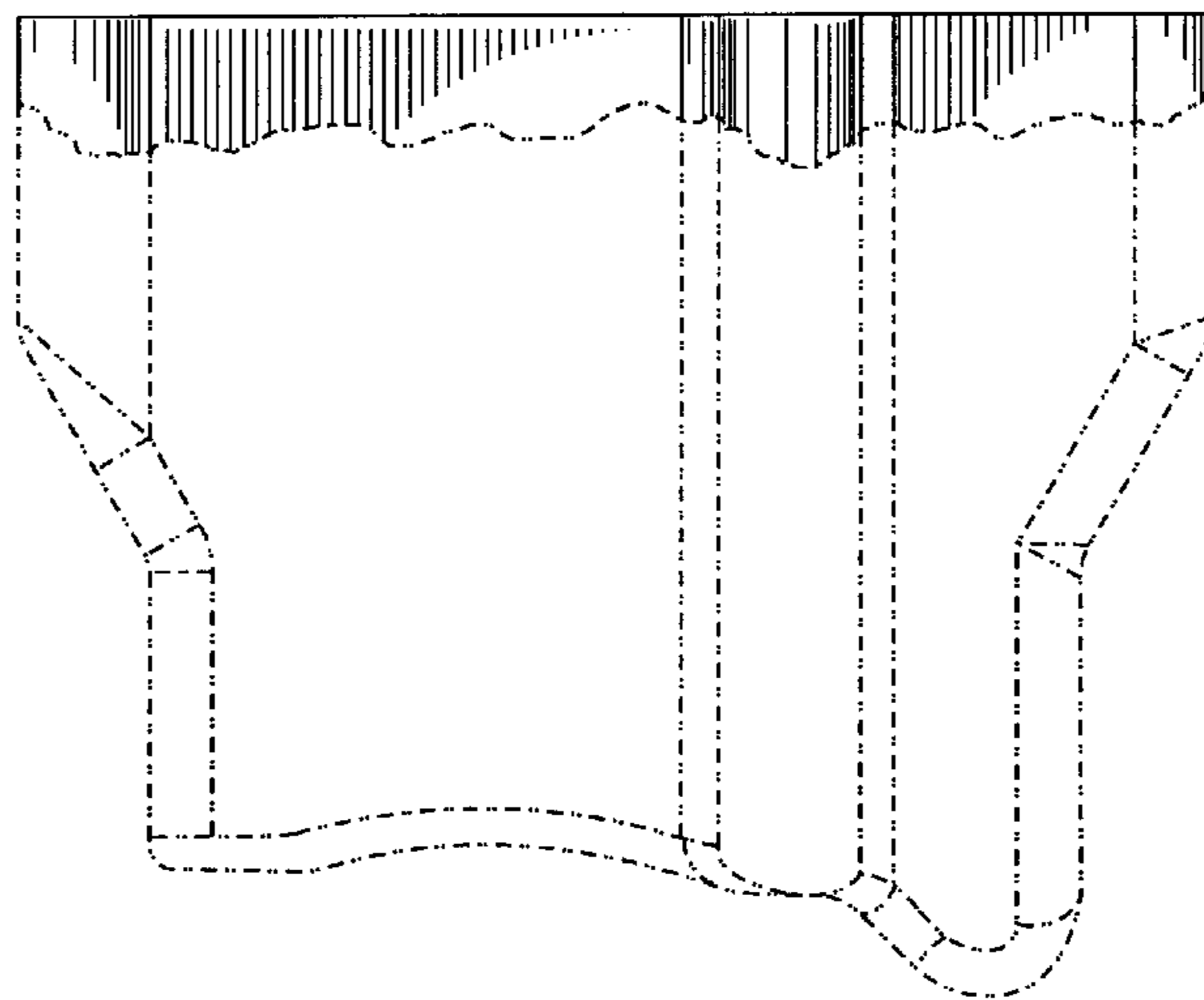

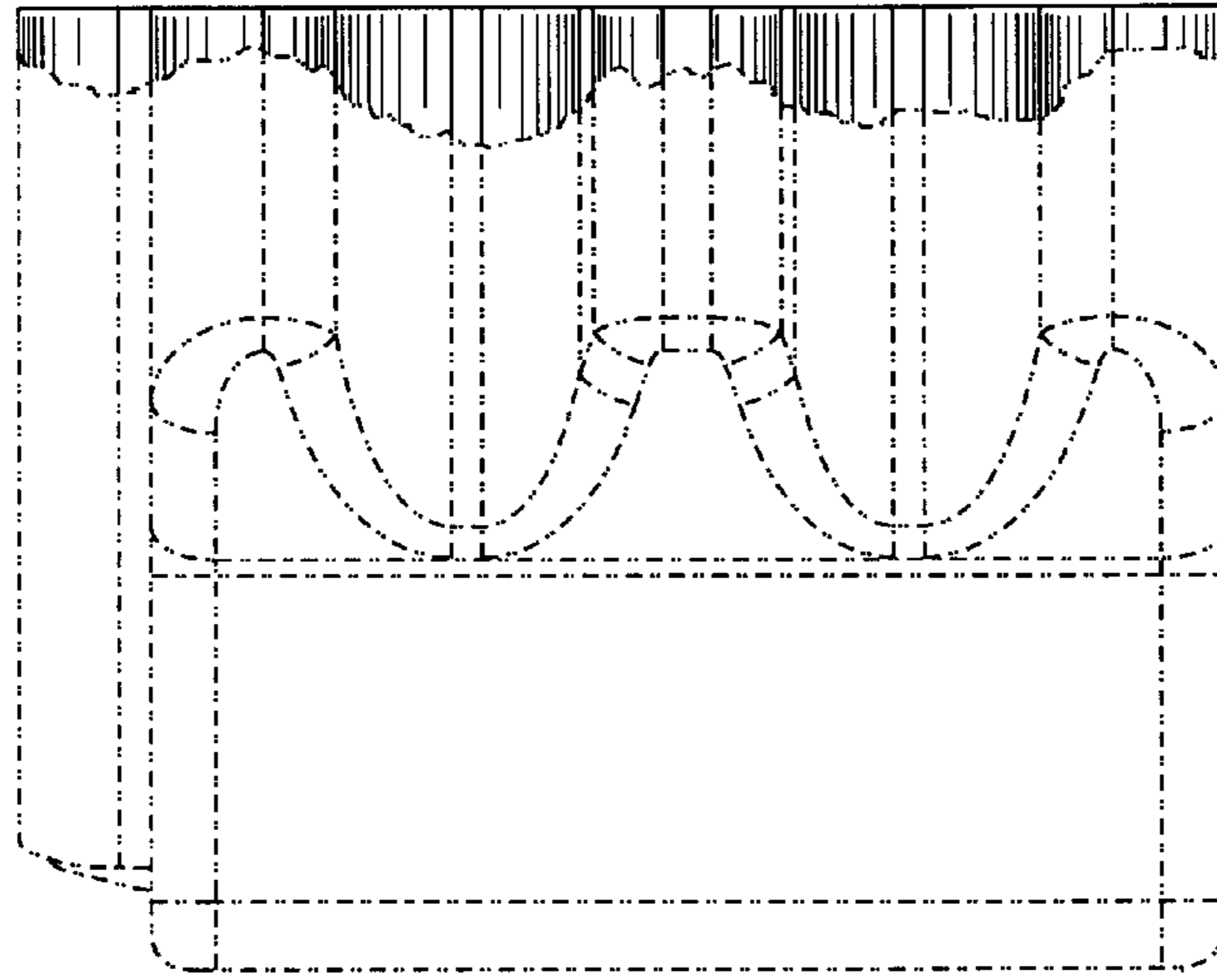

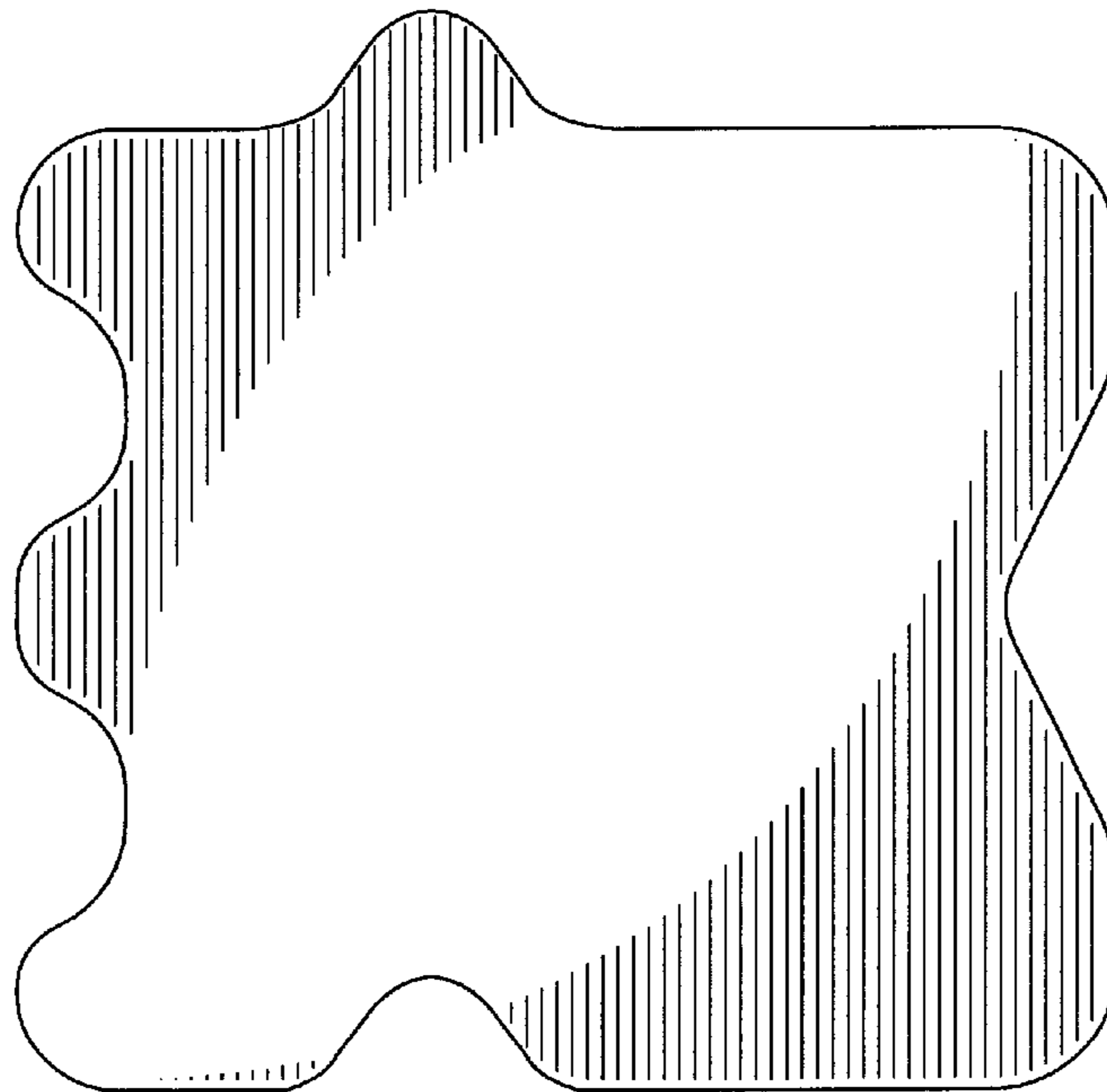

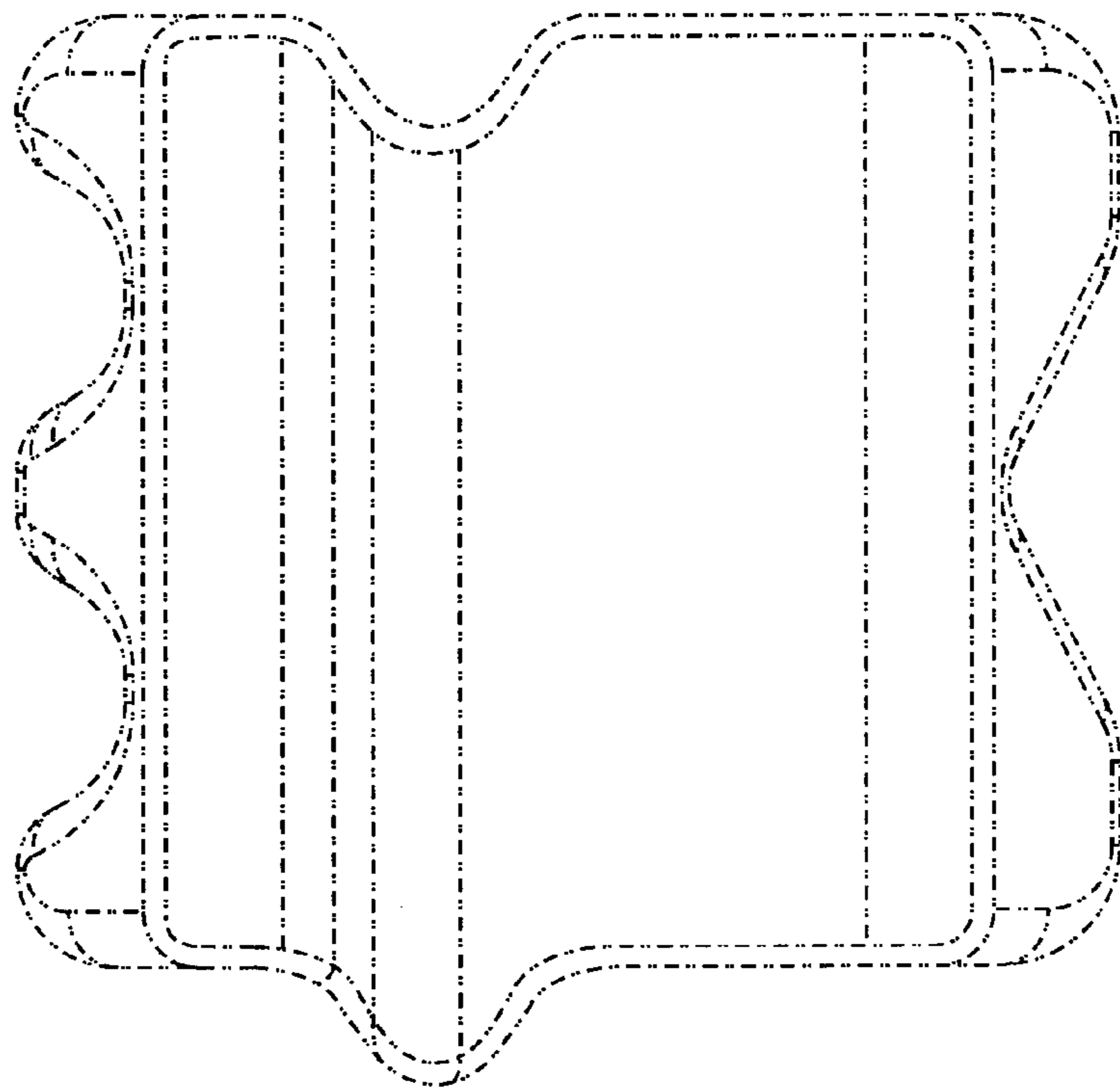
