The ornamental design for a card assembly with vertical magnetic stripe, as shown and described.

DESCRIPTION

Design Patent Application No. 29/205,080, Design Patent Application No. 29/205,081, Design Patent Application No. 29/205,091, filed concurrently with the present application, are related by subject matter.

FIG. 1 is a back view of a card assembly with vertical magnetic stripe showing a new design;

FIG. 2 is a front view of the embodiment of FIG. 1; and,

FIG. 3 is a side view of the embodiment of FIG. 1.

The broken line showing of card indicia, indicia box and punch out display hole are for illustrative purposes only and form no part of the claimed design.

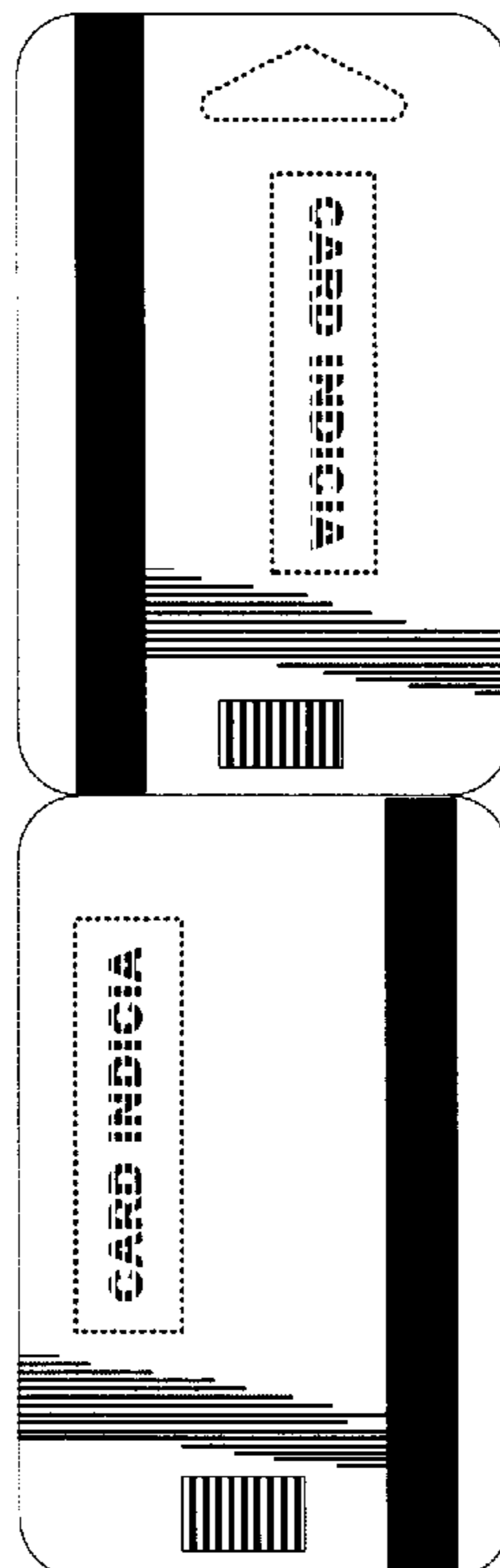

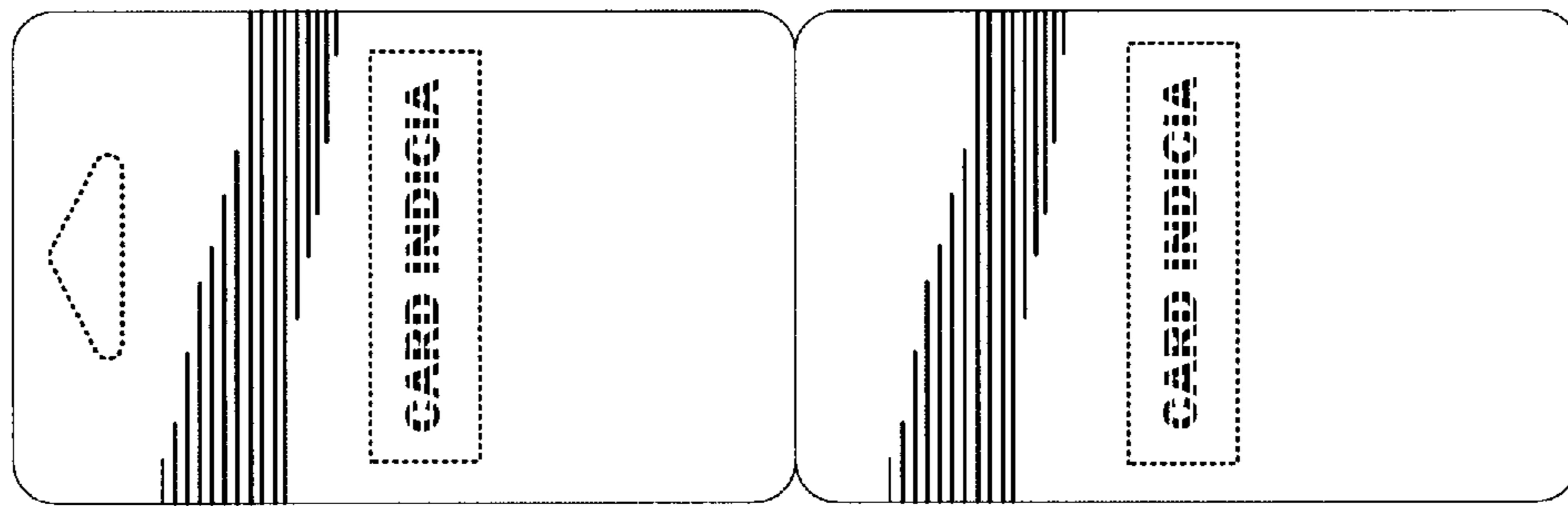
