The ornamental design for a controller for a game device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of my new design for a controller for a game device;

FIG. 2 is a rear elevational view of the controller for a game device of FIG. 1;

FIG. 3 is a top plan view of the controller for a game device of FIG. 1;

FIG. 4 is a bottom plan view of the controller for a game device of FIG. 1;

FIG. 5 is a right side elevational view of the controller for a game device of FIG. 1; and,

FIG. 6 is a left side elevational view of the controller for a game device of FIG. 1.

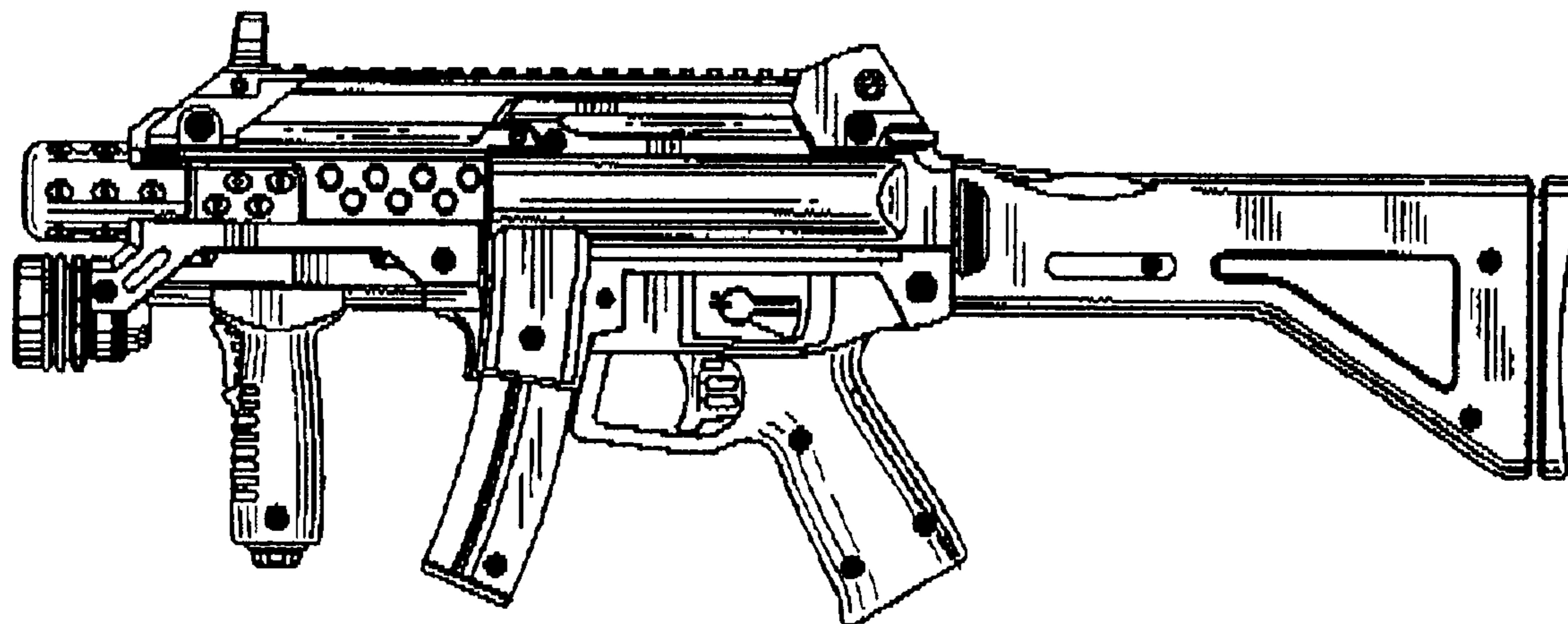

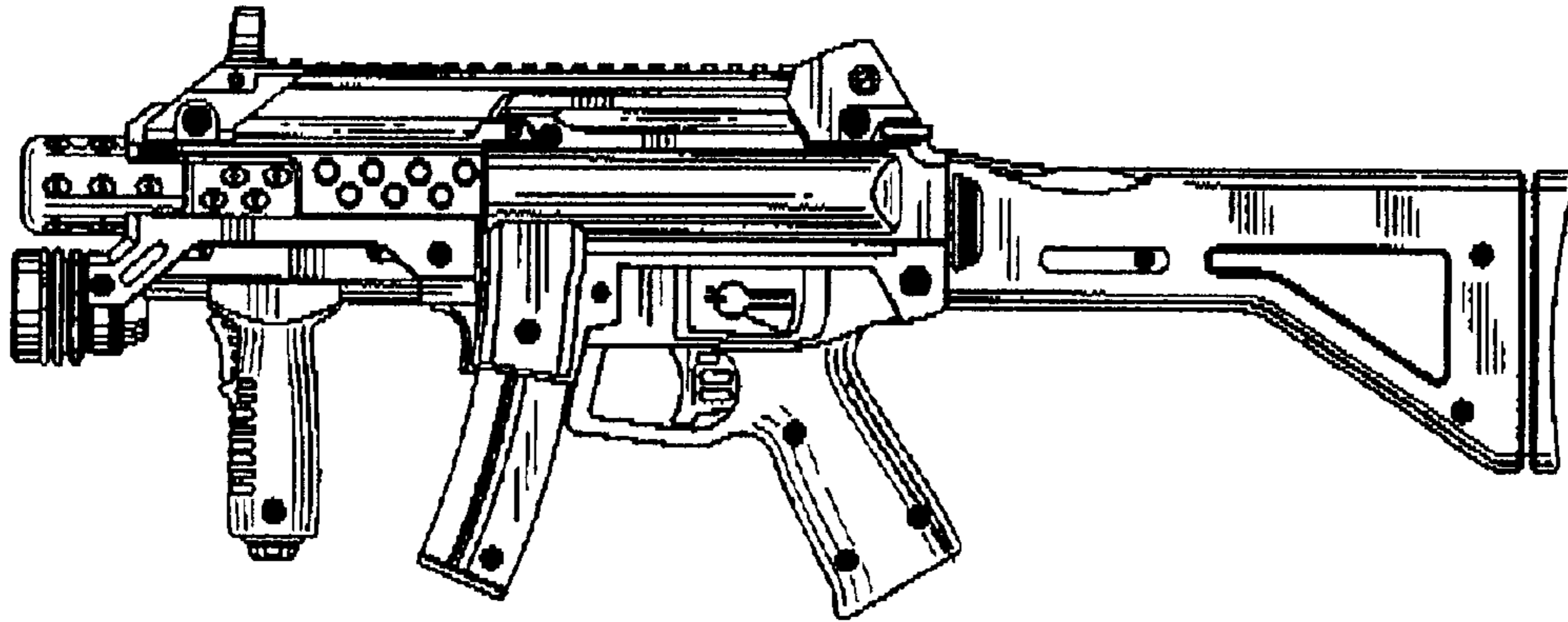

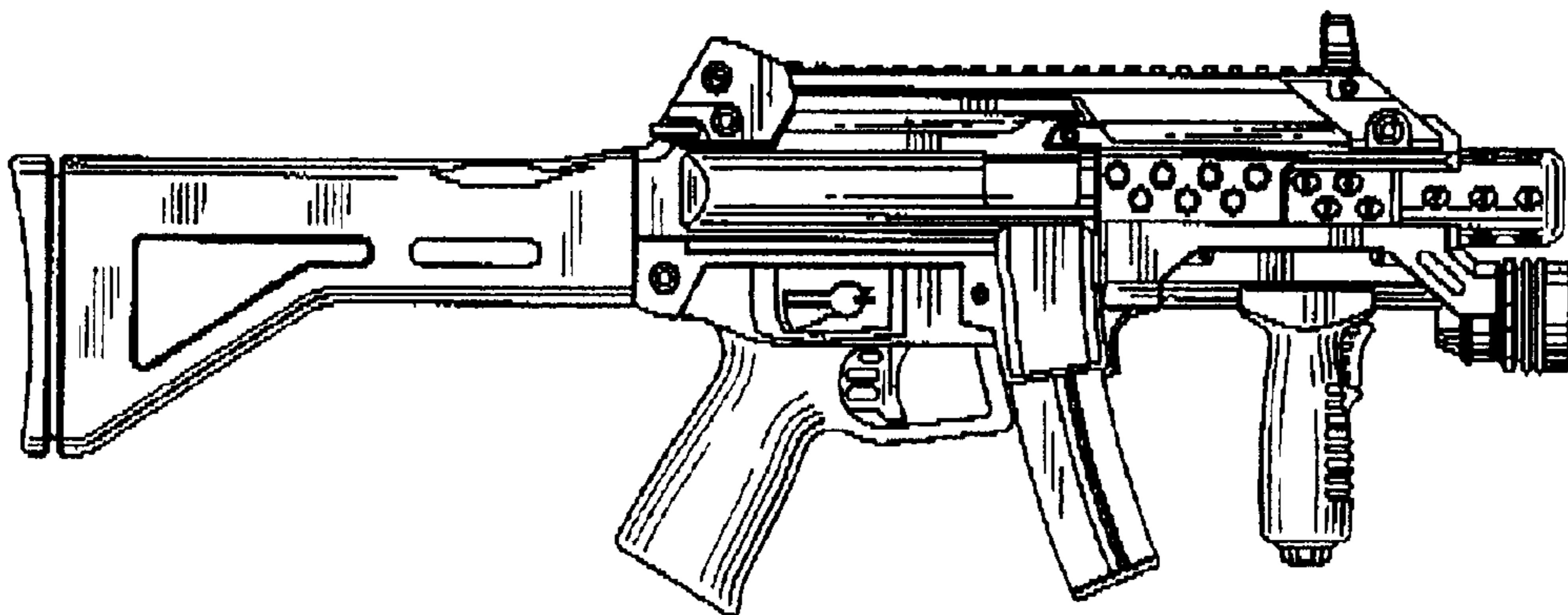
