The ornamental design for a portion of an illuminating device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a portion of an illuminating device showing our new design;

FIG. 4 is a right side thereof;

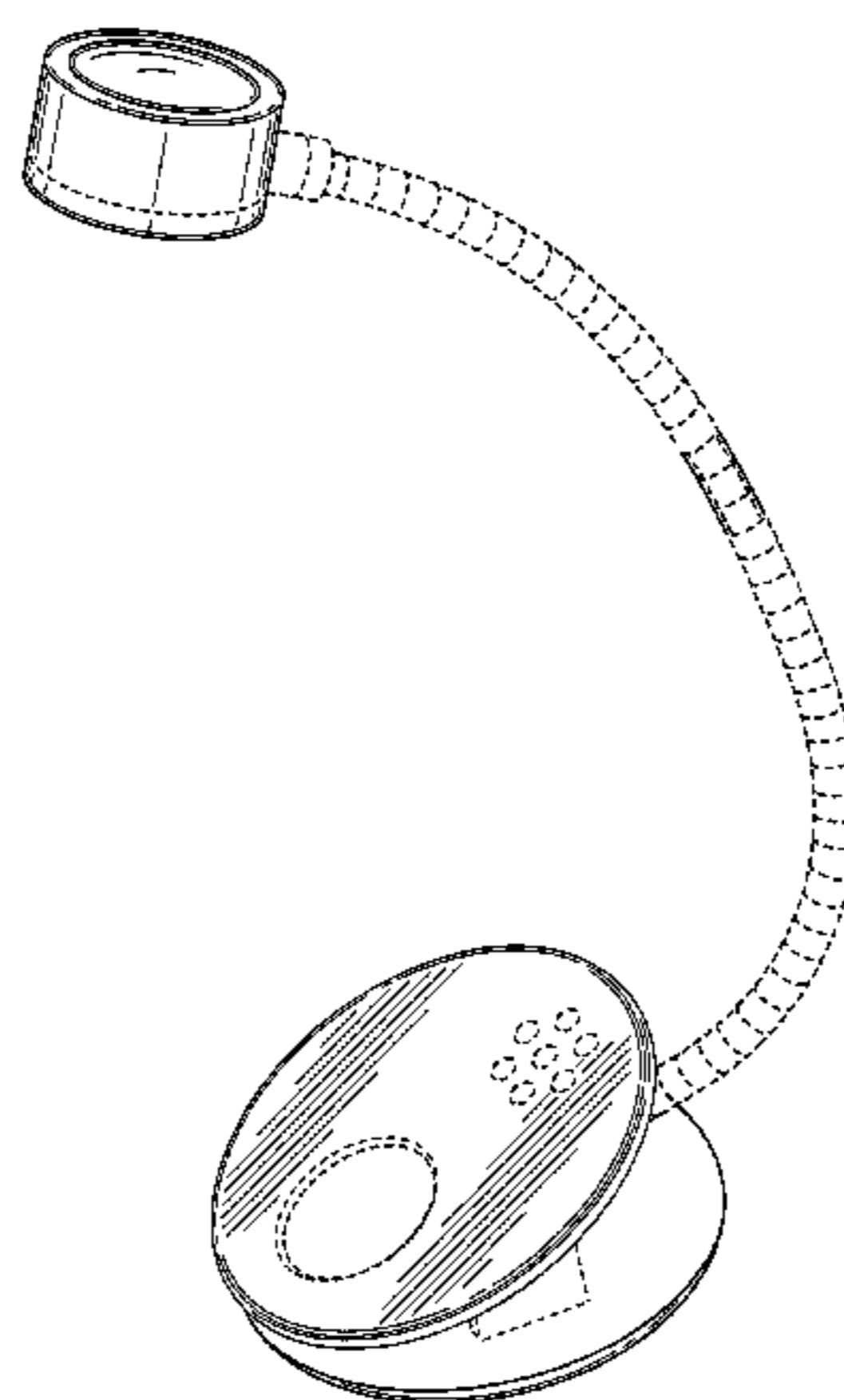
FIG. 5 is a left side view thereof;

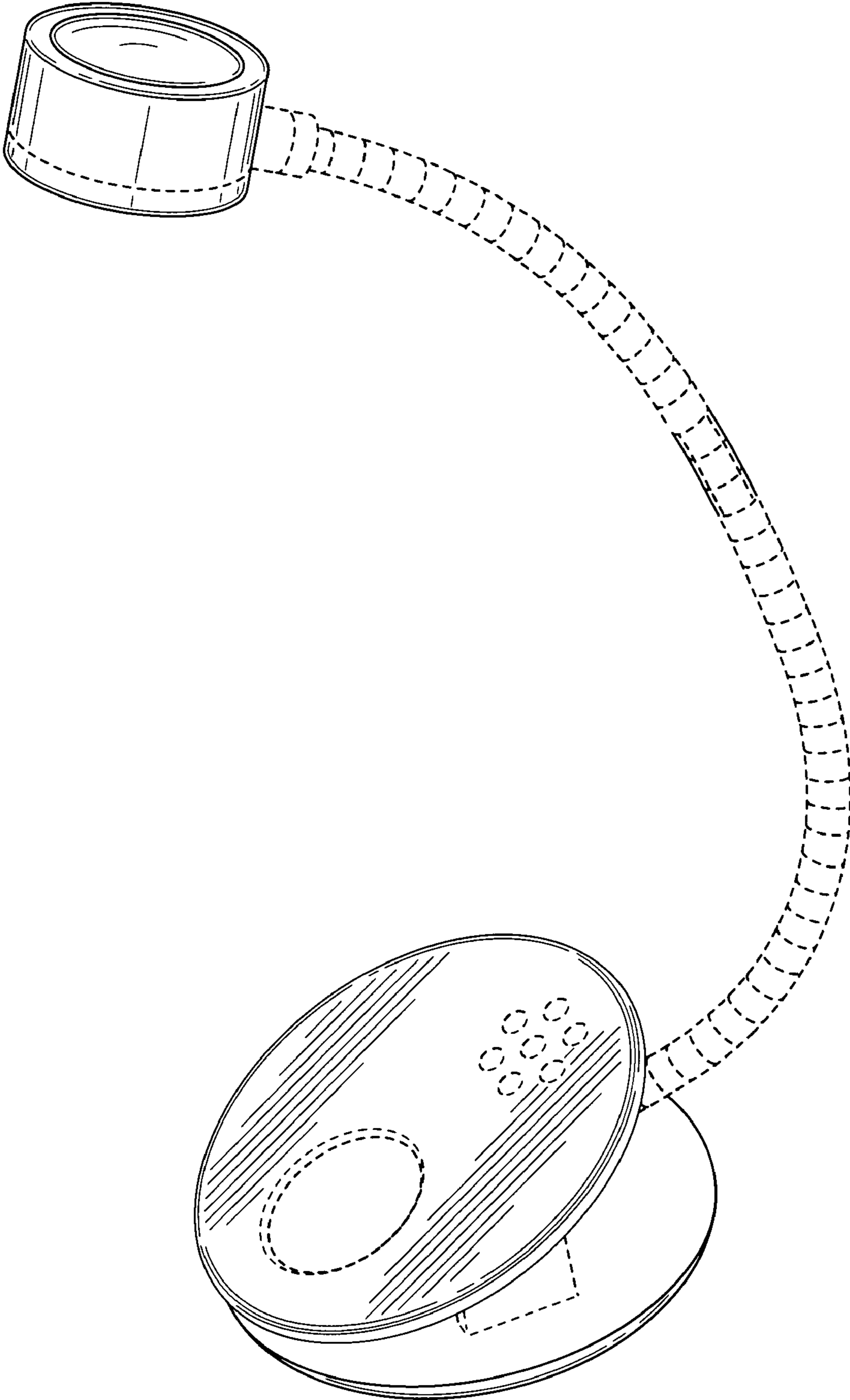

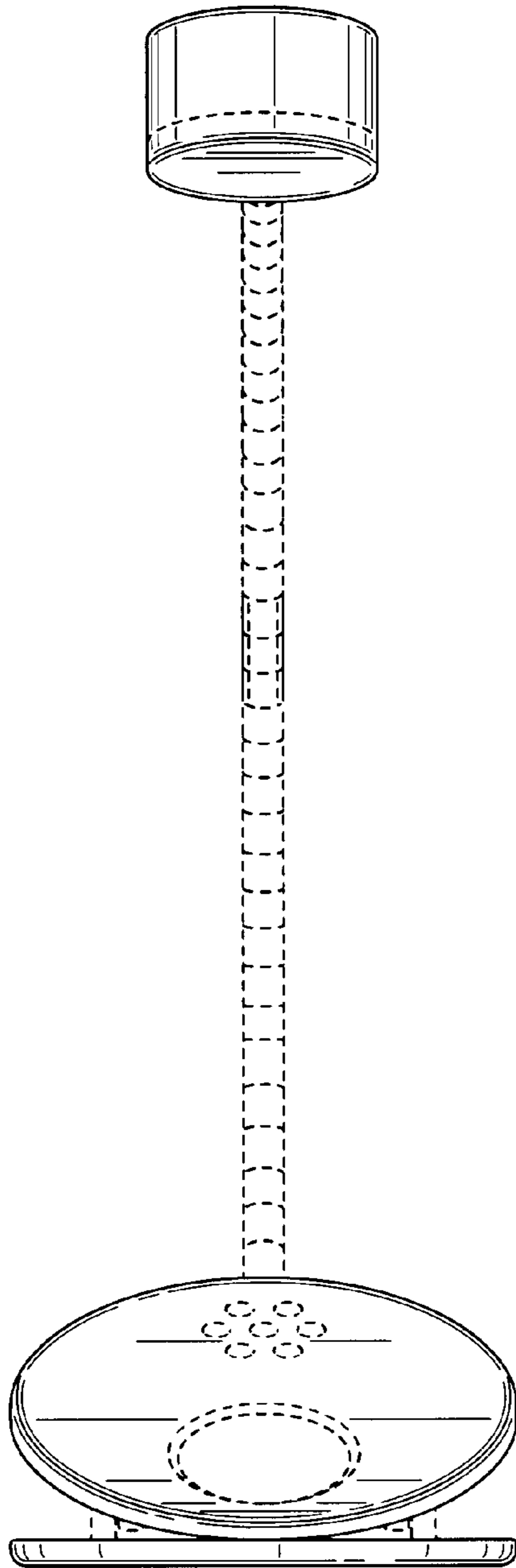

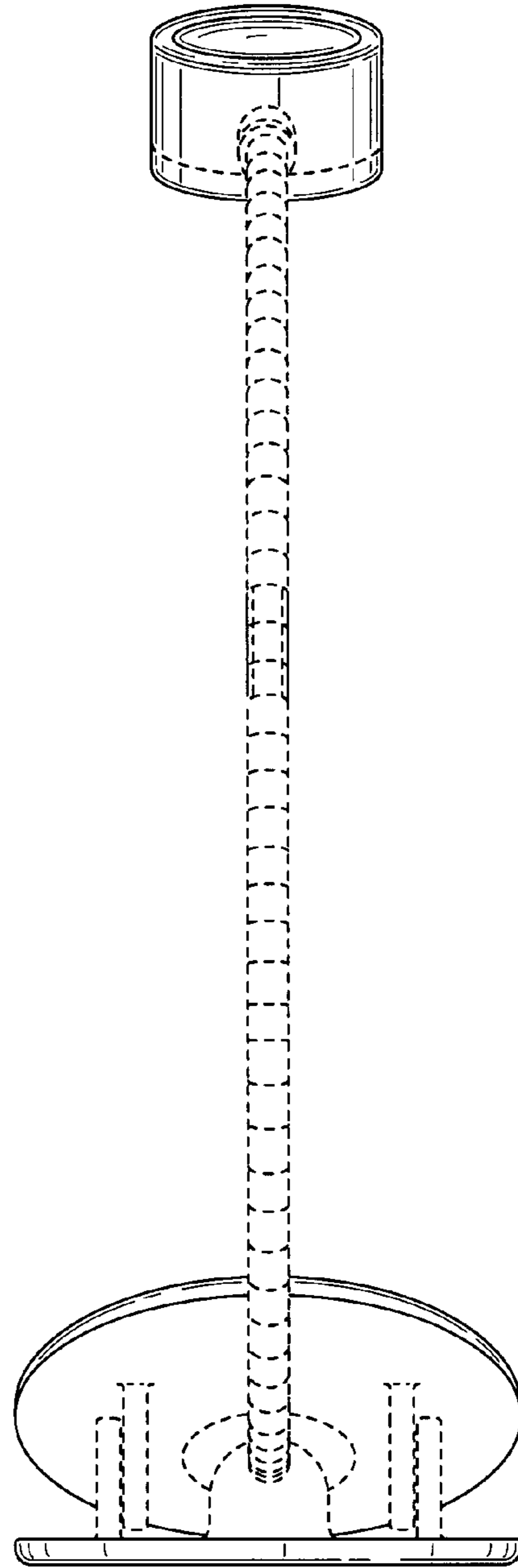

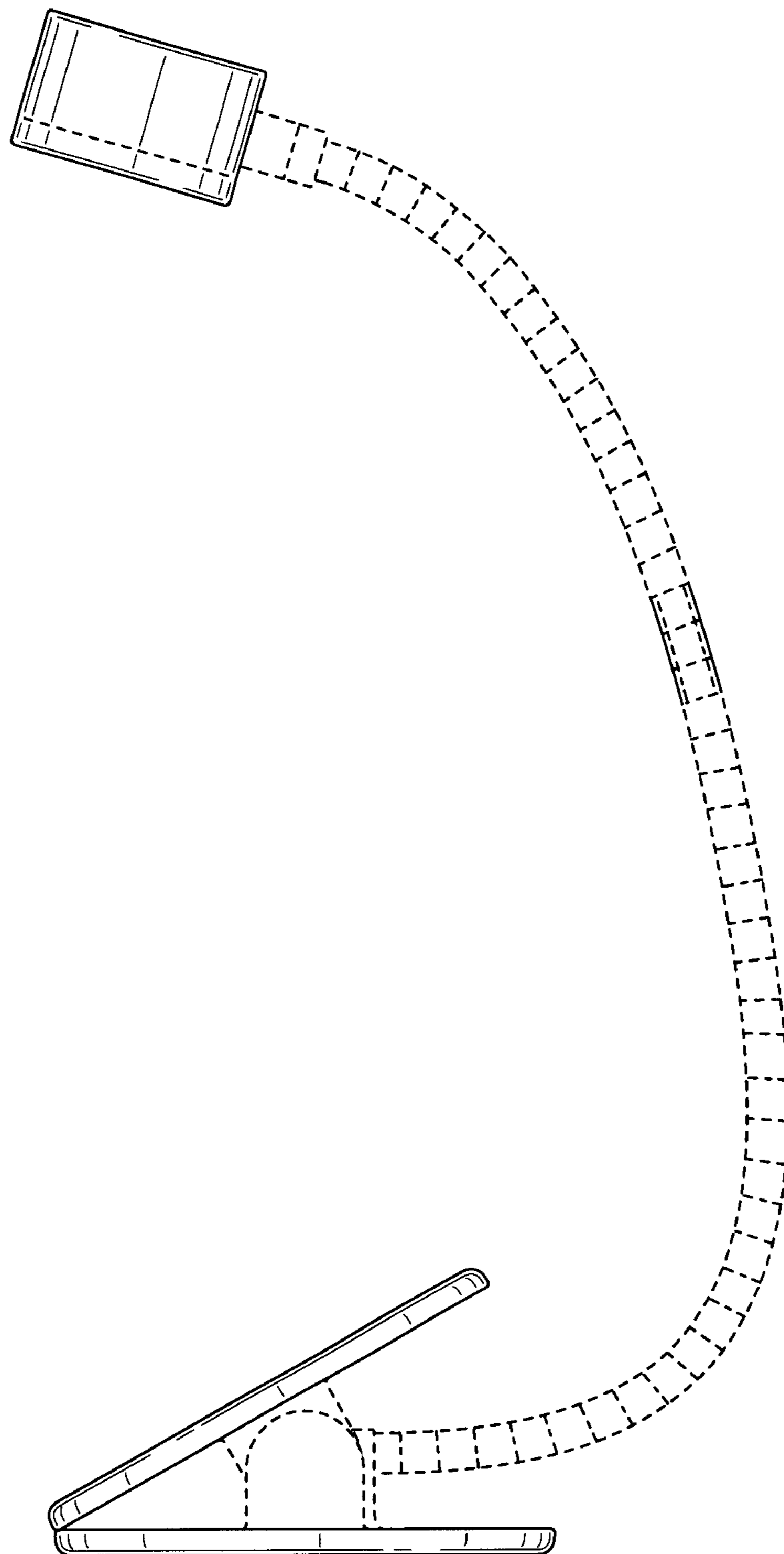

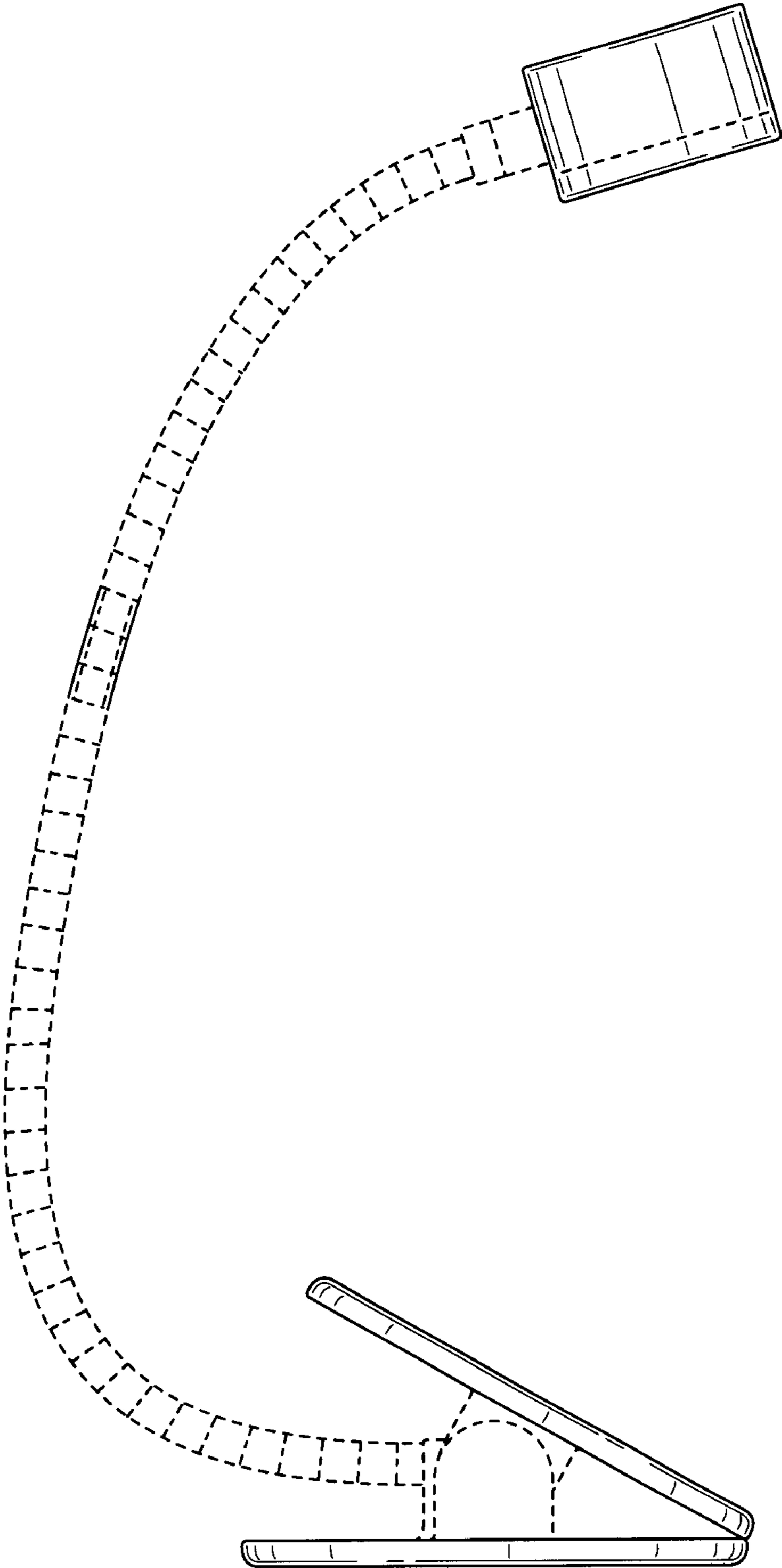

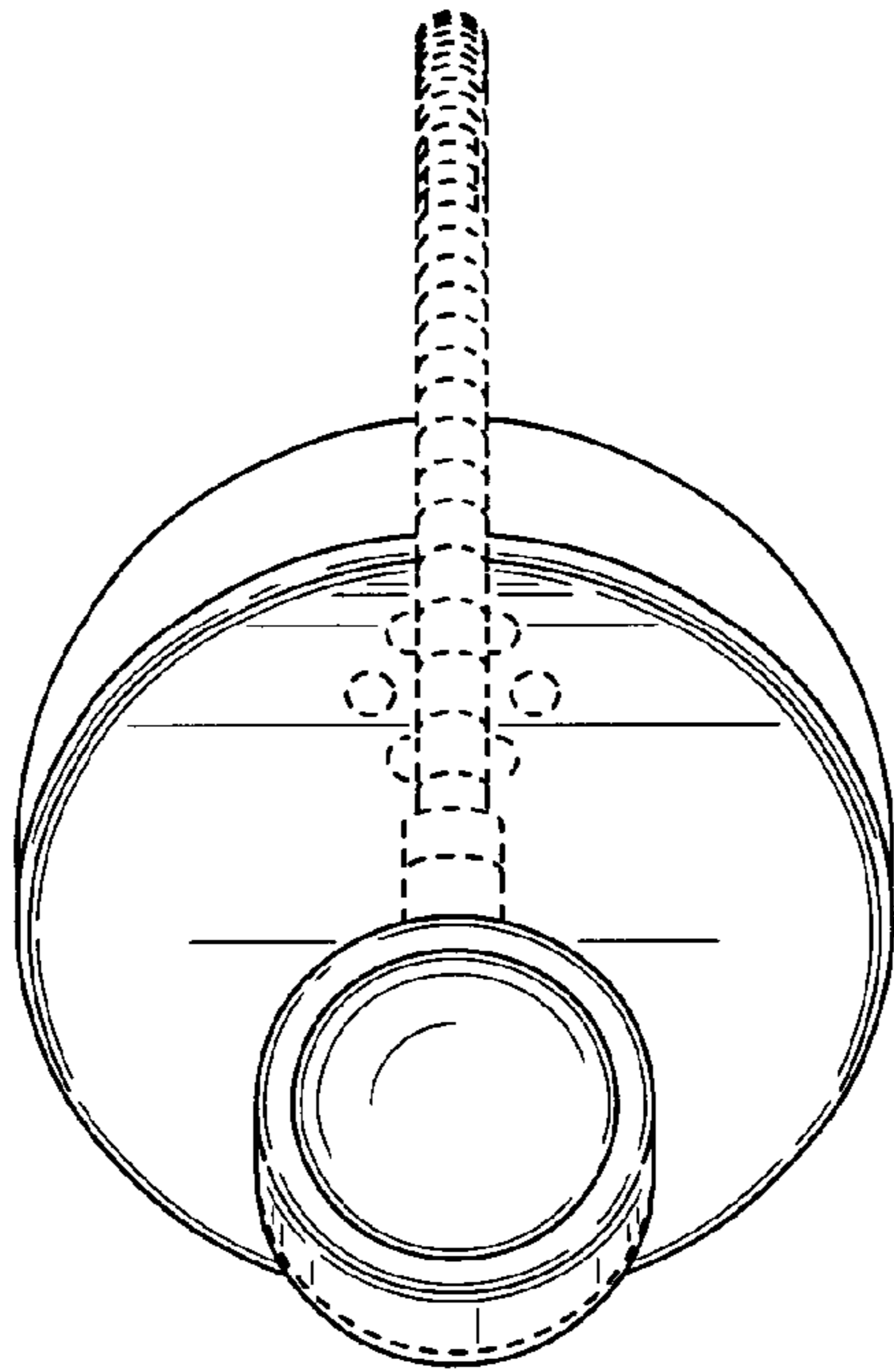

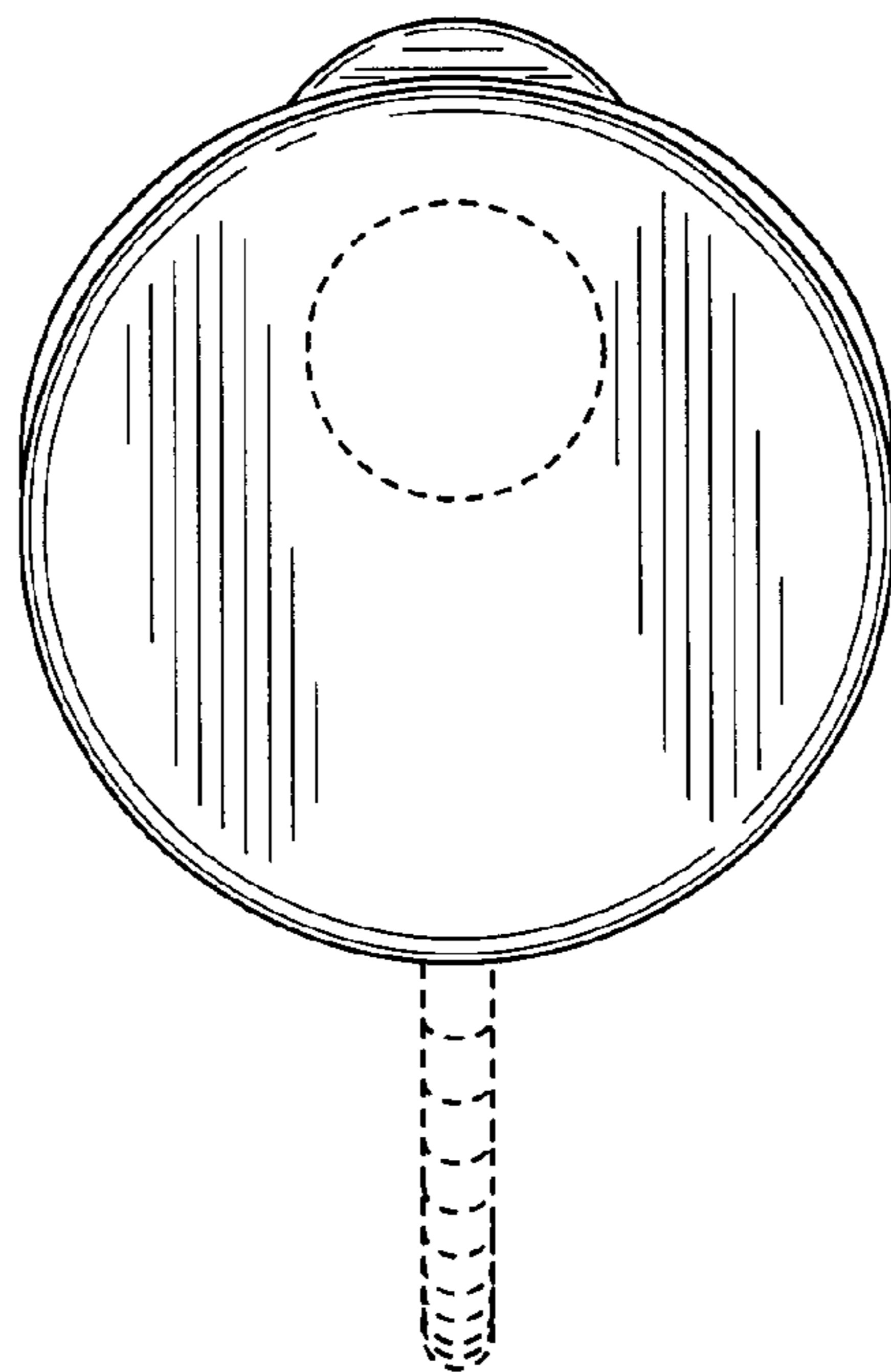
