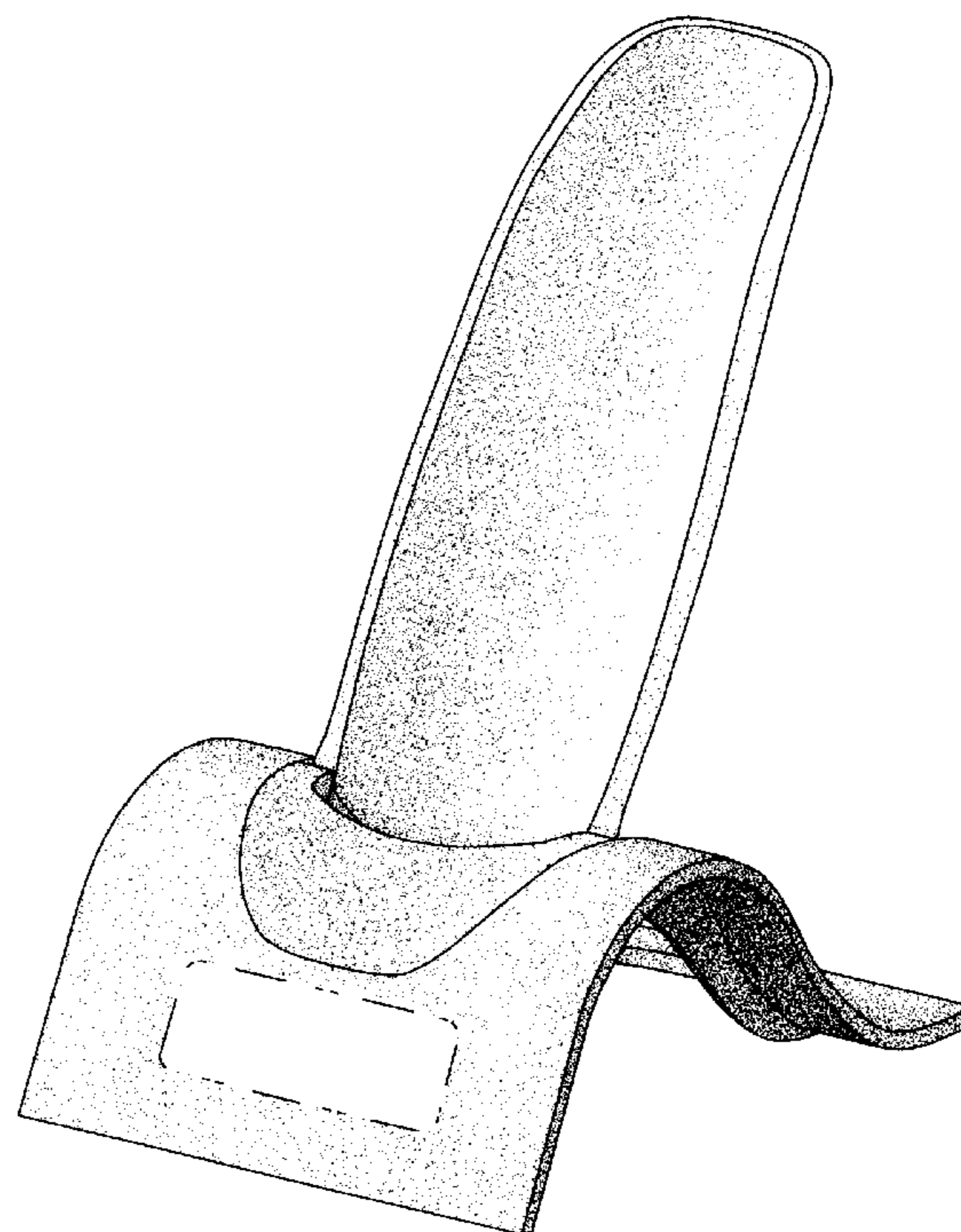
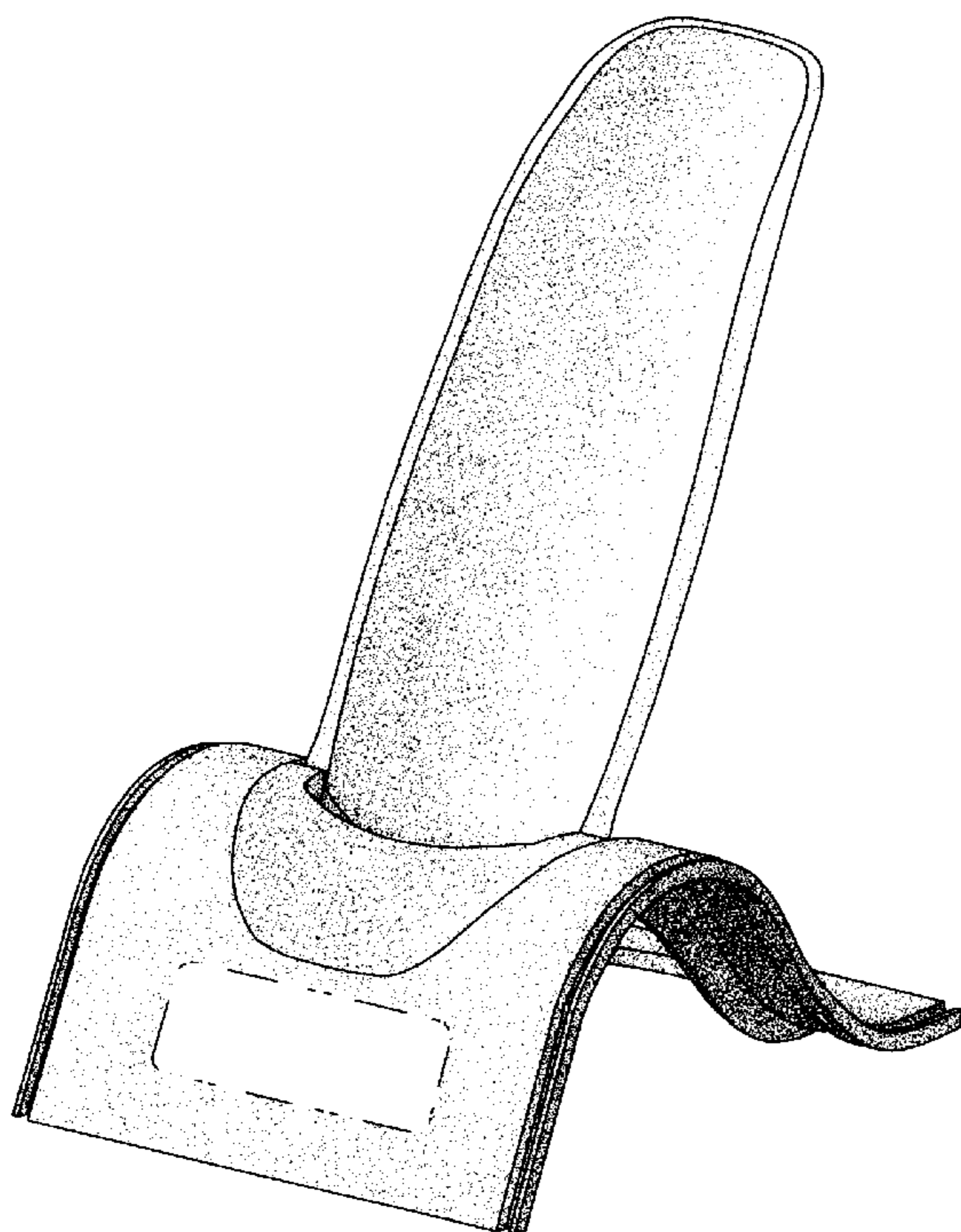
(57) **CLAIM**

The ornamental design for a hair trimmer stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a hair trimmer stand of the present invention; FIG. 2 is a front view of the hair trimmer stand of FIG. 1; FIG. 3 is a right side view of the hair trimmer stand of FIG. 1; FIG. 4 is a left side view of the hair trimmer stand of FIG. 1; FIG. 5 is a rear view of the hair trimmer stand of FIG. 1; FIG. 6 is a top view of the hair trimmer stand of FIG. 1; and FIG. 7 is a bottom view of the hair trimmer stand of FIG. 1. FIG. 8 is a perspective view of an alternate embodiment of a hair trimmer stand of the present invention; FIG. 9 is a front view of the hair trimmer stand of FIG. 8; FIG. 10 is a right side view of the hair trimmer stand of FIG. 8; FIG. 11 is a left side view of the hair trimmer stand of FIG. 8; FIG. 12 is a rear view of the hair trimmer stand of FIG. 8; FIG. 13 is a top view of the hair trimmer stand of FIG. 8; and, FIG. 14 is a bottom view of the hair trimmer stand of FIG. 8. The broken line showing of the graphics area, contacts, input port and interface is for illustration purposes only and forms no part of the claimed design.

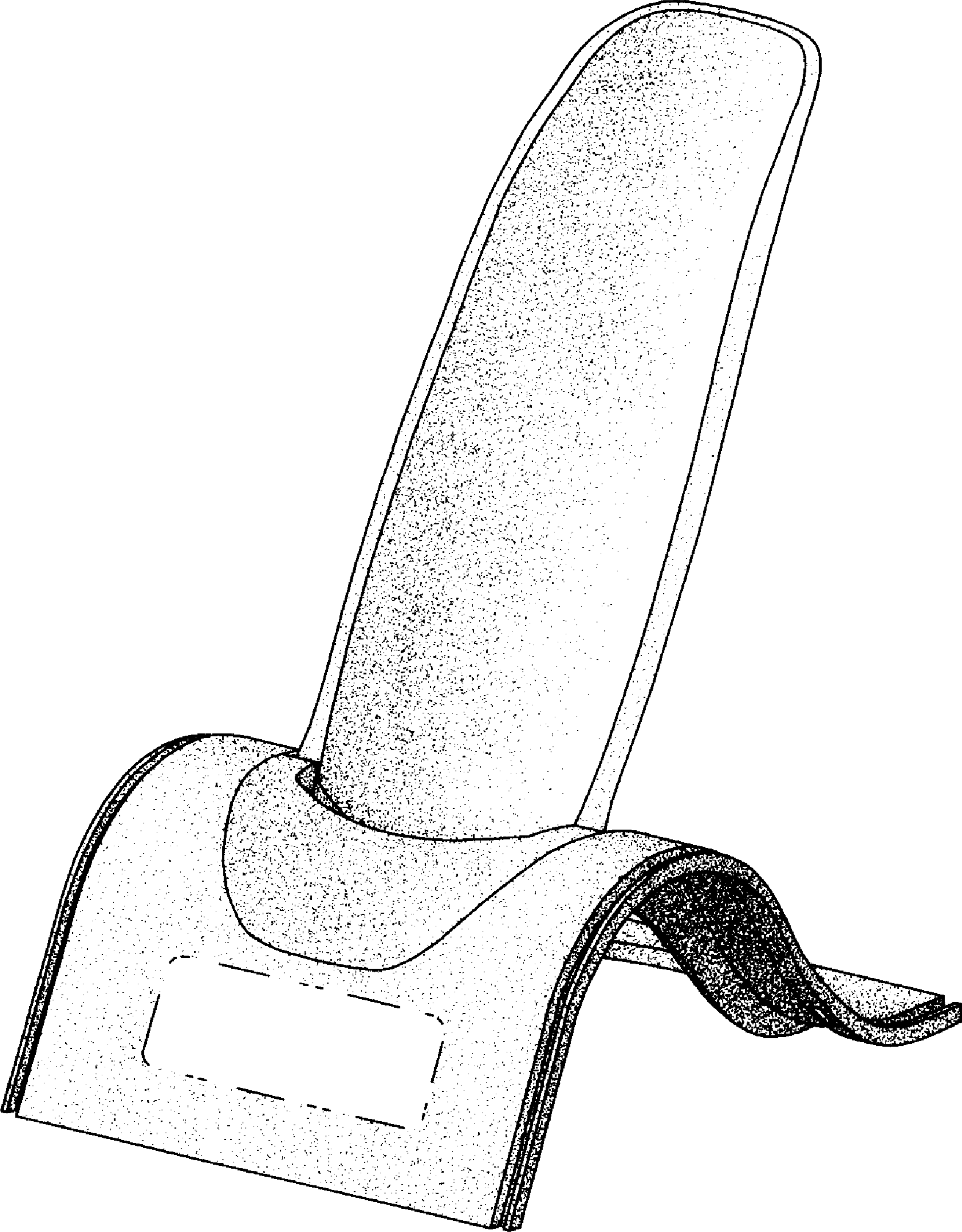

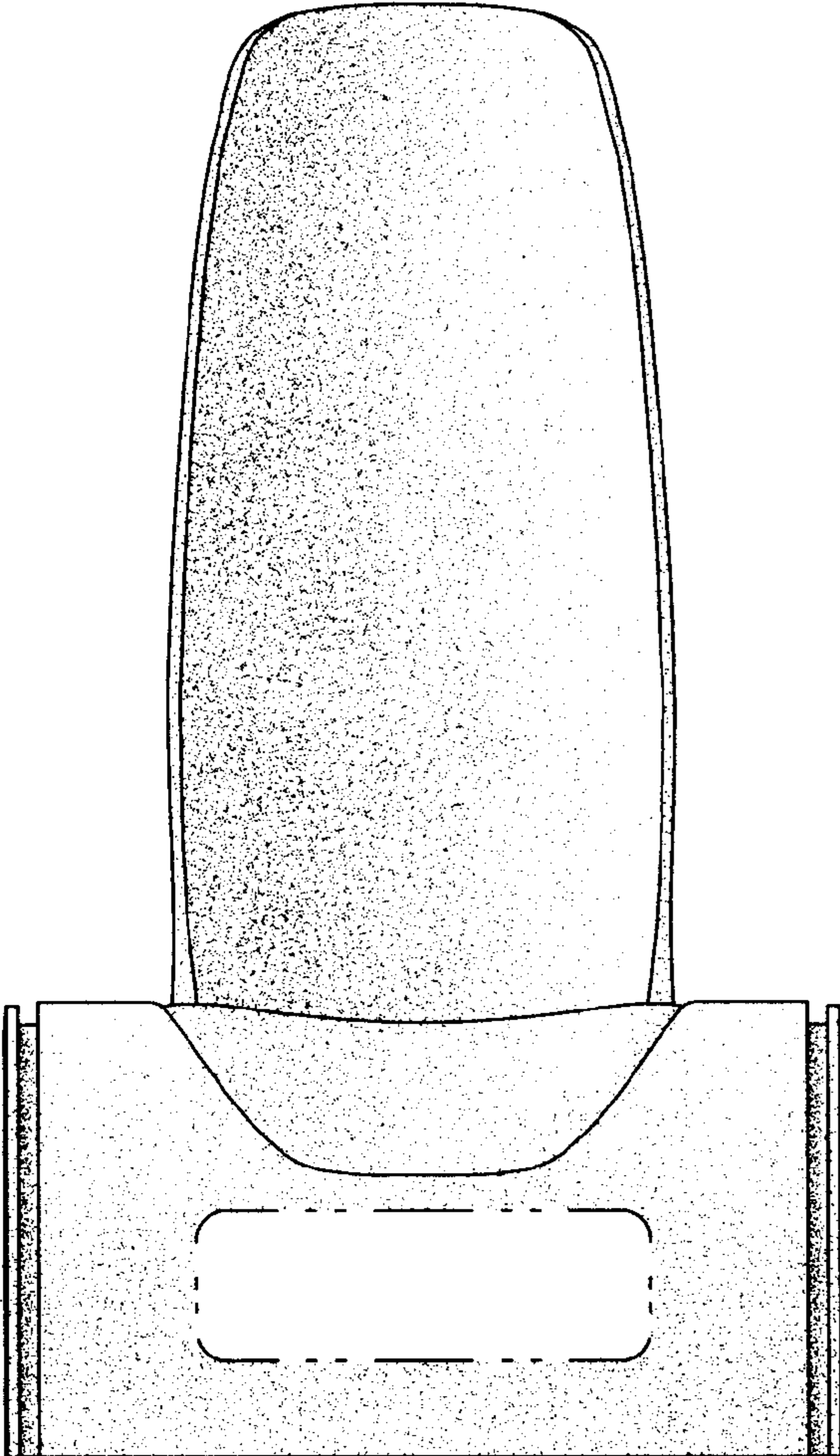

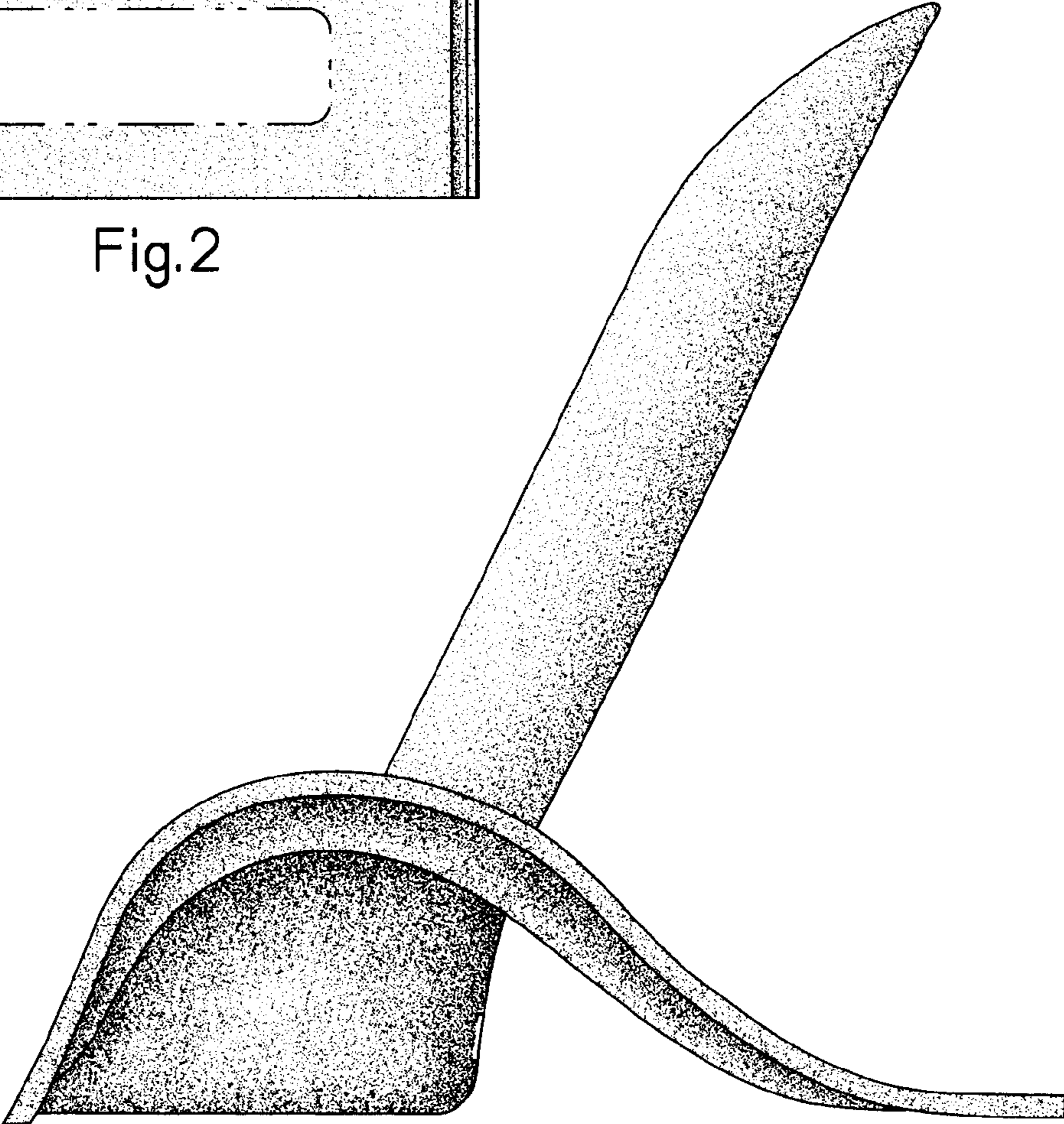

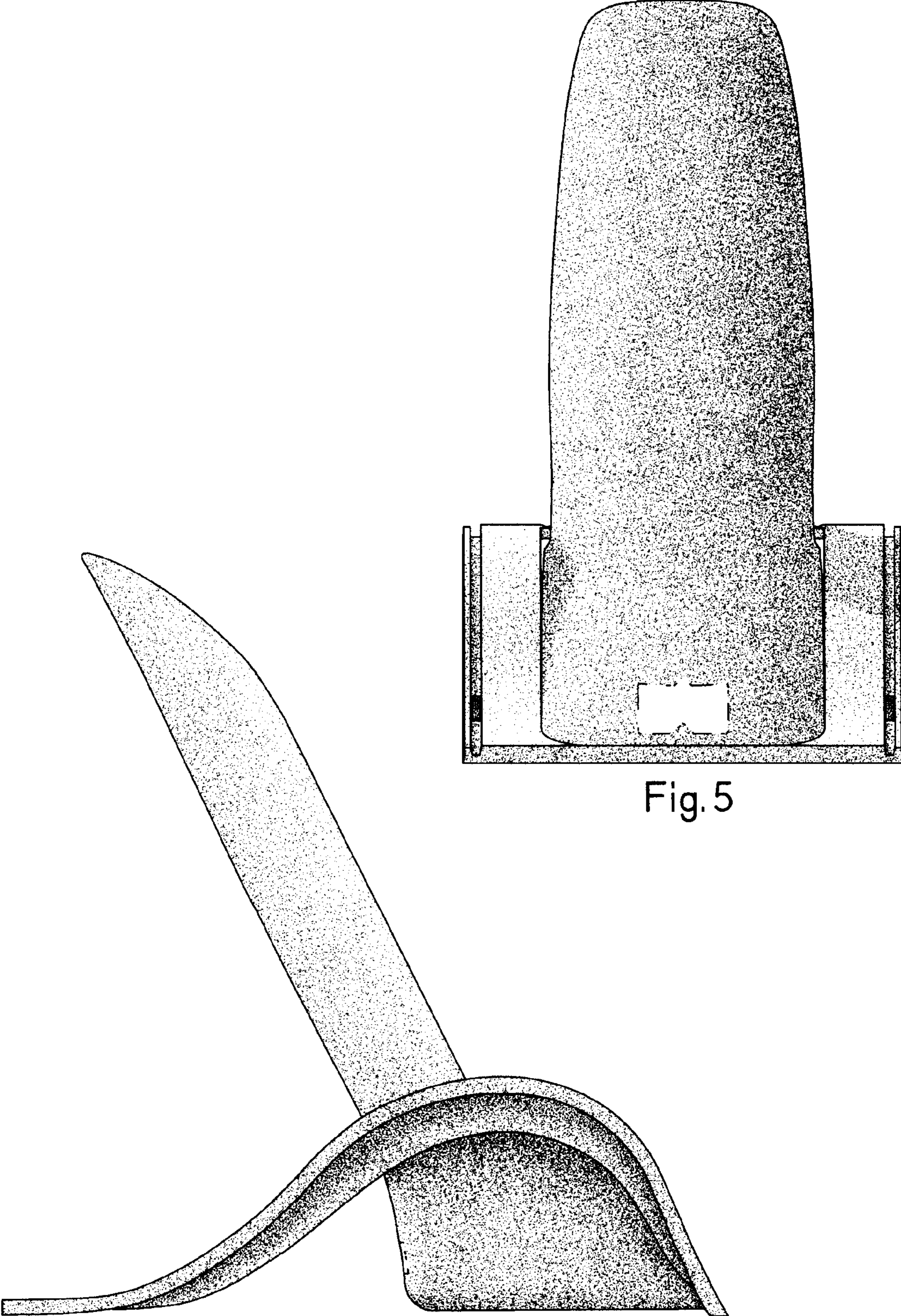

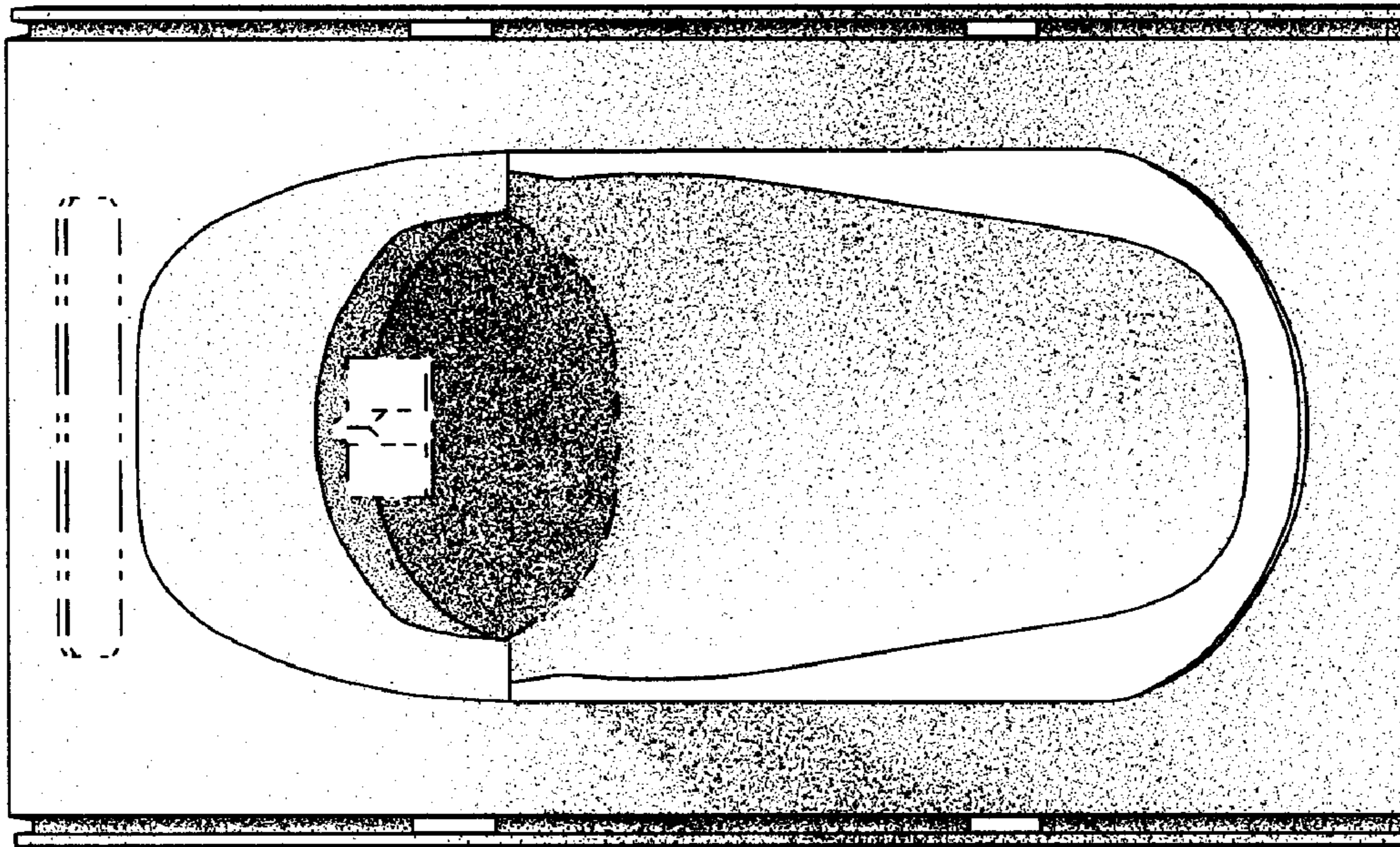

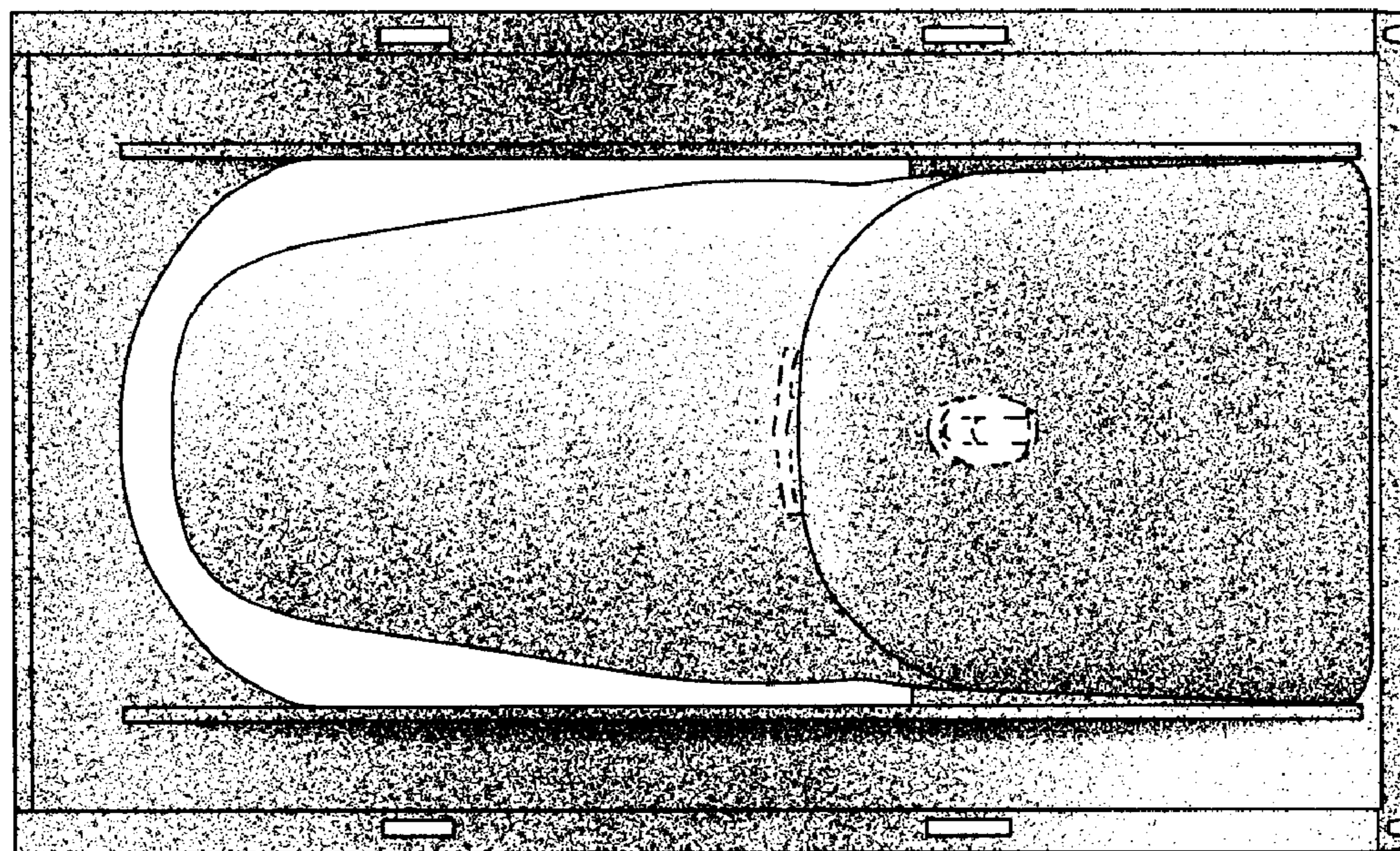

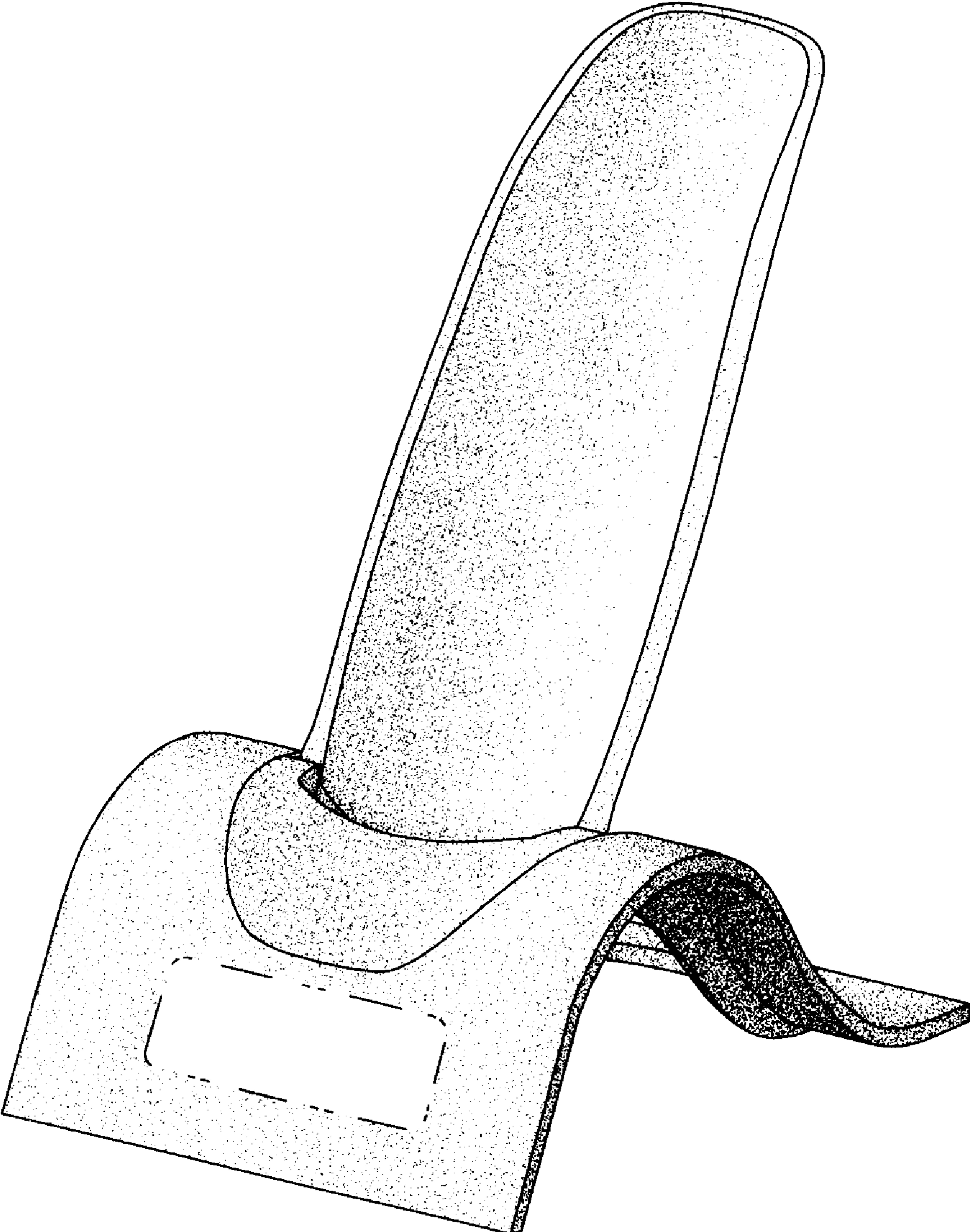

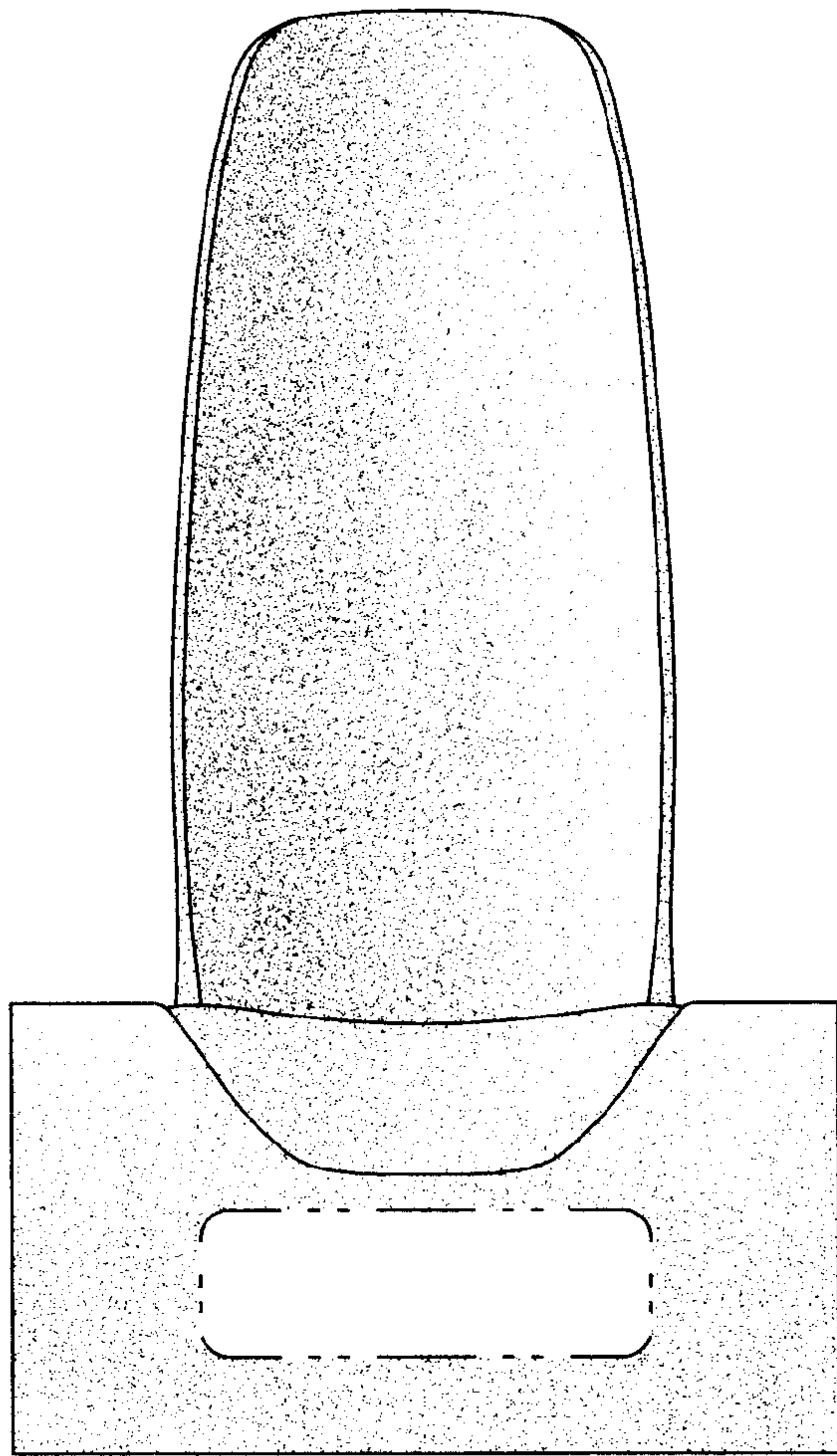

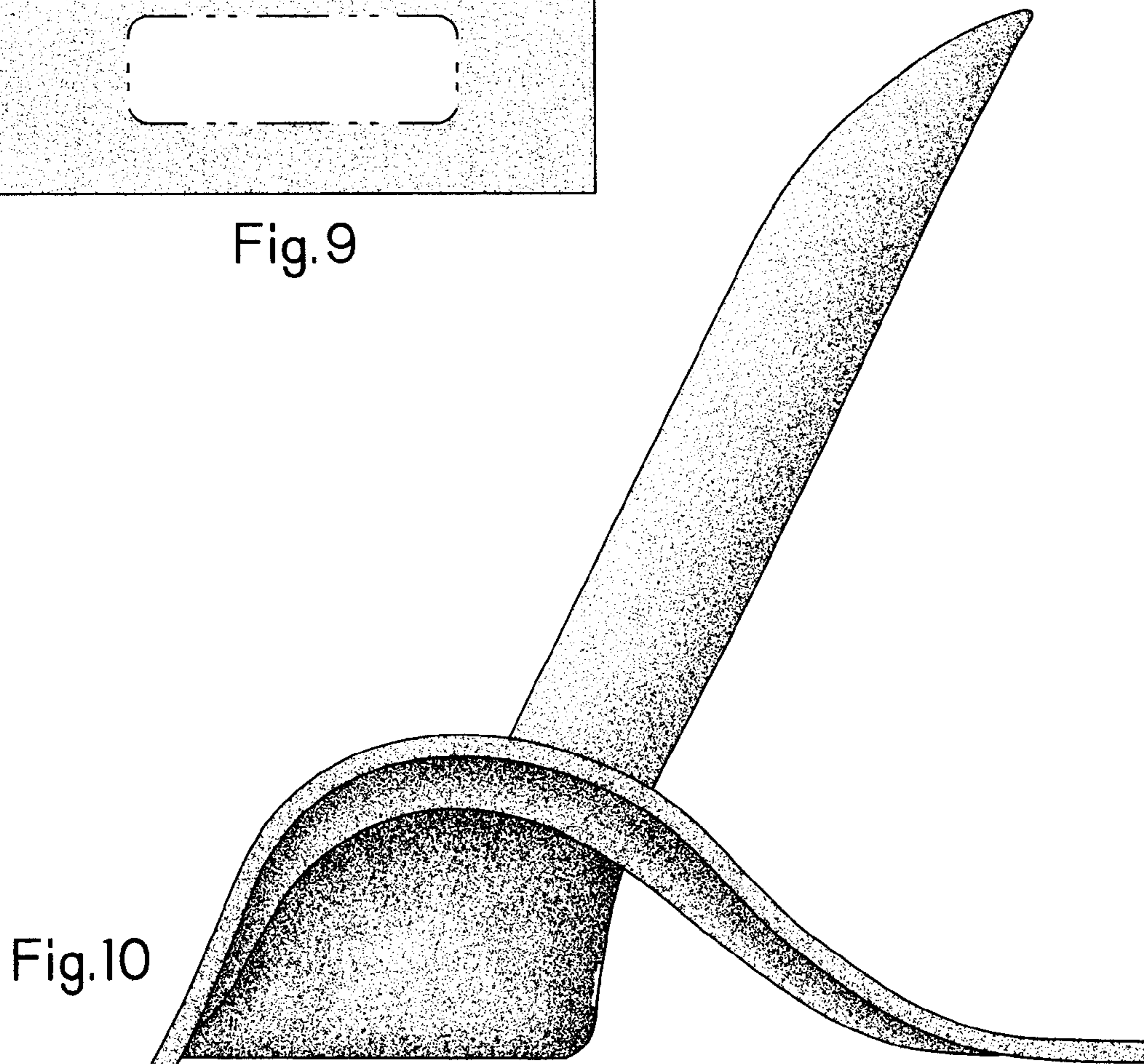

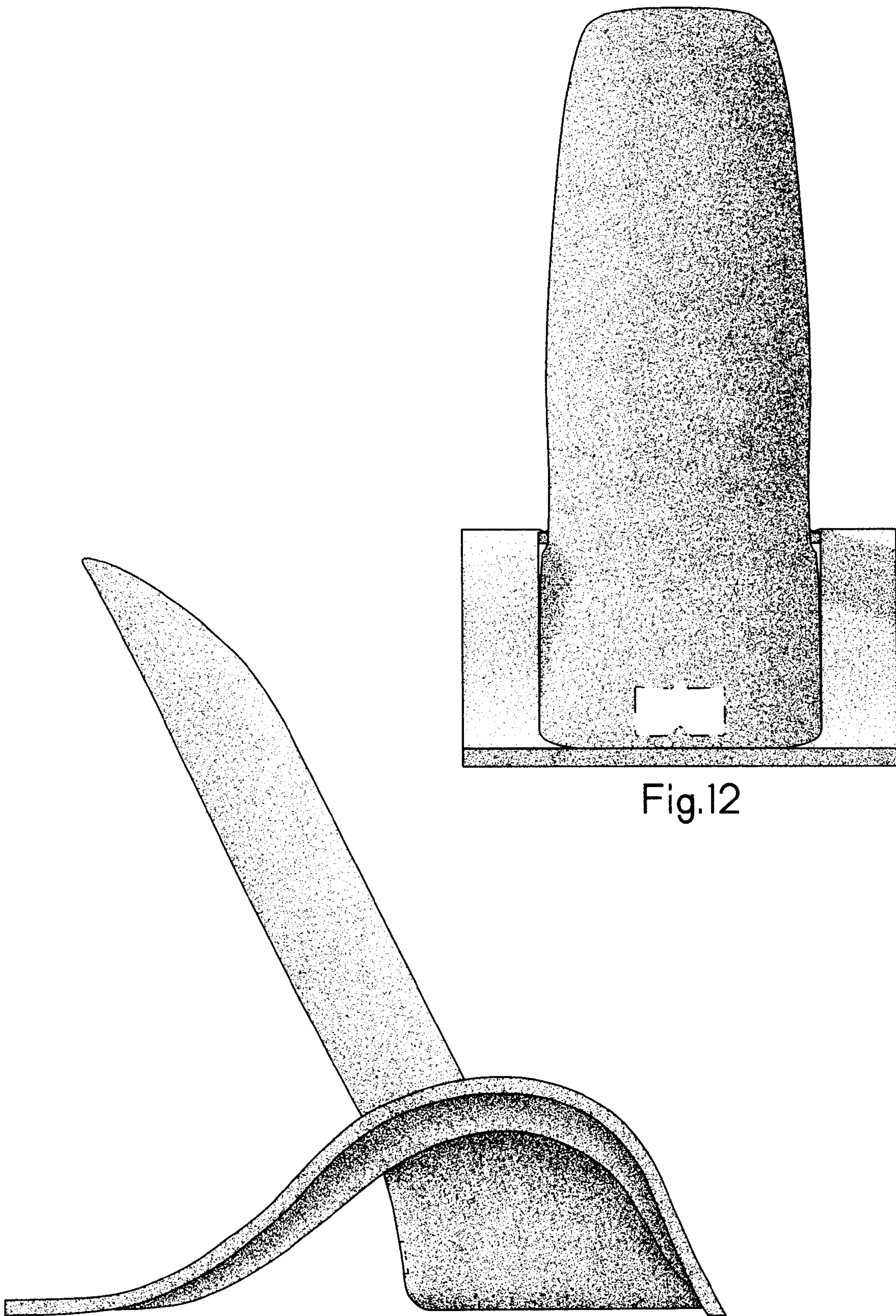

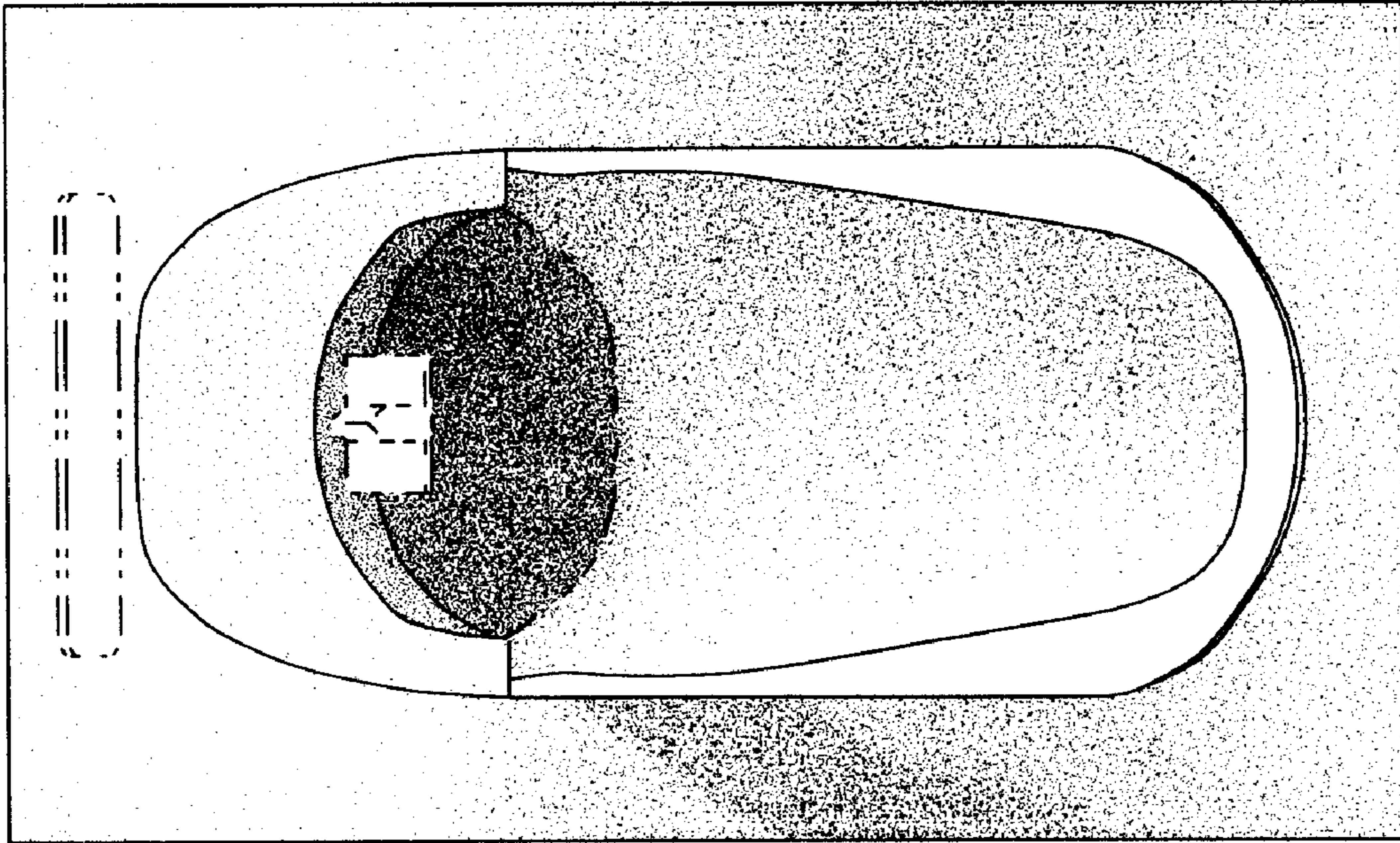

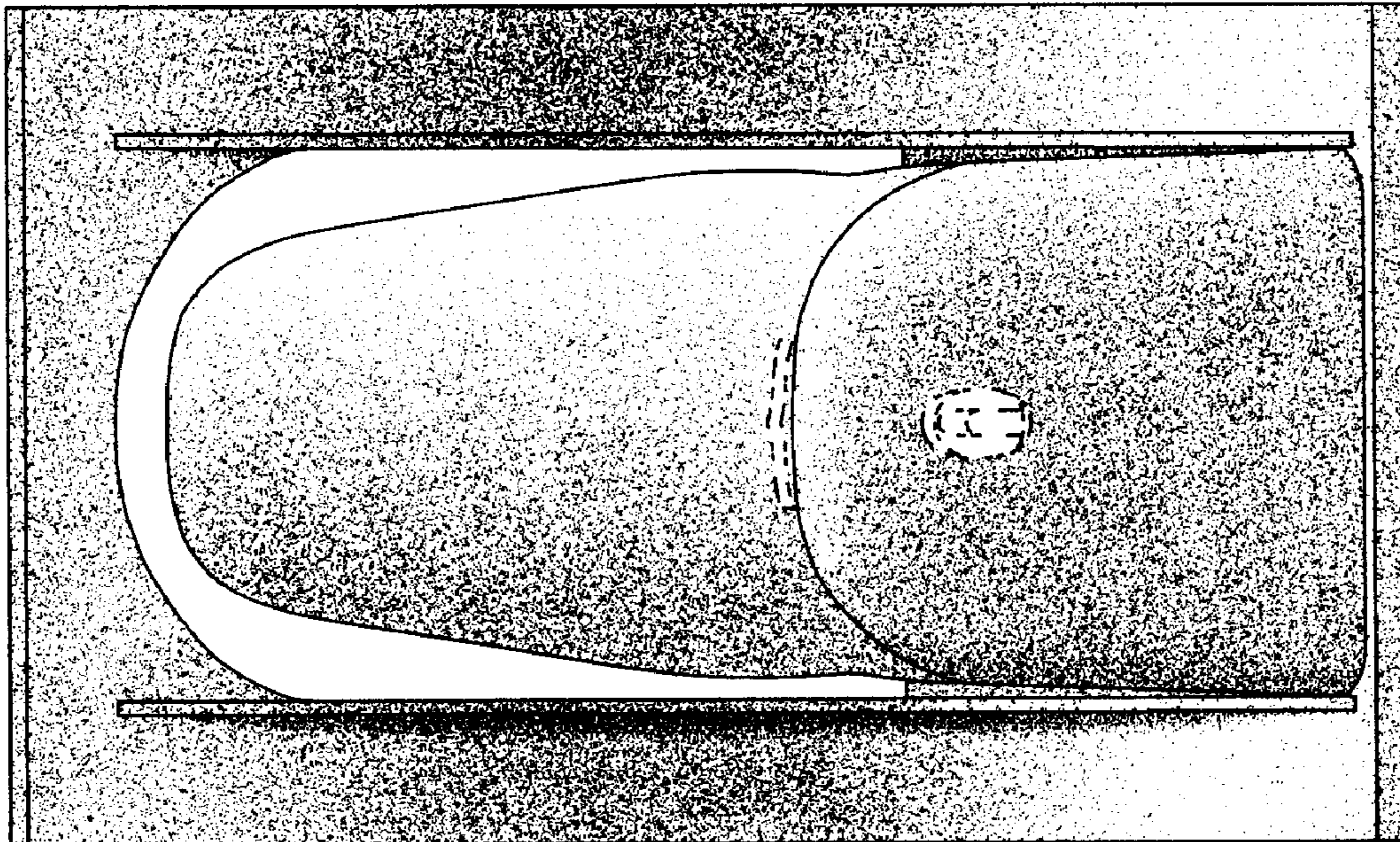
