**DESCRIPTION**

FIG. 3 is a view from one side of the helmet of FIG. 1;

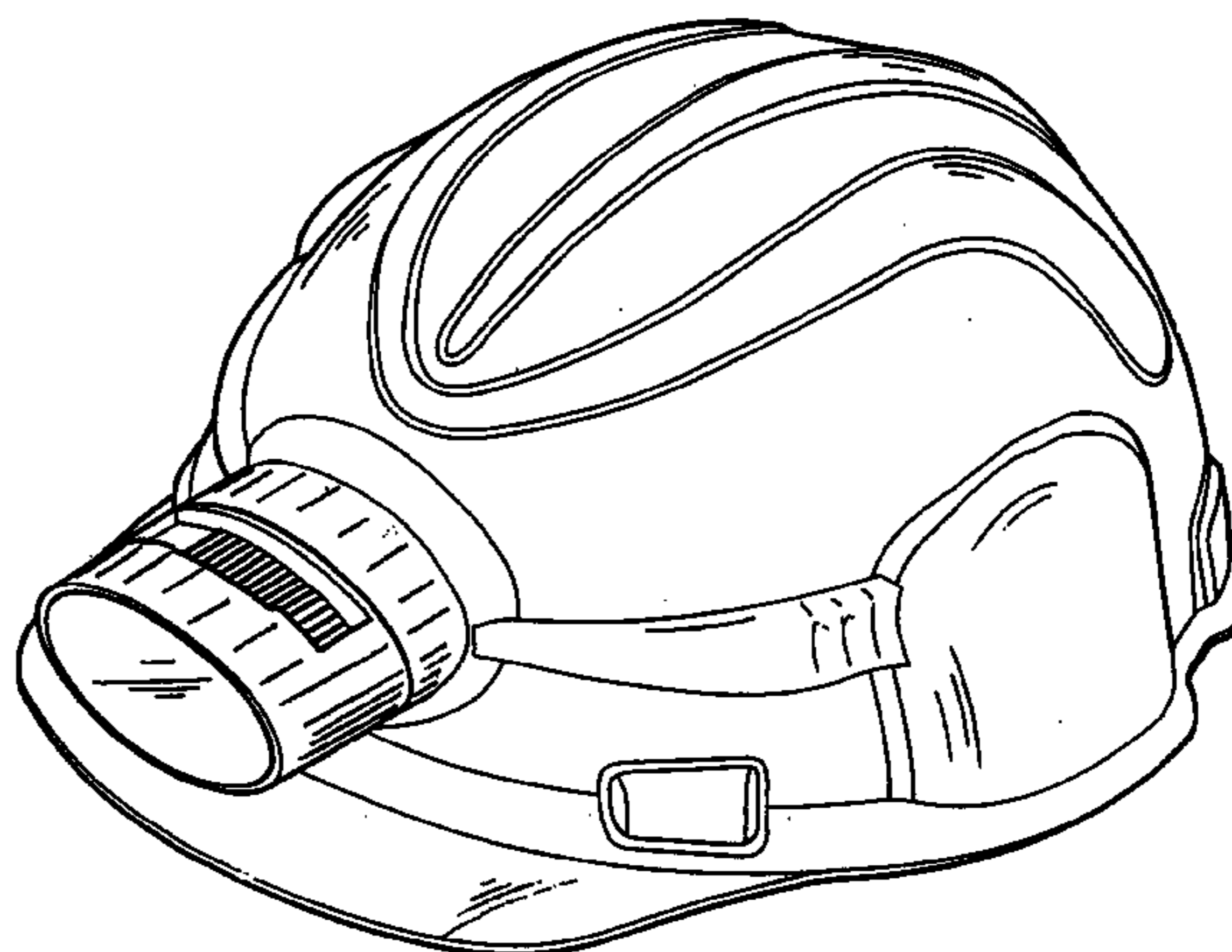
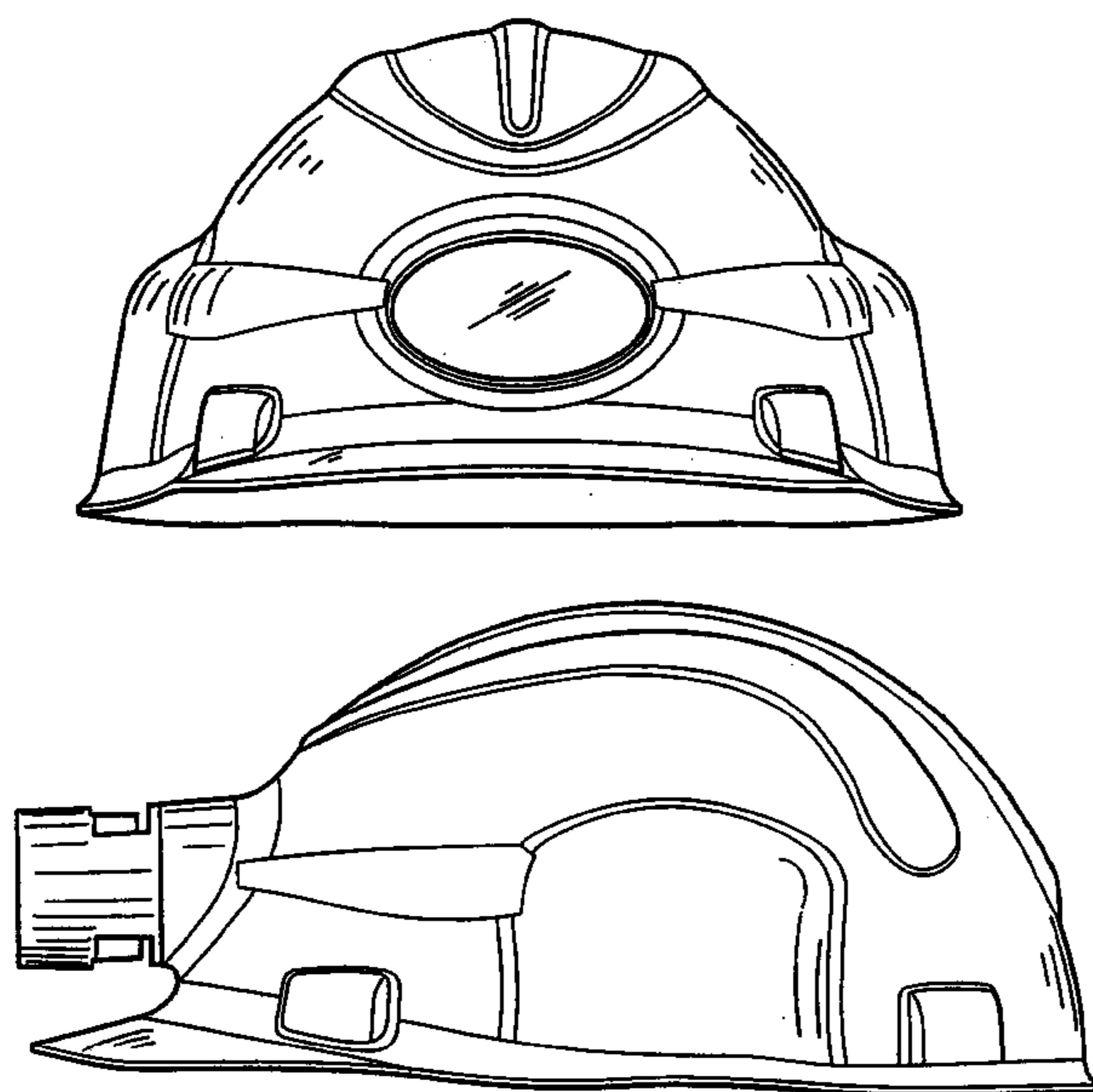
FIG. 4 is a view from another side of the helmet of FIG. 1;

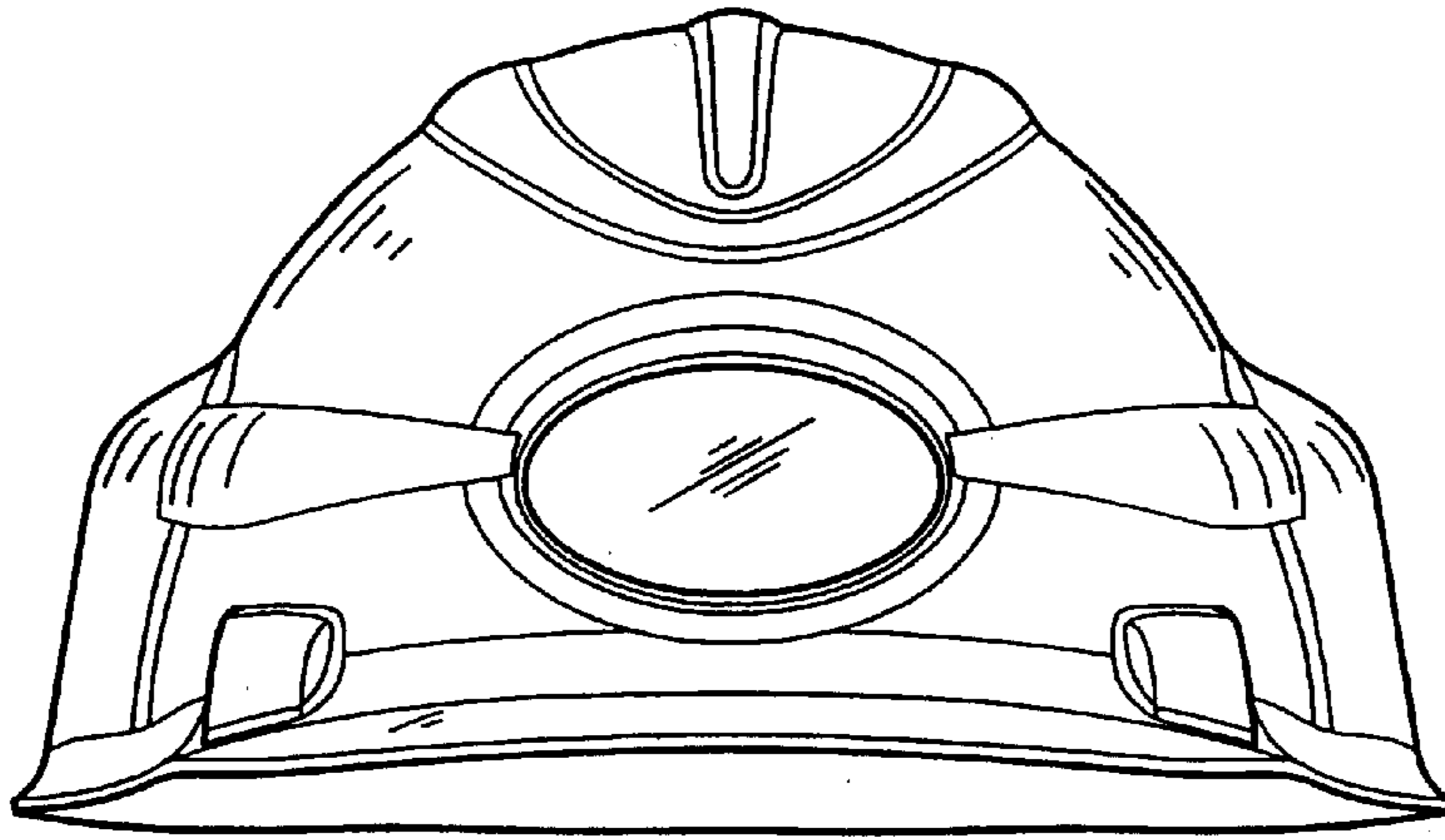

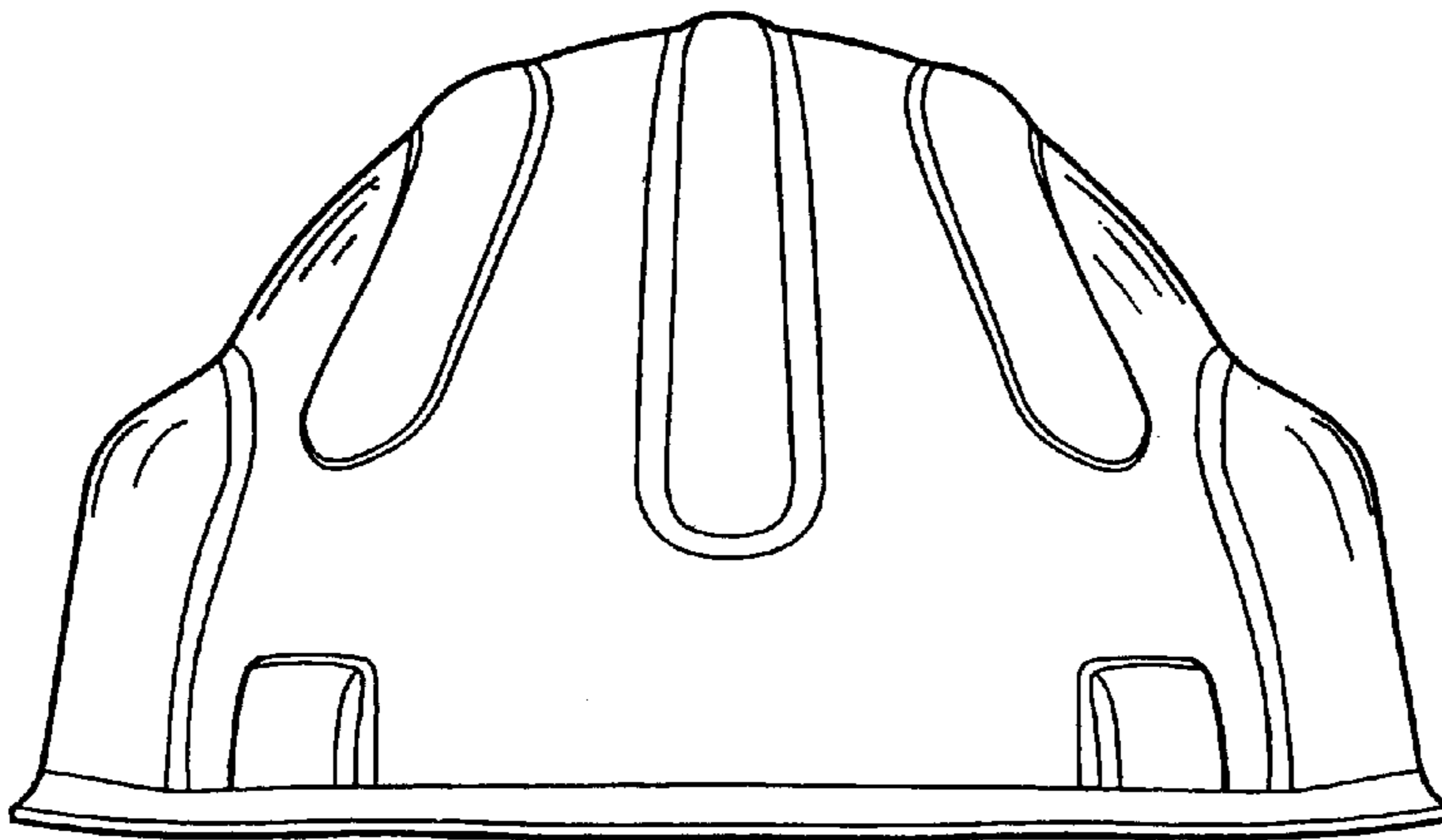

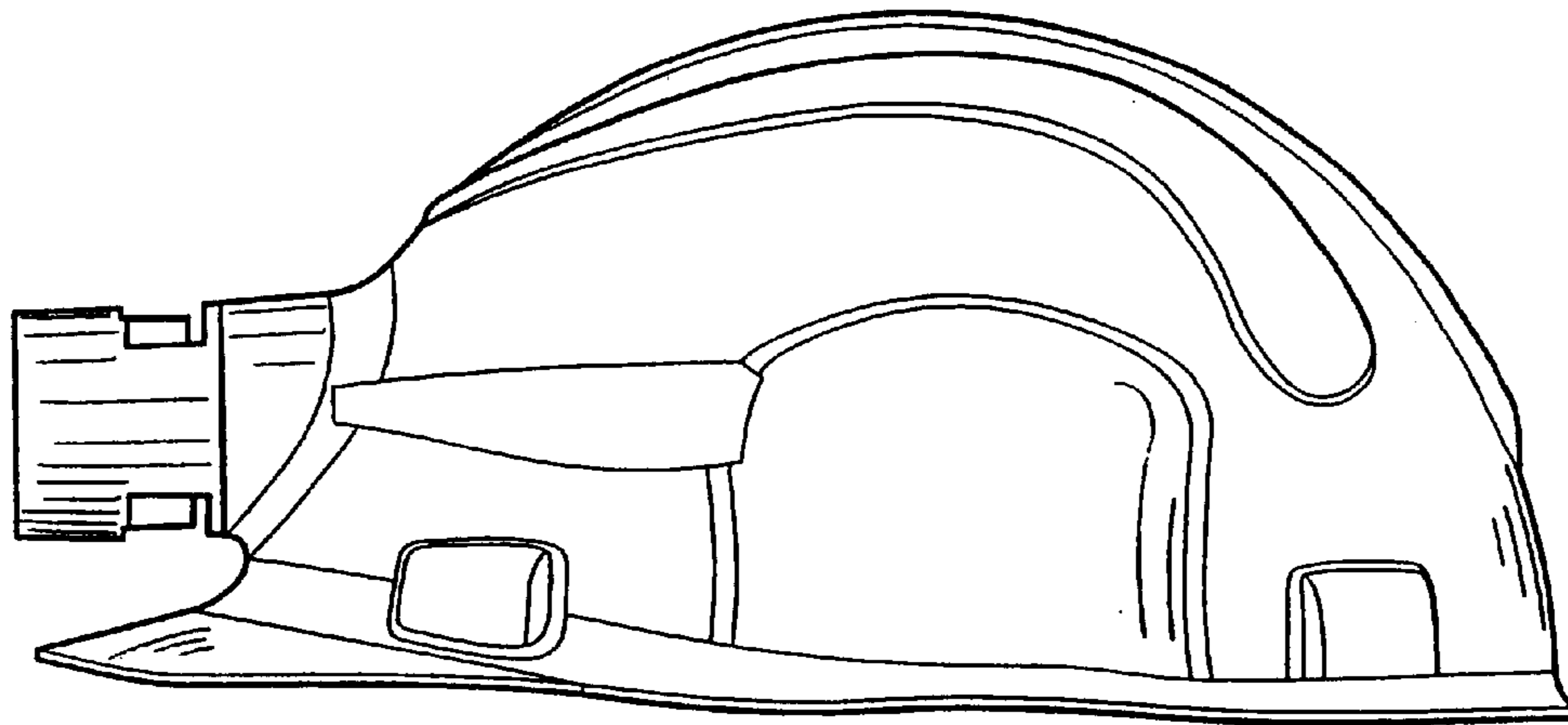

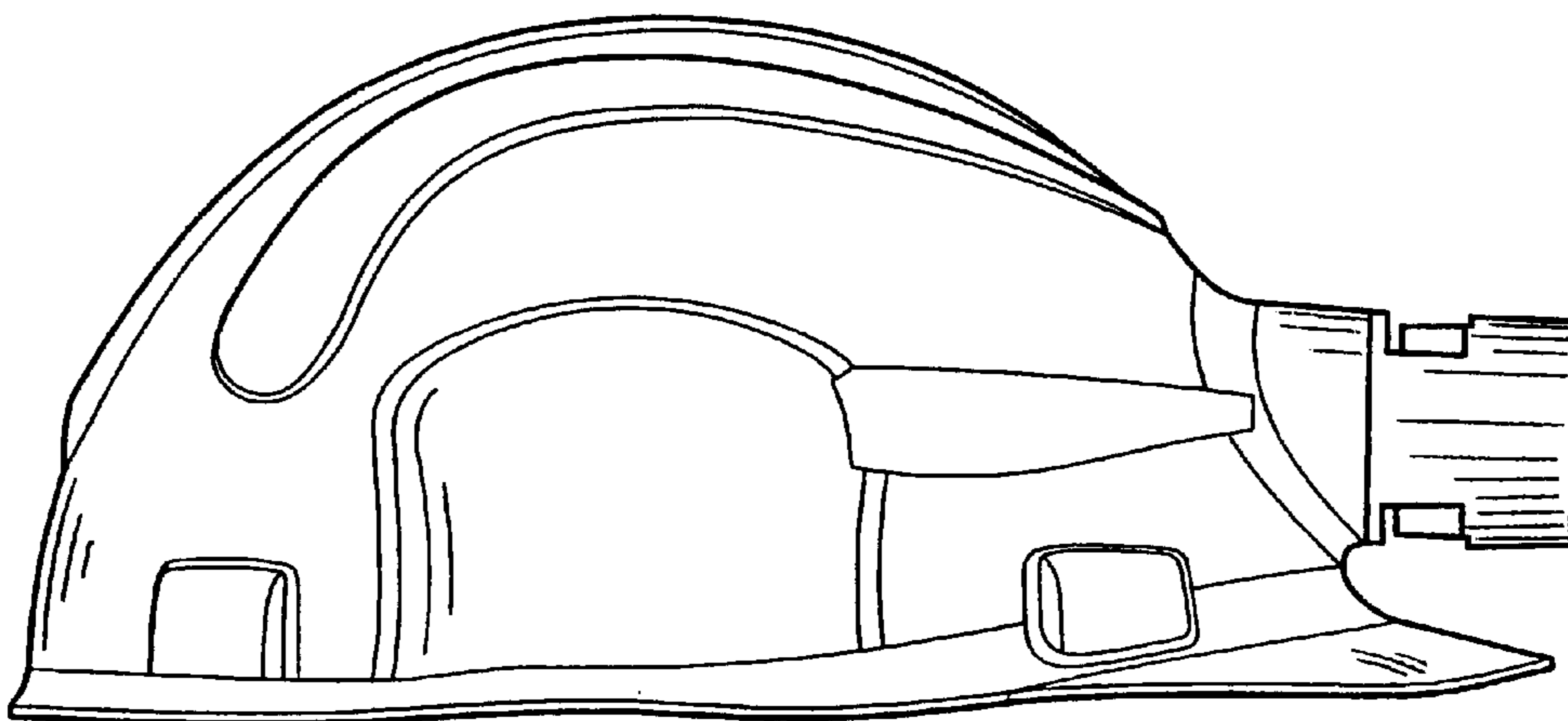

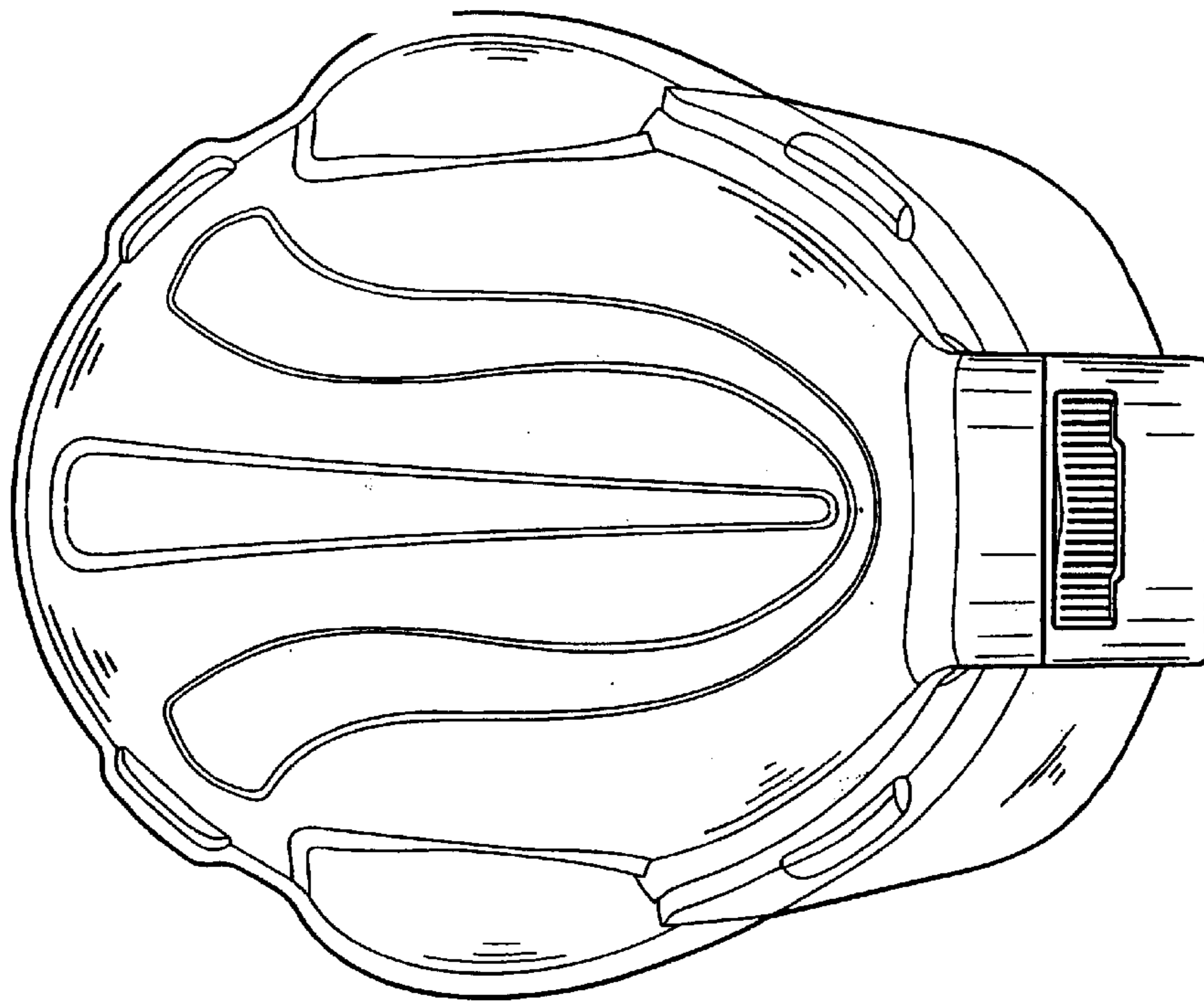

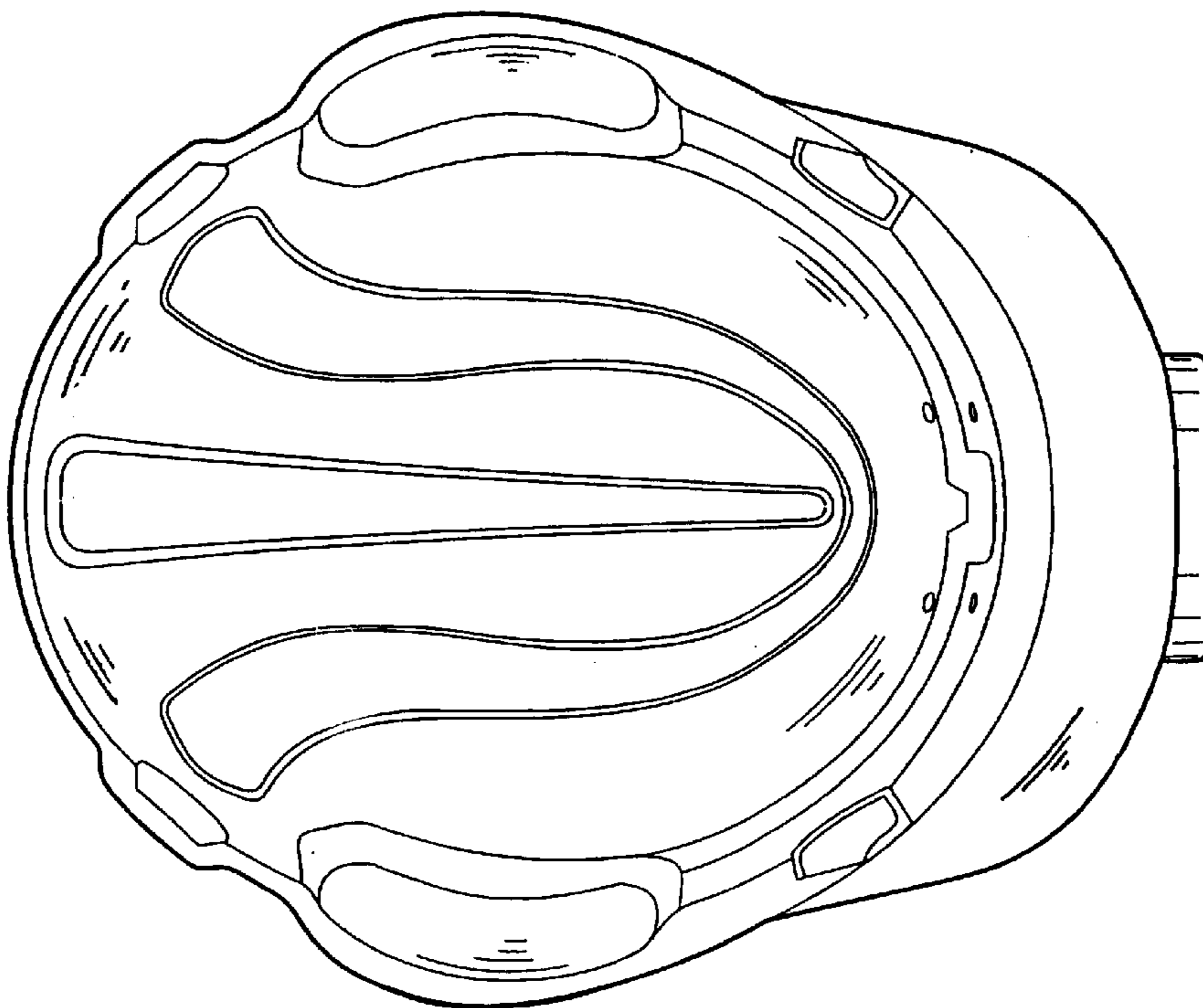

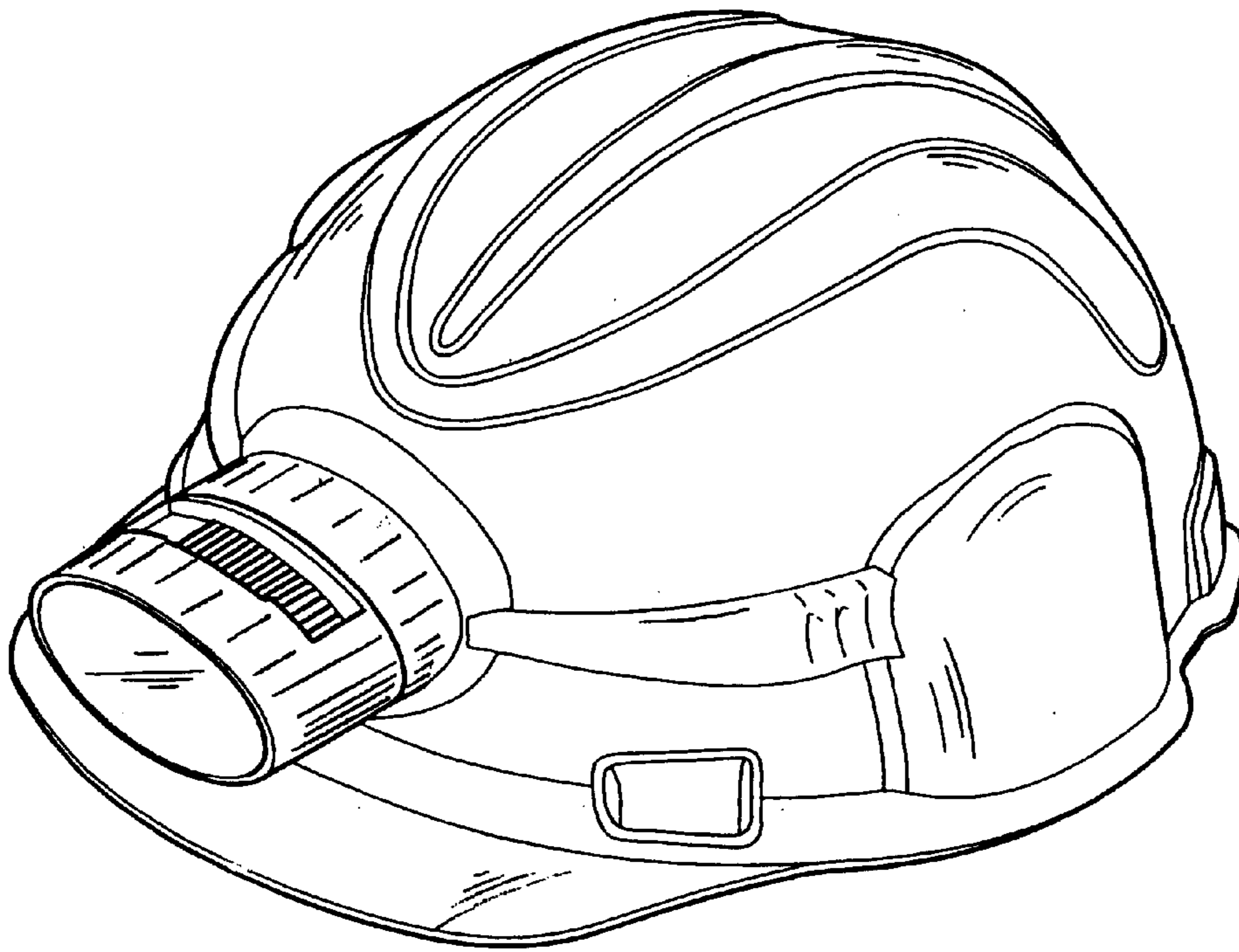
