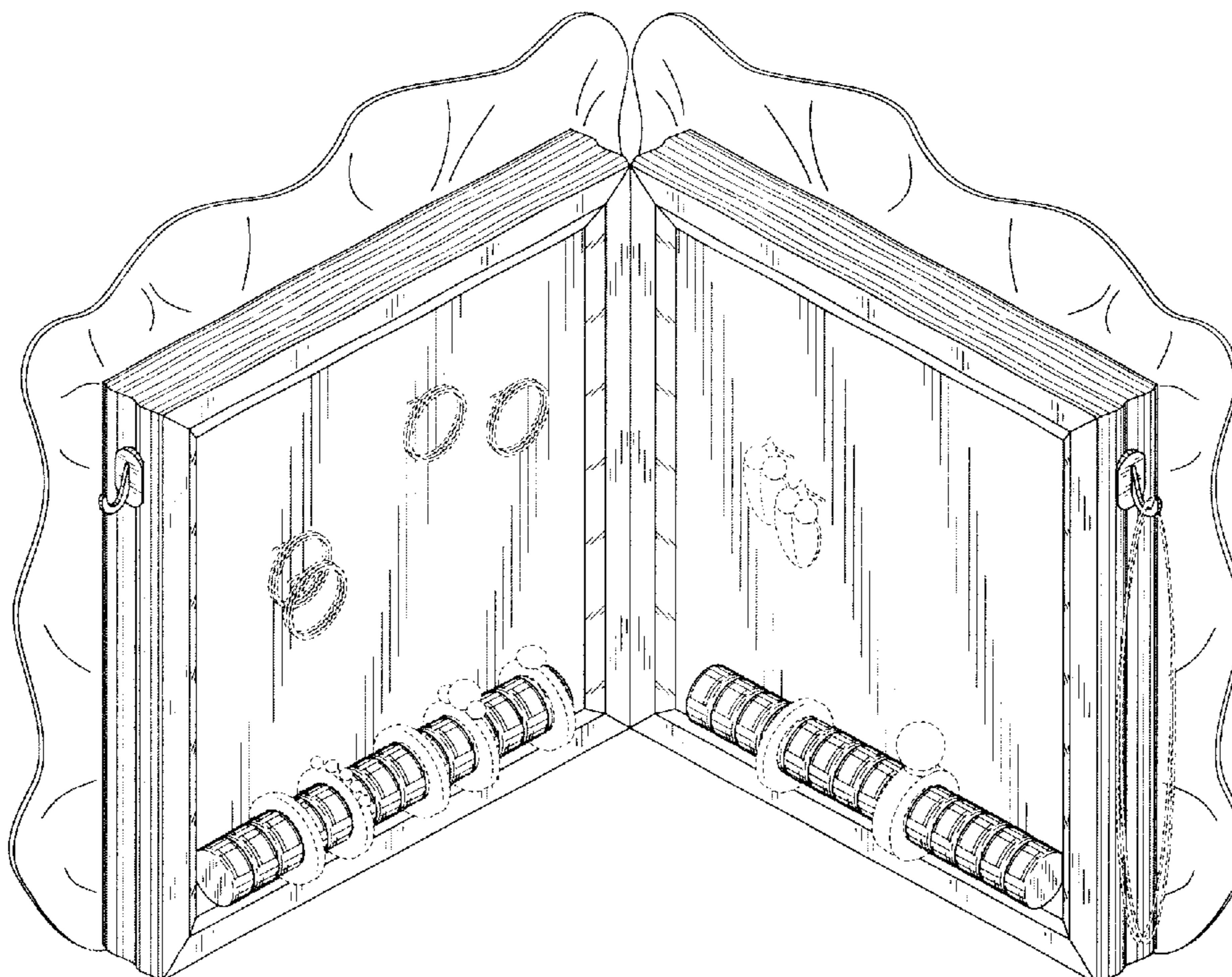
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an open jewelry book illustrating rings and earrings secured thereof; FIG. 2 is a perspective view of an open jewelry book thereof; FIG. 3 is an elevational left side view thereof; FIG. 4 is an elevational right side view thereof; FIG. 5 is an elevational back view thereof; FIG. 6 is an elevational front view thereof; FIG. 7 is an elevational top view thereof; and, FIG. 8 is an elevational bottom view thereof.

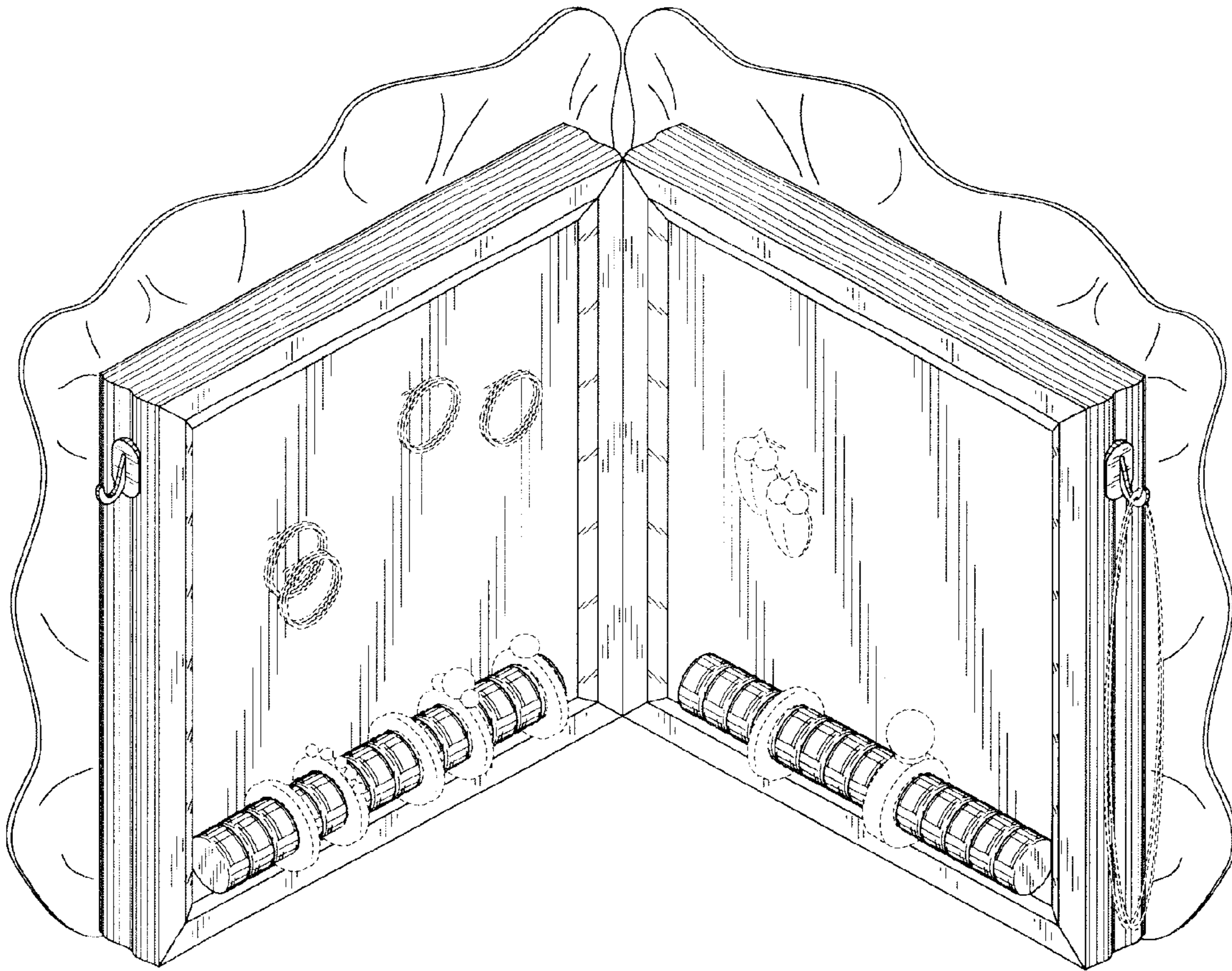

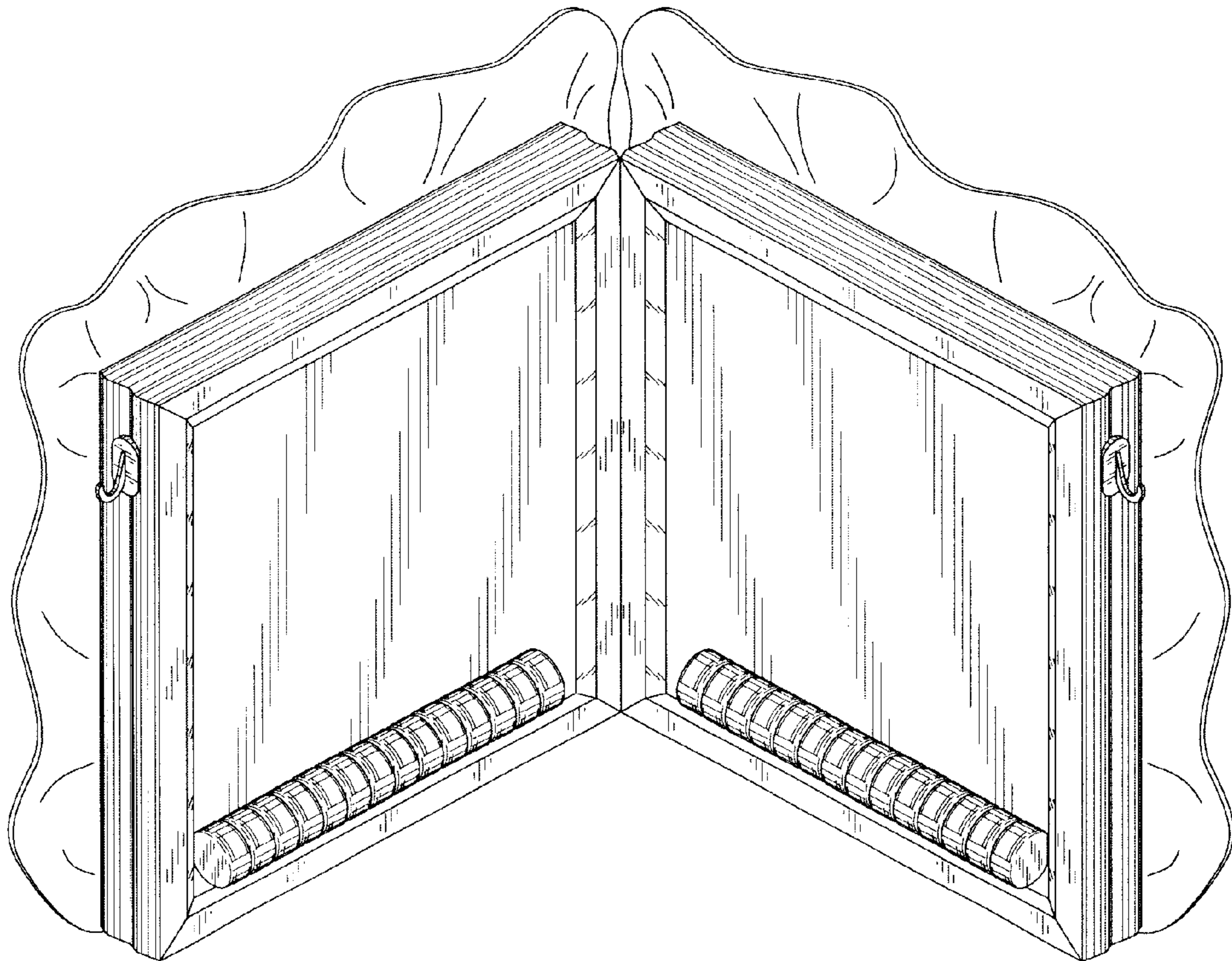

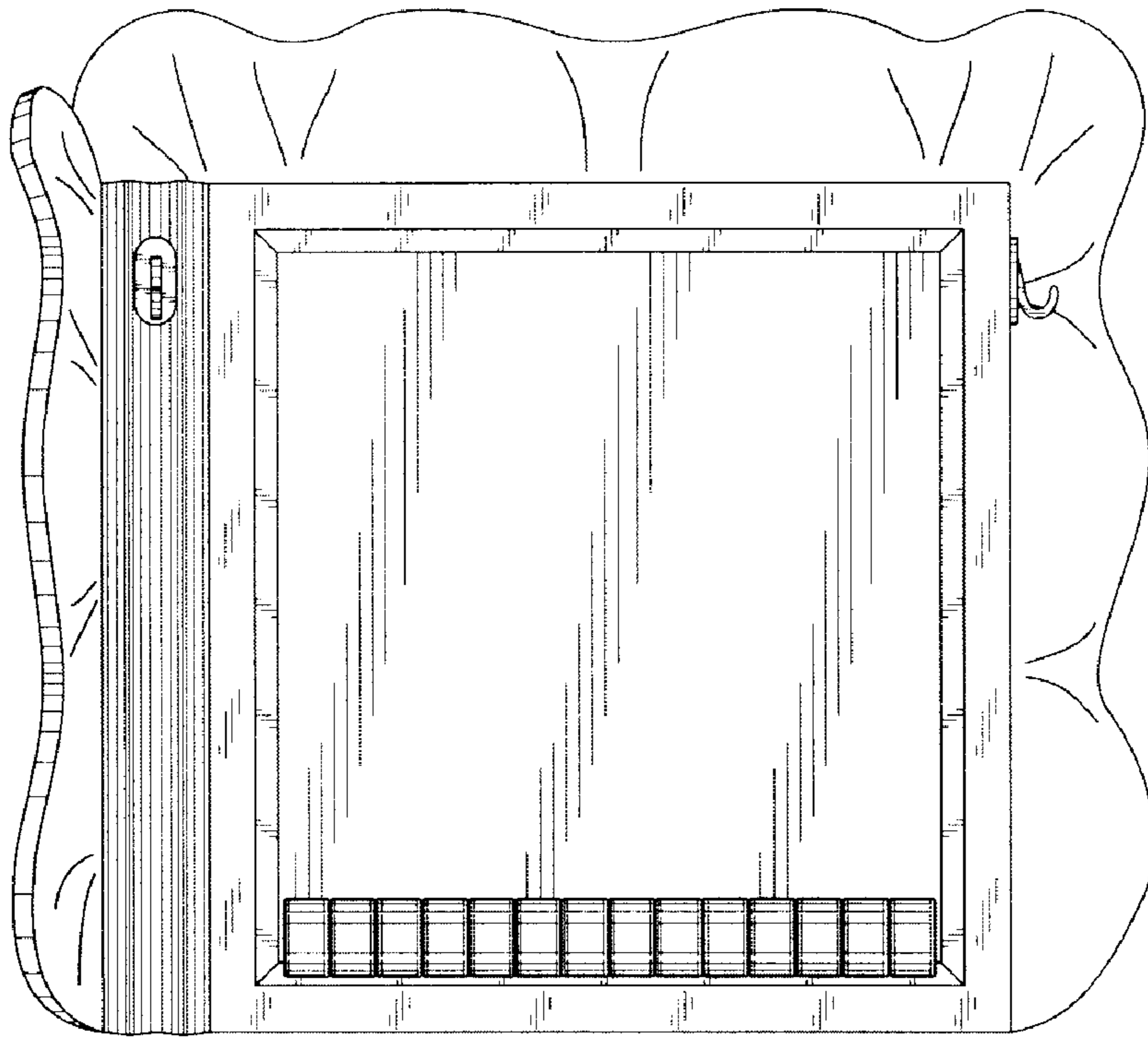

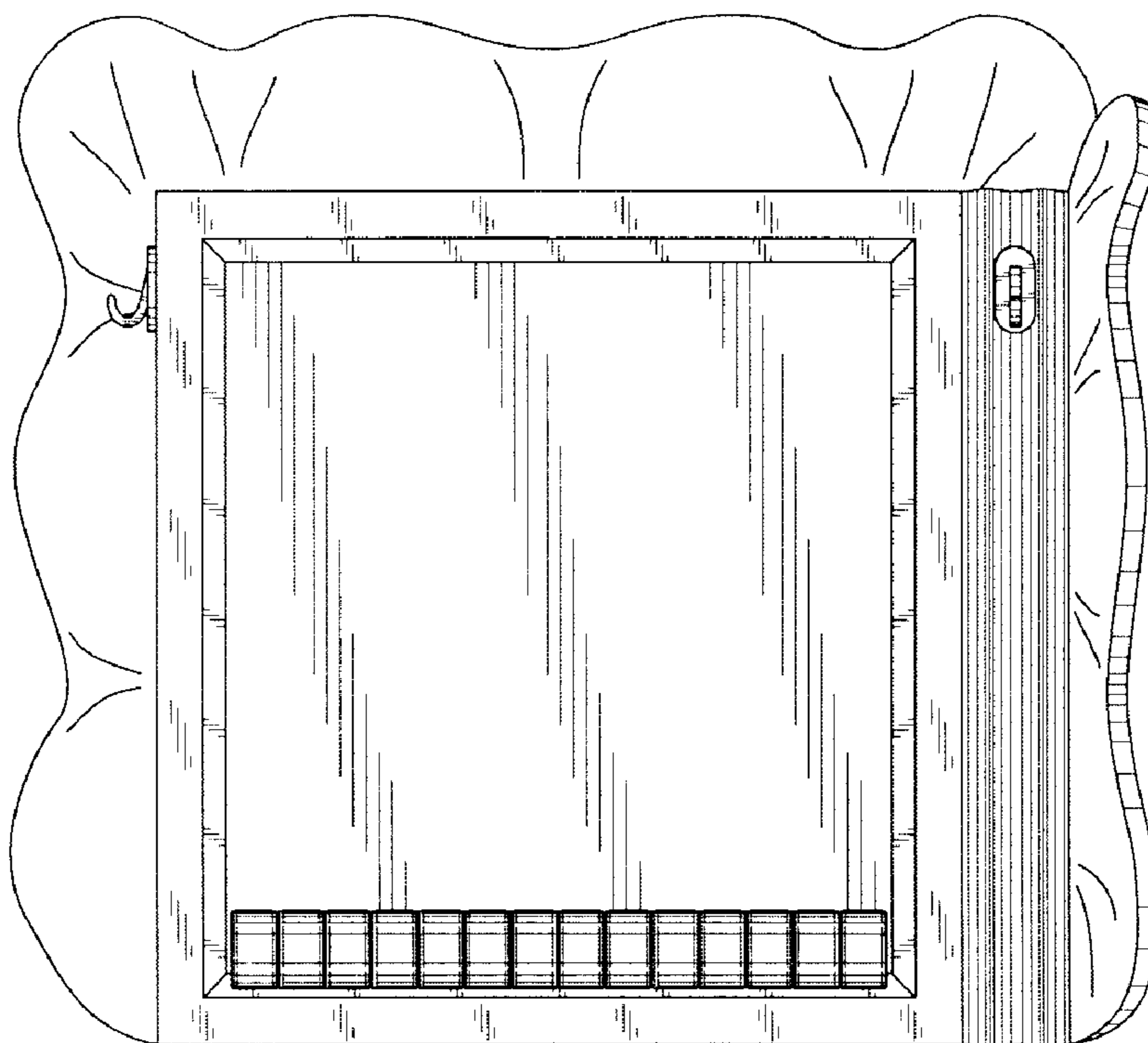

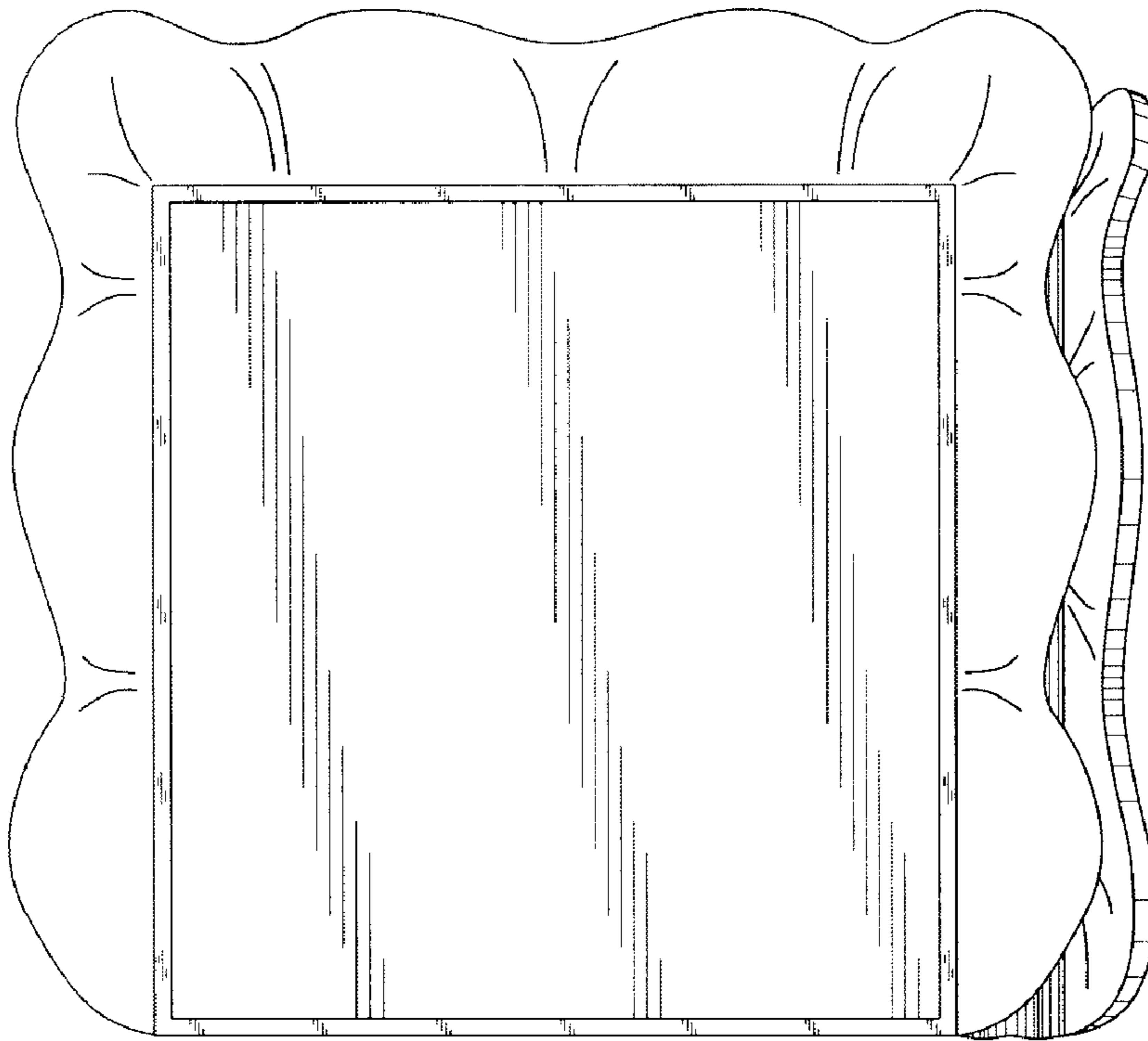

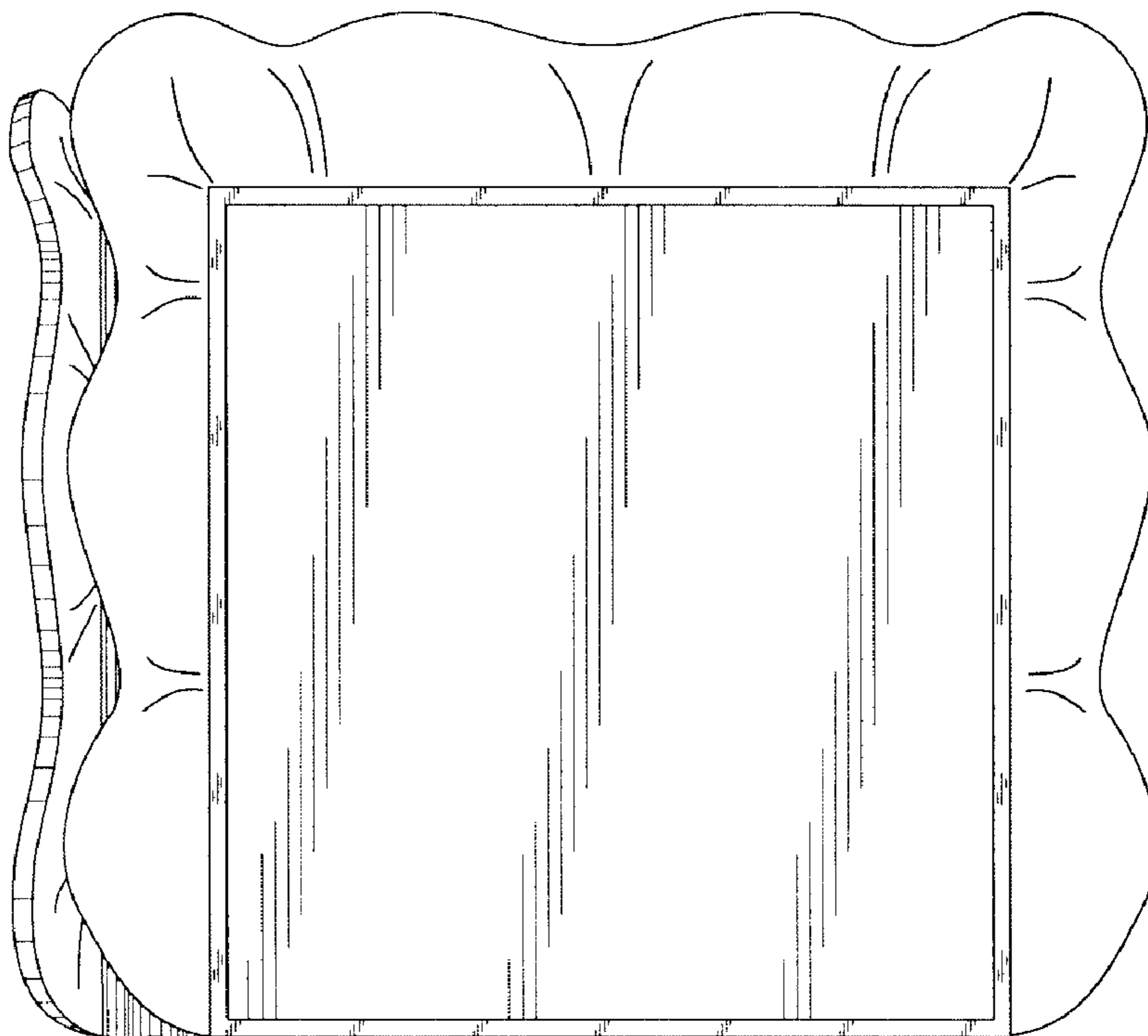

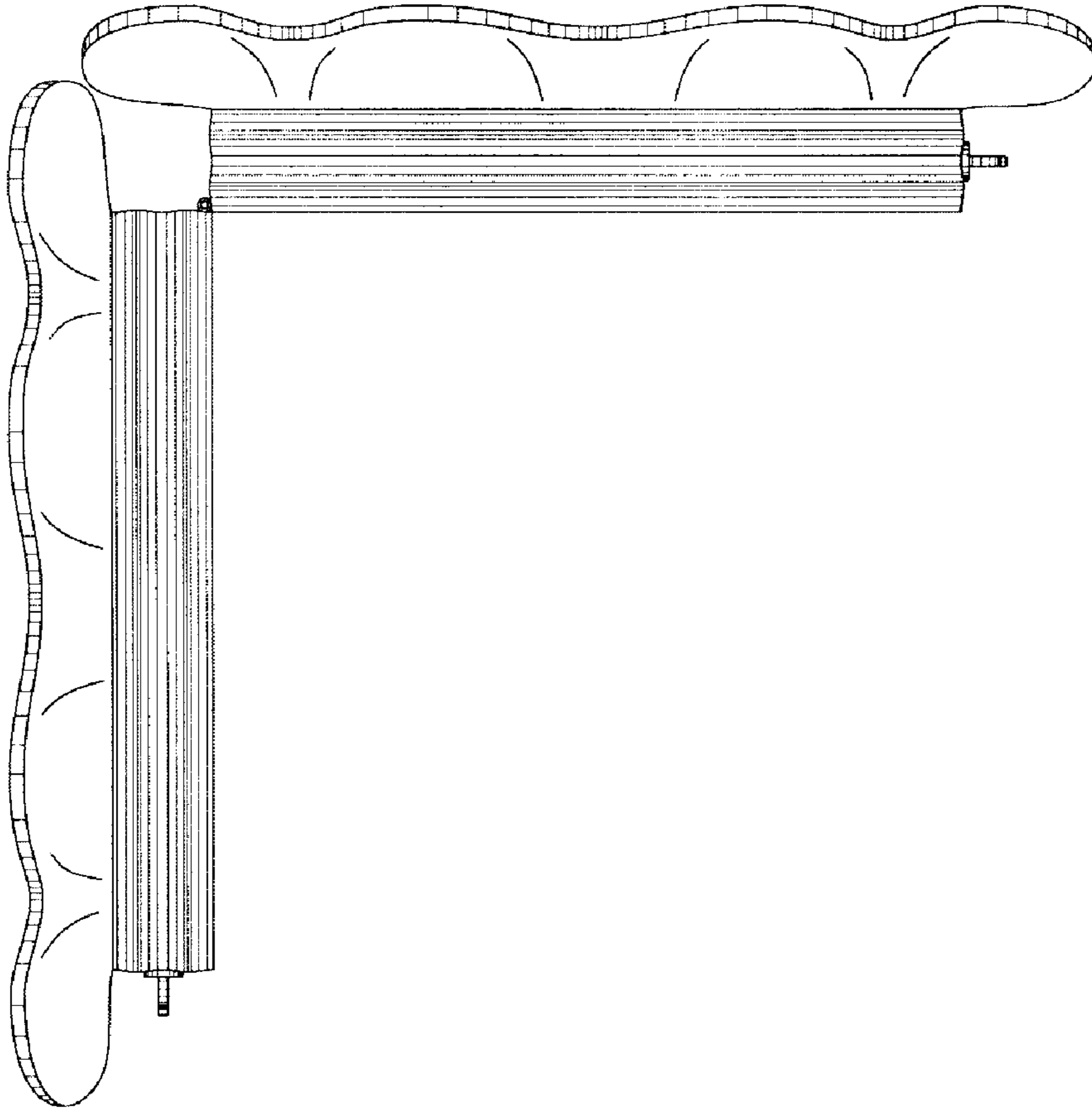

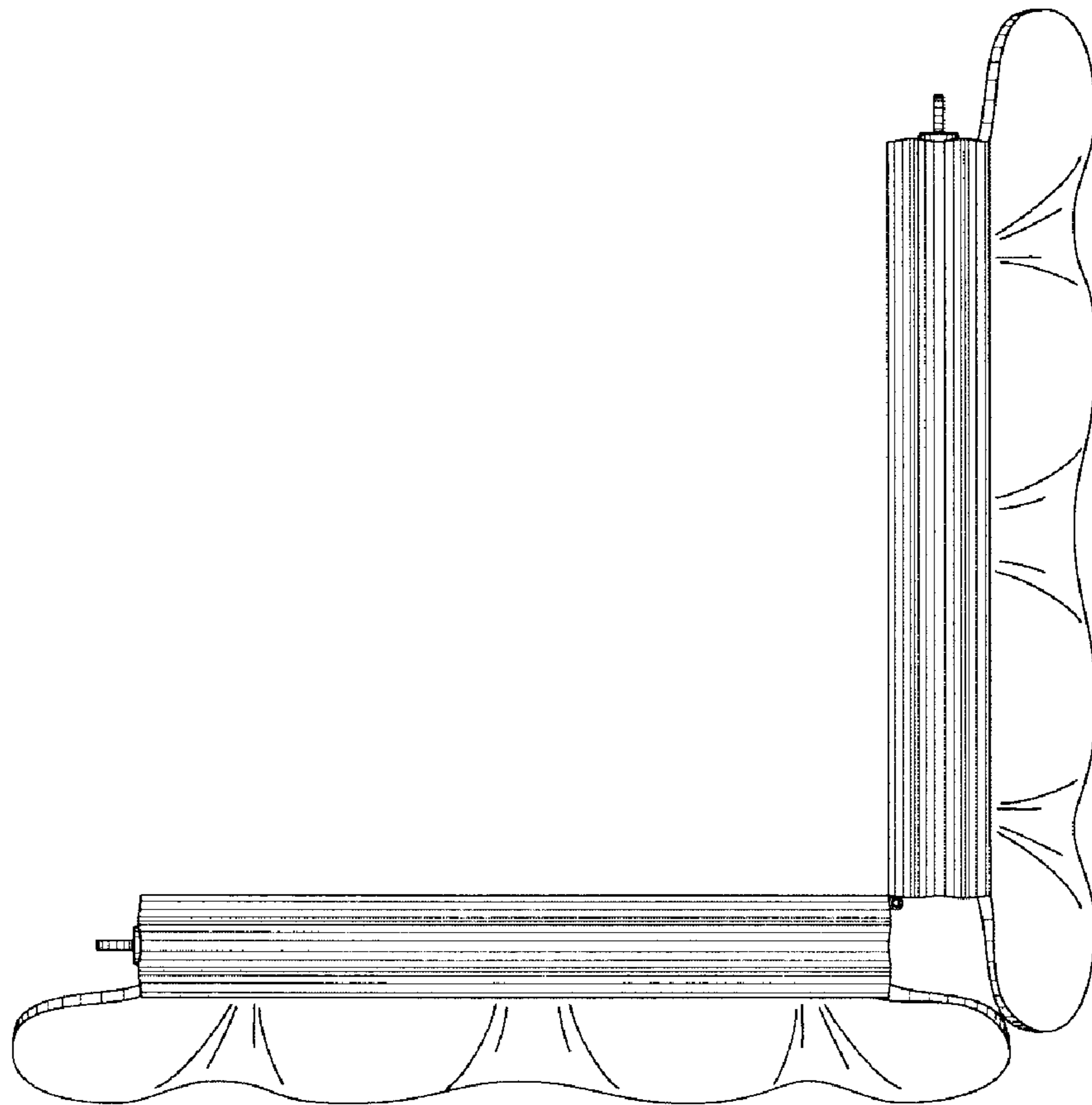
