FIG. 1 is a perspective view of a chair in accordance with the new design;

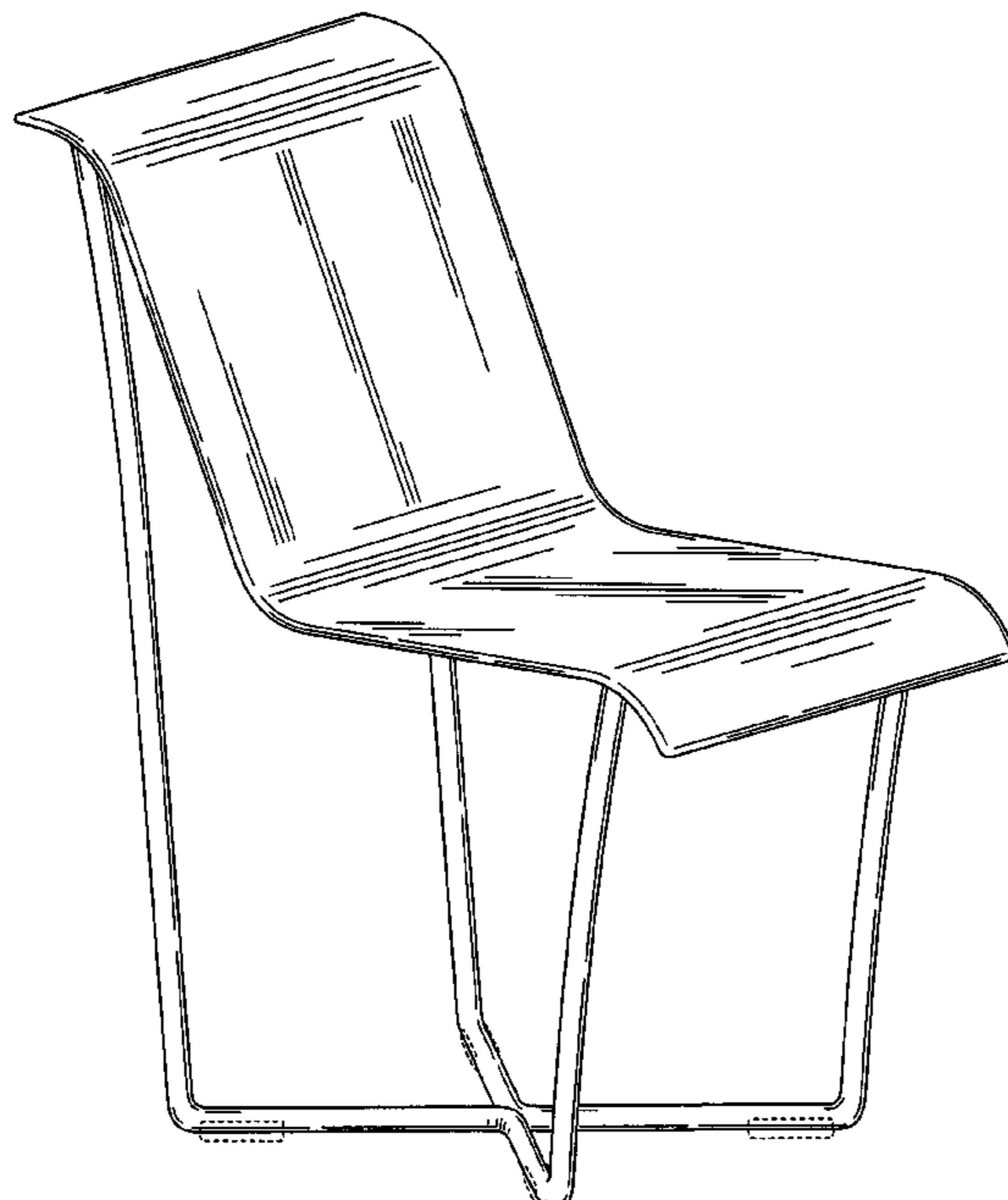
FIG. 2 is a top view thereof;

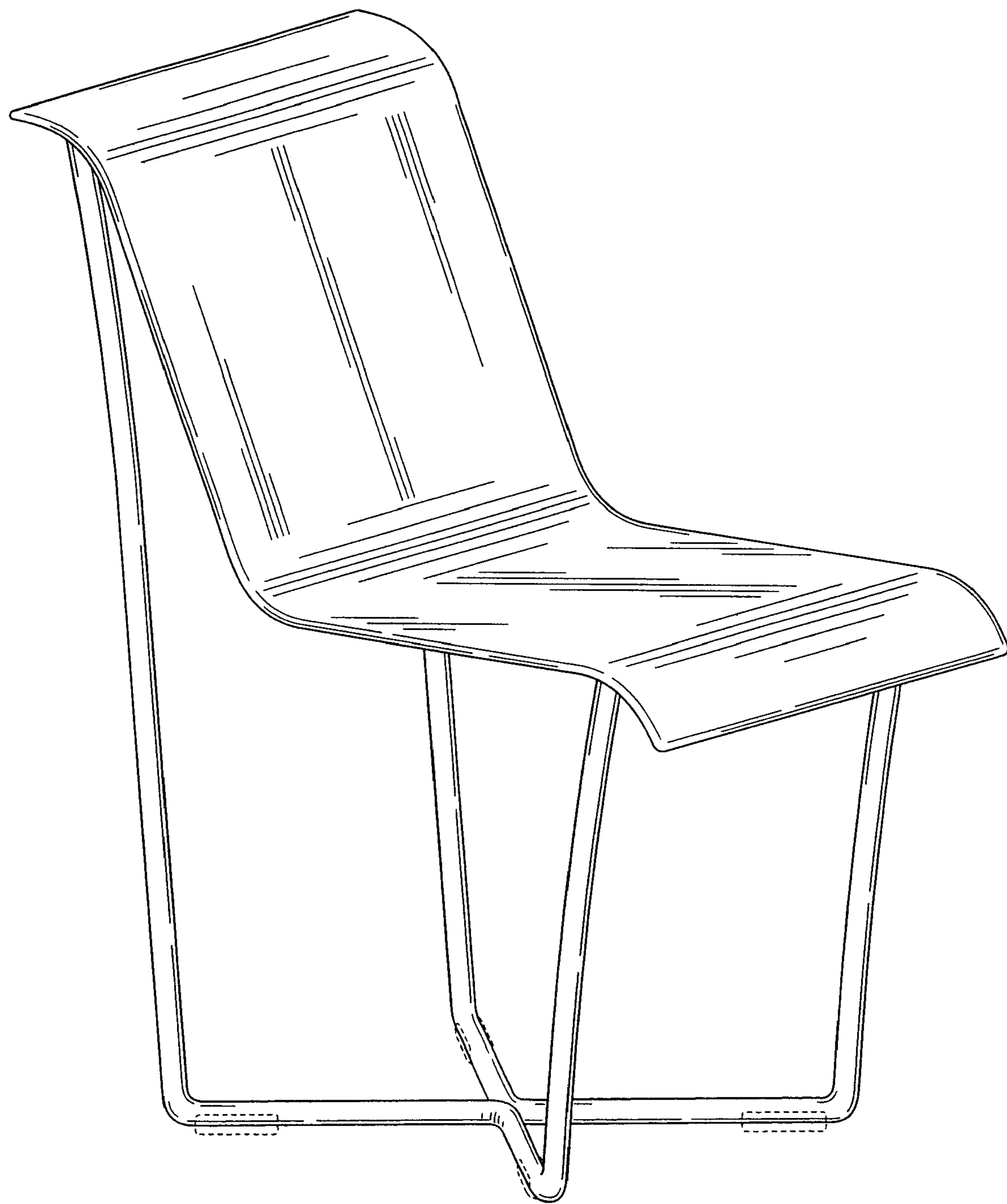
FIG. 3 is a front elevational view thereof;

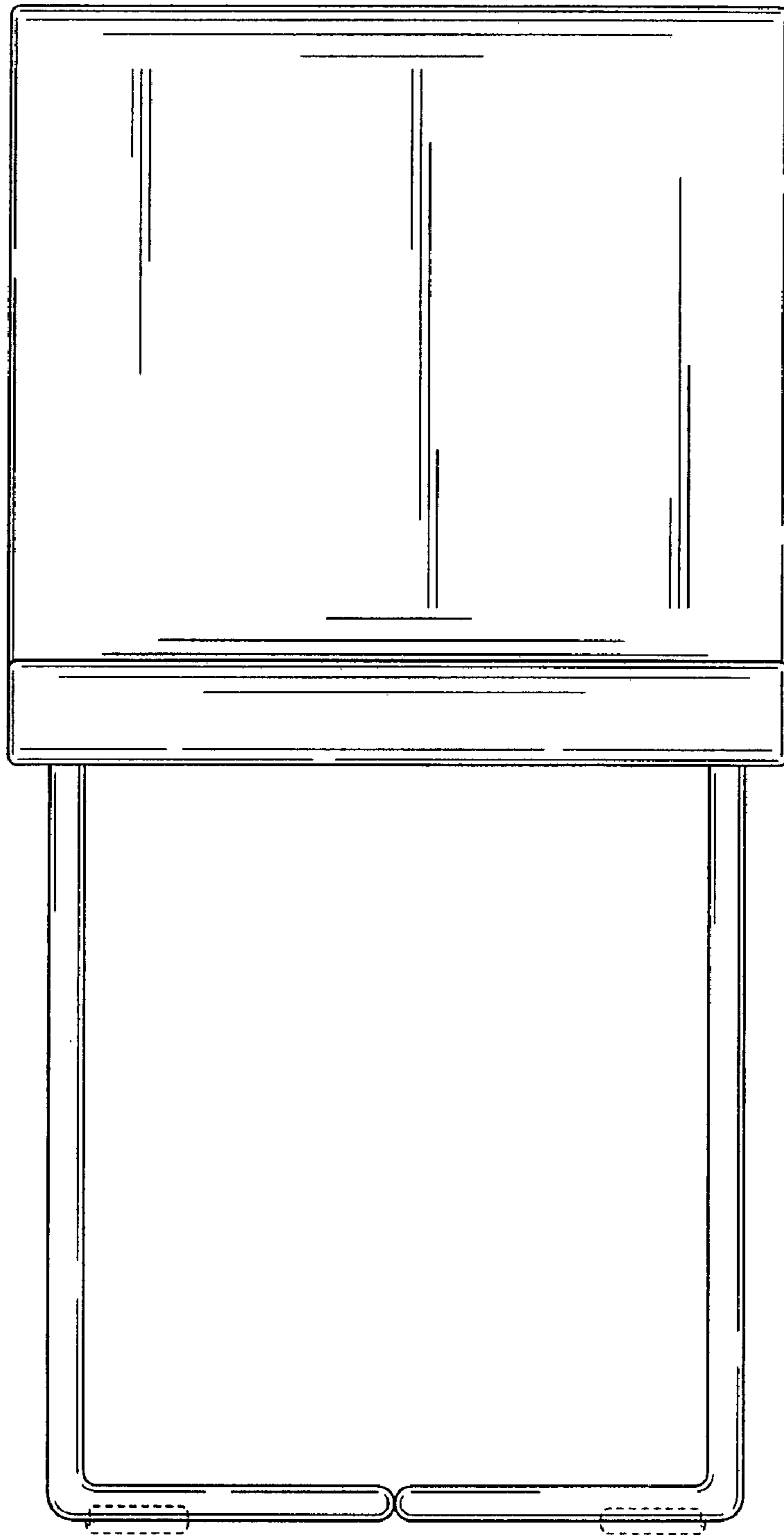




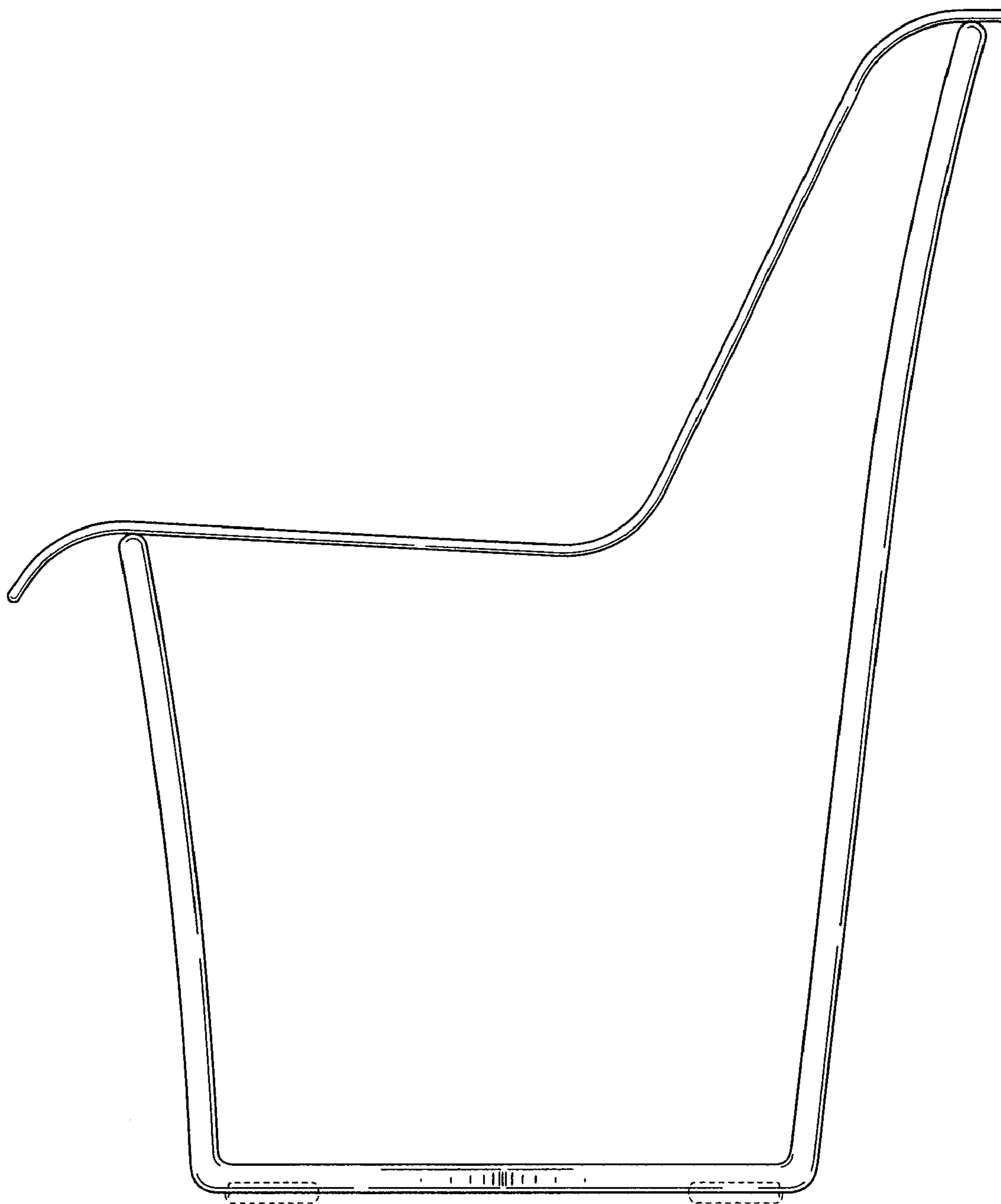

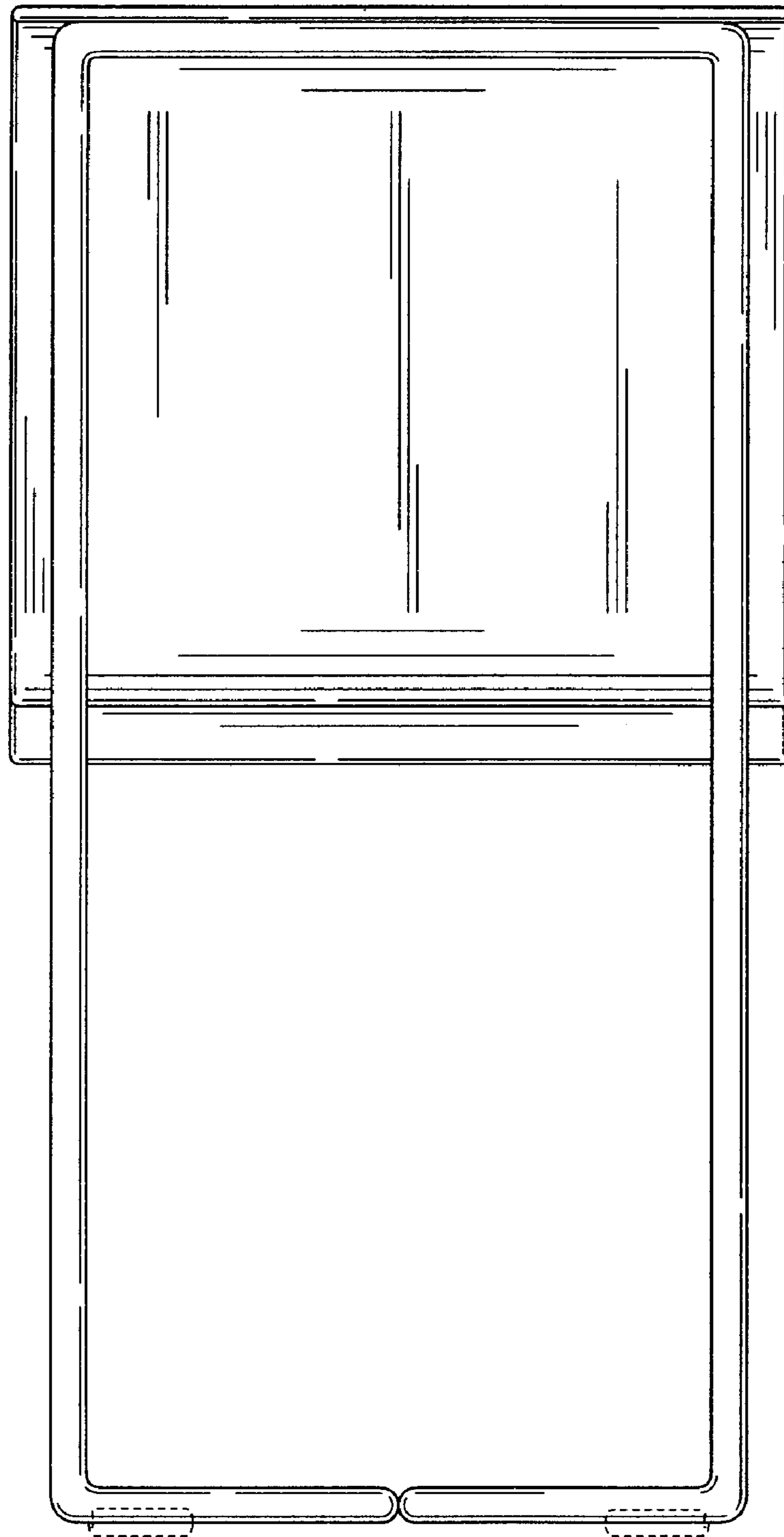
