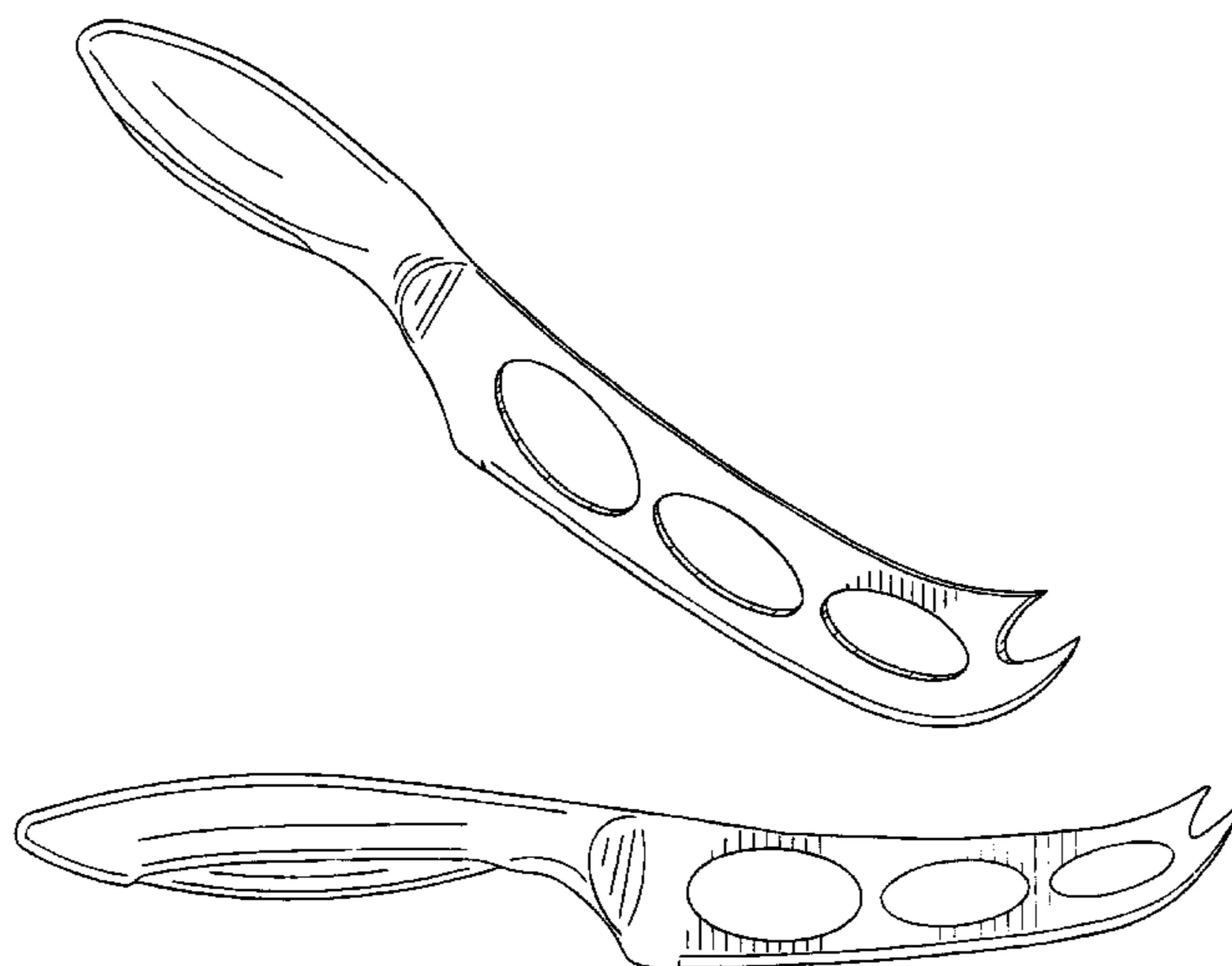

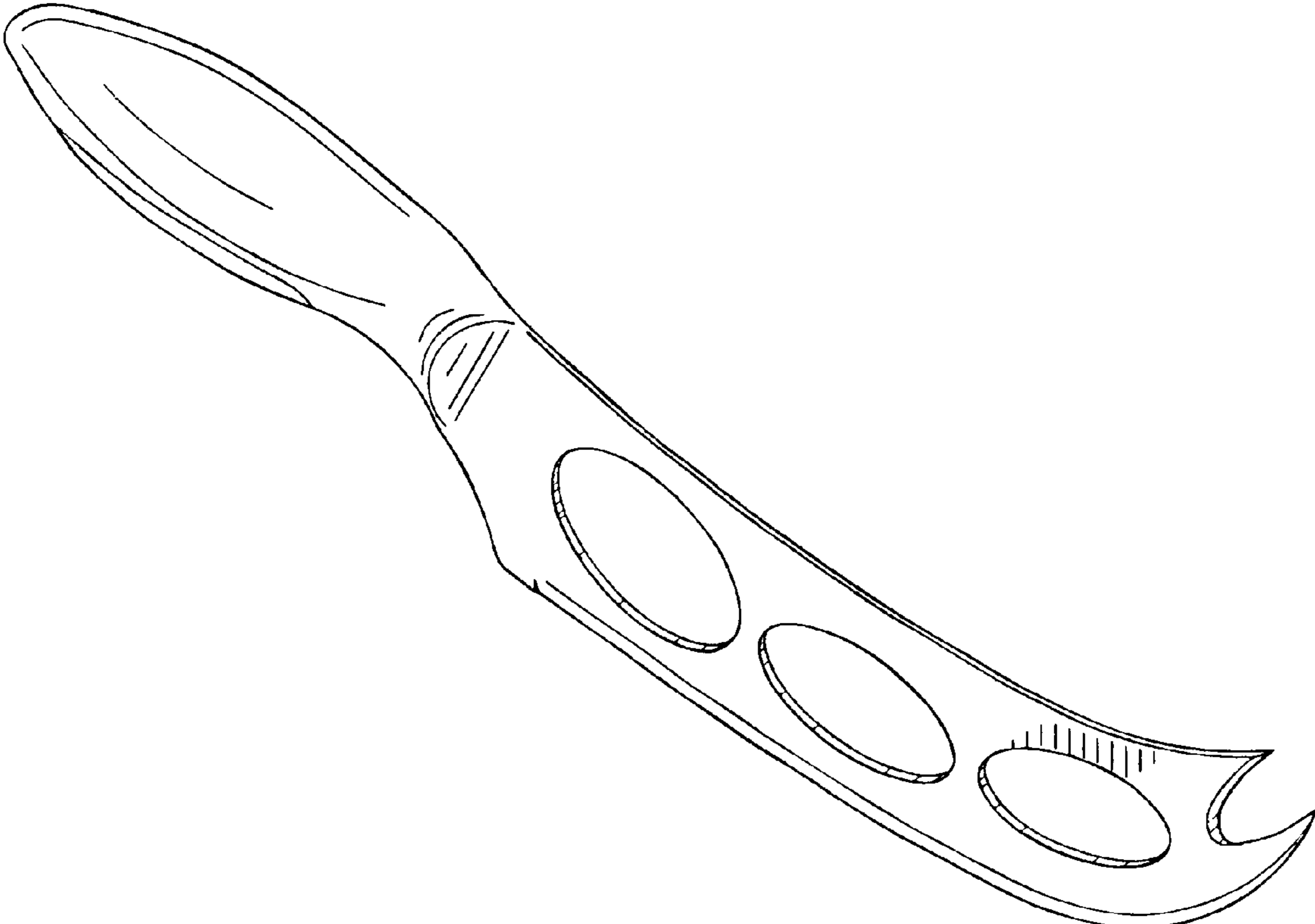
The ornamental design for a knife, as shown.

**DESCRIPTION**

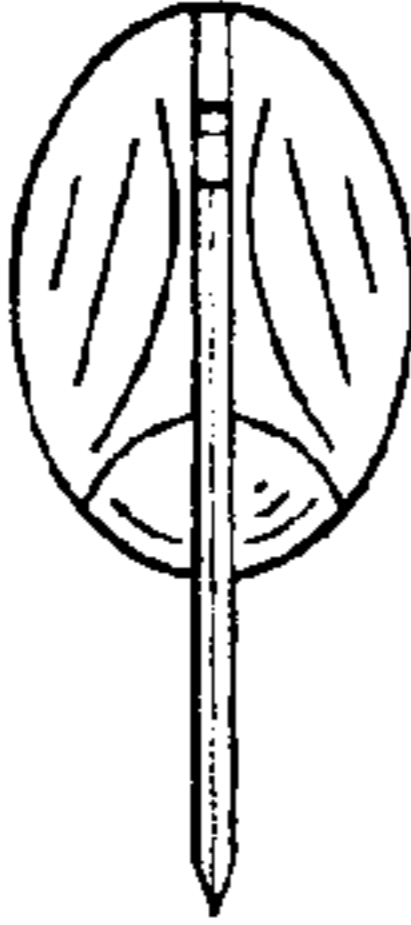

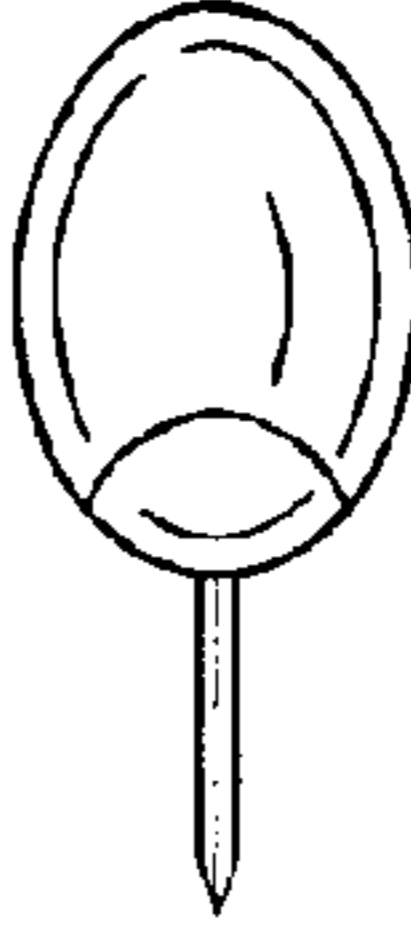




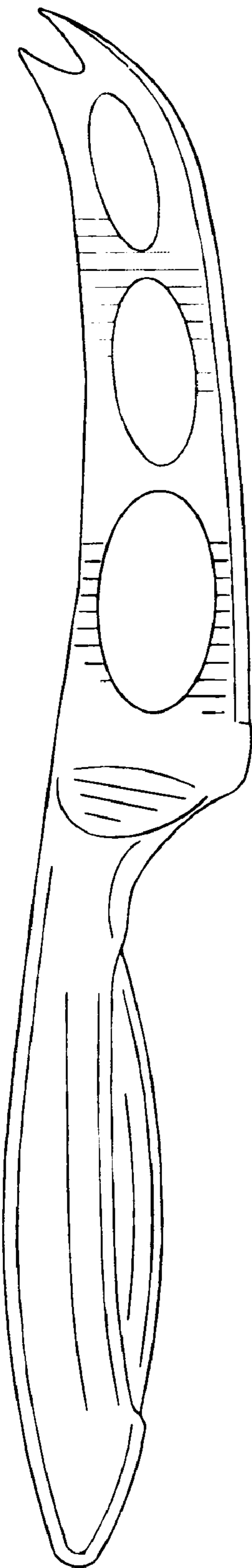

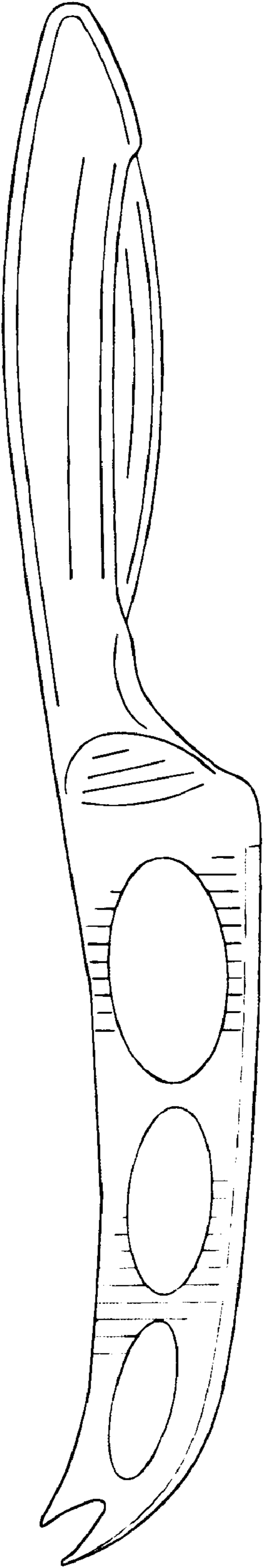

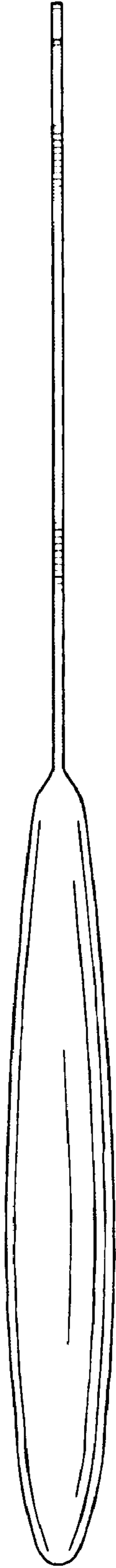

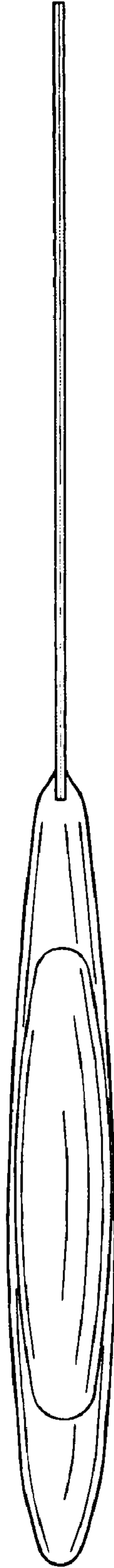
