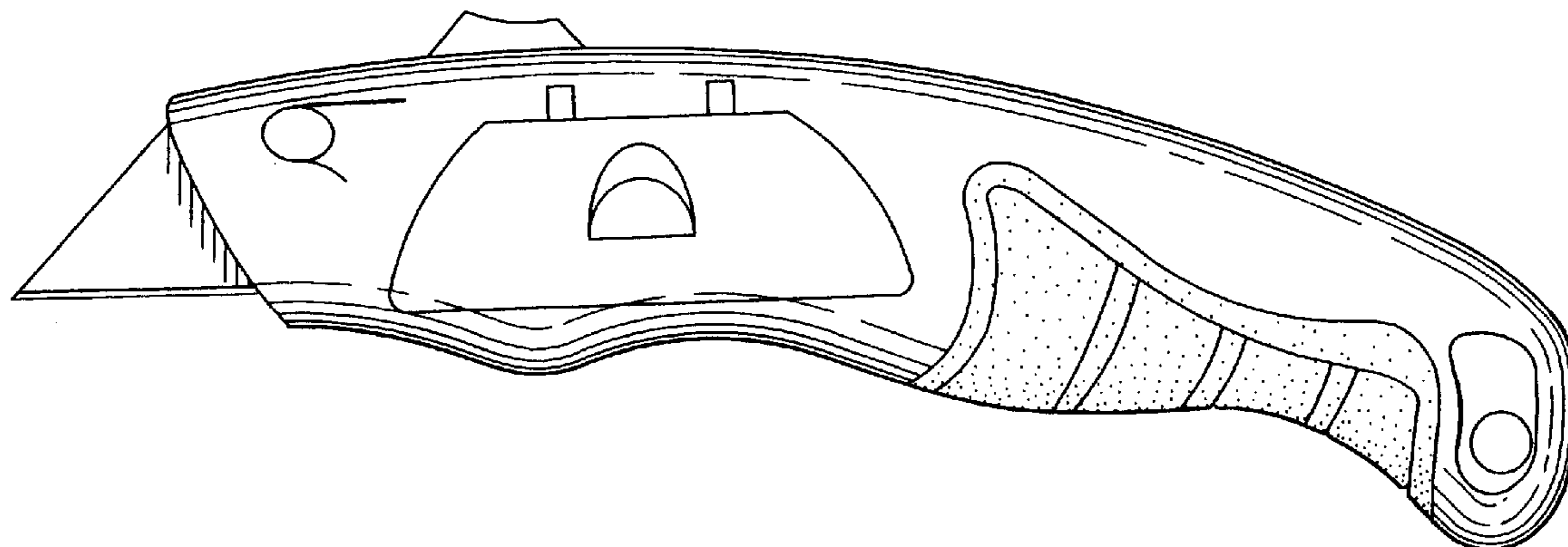

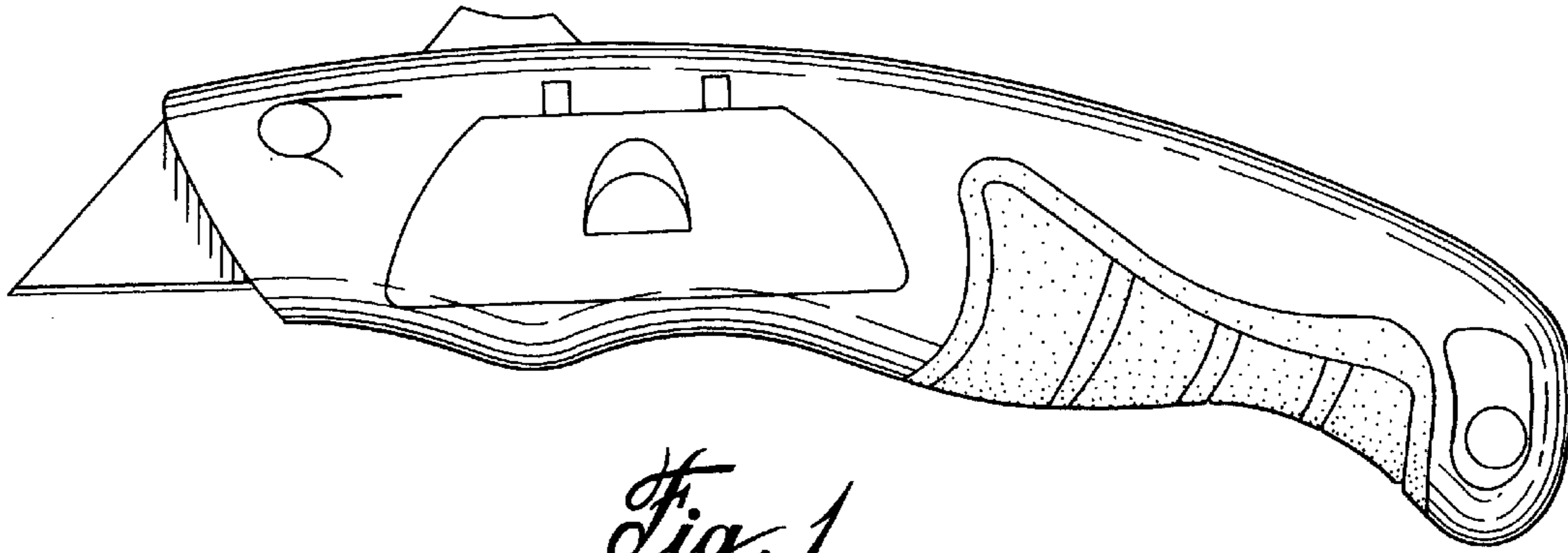
The ornamental design for a utility knife, as shown and described.

**DESCRIPTION**

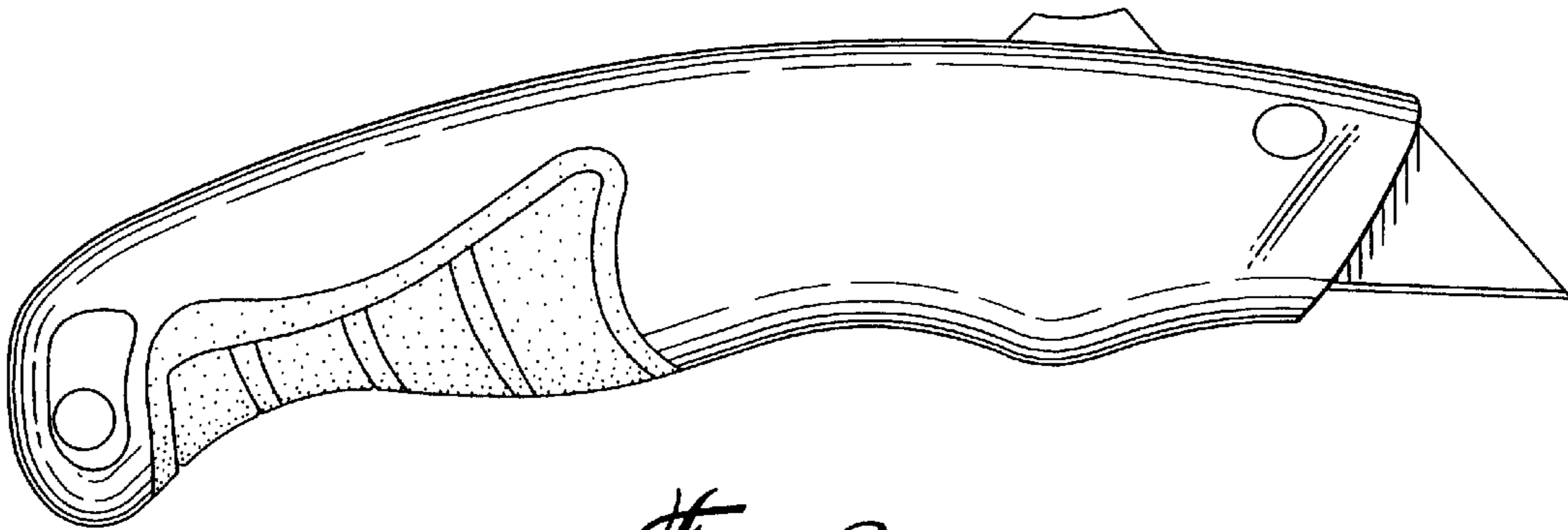
FIG. 1 is a right side view of the utility knife;

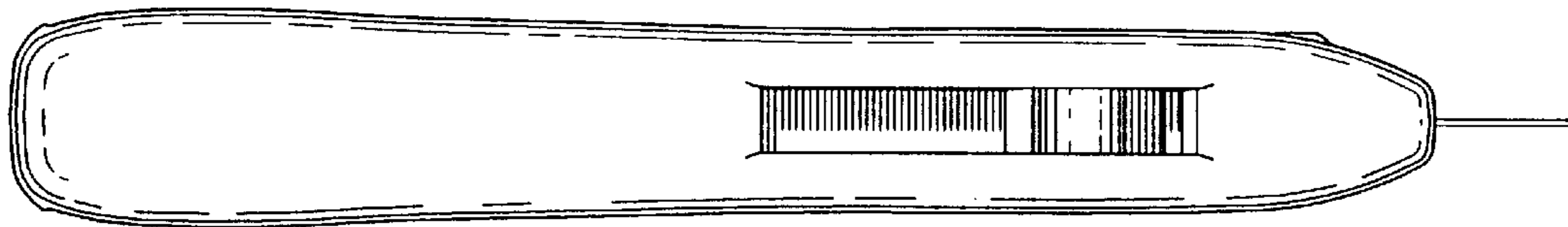




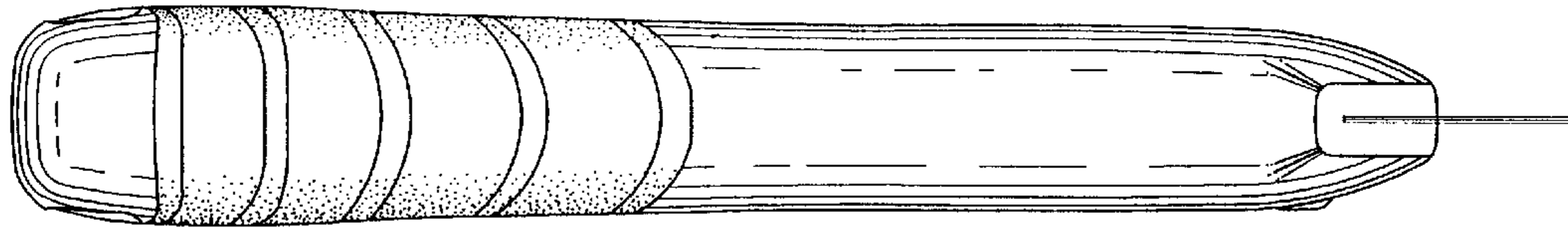

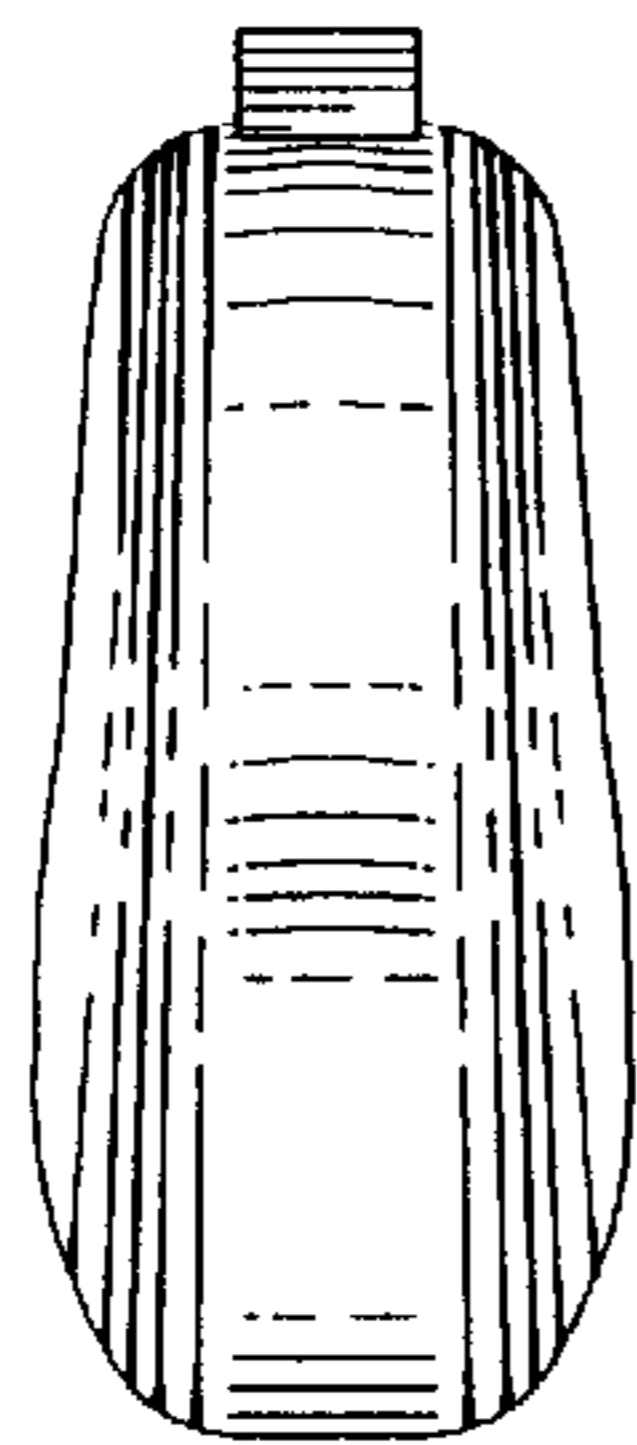

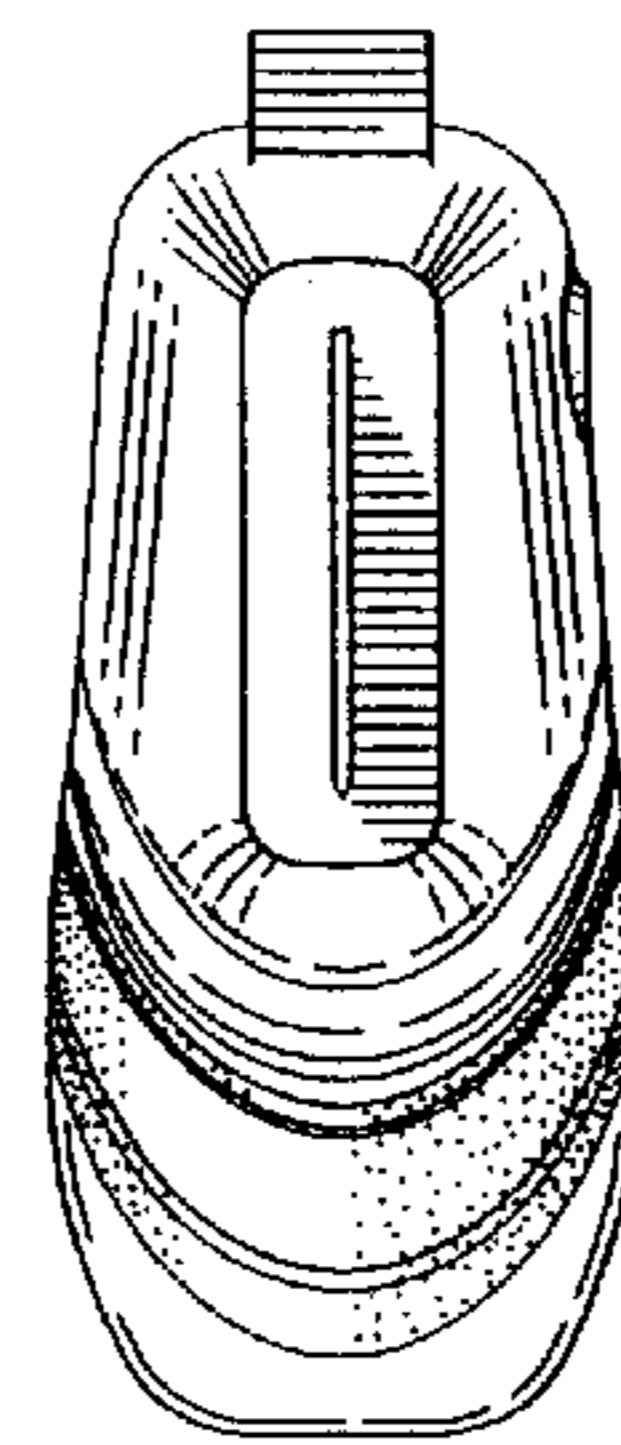
