(57) **CLAIM**

We claim the ornamental design for an hinged protective cover with resilient receiving pads for padlock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an hinged protective cover with resilient receiving pads for padlock showing our new design;

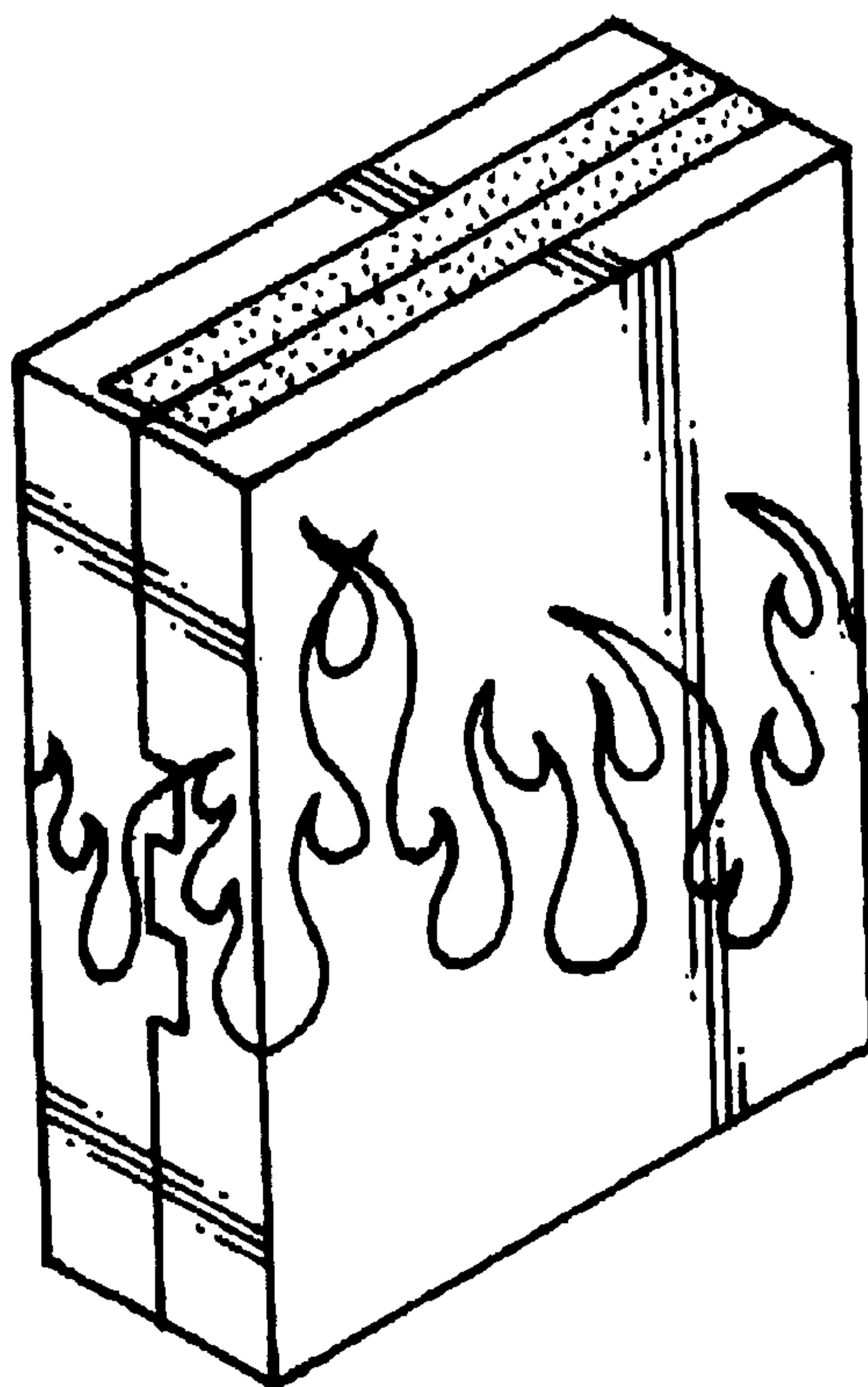
FIG. 2 is a front elevational view thereof, the rear elevational view being identical thereto; the broken lines depict environmental structure for illustrative purposes only and form no part of the claimed design;

FIG. 3 is a side elevational view thereof, the bottom plan view being substantially identical thereto;

FIG. 4 is an elevational view of the opposing side thereof; and,

FIG. 5 is a top plan view thereof.

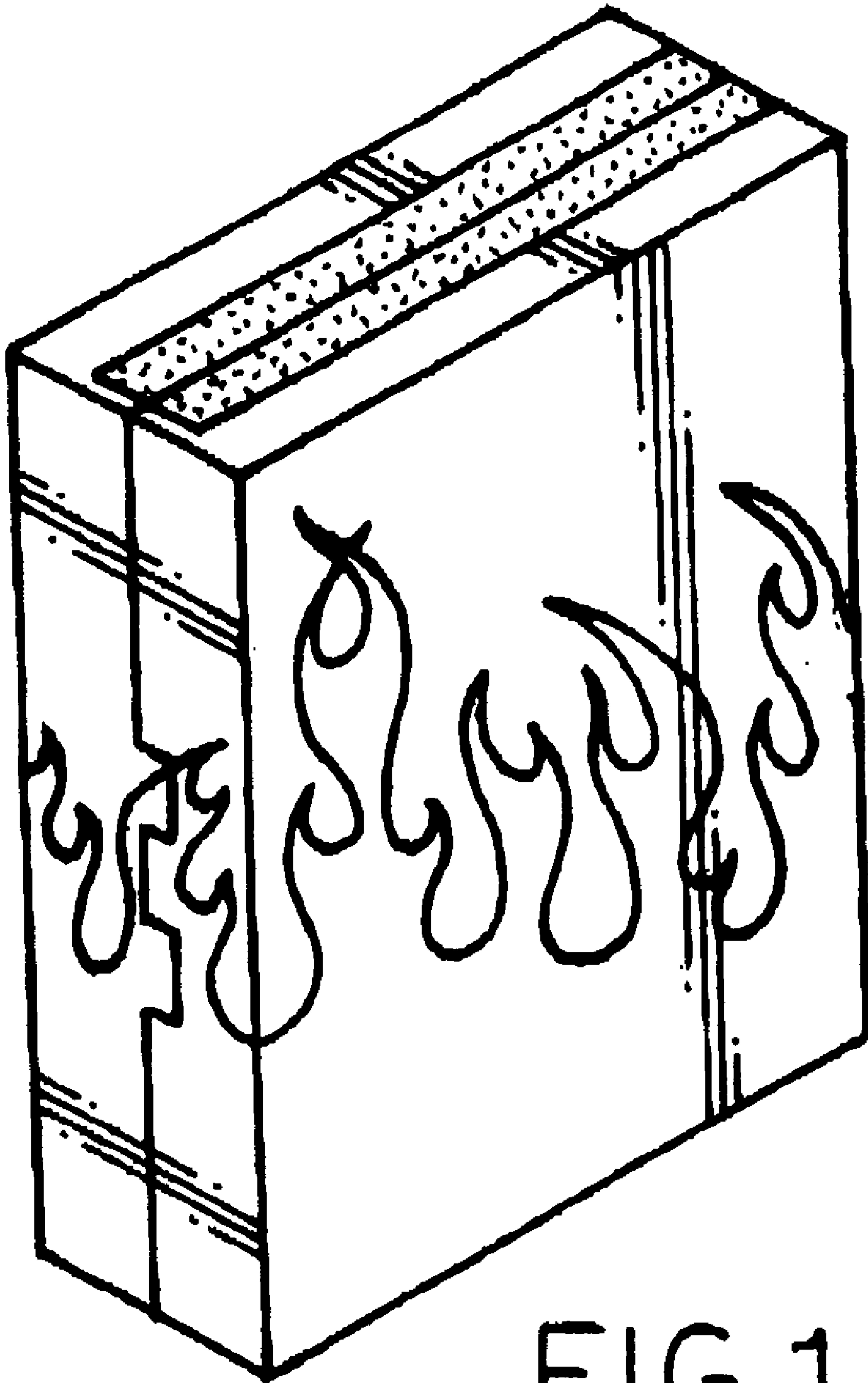

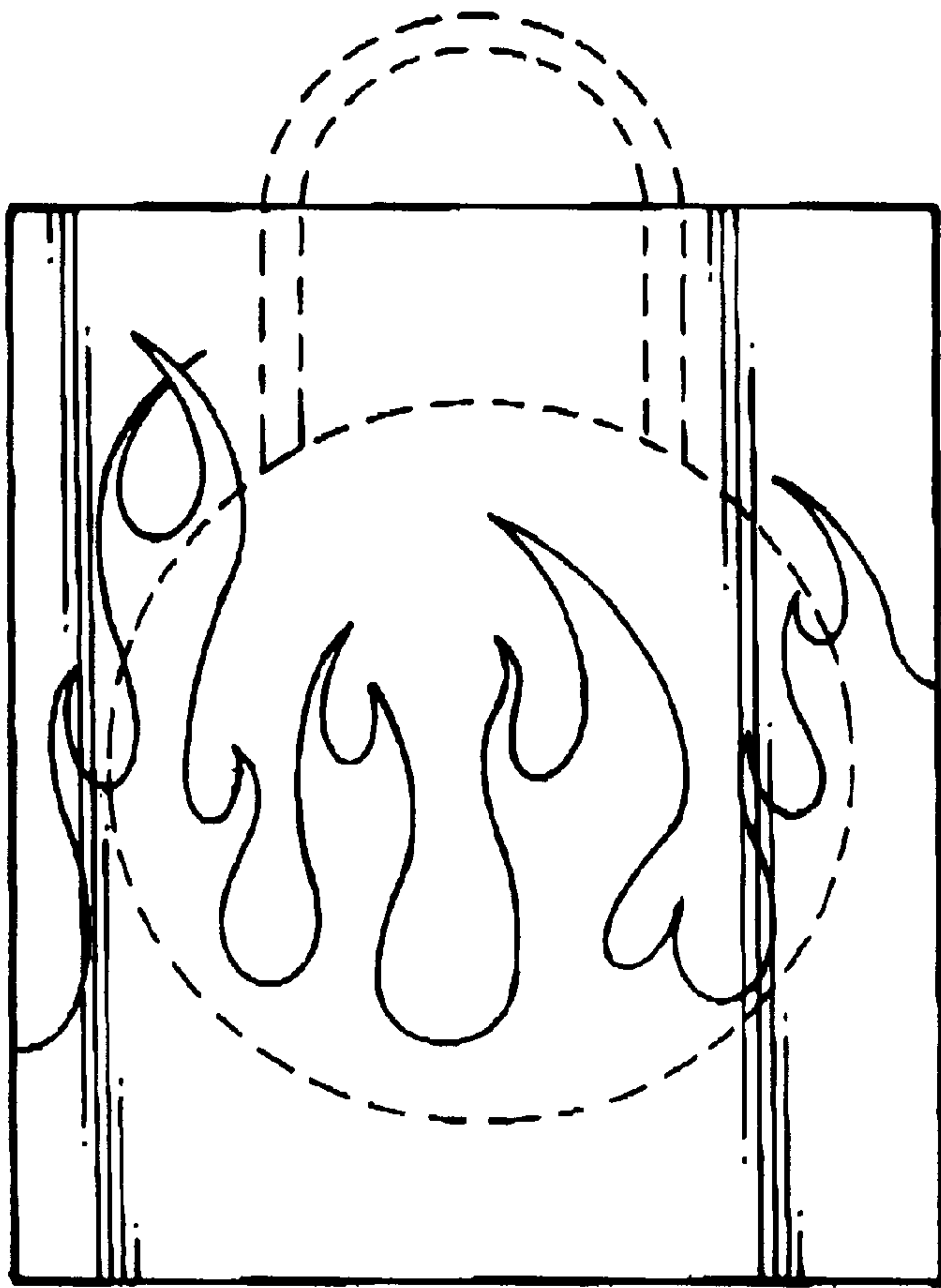

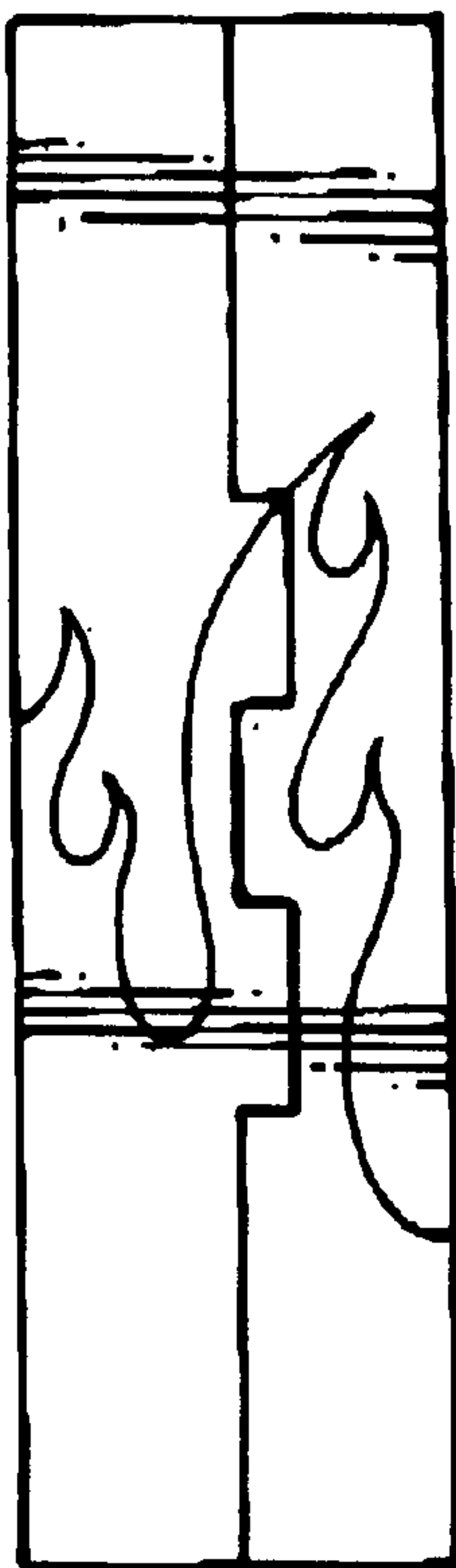

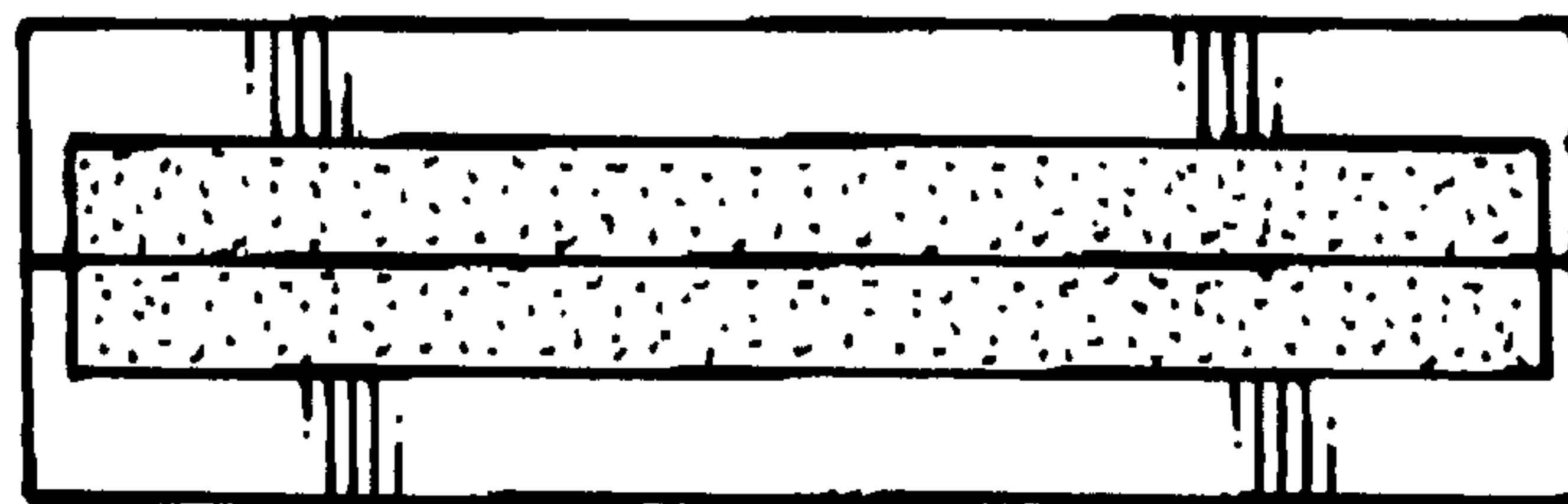
