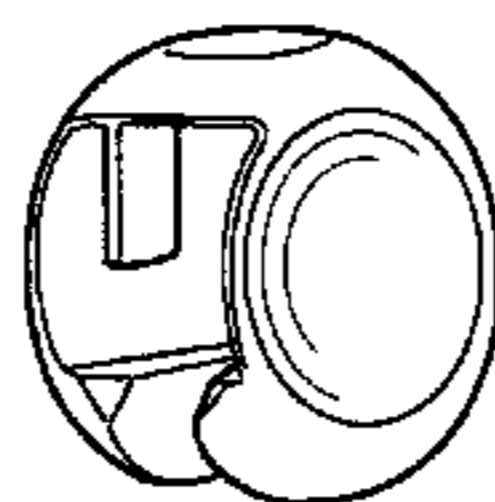
(57) **CLAIM**

The ornamental design for a round slider, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a top, front, and left side of an ornamental design for a round slider for reclosable bags according to the present invention;
 FIG. 2 is a front elevational view of the slider of FIG. 1;
 FIG. 3 is a rear elevational view of the slider of FIG. 1;
 FIG. 4 is a left side elevational view of the slider of FIG. 1;
 FIG. 5 is a plan view of the slider of FIG. 1;
 FIG. 6 is a bottom elevational view of the slider of FIG. 1;
 and,
 FIG. 7 is an isometric view illustrating in phantom a reclosable bag on which a round slider of the present invention may be disposed.
 Structures shown in phantom form no part of the claimed design.

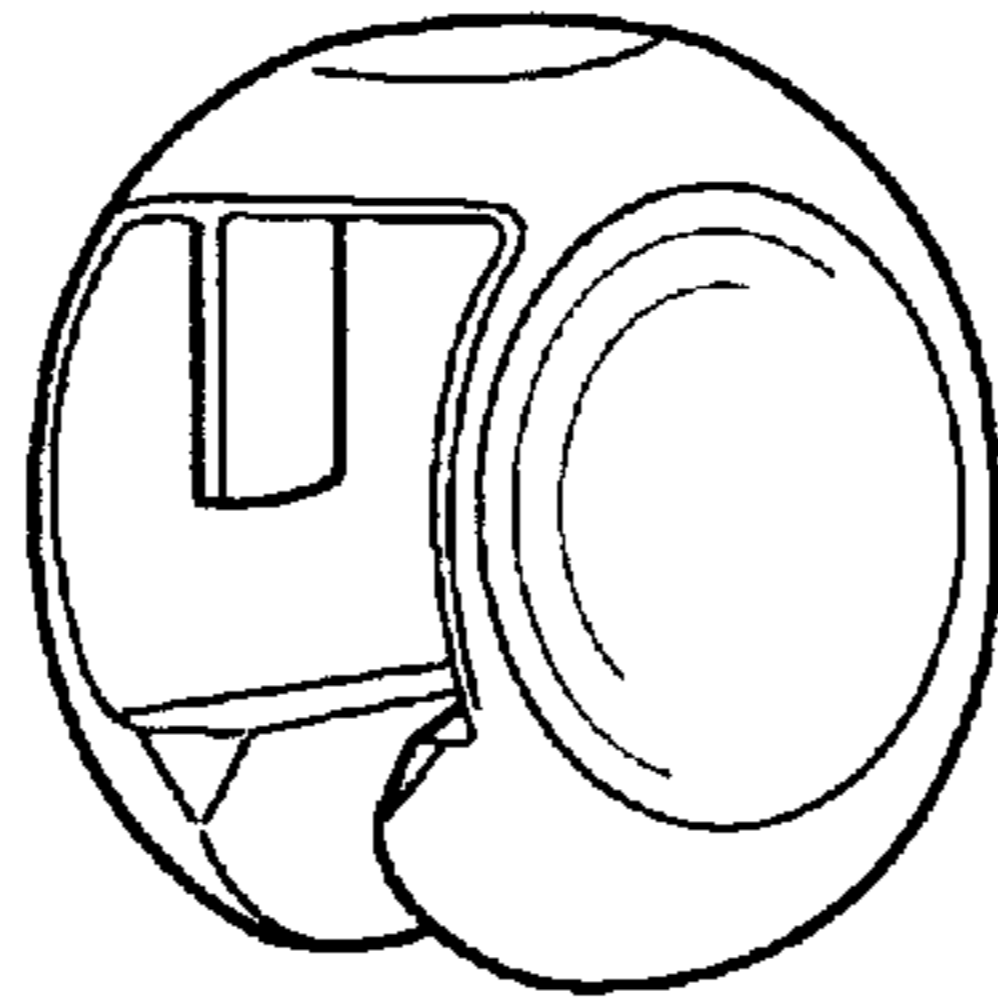

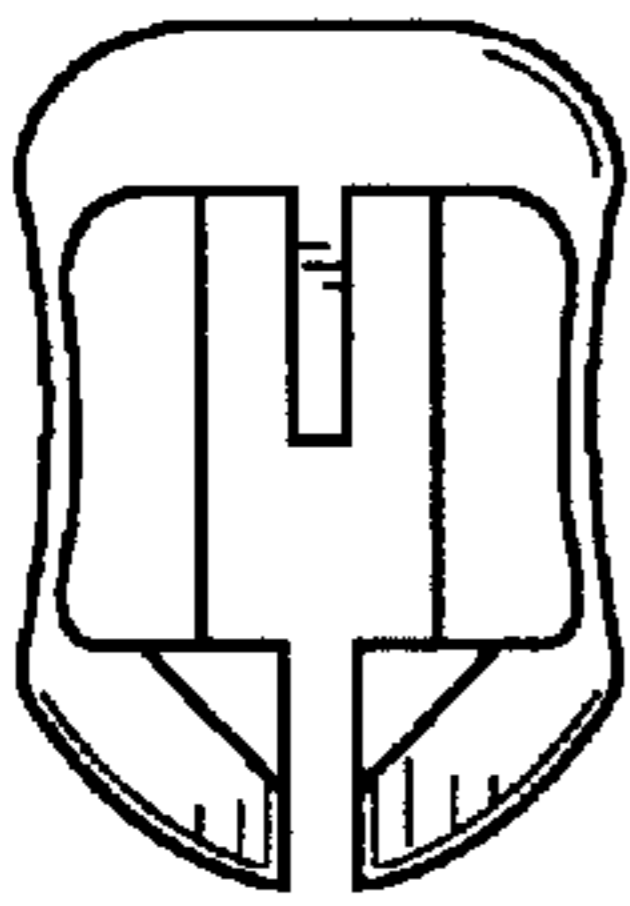

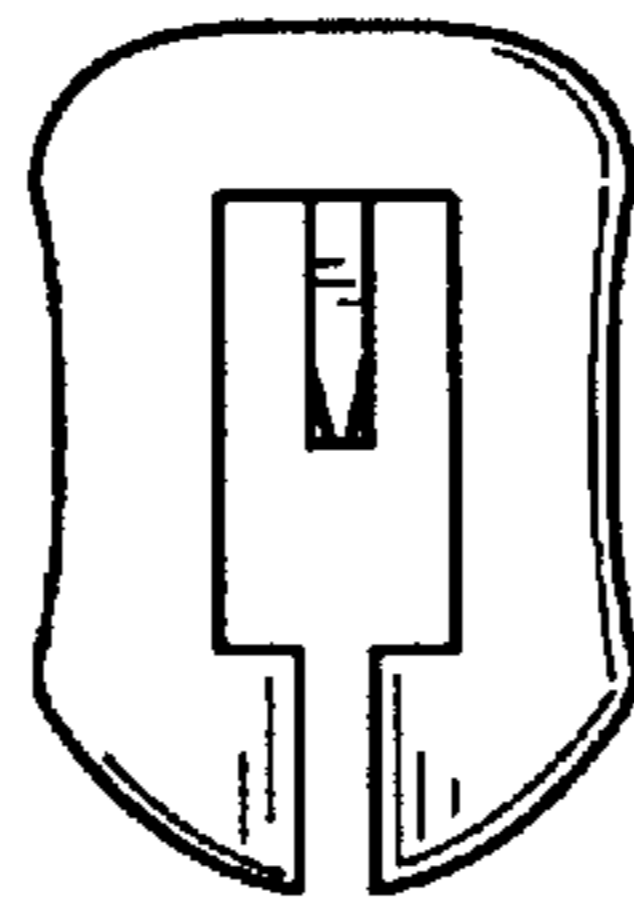

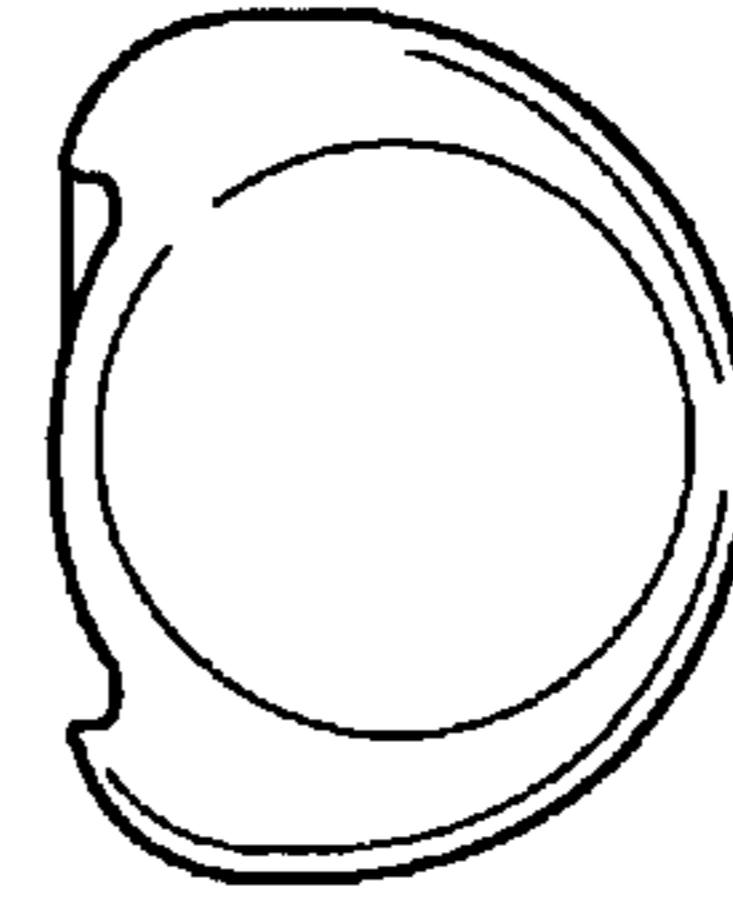

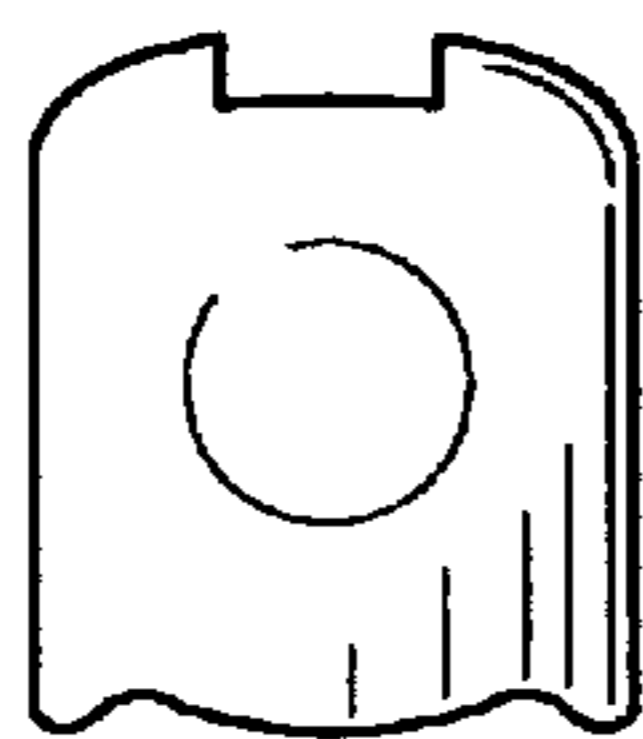

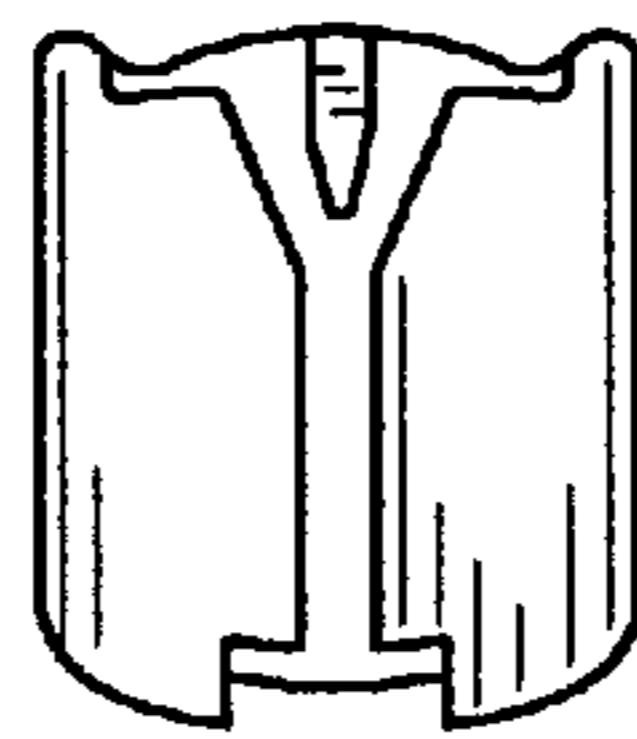
