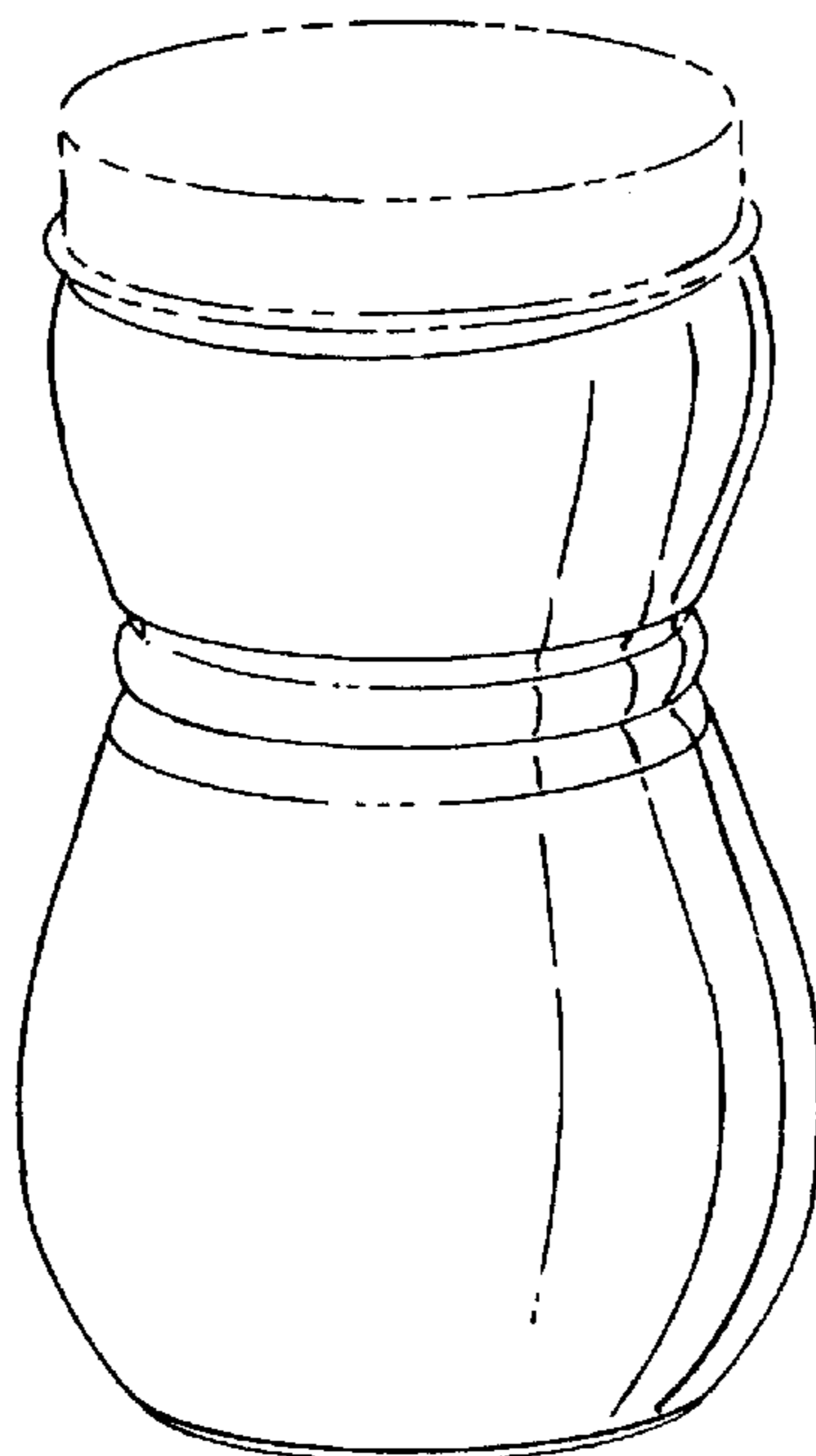
(57) **CLAIM**

The ornamental design for a container, as shown and described.

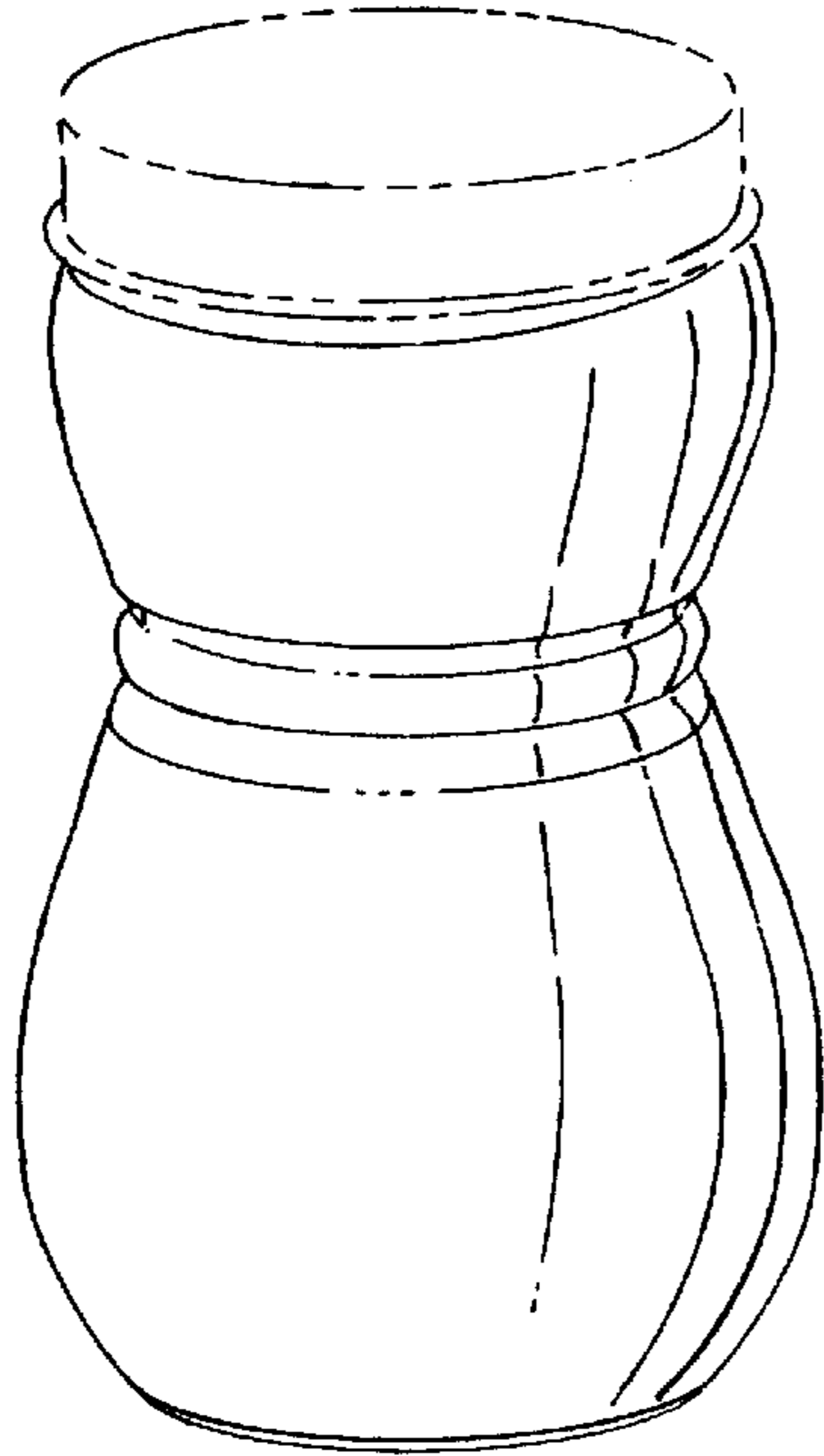
**DESCRIPTION**

Portions of the container are shown in broken lines in FIGS. 1-4 for illustrative purposes only and form no part of the claimed design.

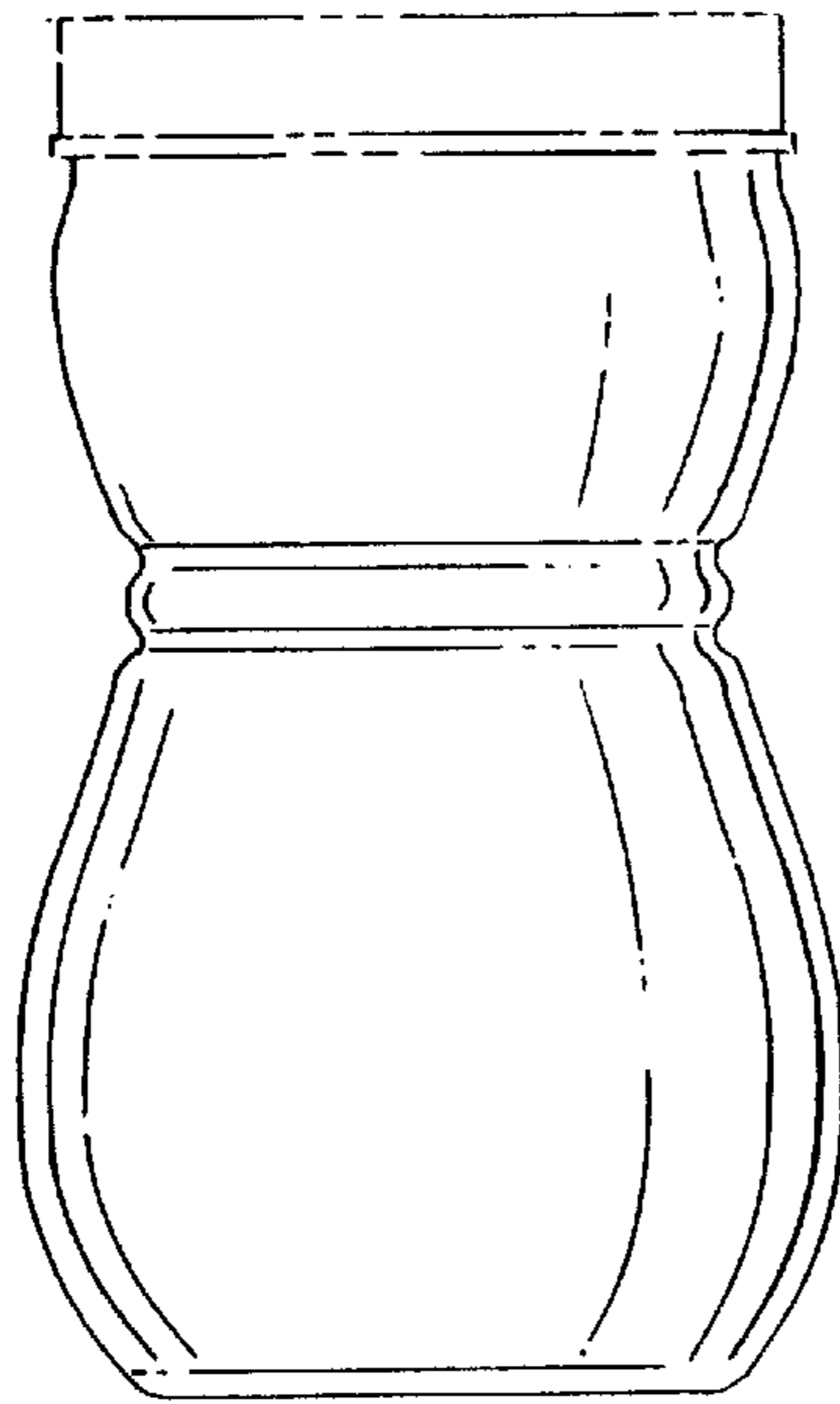

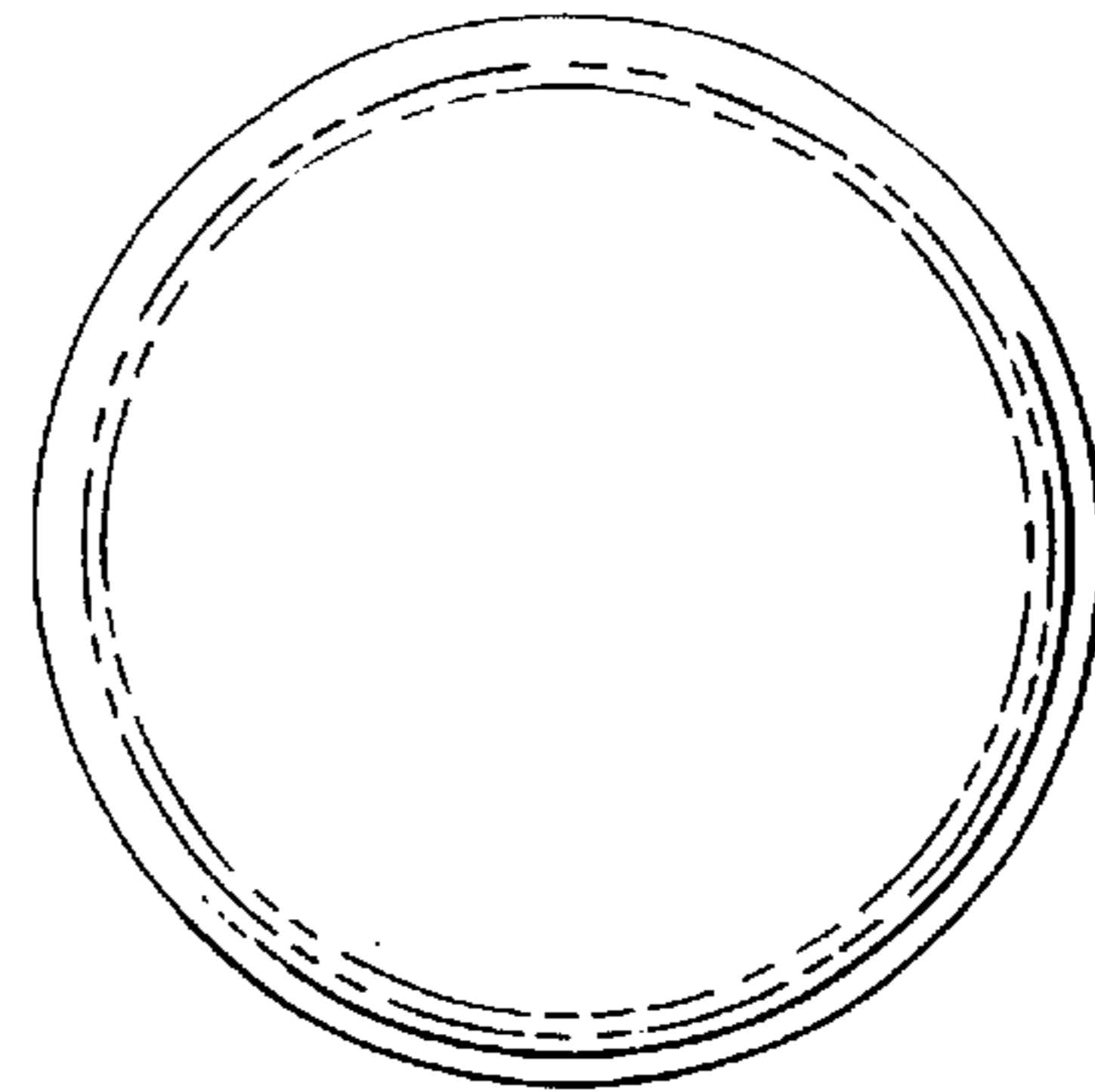
