DESCRIPTION

FIG. 1 is a perspective view of a cosmetic container of the present design;

FIG. 2 is a top plan view of the cosmetic container of FIG. 1;

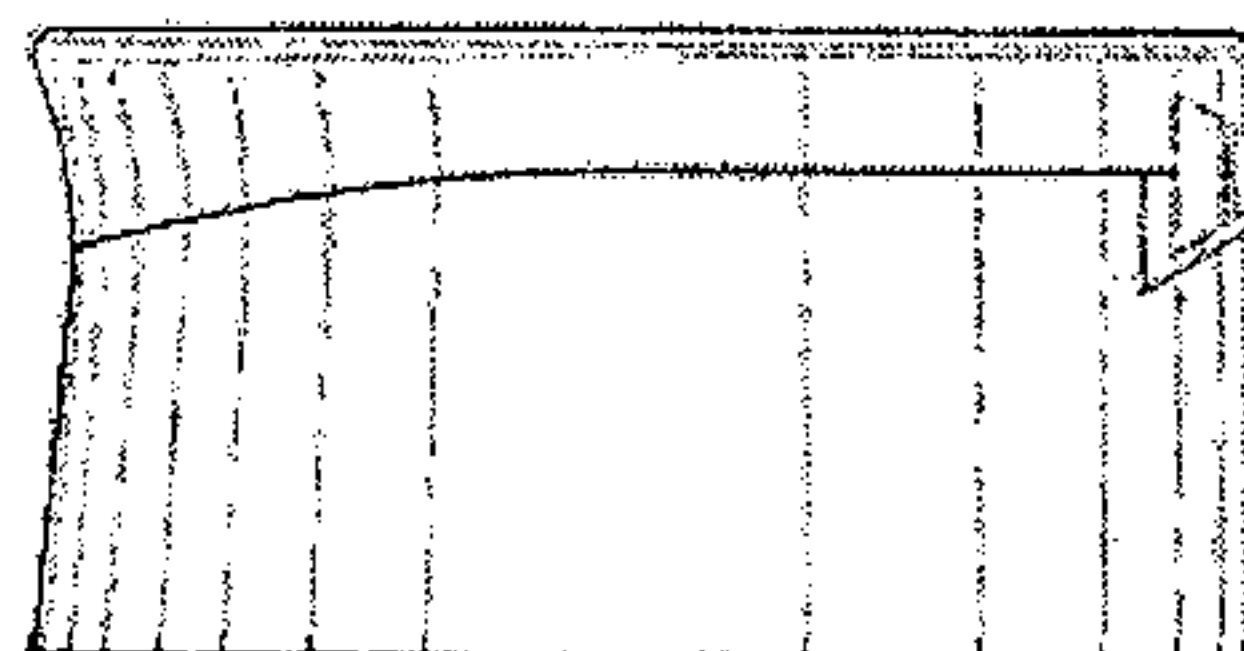
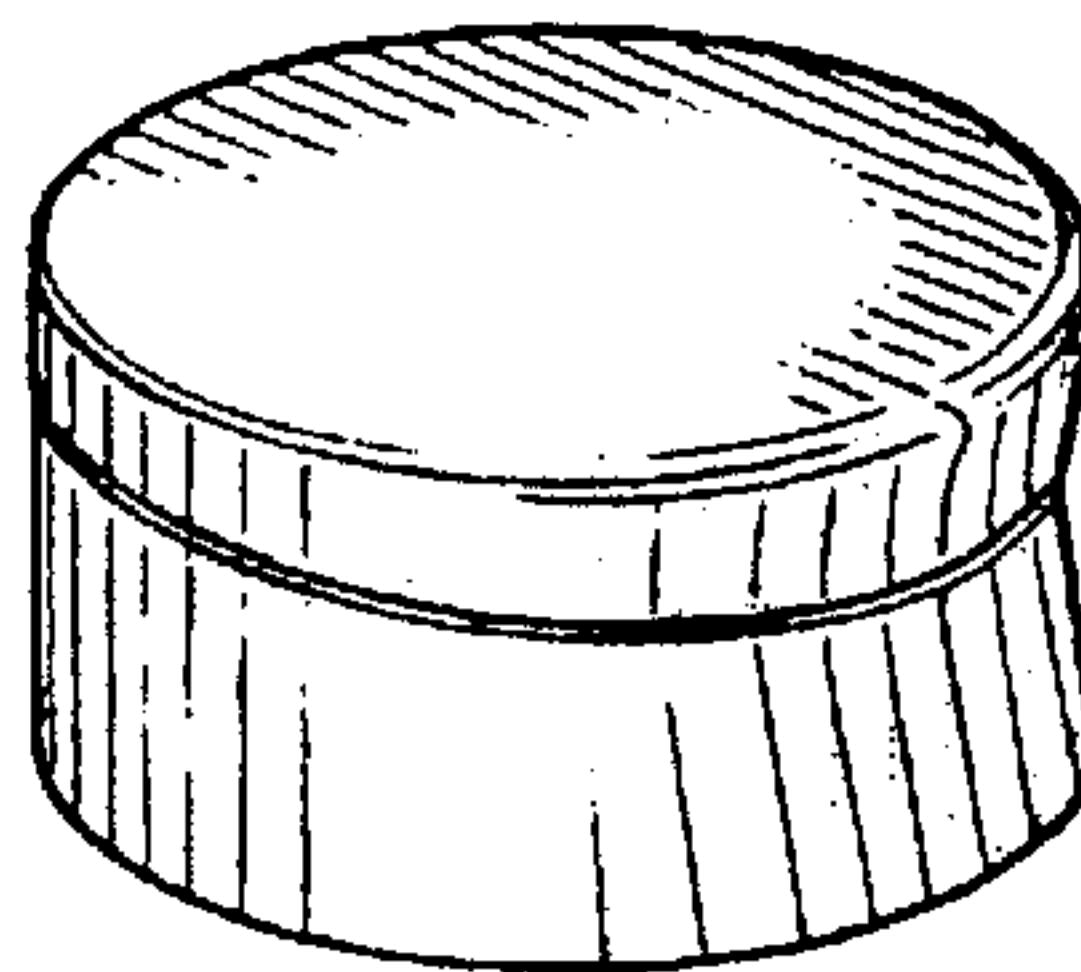
FIG. 3 is a front elevational view of the cosmetic container of FIG. 1;

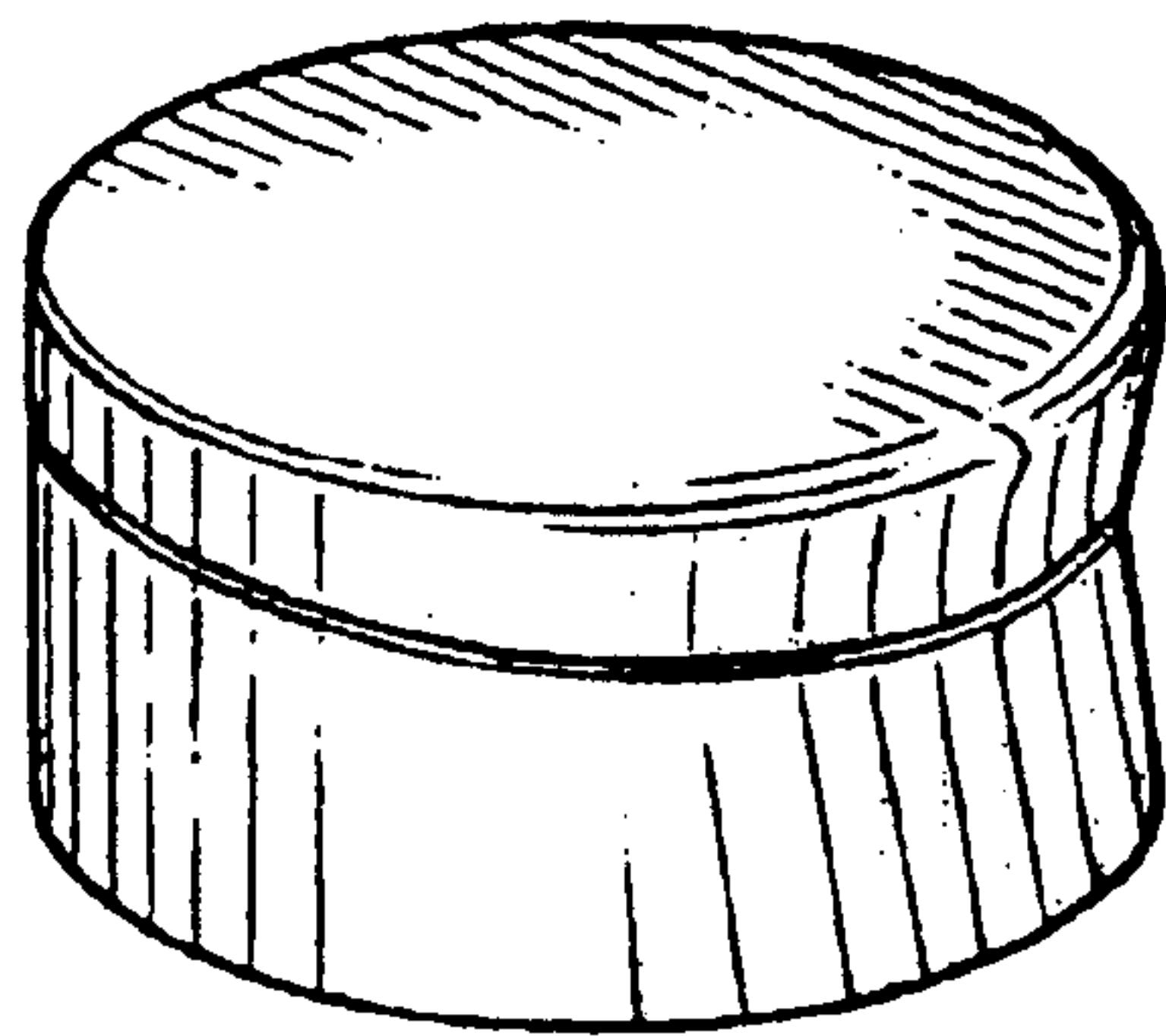

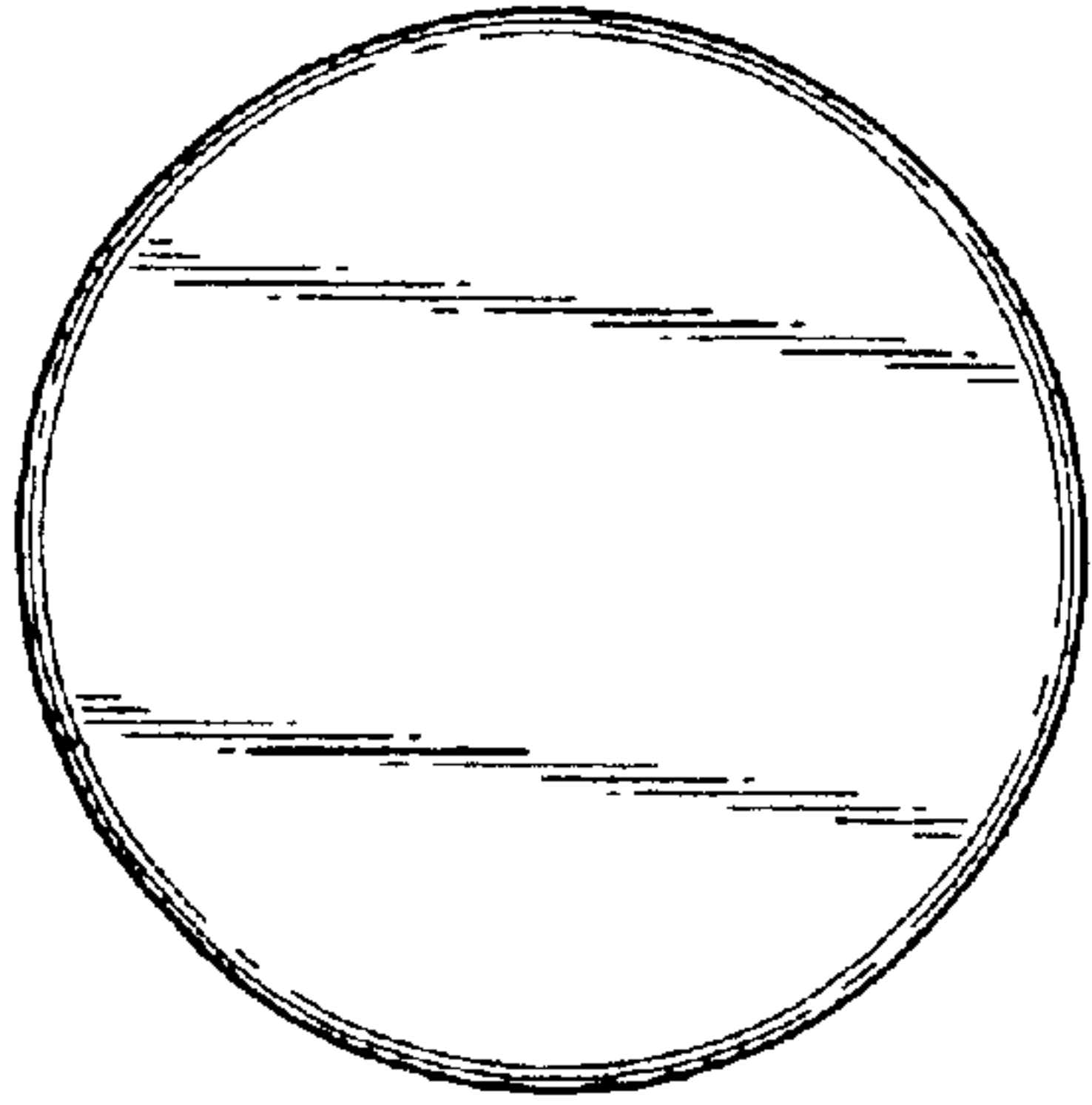

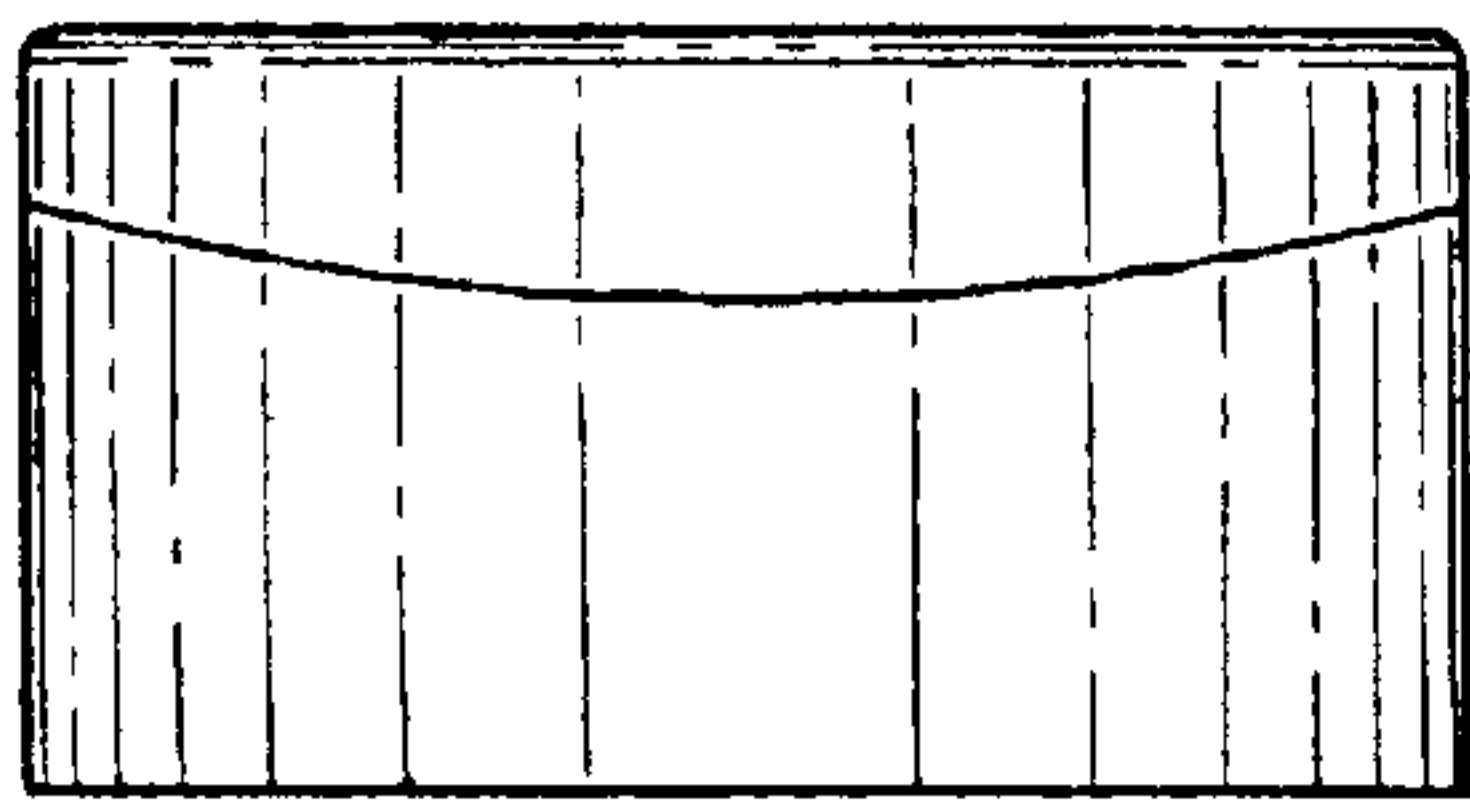

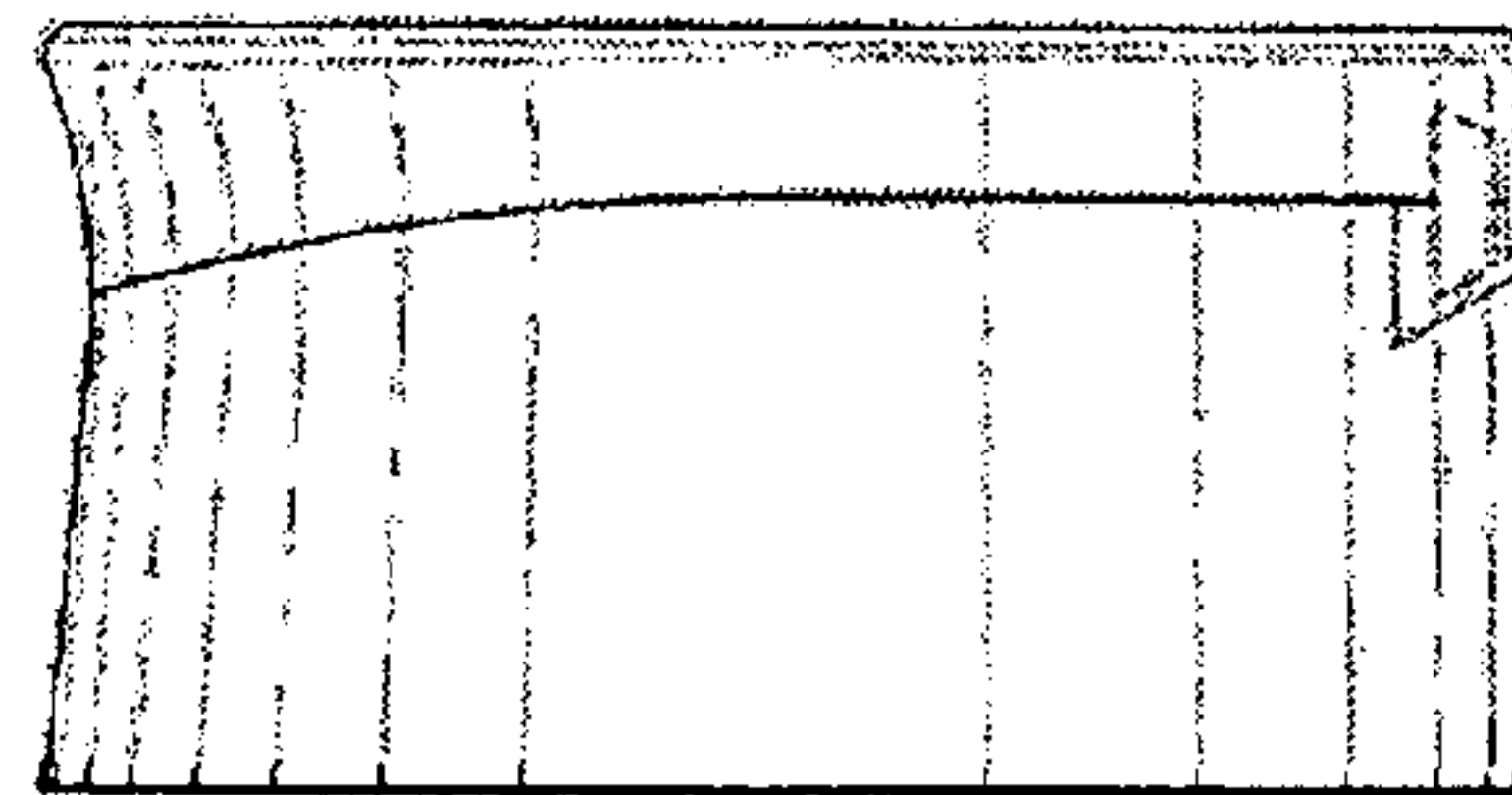

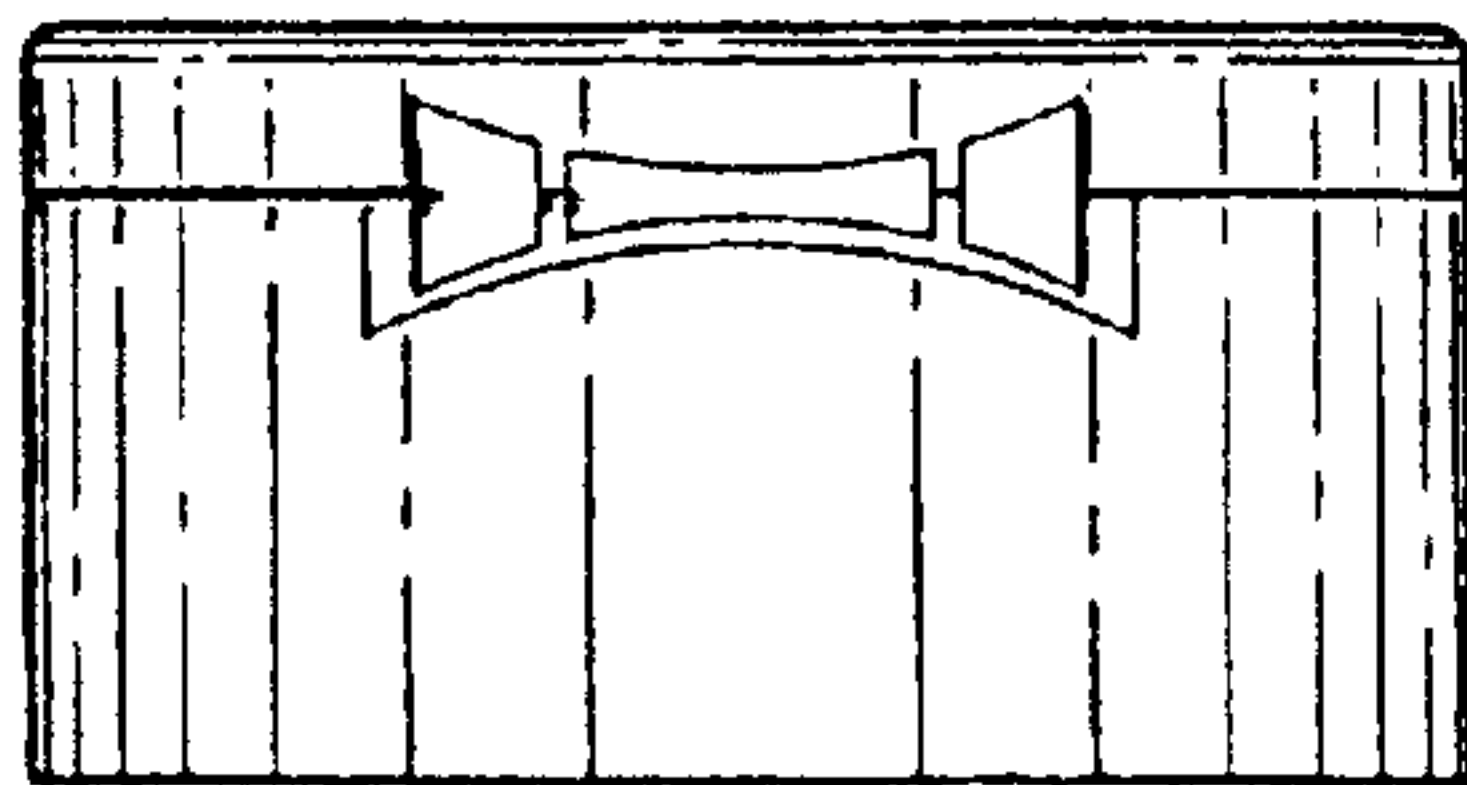

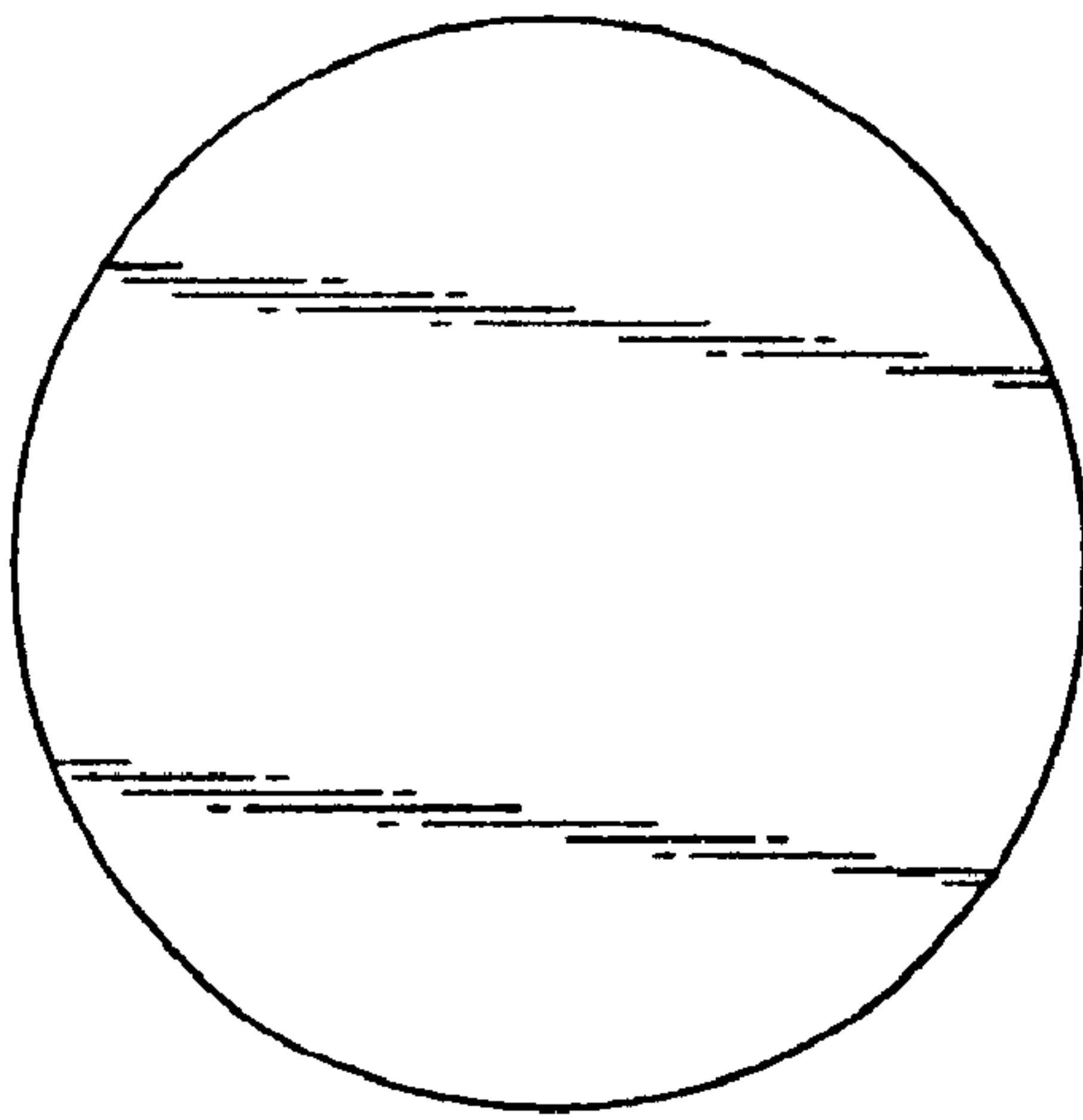
