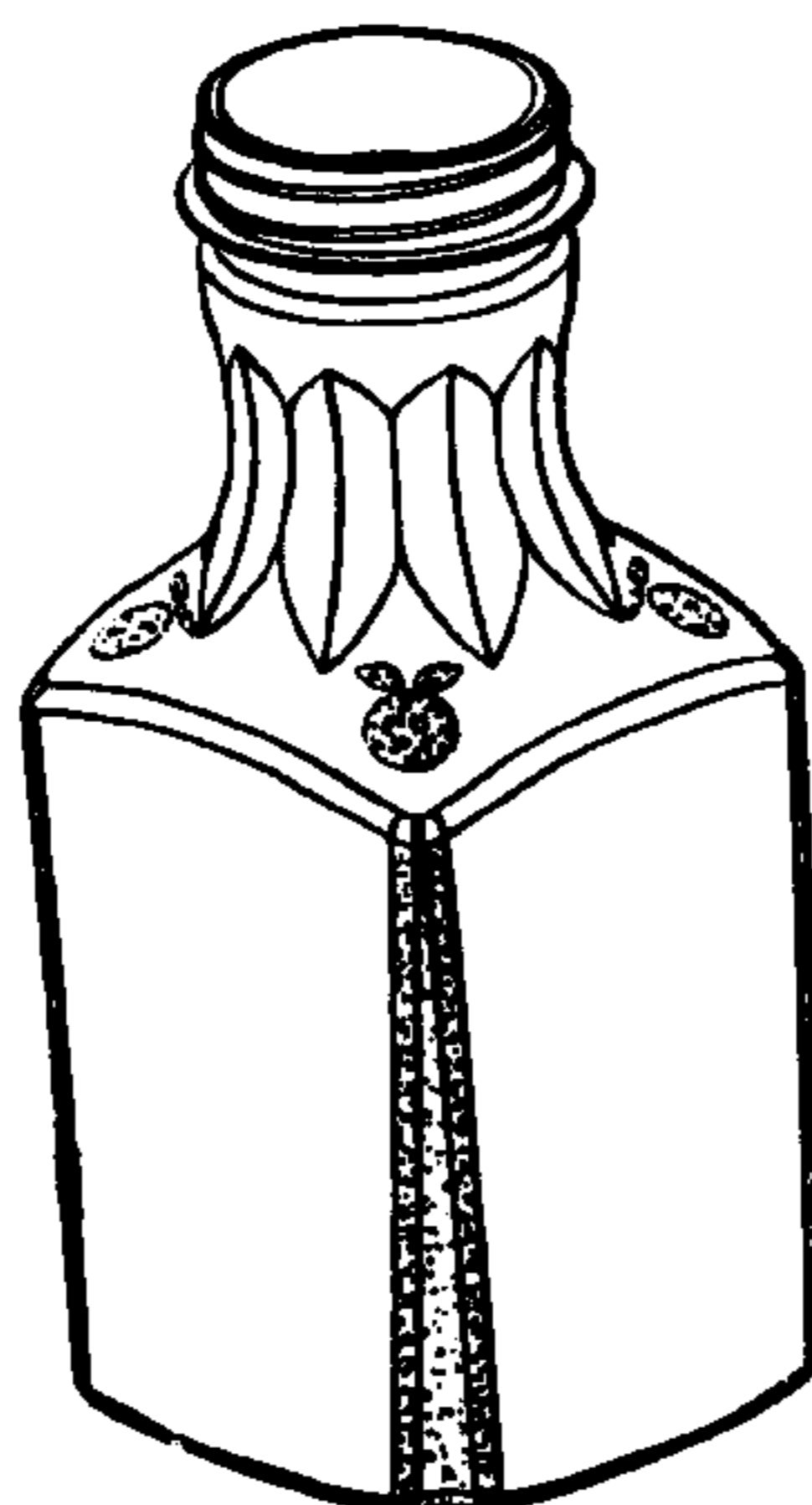
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a top side of a bottle according to the invention.
FIG. 2 is a right side view of the bottle of FIG. 1.
FIG. 3 is a top view of the bottle of FIG. 1; and,
FIG. 4 is a perspective view of an alternative embodiment of a bottle according to the invention.
The design is directed to a bottle.

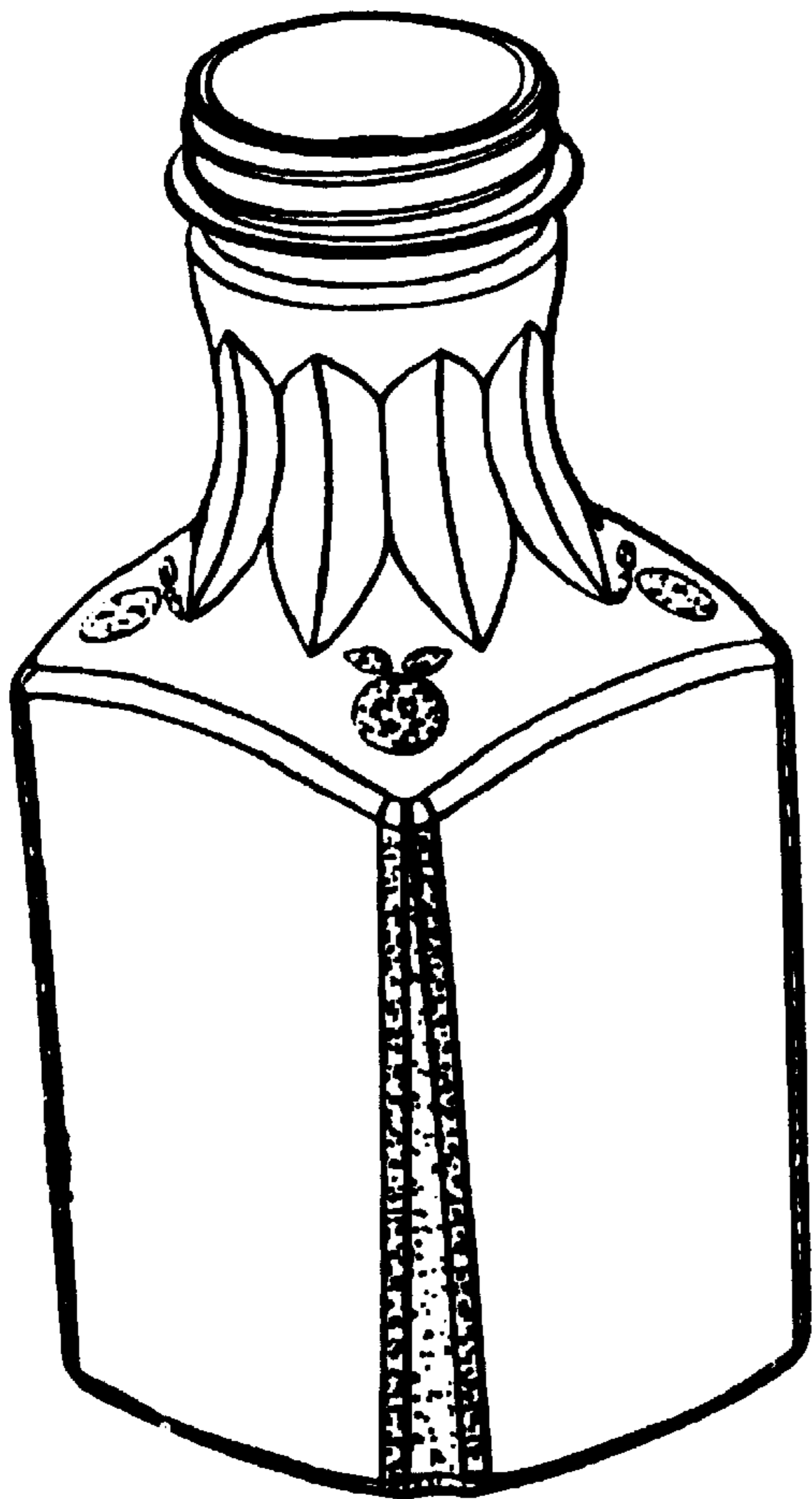

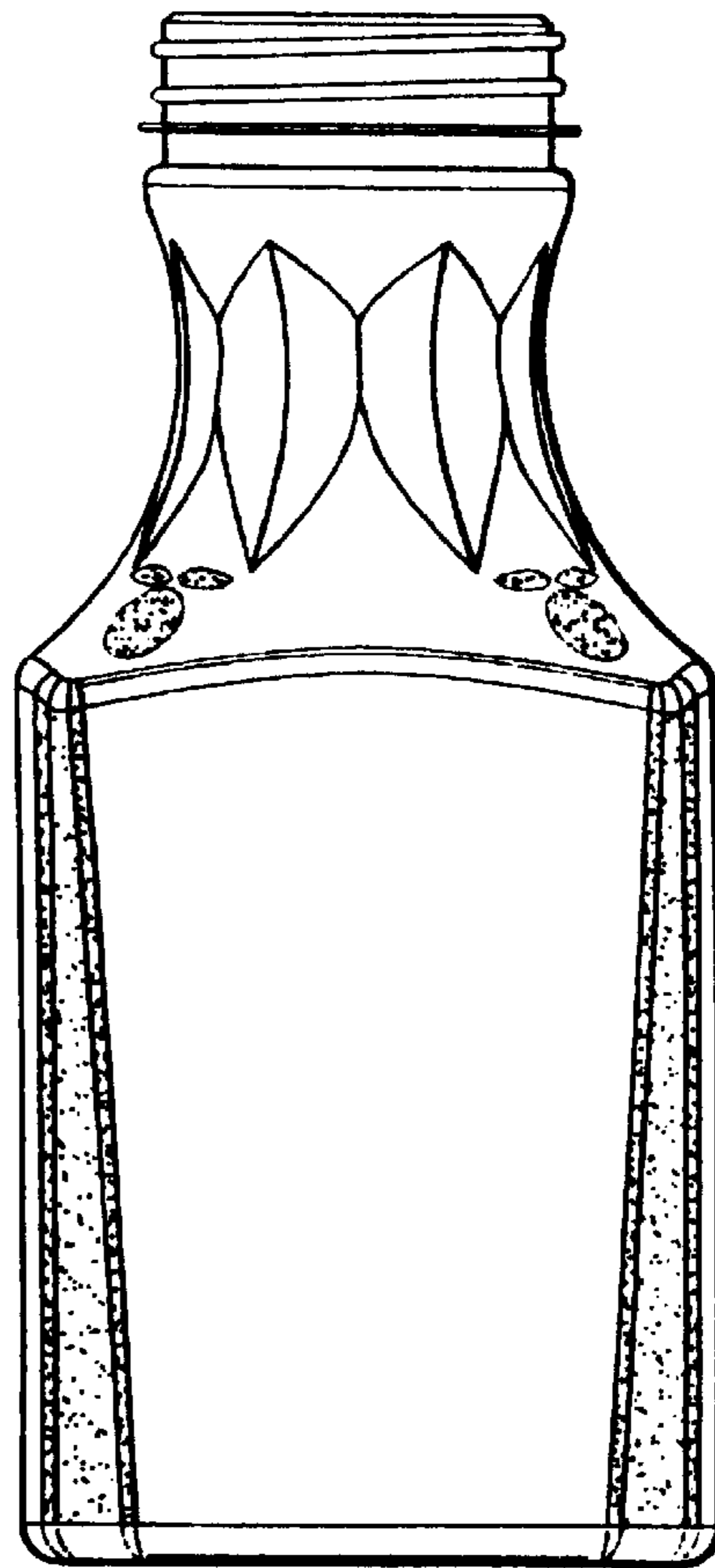

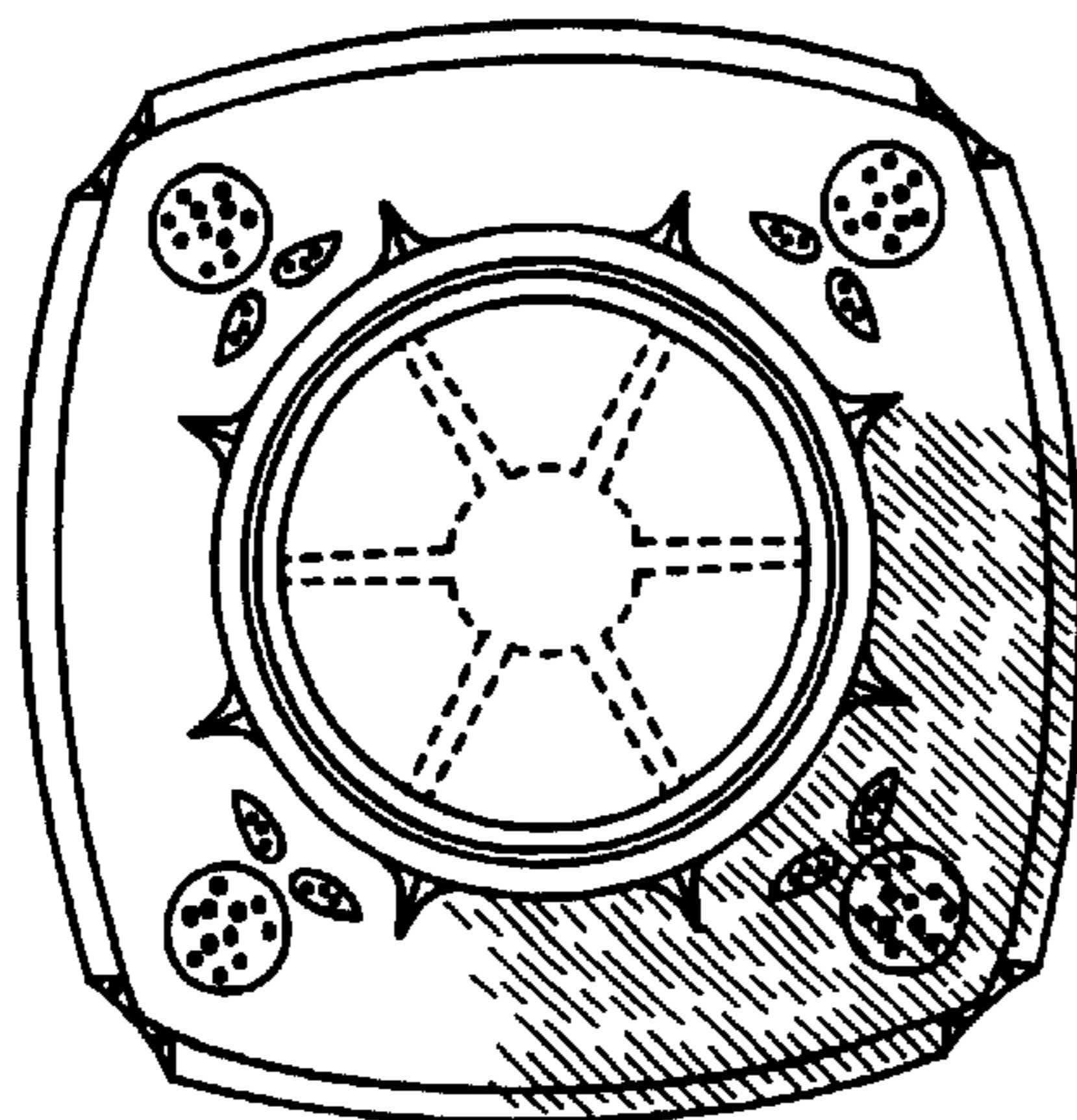

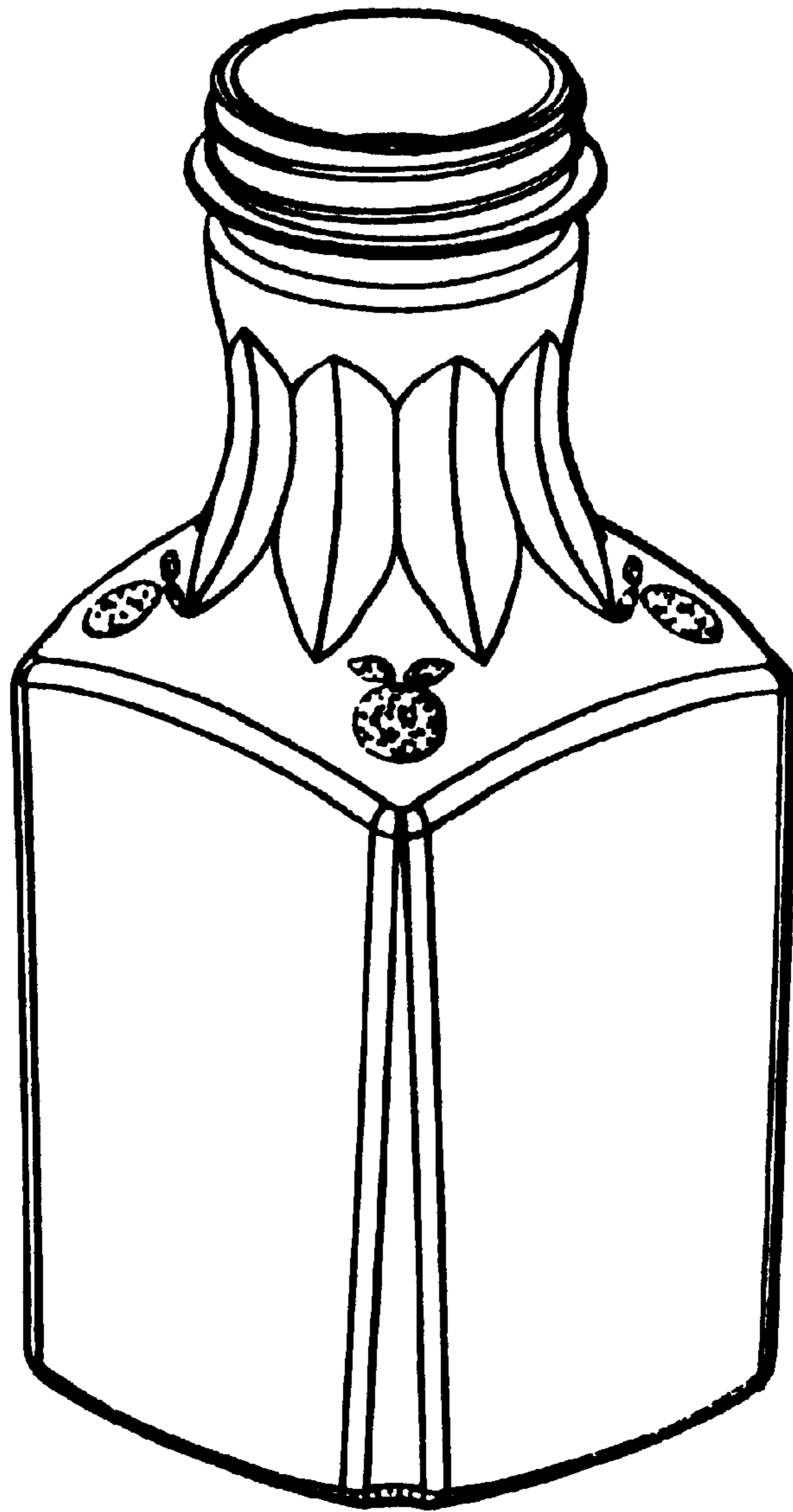
