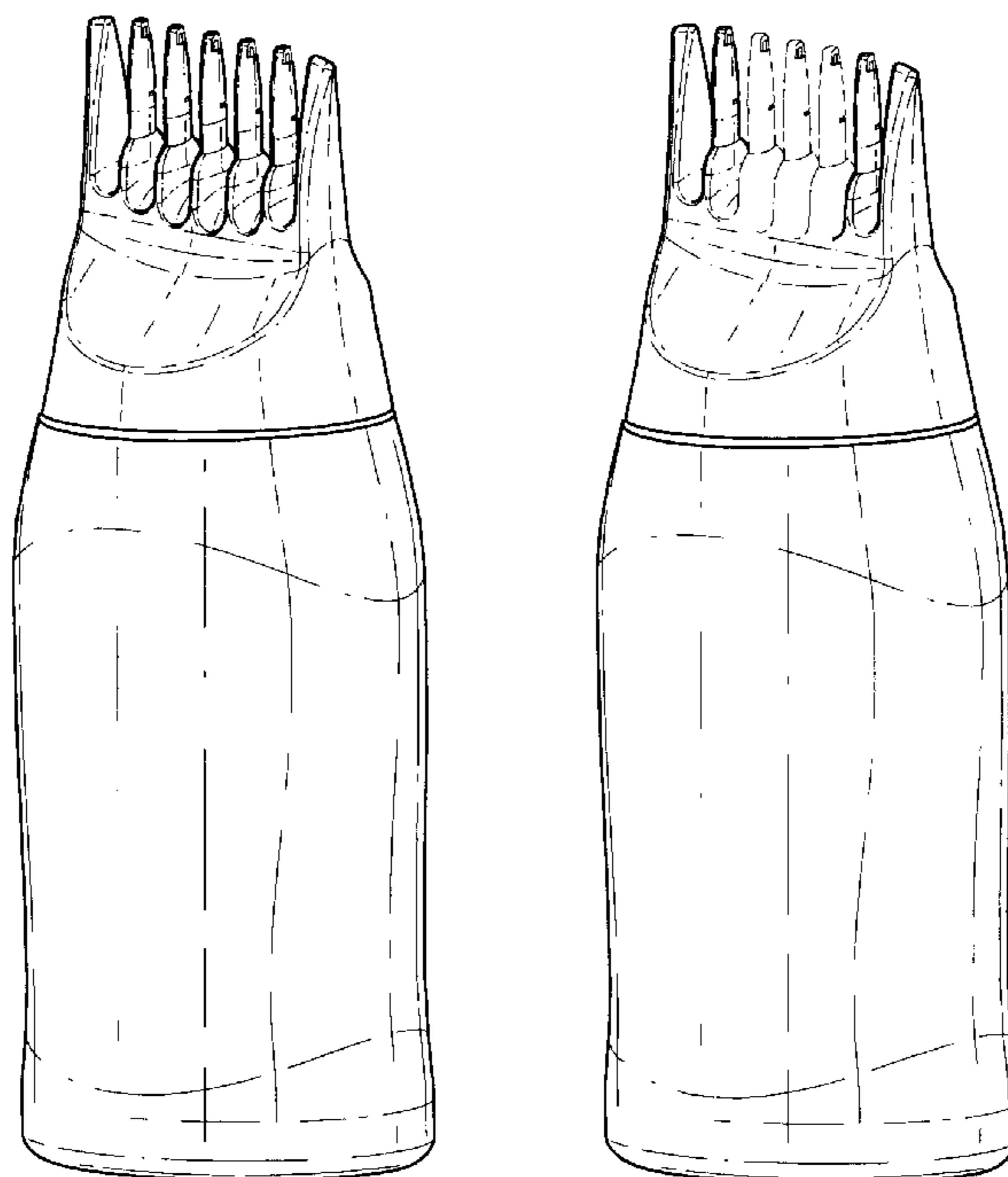
(57) **CLAIM**

The ornamental design for a hair treatment applicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a hair treatment applicator showing our new design; FIG. 2 is a side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a perspective view of a second embodiment of the hair treatment applicator; FIG. 7 is a side elevational view thereof; FIG. 8 is a top plan view thereof; FIG. 9 is a front elevational view thereof; and, FIG. 10 is a bottom plan view thereof. 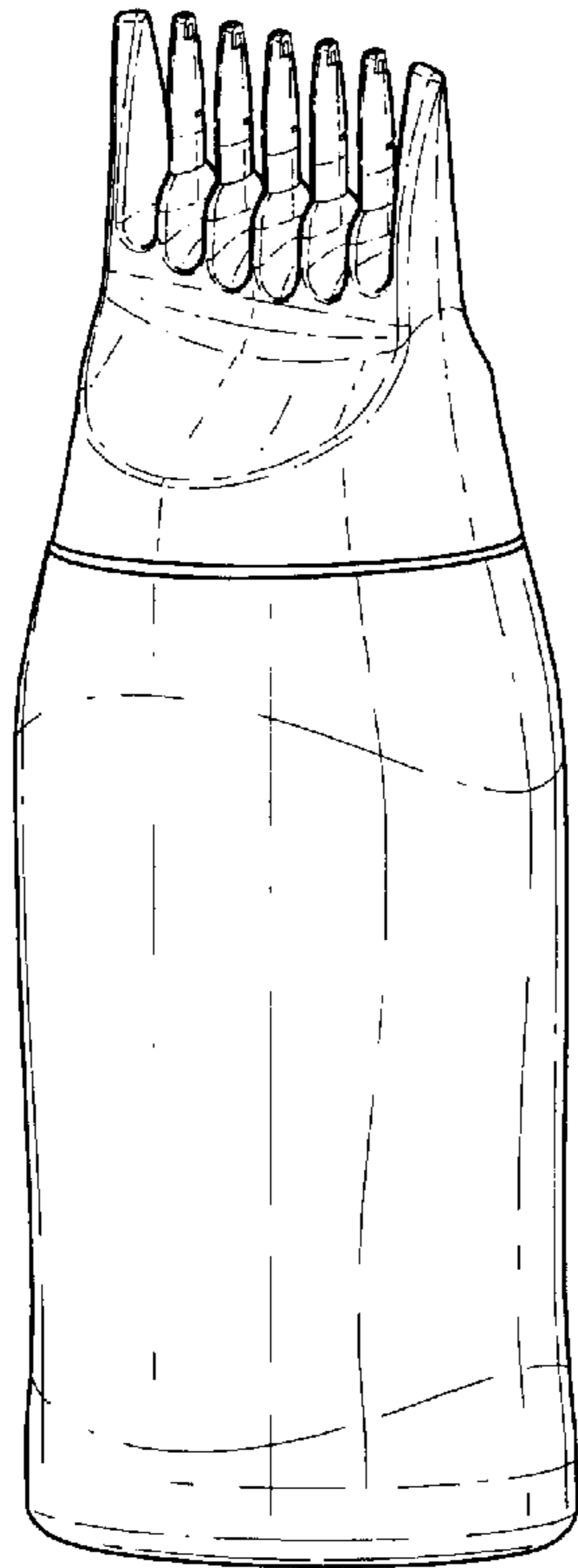

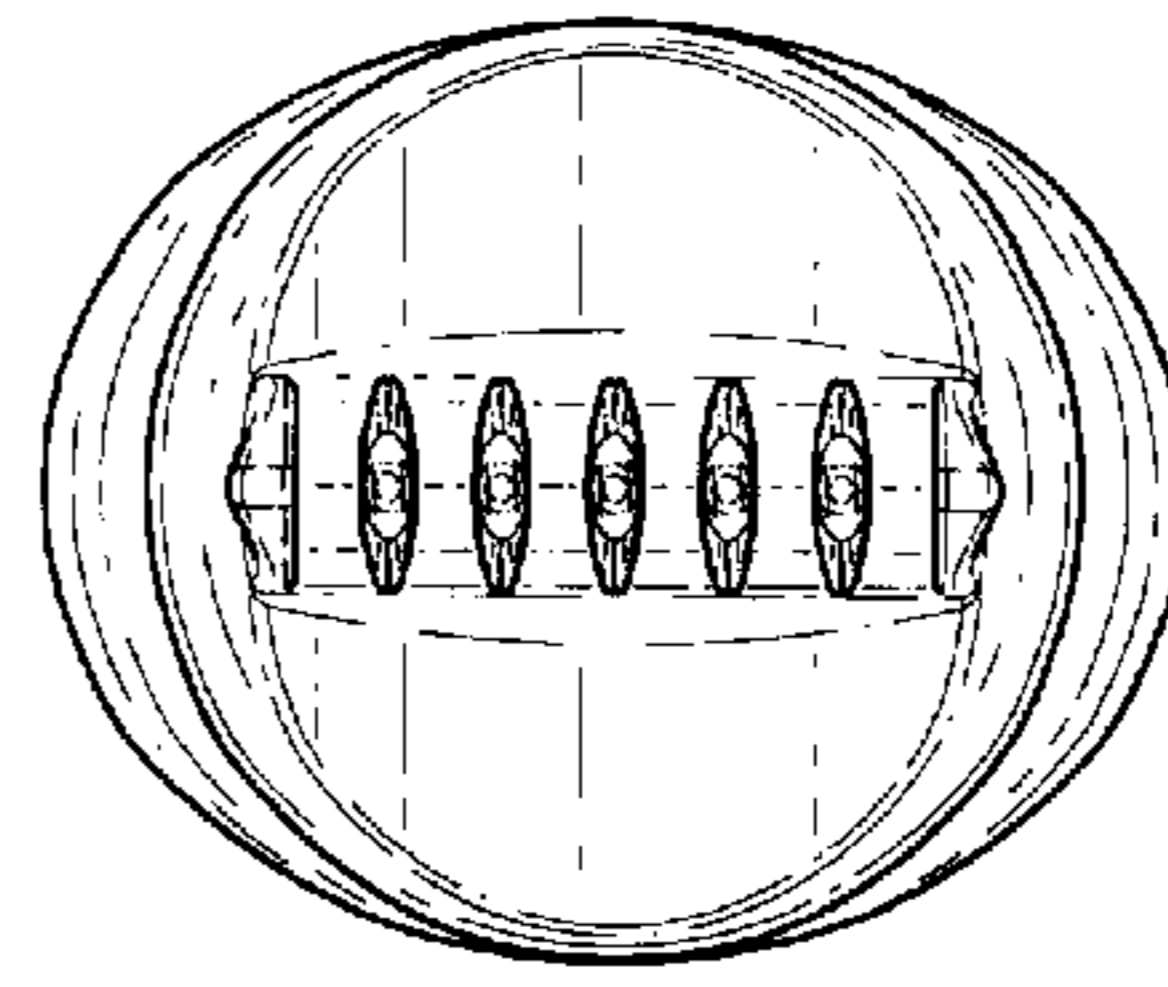

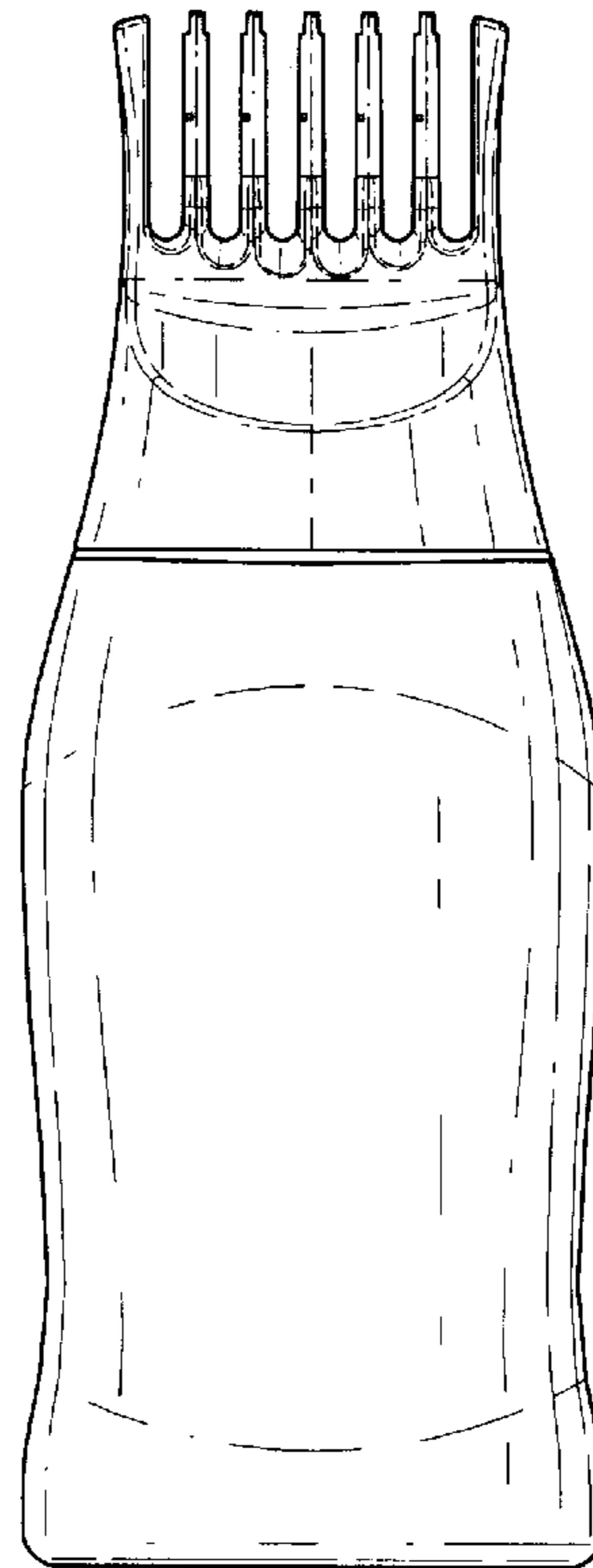

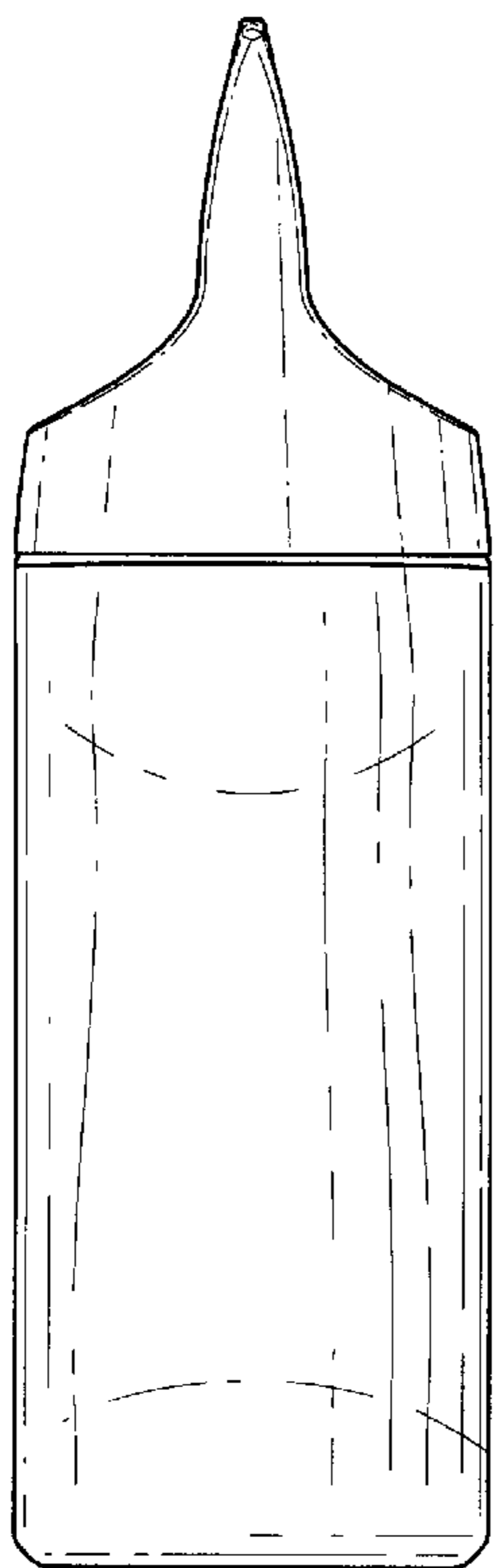

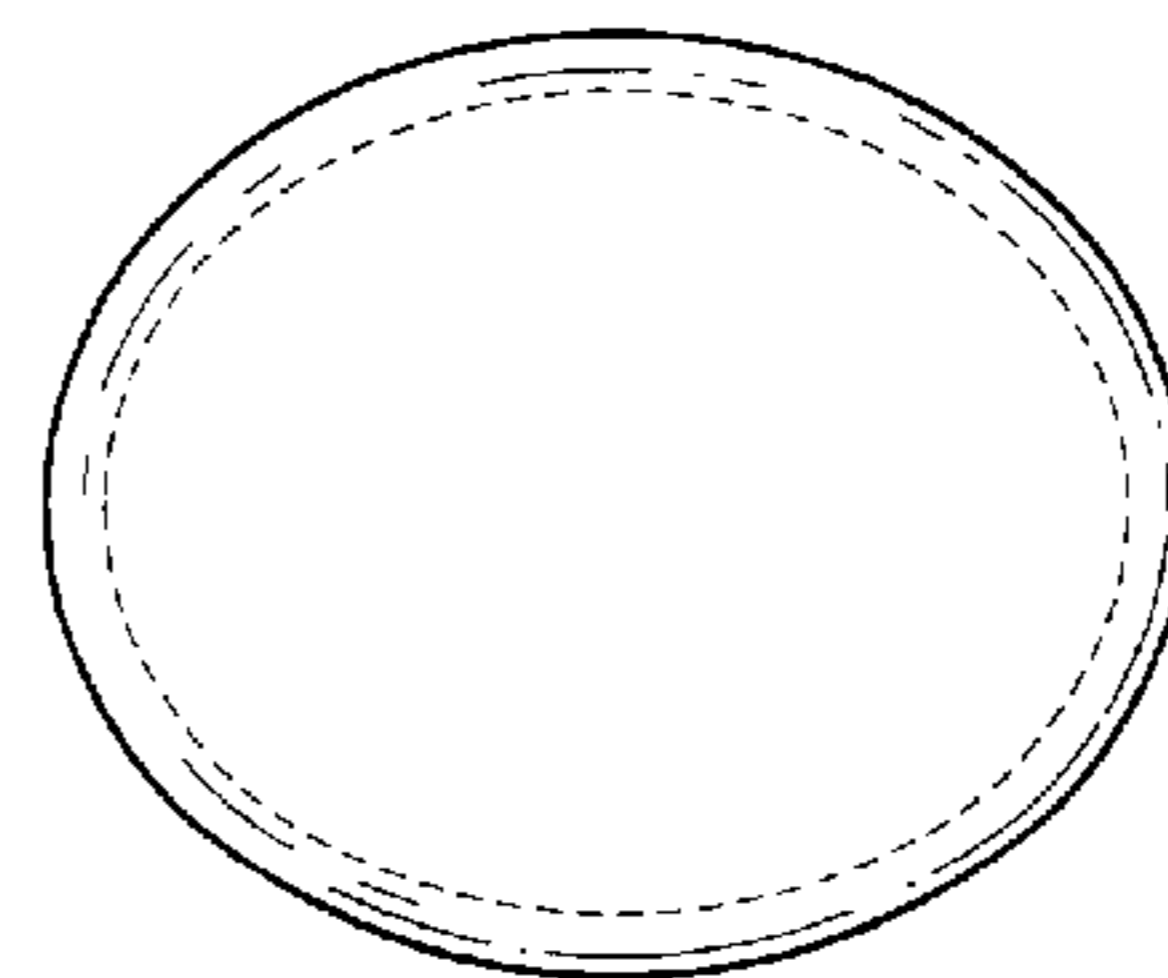

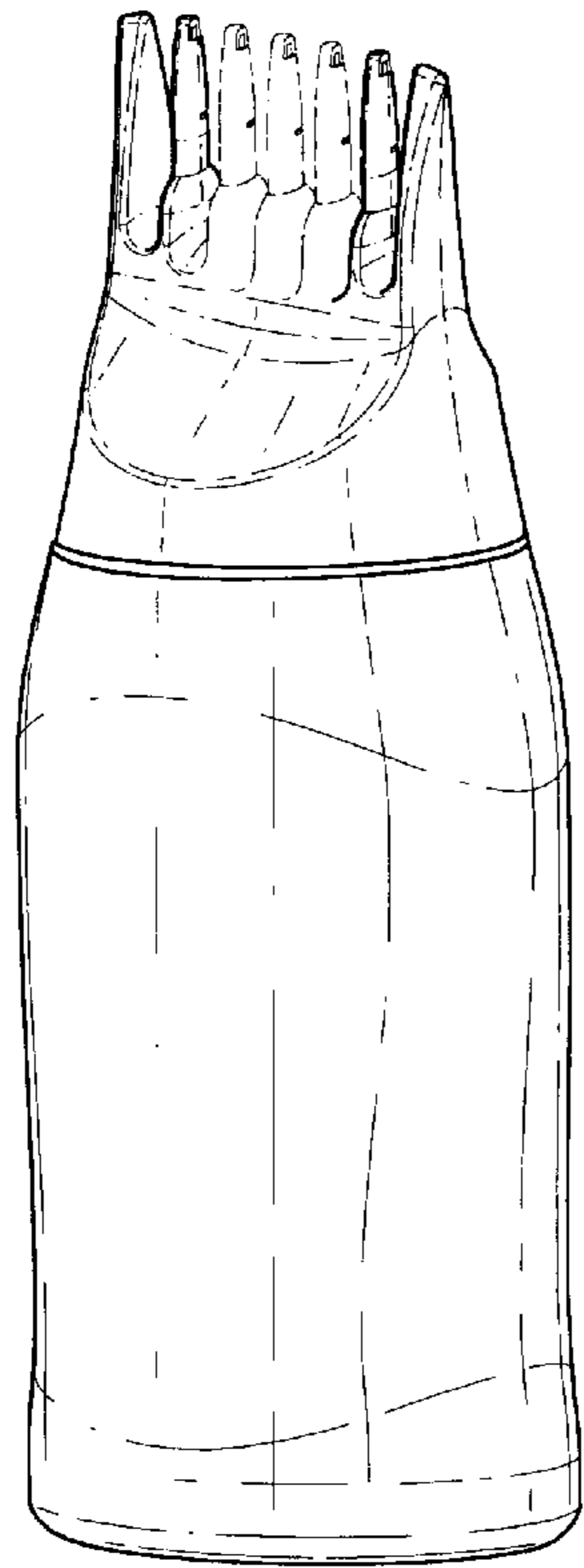

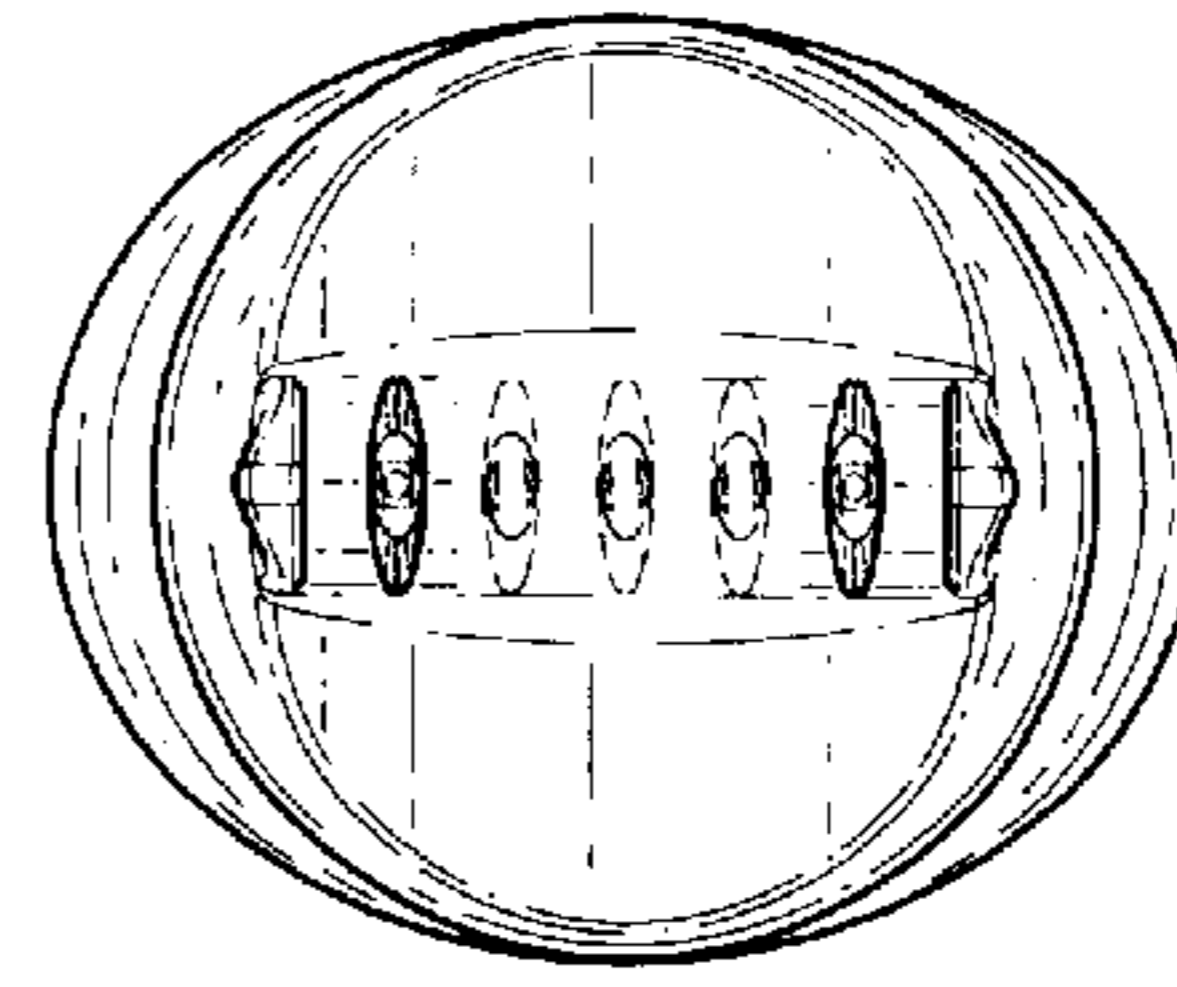

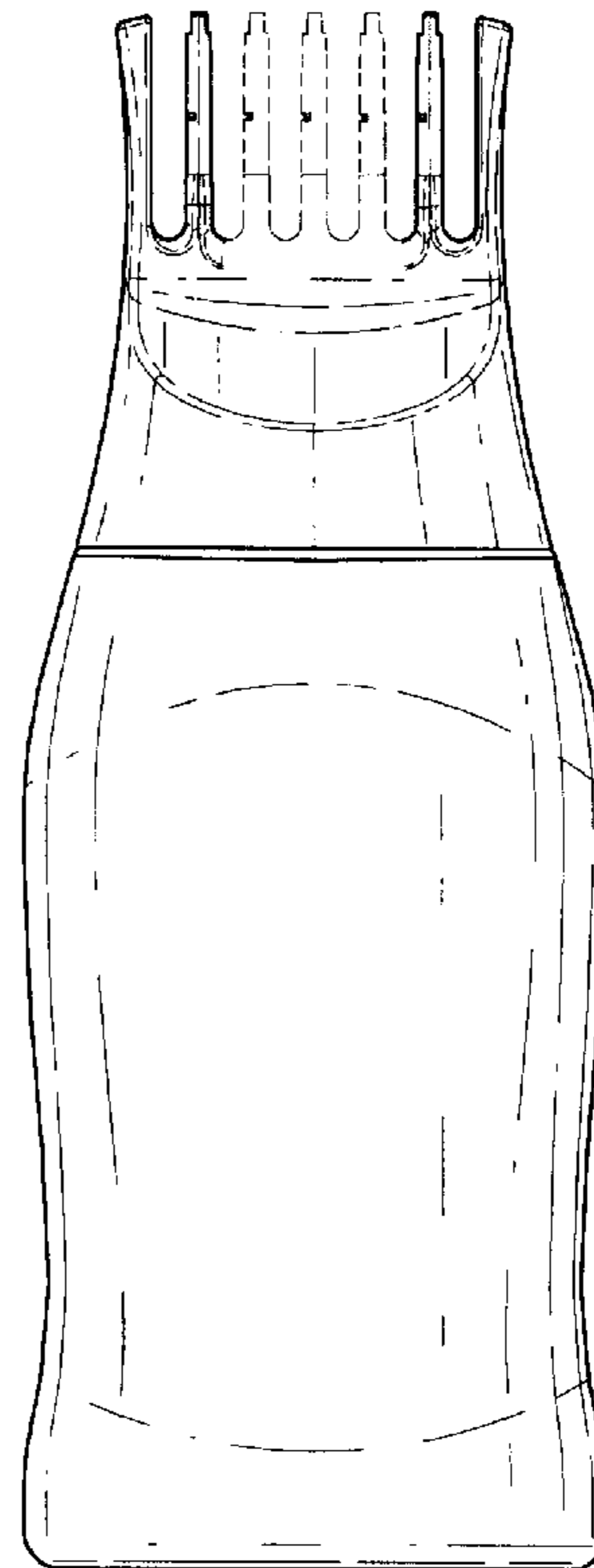

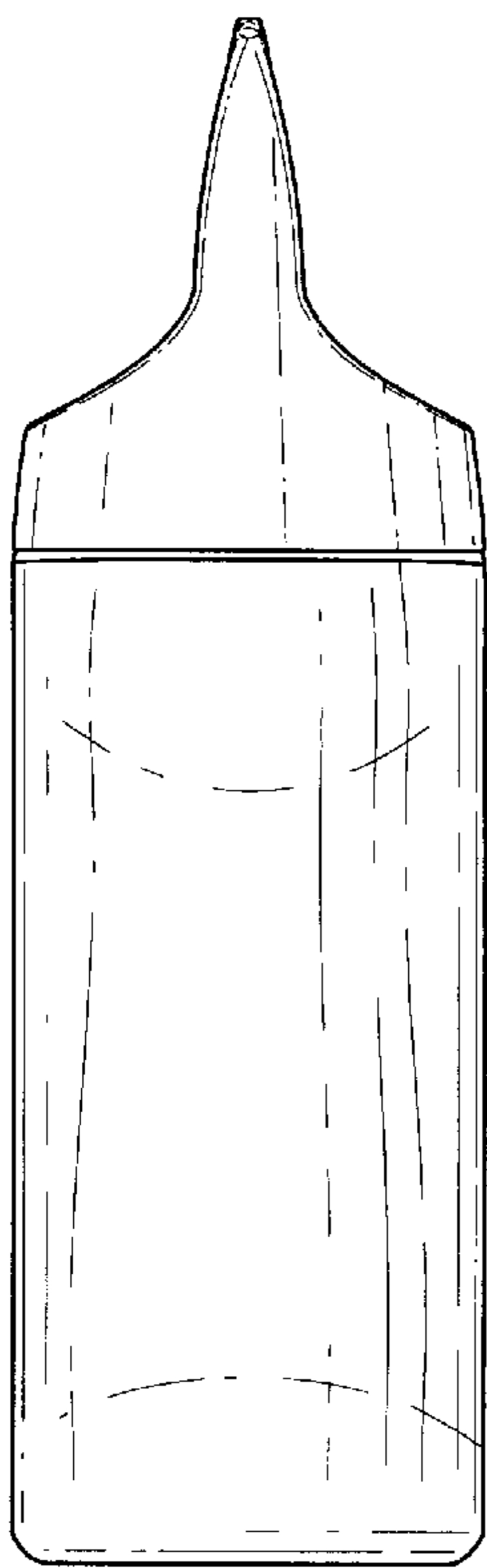

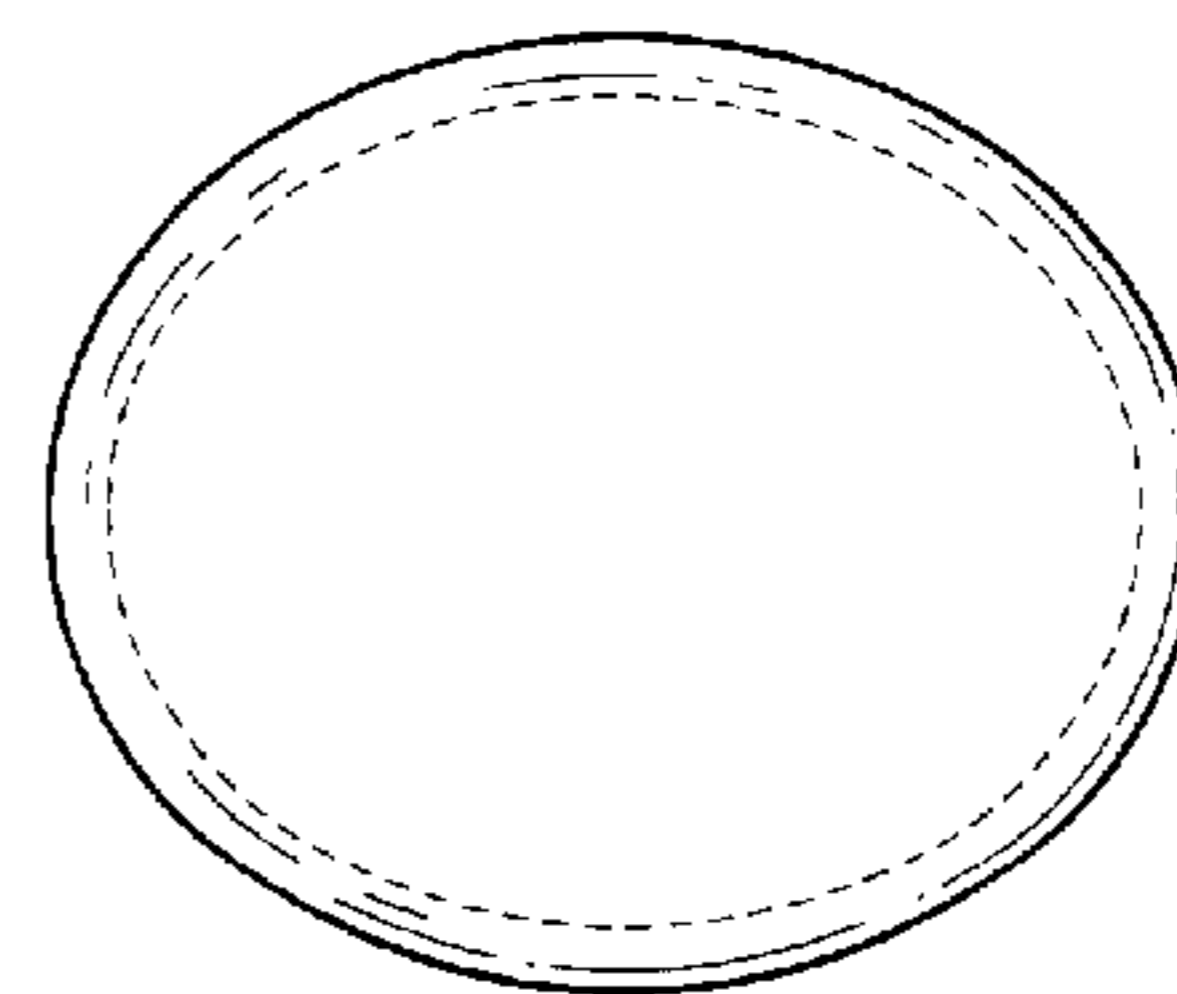
