(57) **CLAIM**

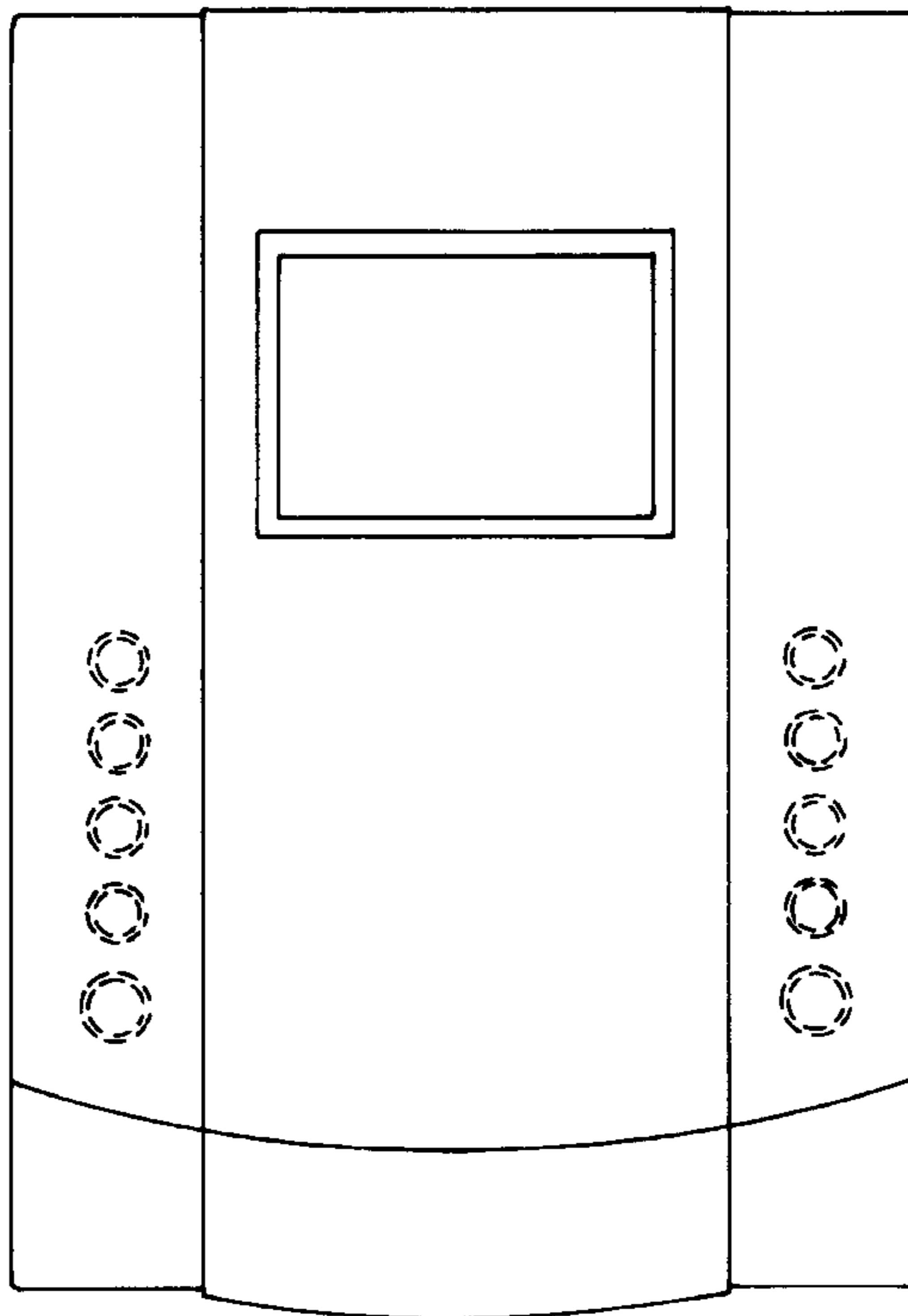
The ornamental design for a controller for television surveillance system, as shown and described.

**DESCRIPTION**

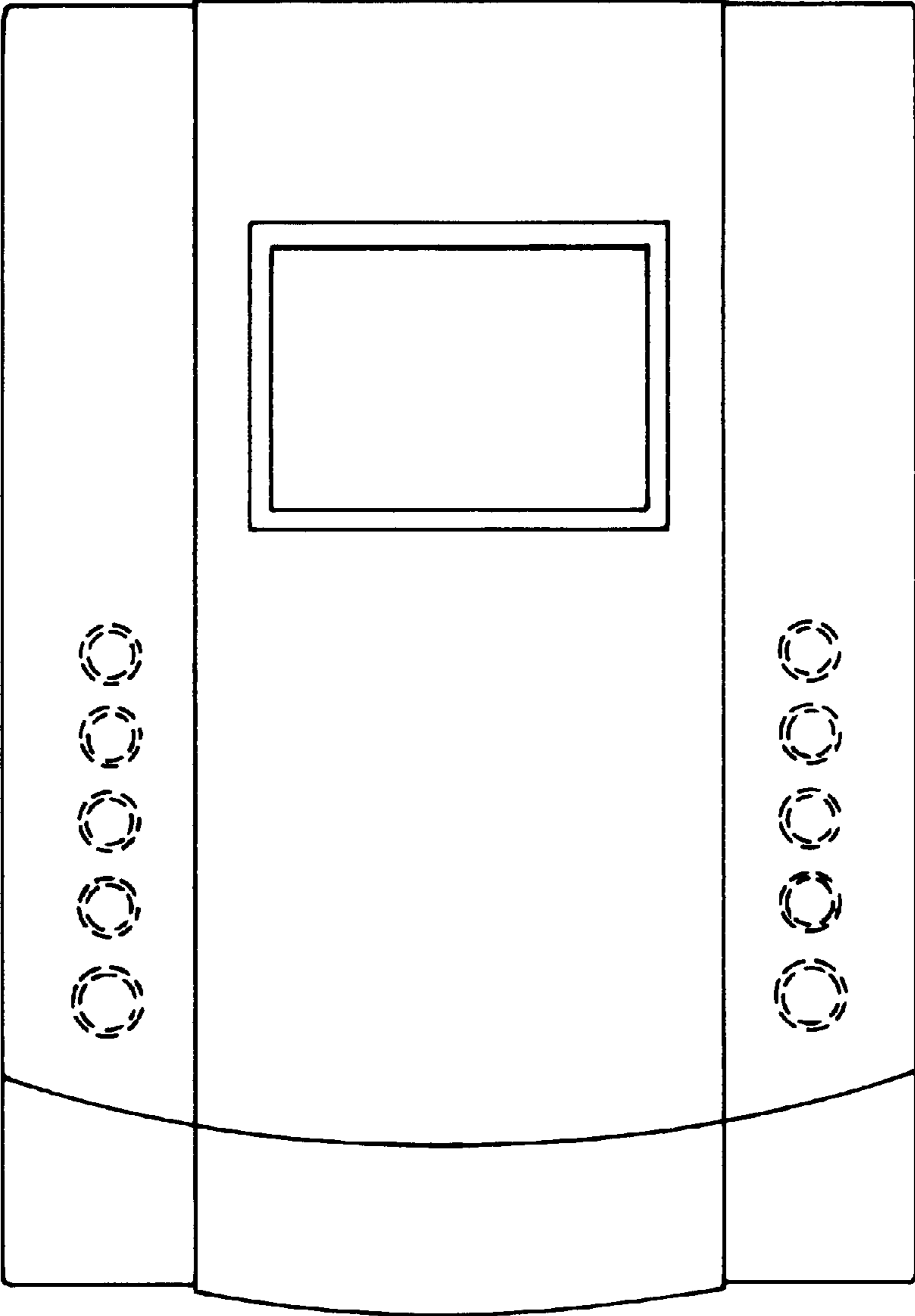
FIG. 1 is a front elevational view of a controller for television surveillance system showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side elevational view thereof; and FIG. 6 is a cross-sectional view thereof.

The broken lines (immediately adjacent to the claimed areas in FIGS. 2–6) represent the bounds of the claim and the dotted lines in FIGS. 2–6 are for illustrative purposes only. None of the broken lines form part of the claimed design. The left side elevational view is a mirror image of the right side elevational view.

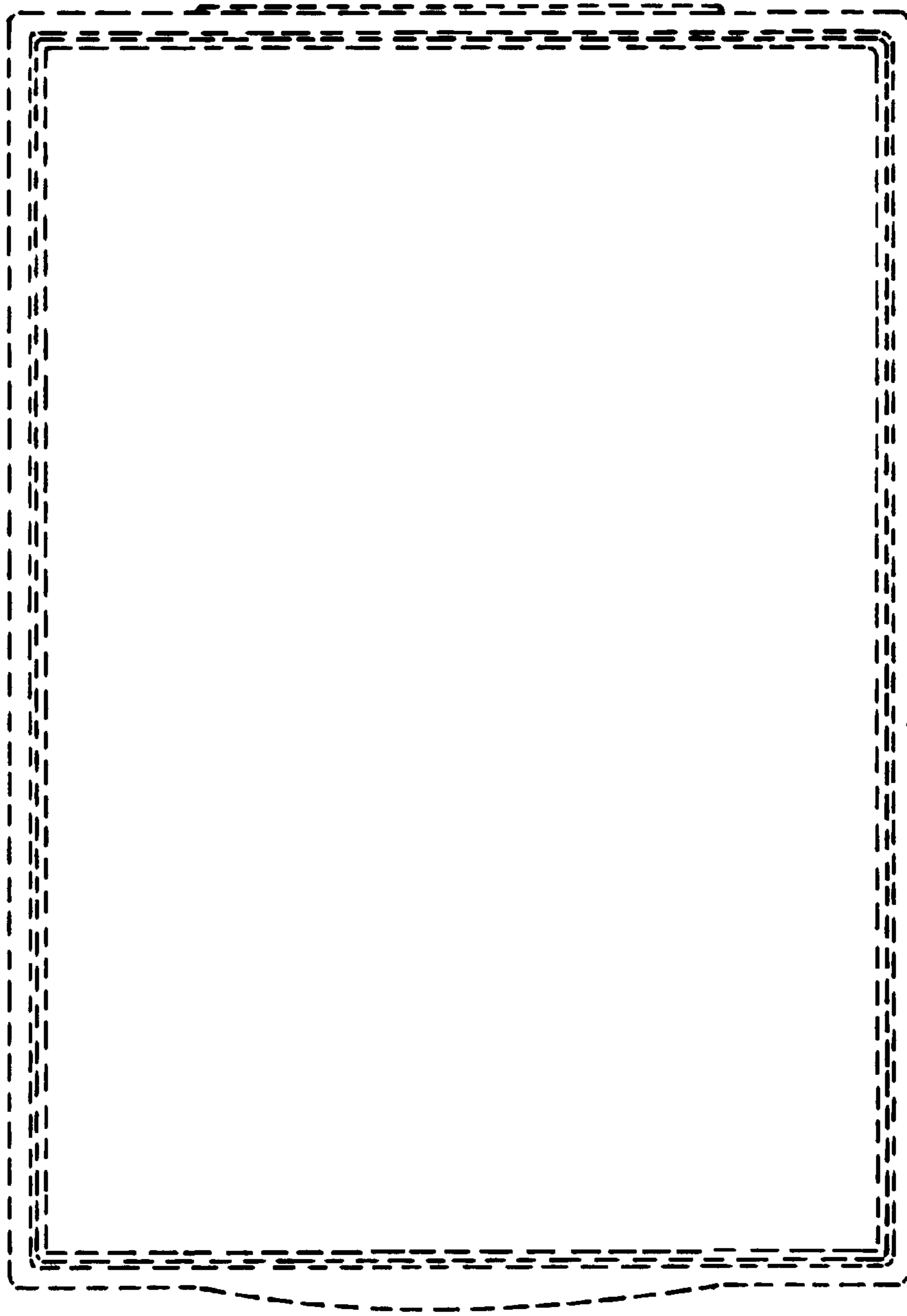

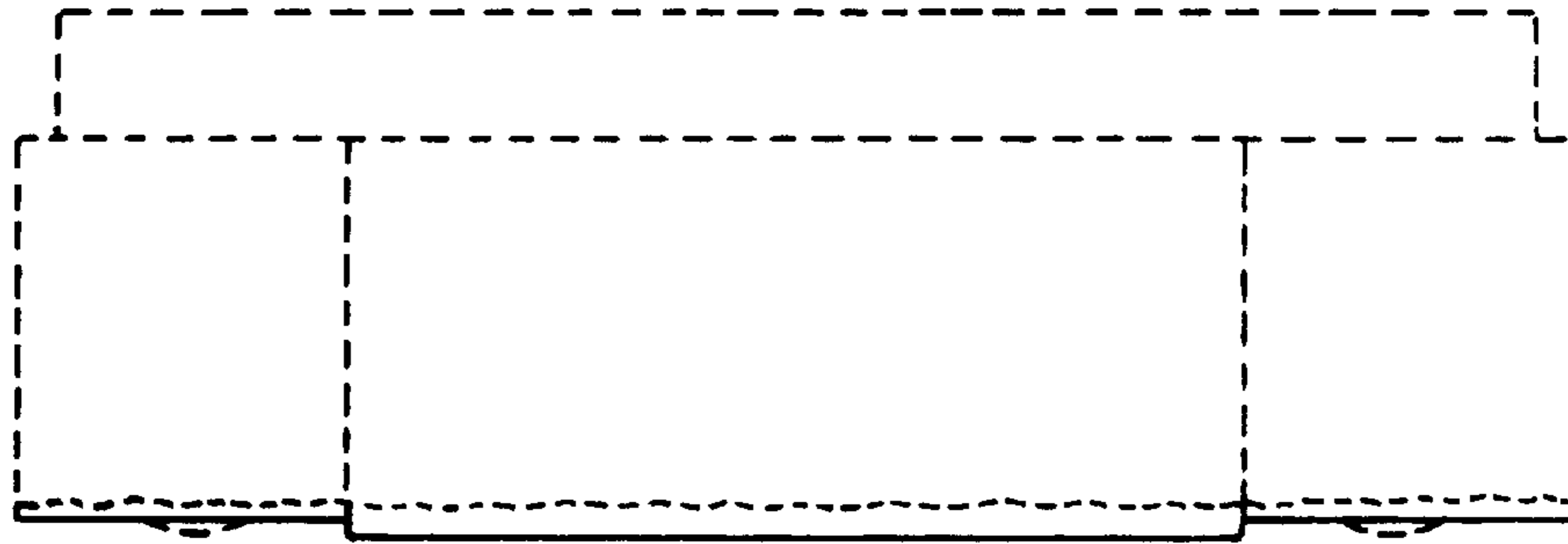

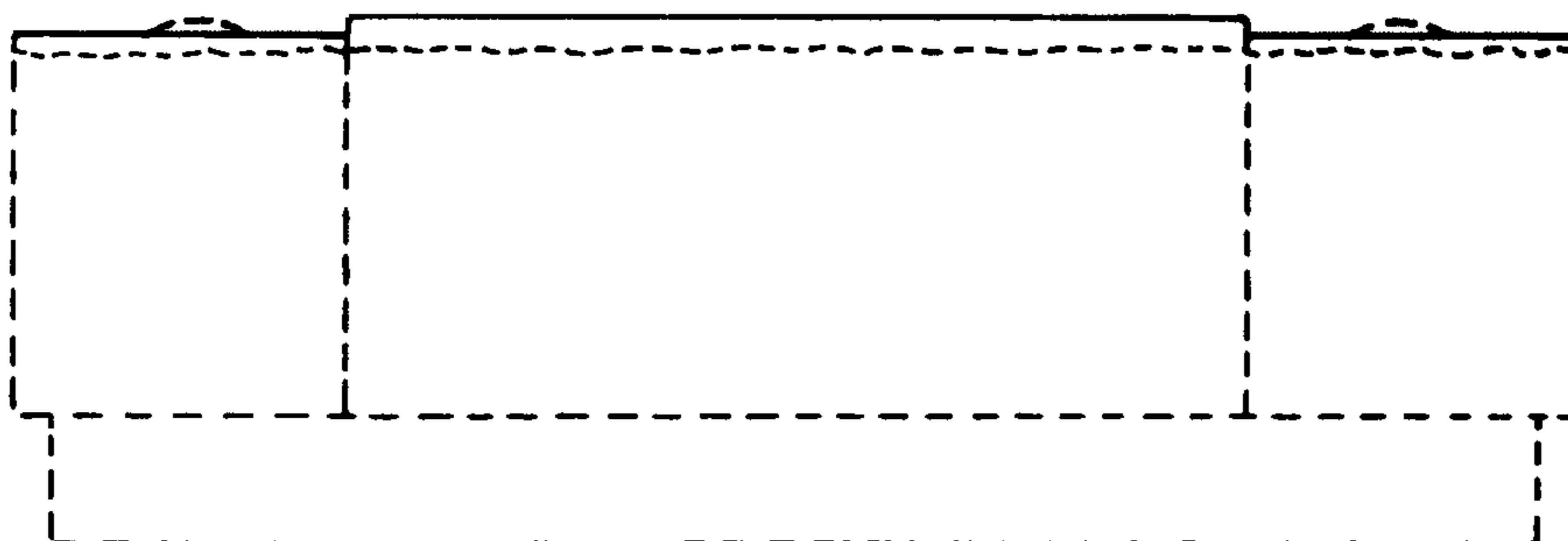

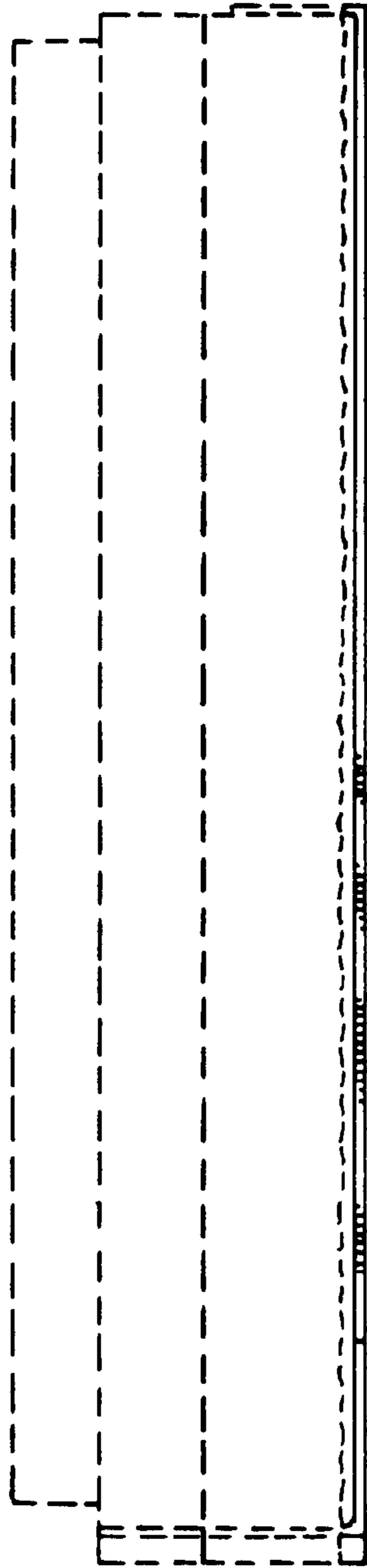
