(57) **CLAIM**

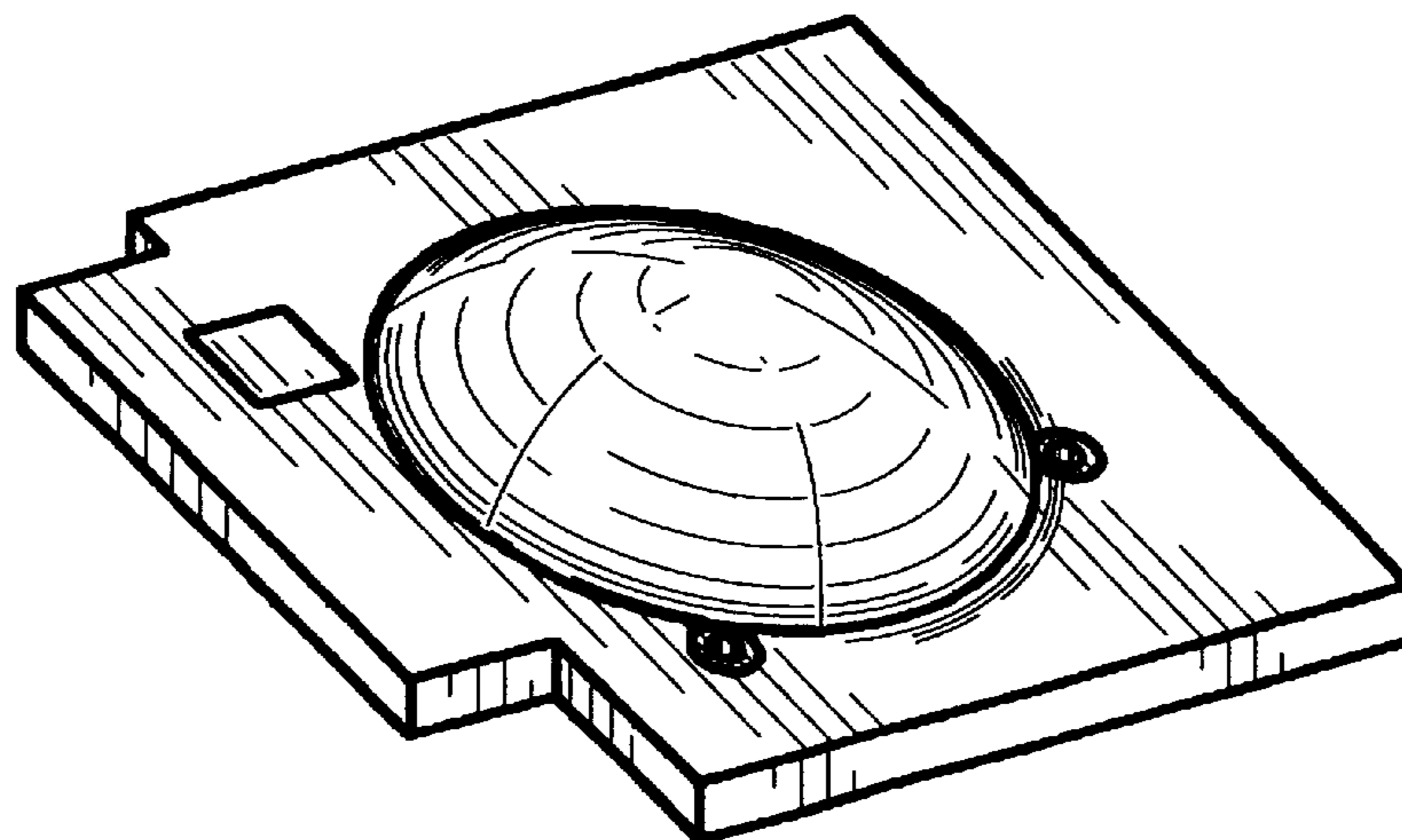
We claim the ornamental design for an information storage semiconductor element, as shown and described.

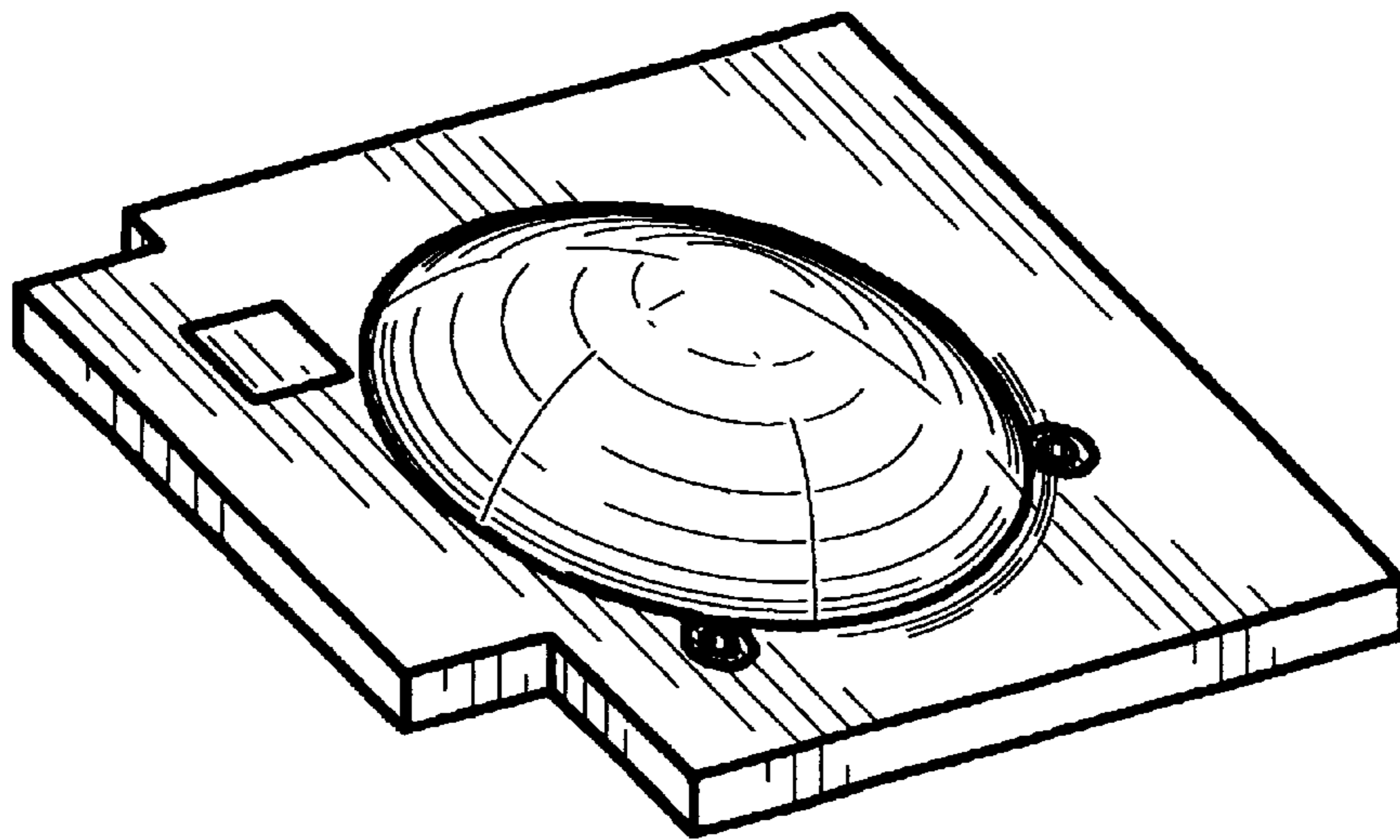

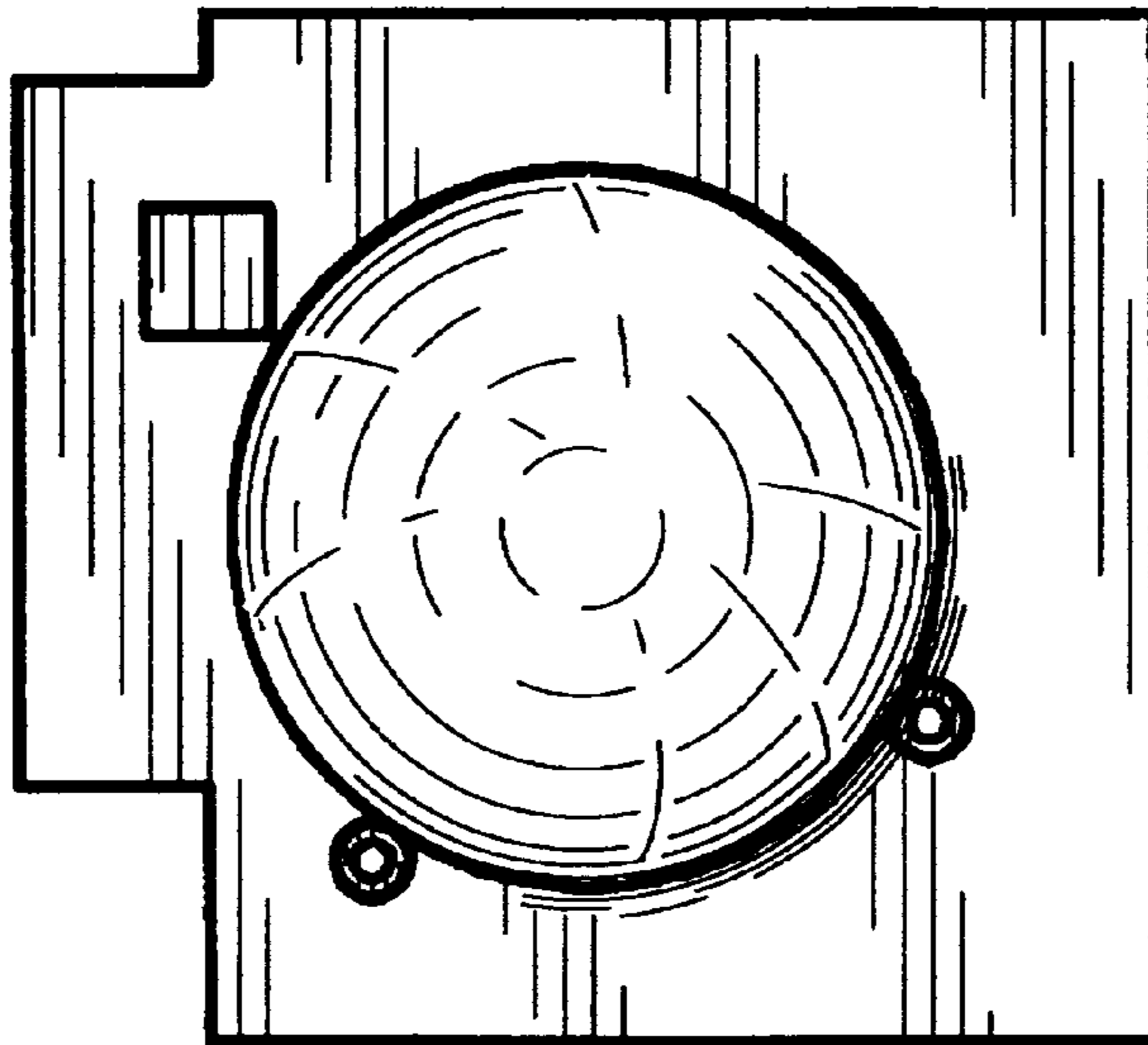

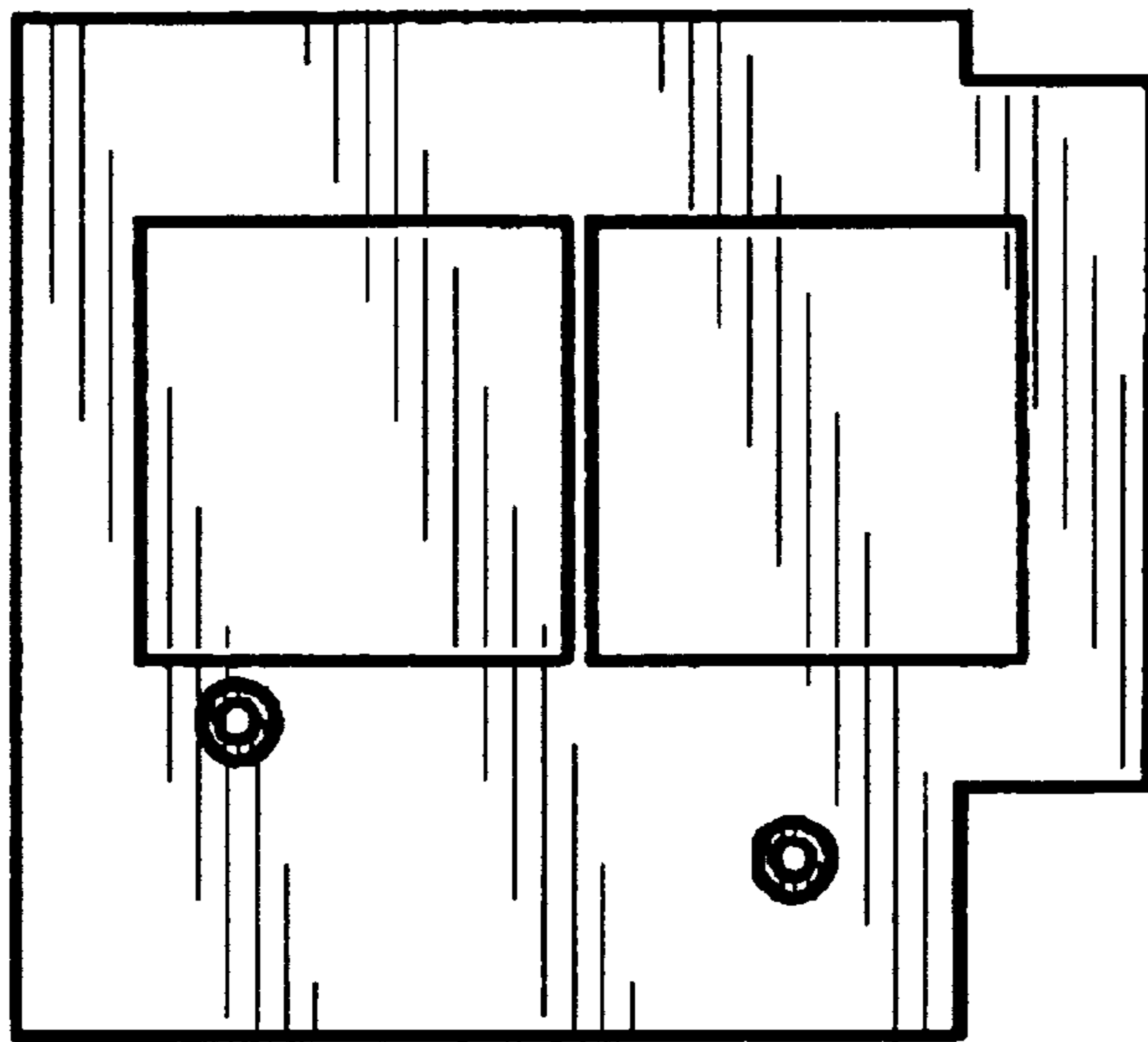
