(57) **CLAIM**

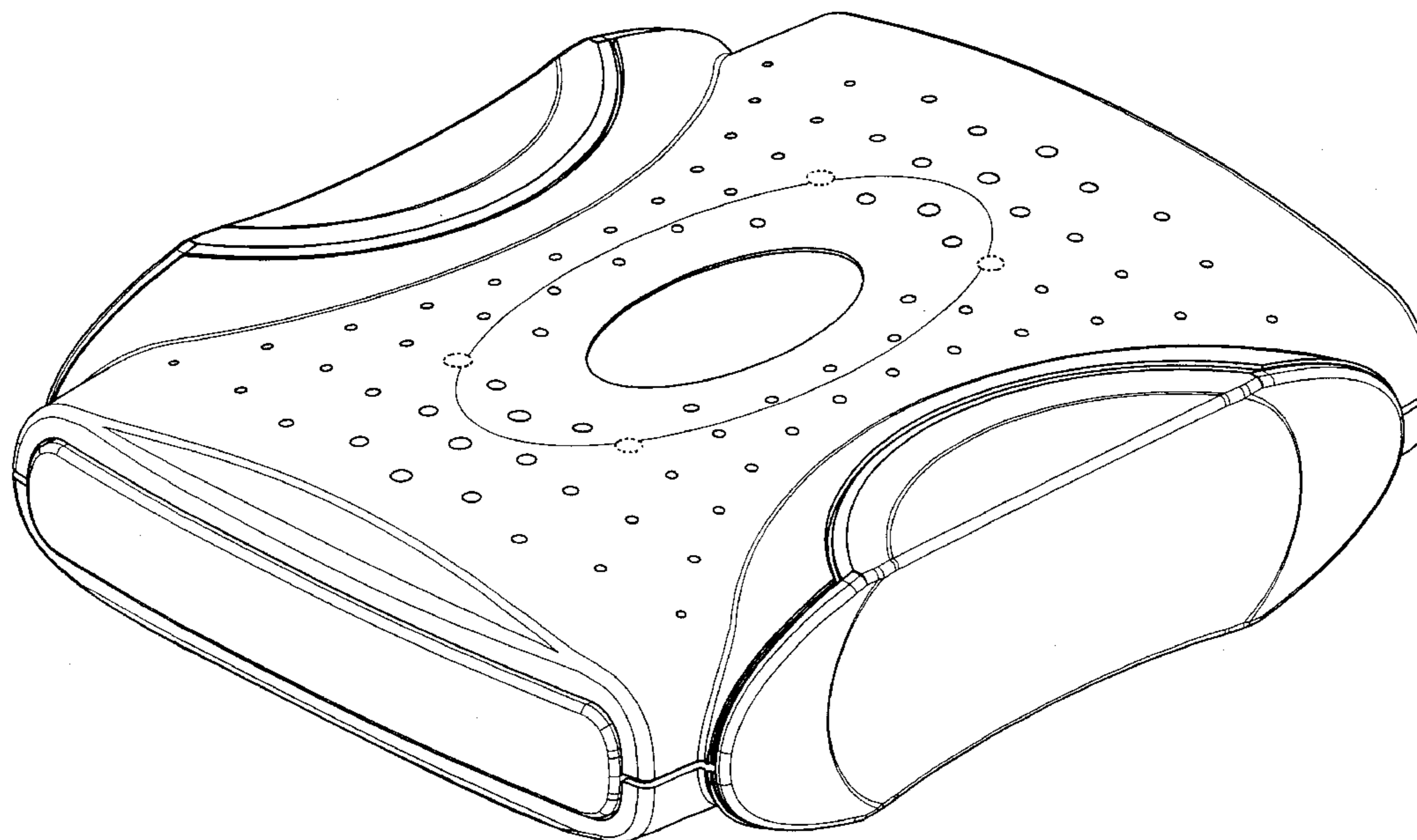
The ornamental design for an access appliance device enclosure, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of an access appliance device enclosure showing our new design; FIG. 2 is a top, rear and right side perspective view thereof; FIG. 3 is a top plan perspective view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a left side perspective view thereof; FIG. 6 is a right side perspective view thereof; FIG. 7 is a rear elevation thereof; FIG. 8 is a front elevation thereof; and, FIG. 9 is another front perspective view thereof in an alternate position.

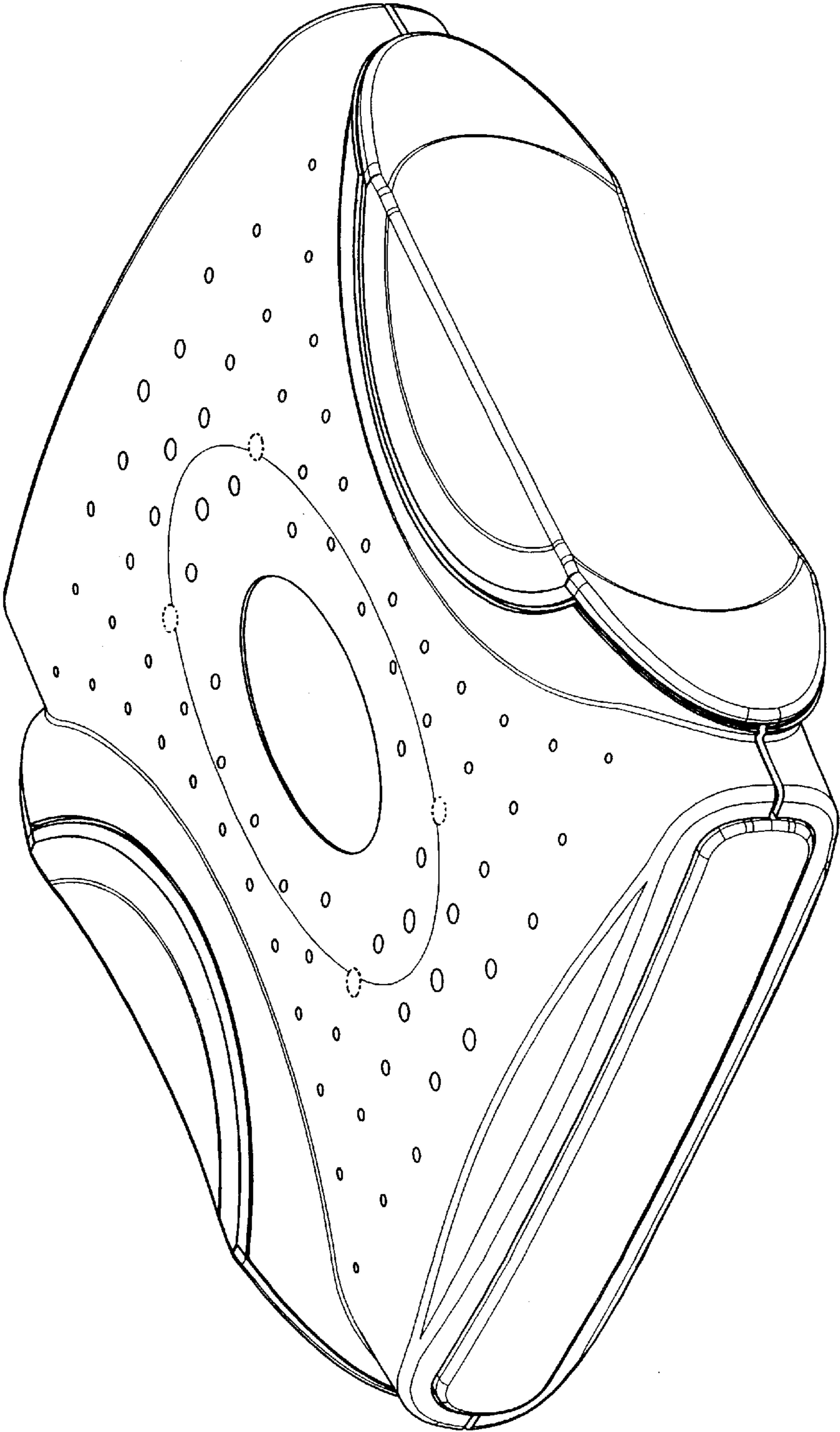

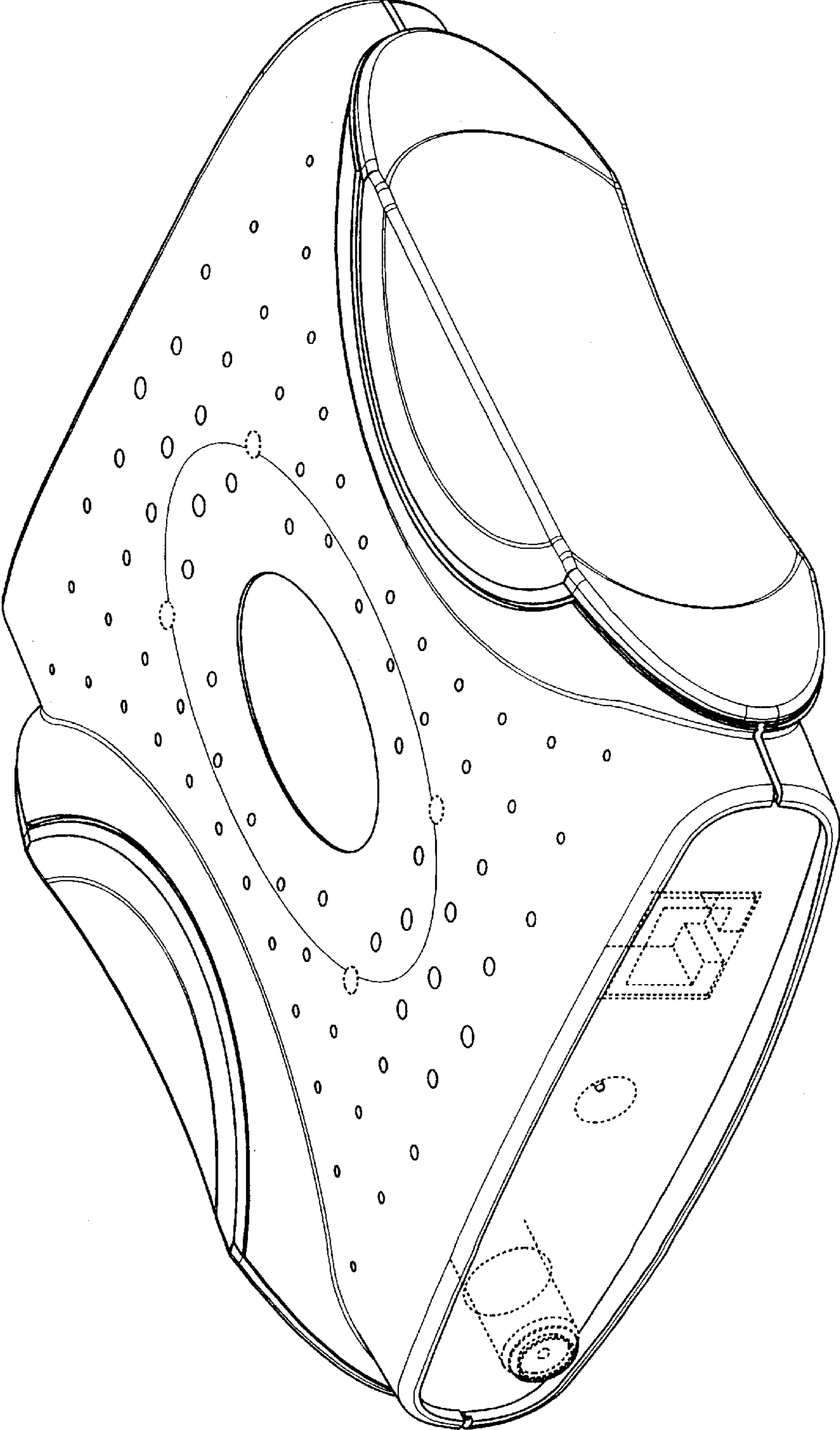

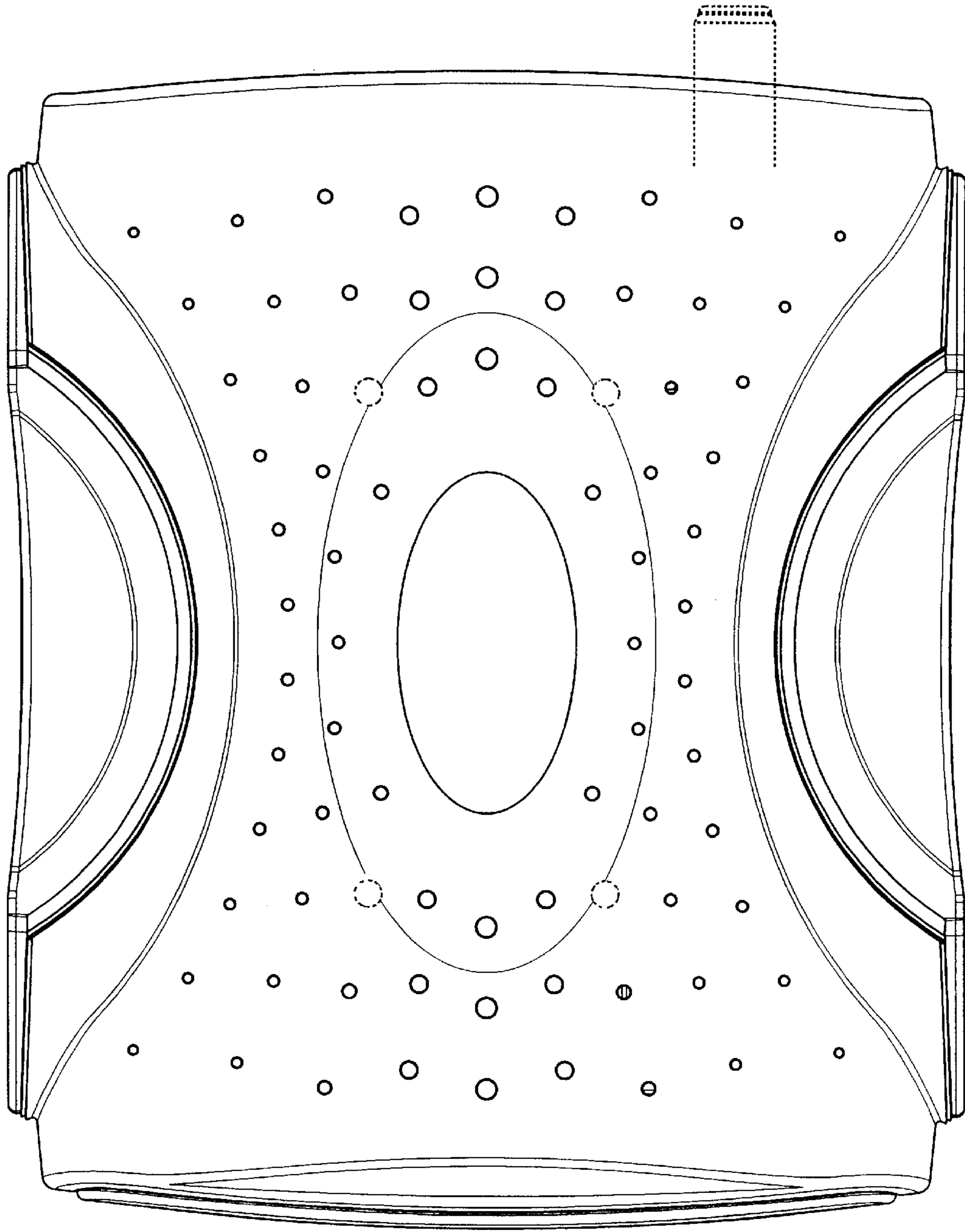

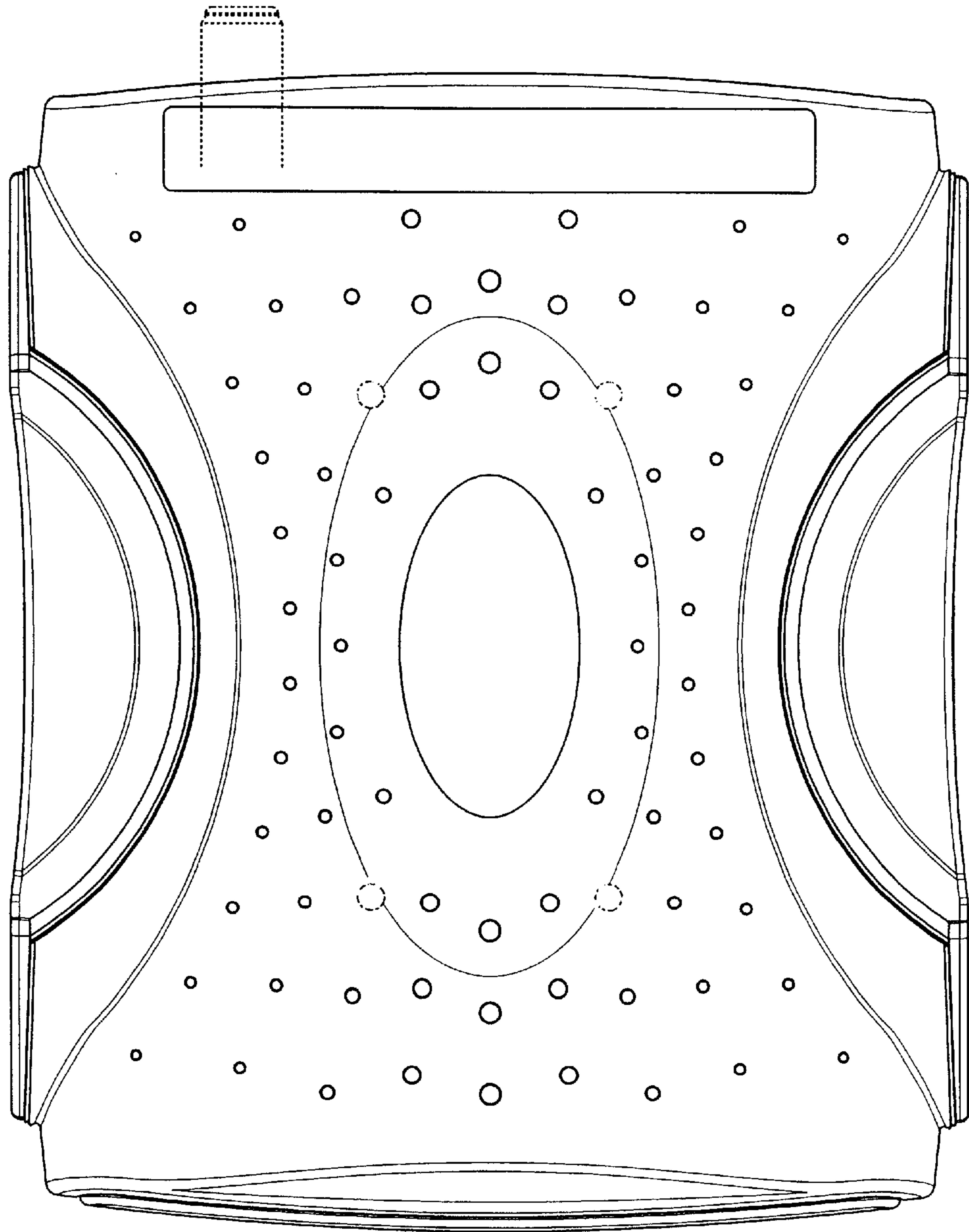

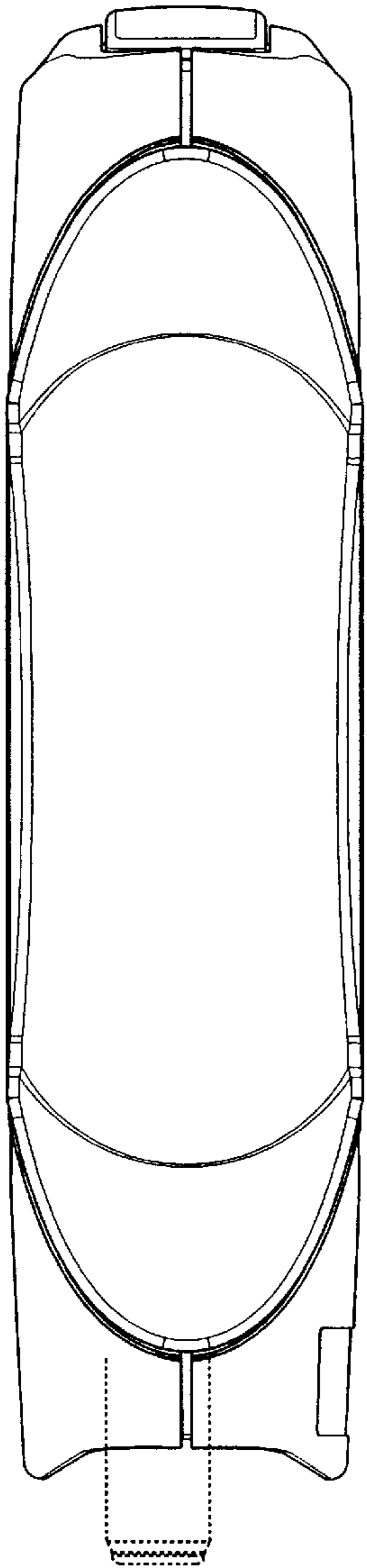

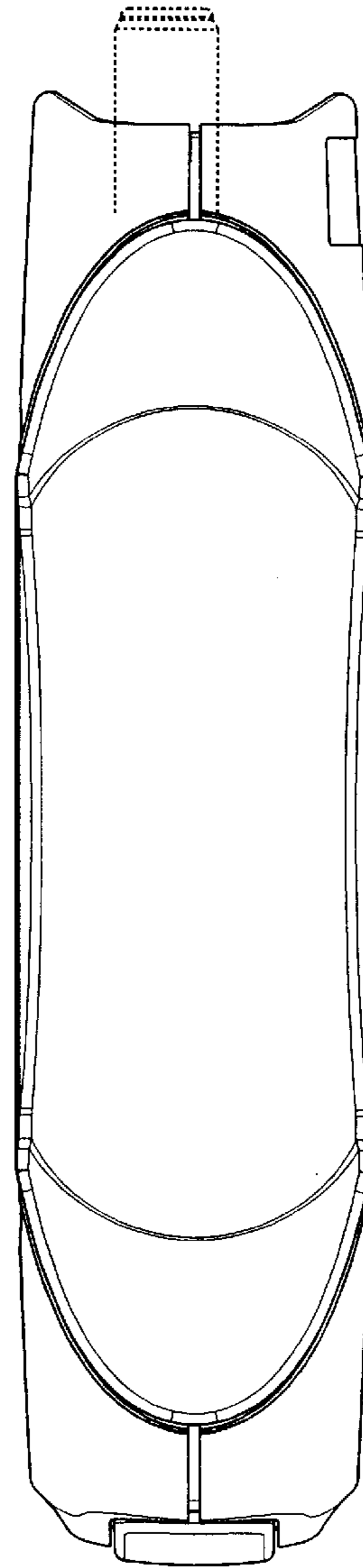

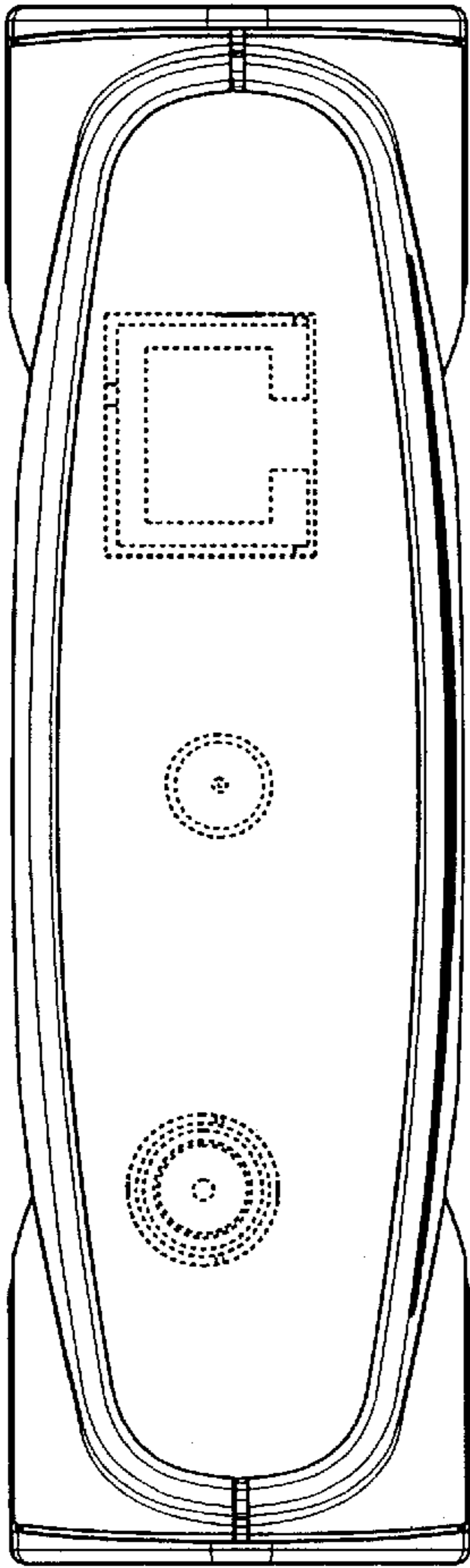

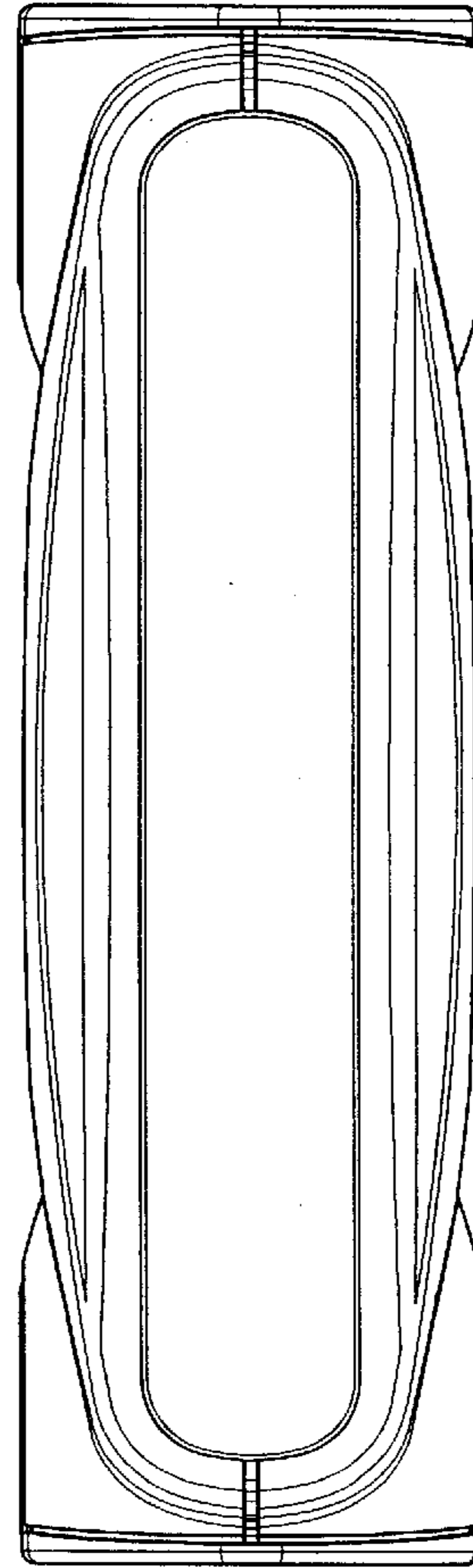

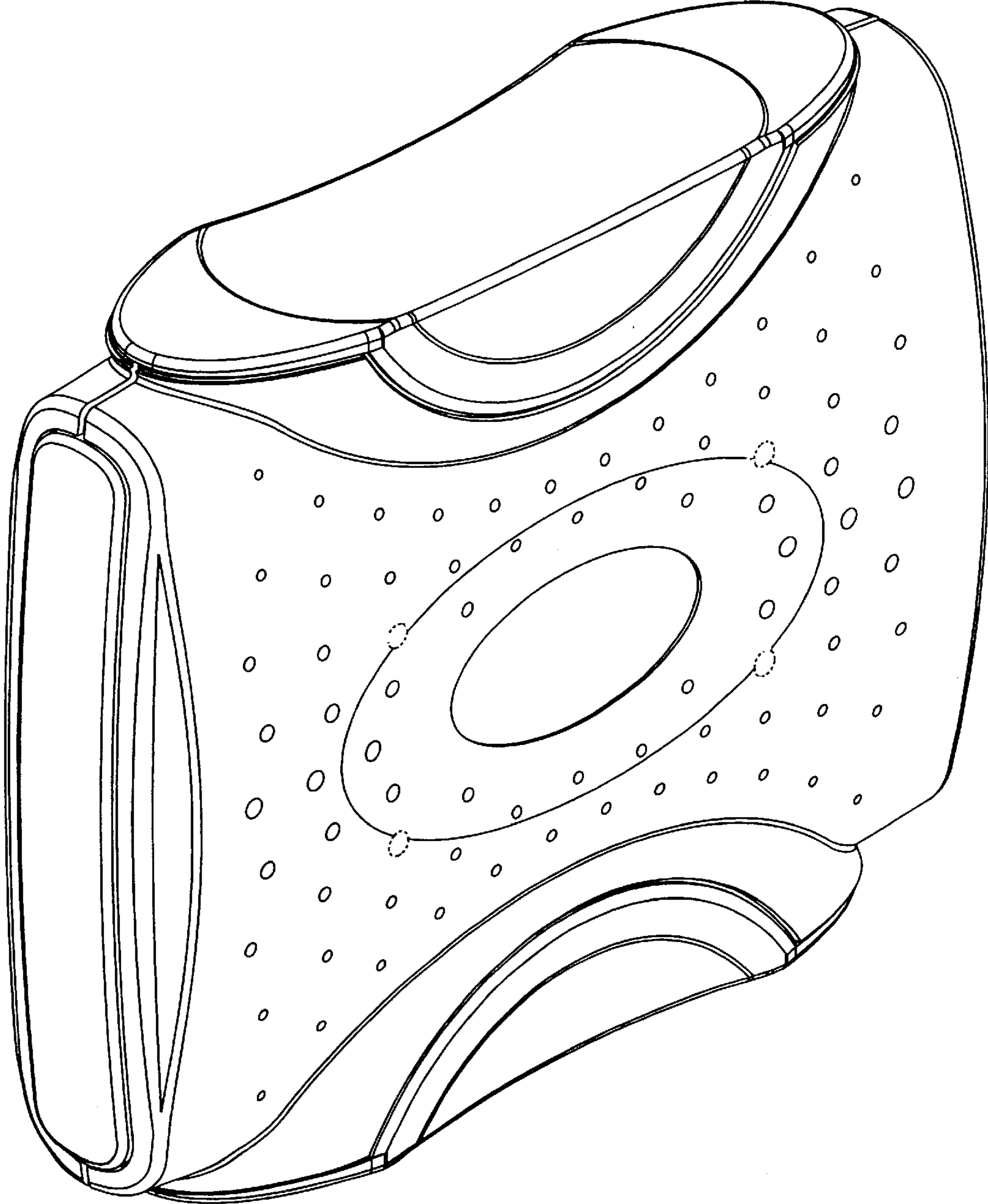
