**DESCRIPTION**

FIG. 8 is a sectional view taken along line 8—8 of FIG. 5, with part of the inside structure being omitted for clarity;

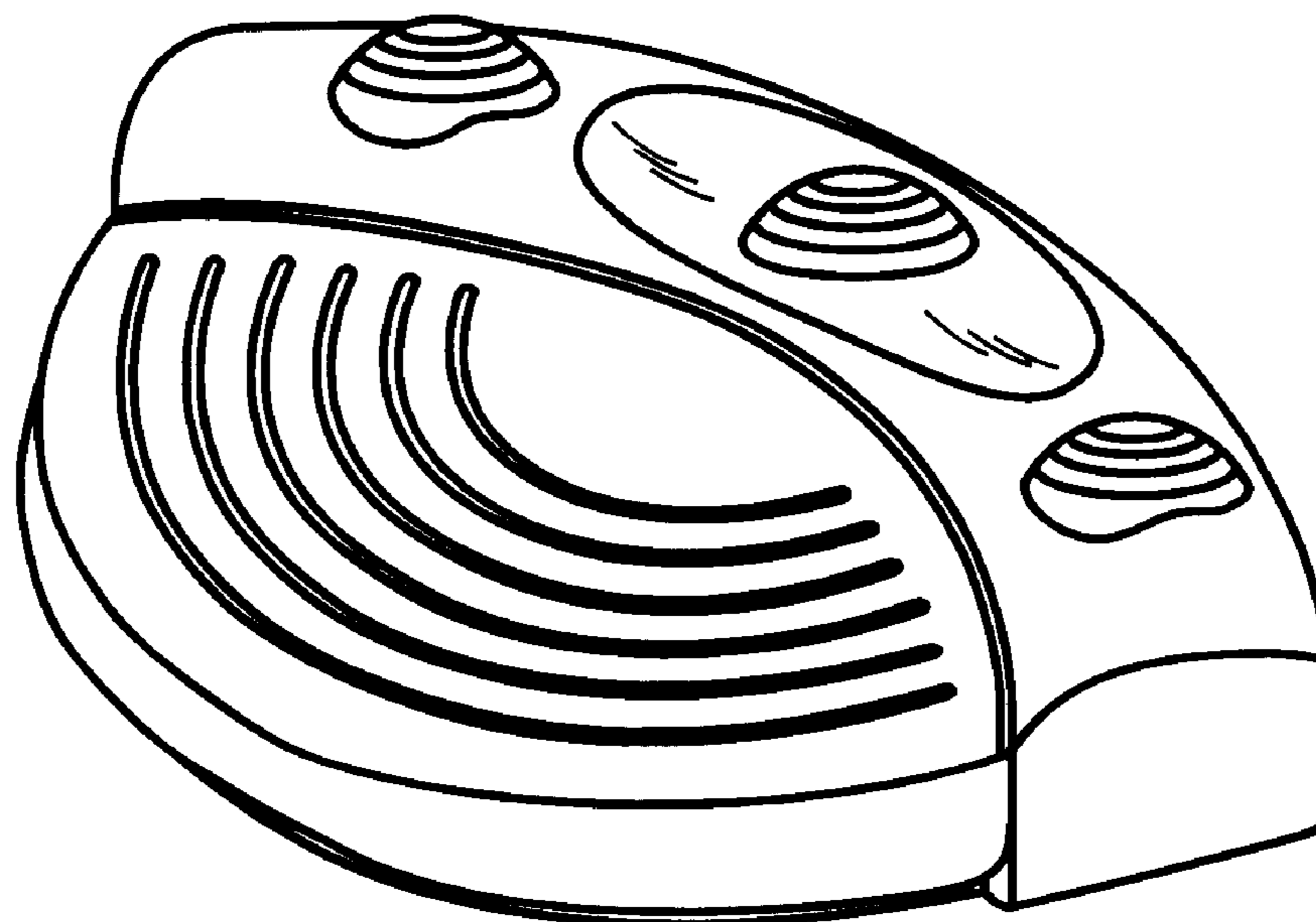
FIG. 9 is a top plan view thereof, shown in its environmental use;

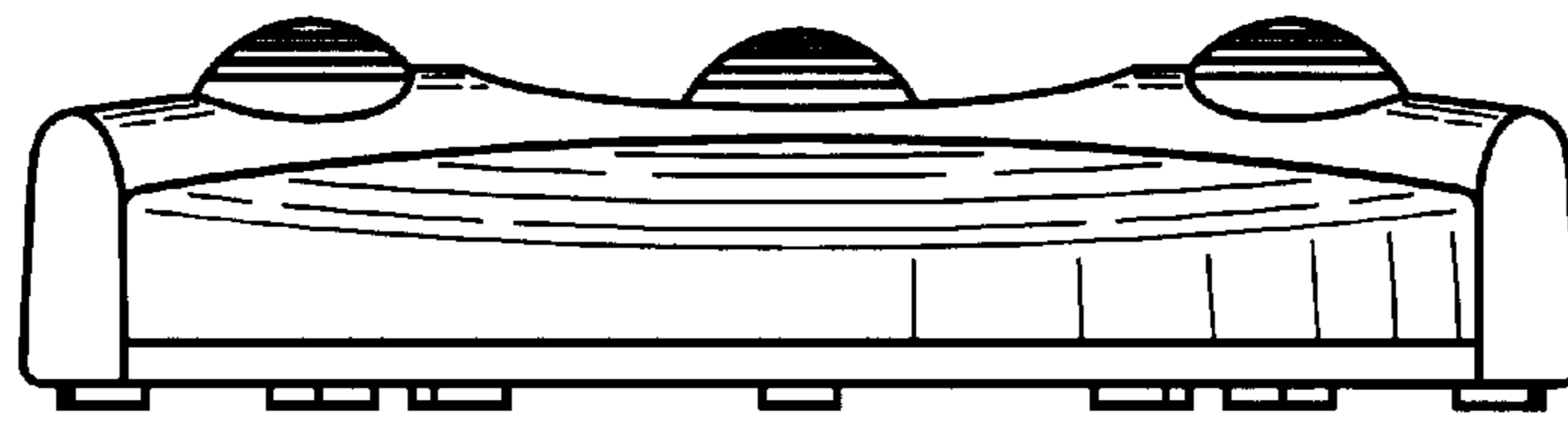
FIG. 10 is a right side elevational view thereof, shown in its environmental use; and,

FIG. 11 is a perspective view thereof.

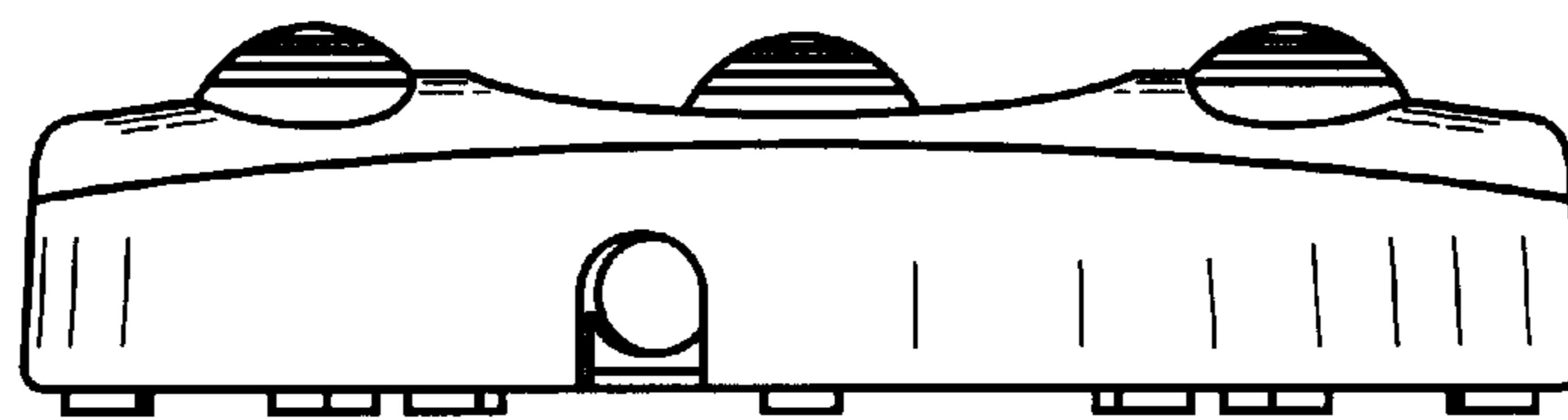
The broken line showing of cable and connector is for illustrative purpose only and form no part of the claimed design.

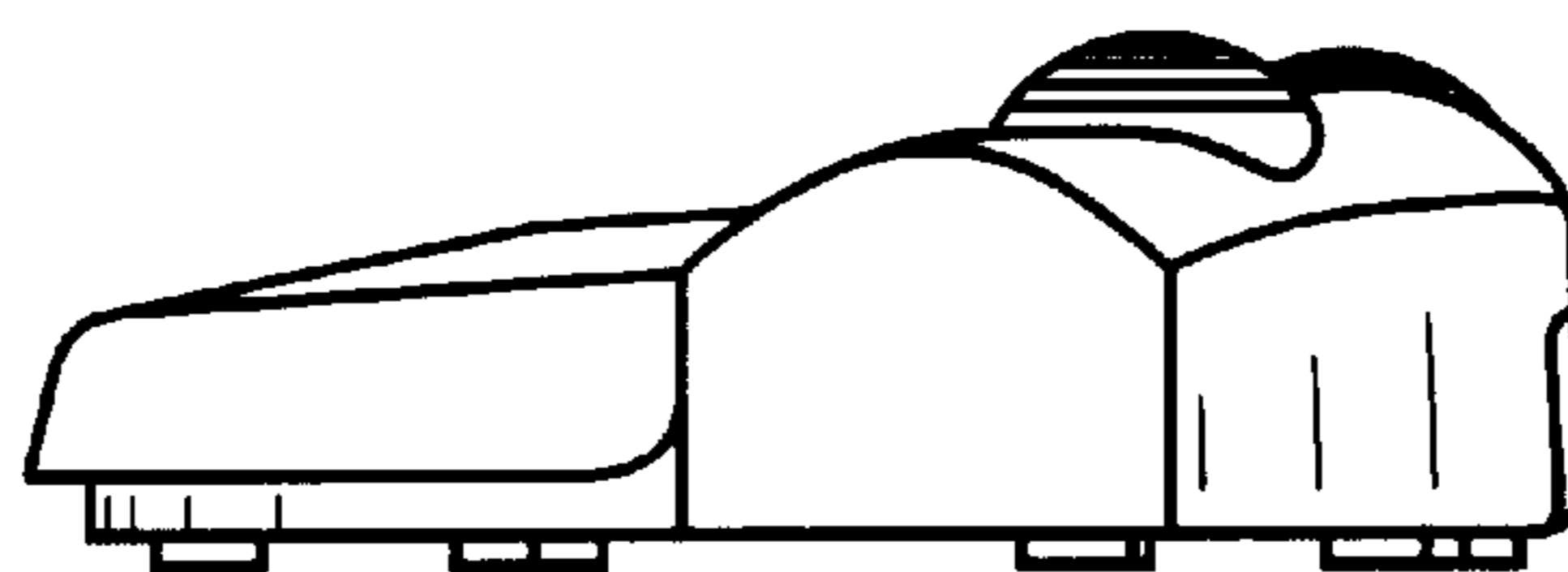




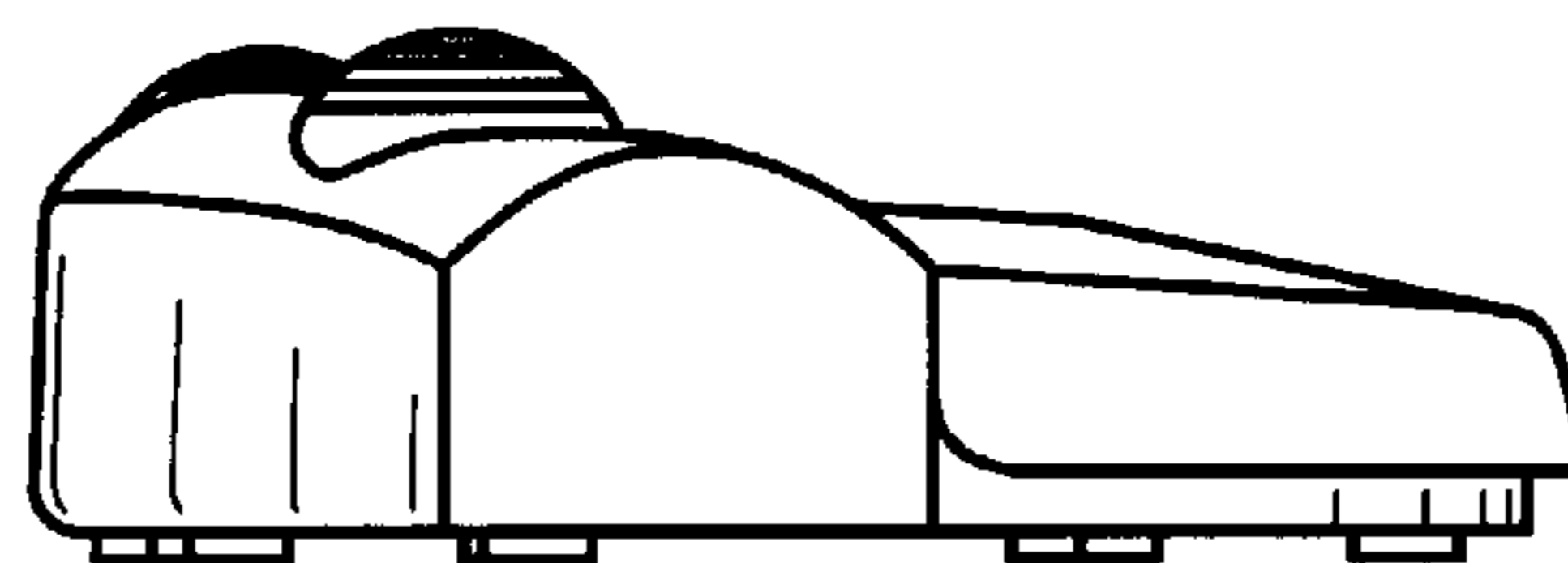

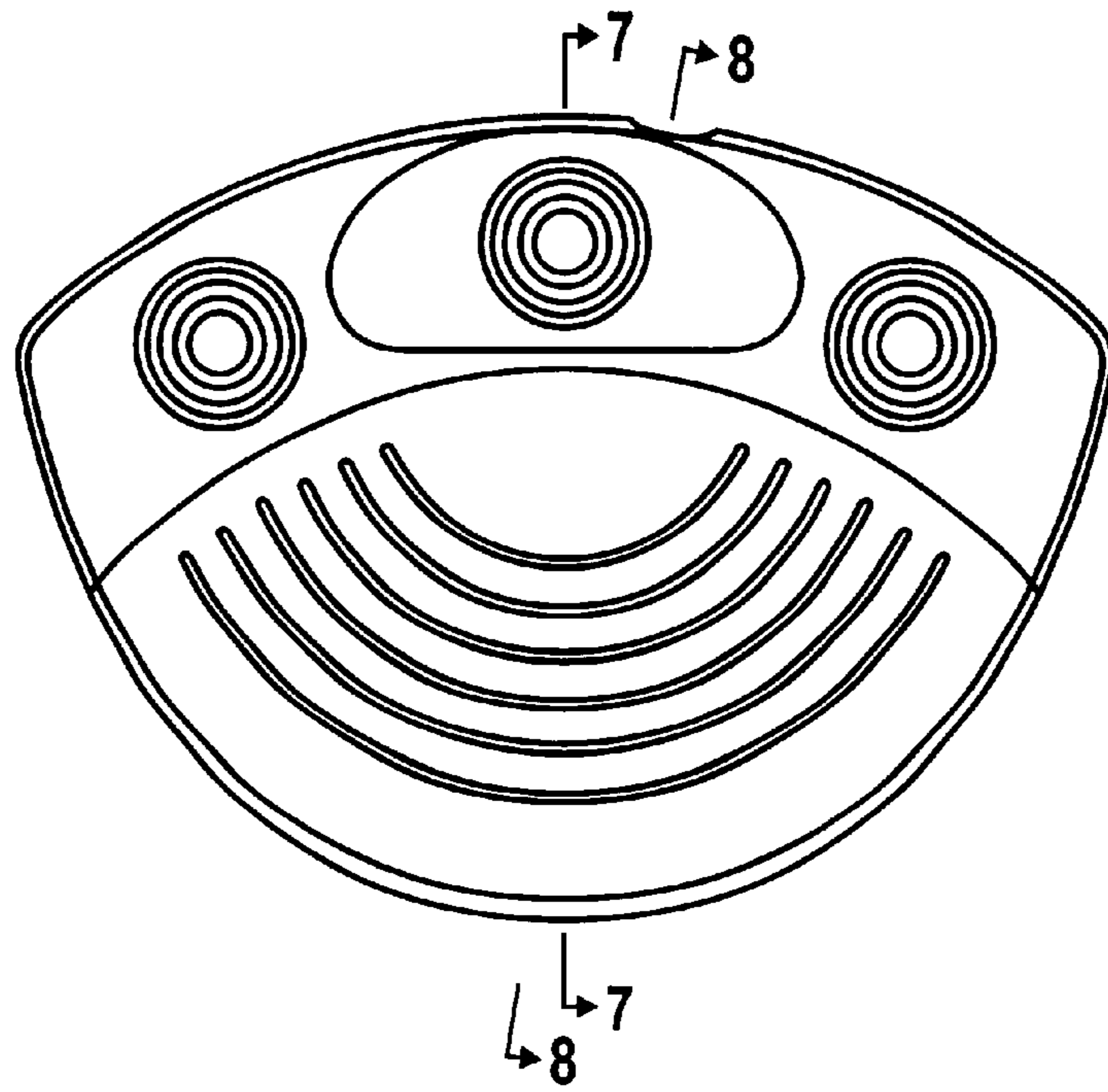

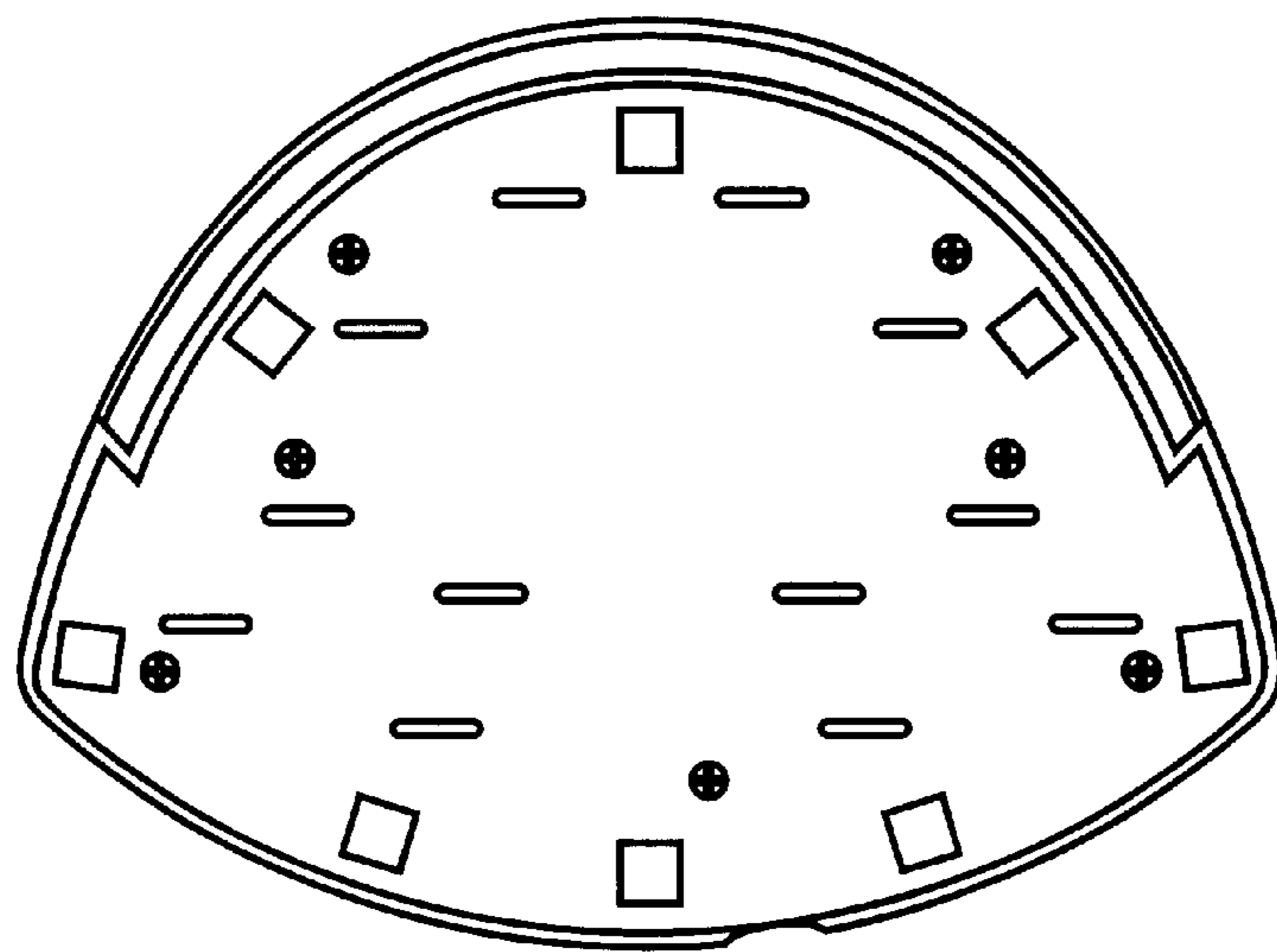

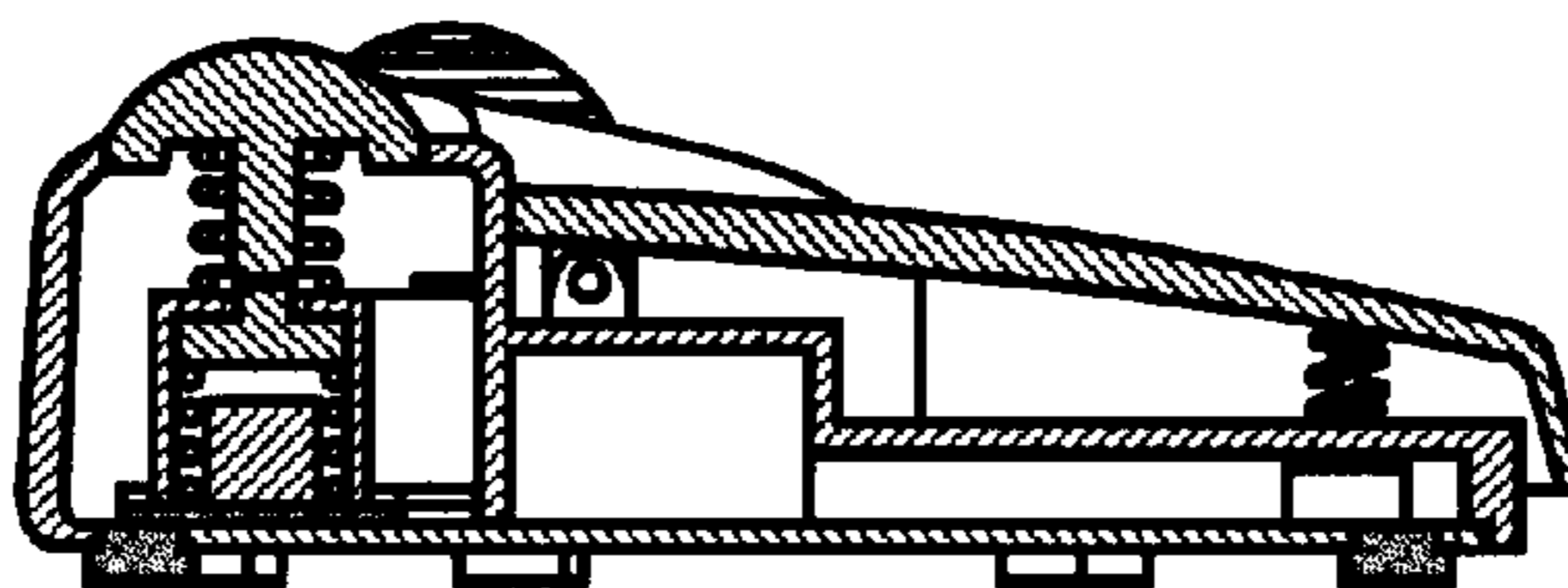

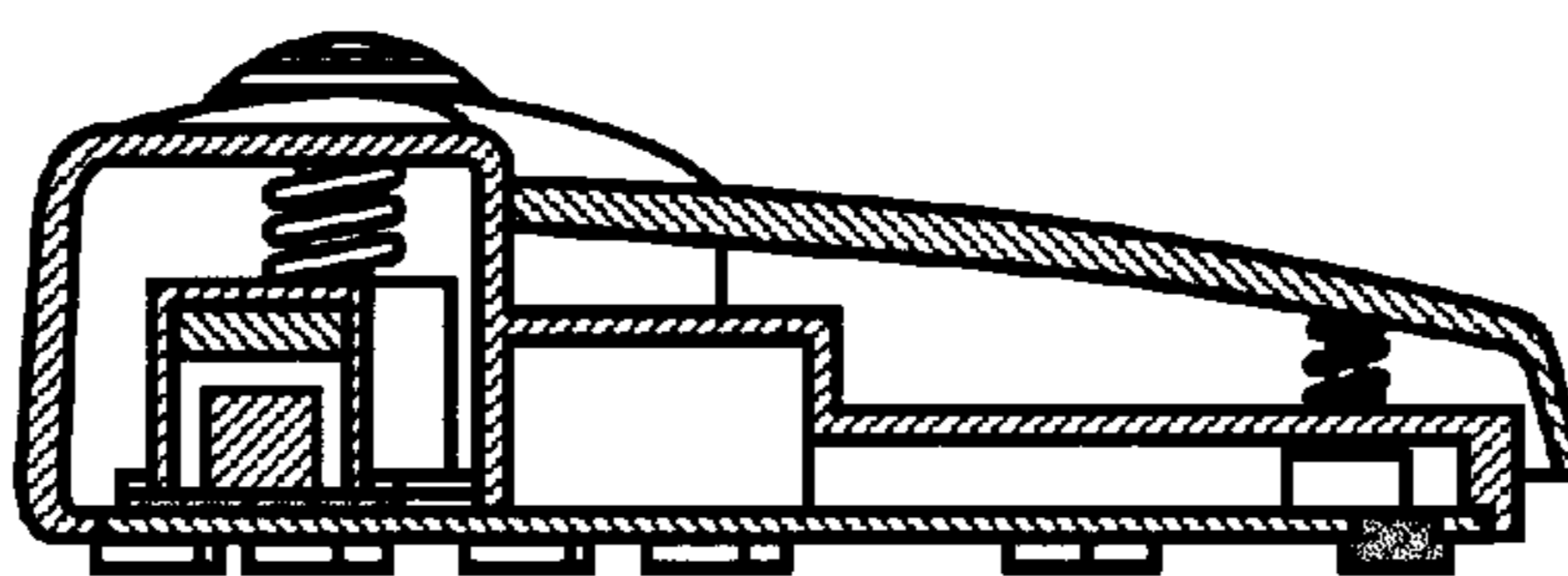

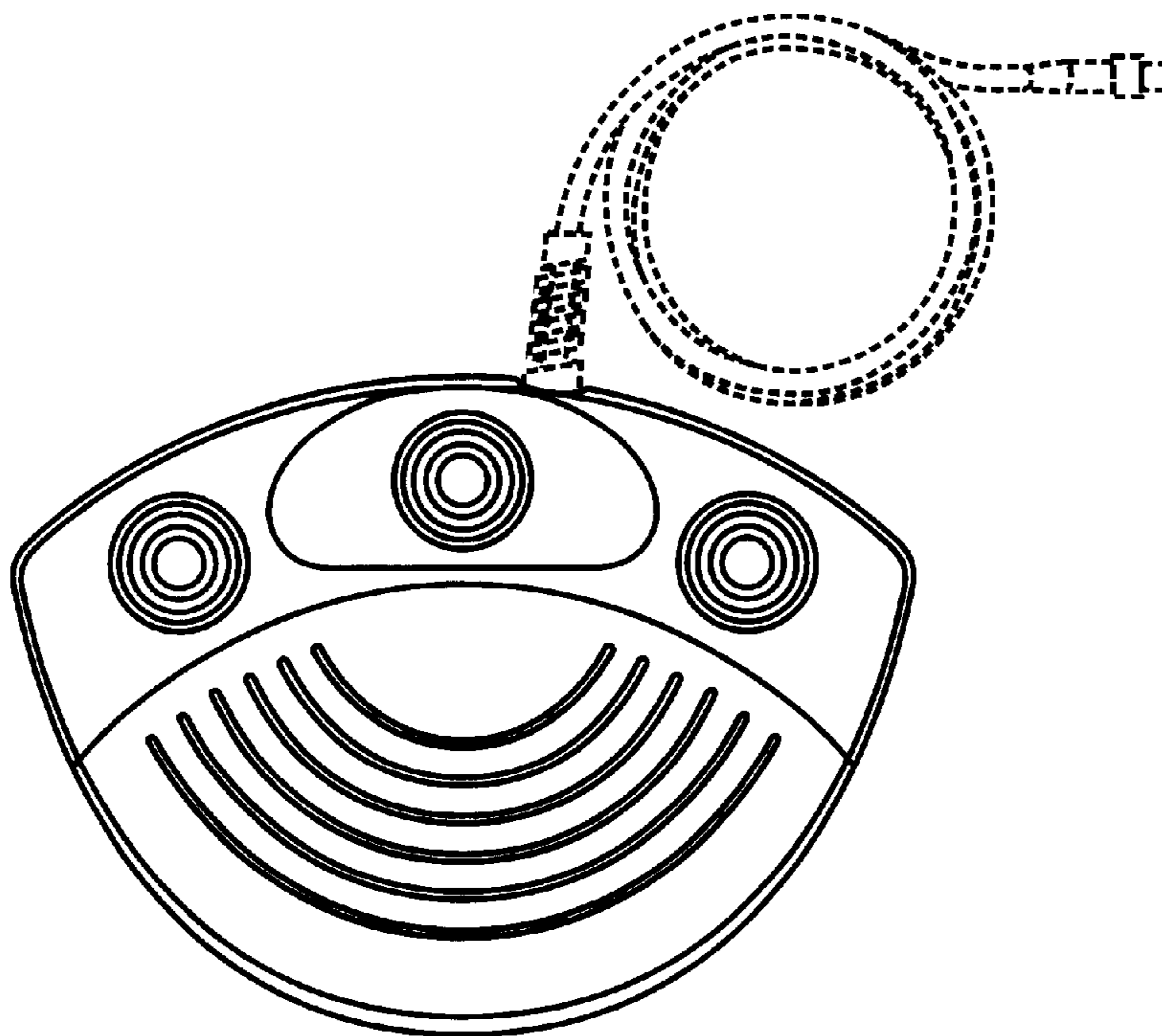
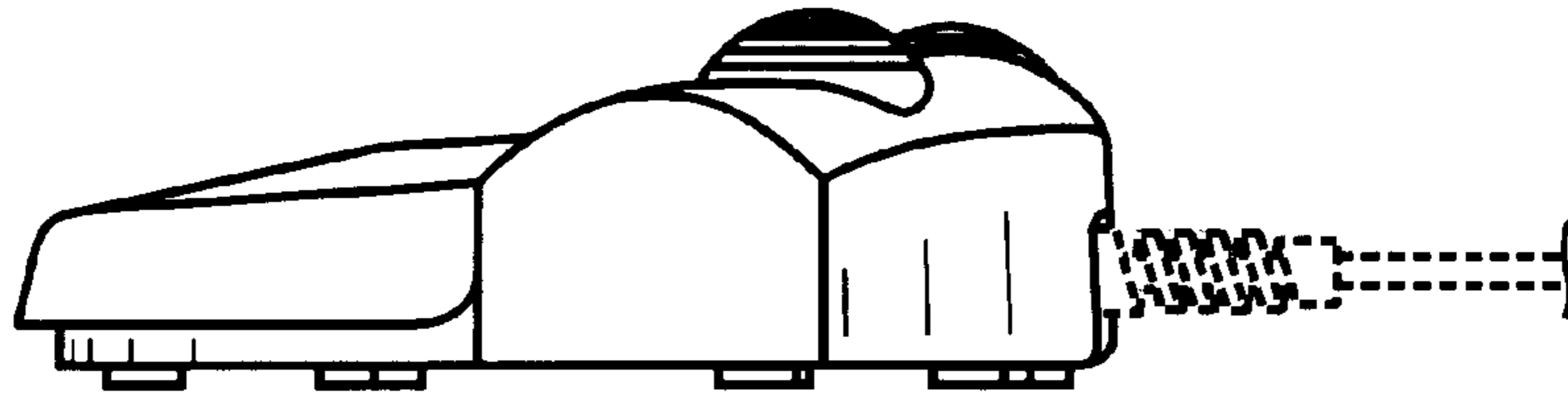
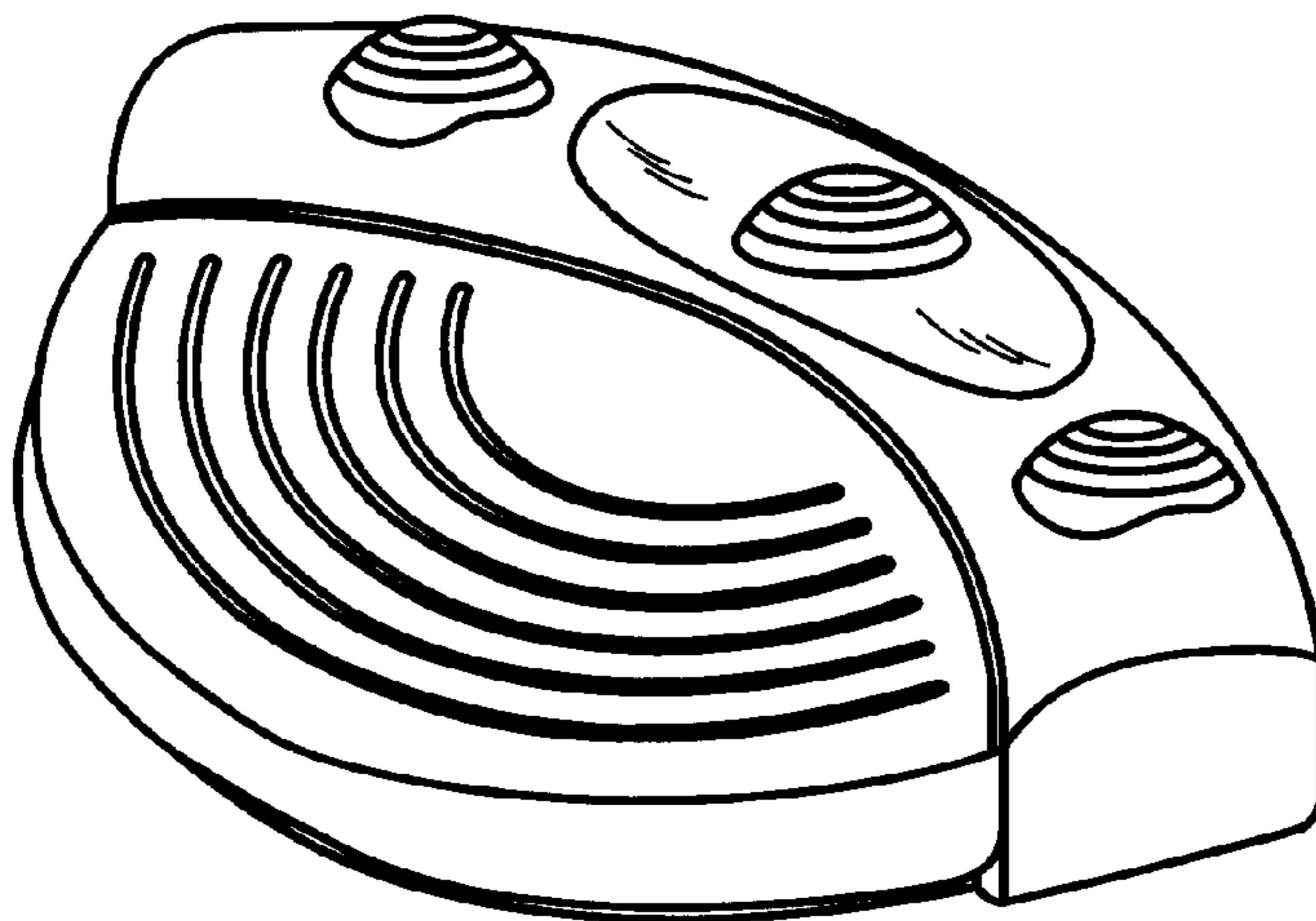
