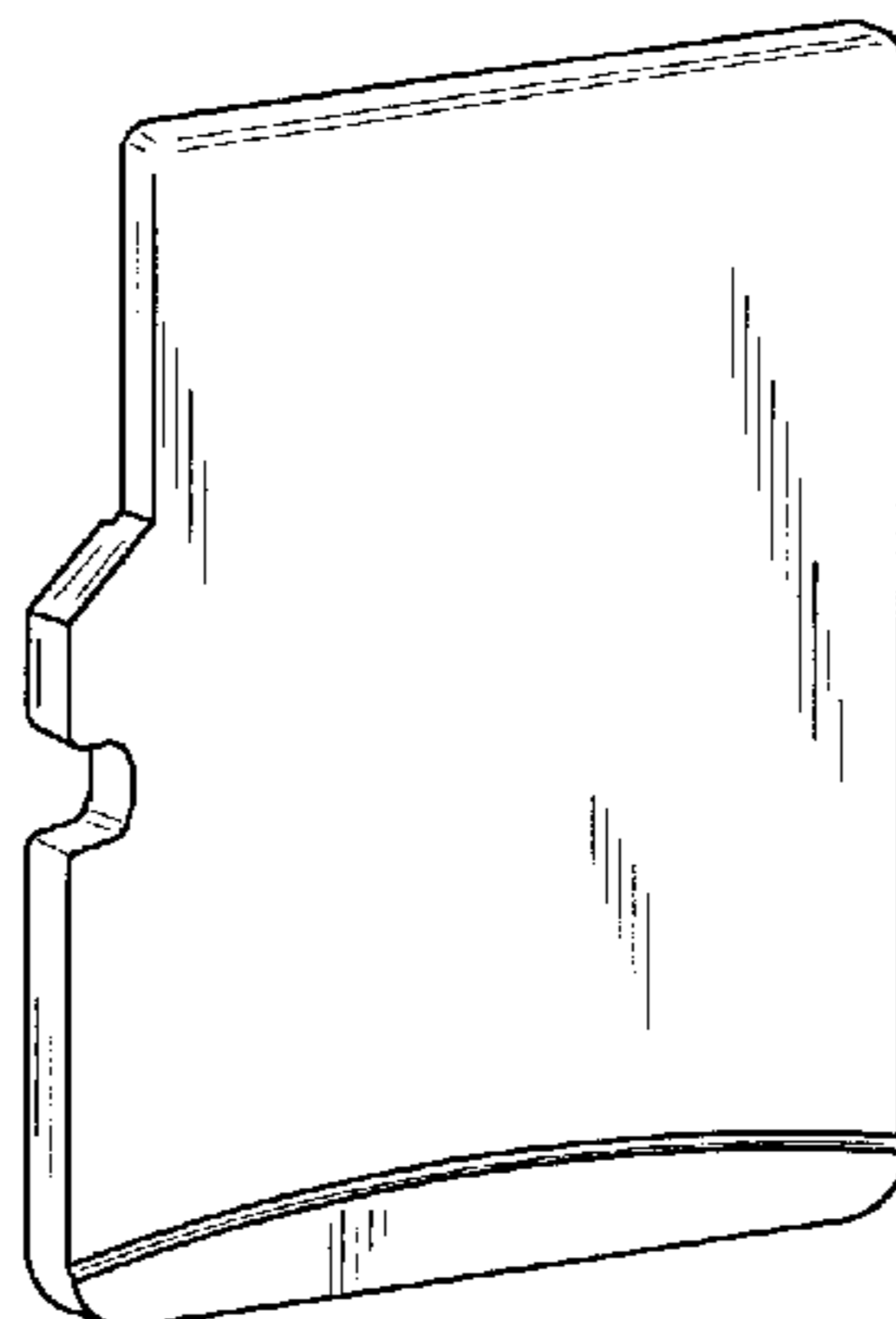
(57) **CLAIM**

The ornamental design for a memory card, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a memory card, on a slightly reduced scale;

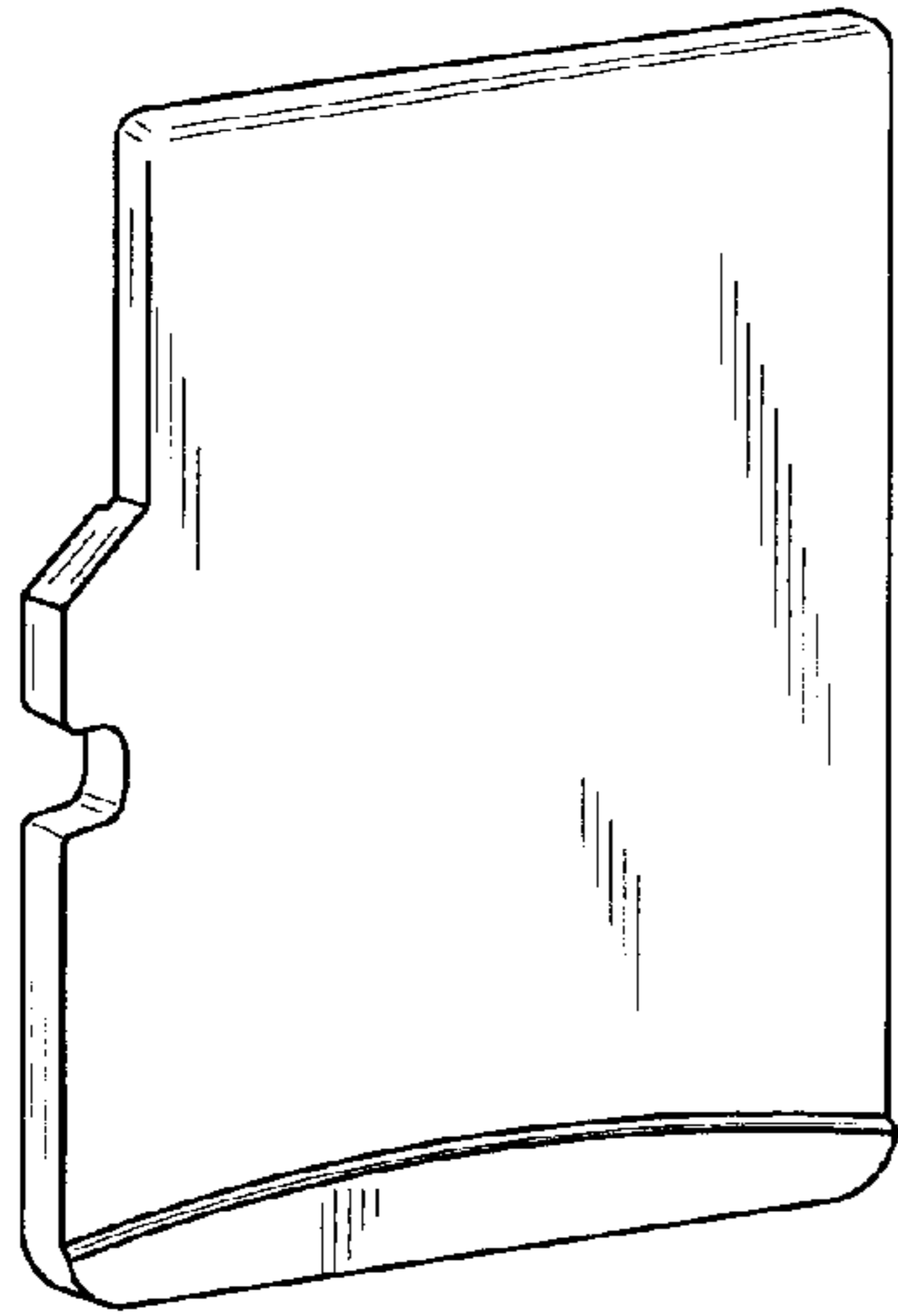

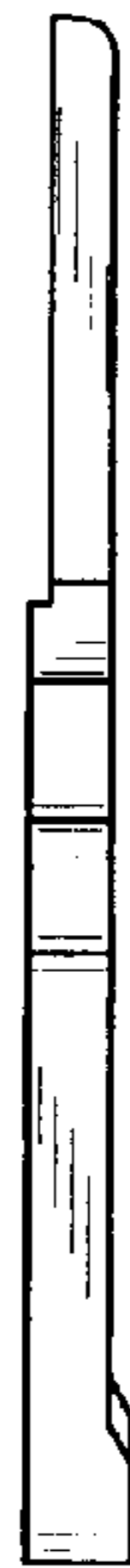

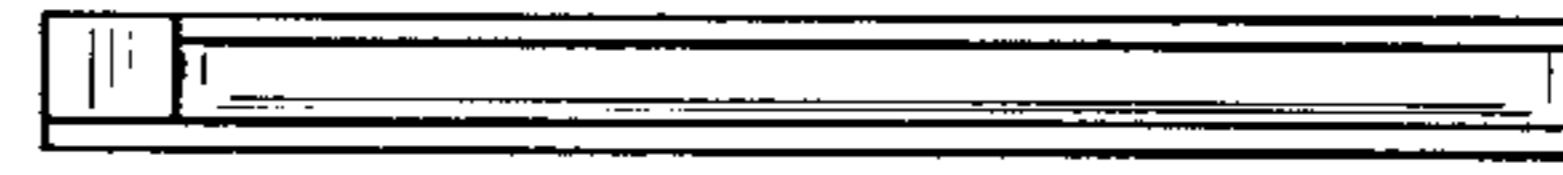

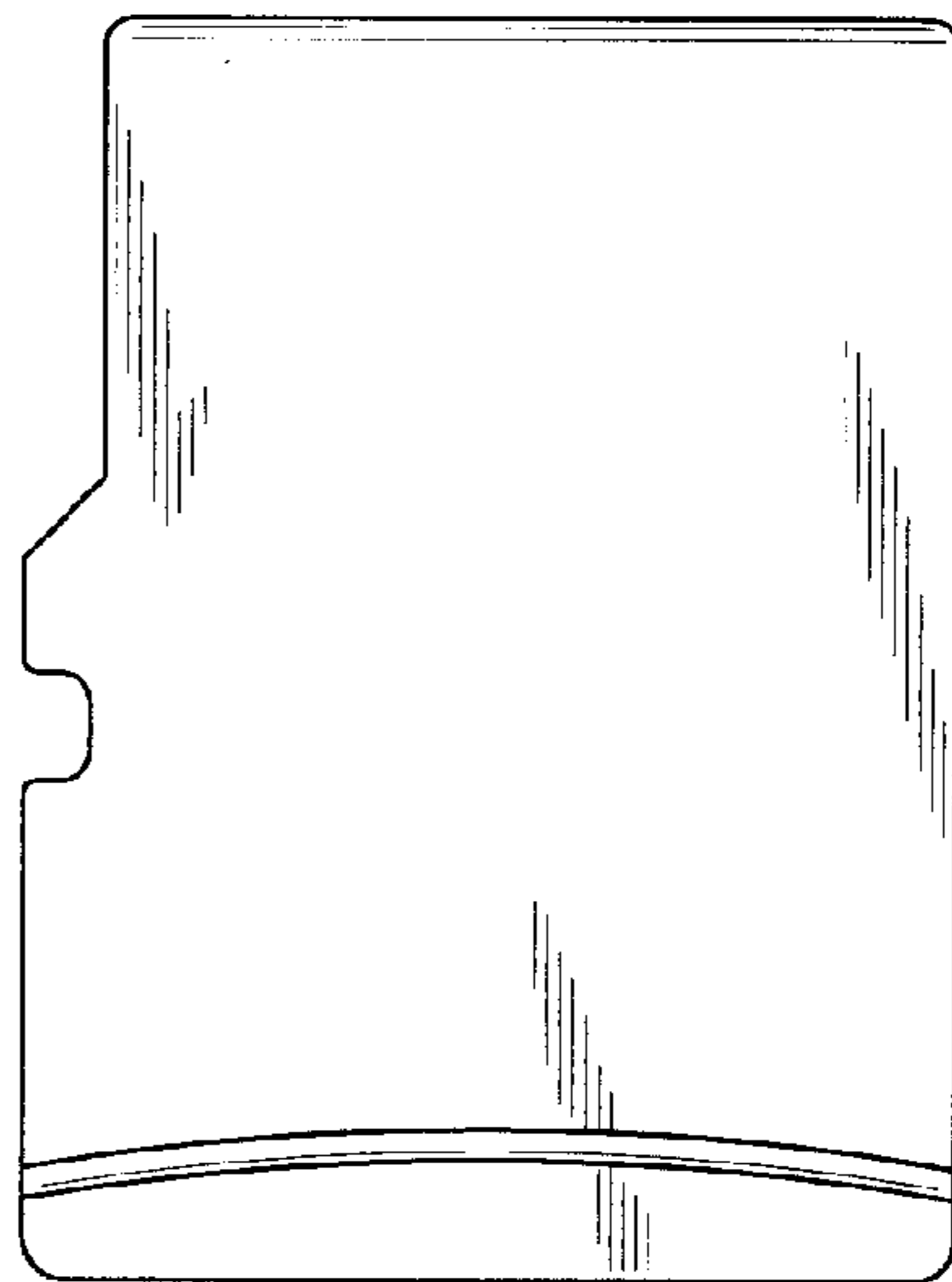

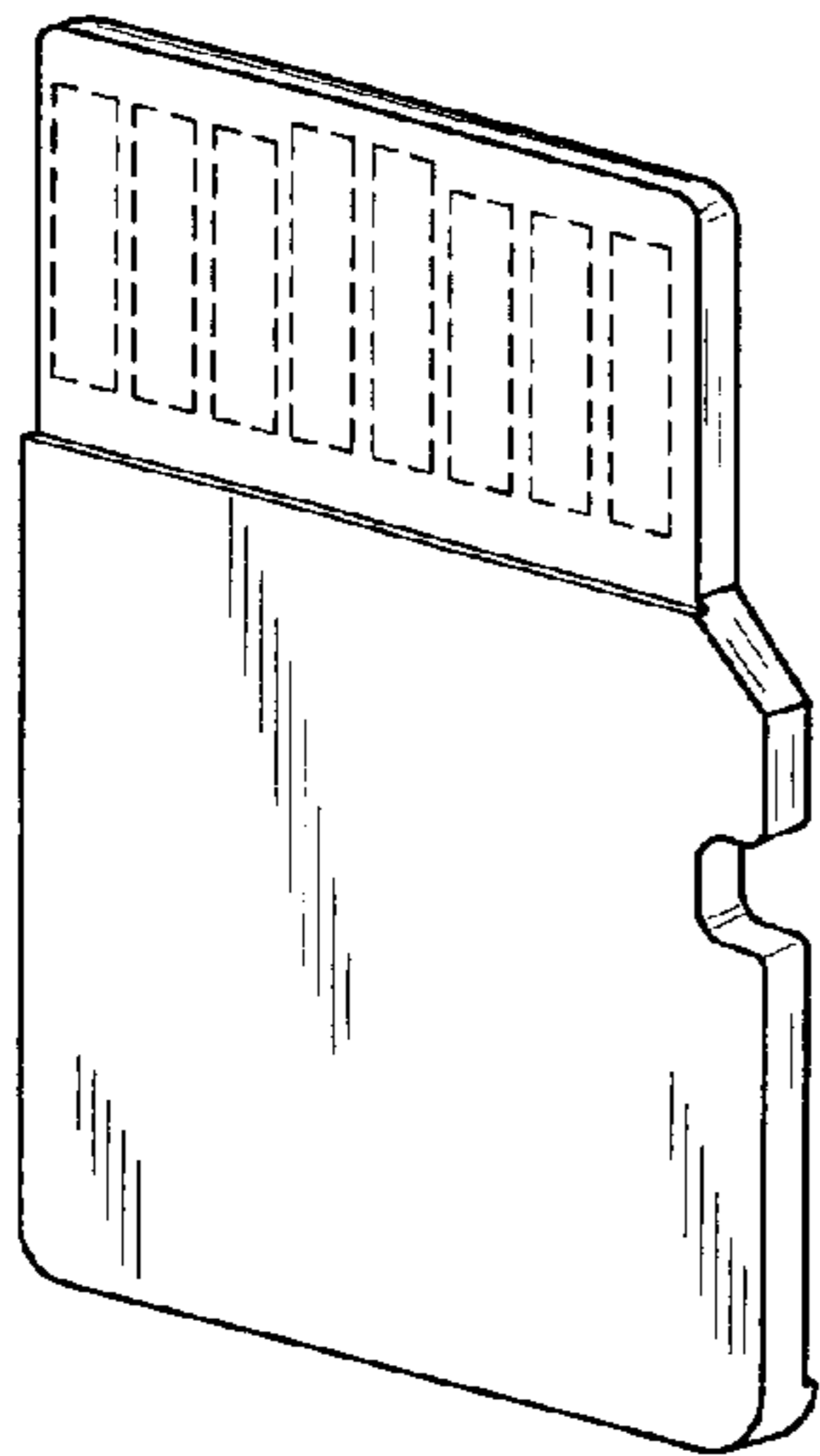

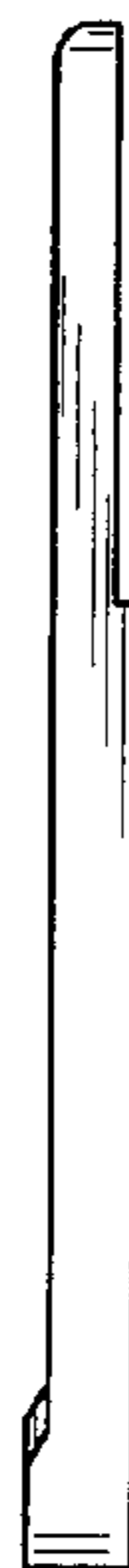

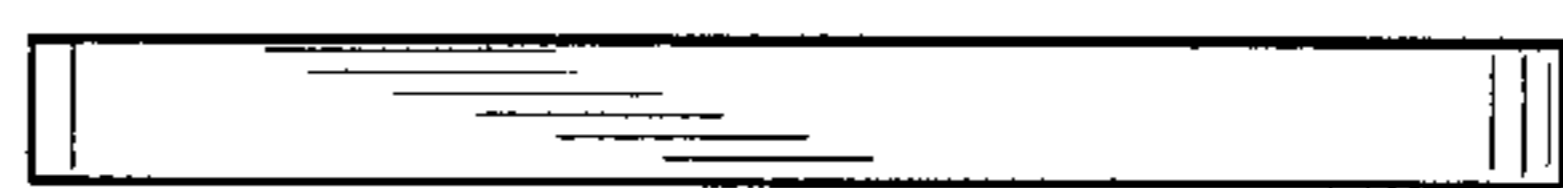

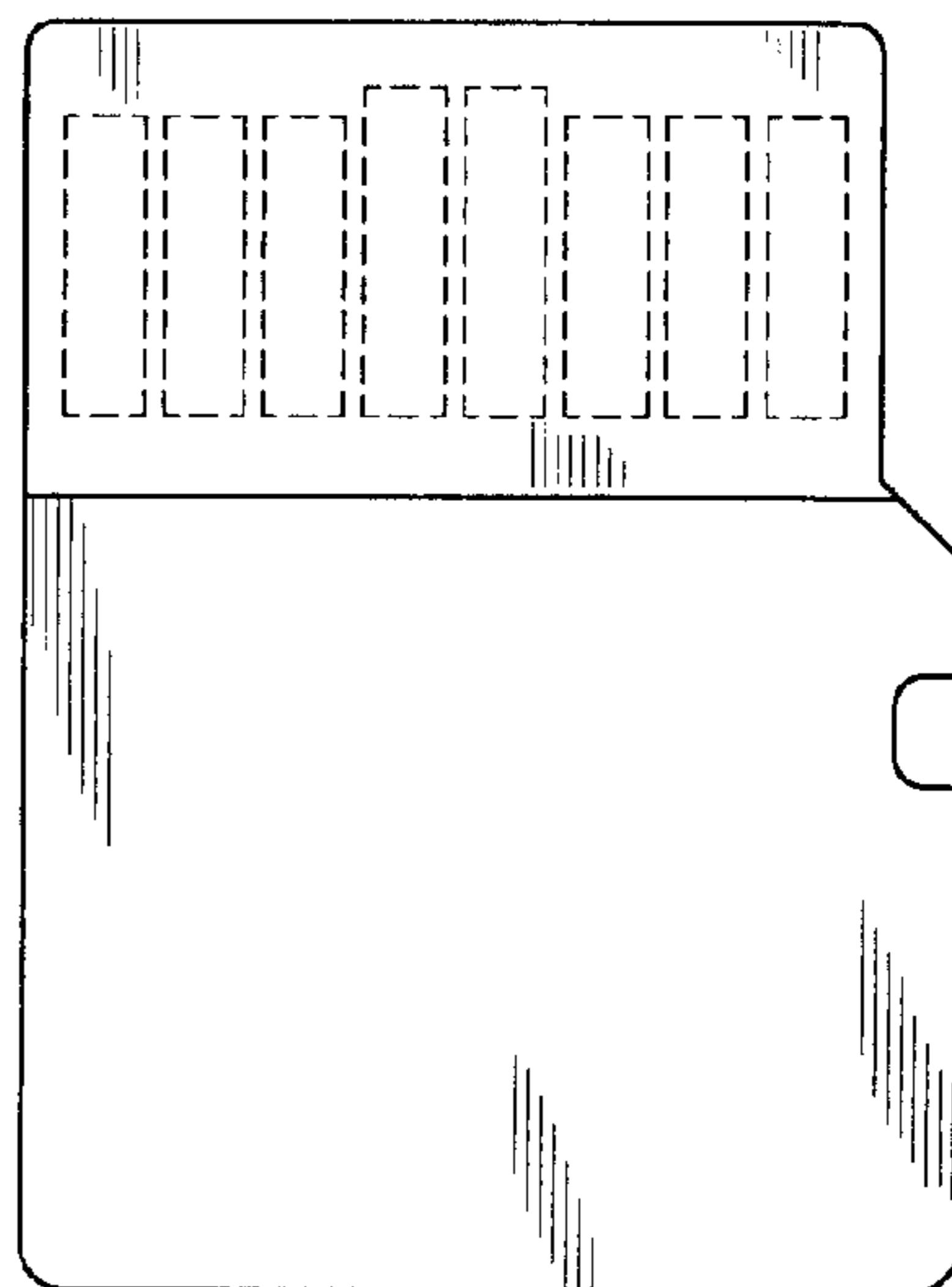

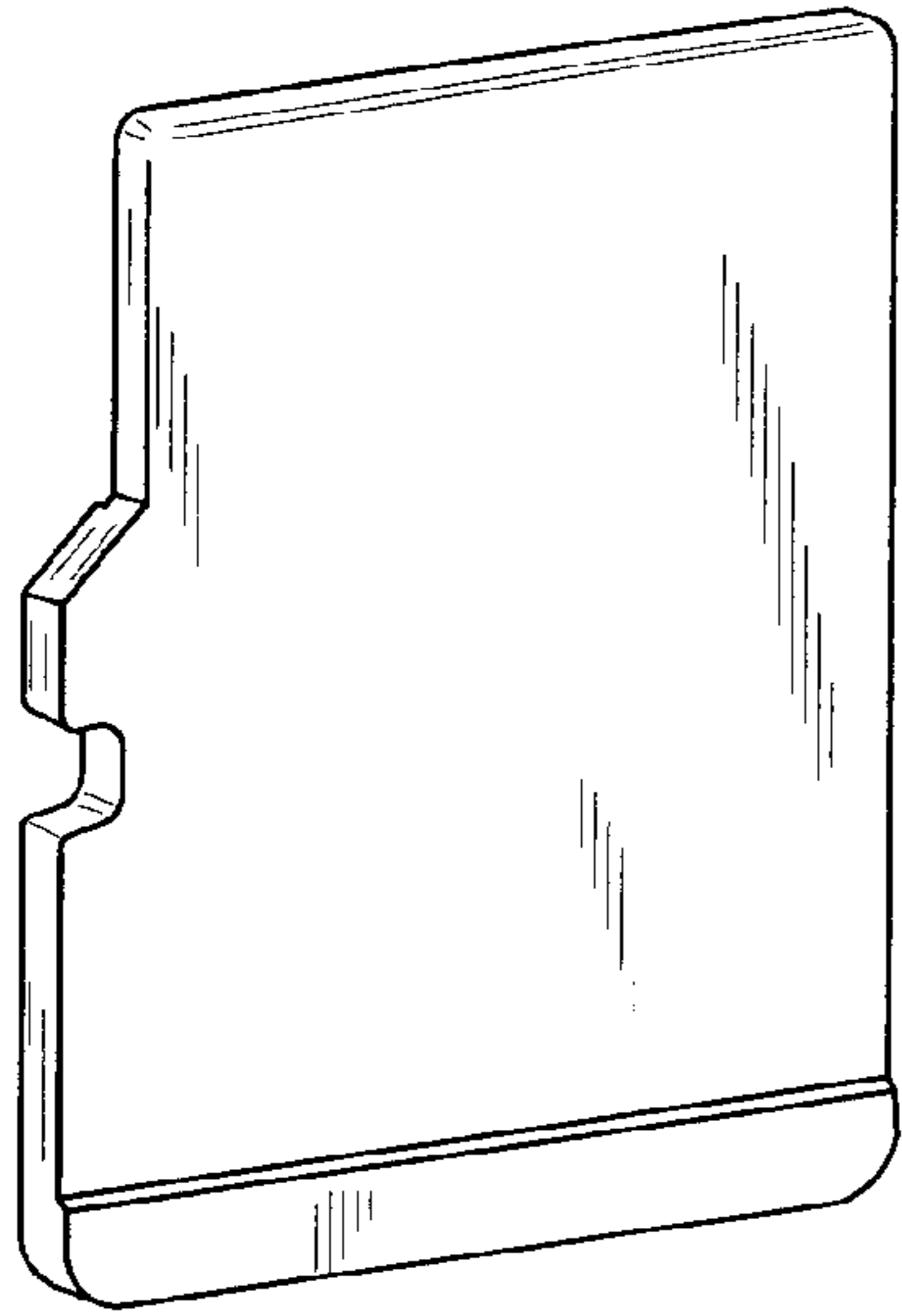

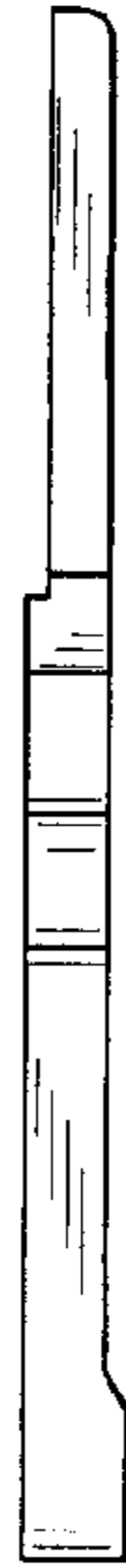

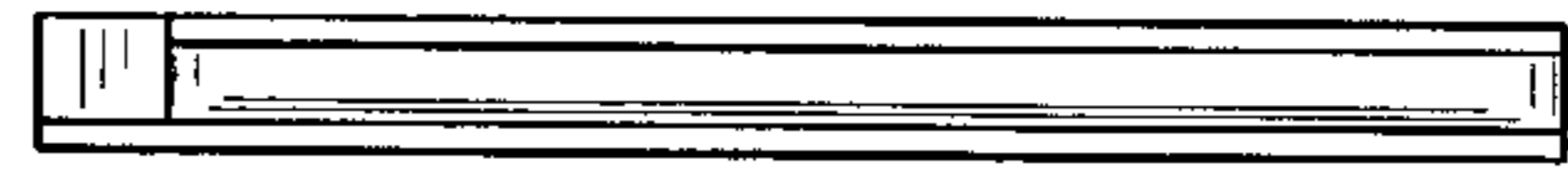

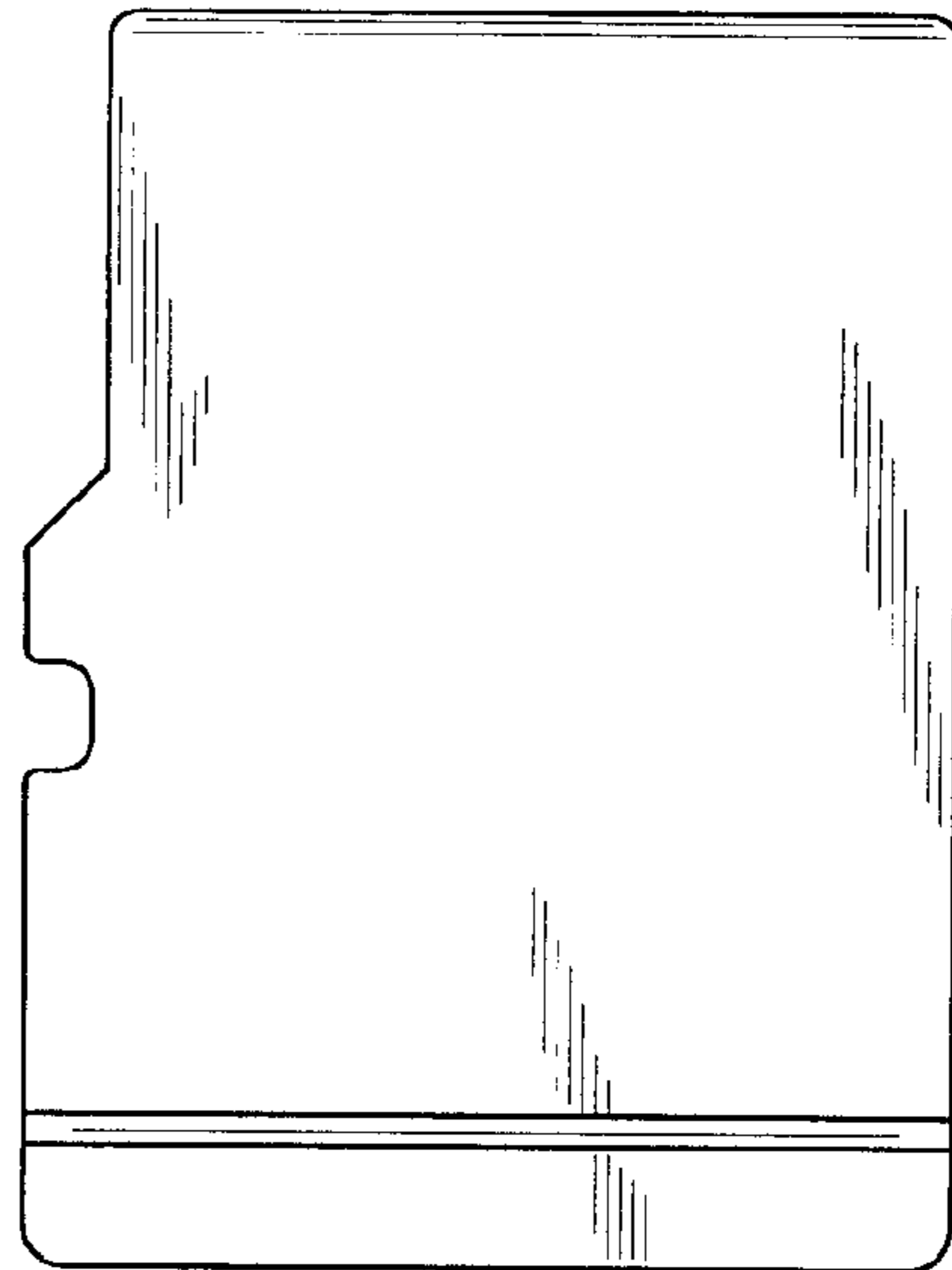

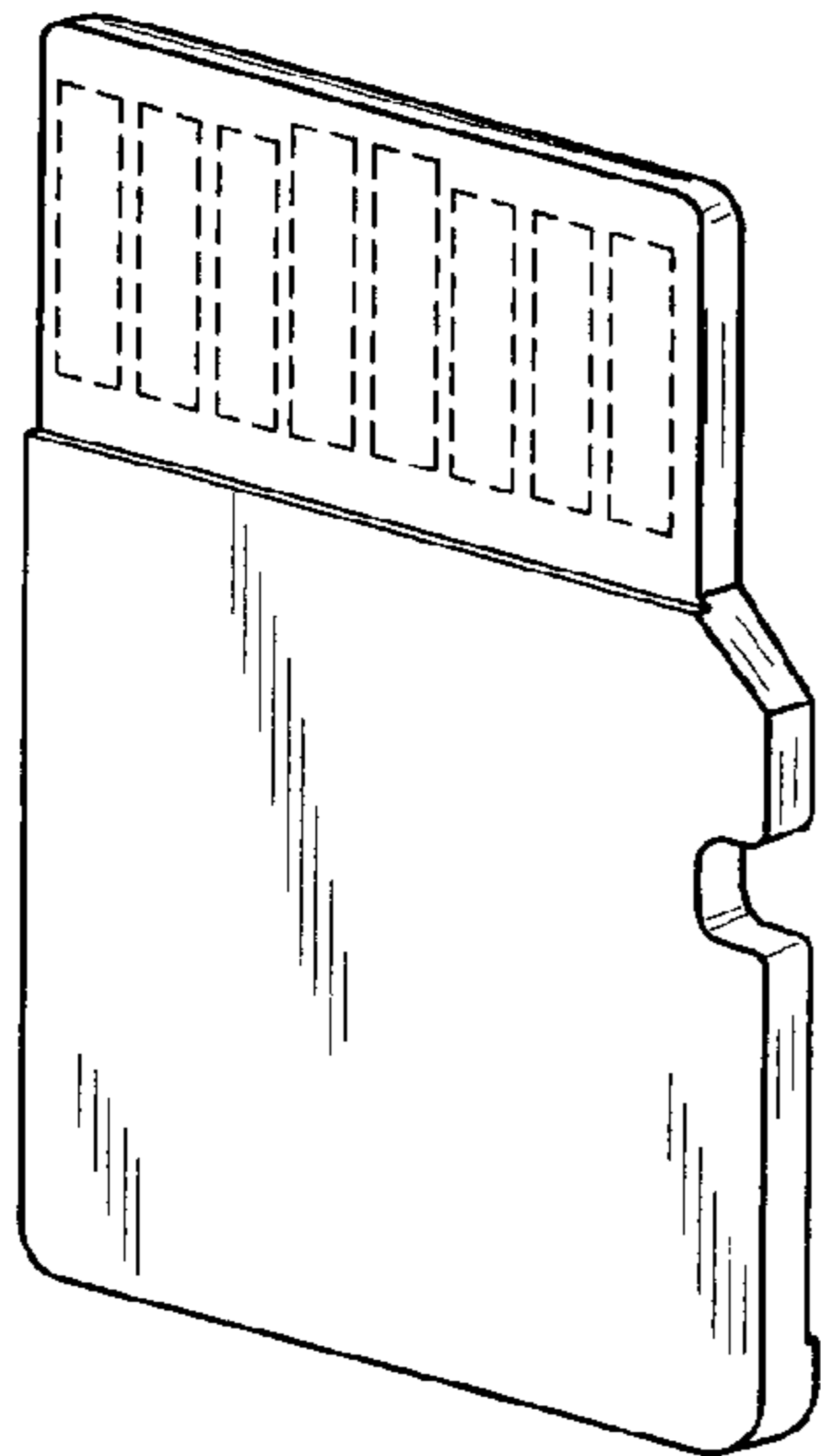

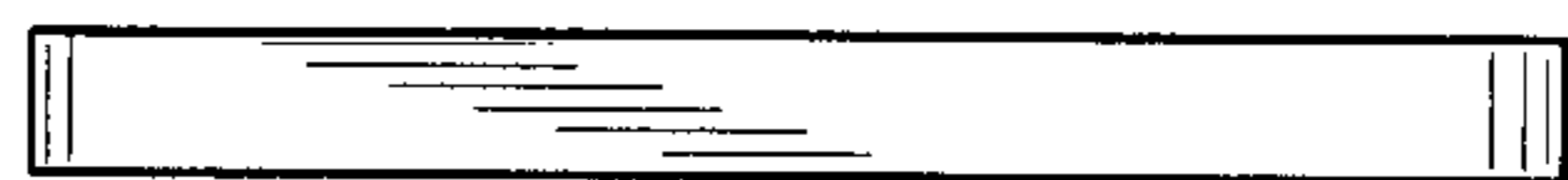

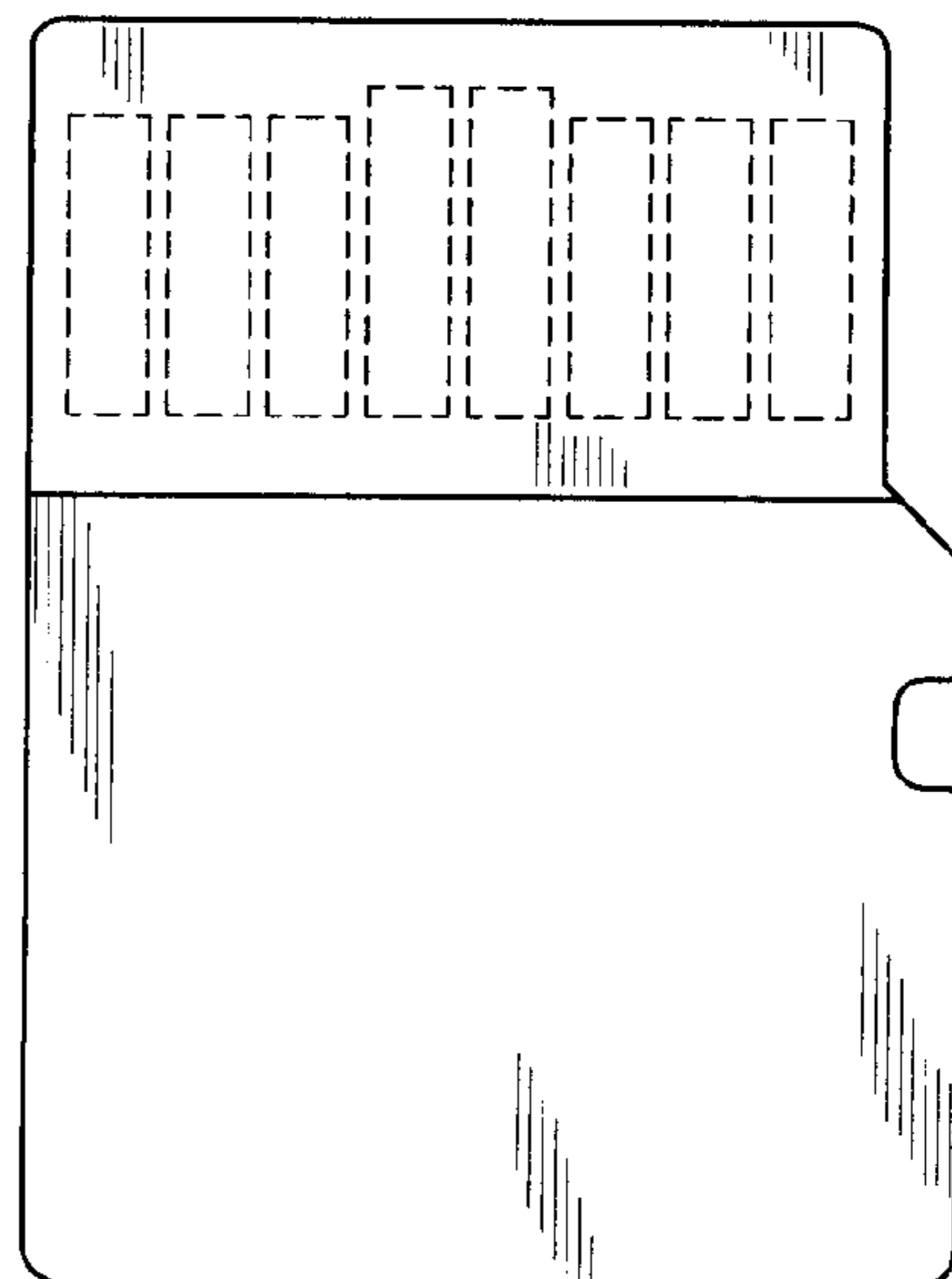

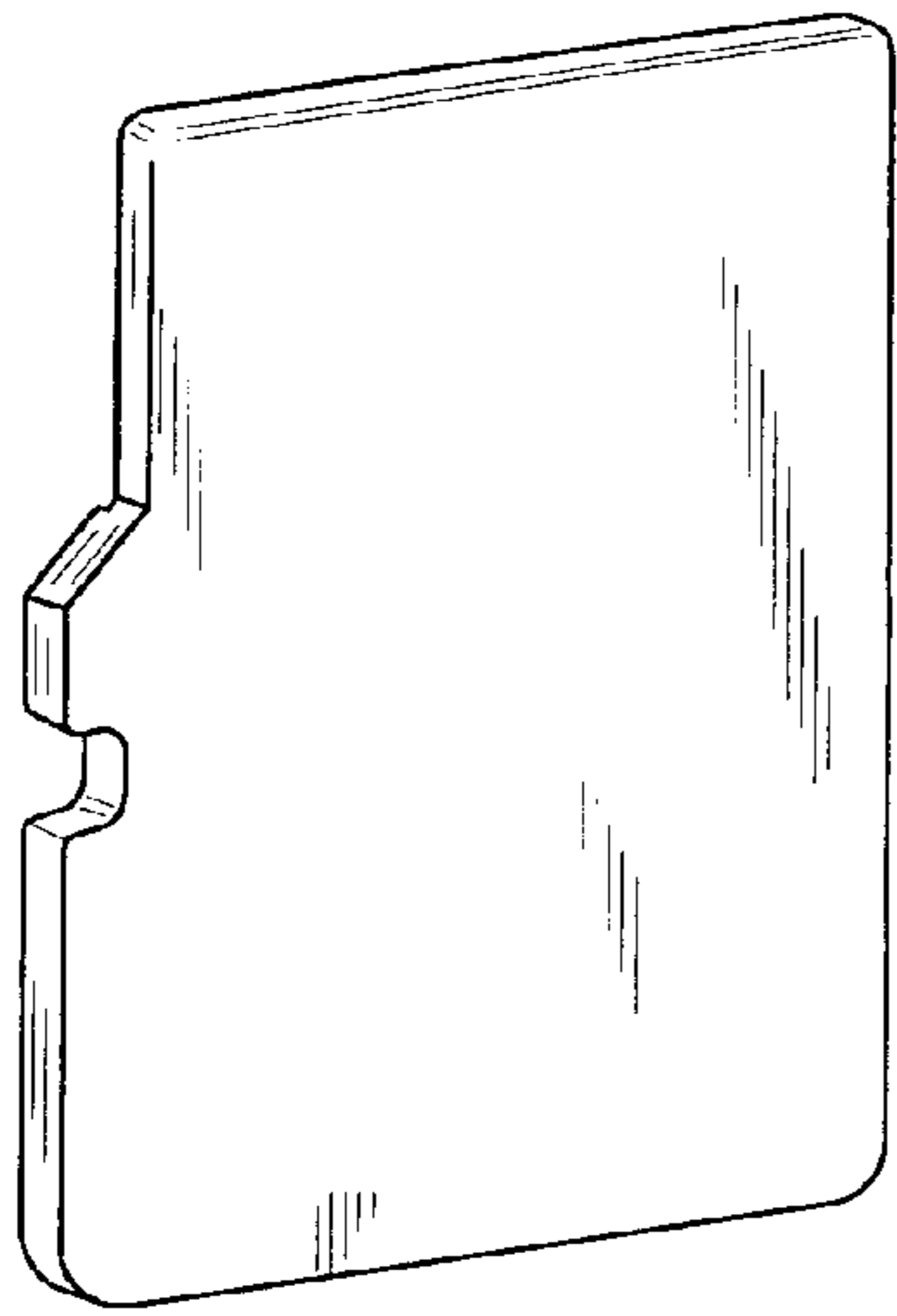

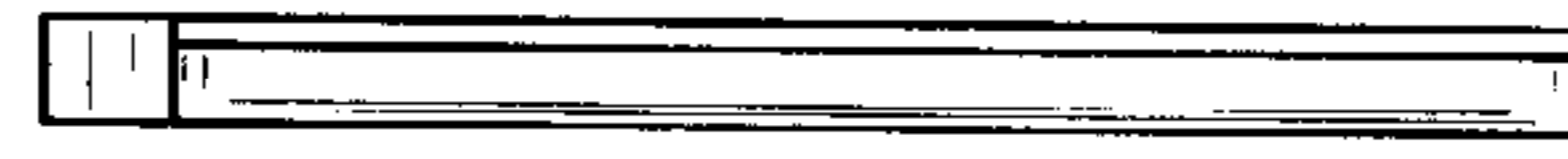

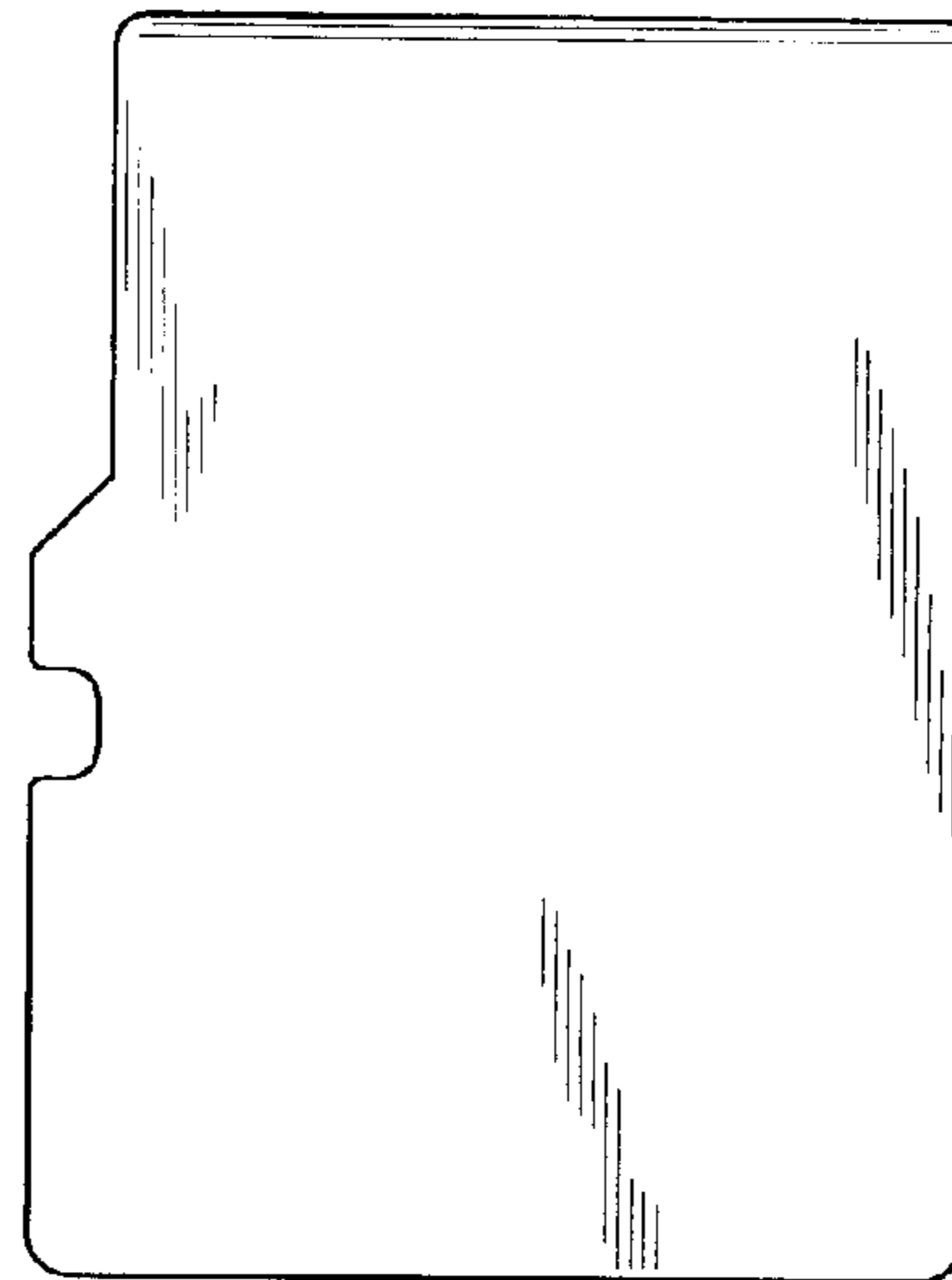

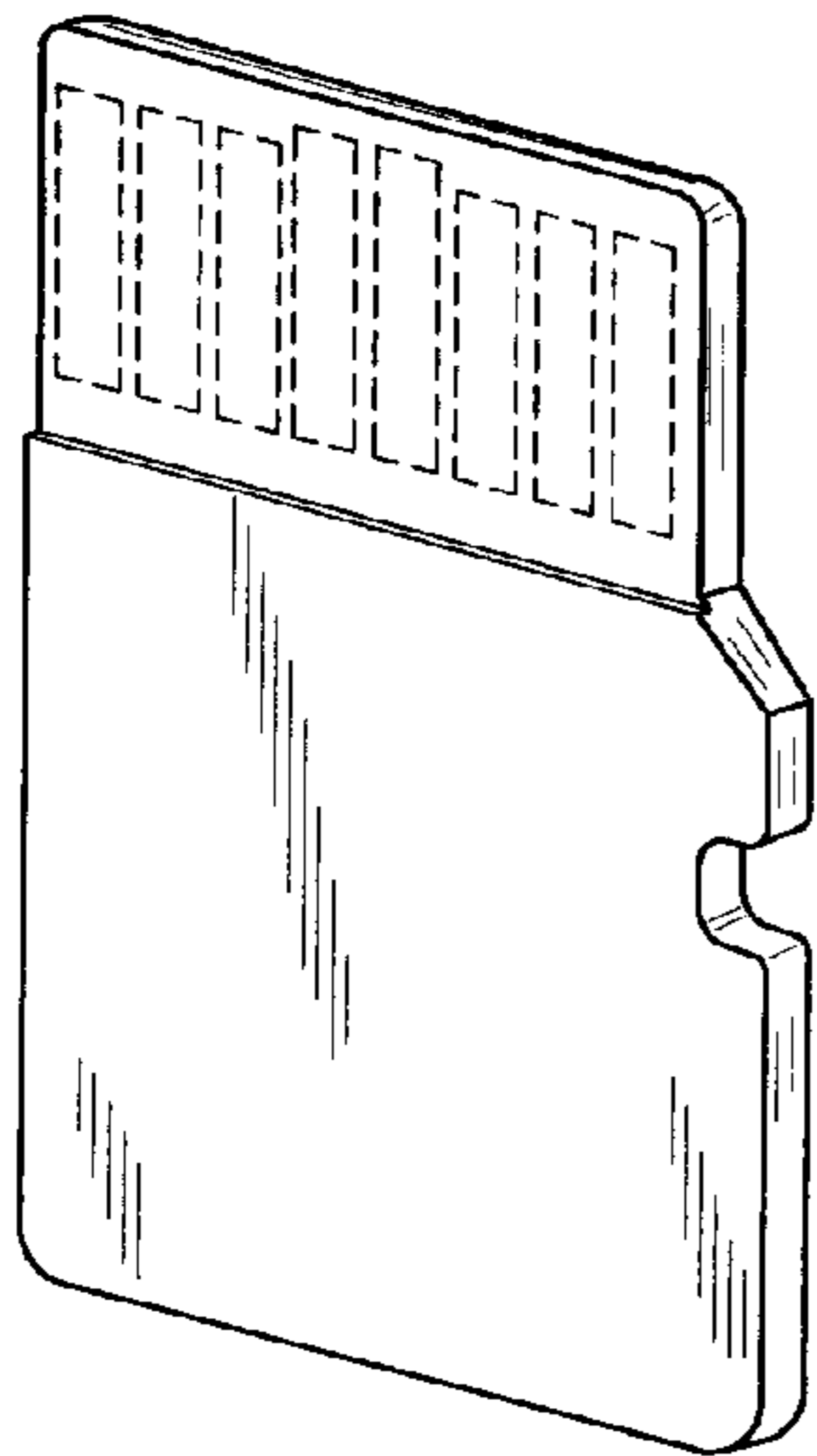

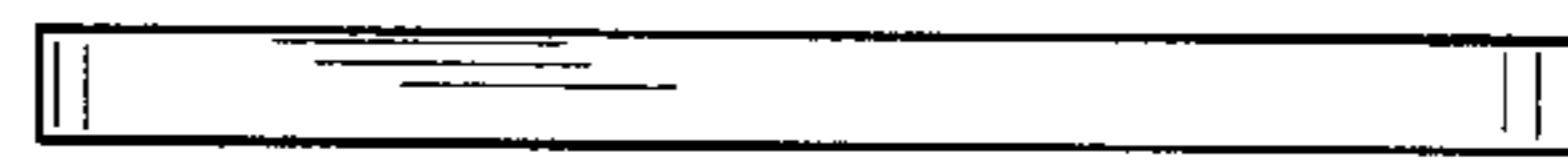

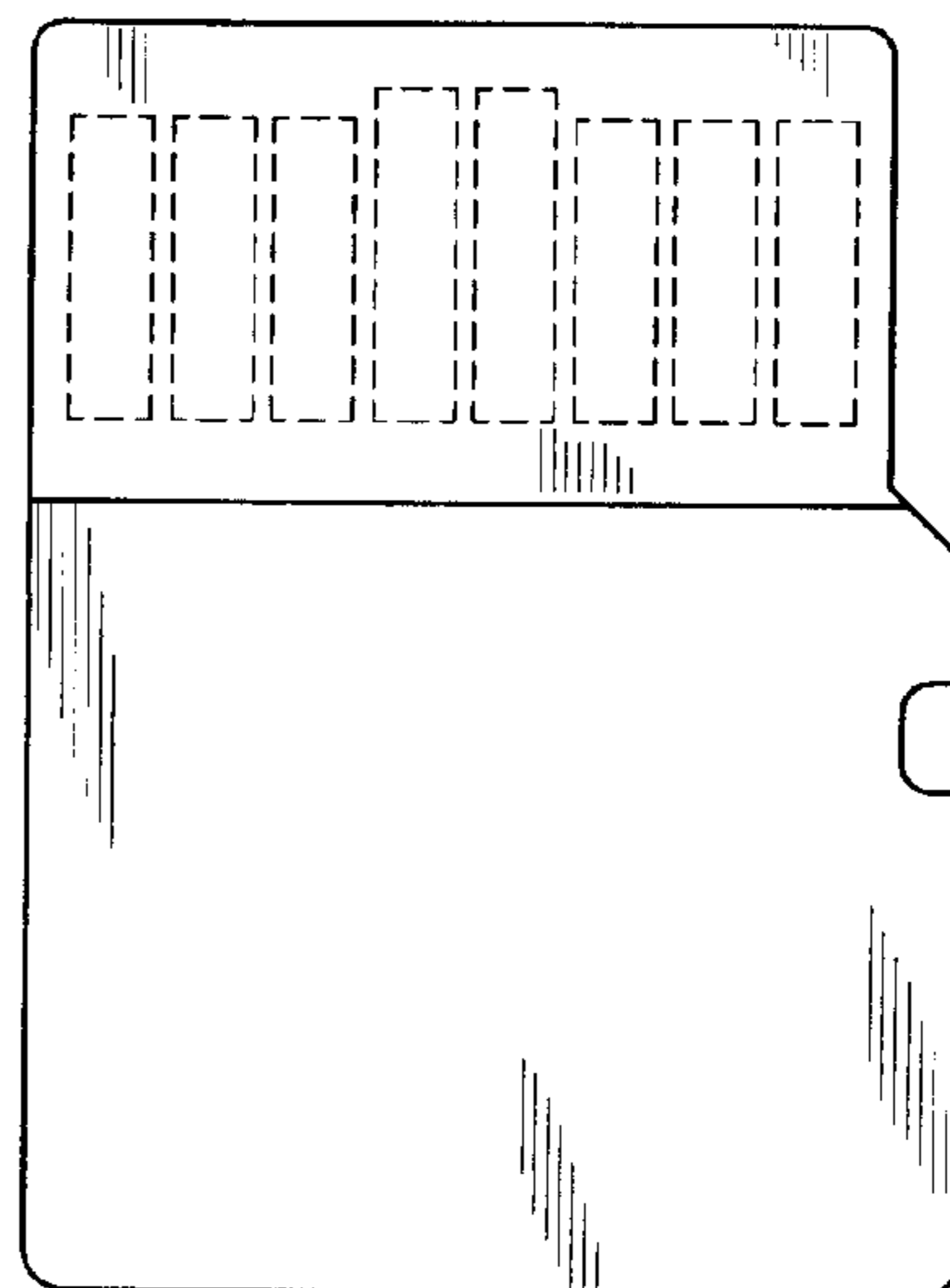
