(57) **CLAIM**

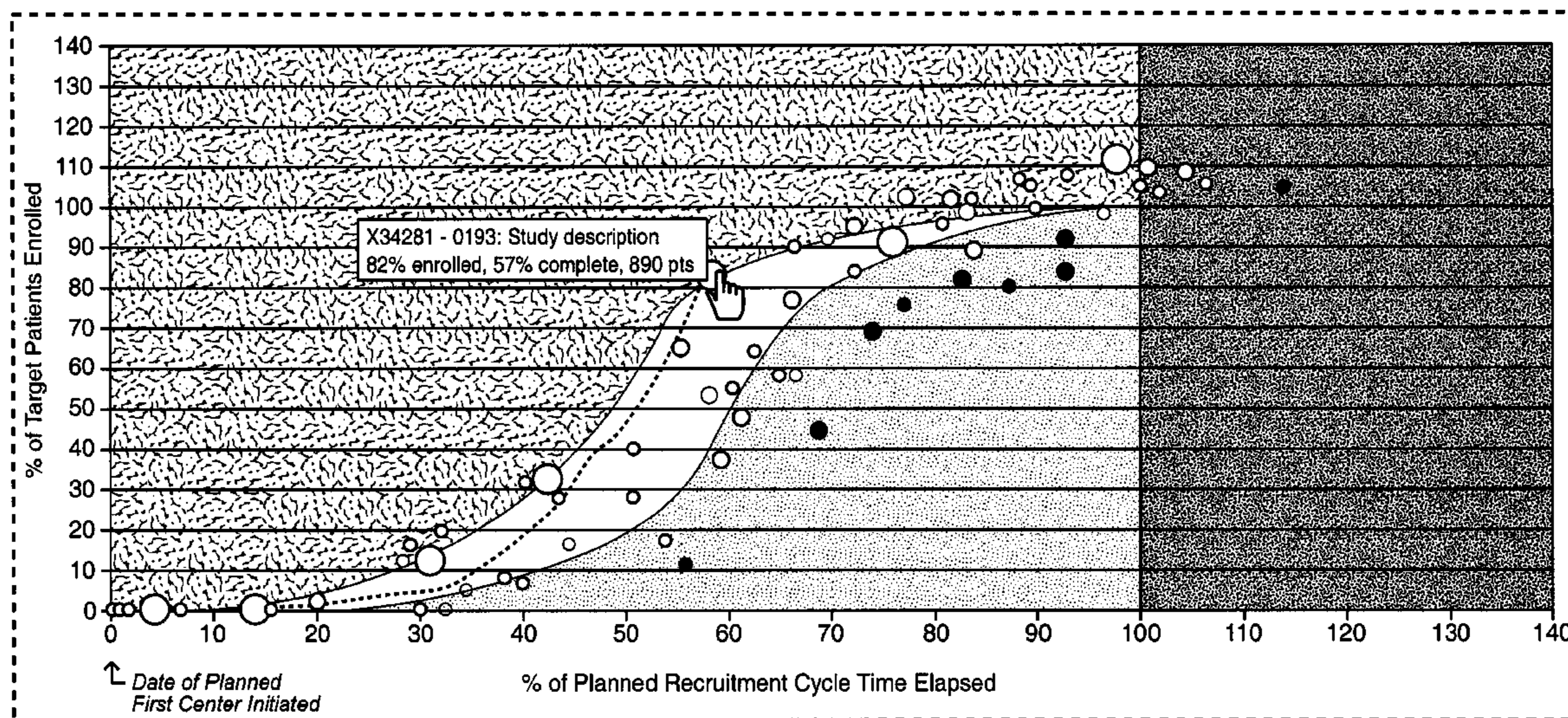
We claim the ornamental design for a portion of a computer screen with a computer-generated image for a full screen display, as shown and described.

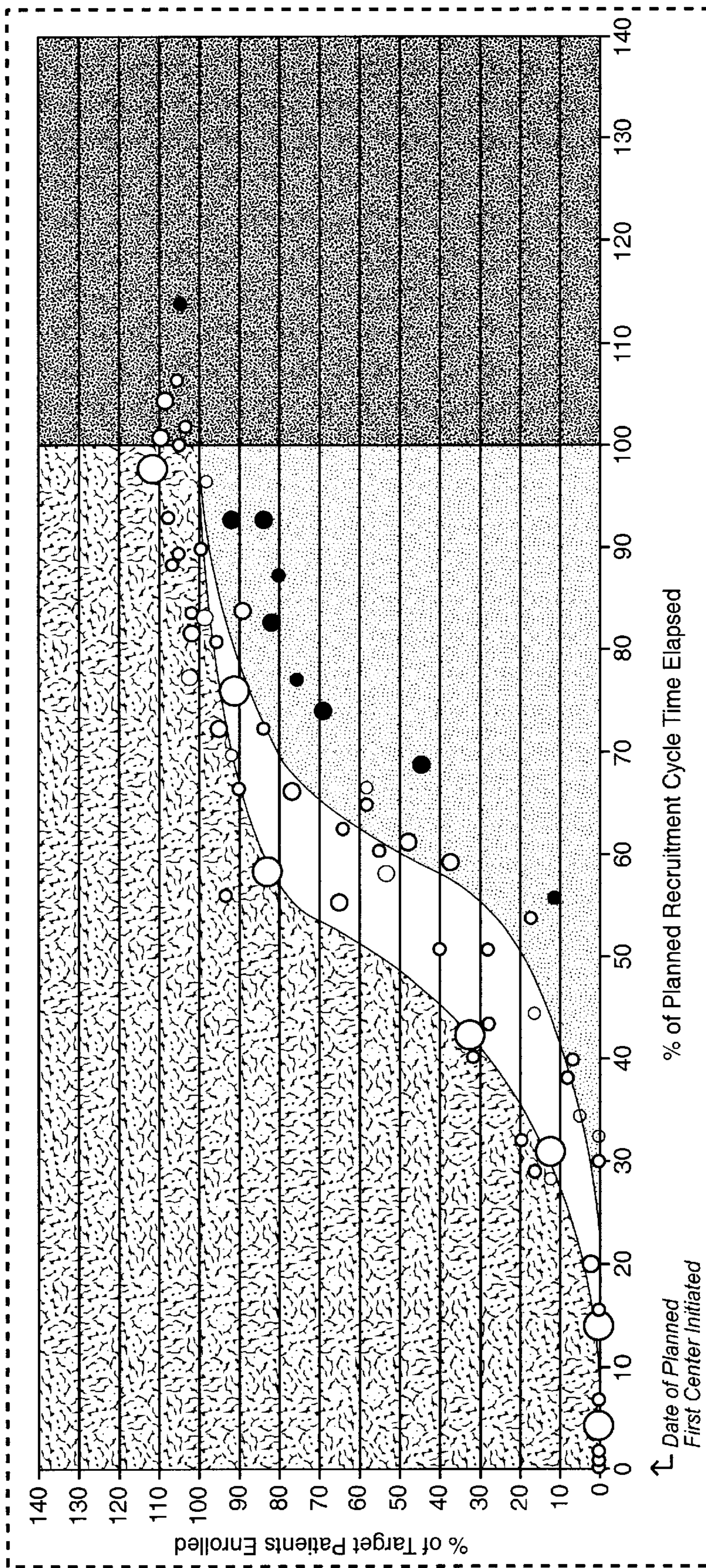

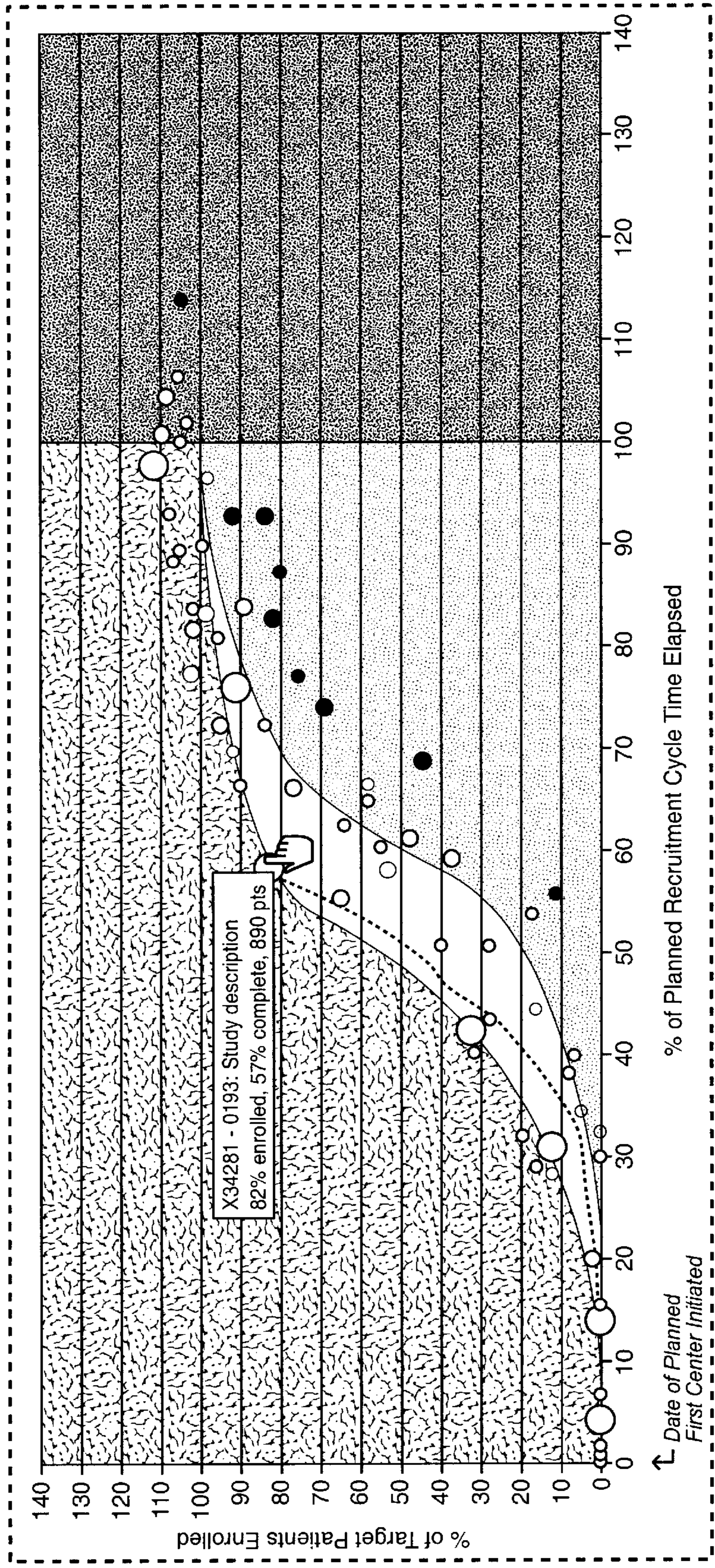
