(57) **CLAIM**

The ornamental design for a novelty noisemaker incorporating inflated stick with stiffened flag, as shown and described.

**DESCRIPTION**

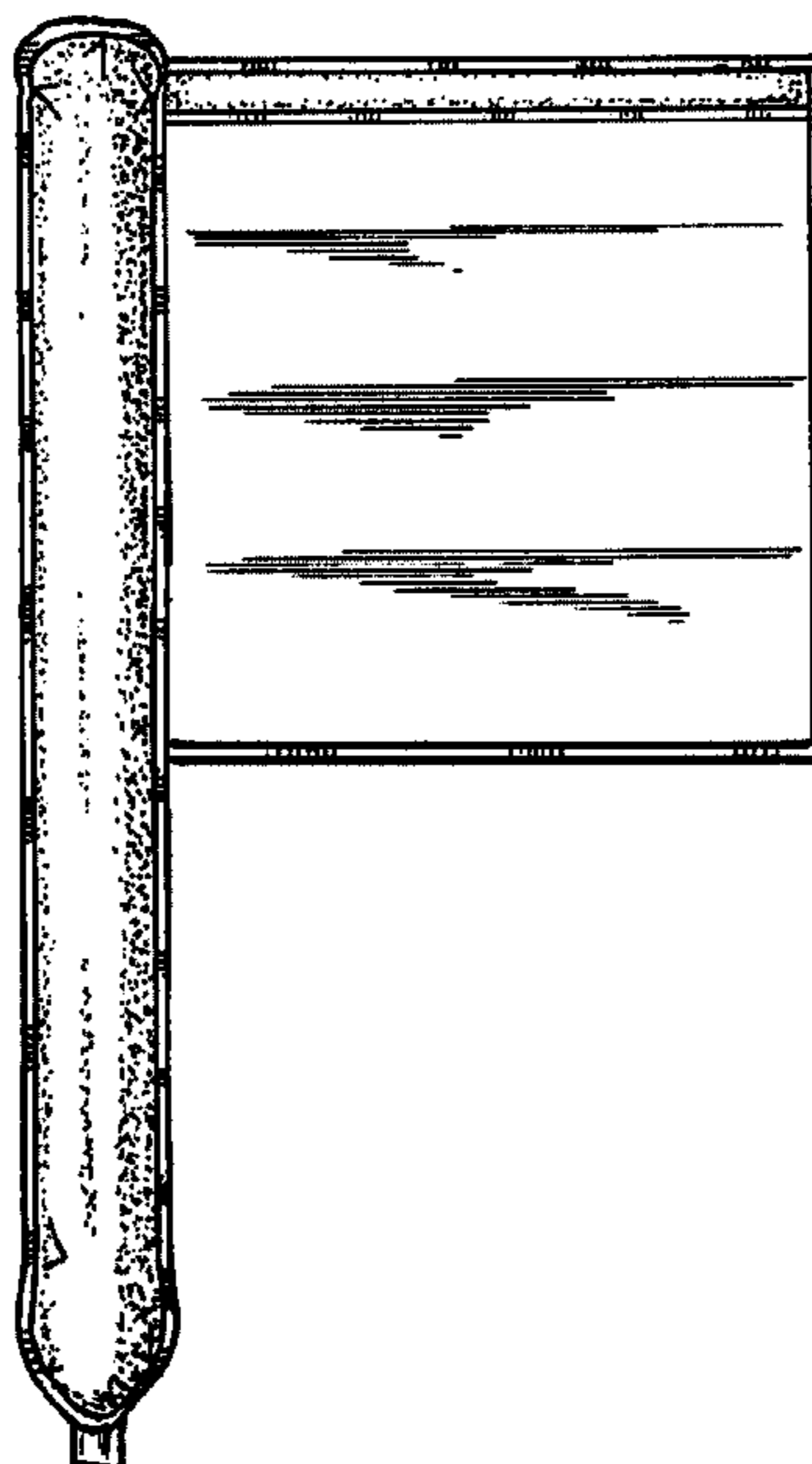
FIG. 2 is a right side elevational view;

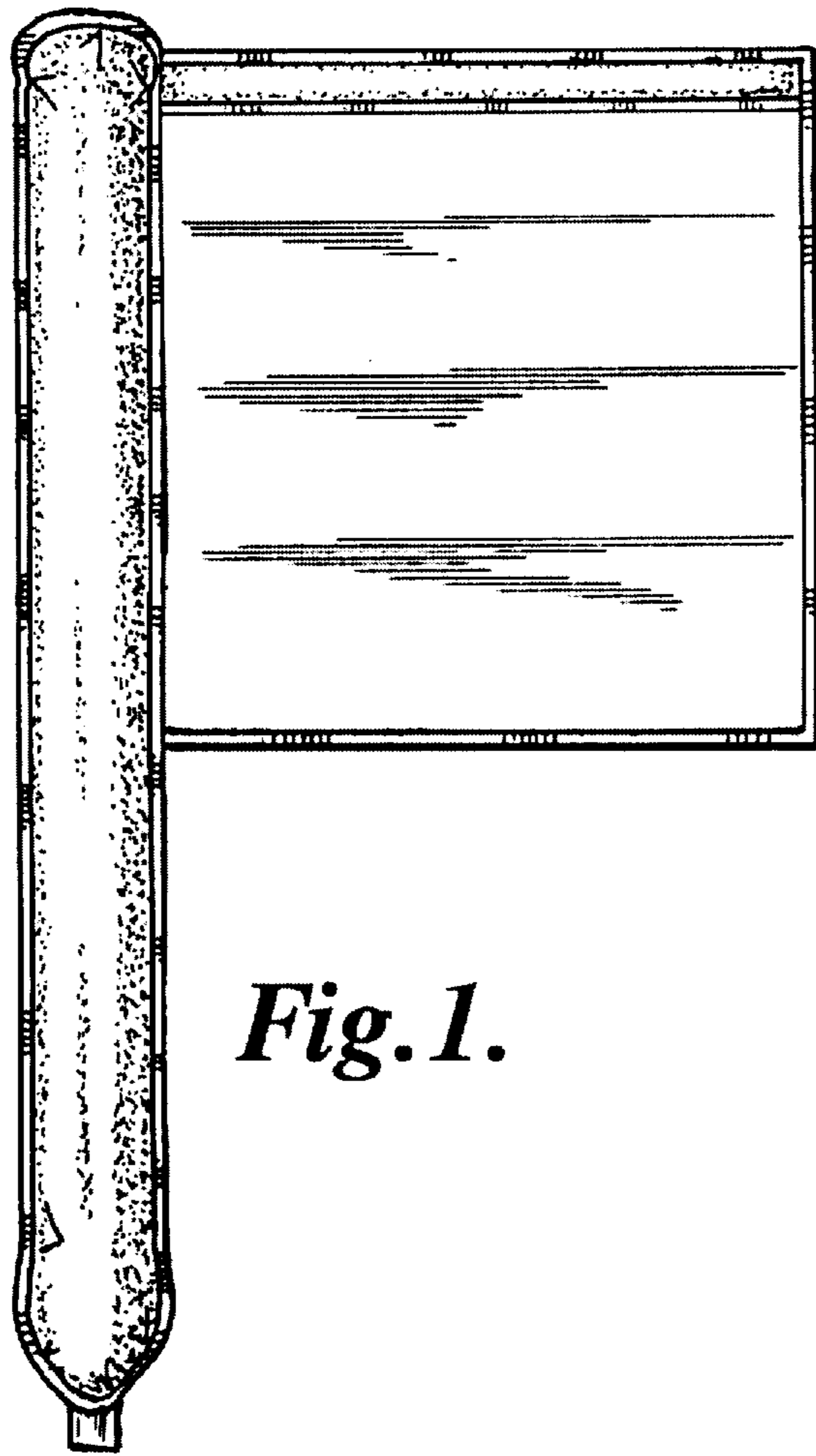
FIG. 3 is a left side elevational view;

FIG. 4 is a bottom plan view; and,

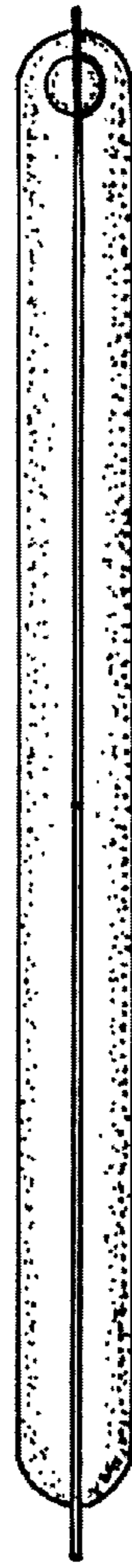
FIG. 5 is a top plan view.

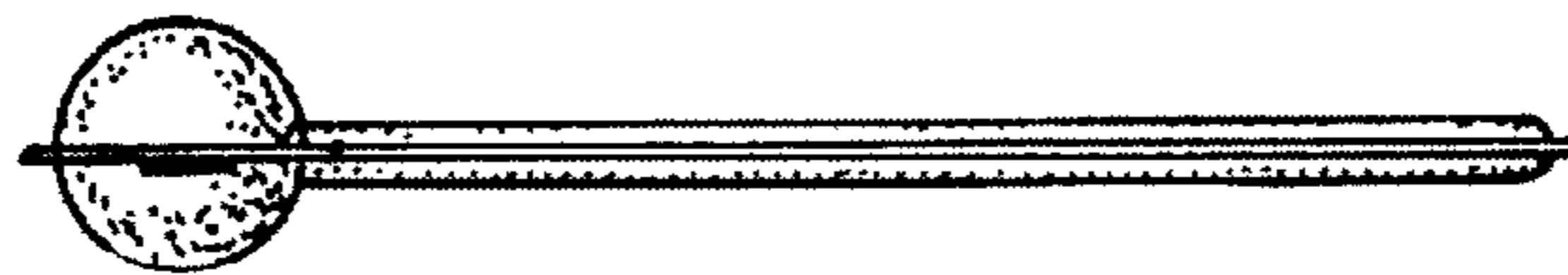

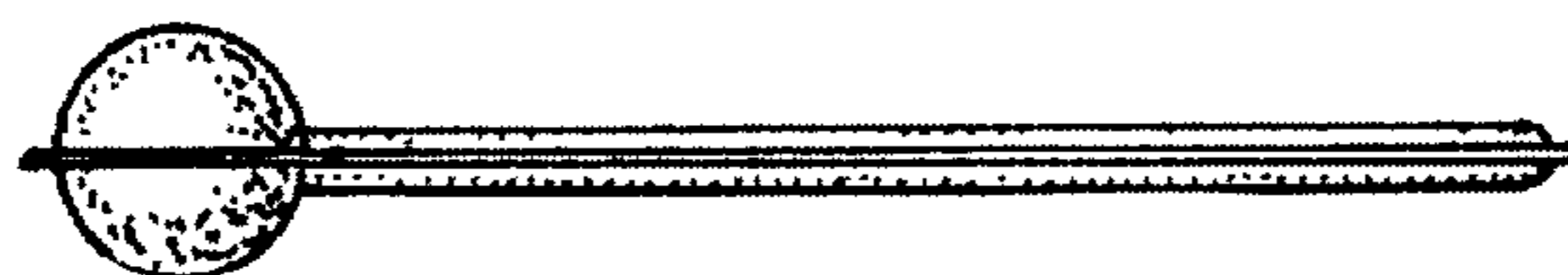
