(57) **CLAIM**

I claim the ornamental design for scent dispensing lure bodies having an interior chamber, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lure body according to the present disclosure.

FIG. 2 is a front elevation view of the lure body shown in FIG. 1.

FIG. 3 is a rear elevation view of the lure body shown in FIG. 1.

FIG. 4 is a top view of the lure body shown in FIG. 1.

FIG. 5 is a right side view of the lure body shown in FIG. 1.

FIG. 6 is a bottom view of the lure body shown in FIG. 1.

FIG. 7 is an exploded view of the lure body shown in FIG. 1.

FIG. 8 is a perspective view of another lure body according to the present disclosure.

FIG. 9 is a front elevation view of the lure body in FIG. 8.

FIG. 10 is a rear elevation view of the lure body in FIG. 8.

FIG. 11 is a top view of the lure body in FIG. 8.

FIG. 12 is a right side view of the lure body shown in FIG. 8.

FIG. 22 is a perspective view of another lure body according to the present disclosure.

FIG. 23 is a front elevation view of the lure body in FIG. 22.

FIG. 25 is a top view of the lure body in FIG. 22.

FIG. 26 is right side view of the lure body shown in FIG. 22.

FIG. 27 is a bottom view of the lure body shown in FIG. 22; and,

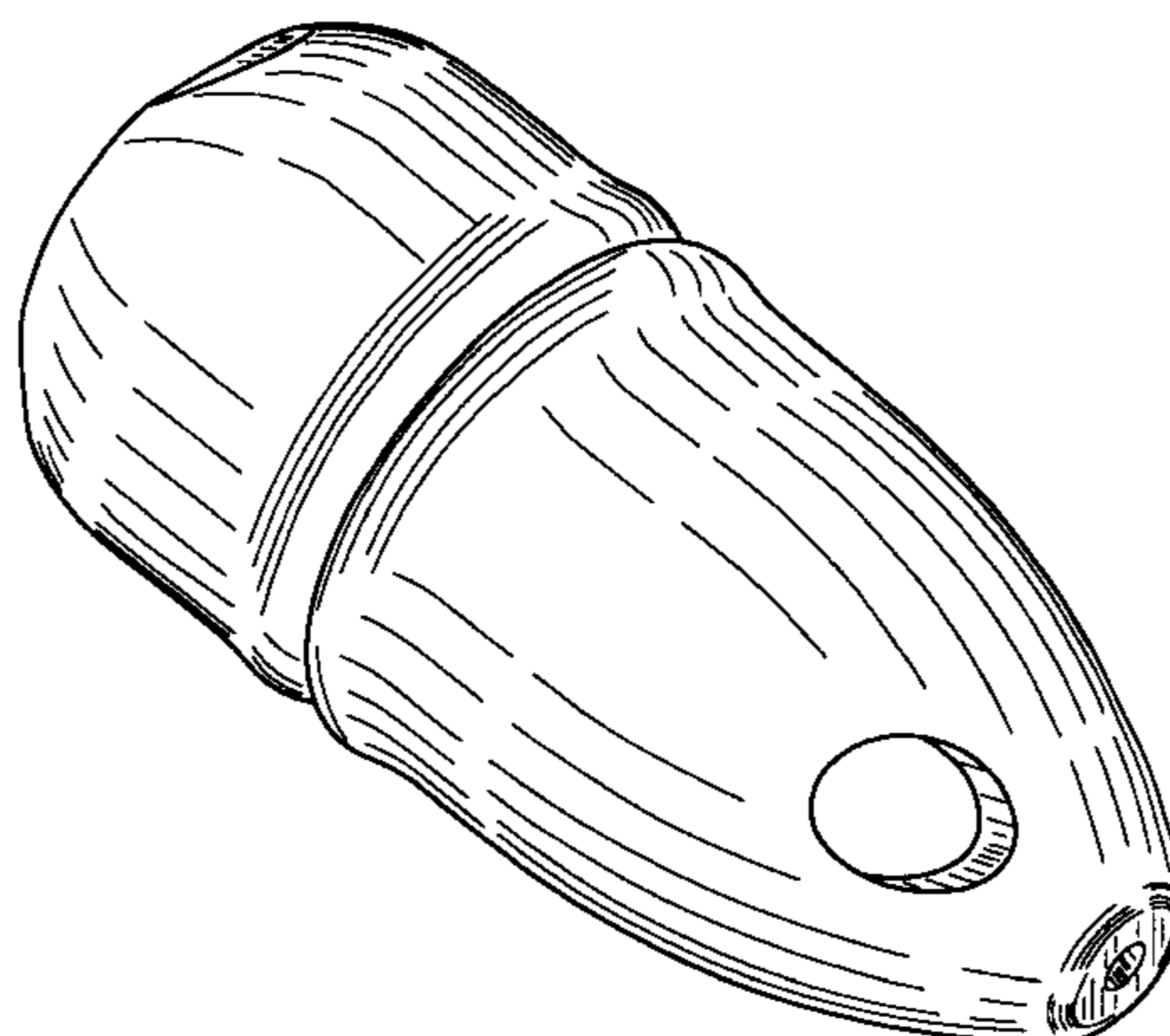
FIG. 28 is an exploded view of the lure body shown in FIG. 22.

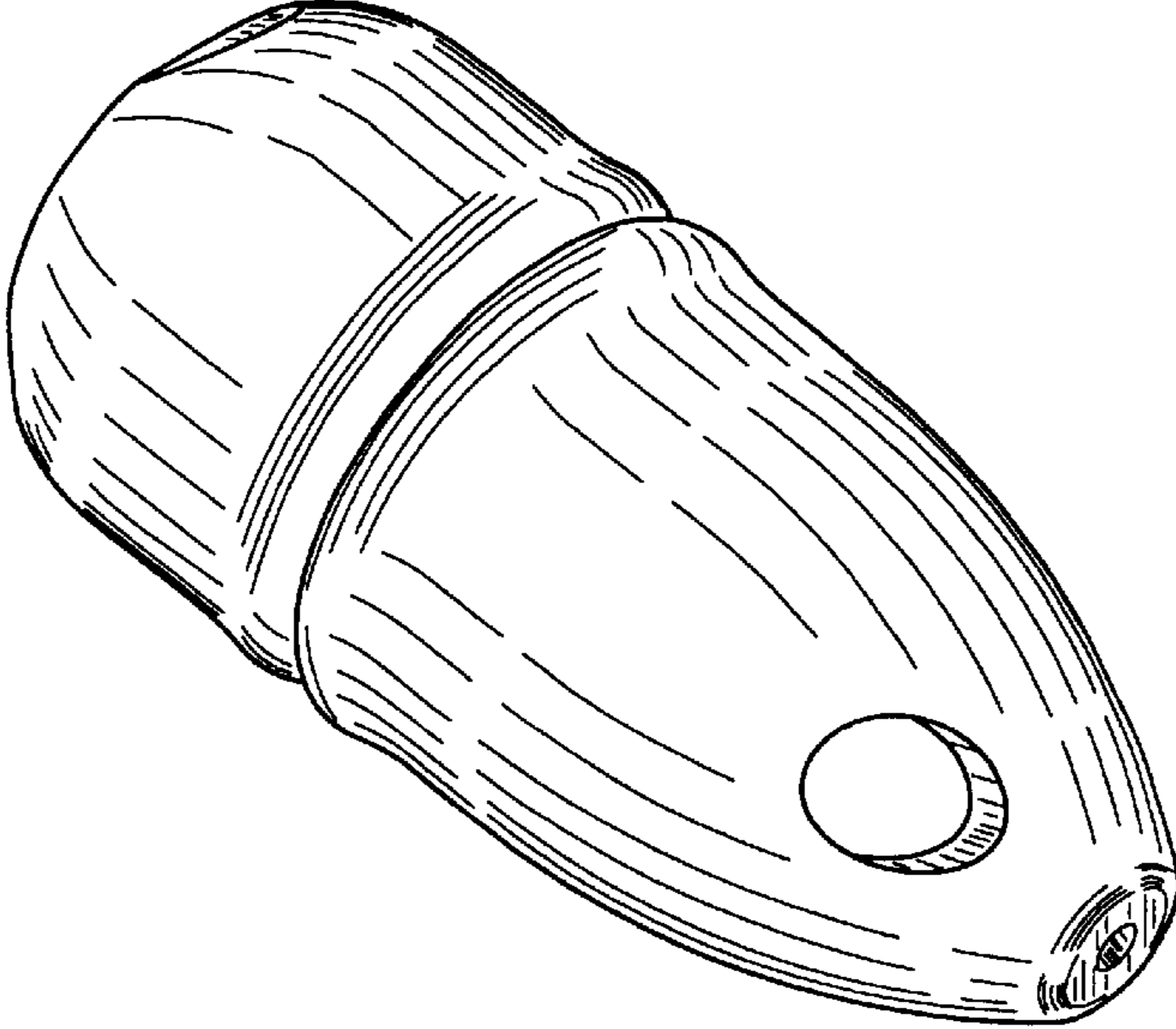

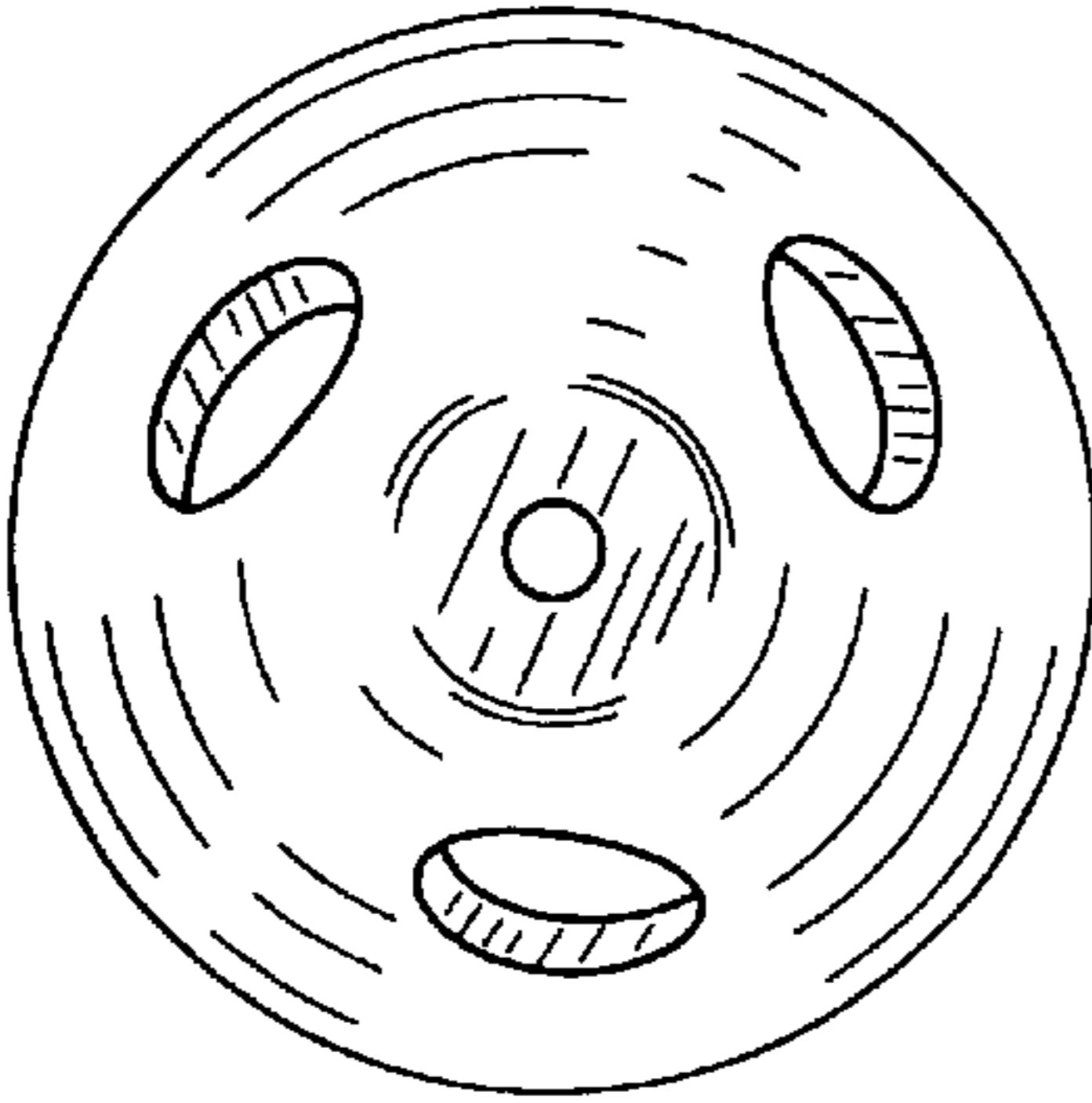

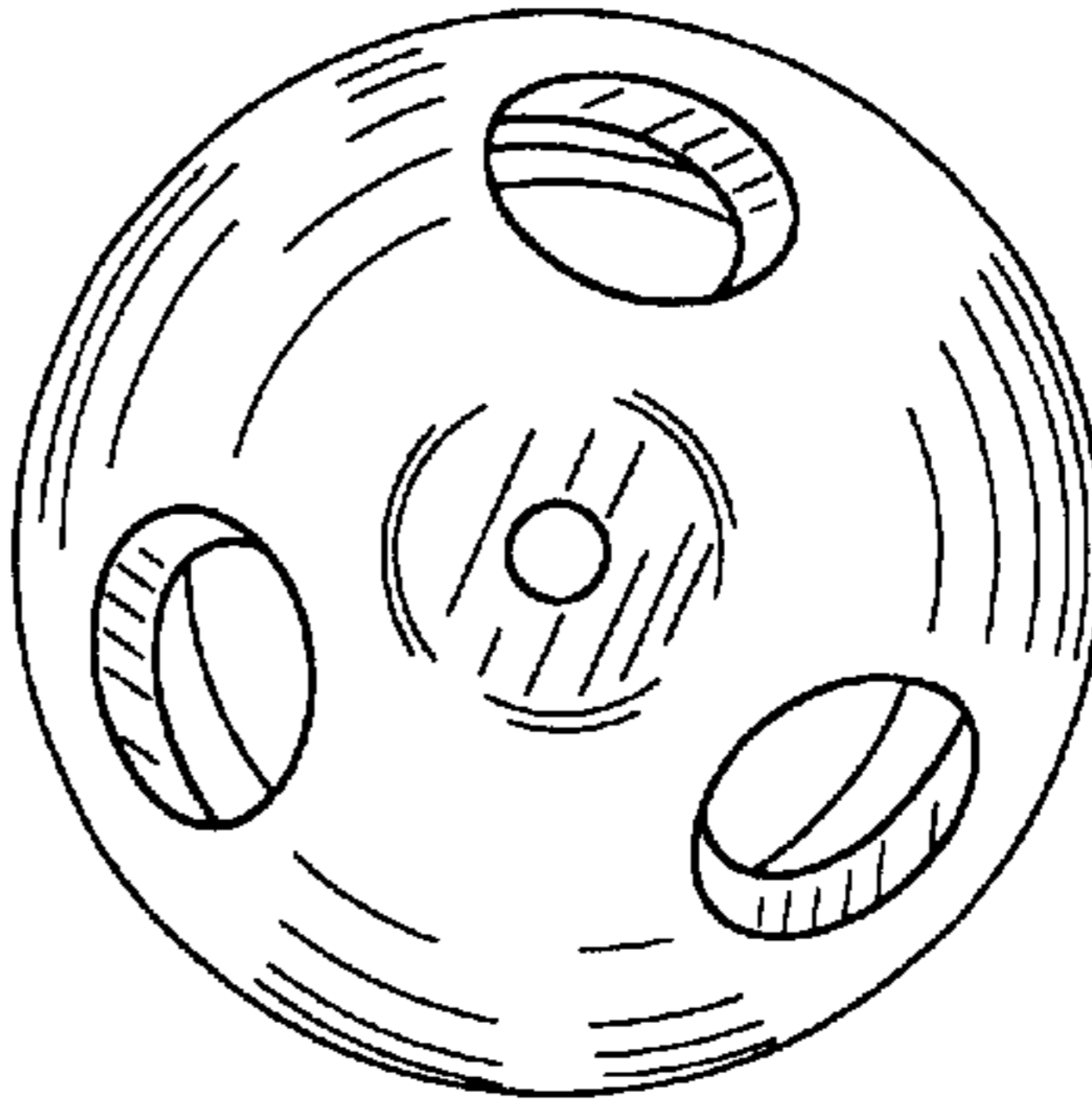

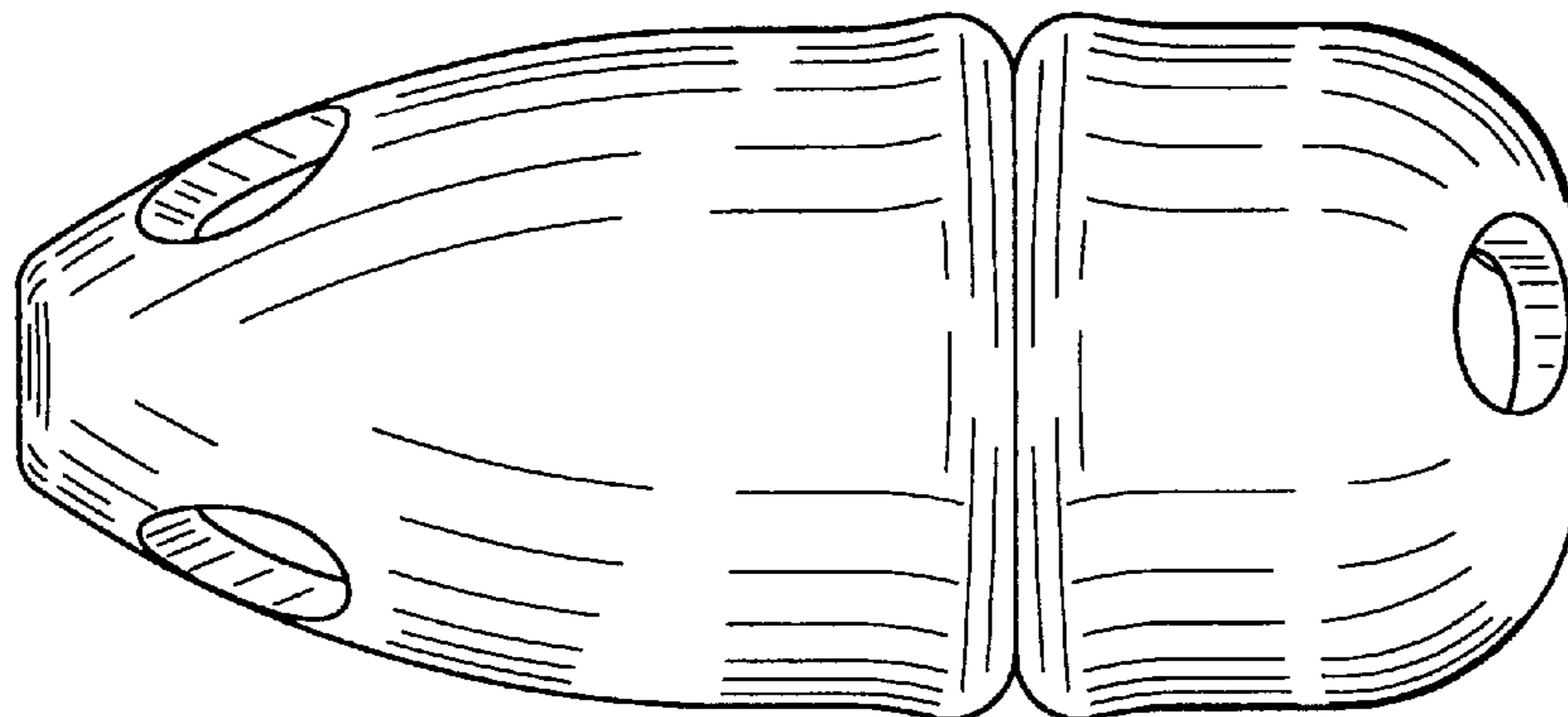

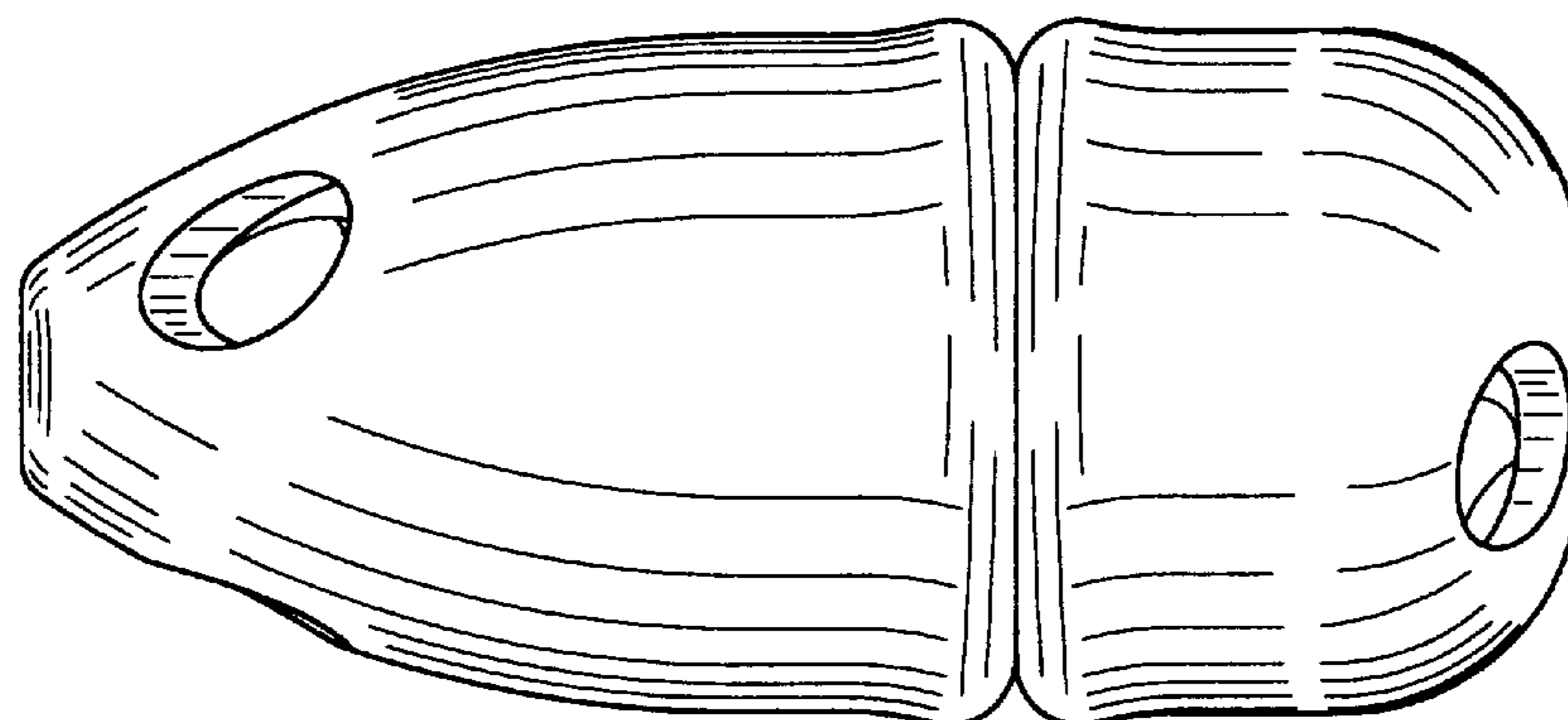

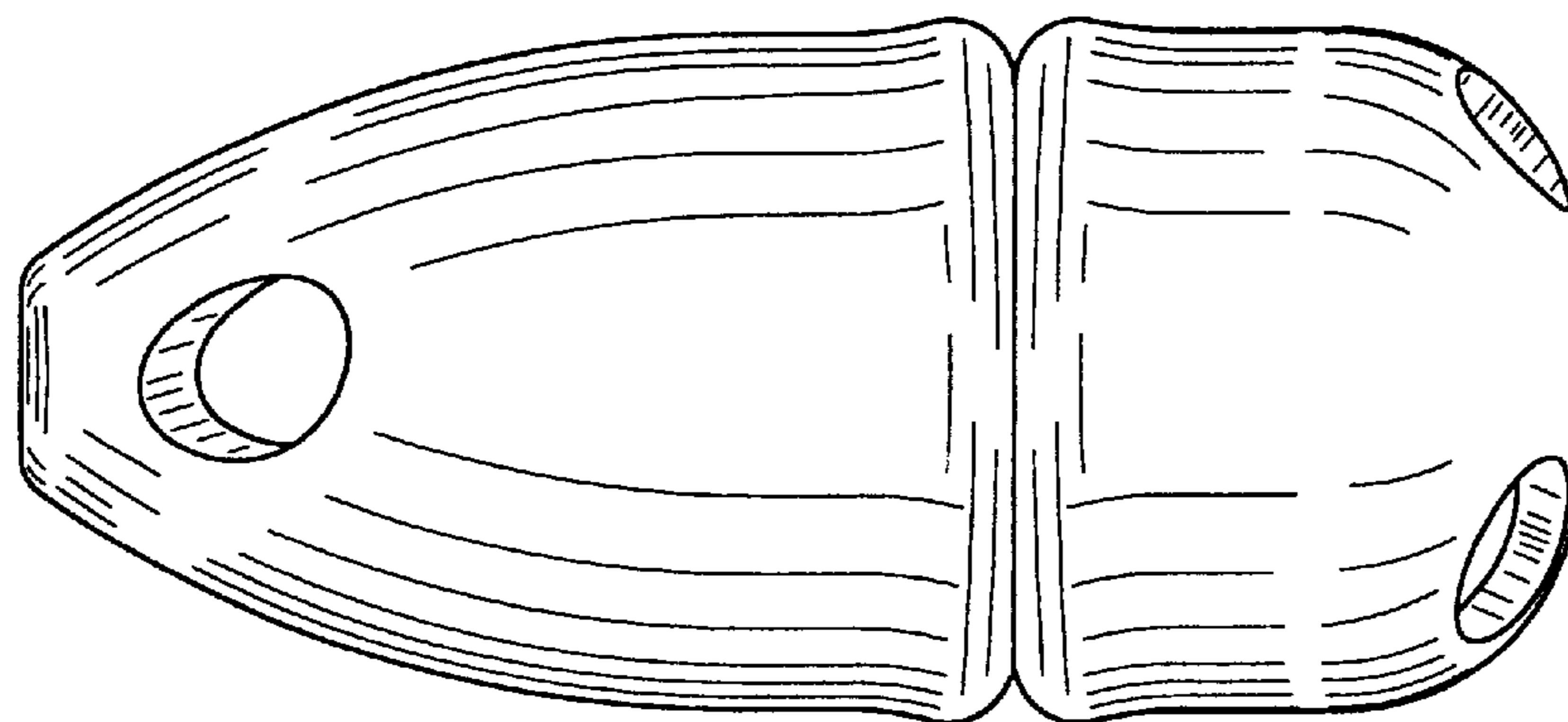

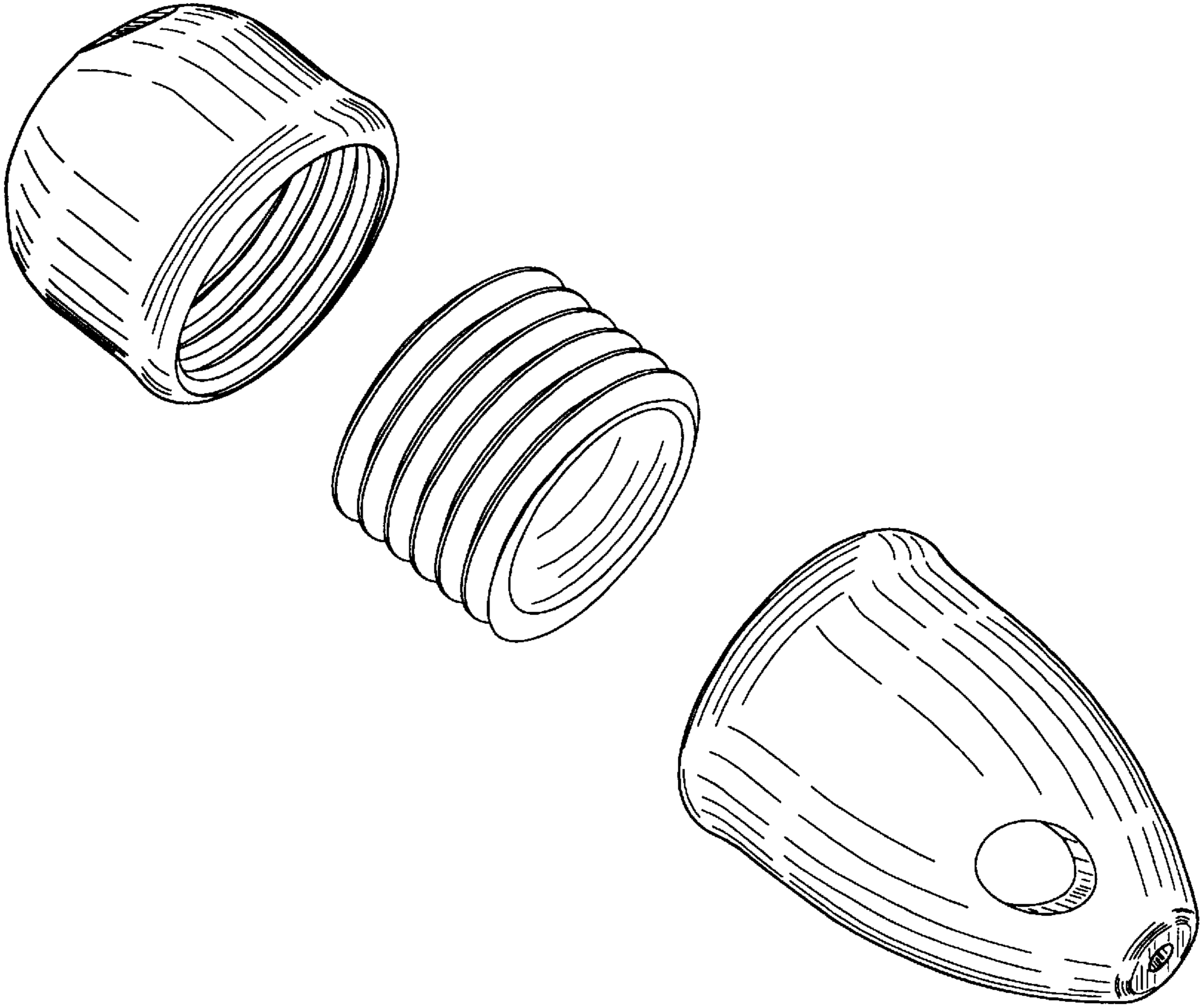

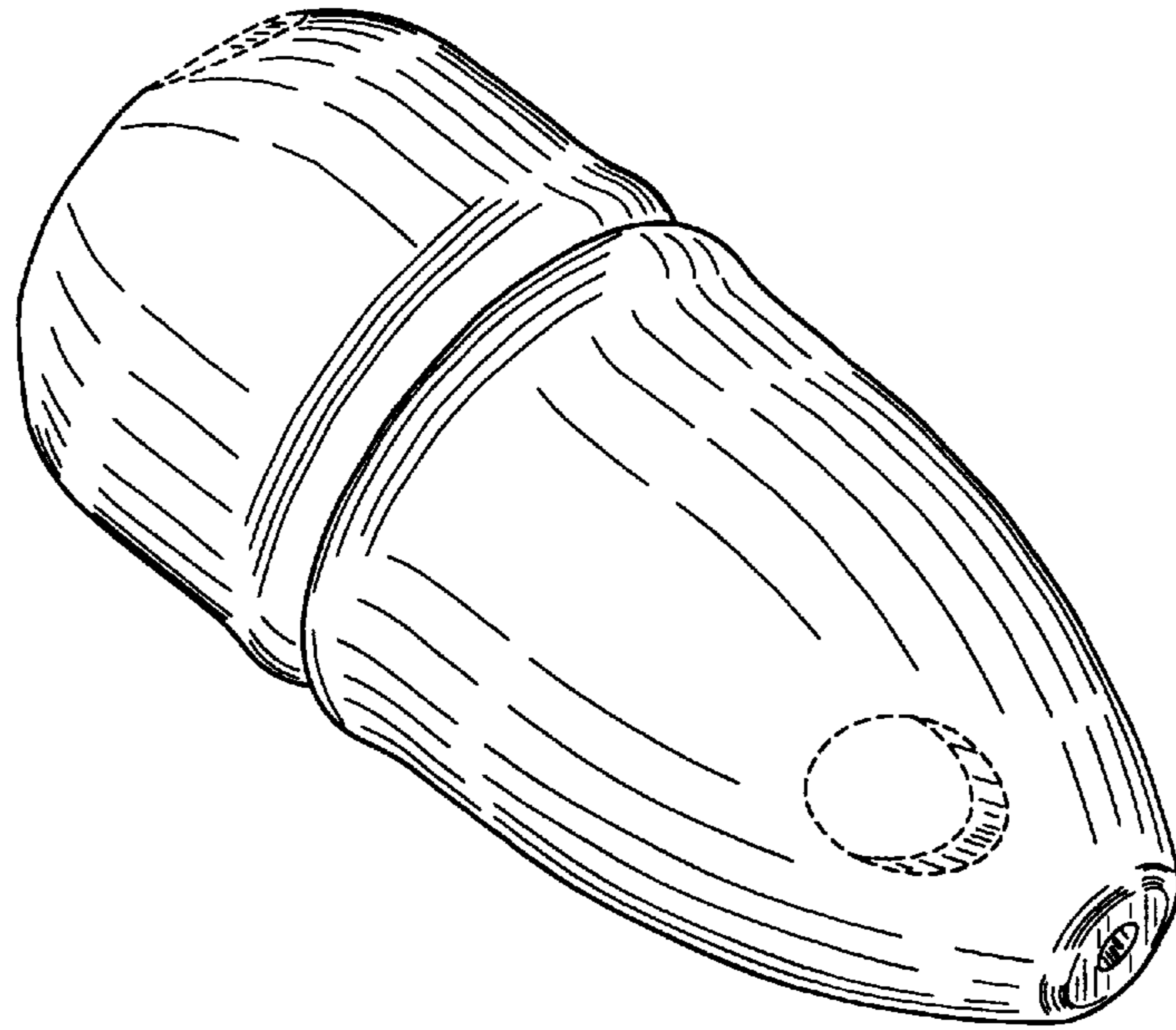

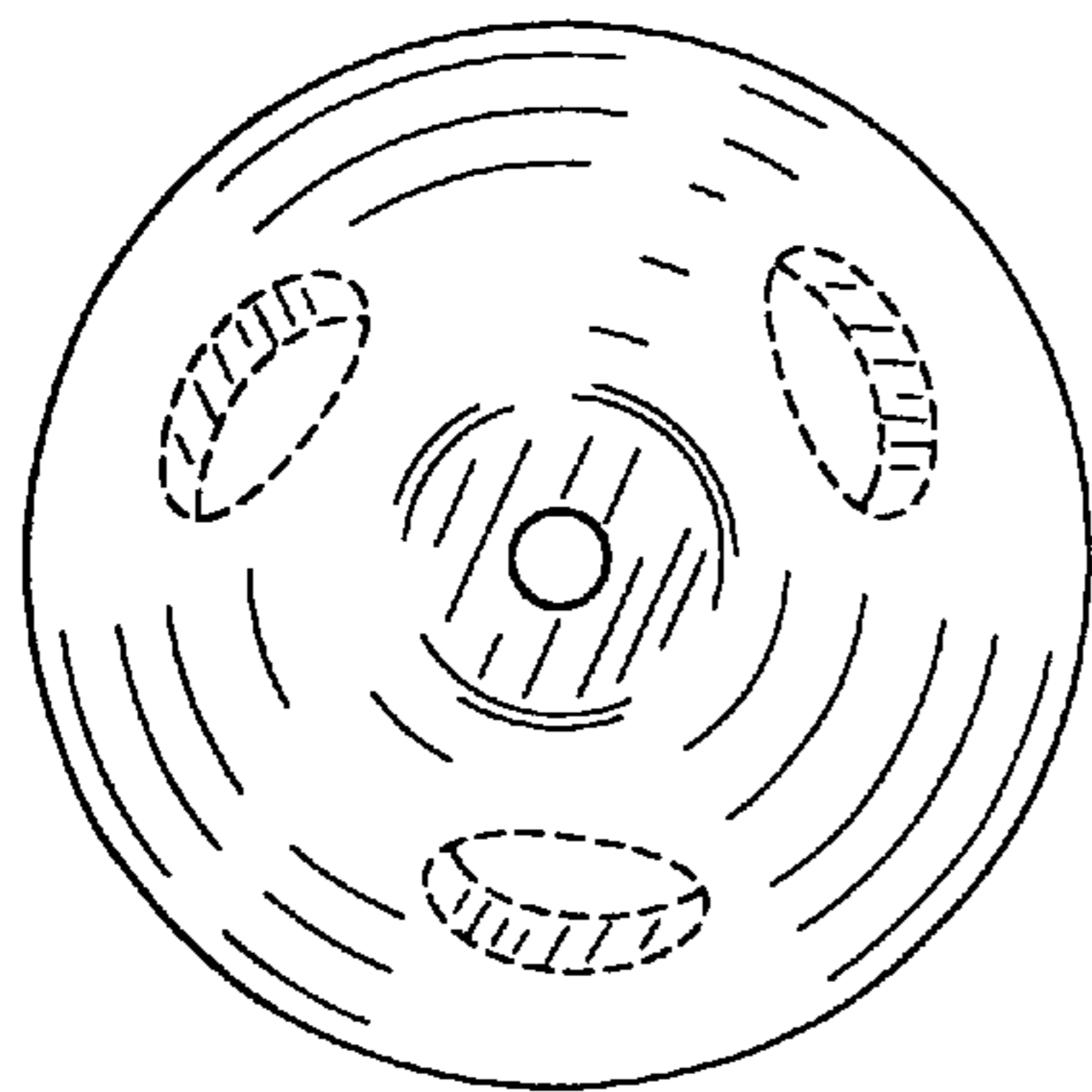

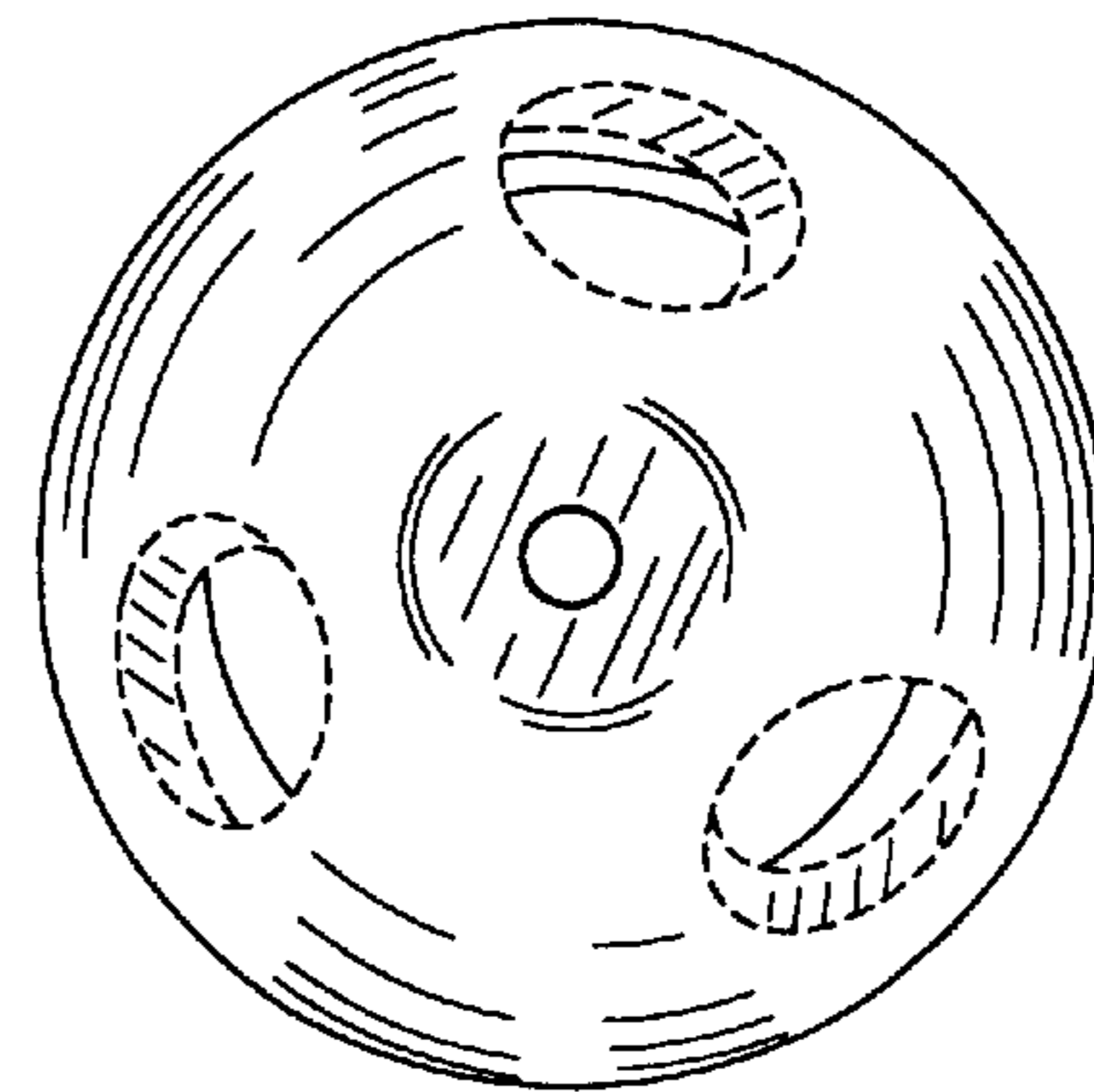

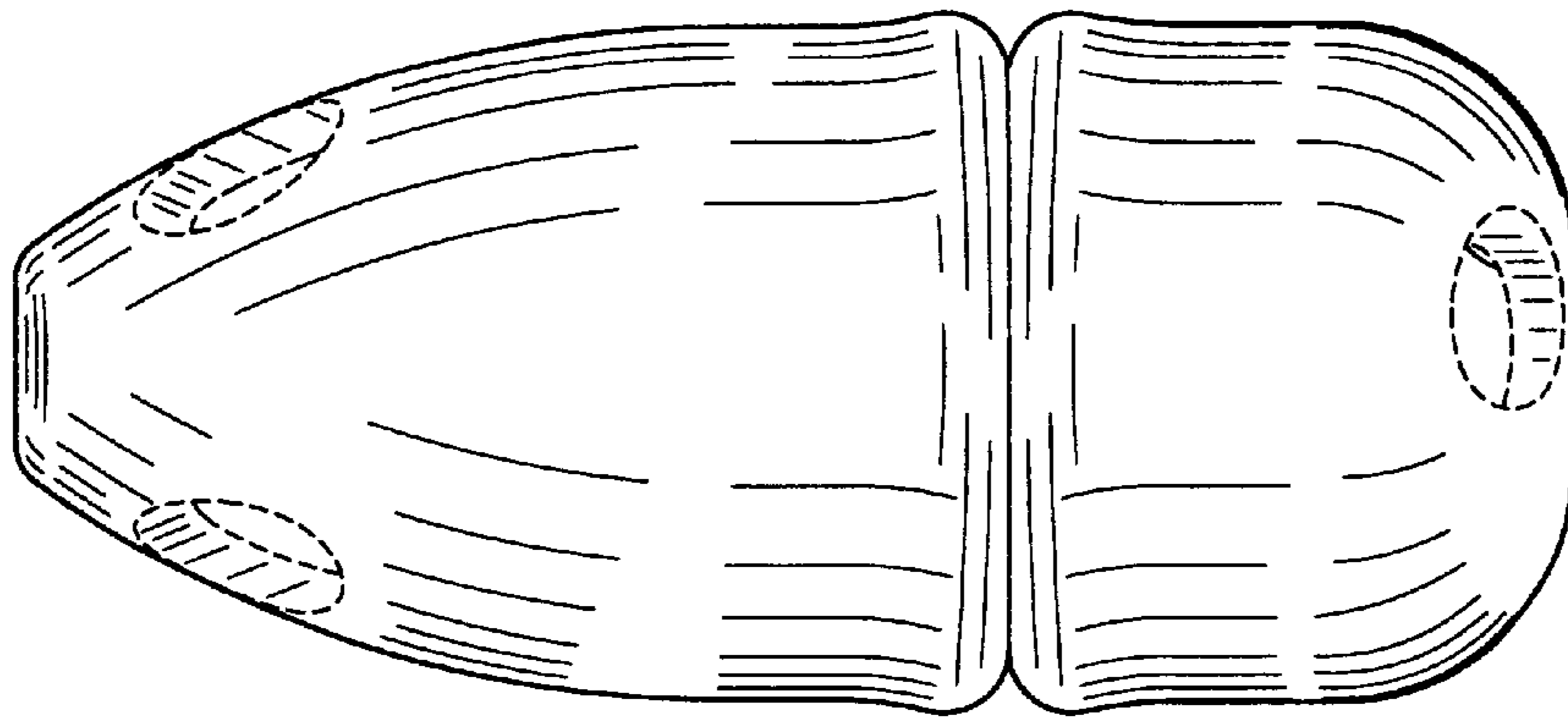

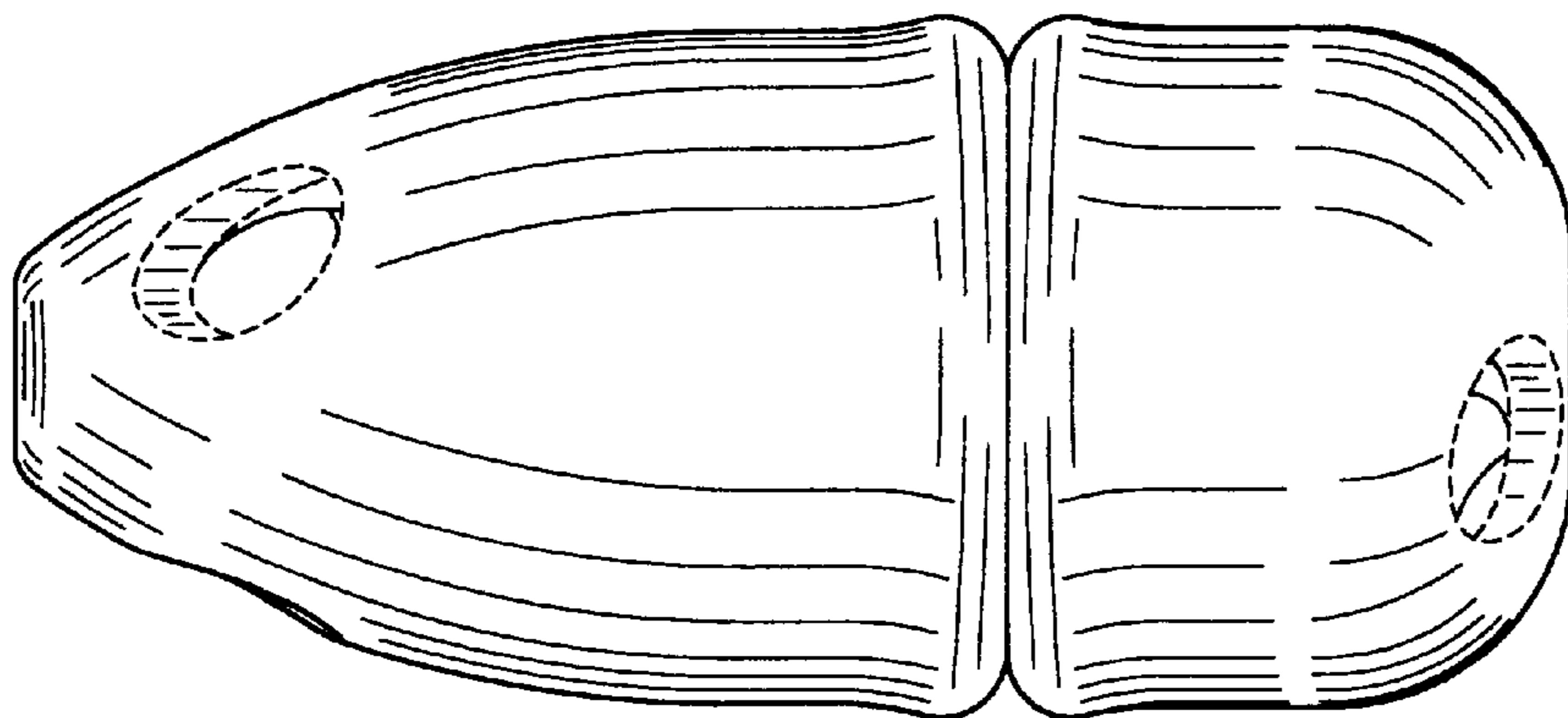

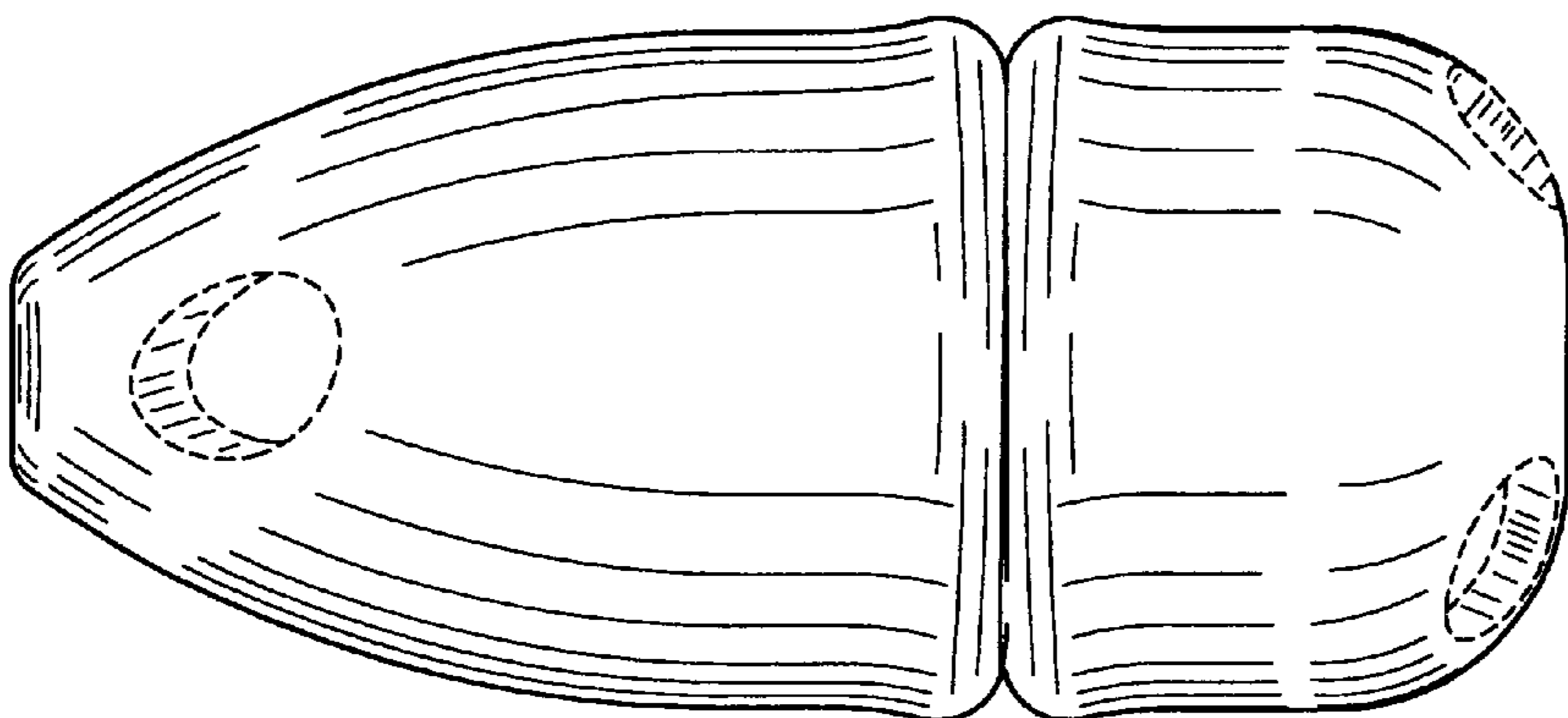

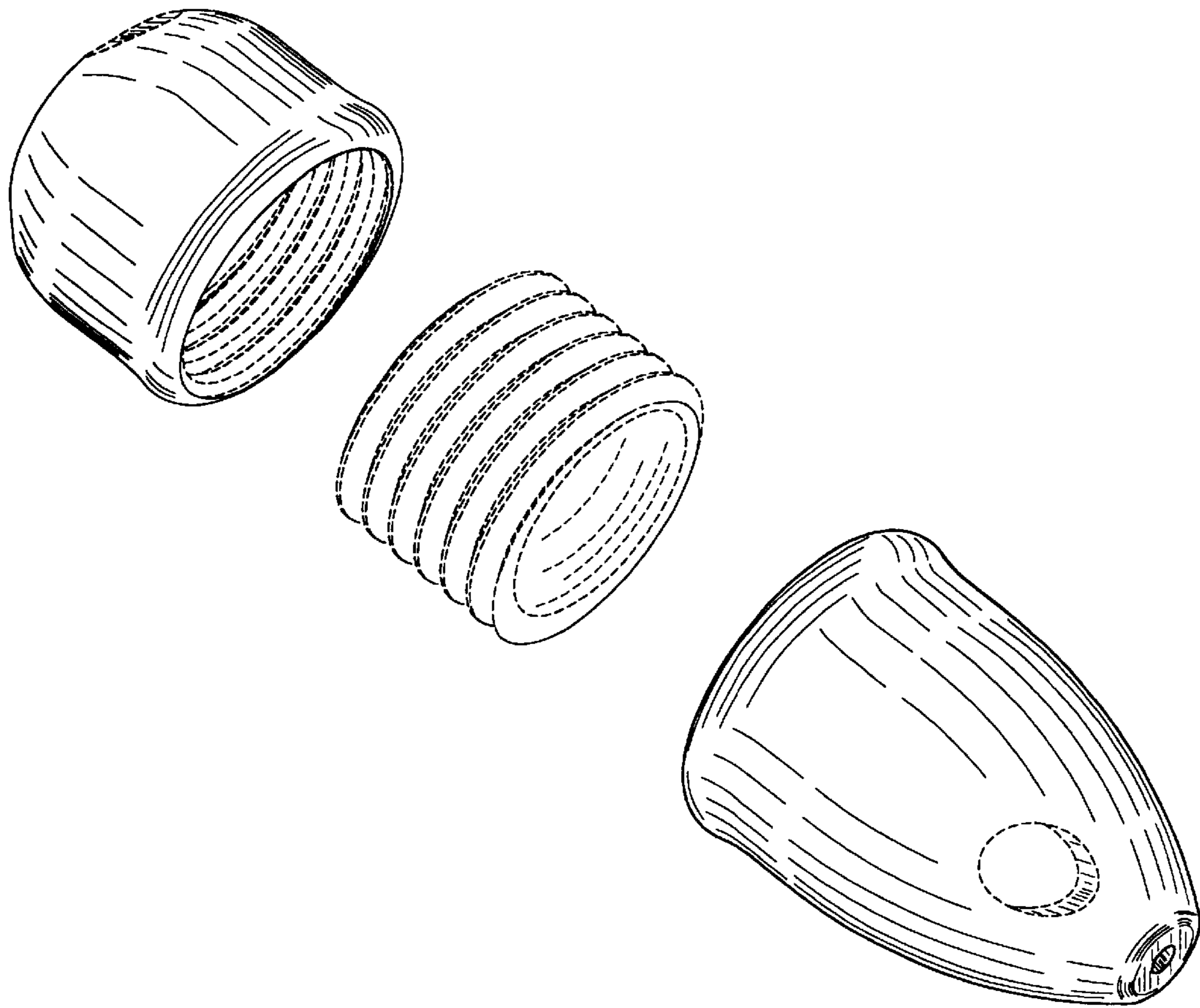

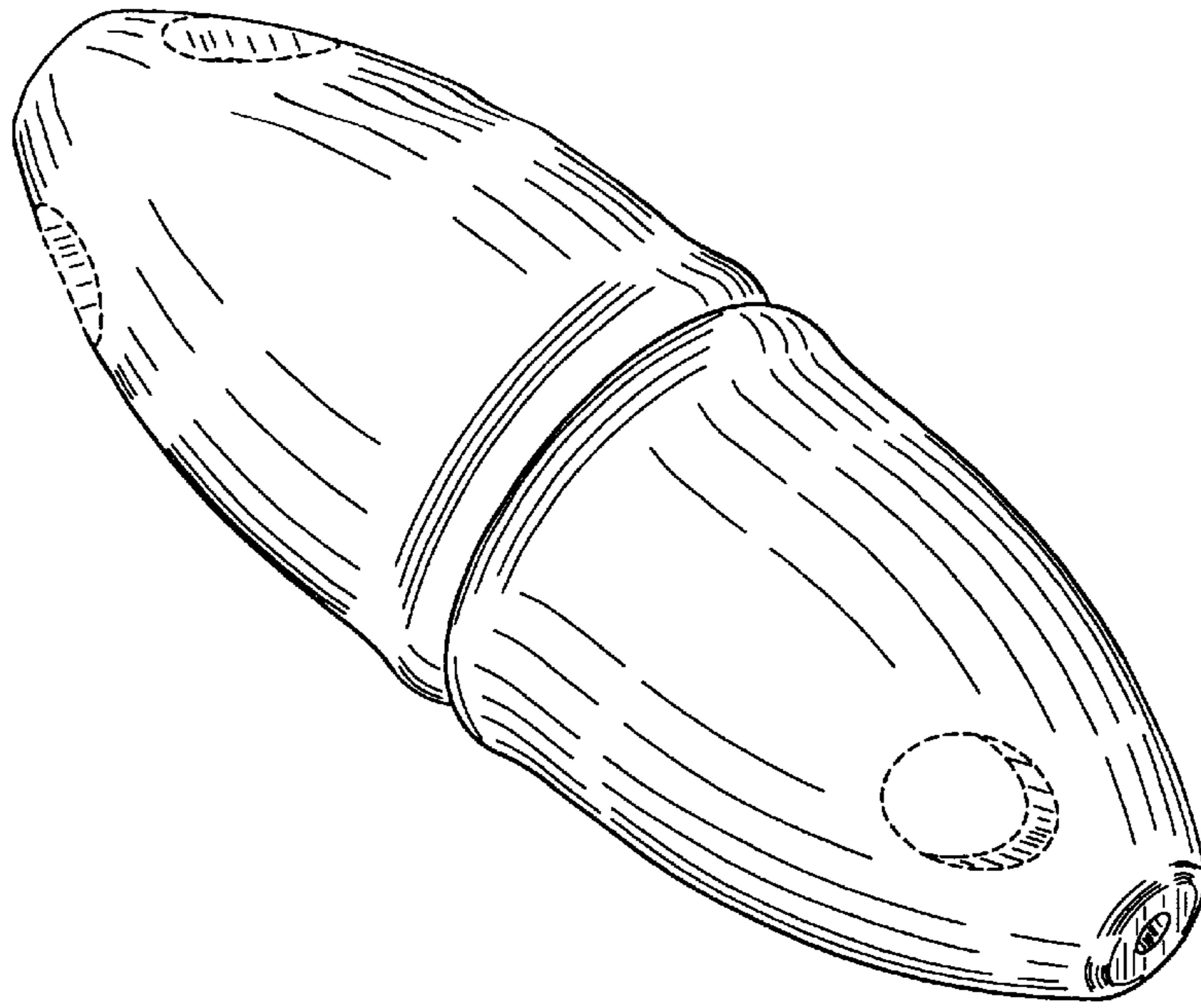

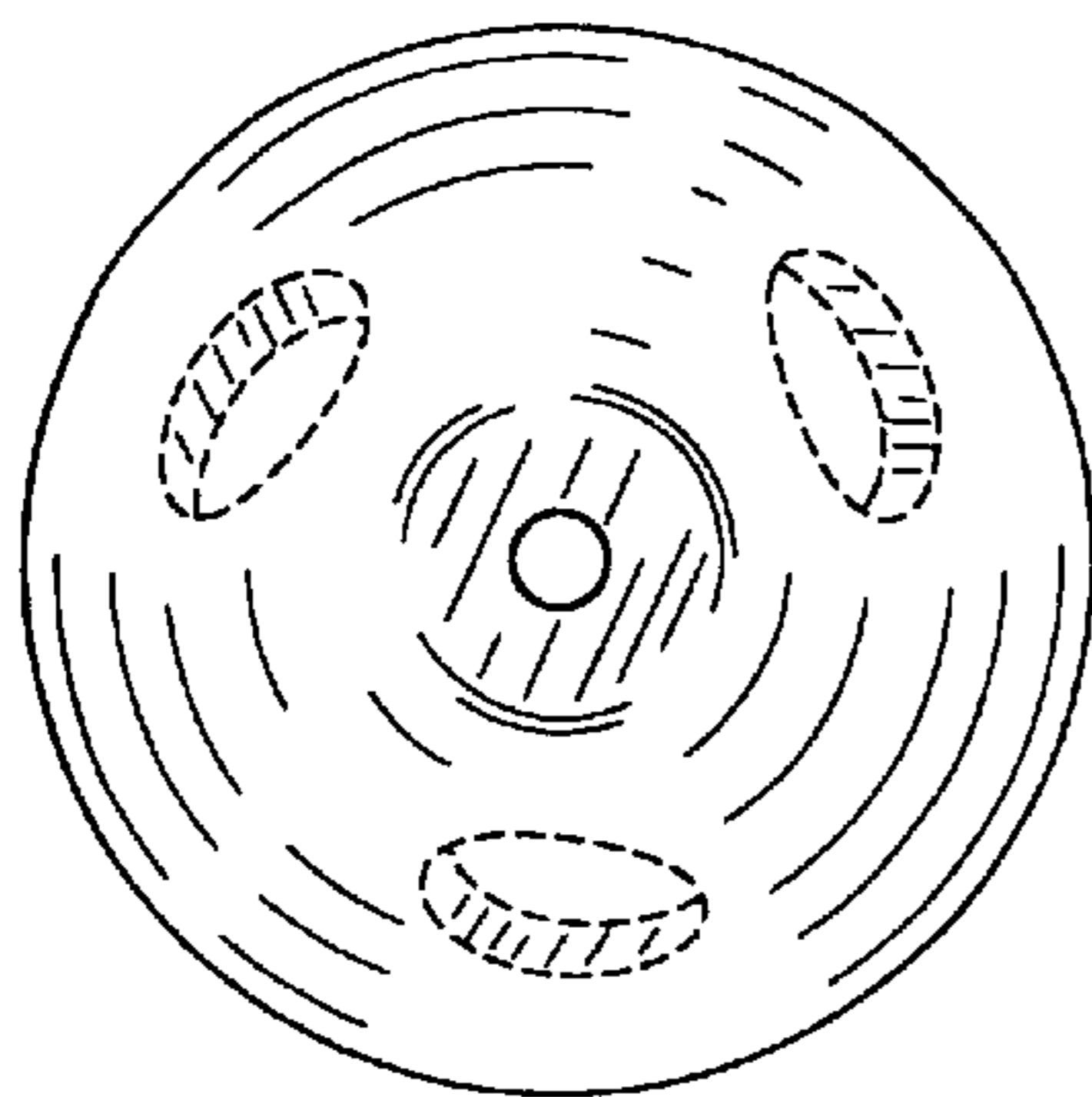

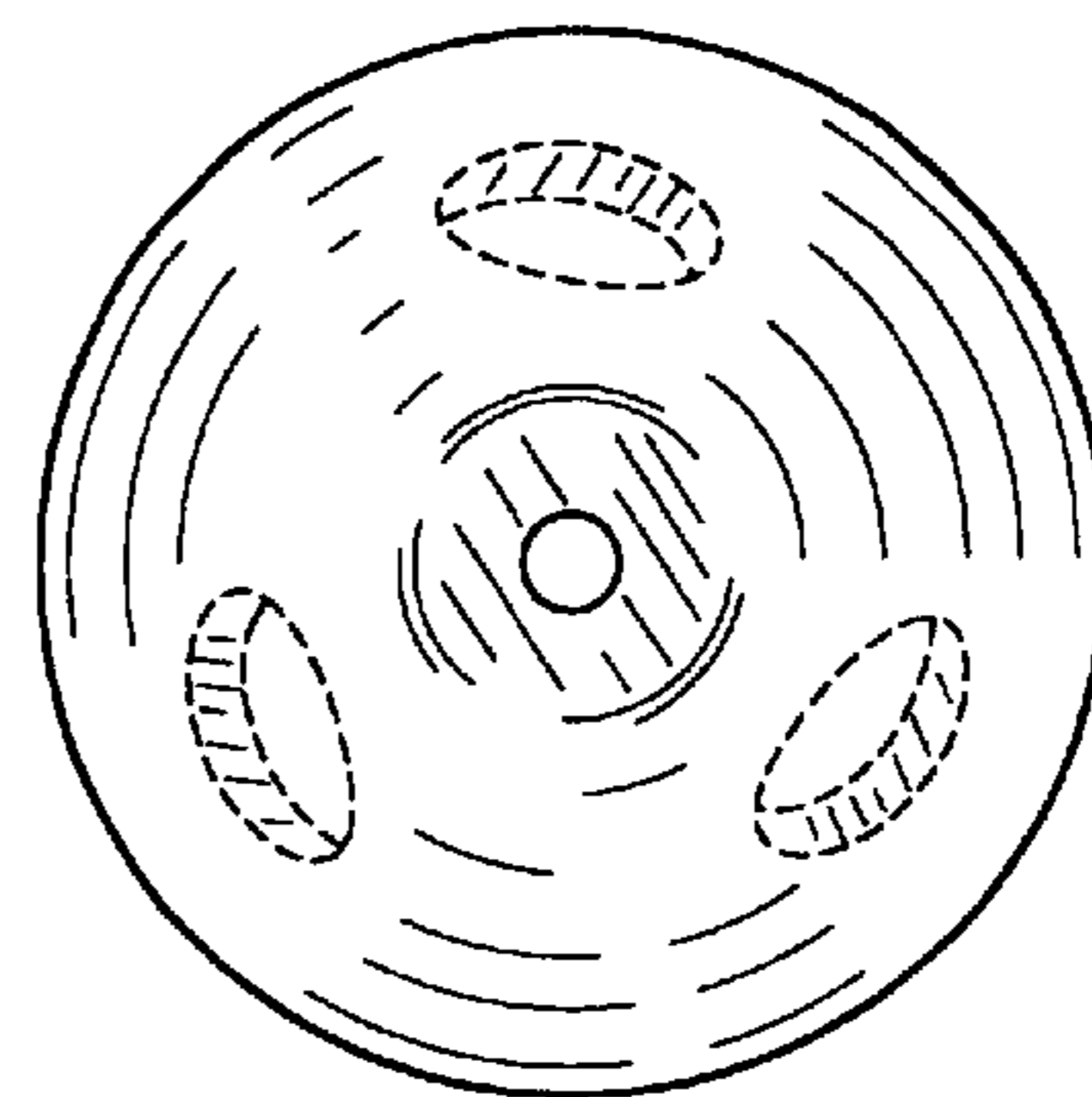

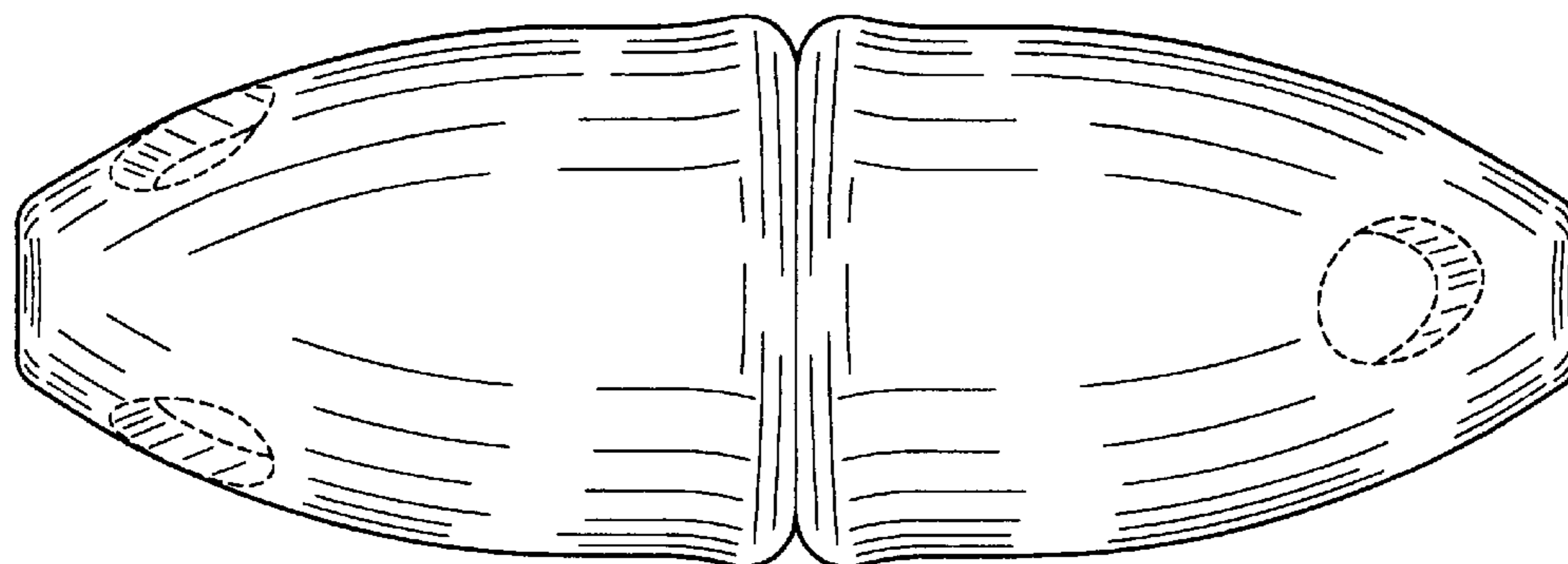

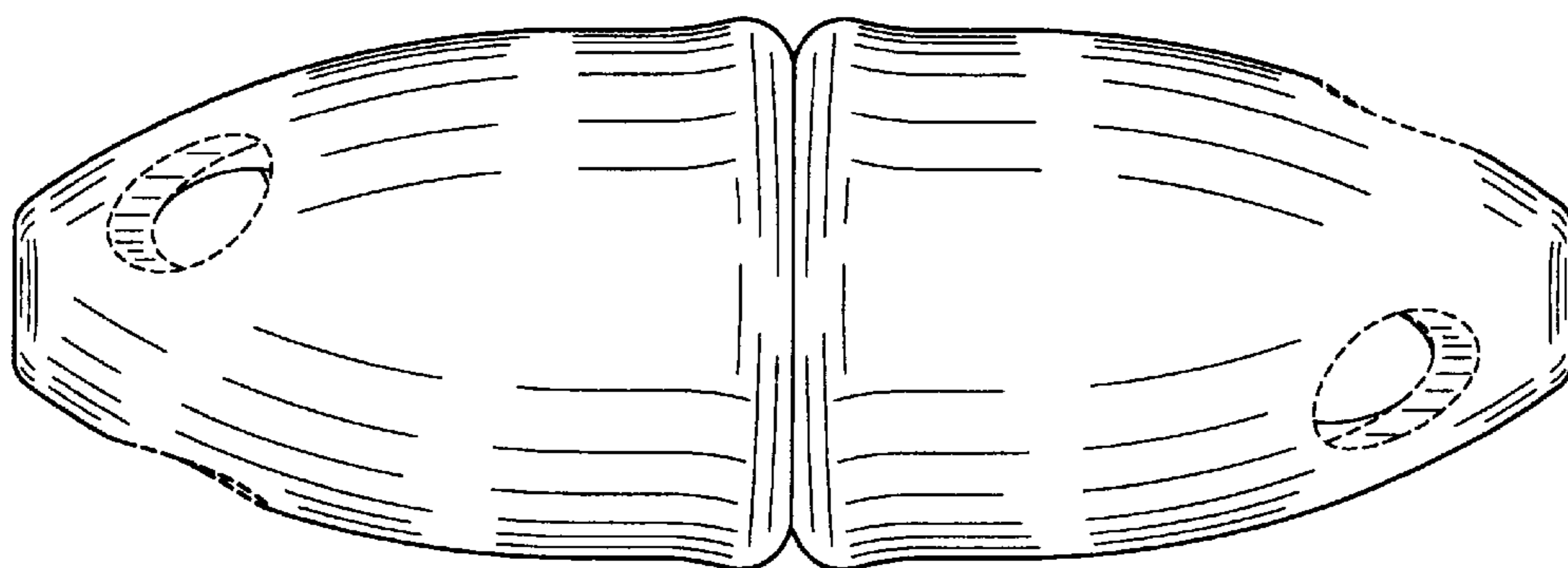

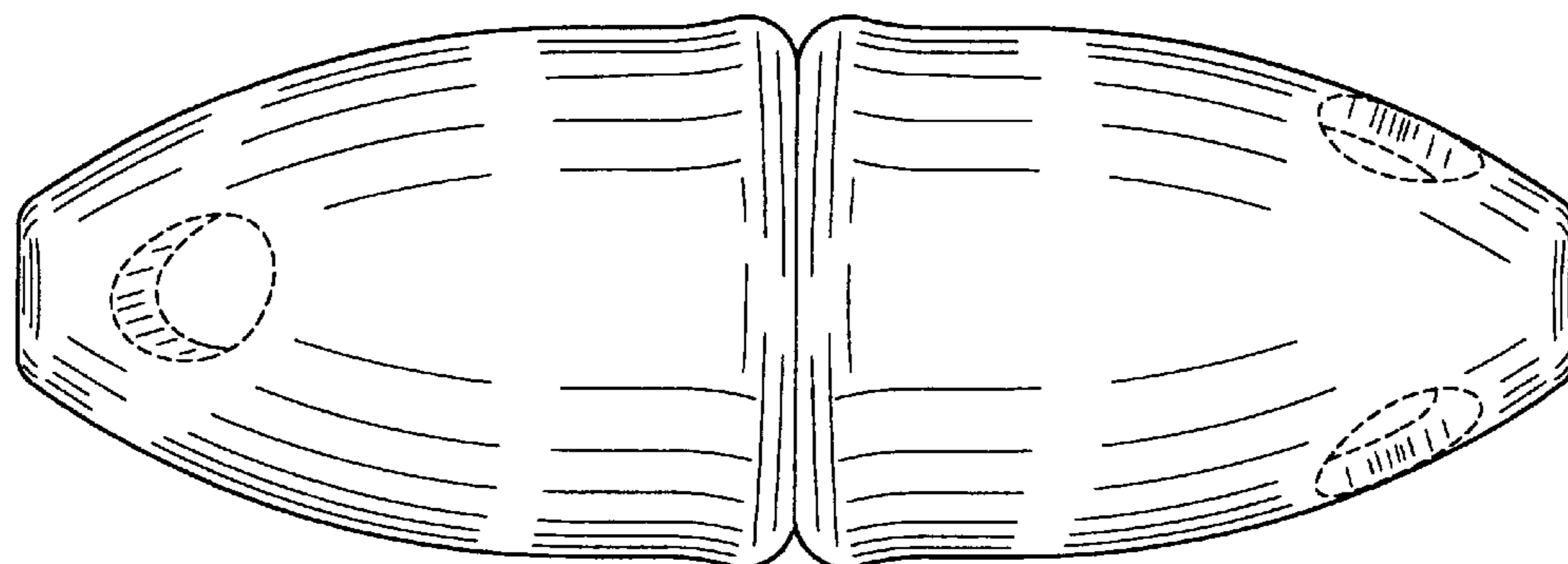

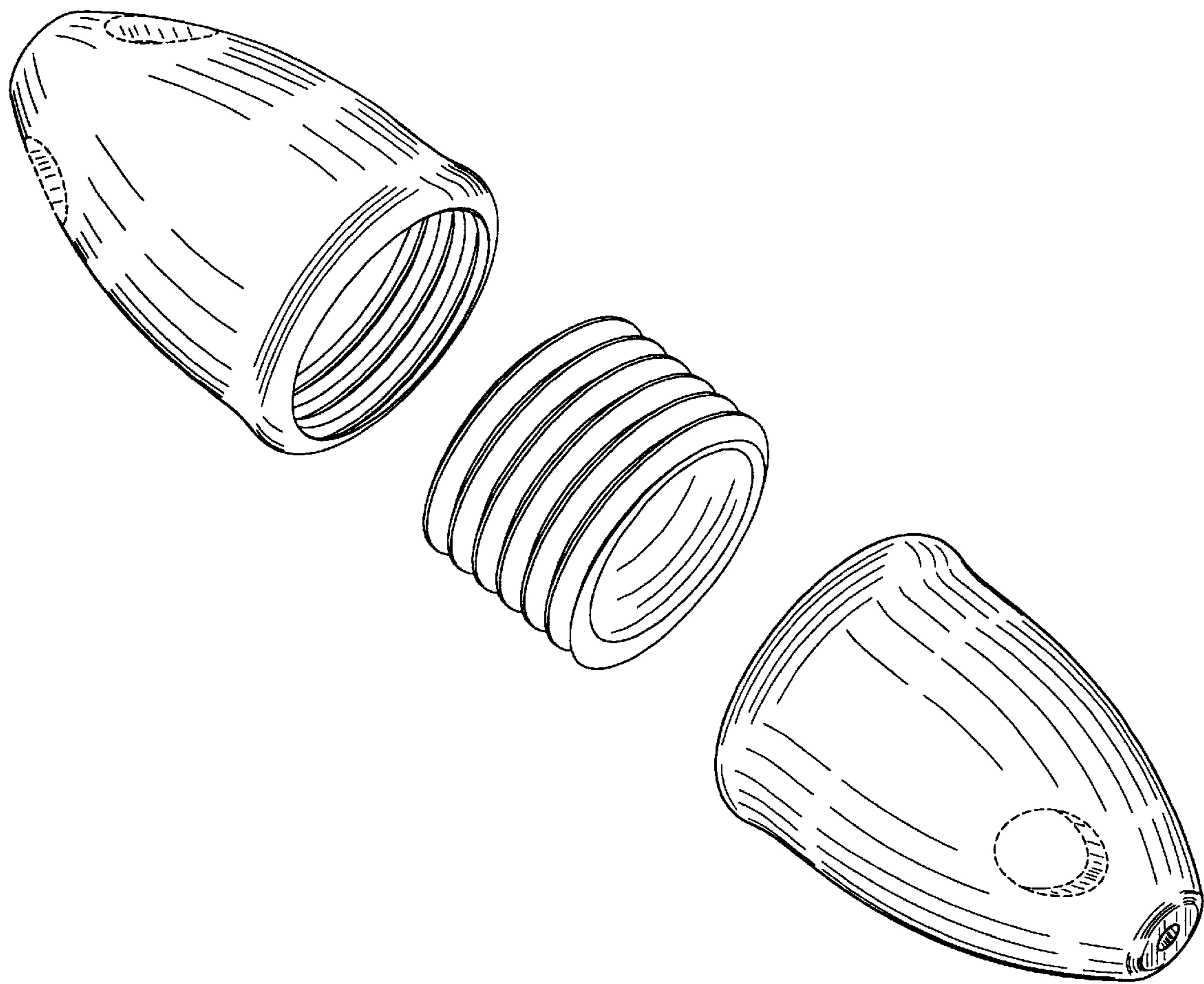

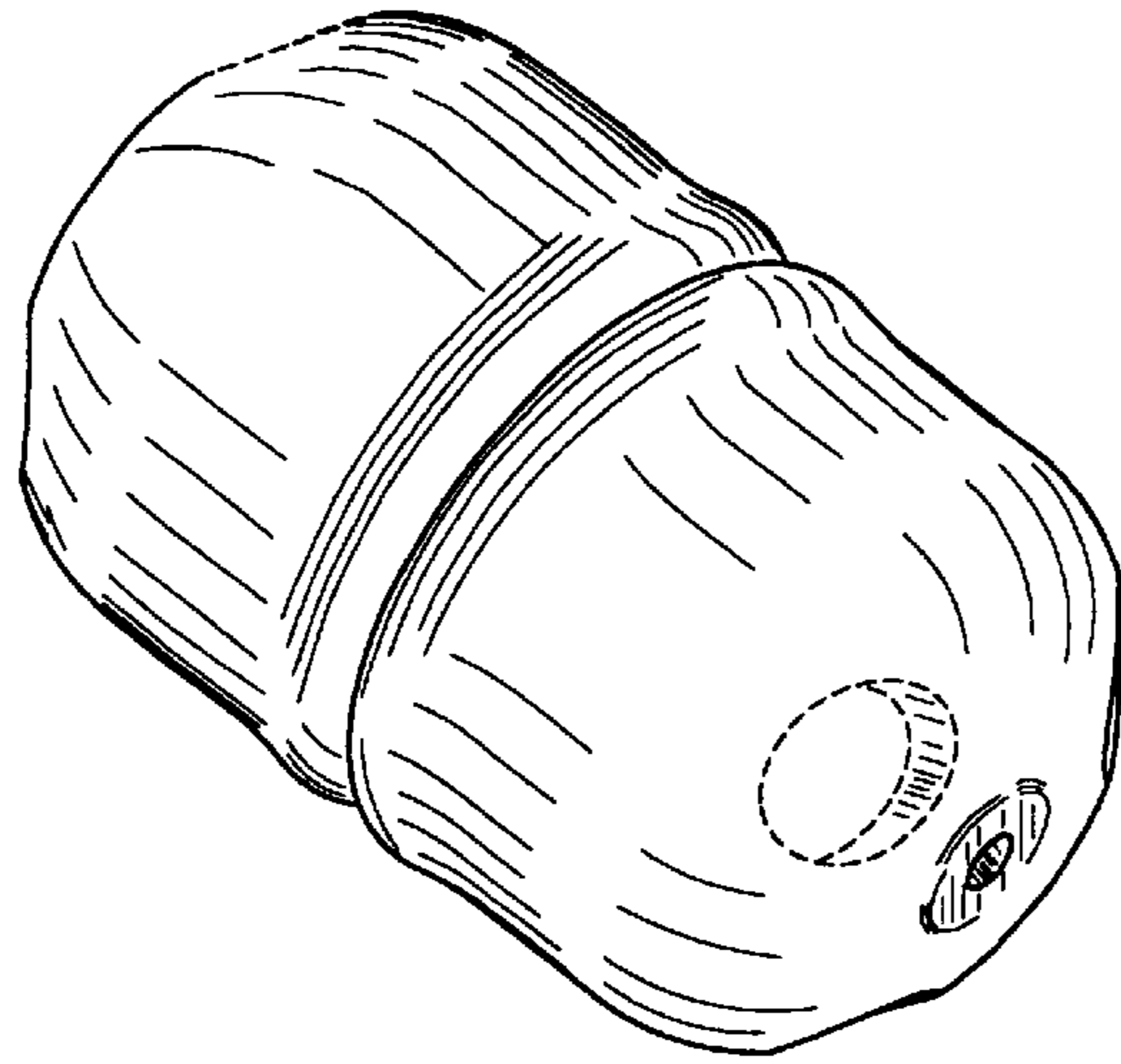

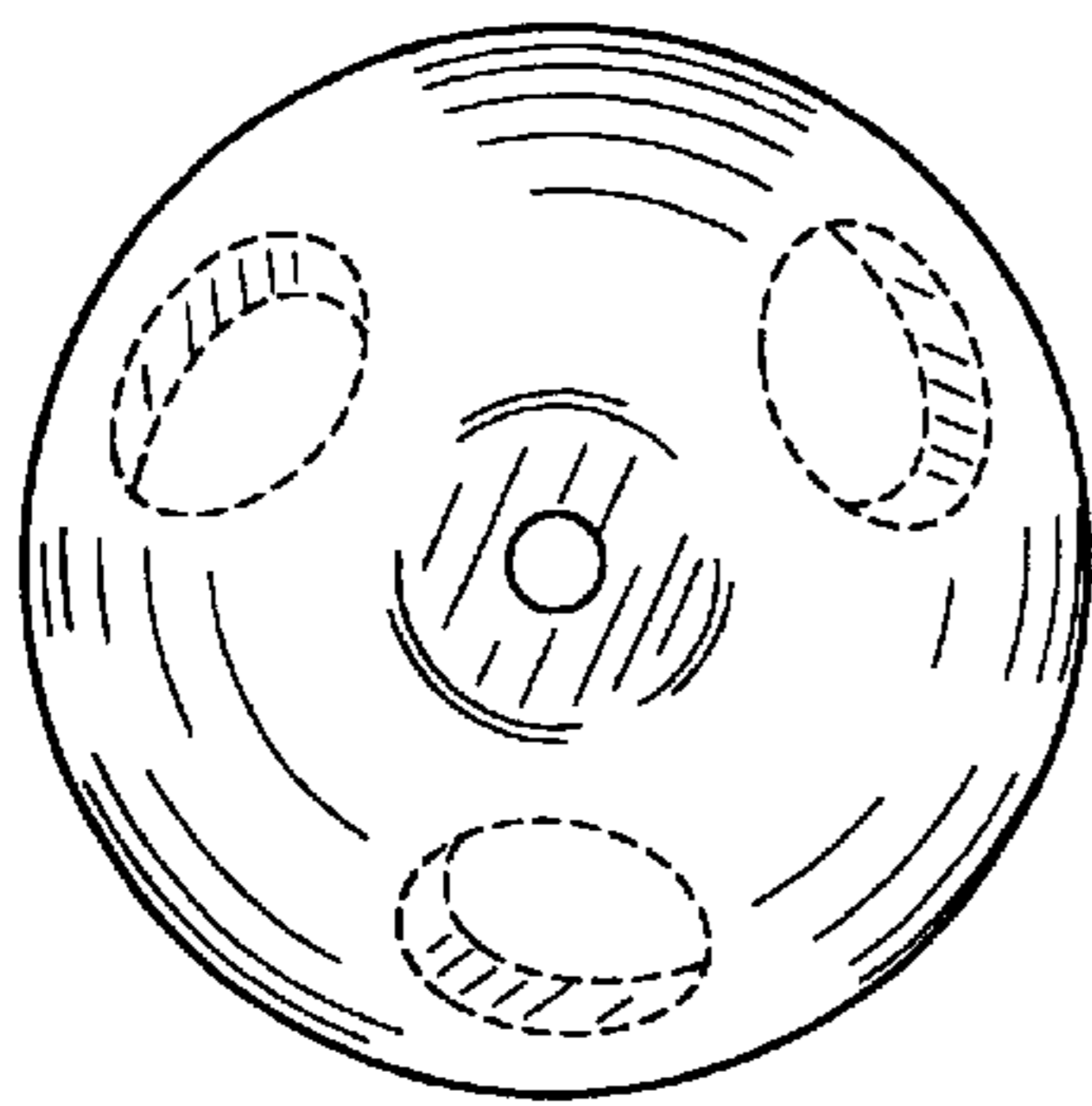

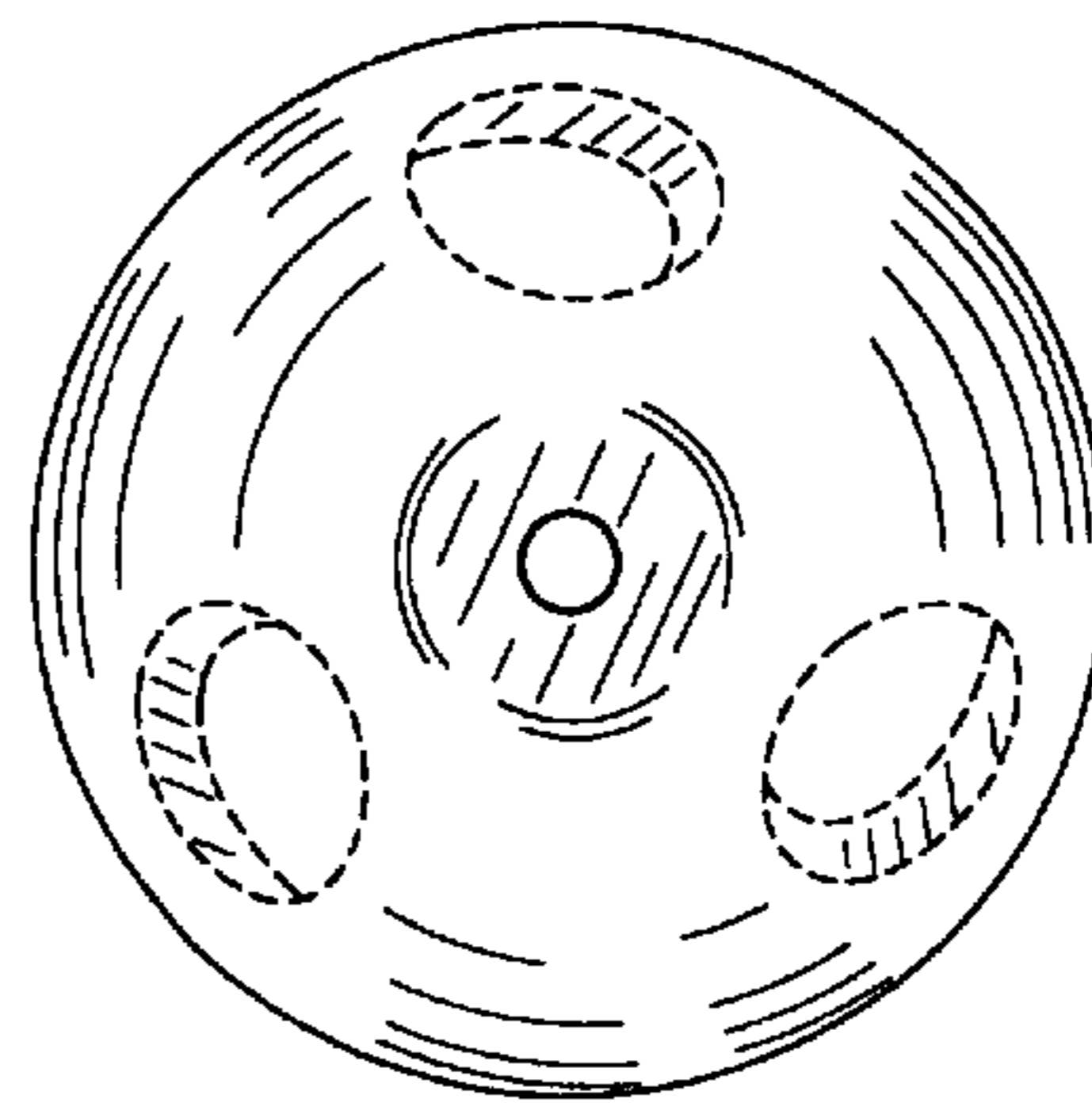

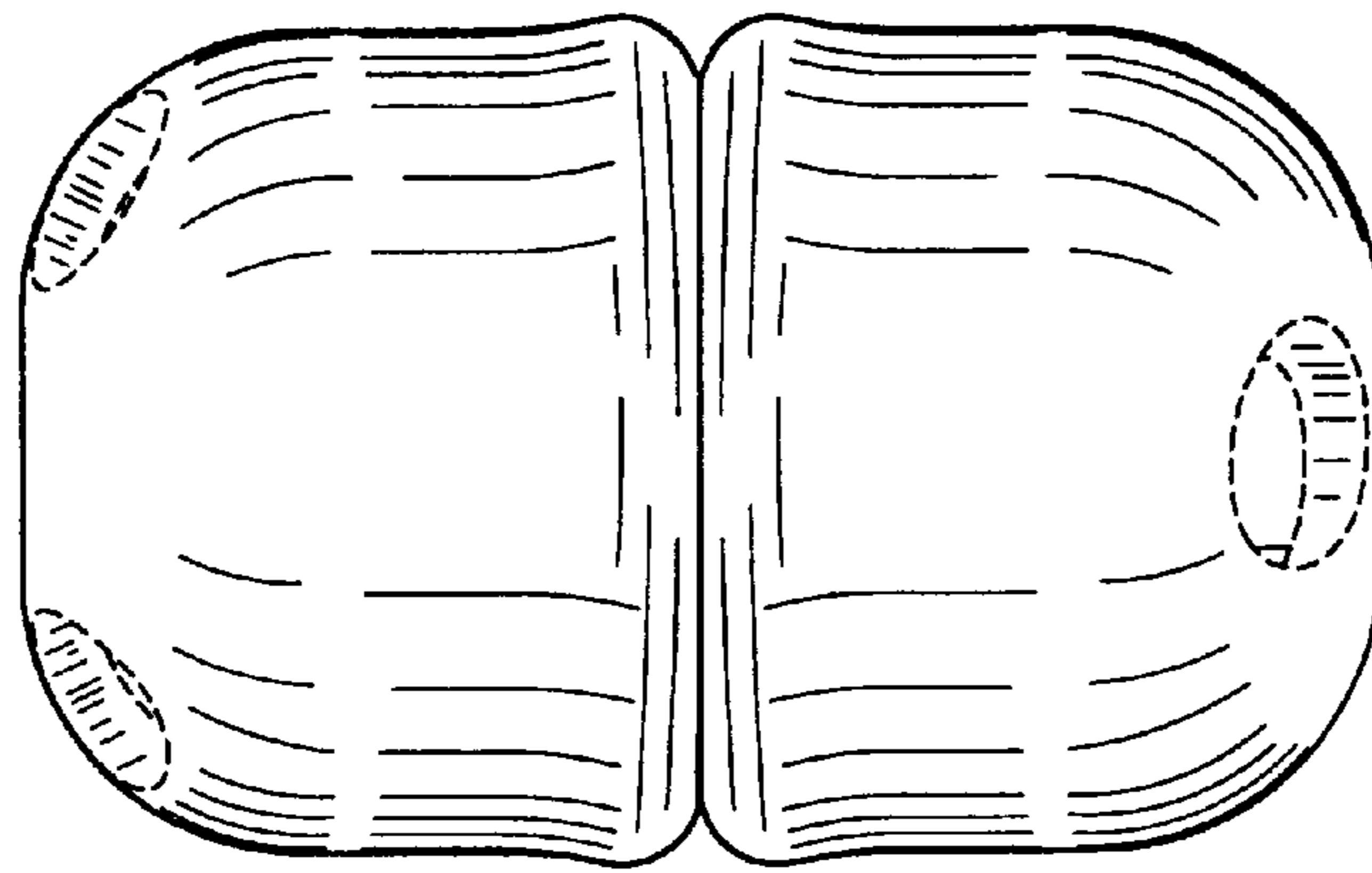

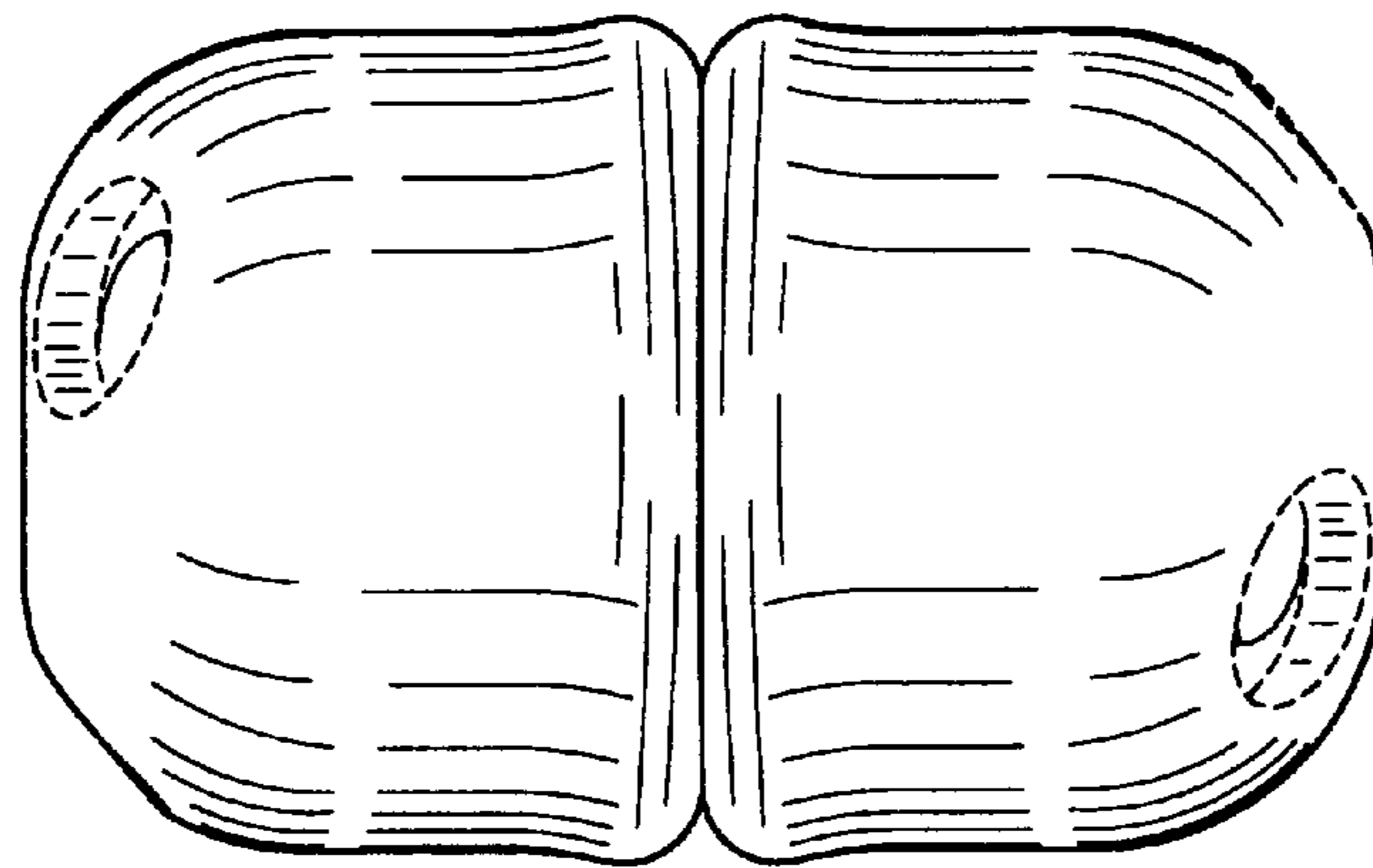

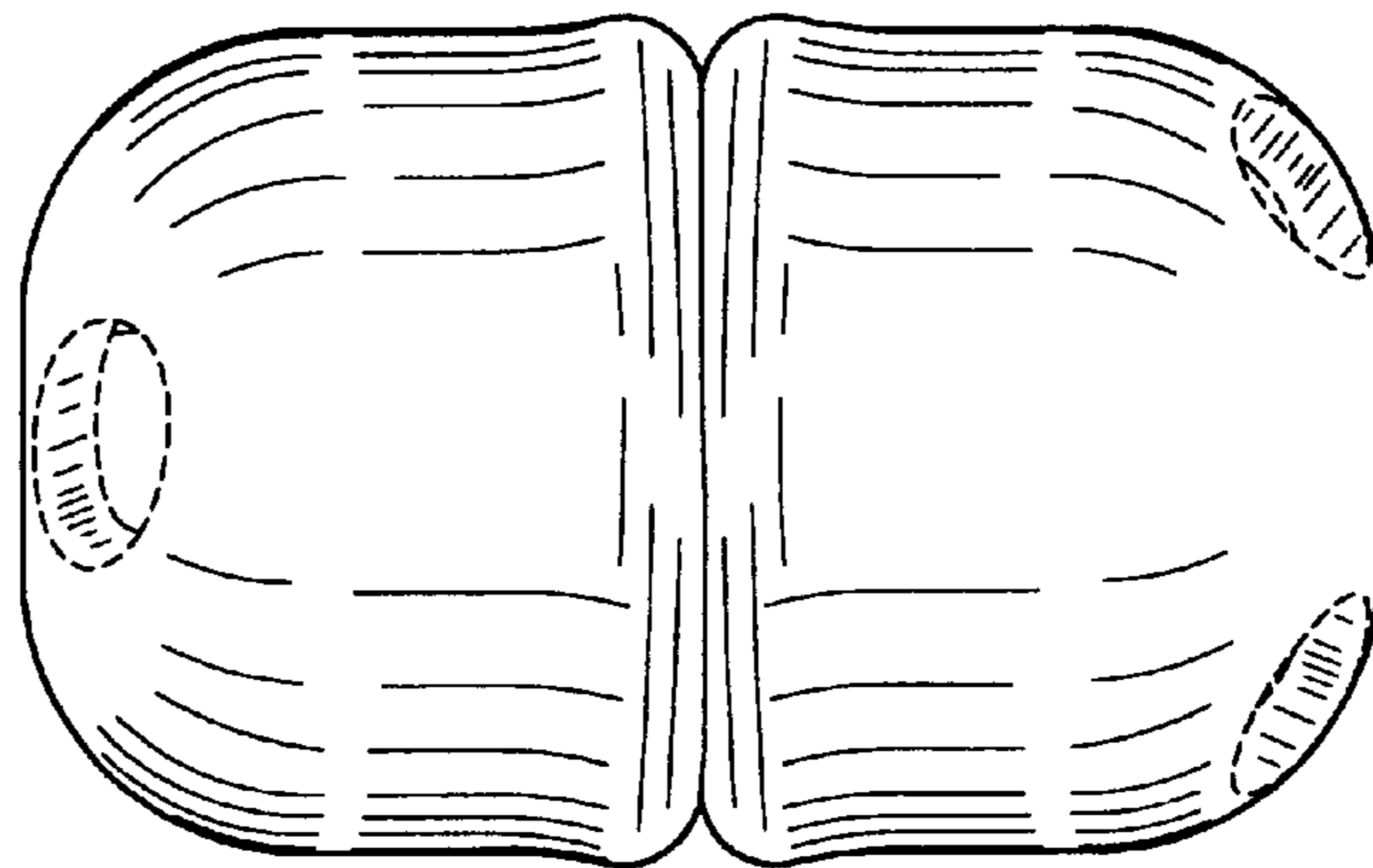

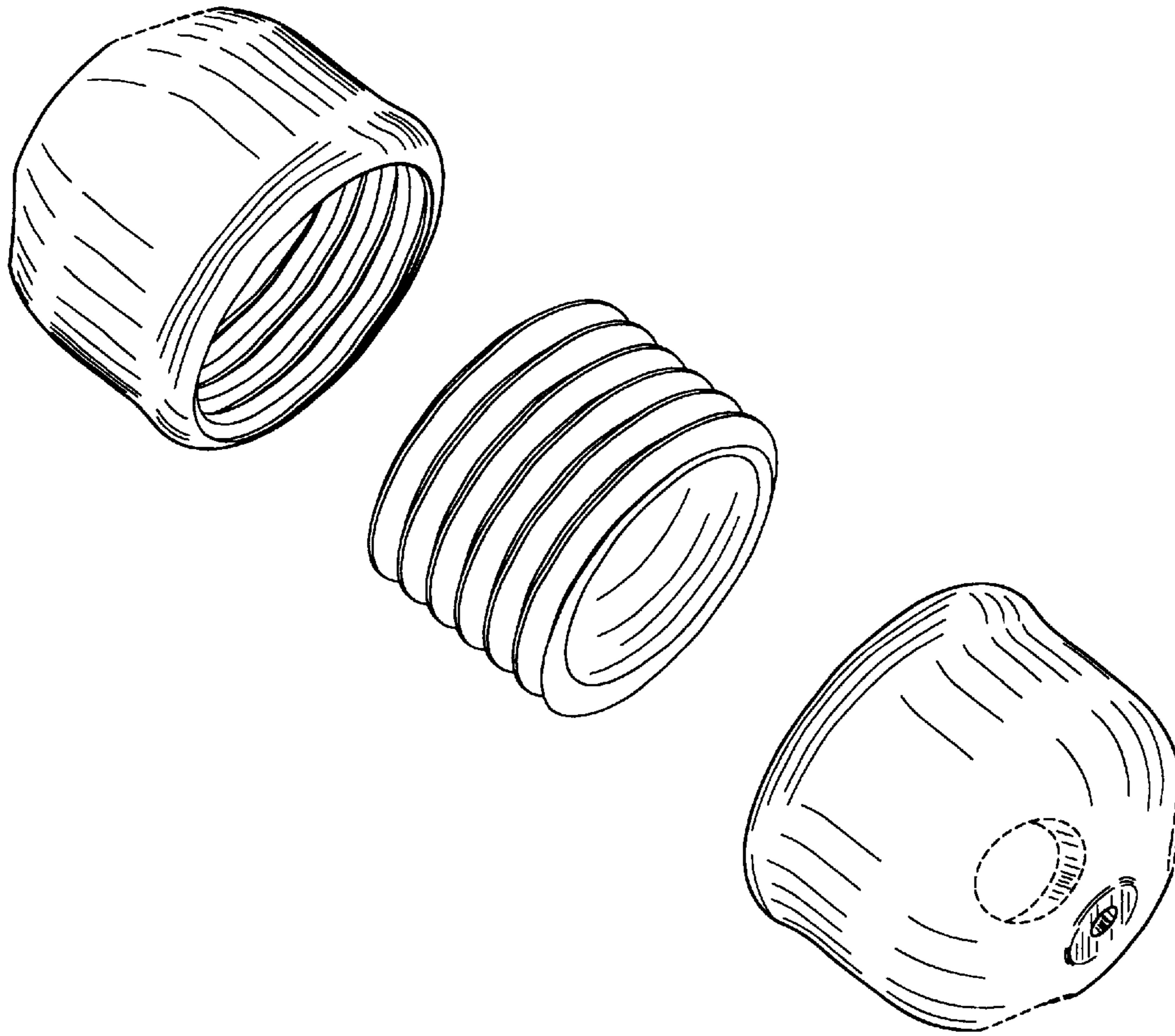
