(57) **CLAIM**

The ornamental design for a medicinal tablet, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a medicinal tablet showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a side elevation thereof, the side opposite being a mirror image; and, FIG. 4 is a bottom plan view thereof. The broken line disclosure in FIGS. 1–4 is for environmental purposes only and does not constitute a part of the claimed design.

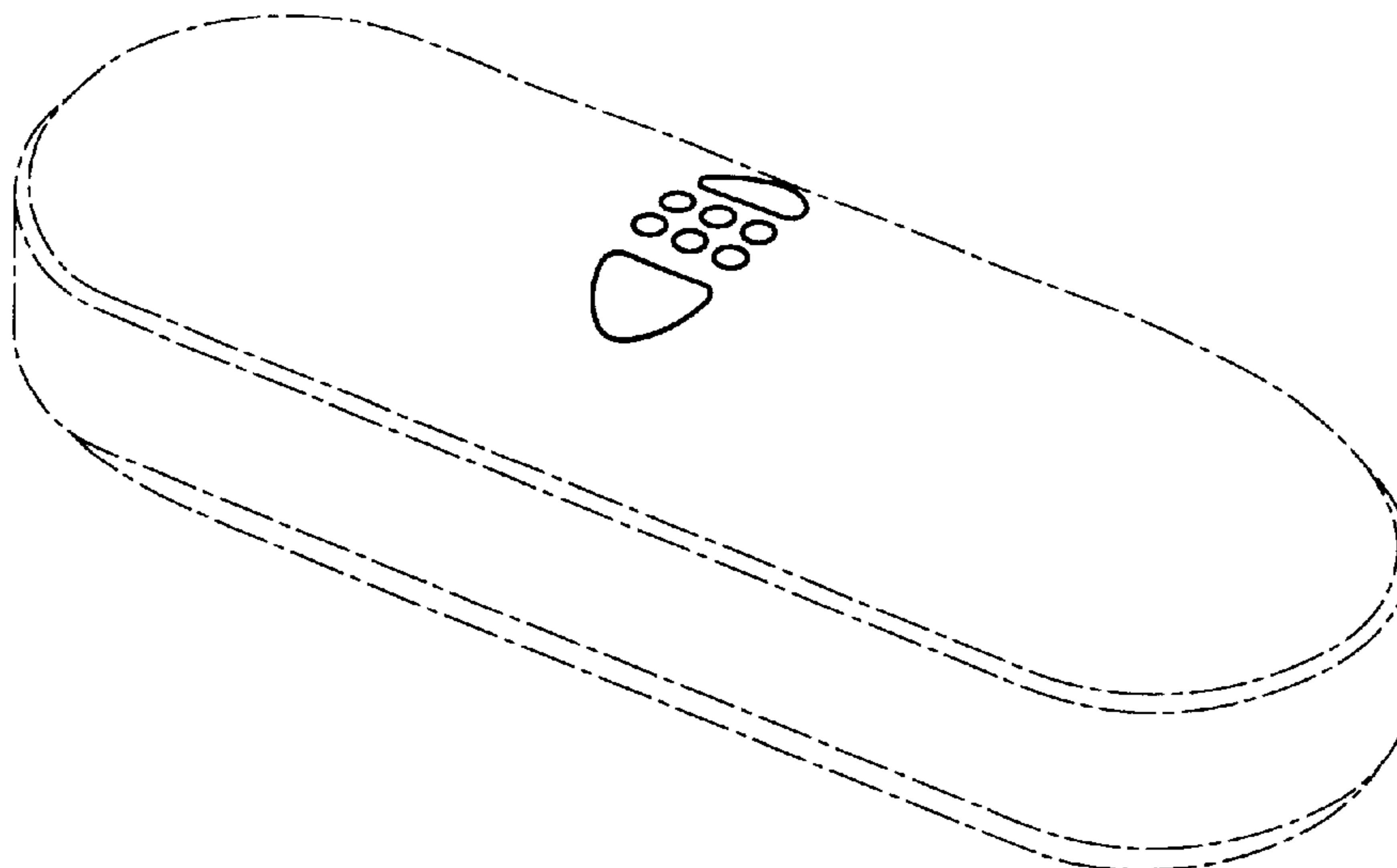

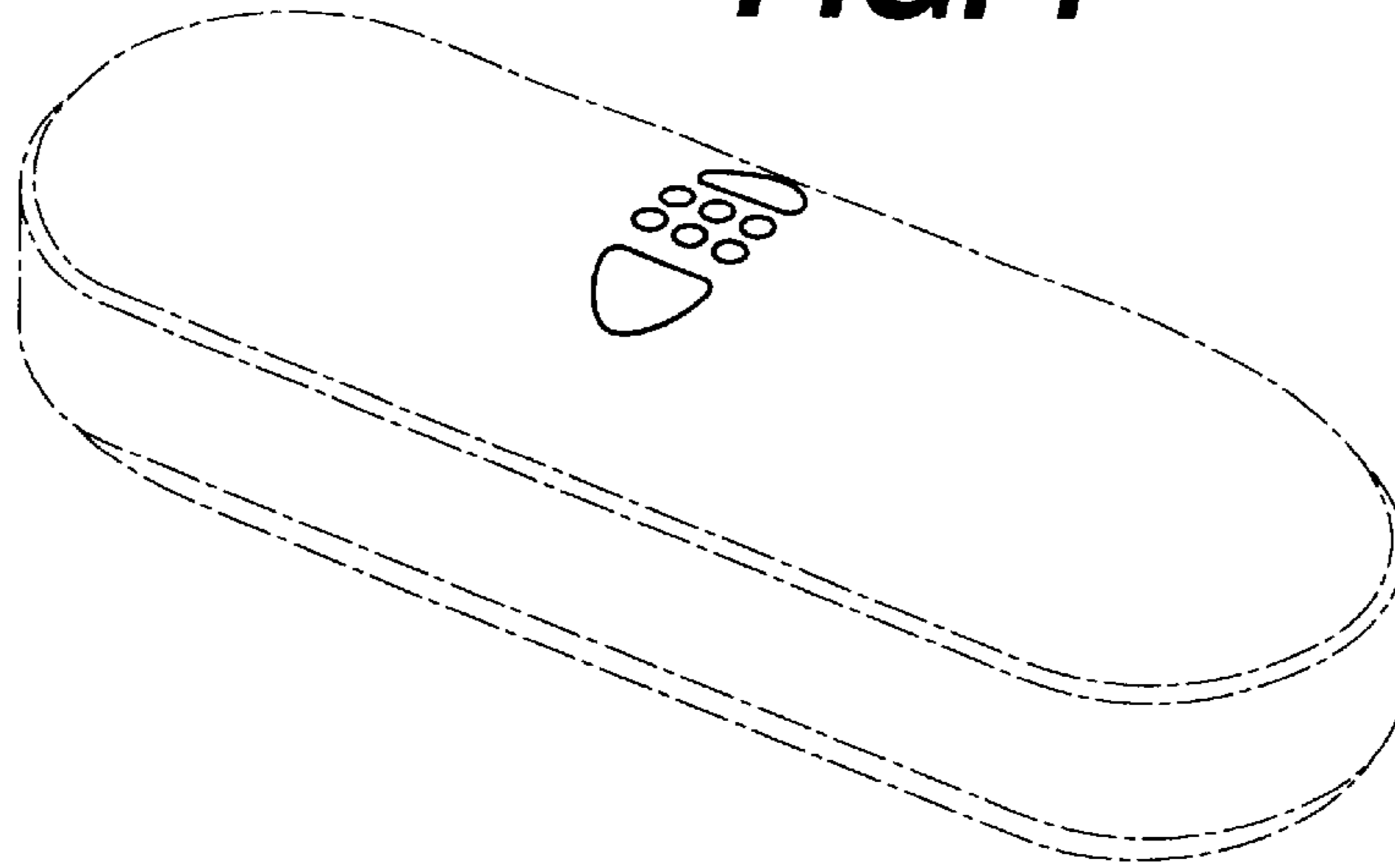

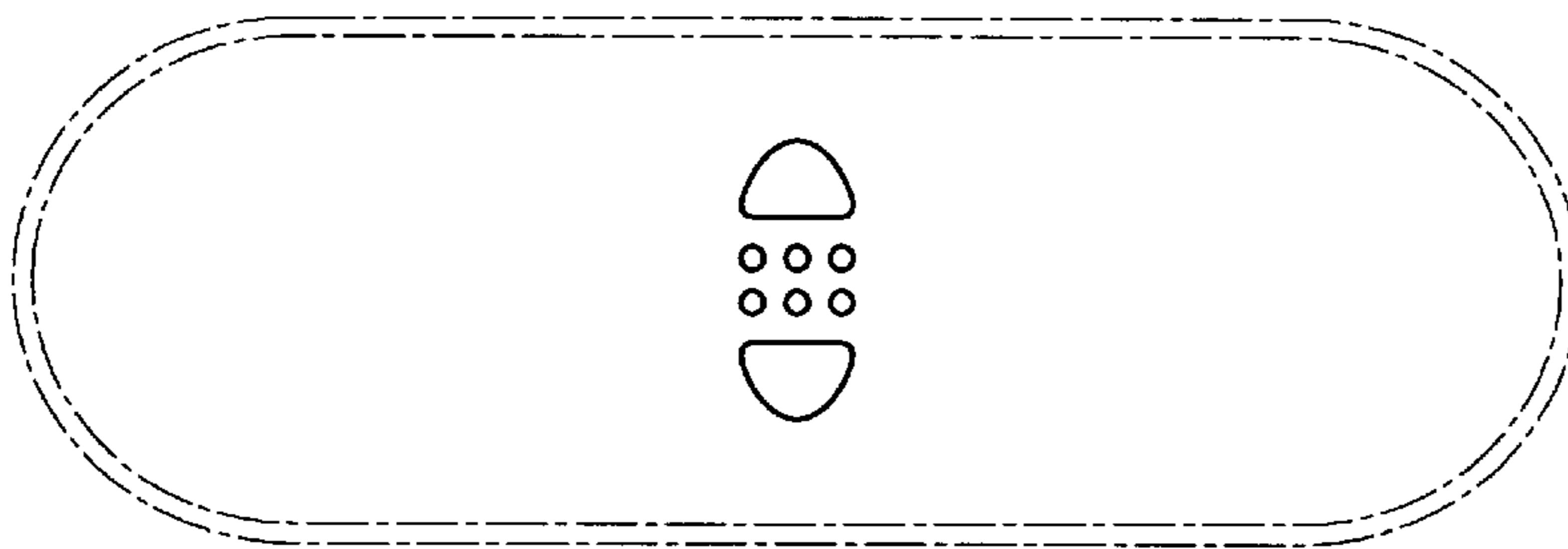

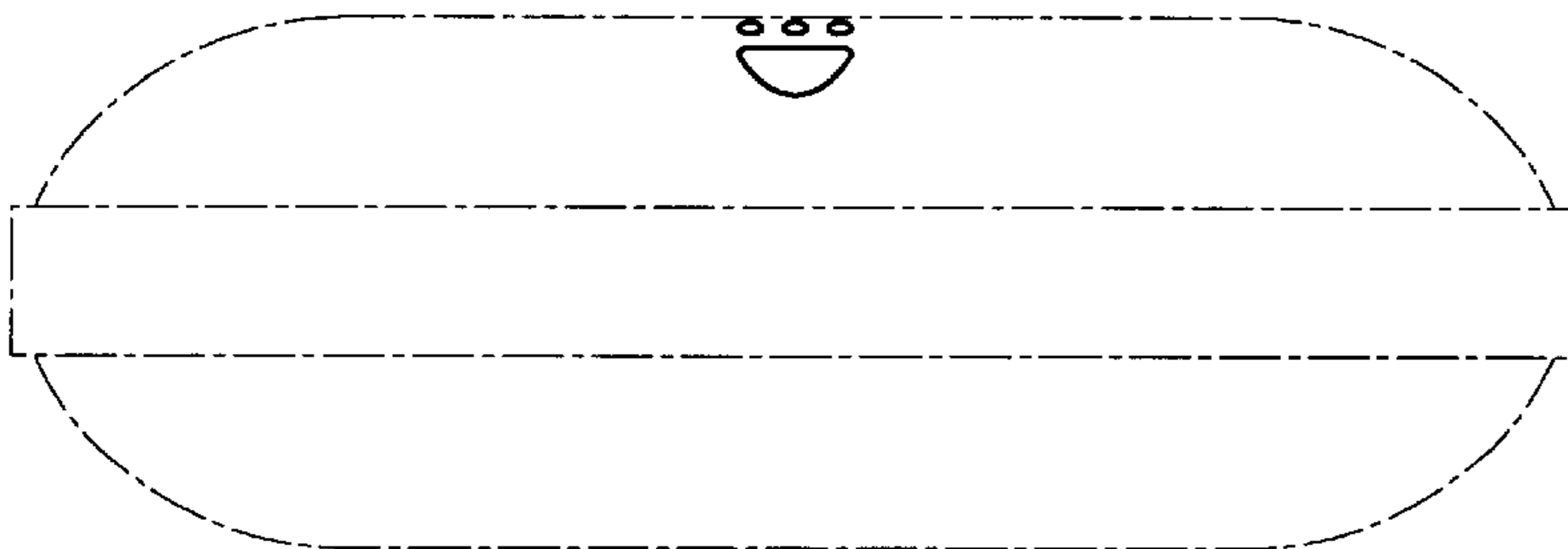
